(57) **CLAIM**

The ornamental designs for raised panel for storage shed, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a raised panel for storage shed;

FIG. 2 is a front elevational view of the raised panel for storage shed of FIG. 1;

FIG. 3 is a rear elevational view of the raised panel for storage shed of FIGS. 1 and 2;

FIG. 4 is a top plan view of the raised panel for storage shed of FIGS. 1–3;

FIG. 5 is a bottom plan view of the raised panel for storage shed of FIGS. 1–4;

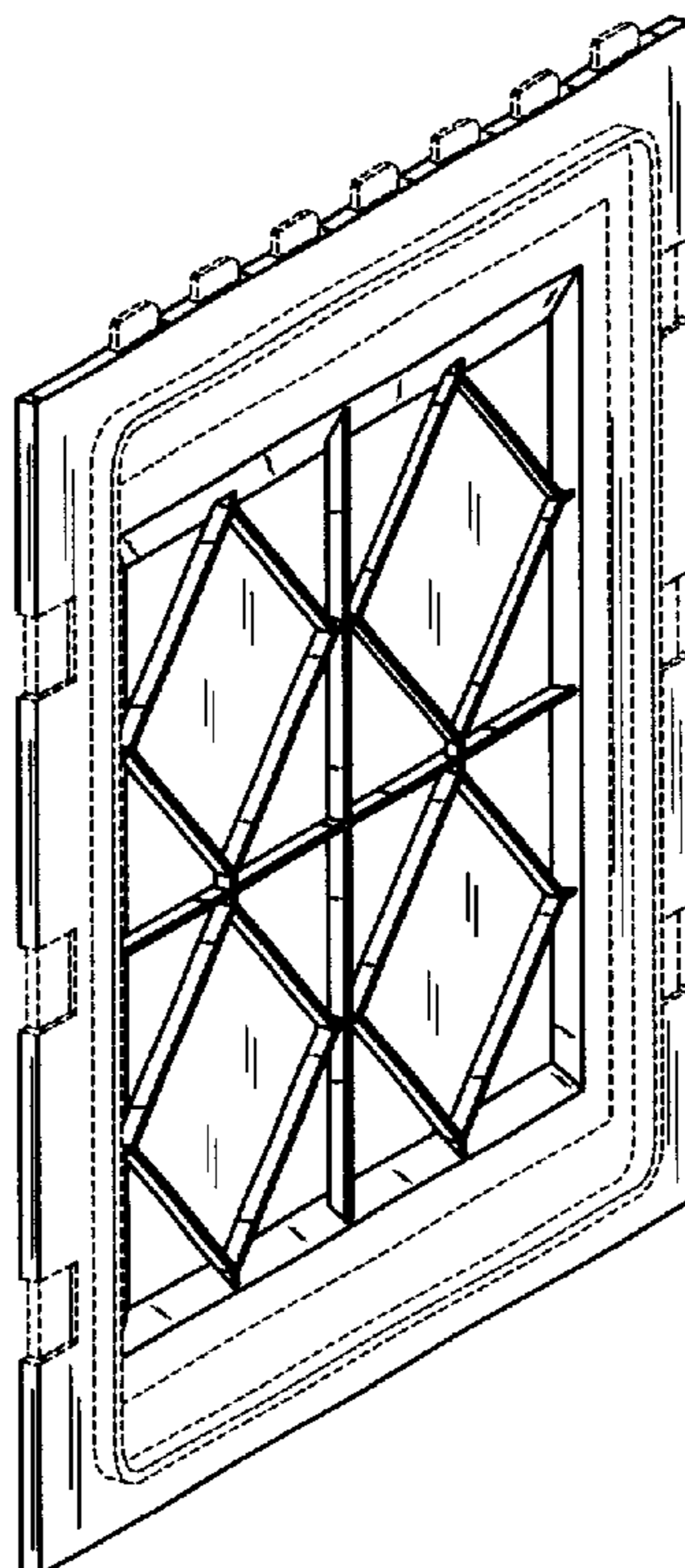
FIG. 6 is a left side elevational view of the raised panel for storage shed of FIGS. 1–5,

FIG. 7 is a right side elevational view of the raised panel for storage shed of FIGS. 1–6; and,

FIG. 8 is a front perspective view of the raised panel for storage shed of FIGS. 1–7 including five other panels and snaps for connecting the panels, shown in phantom.

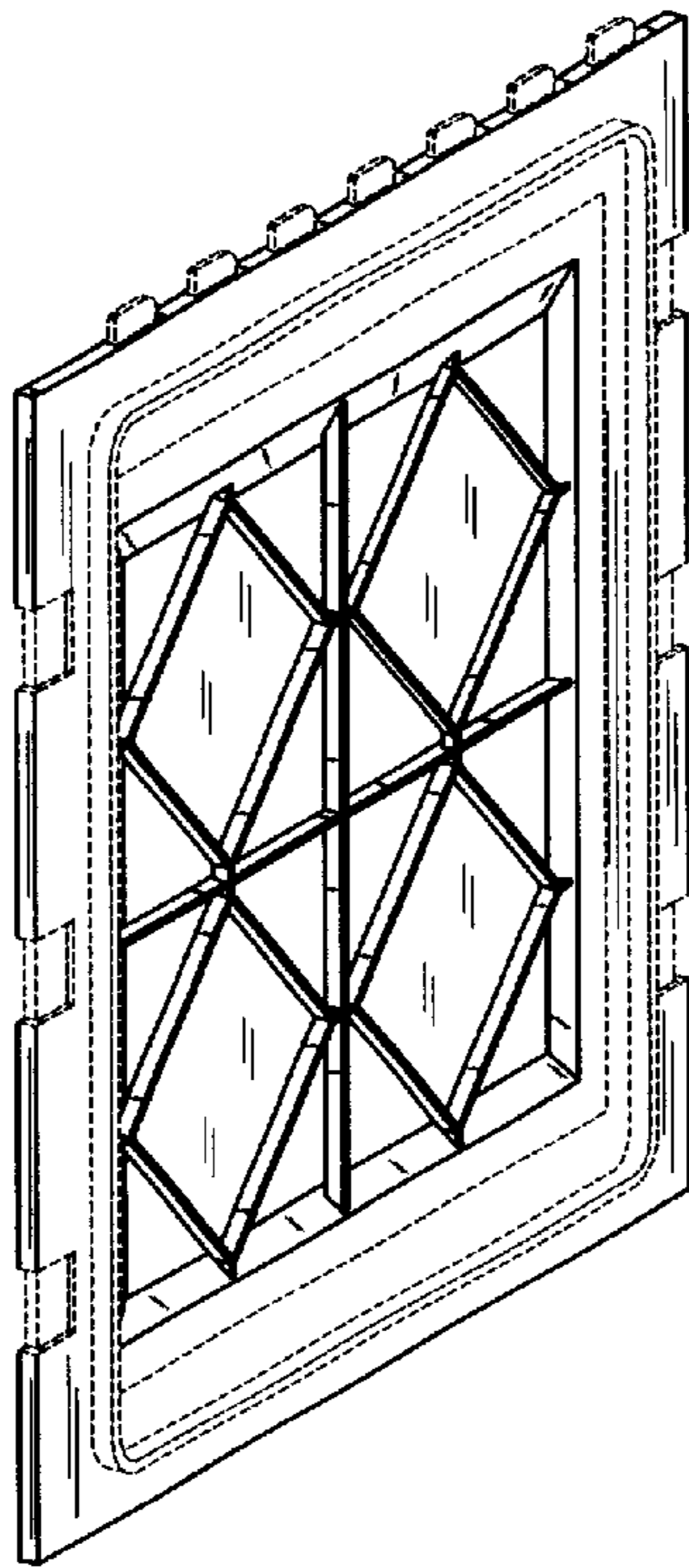

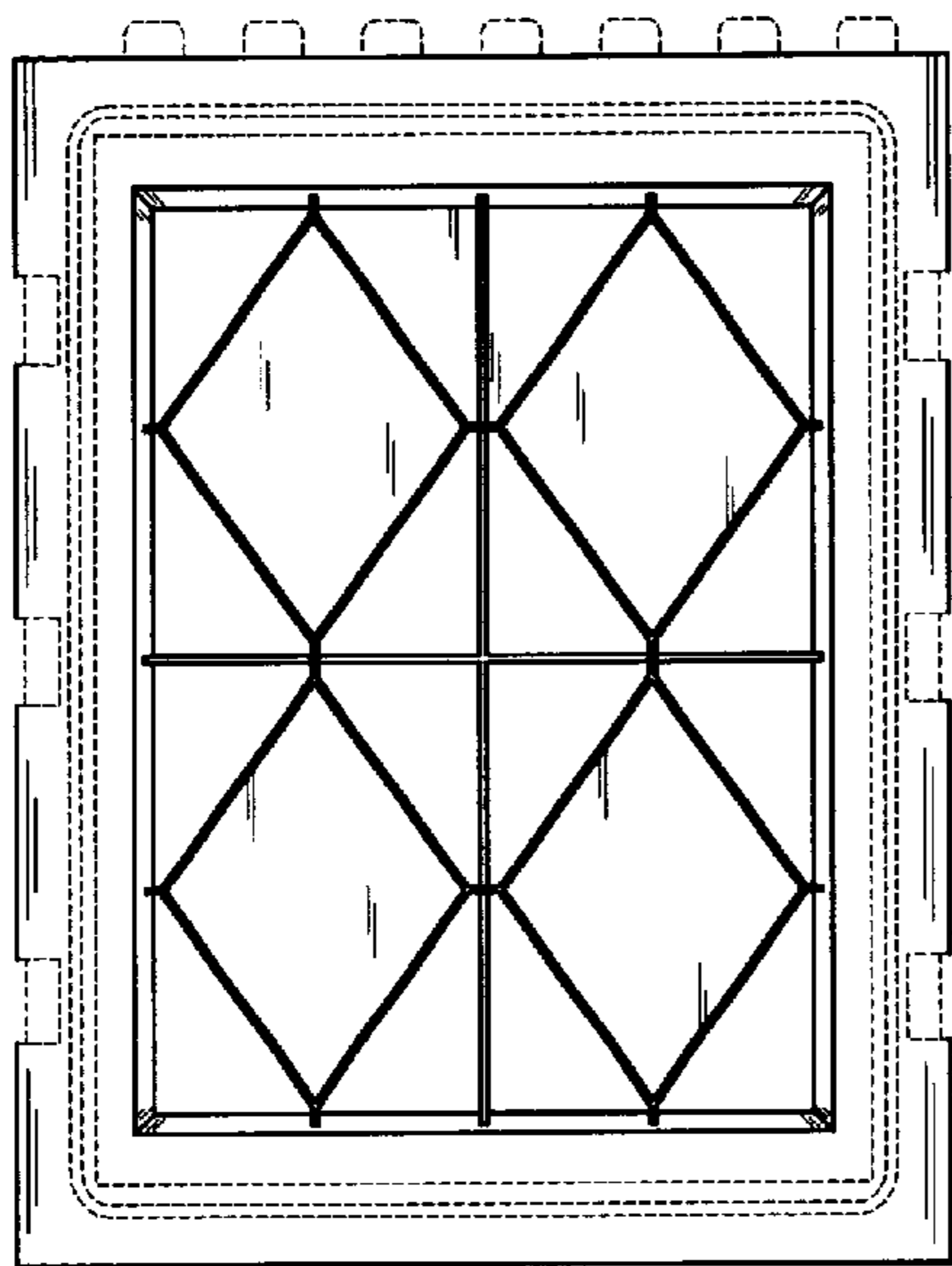

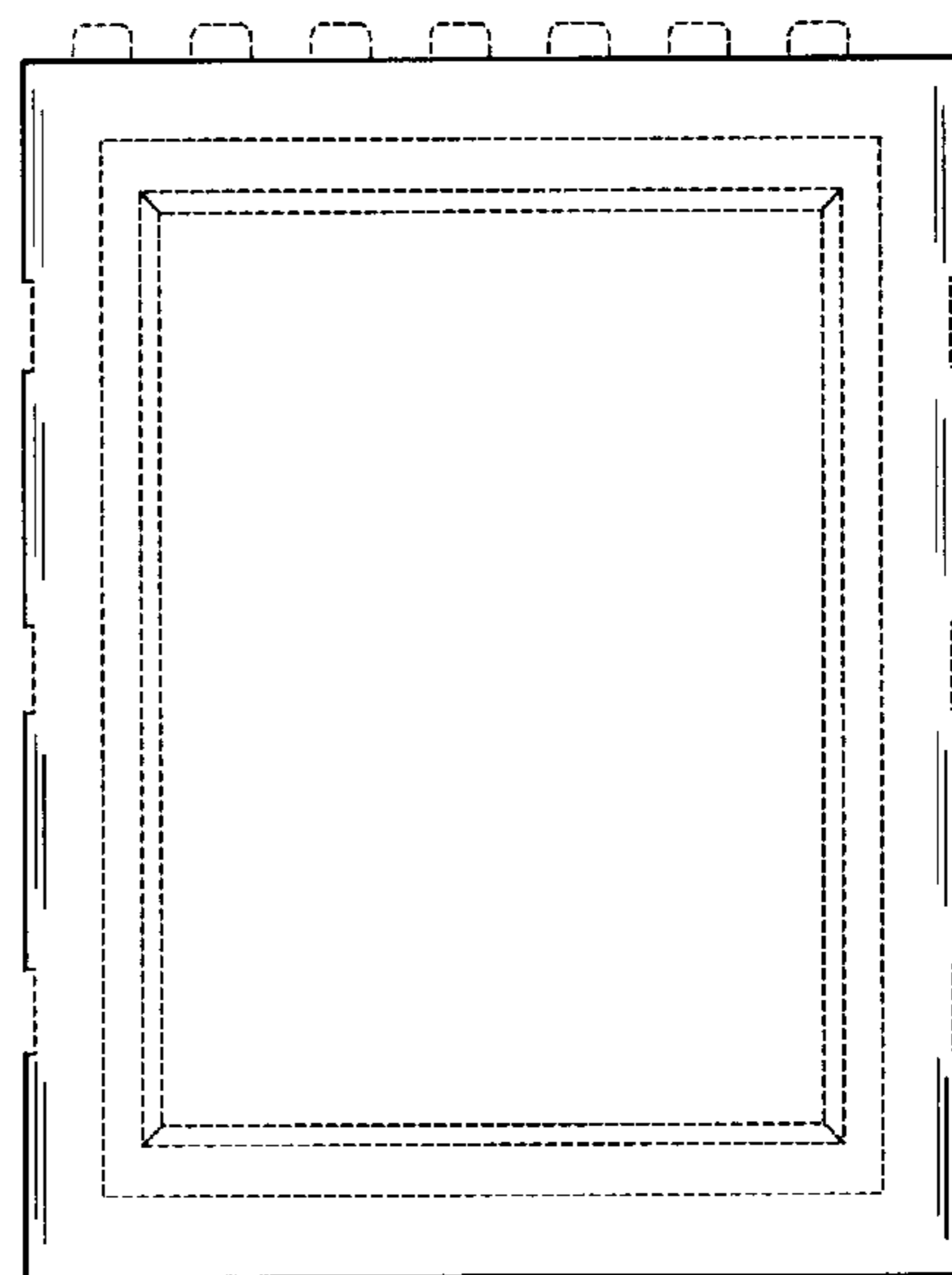

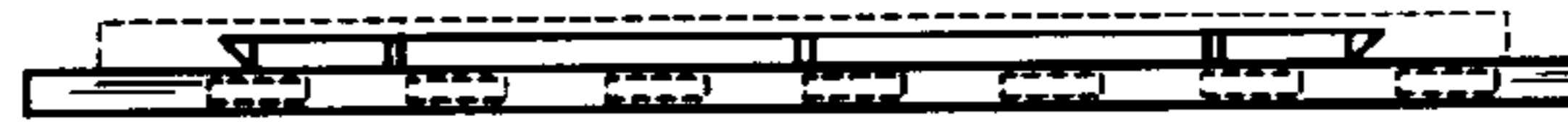

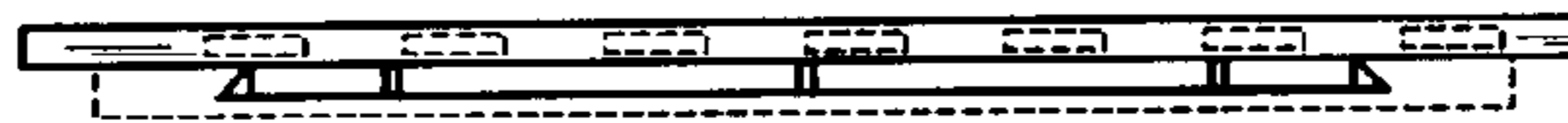

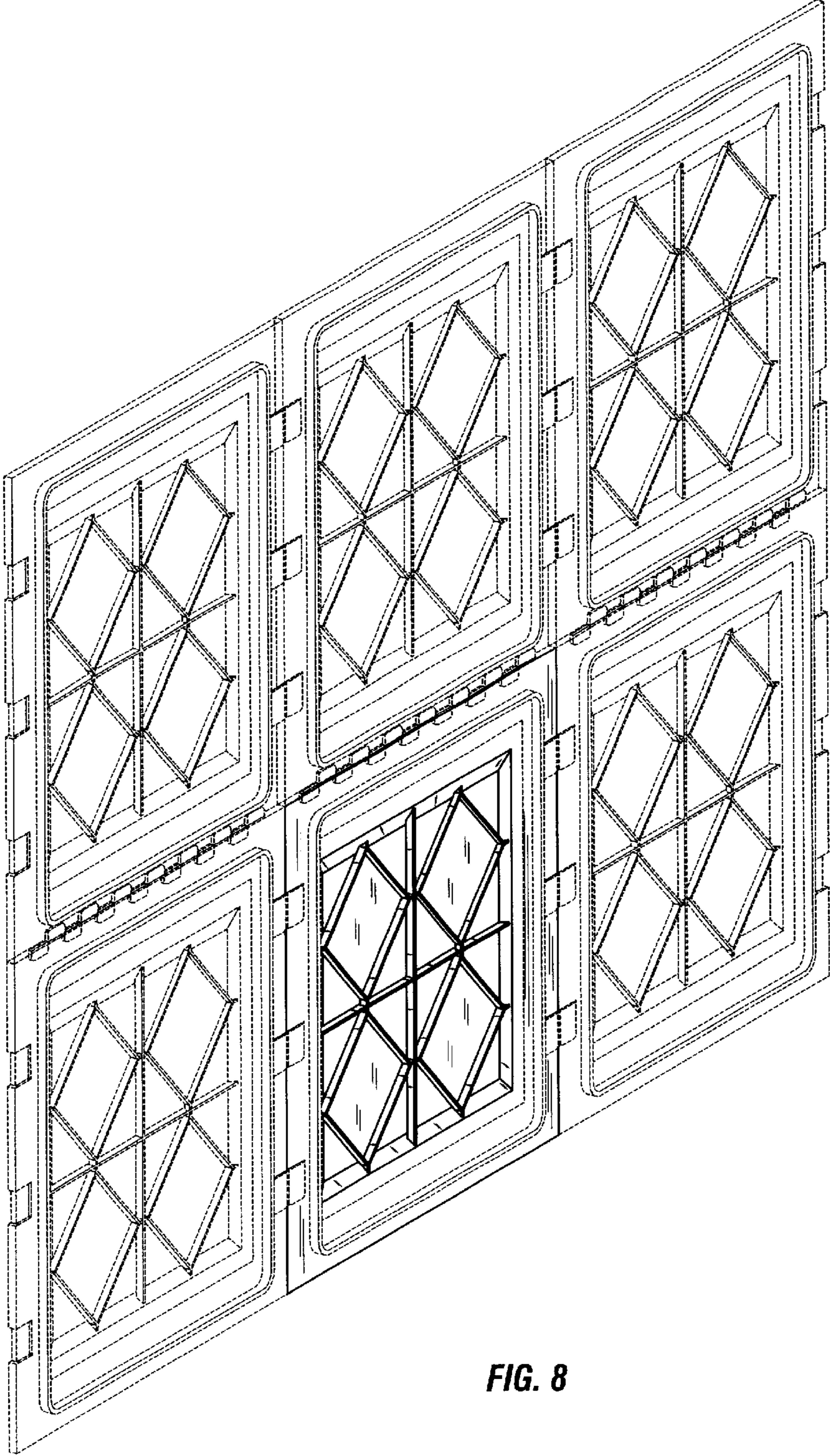
