The ornamental design for a compactable paintball marker squeegee, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a compactable paintball marker squeegee showing my new design in a compacted arrangement;

FIG. 2 is a top view of the design of FIG. 1; FIG. 3 is a cutaway view along line A—A of FIG. 2 detailing internal features which are externally visible on the design of FIG. 1;
