FIG. 8 is a right front perspective view of one portion of a privacy screen for a self-service terminal shown separately for purposes of illustration.

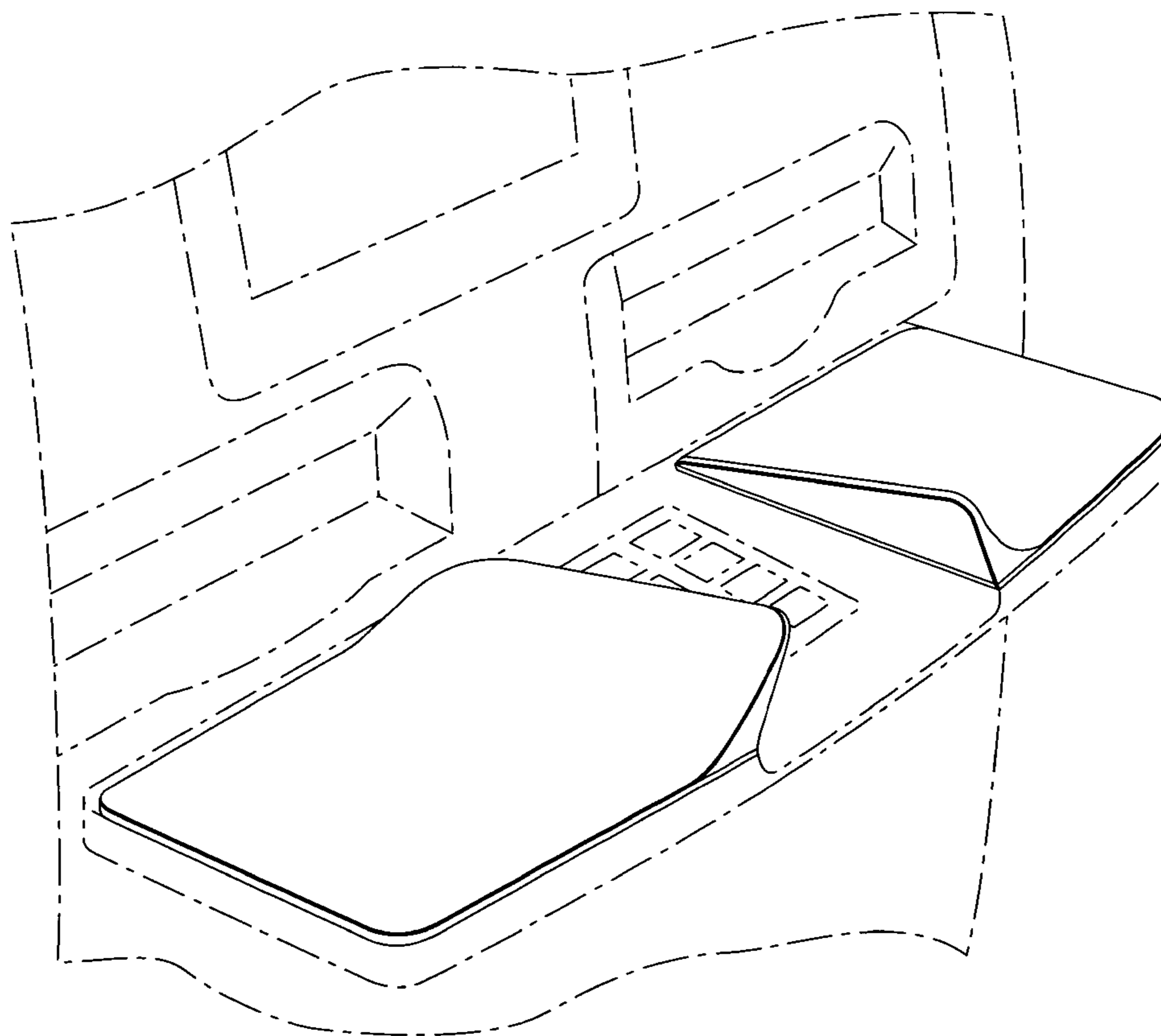

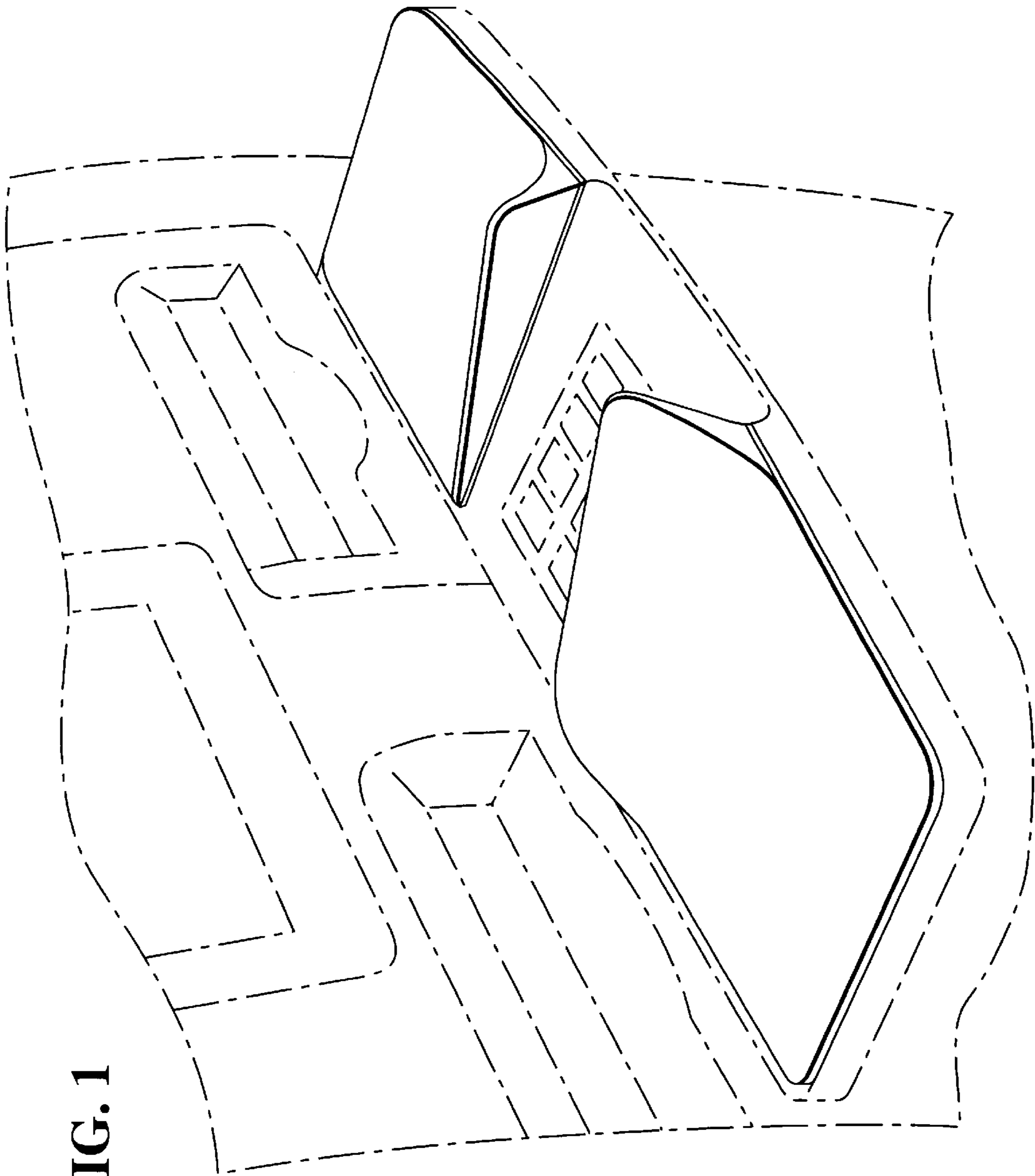

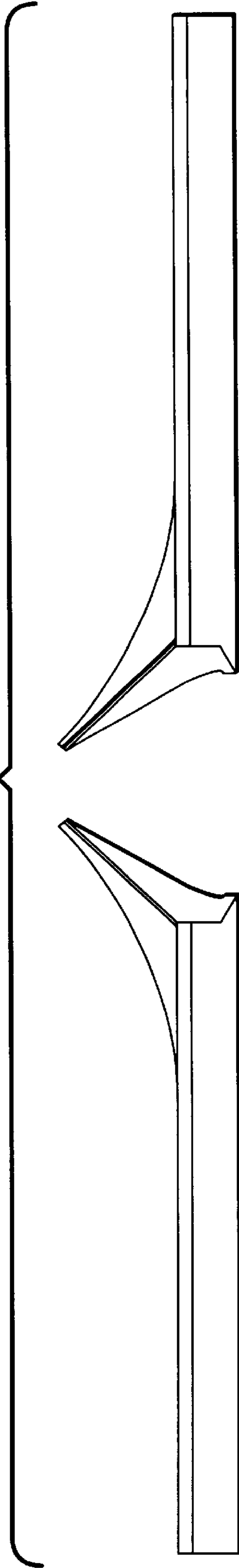

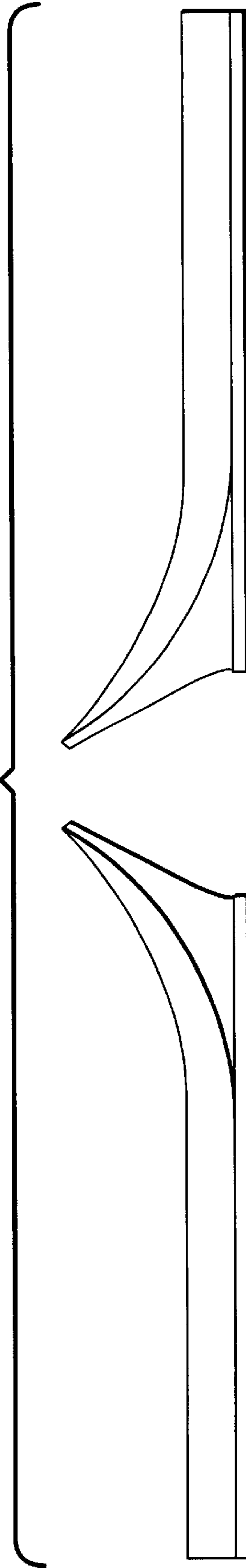

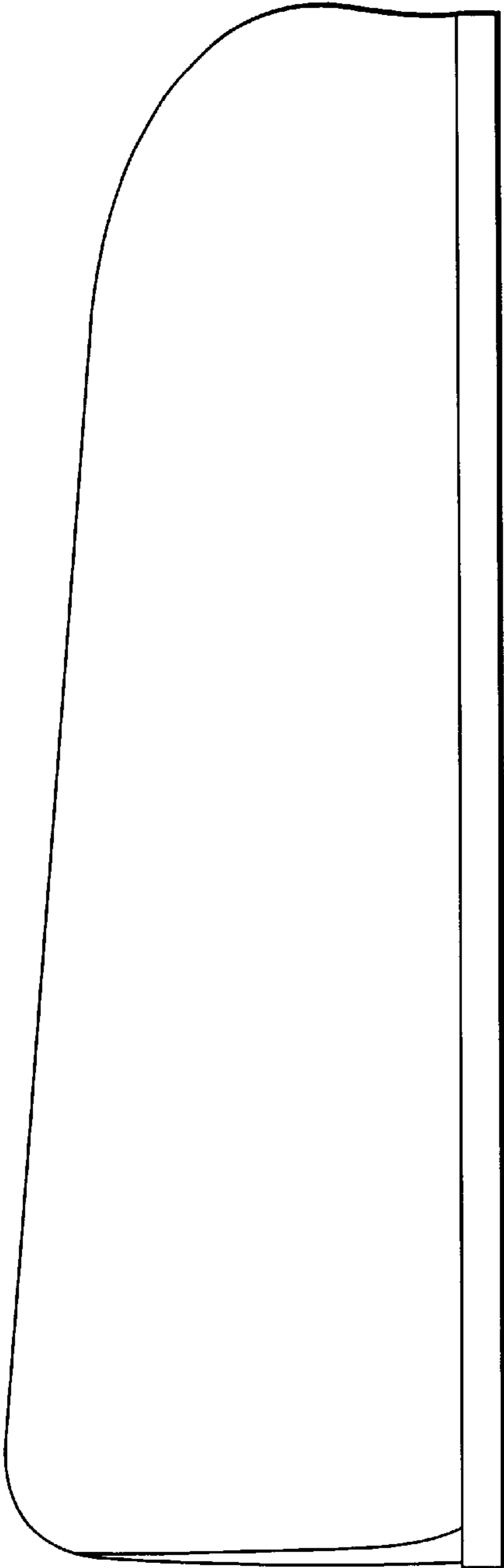

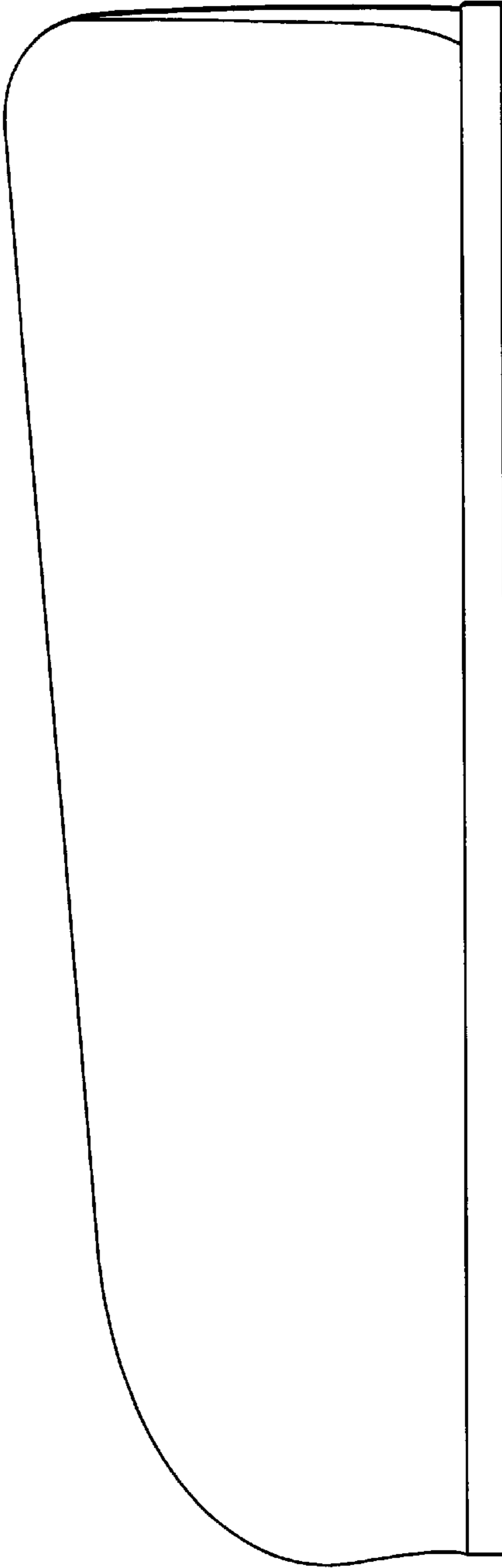

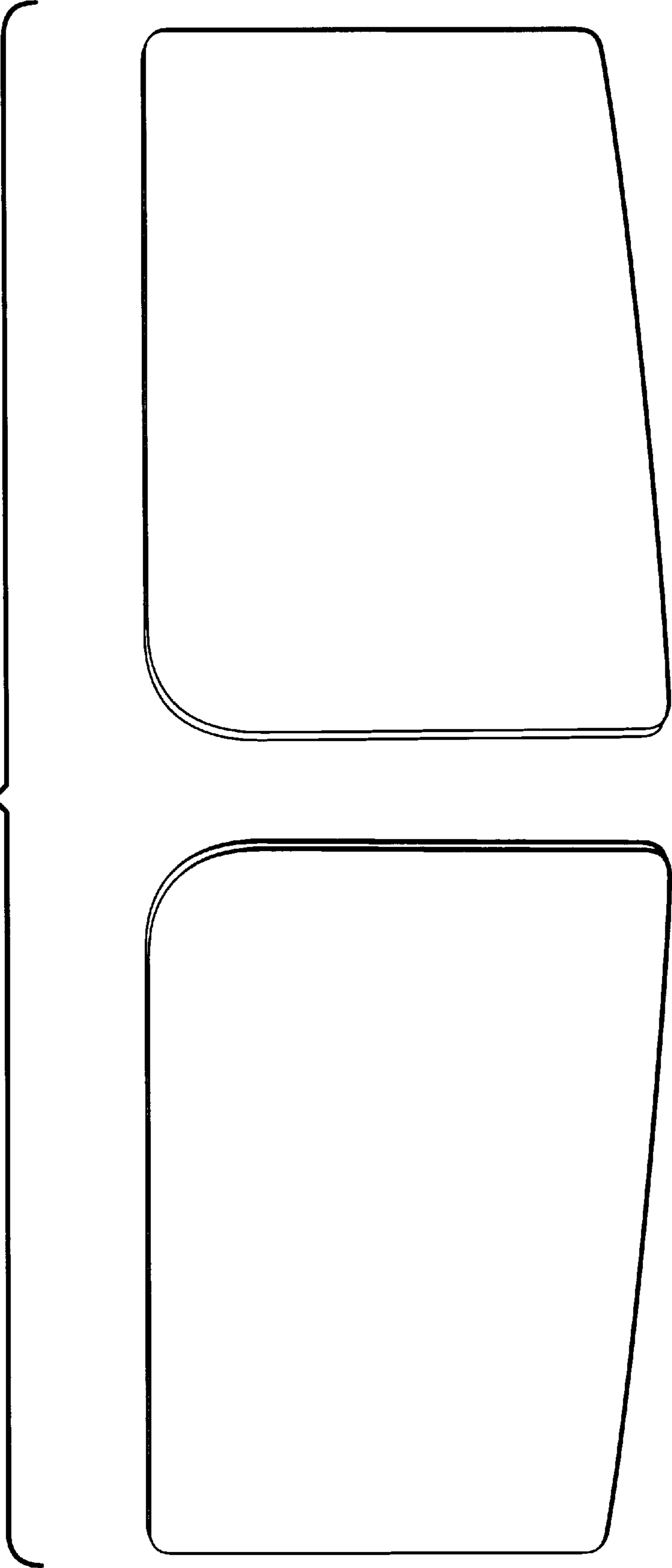

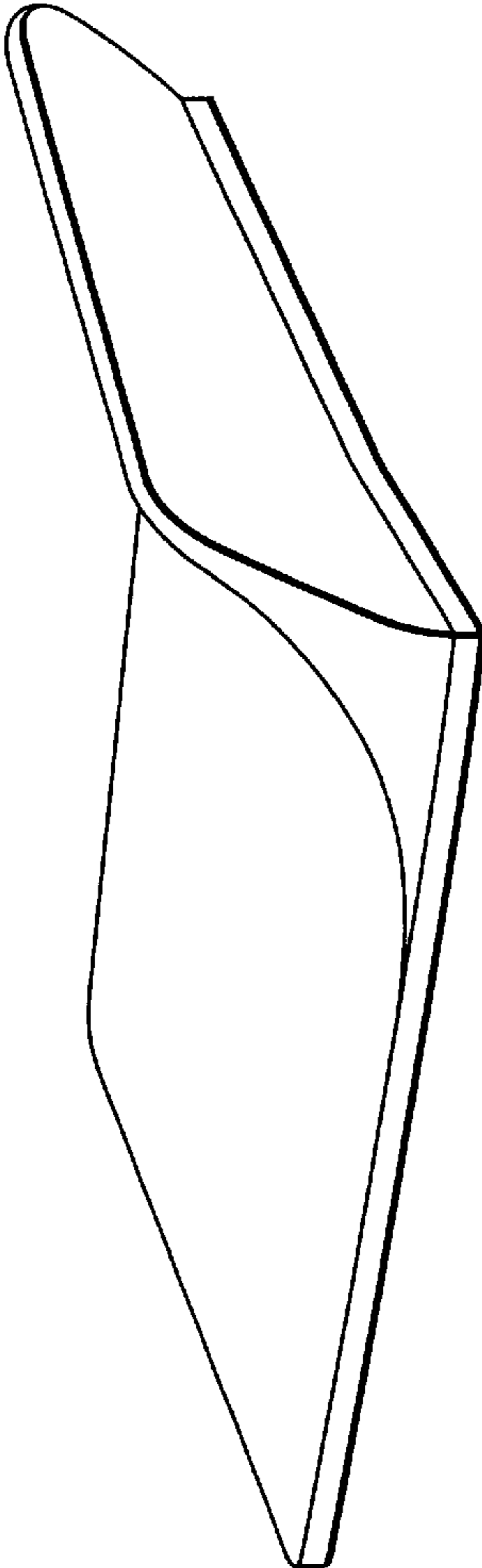
