The ornamental design for a T-shirt, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a T-shirt showing my new design.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a front elevational view of a T-shirt showing an alternative embodiment of my new design; and,

FIG. 4 is a rear elevational view of the alternative embodiment of my new design.

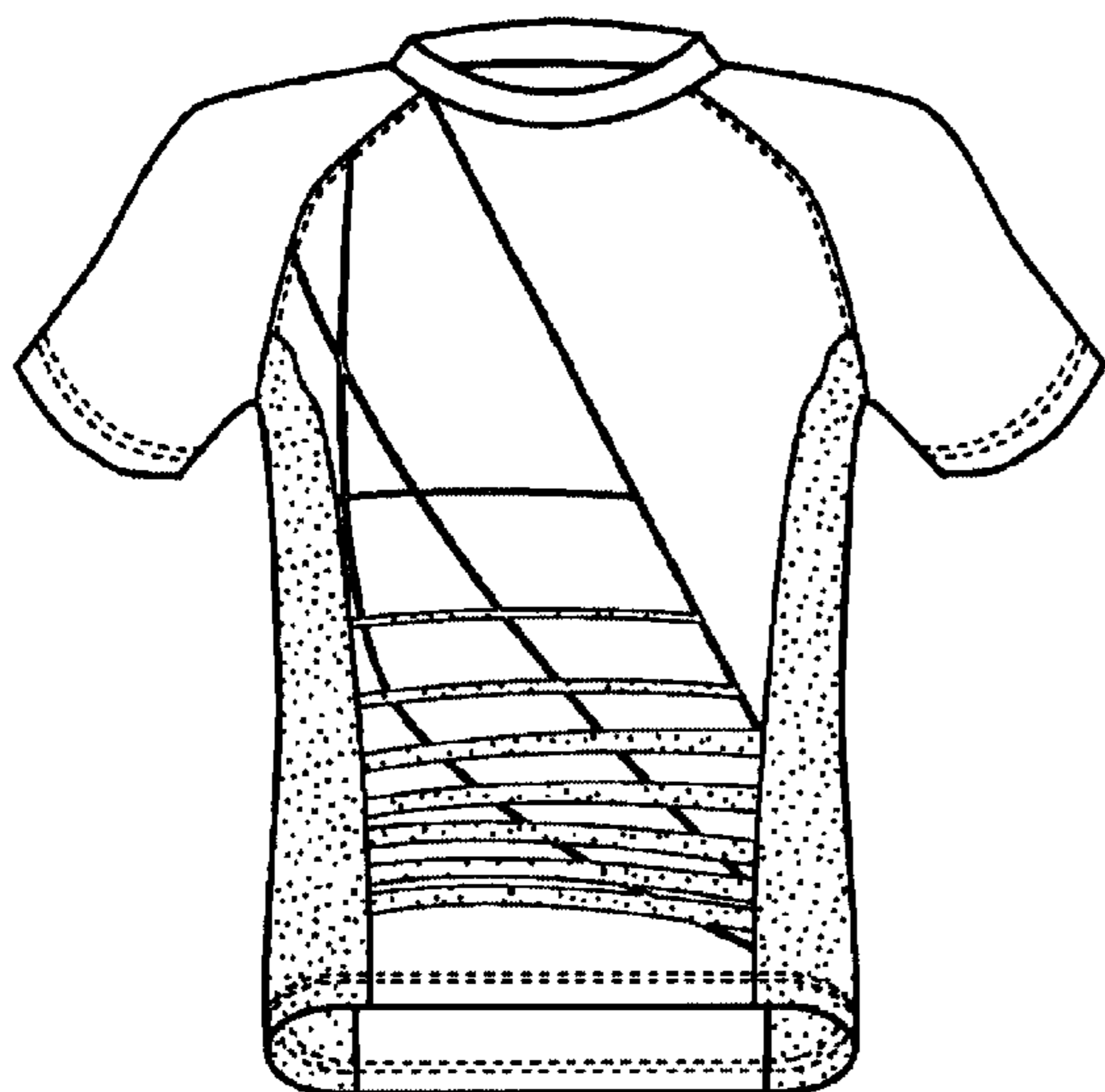
The broken lines shown in FIGS. 1-4 represent stitching.

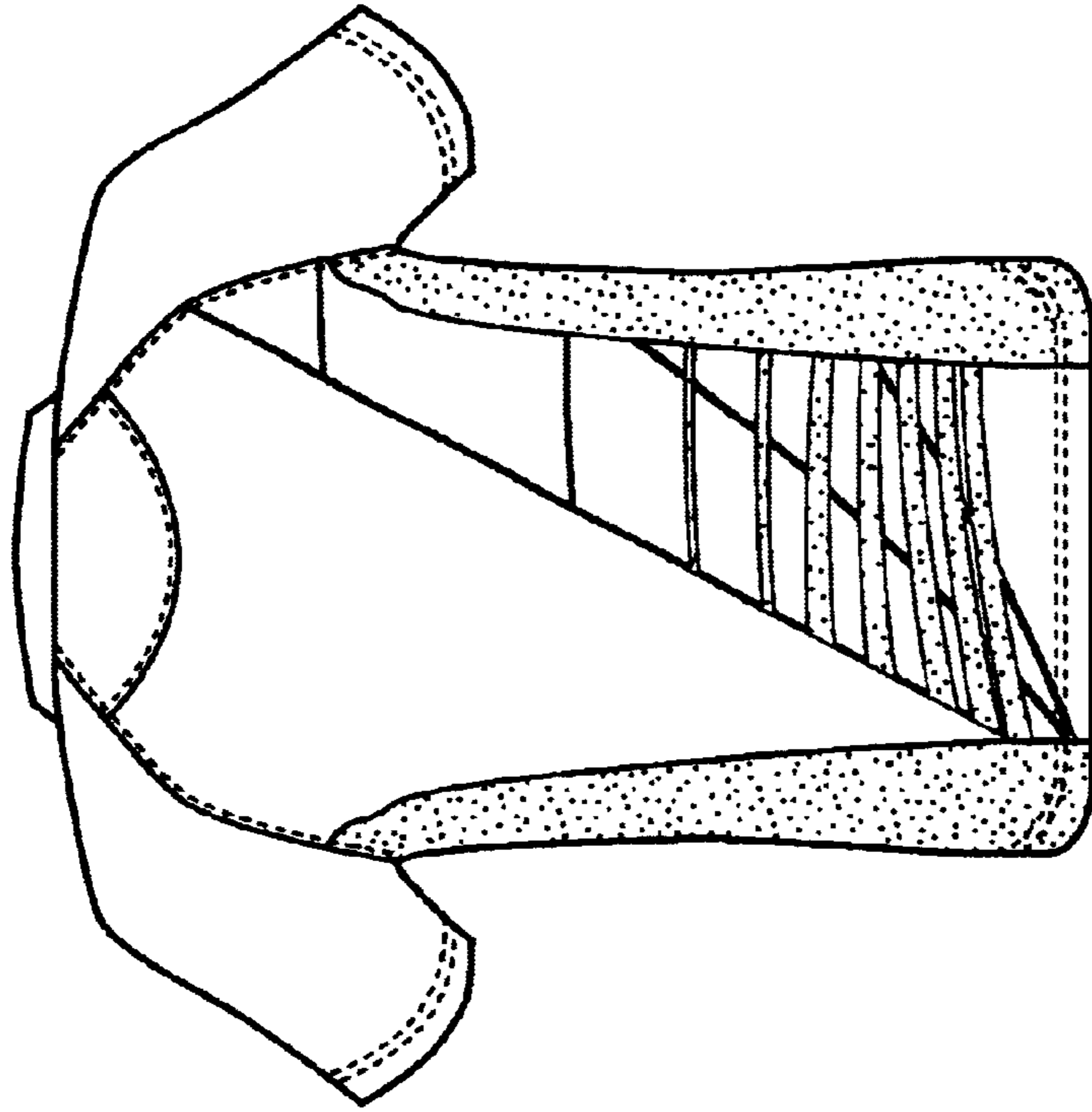

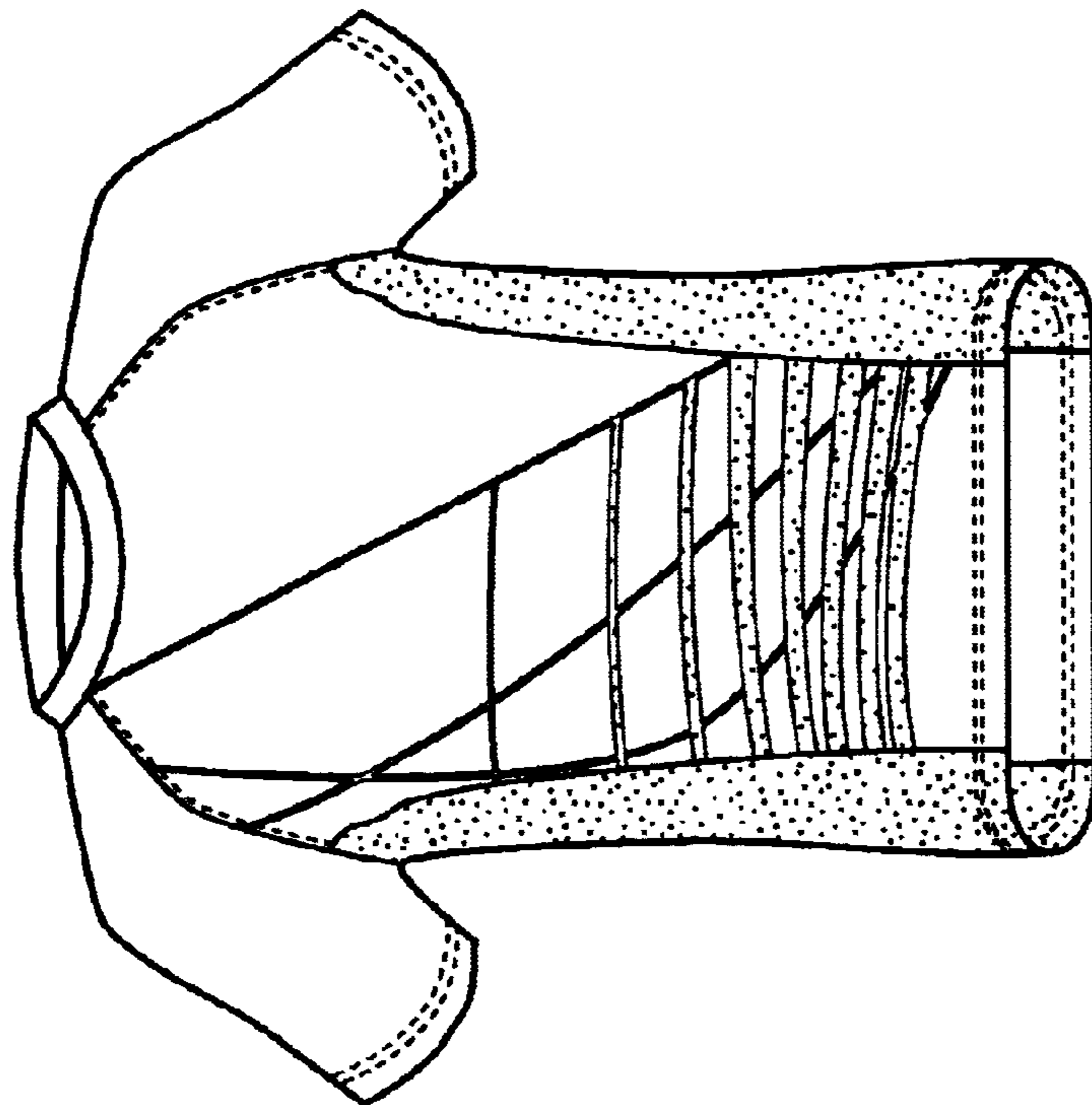

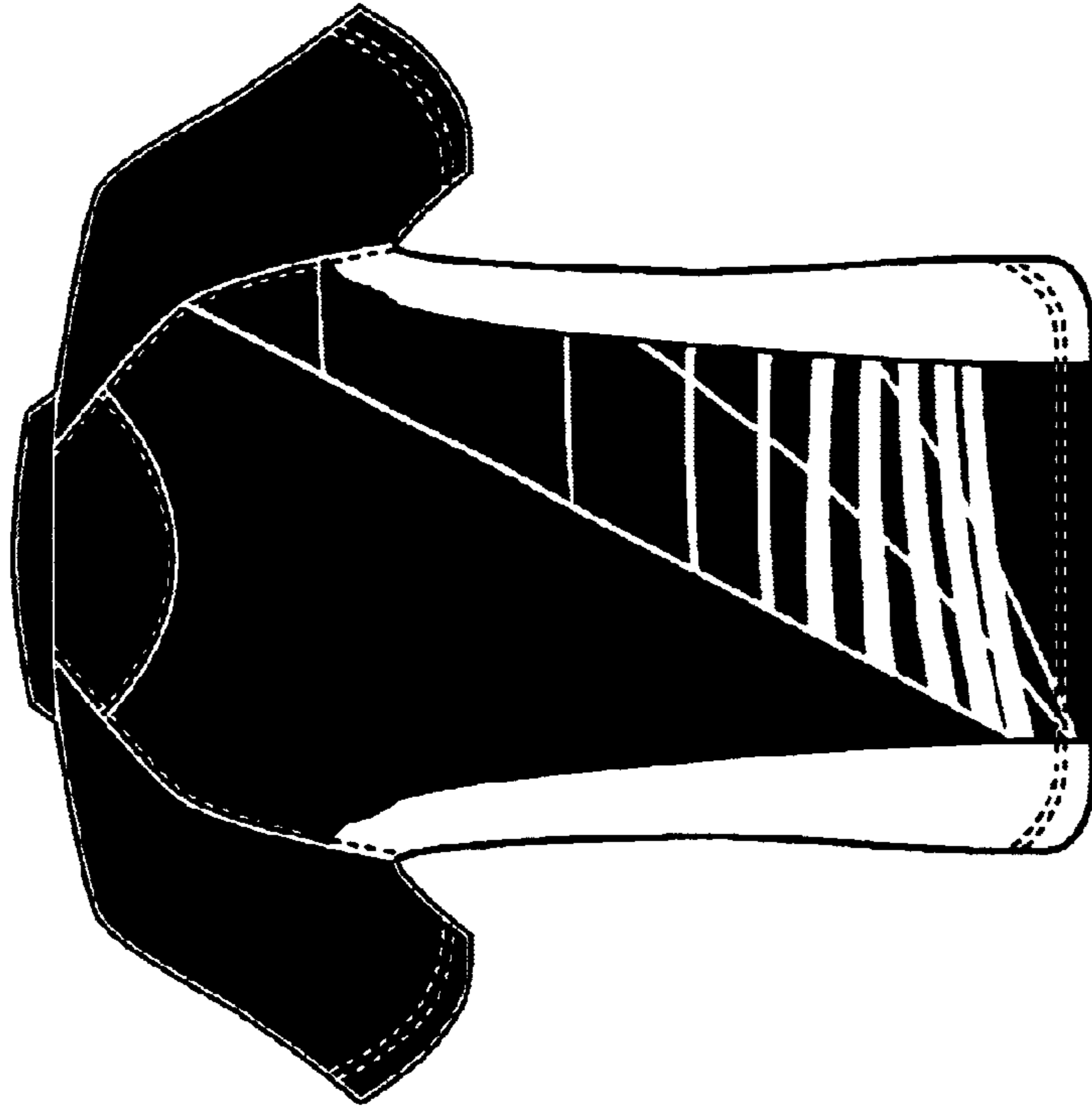

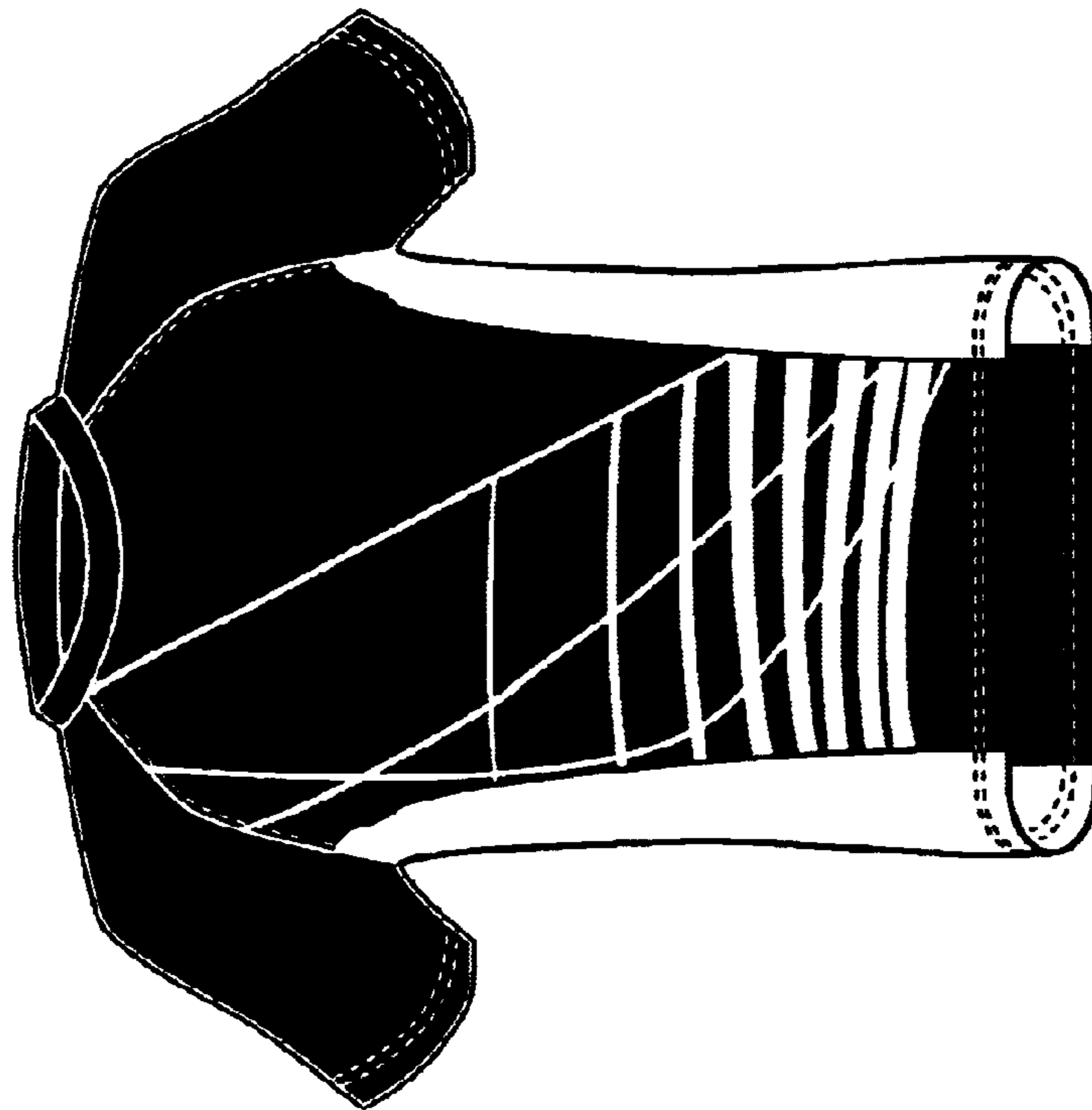
