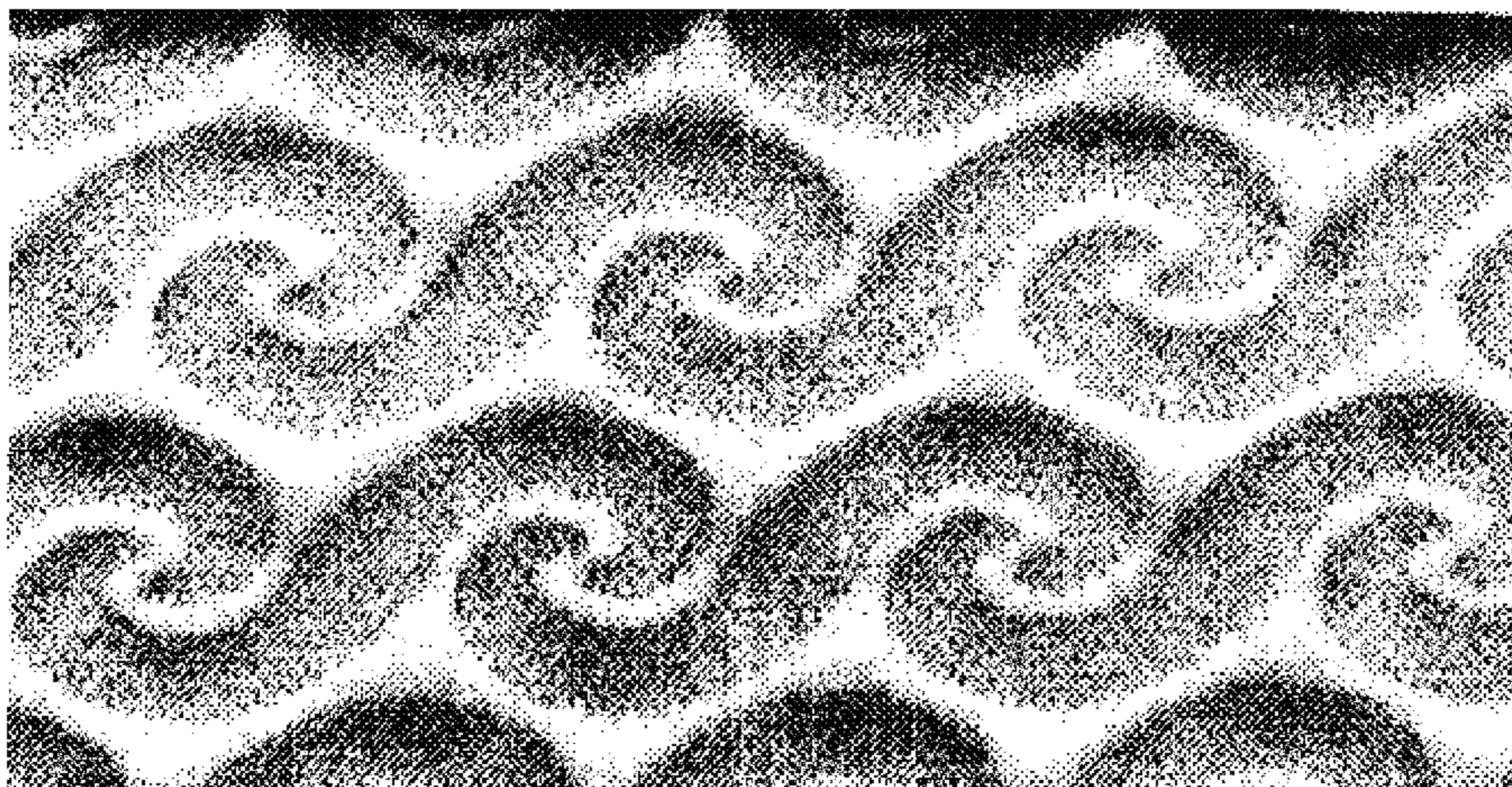
The ornamental design for a nonwoven fabric, as shown and described.
