(57) **CLAIM**

The ornamental design for a baby wipes container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a baby wipes container showing my new design;

FIG. 10 is a left side elevational view thereof;

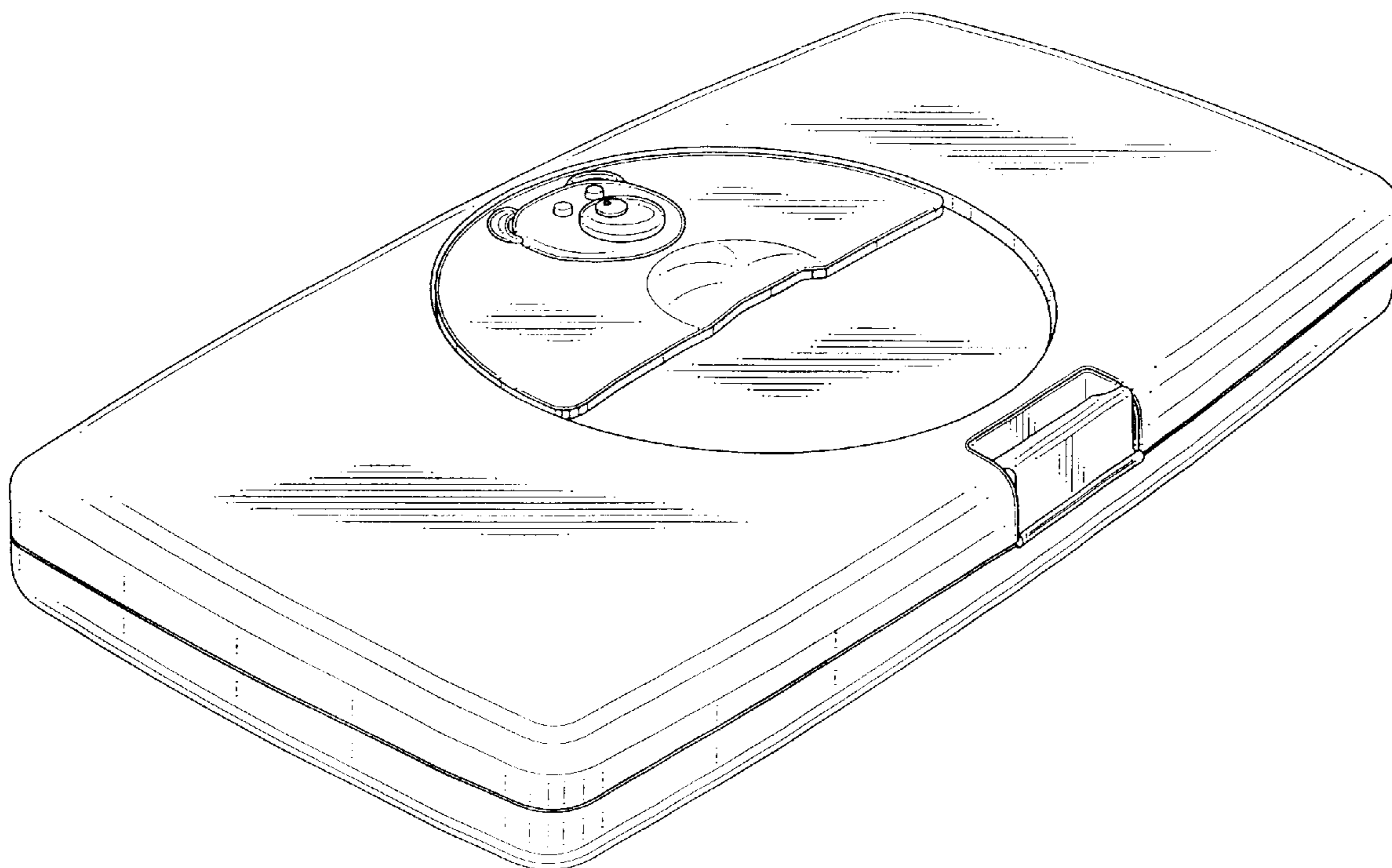
FIG. 11 is a right side elevational view thereof;

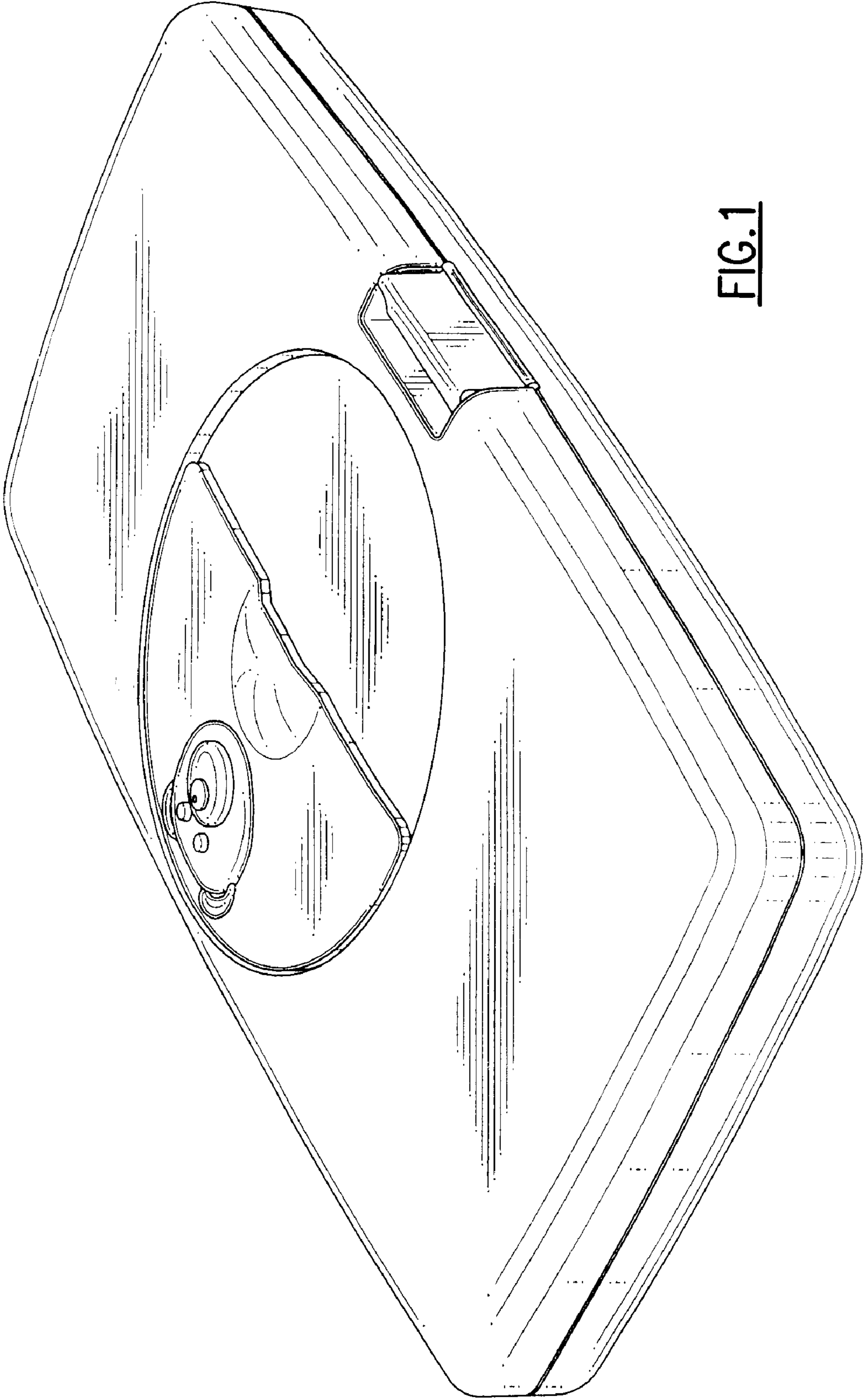

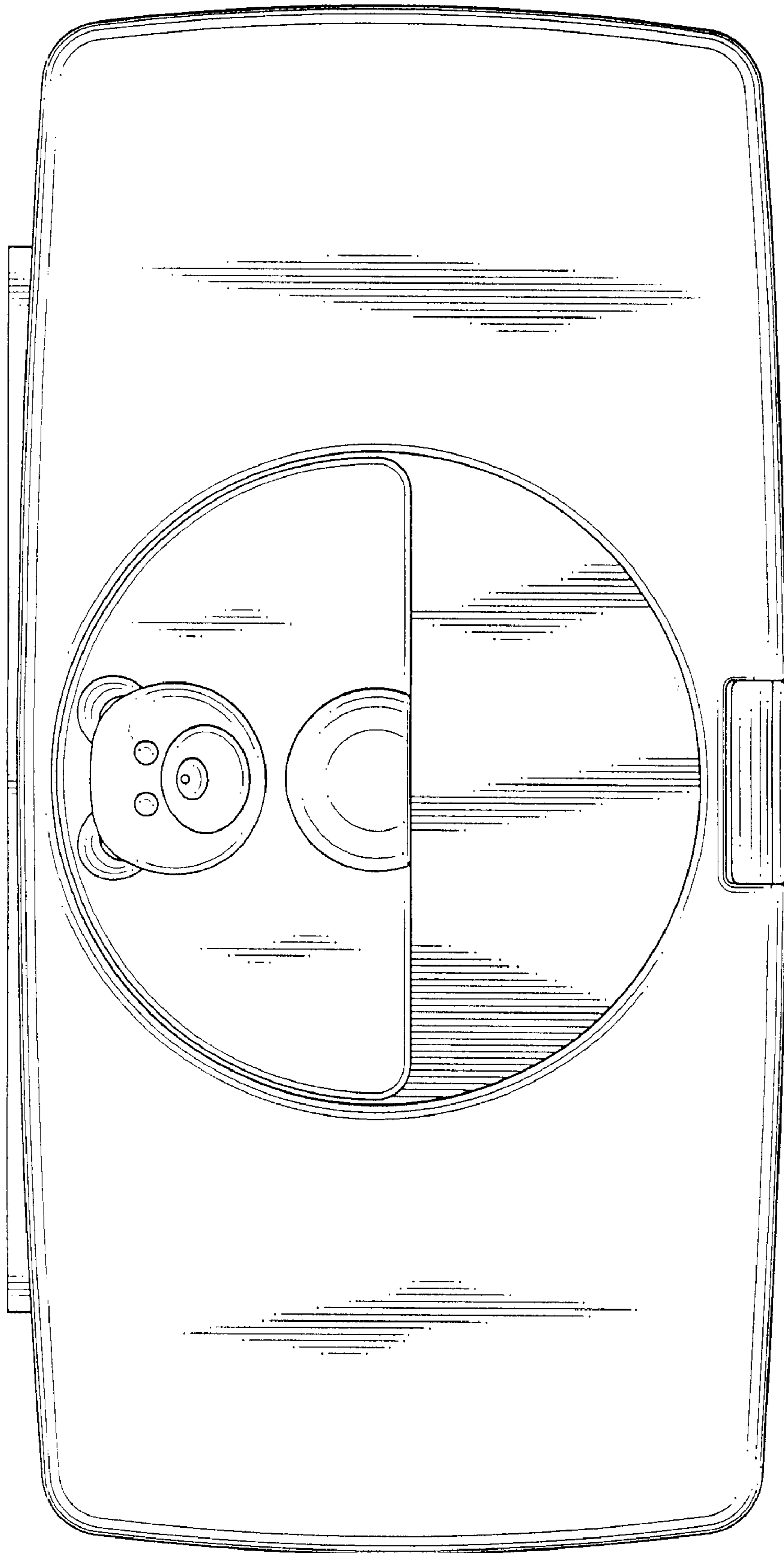

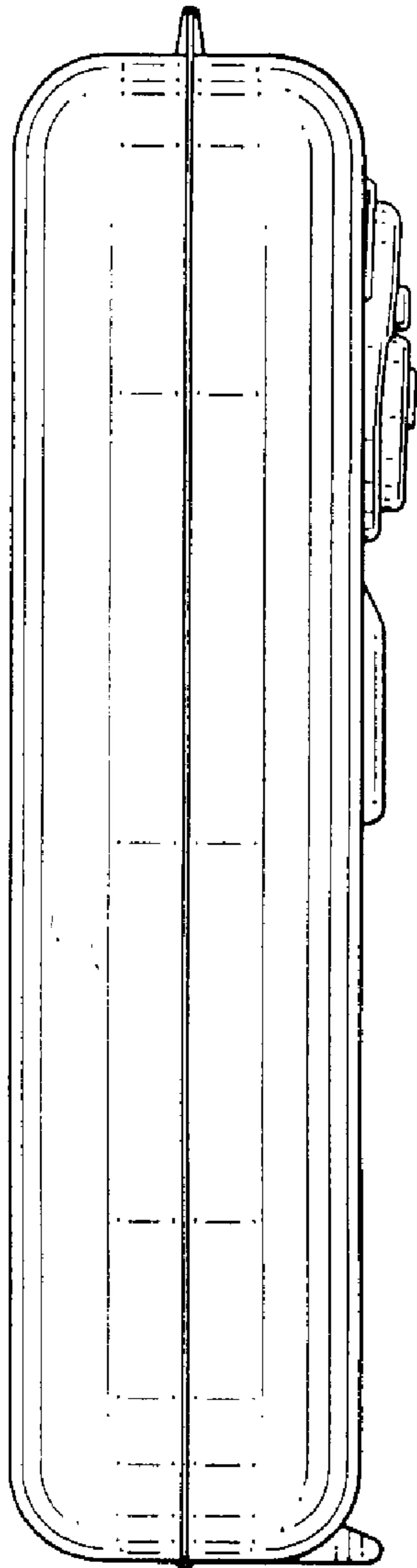

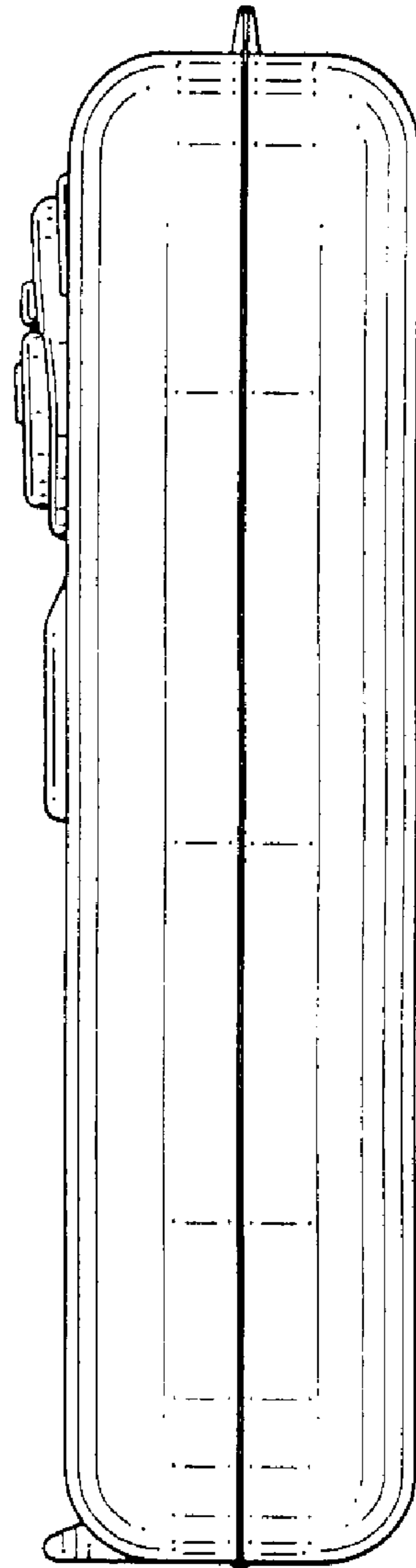

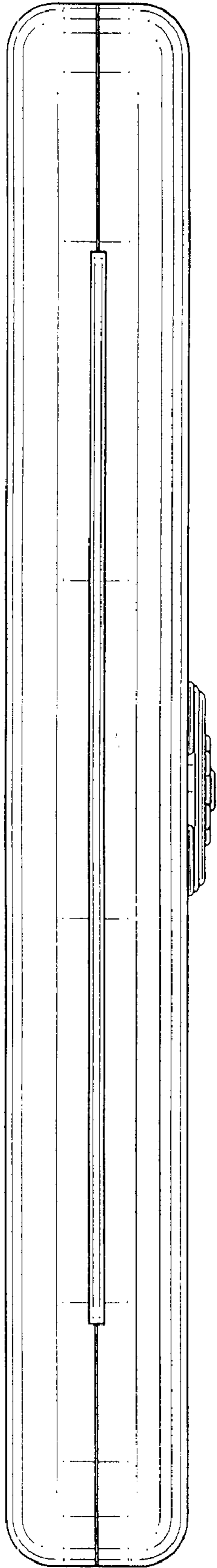

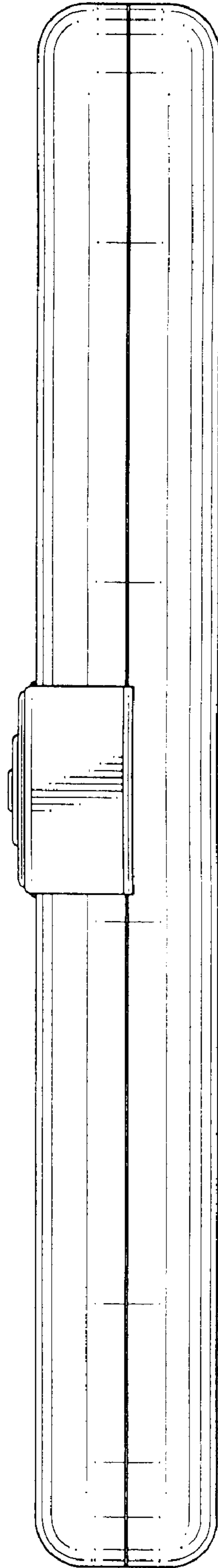

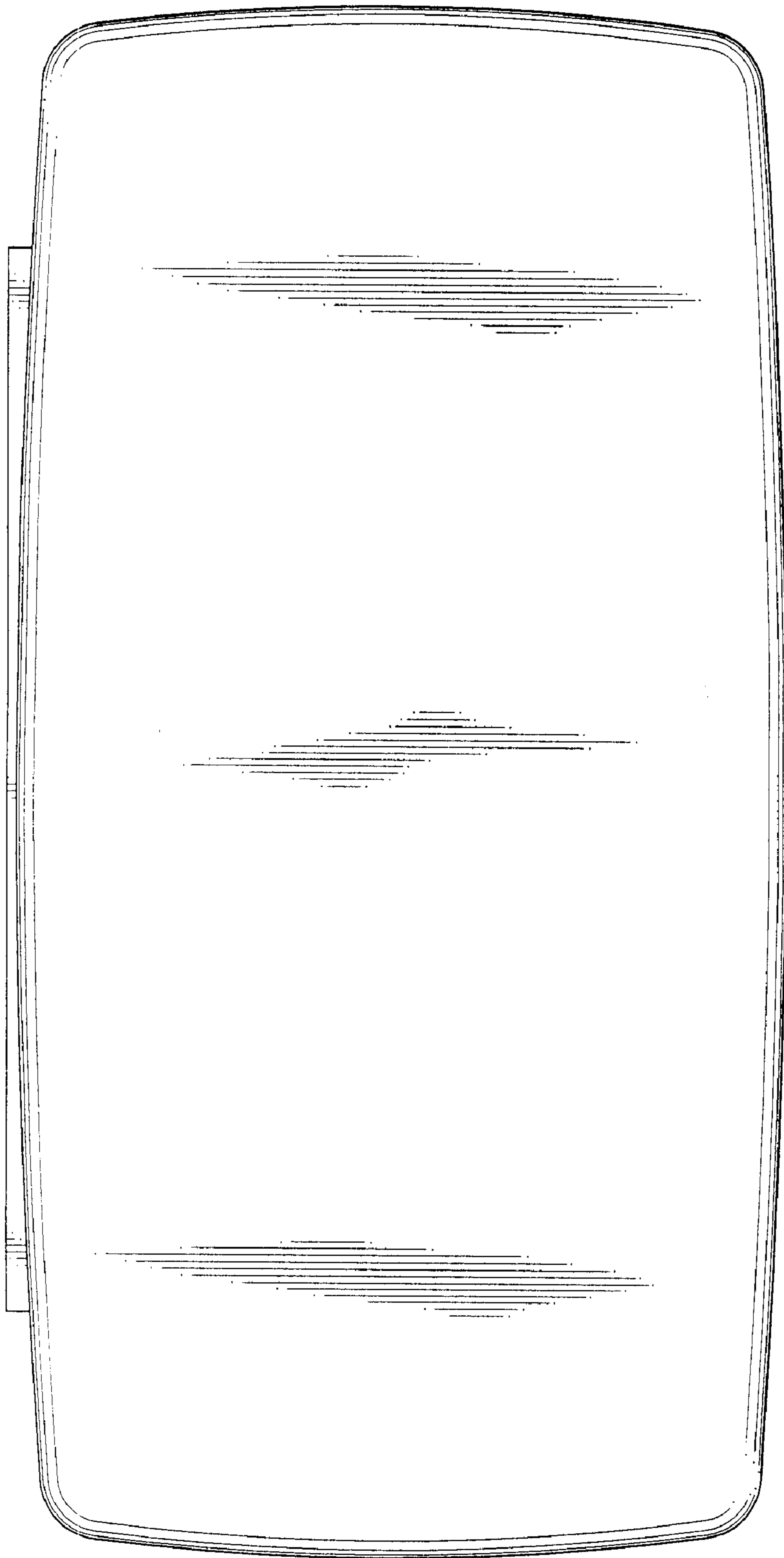

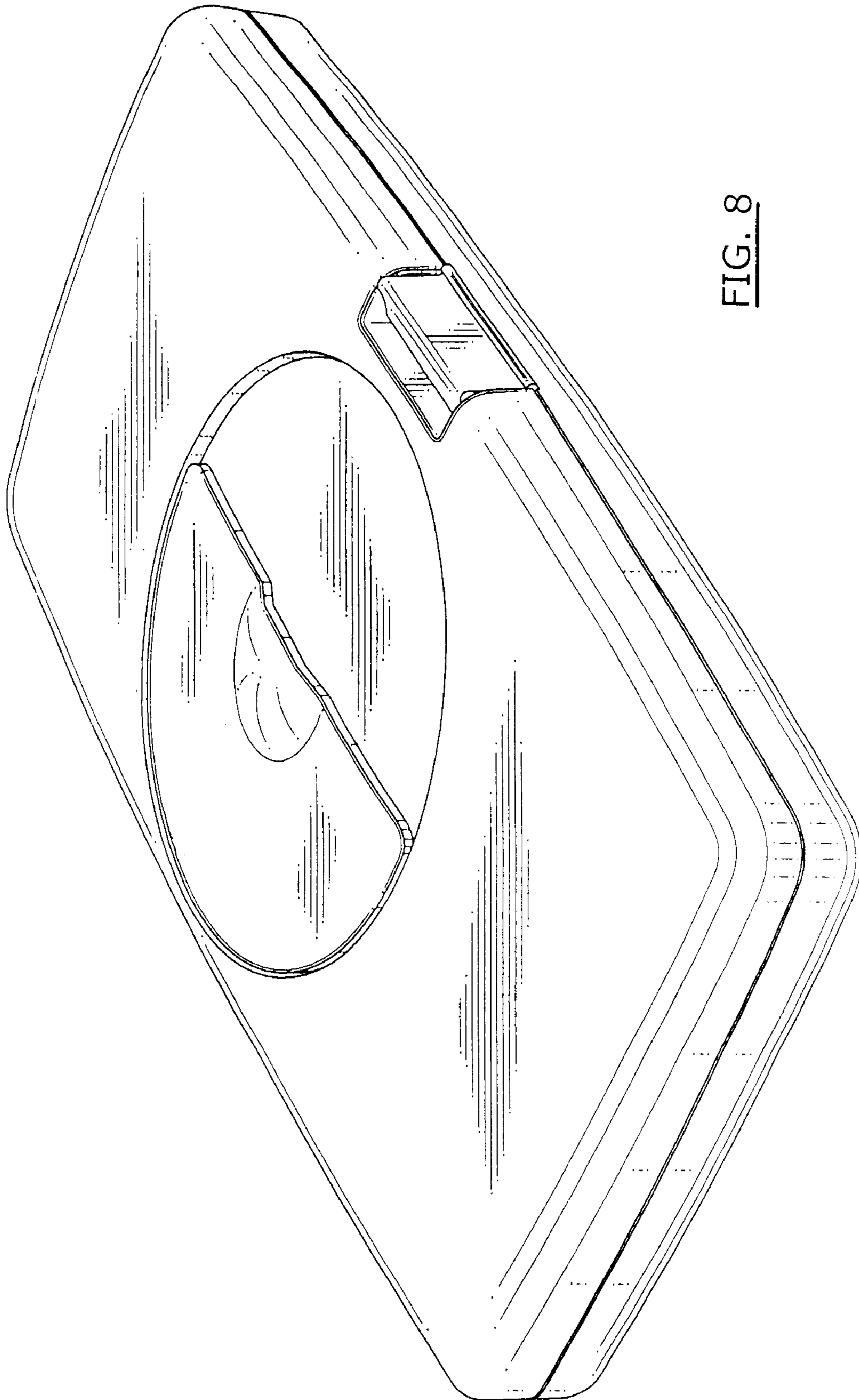

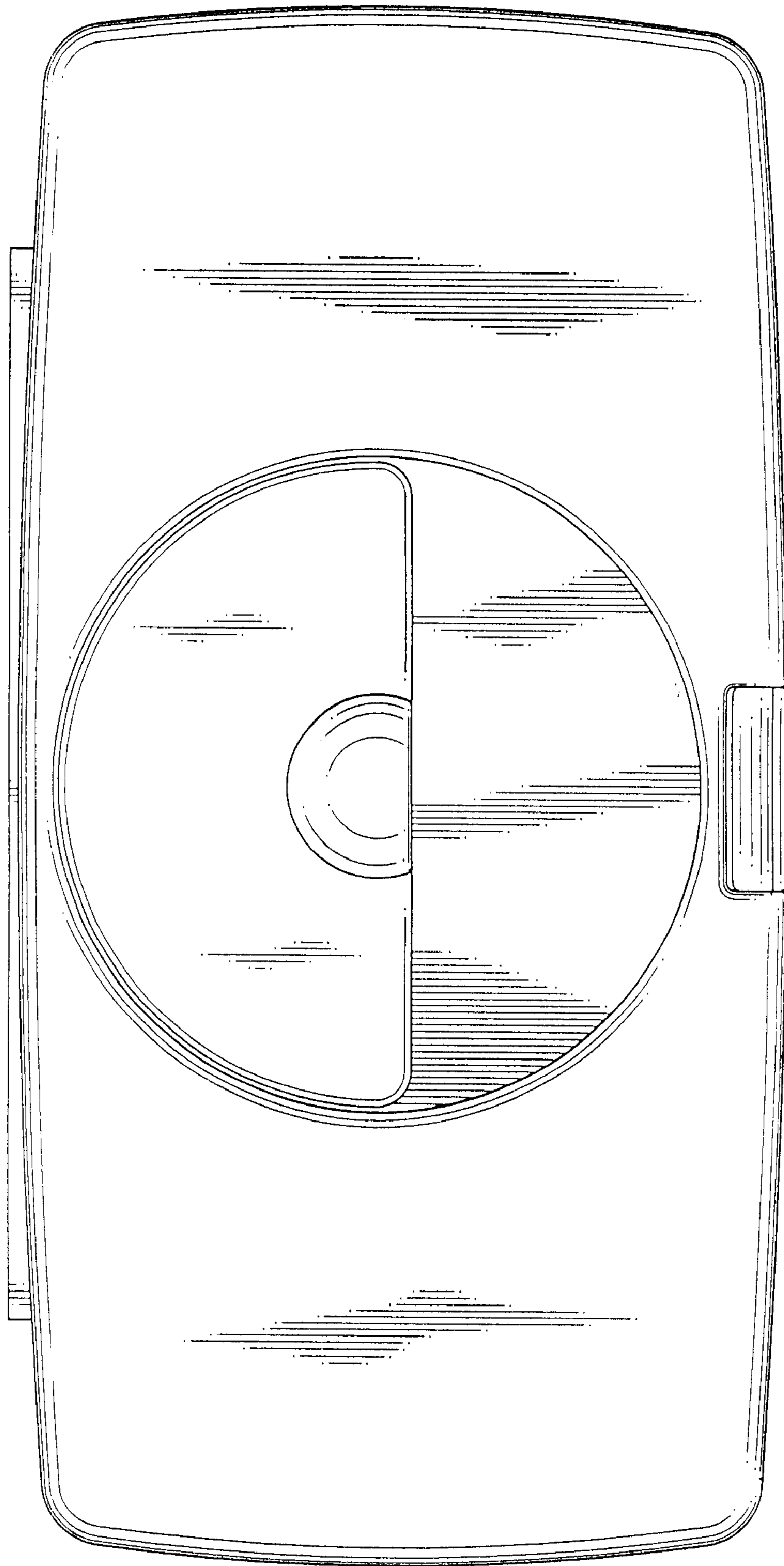

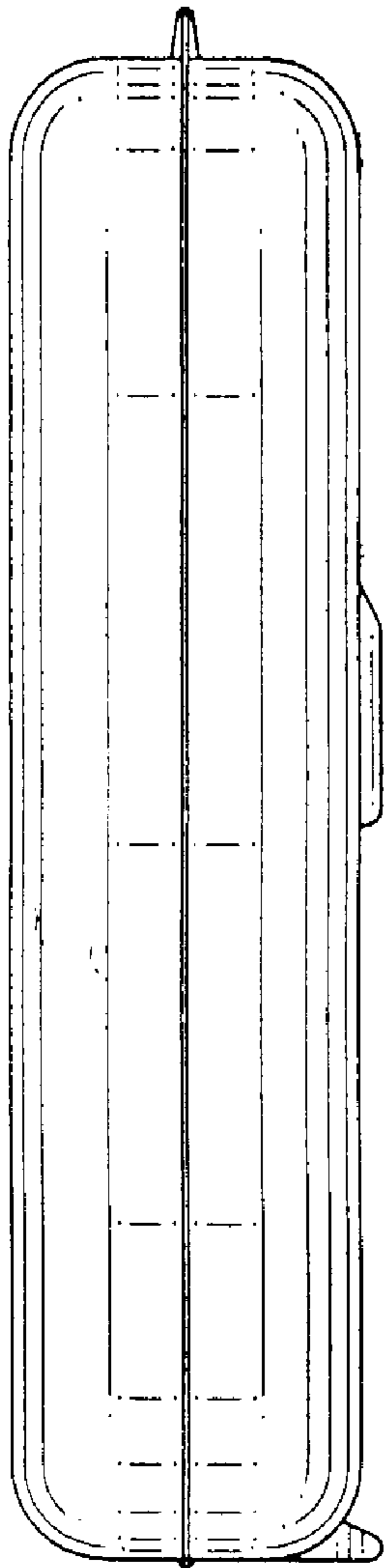

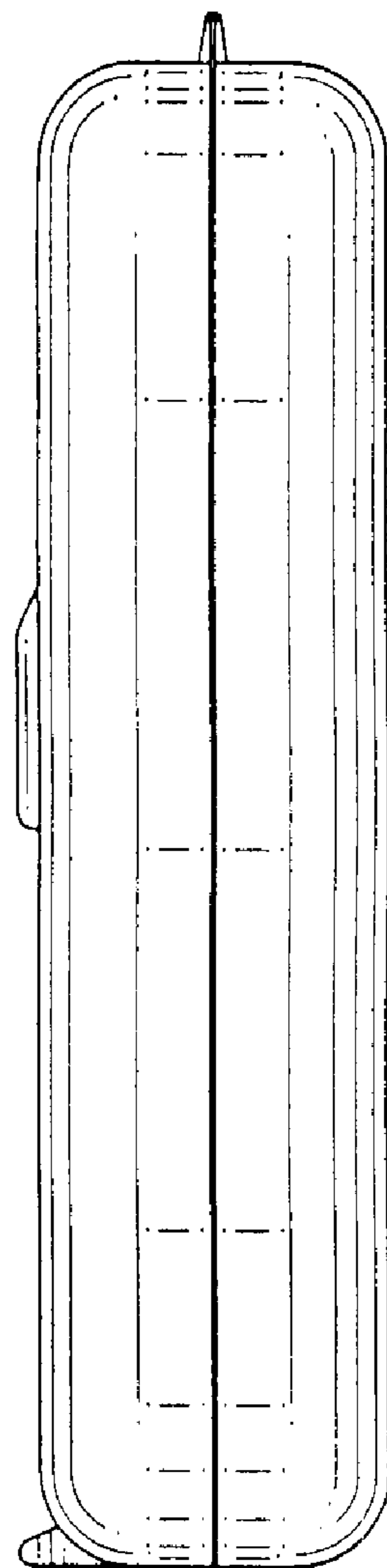

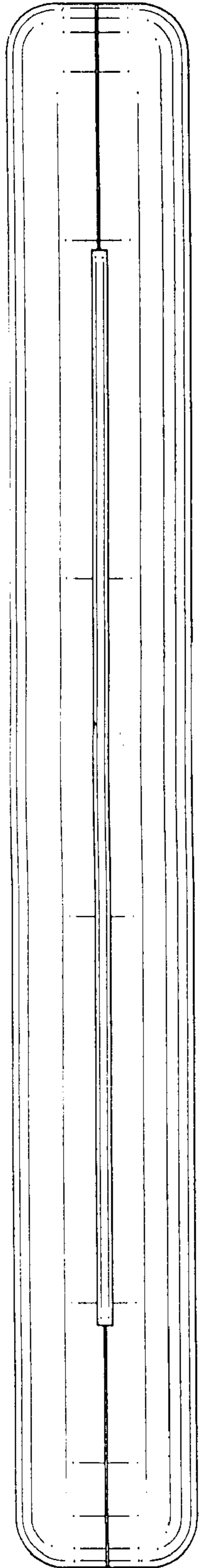

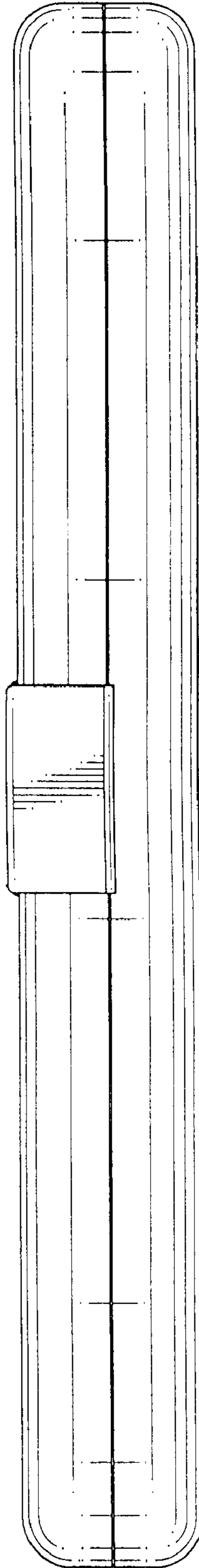

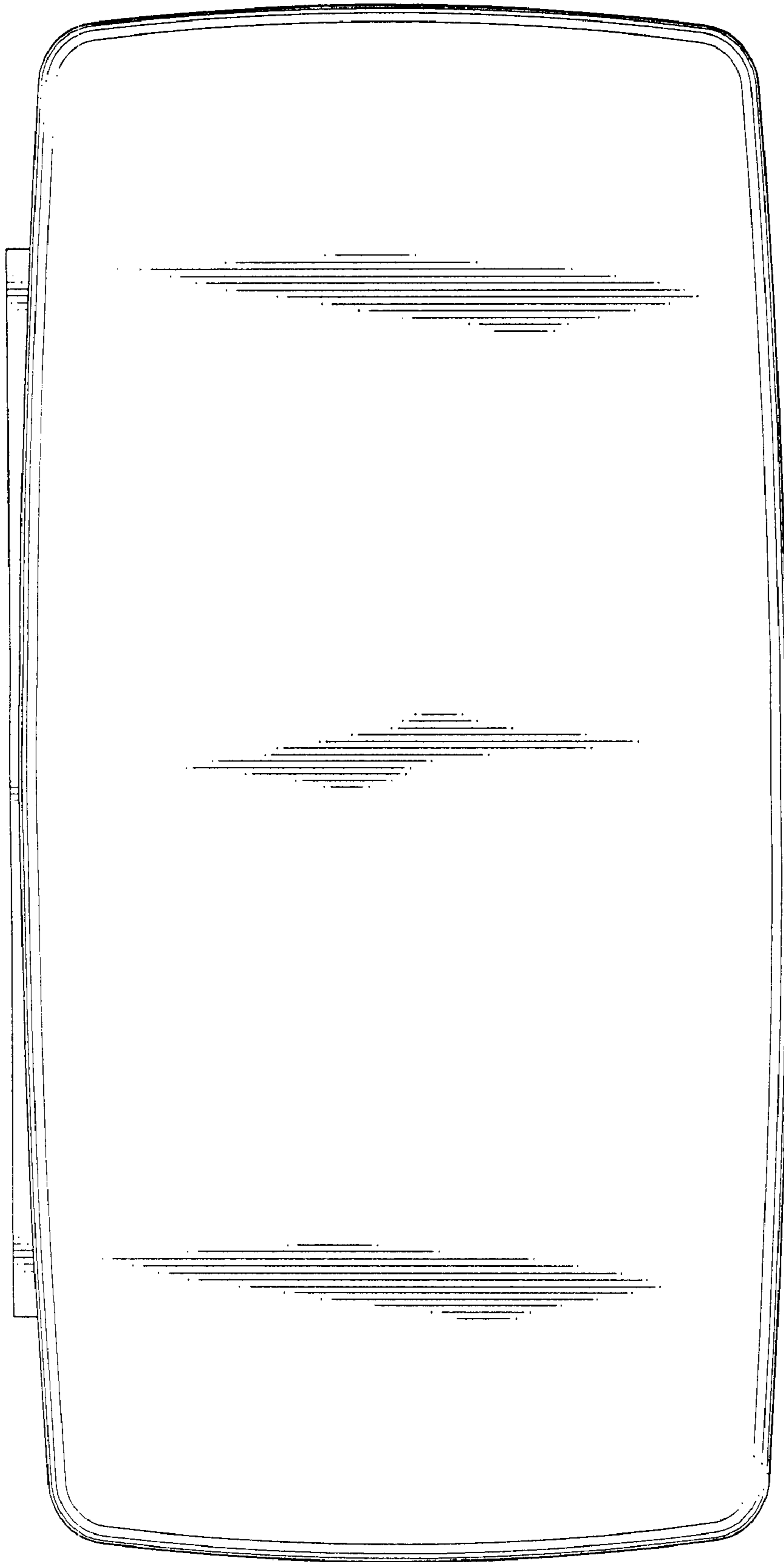
