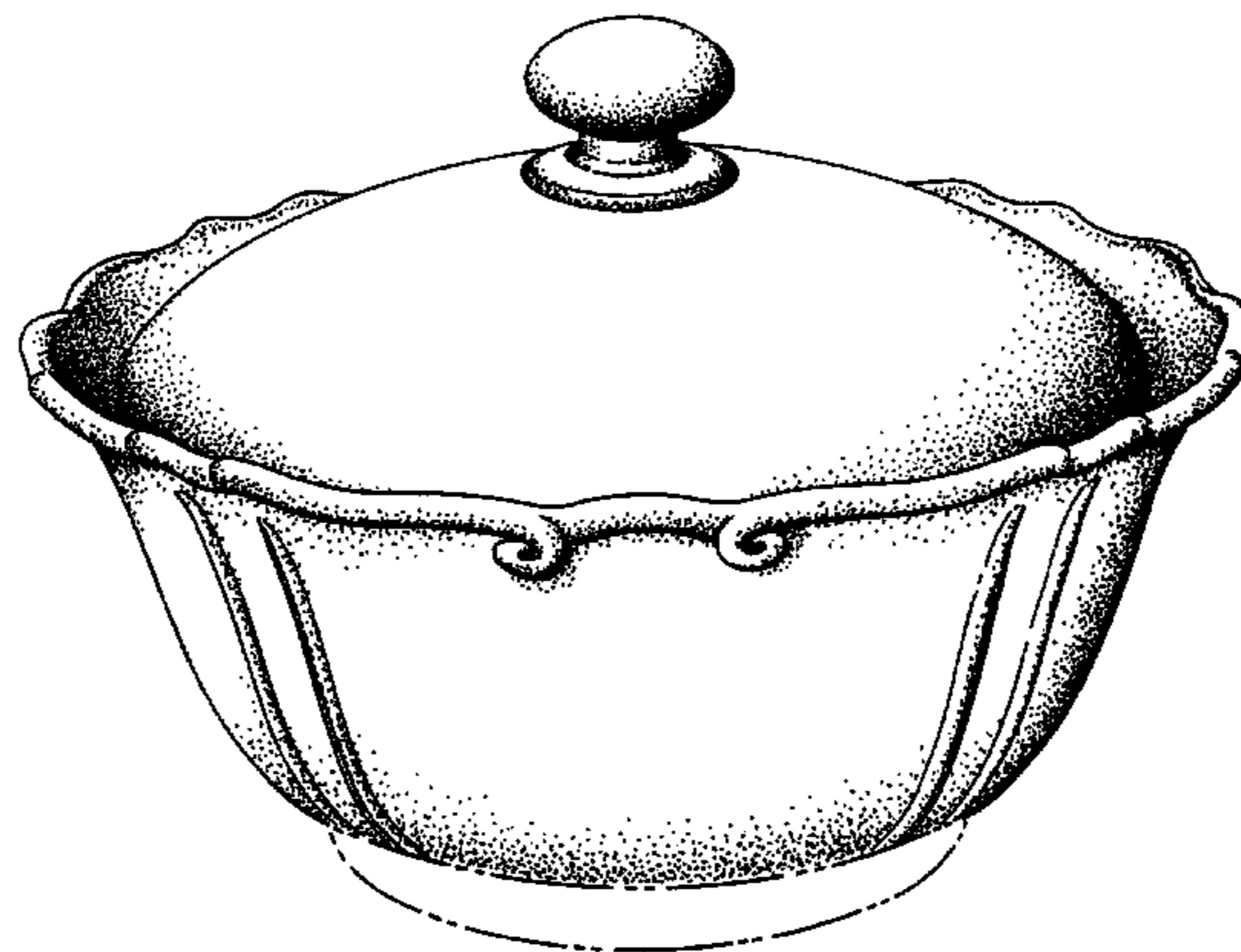
(57) **CLAIM**

I claim the ornamental design for a covered casserole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a covered casserole according to the new design;
FIG. 2 is a front view of the covered casserole shown in FIG. 1, the rear view and side elevation views being substantially identical thereto;
FIG. 3 is a top view of the covered casserole shown in FIG. 1; and,
FIG. 4 is a bottom view of the covered casserole shown in FIG. 1. Features shown in broken lines in the drawings are not part of the claim

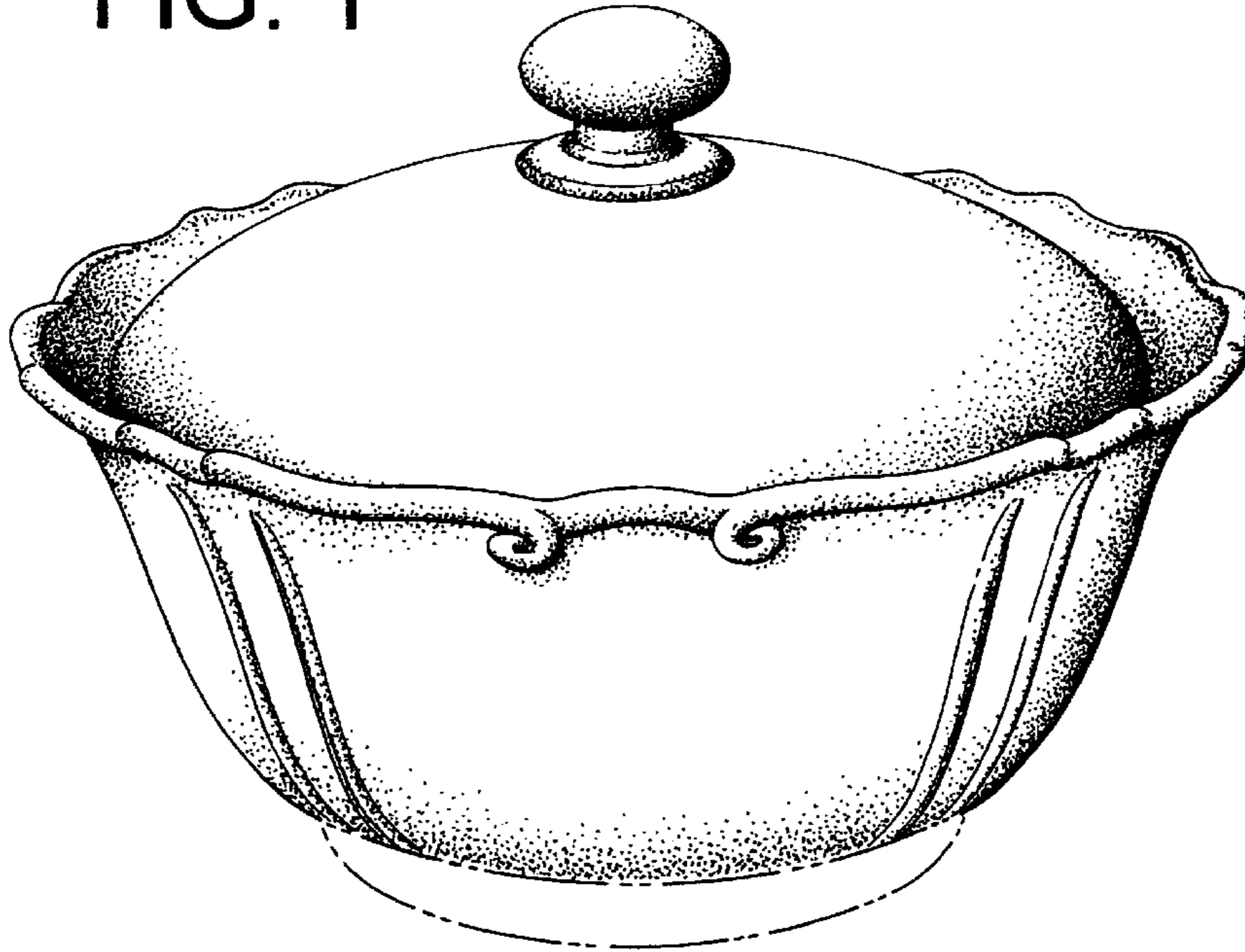

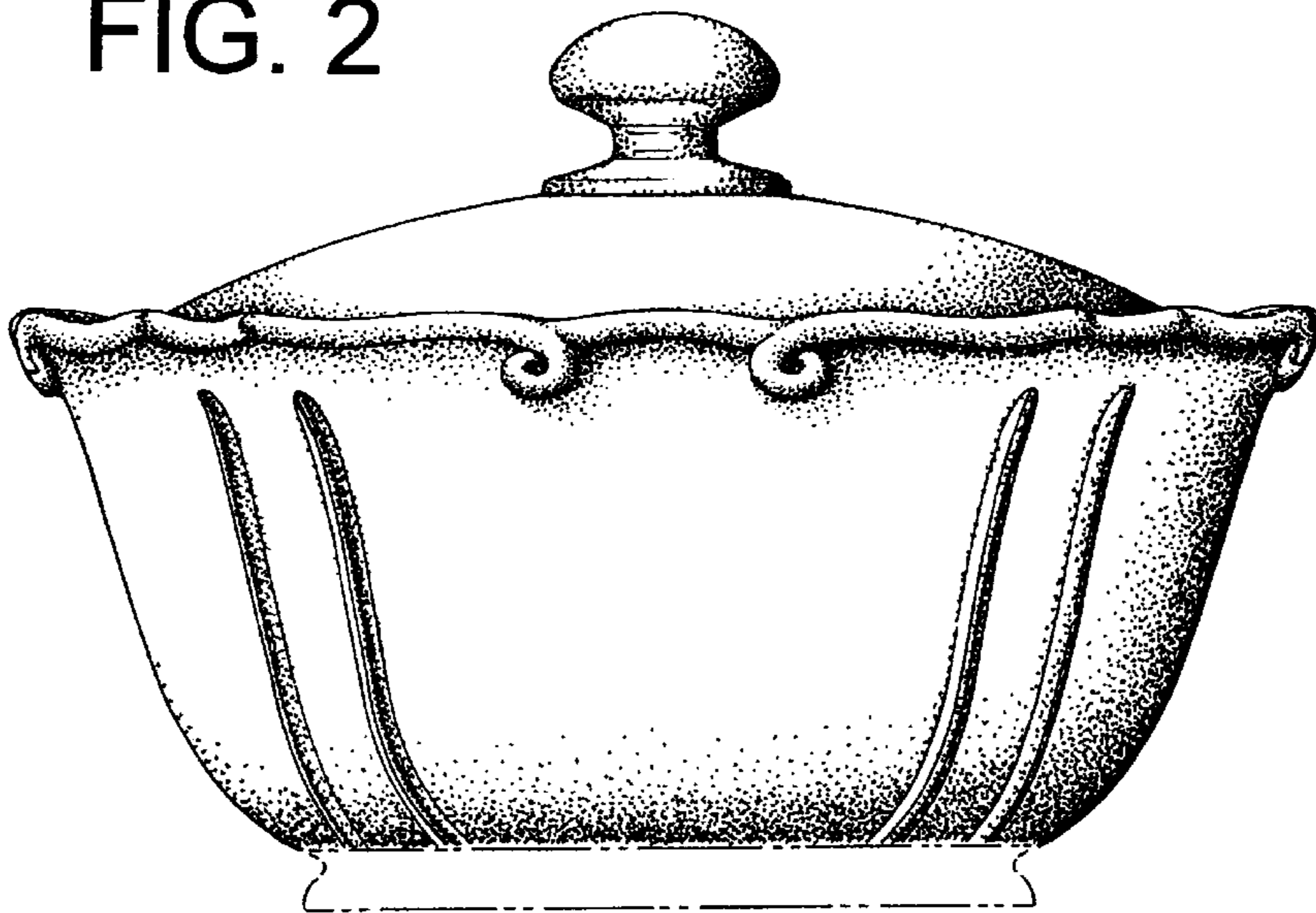

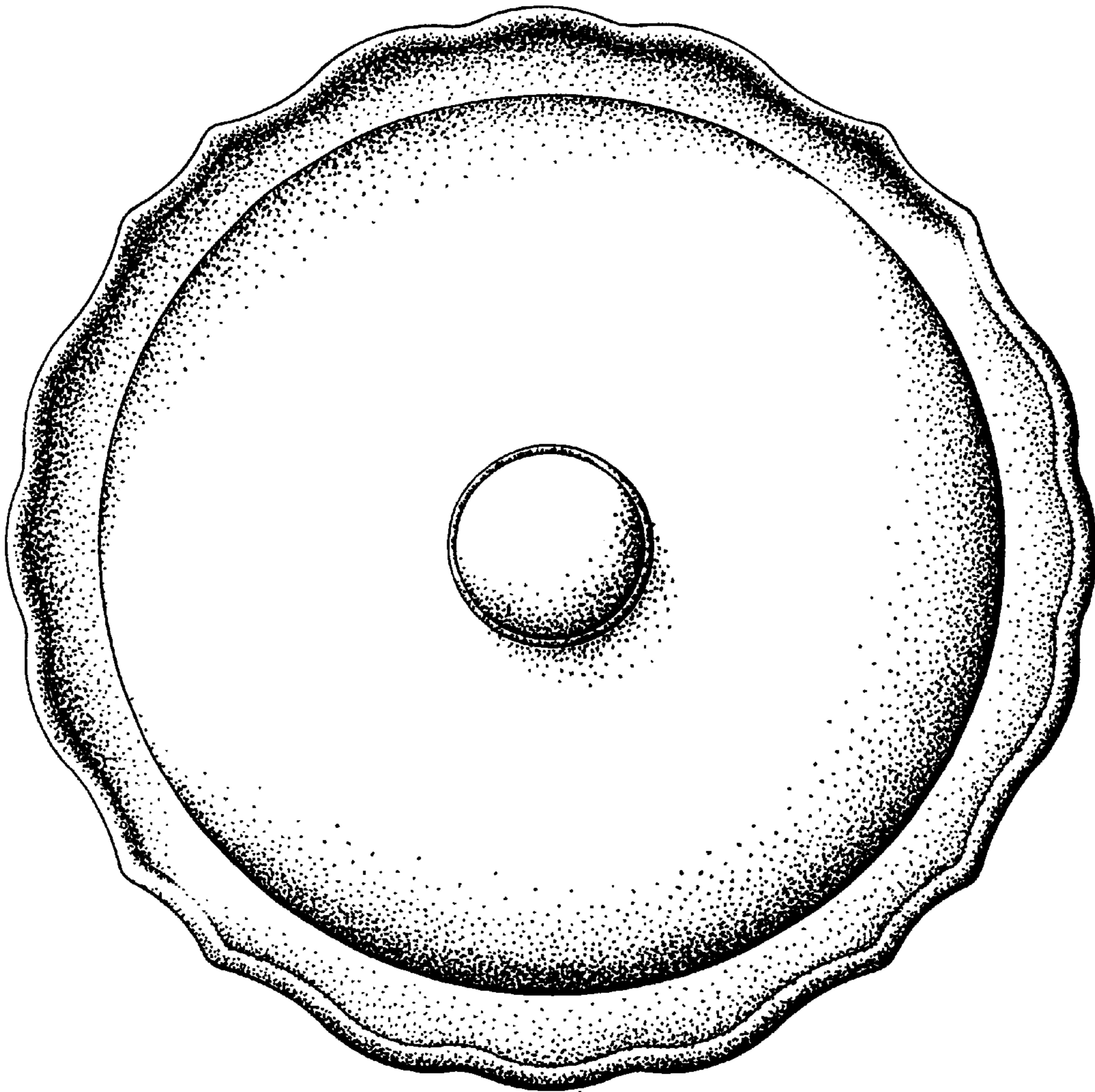
