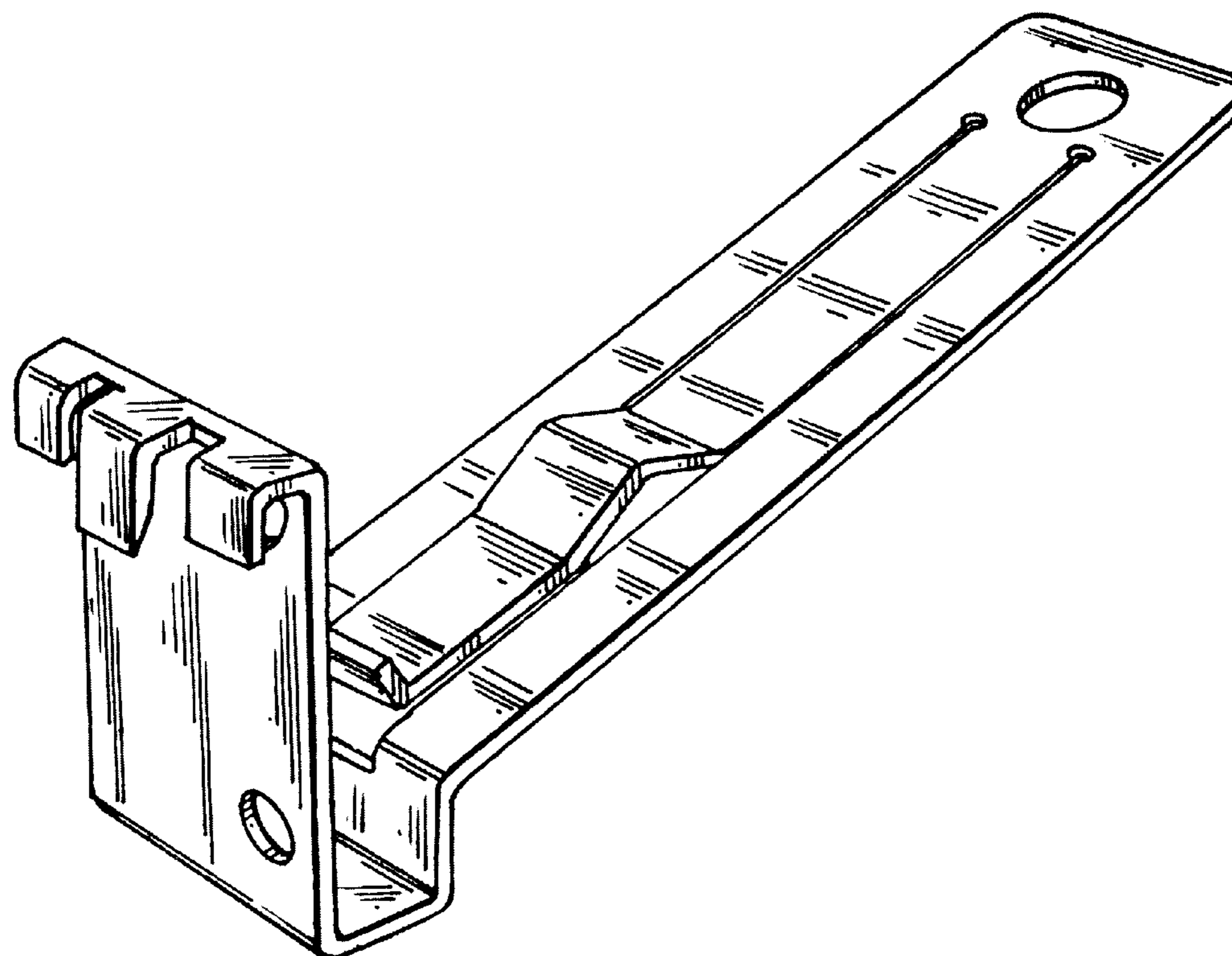
(57) **CLAIM**

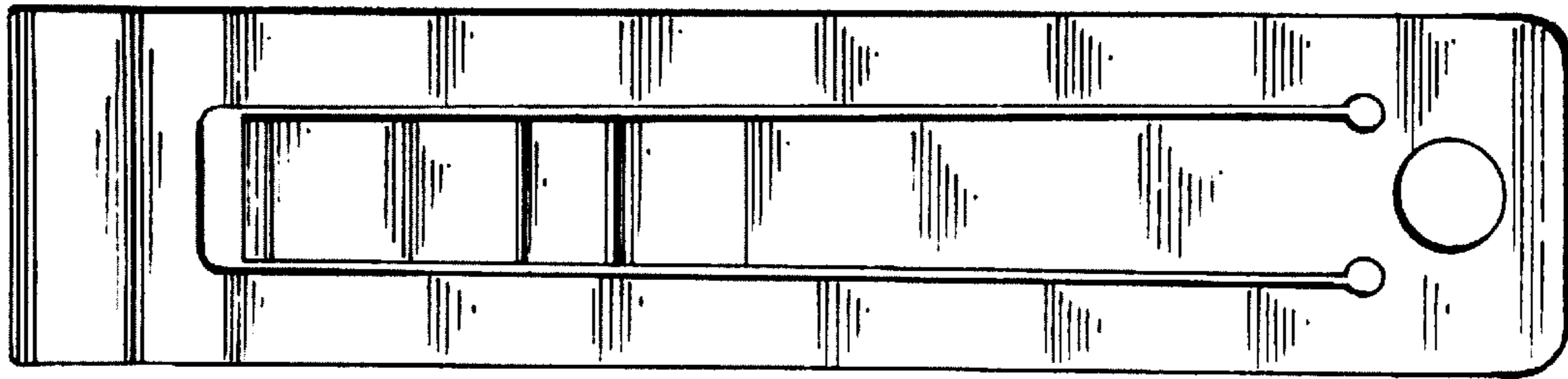
The ornamental design for a fiber cement siding overlap gauge, as shown and described.

**DESCRIPTION**

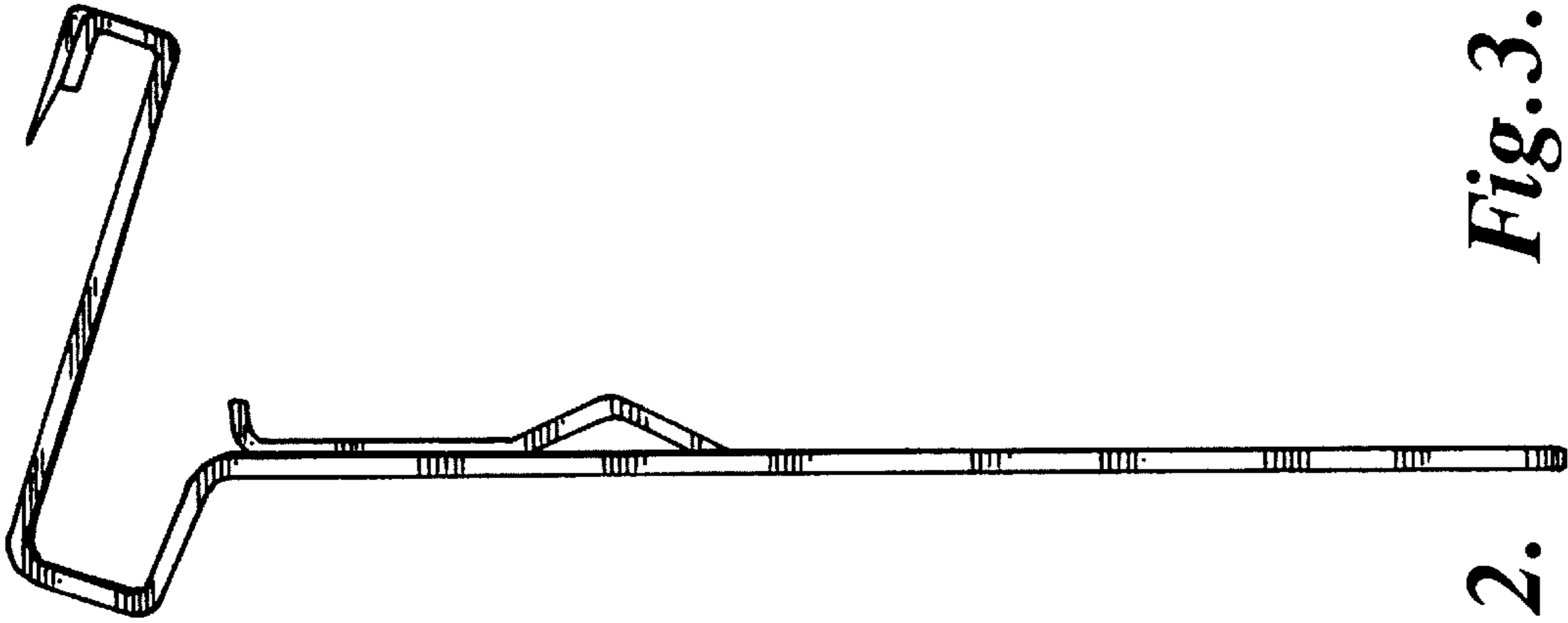
FIG. 1 is a perspective view showing my new design for a fiber cement siding overlap gauge;

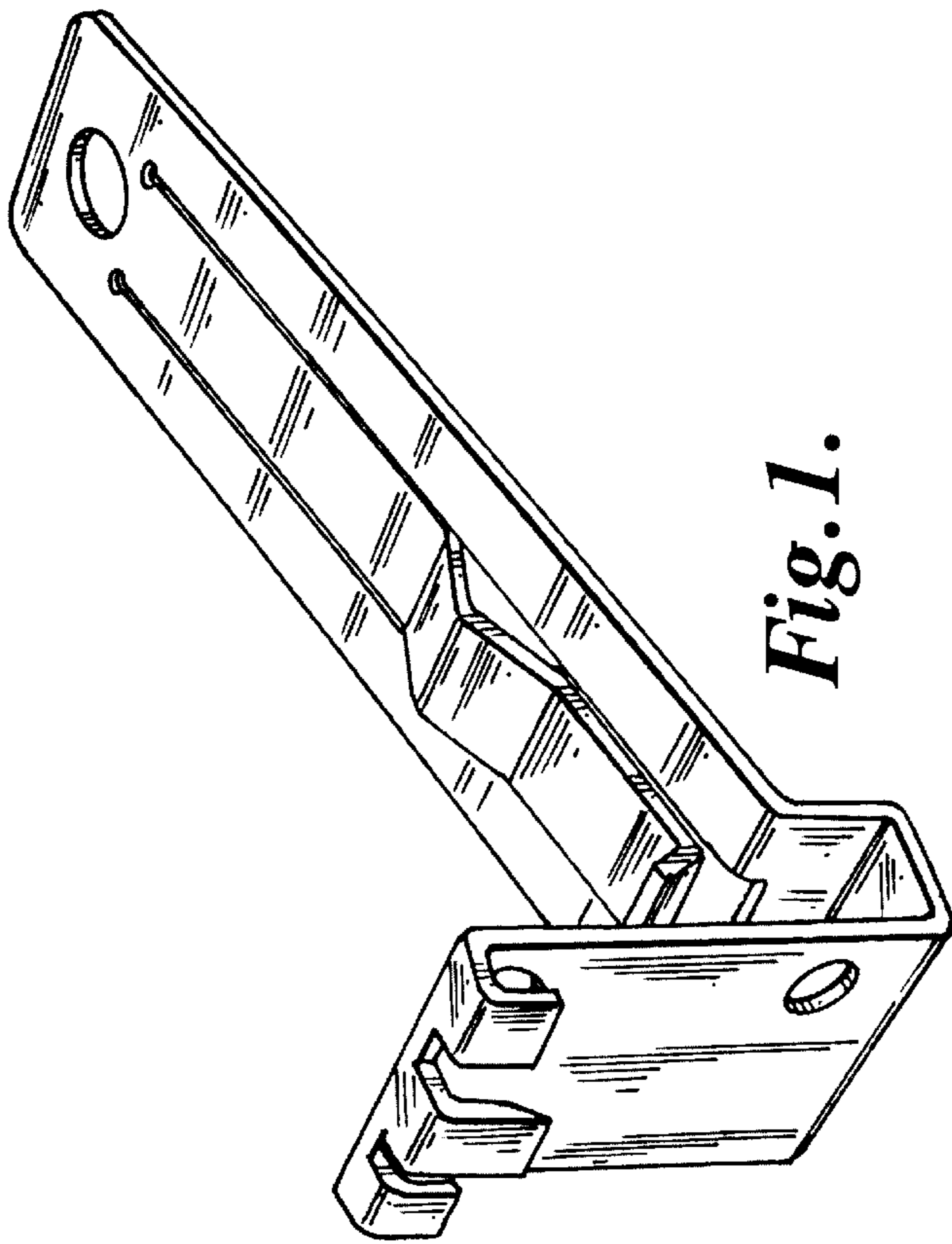




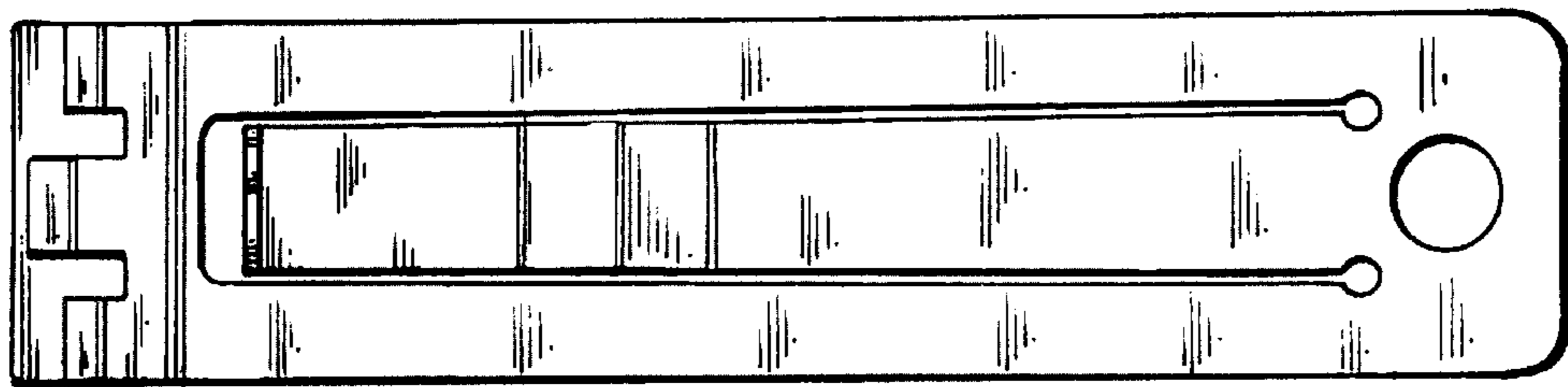

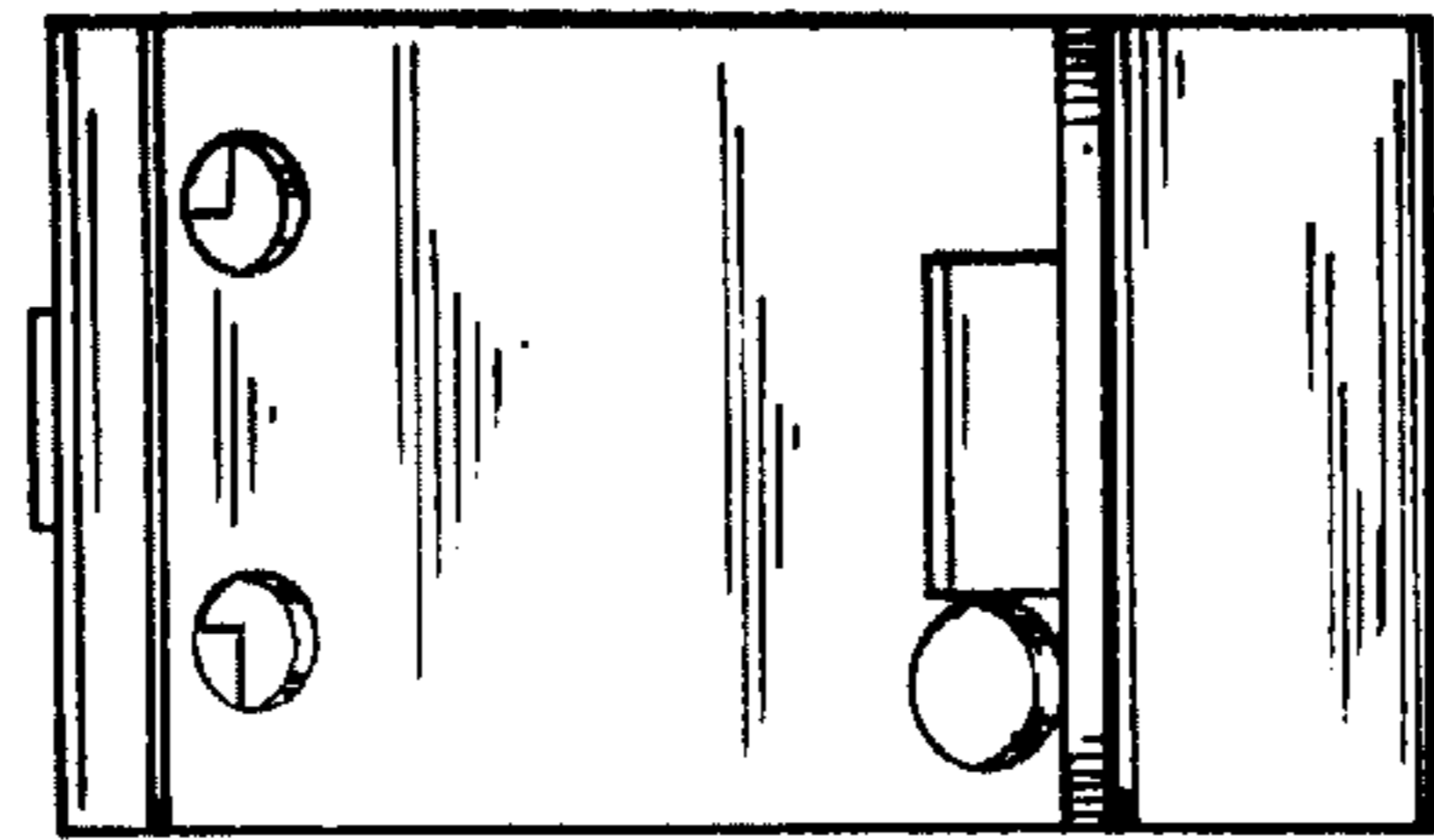

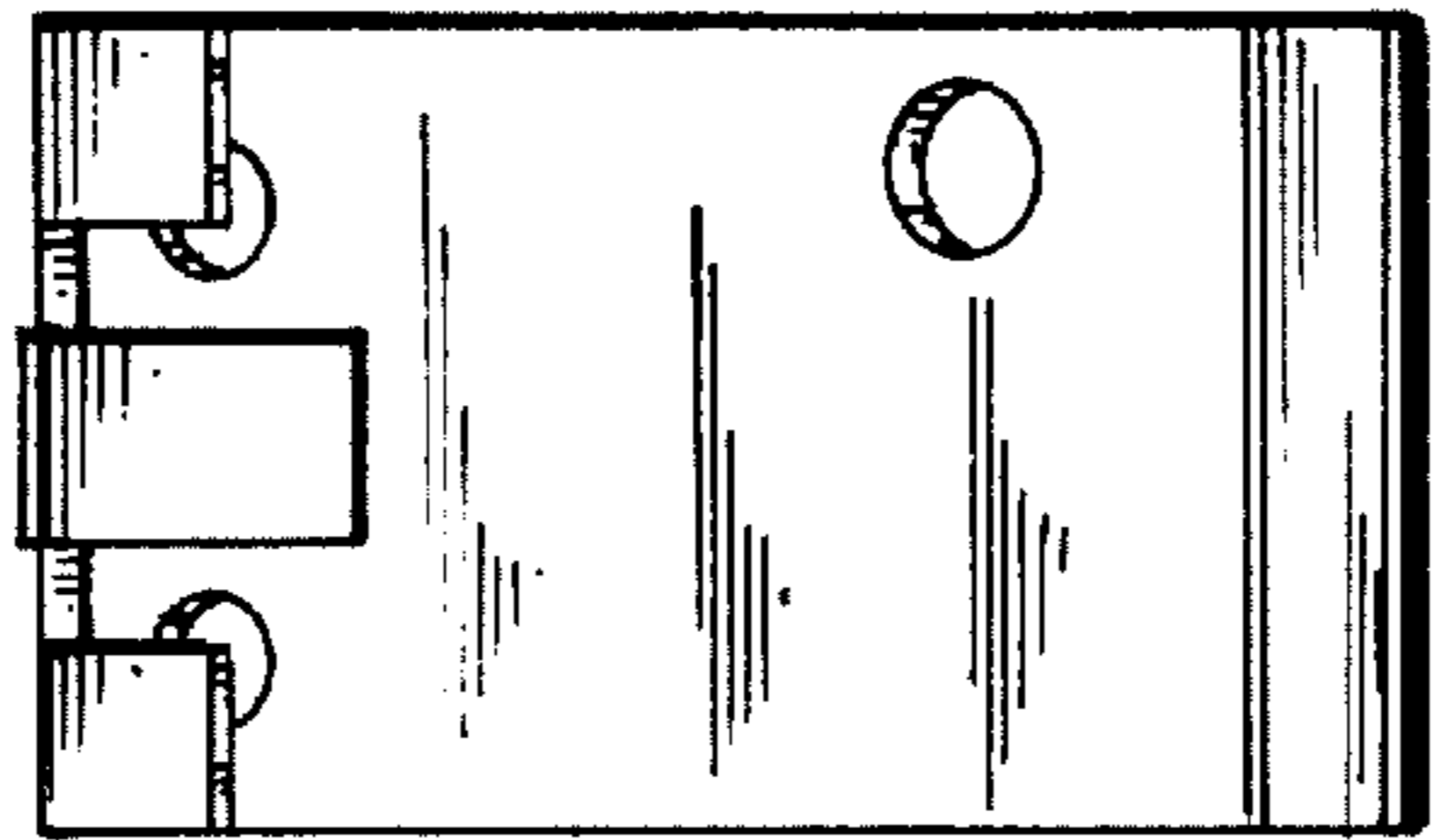
