(57) **CLAIM**

The ornamental design for a ribbon carabiner, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a ribbon carabiner of the present invention showing my new design, the rear elevational view being a mirror image thereof;

FIG. 2 is a left side elevational view of the ribbon carabiner of FIG. 1;

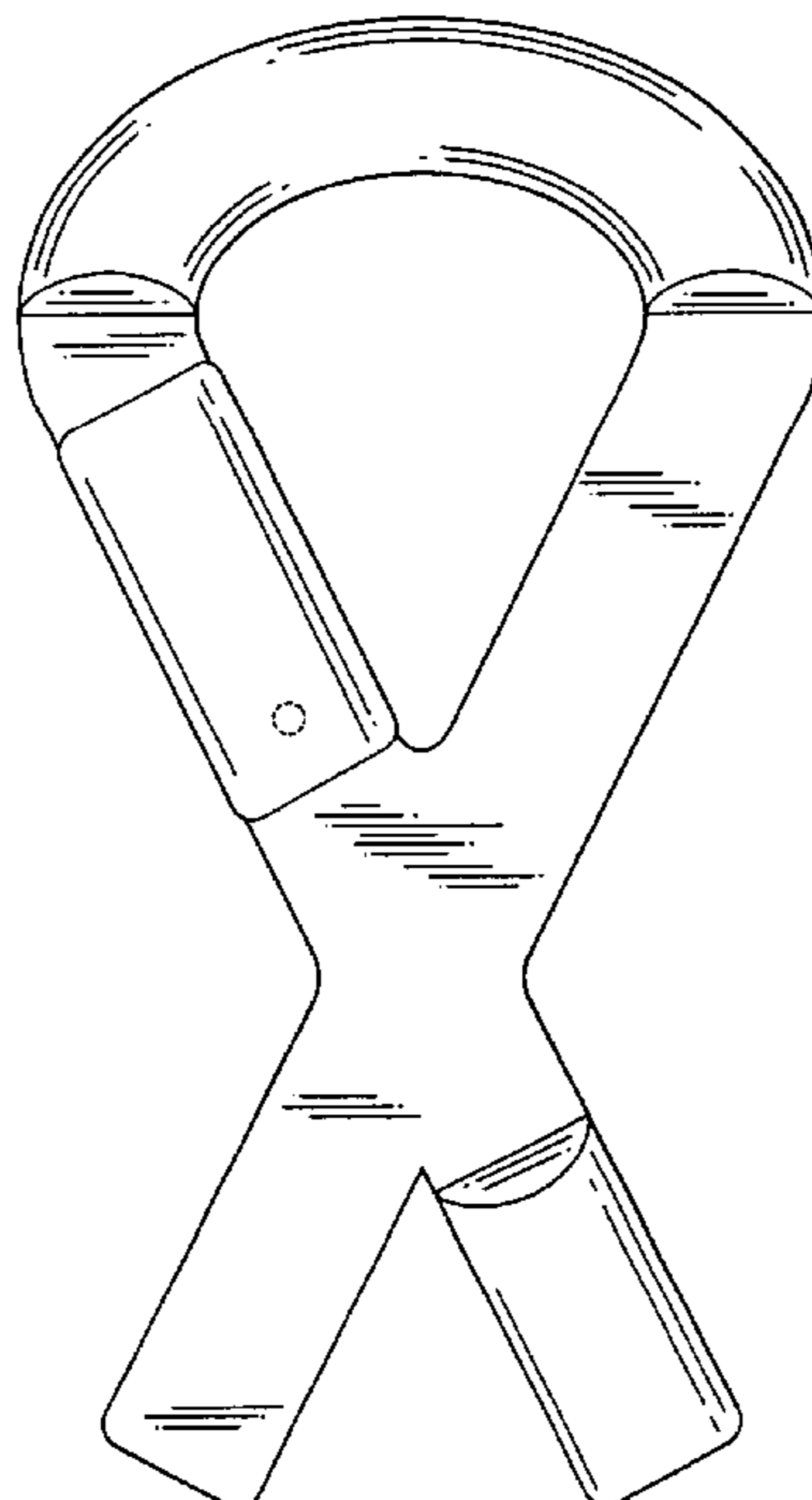
FIG. 3 is a right side elevational view of the ribbon carabiner of FIG. 1;

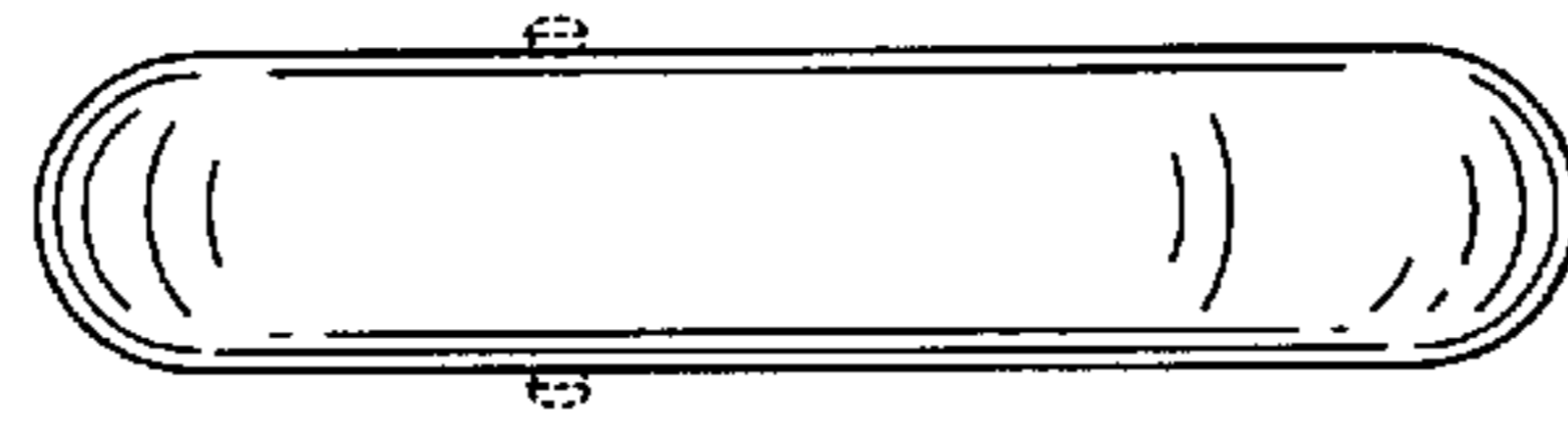

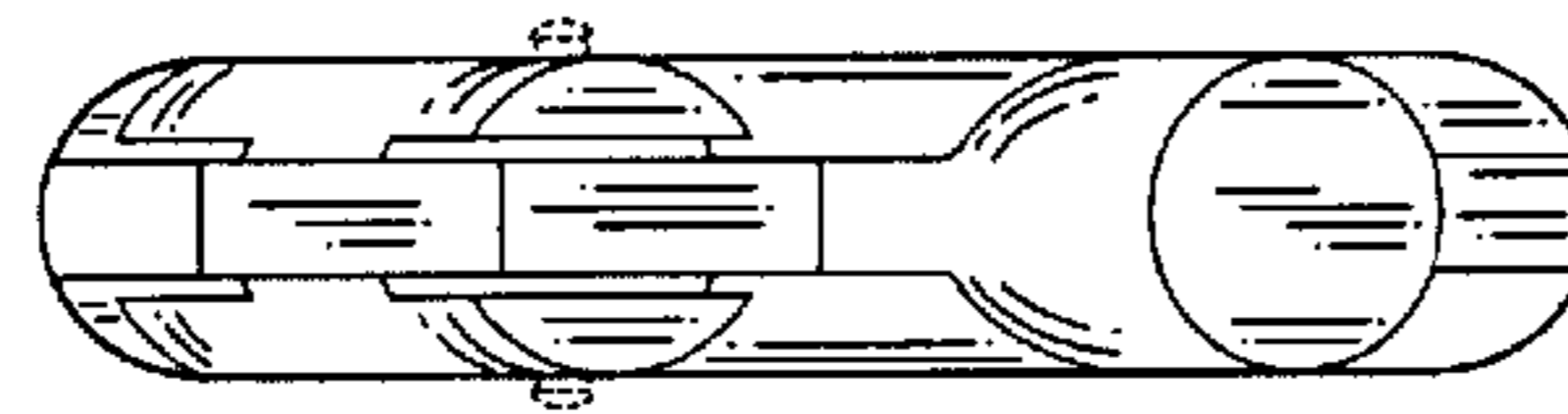

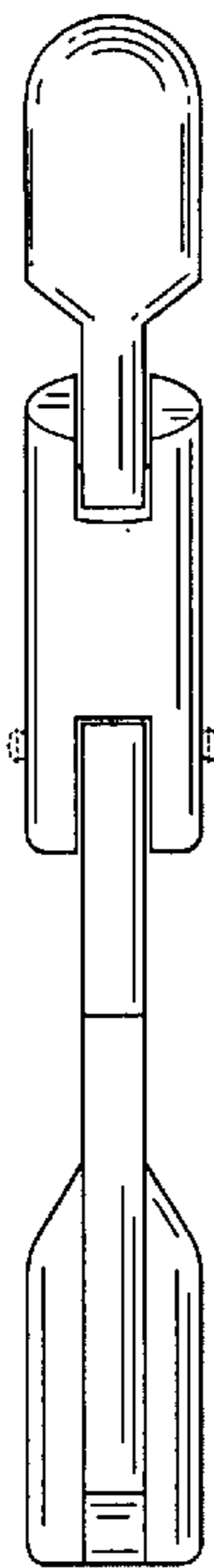

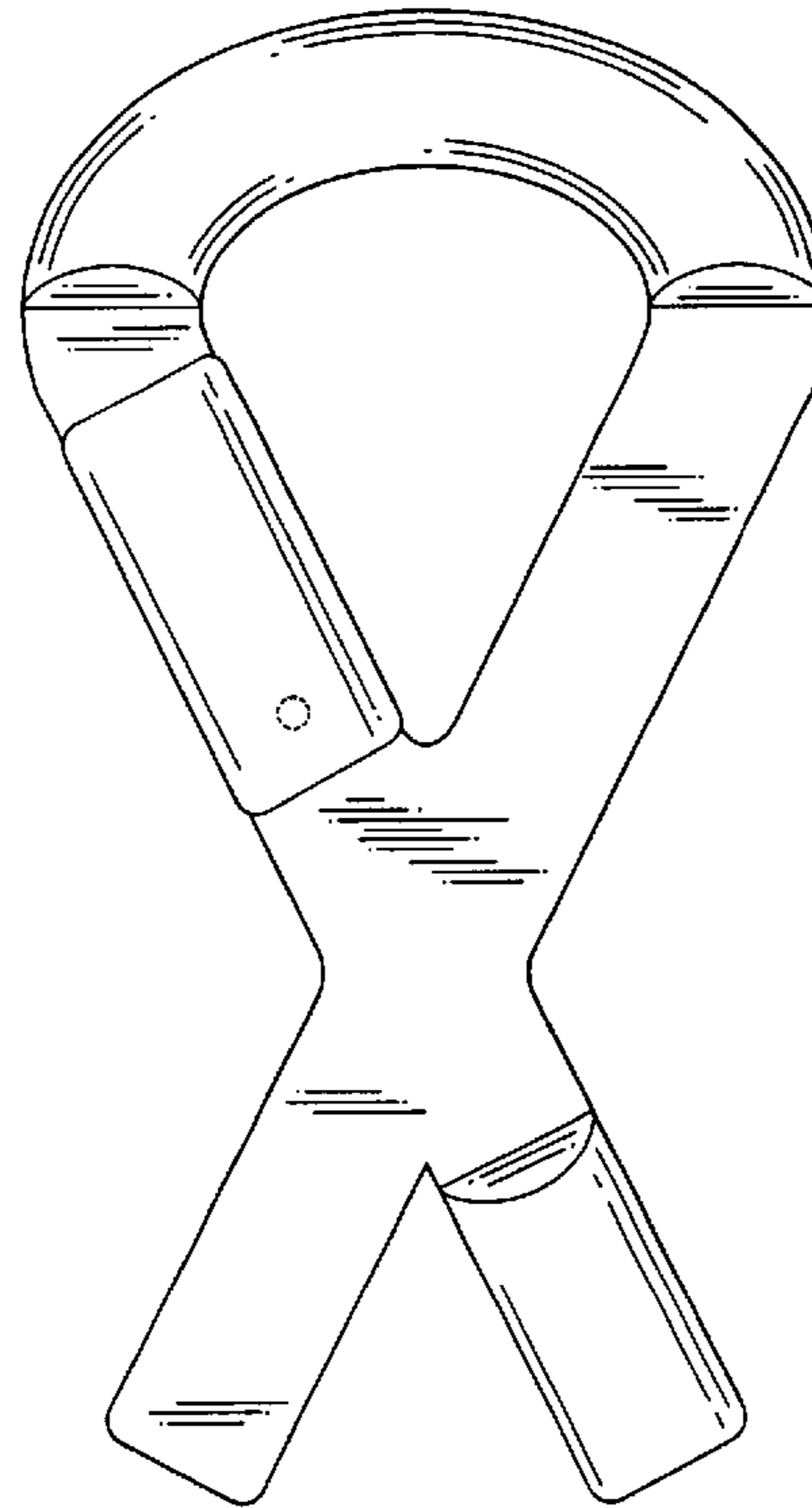

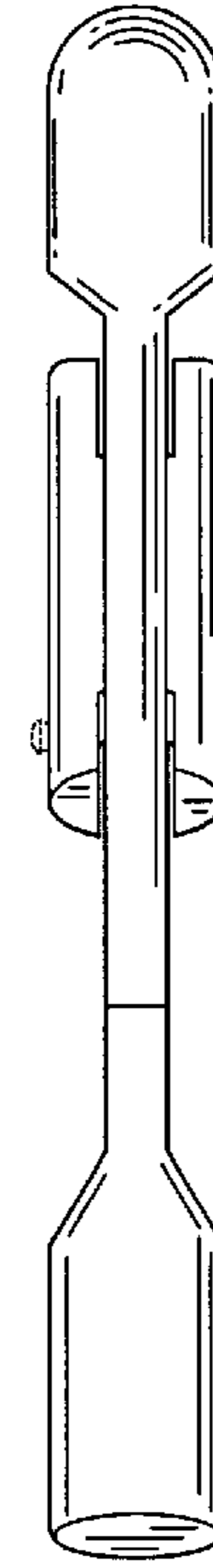
