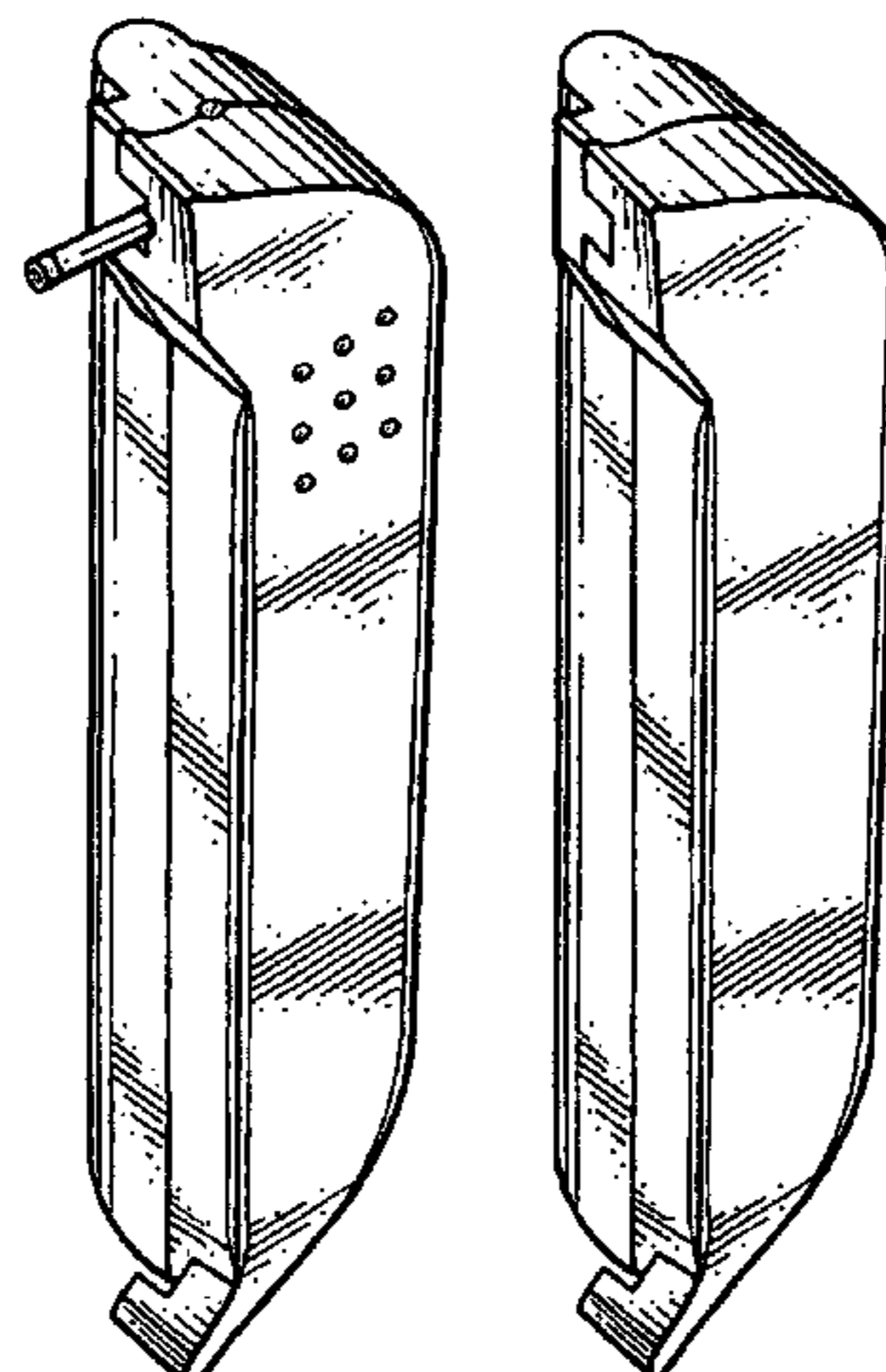
(57) **CLAIM**

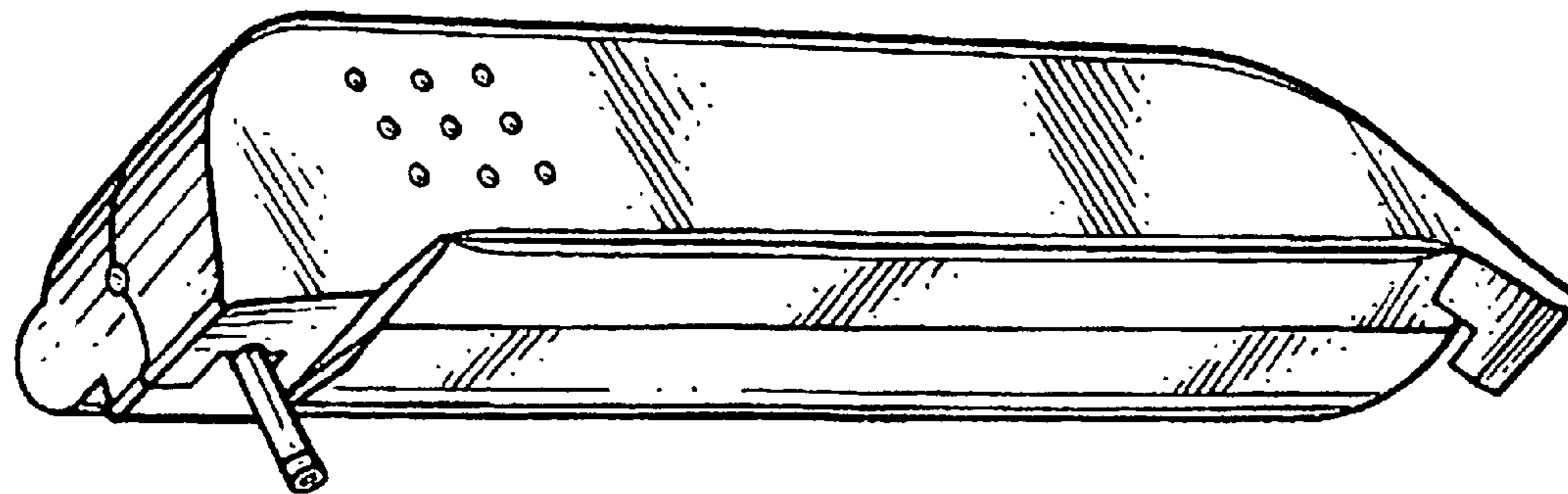

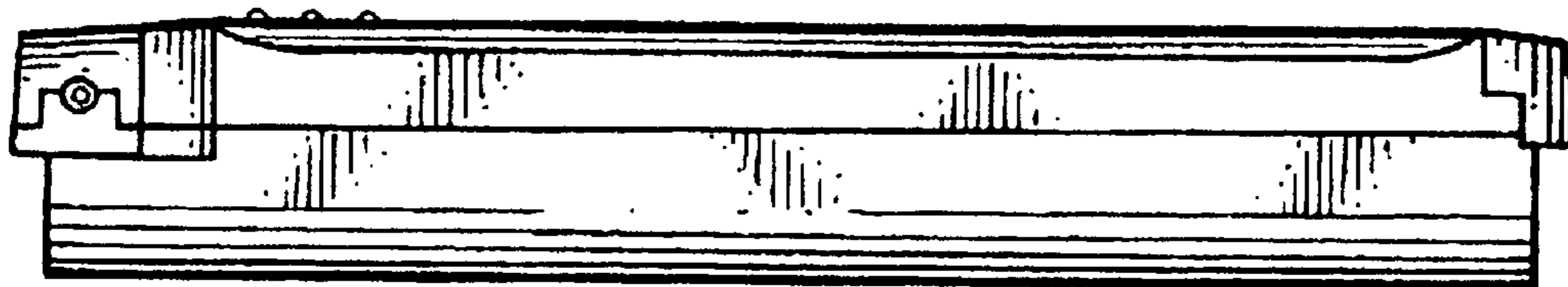

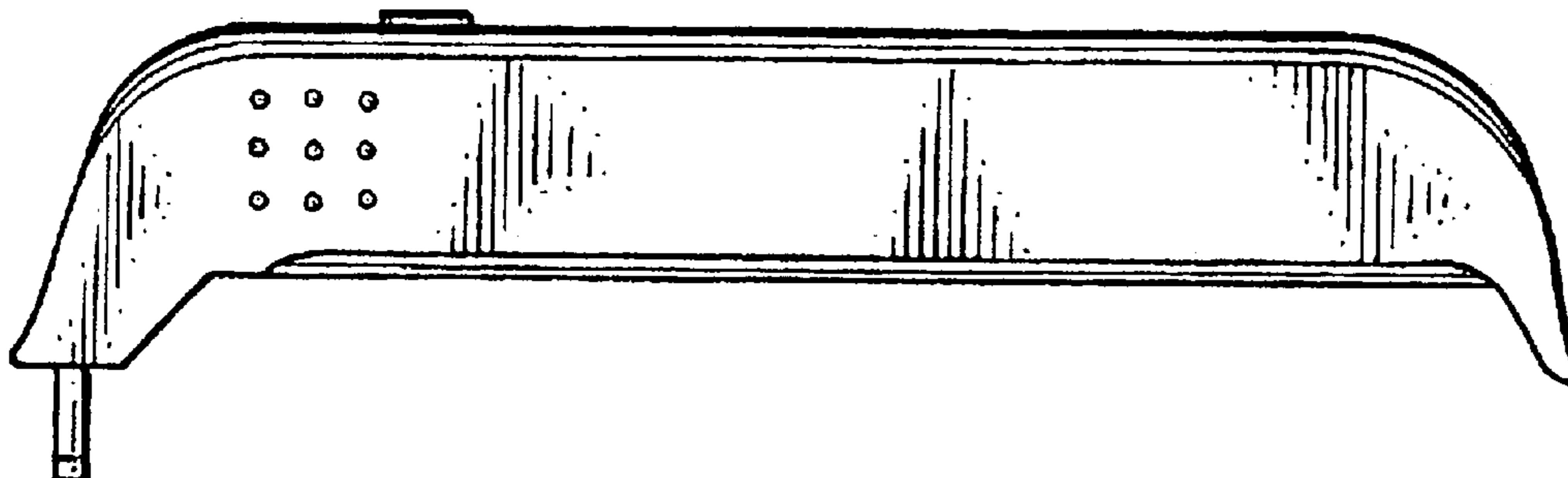

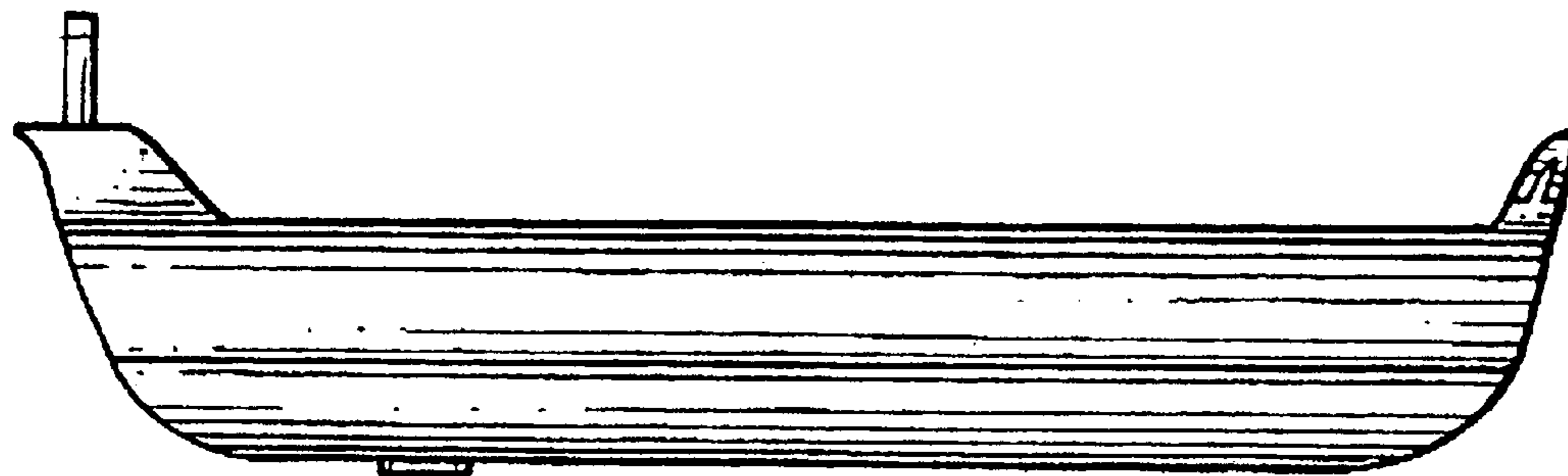

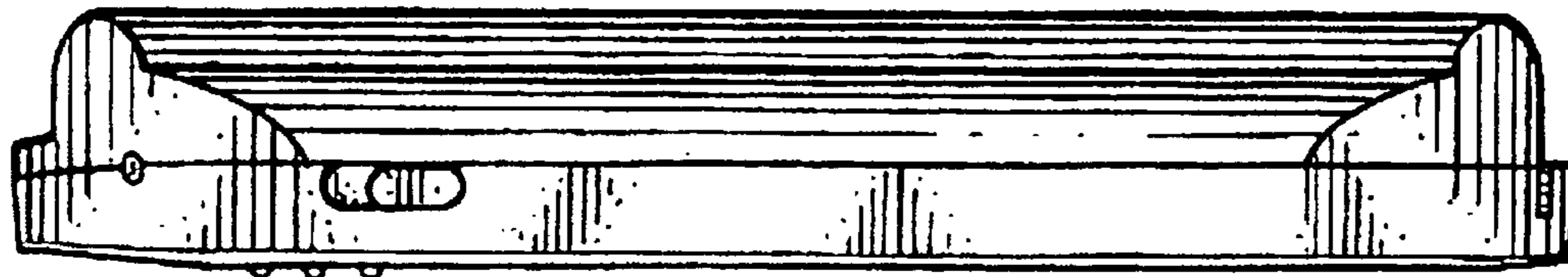

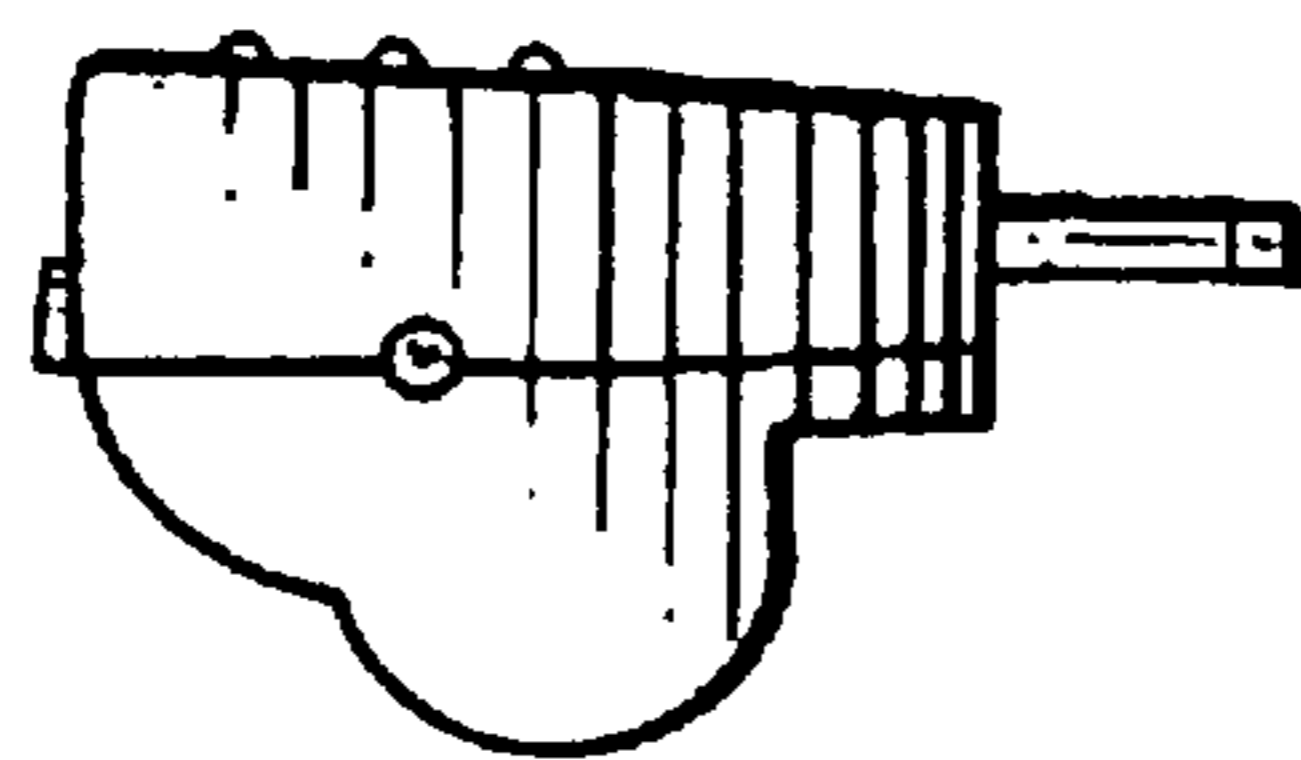

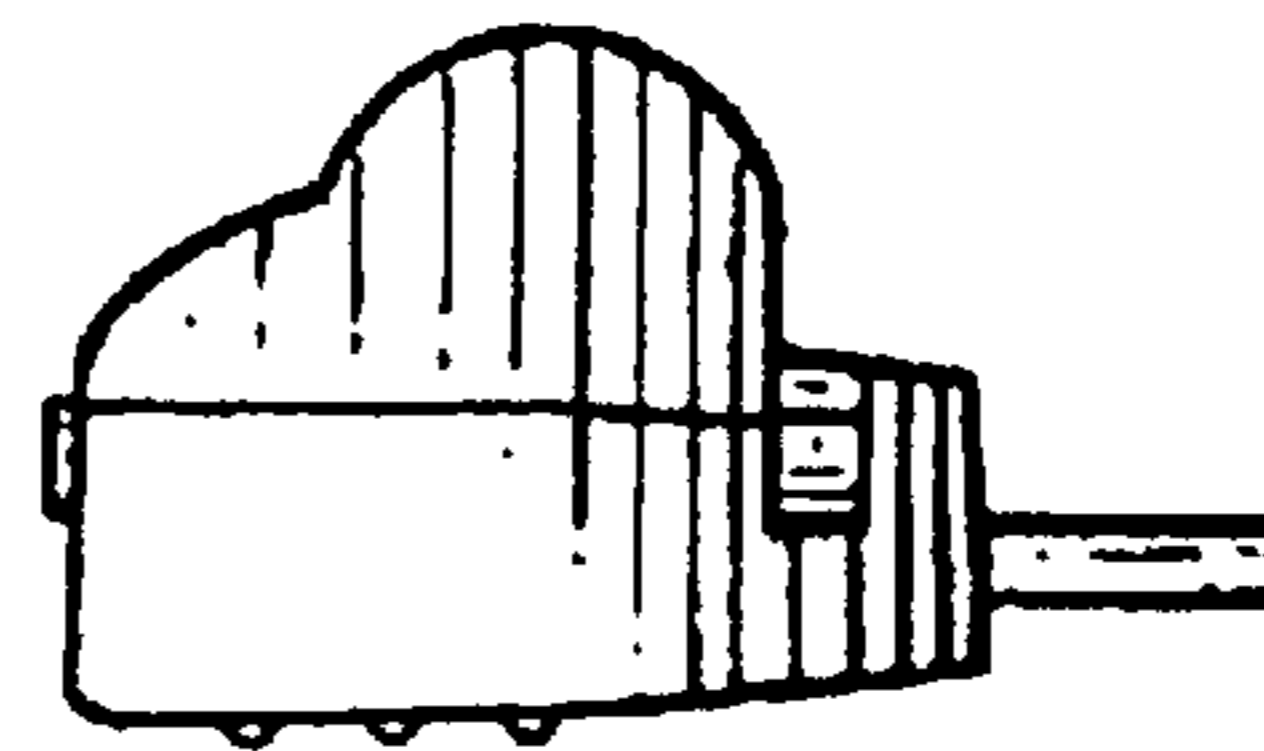

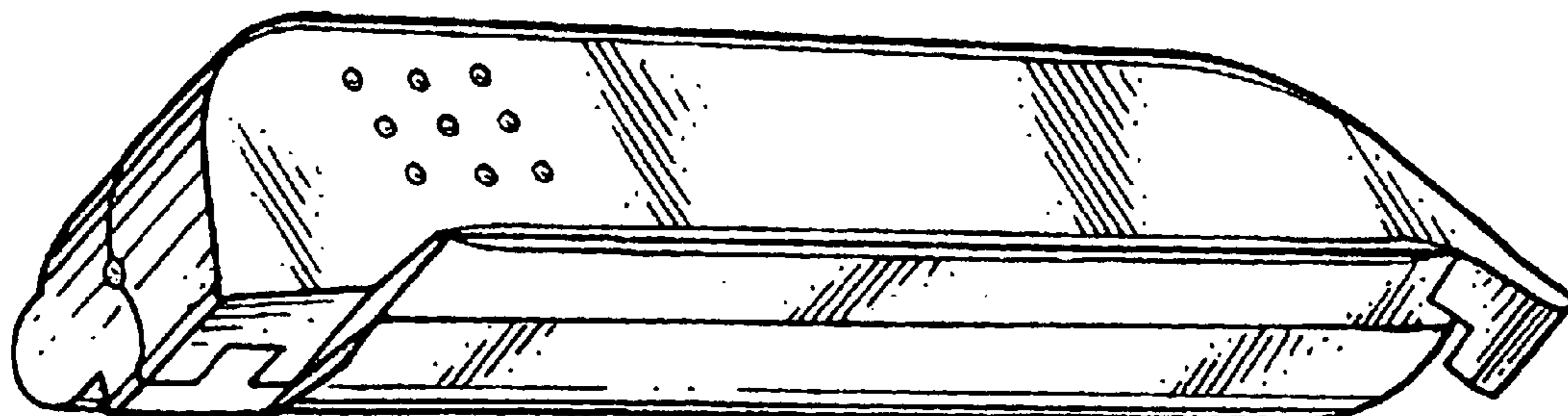

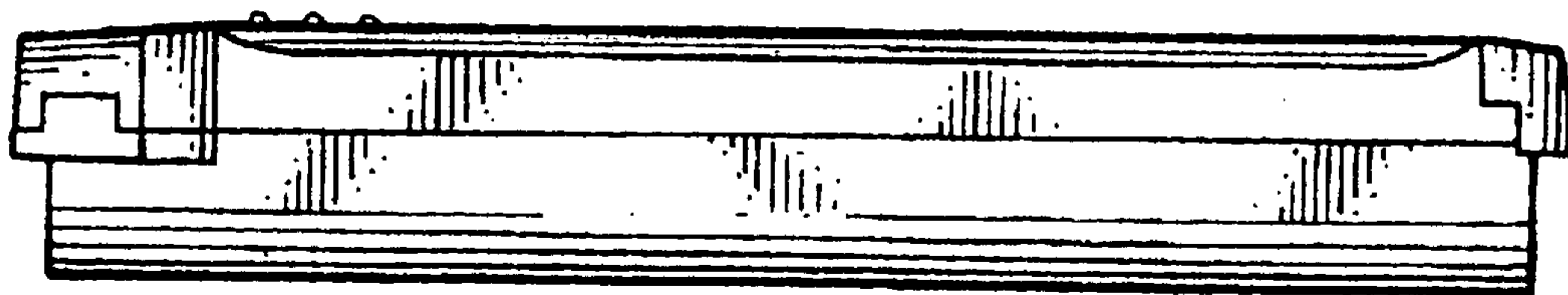

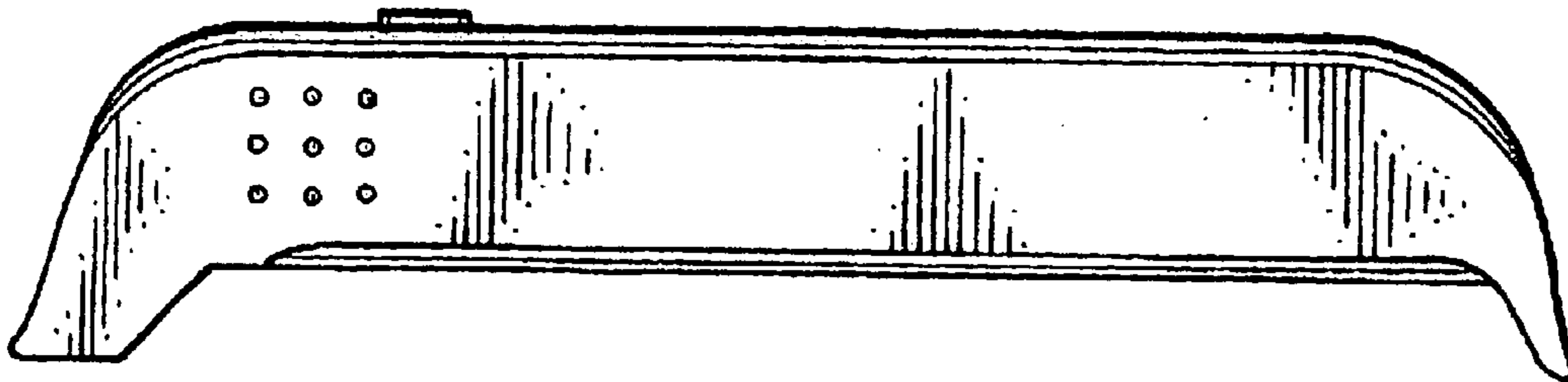

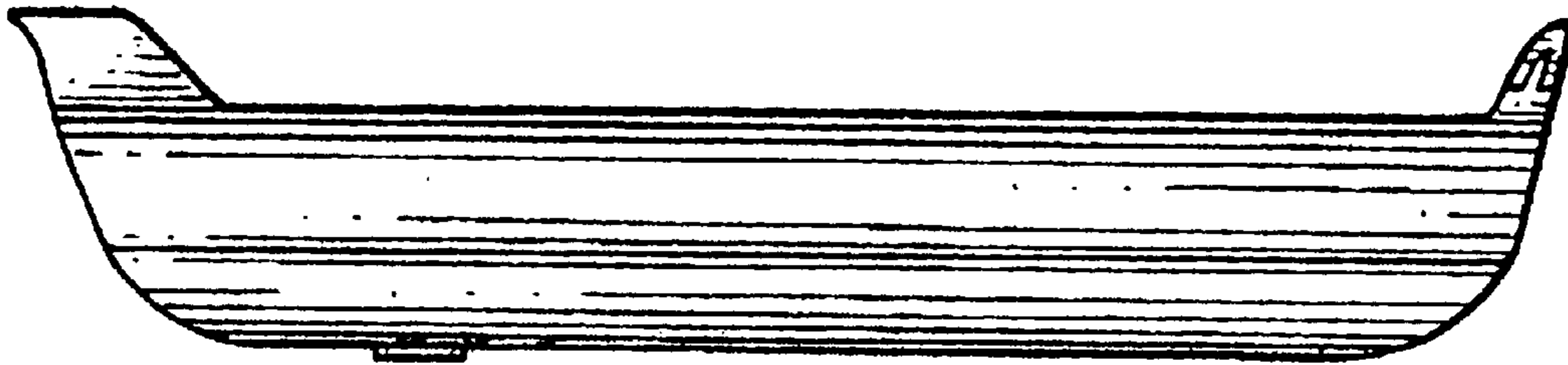

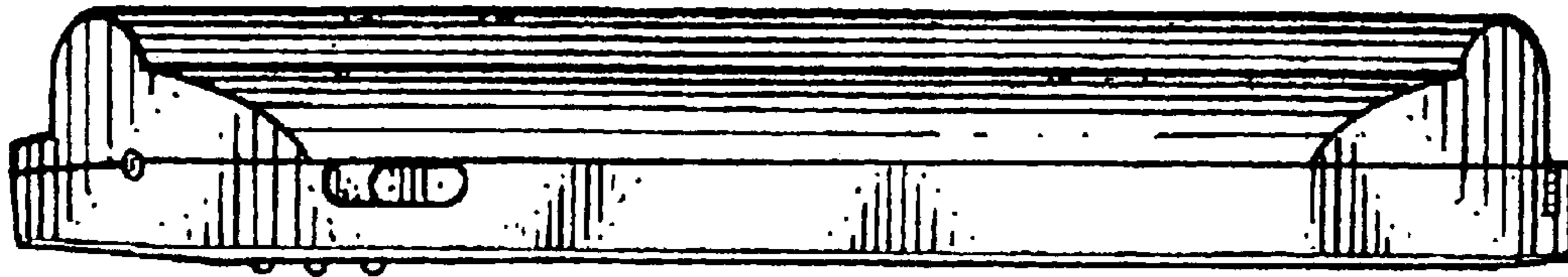

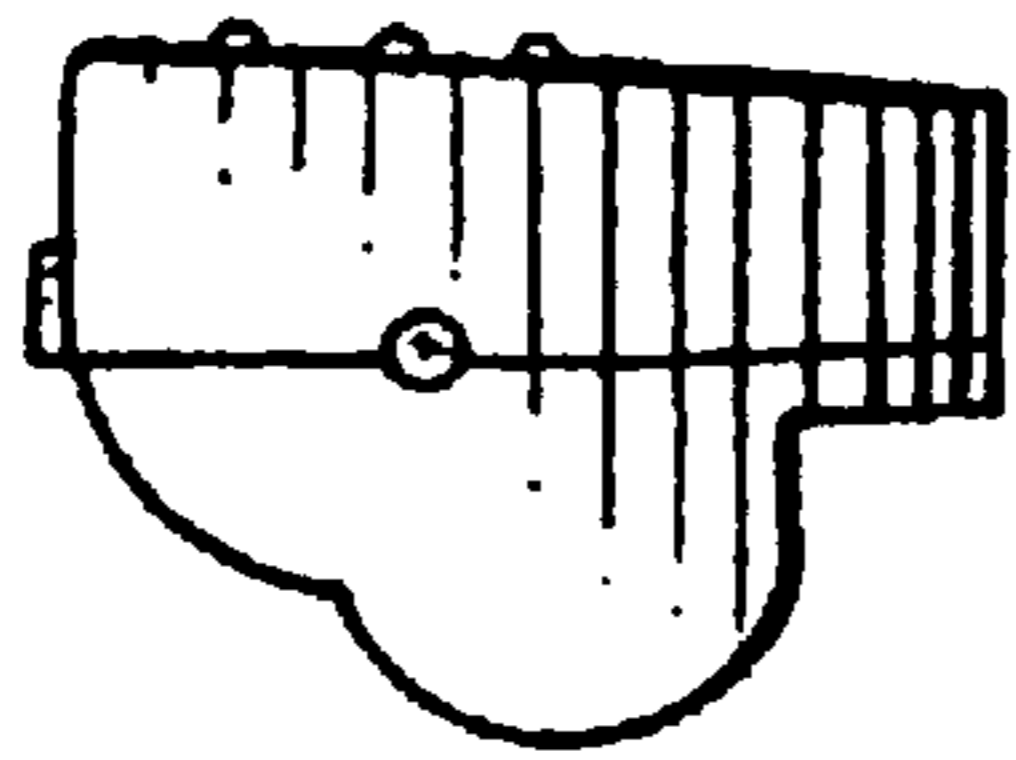

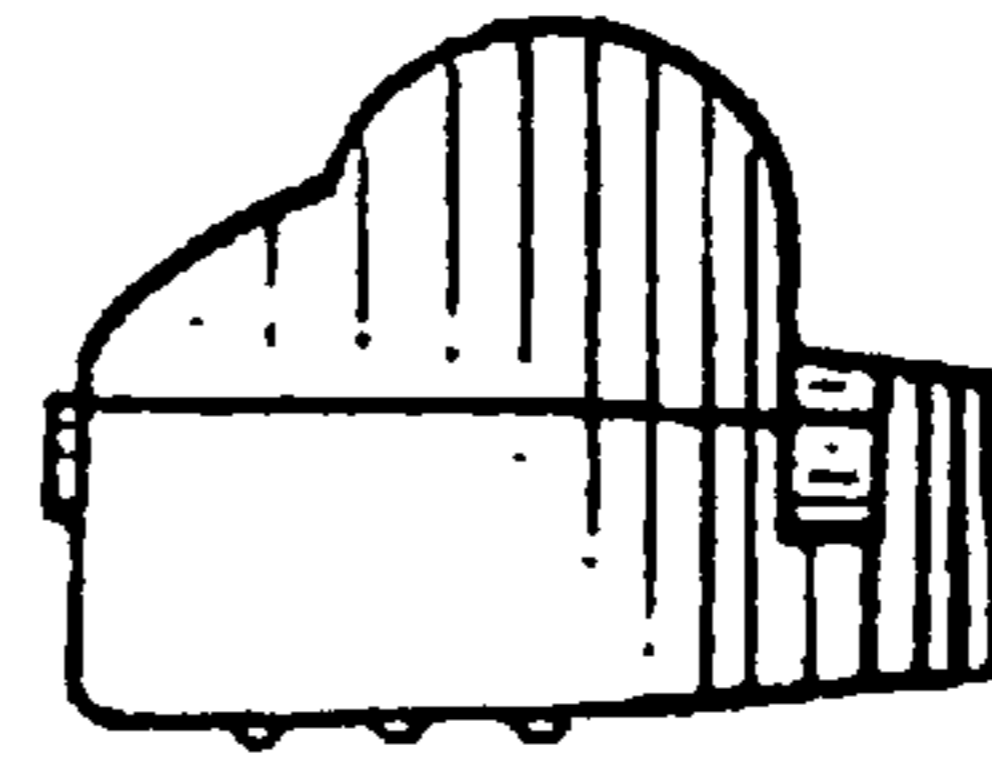

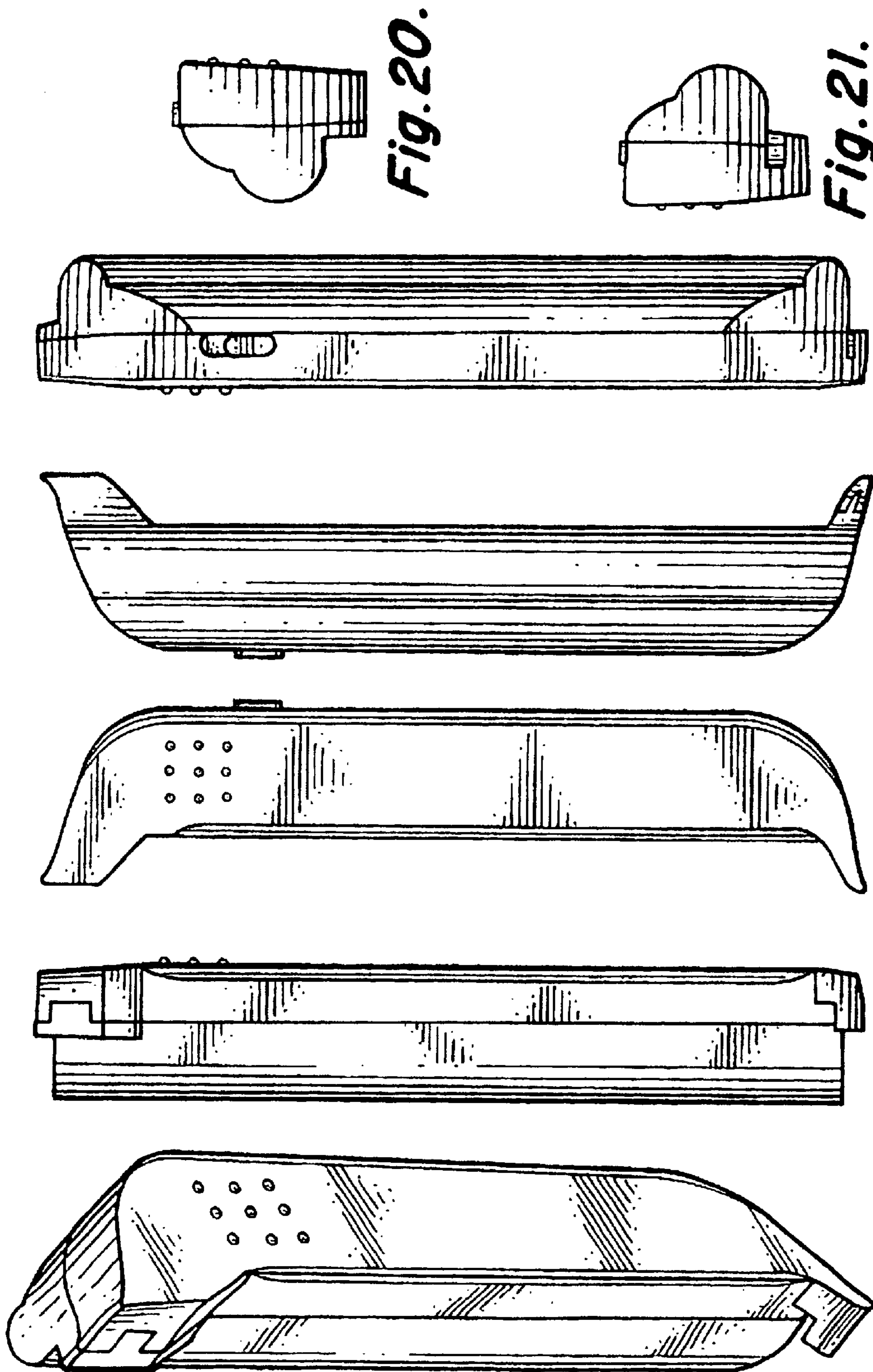

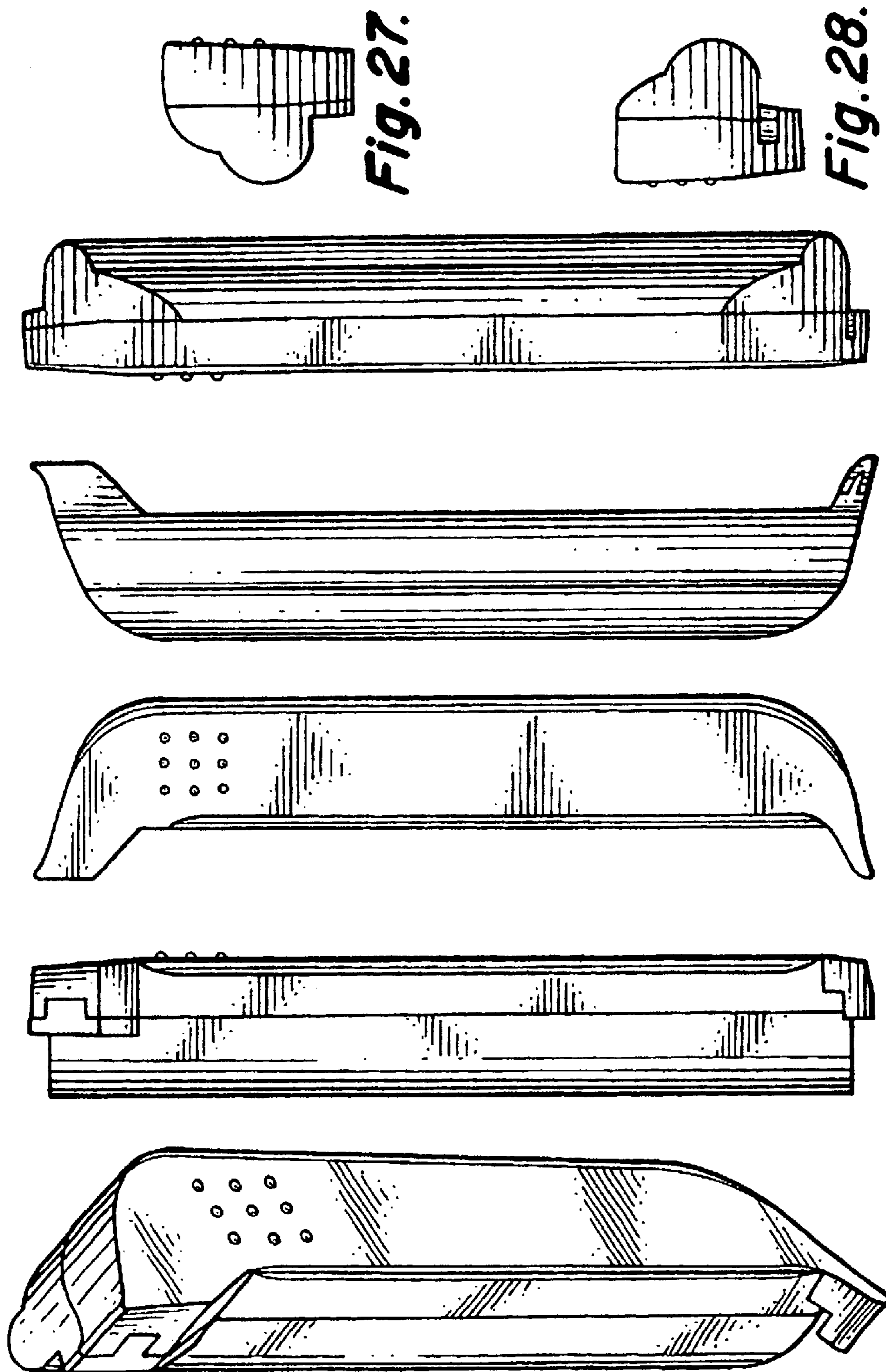


Fig. 22. Fig. 23. Fig. 24. Fig. 25. Fig. 26.

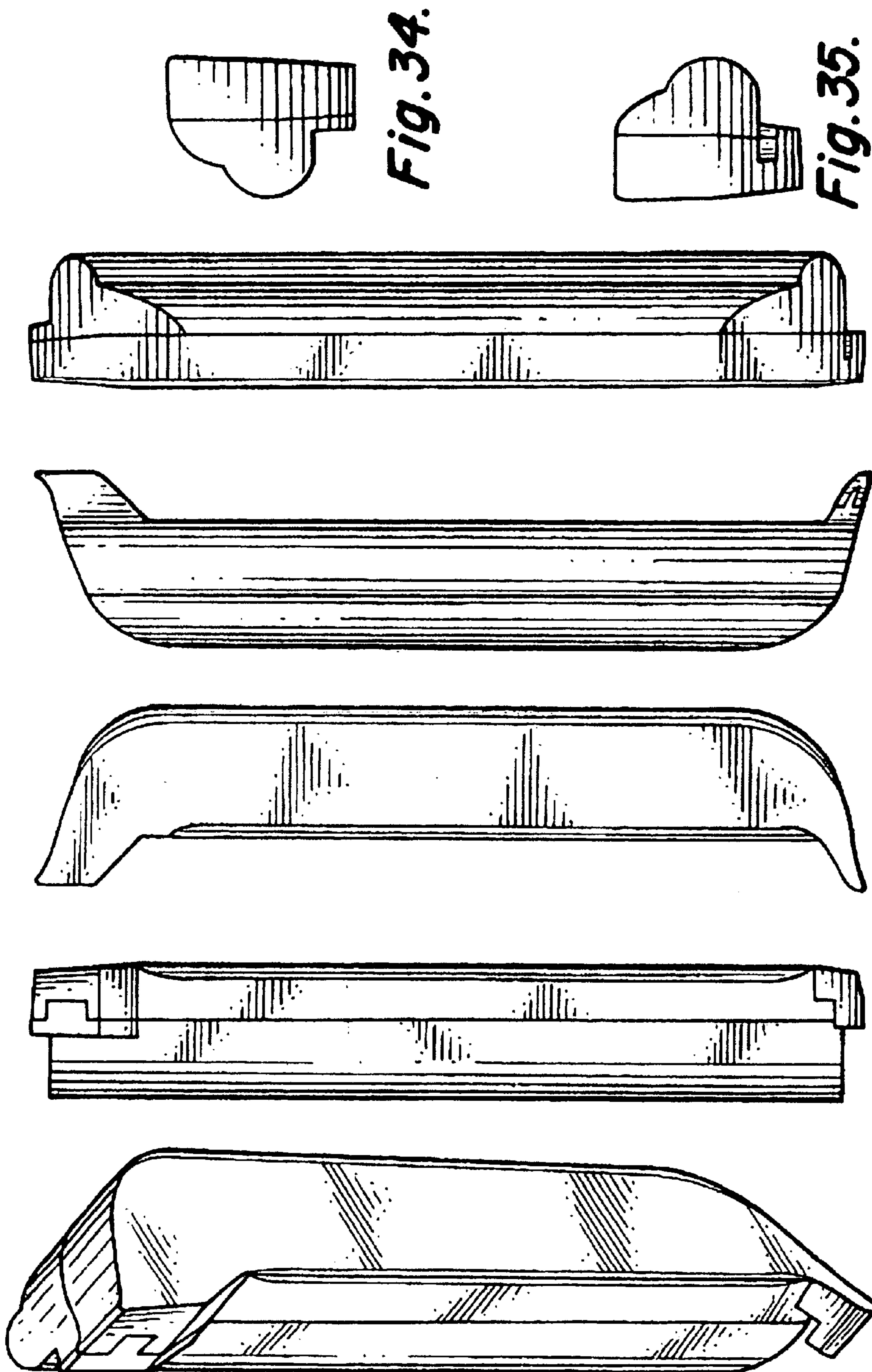


Fig. 29. Fig. 30. Fig. 31. Fig. 32. Fig. 33.
