We claim the ornamental design for a speaker box, as shown and described.

**DESCRIPTION**

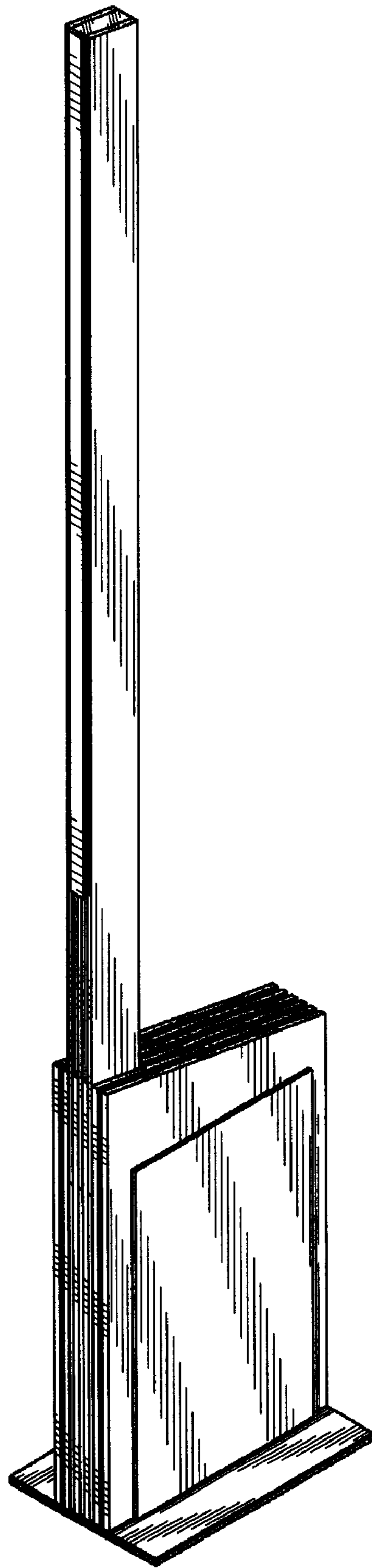
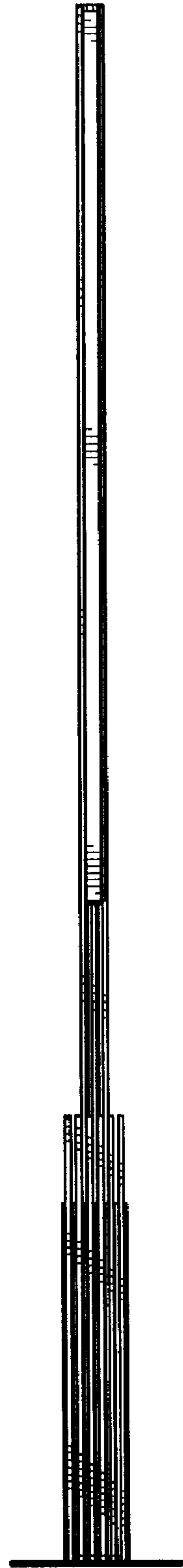
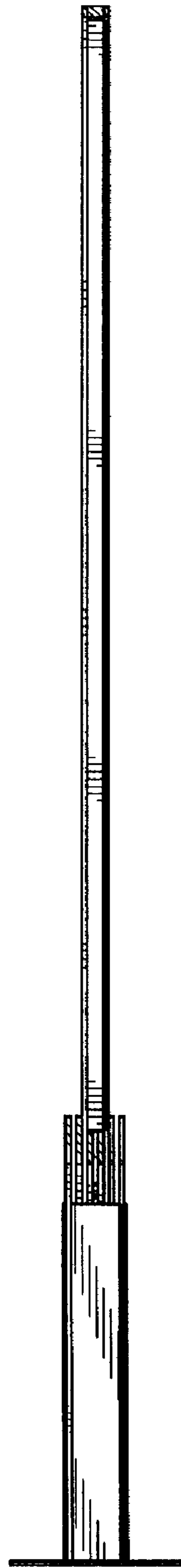


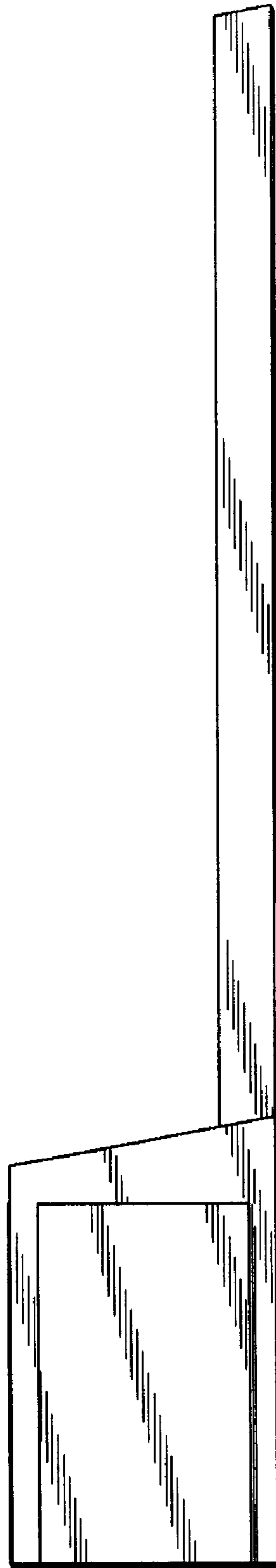

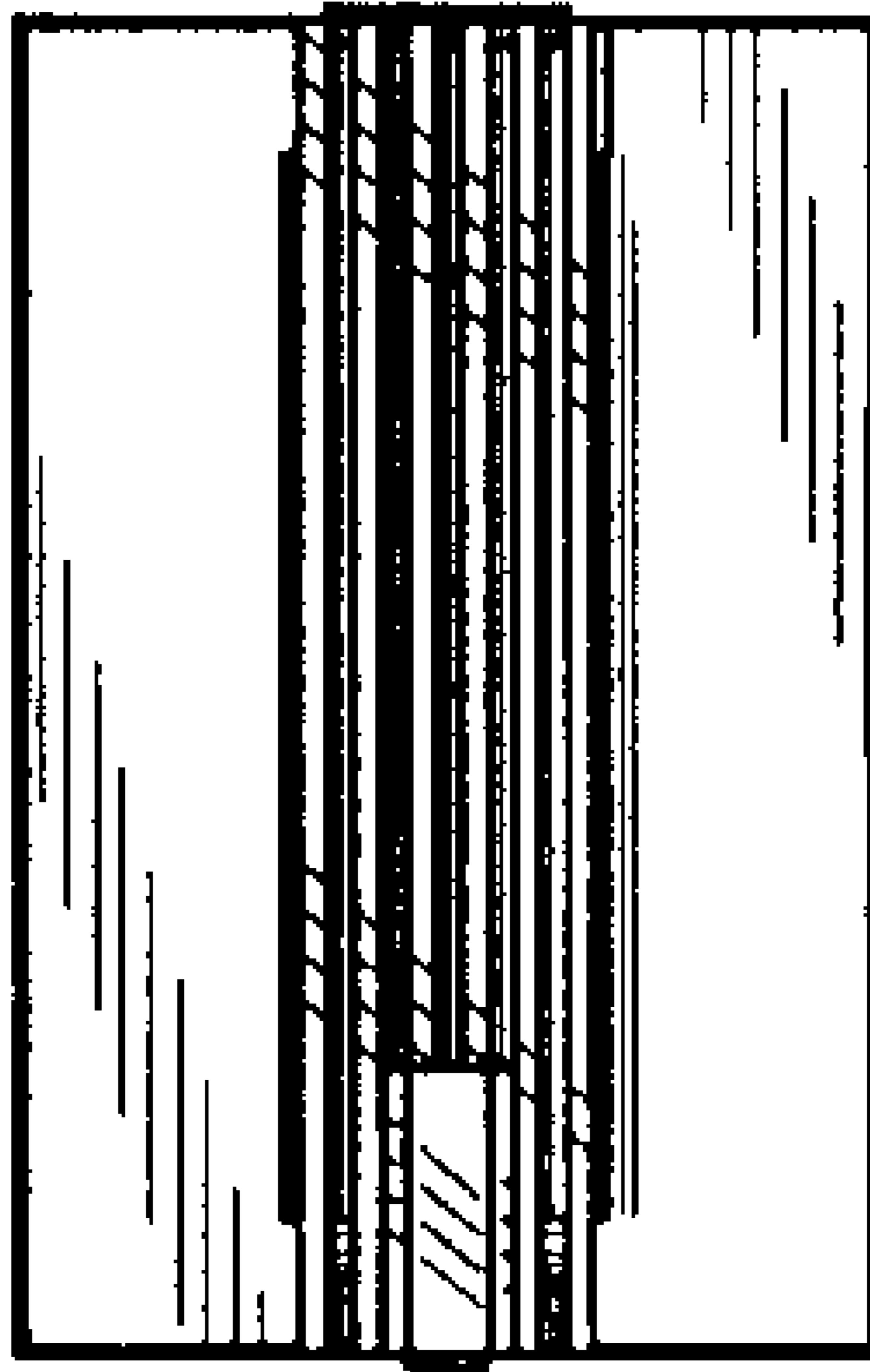

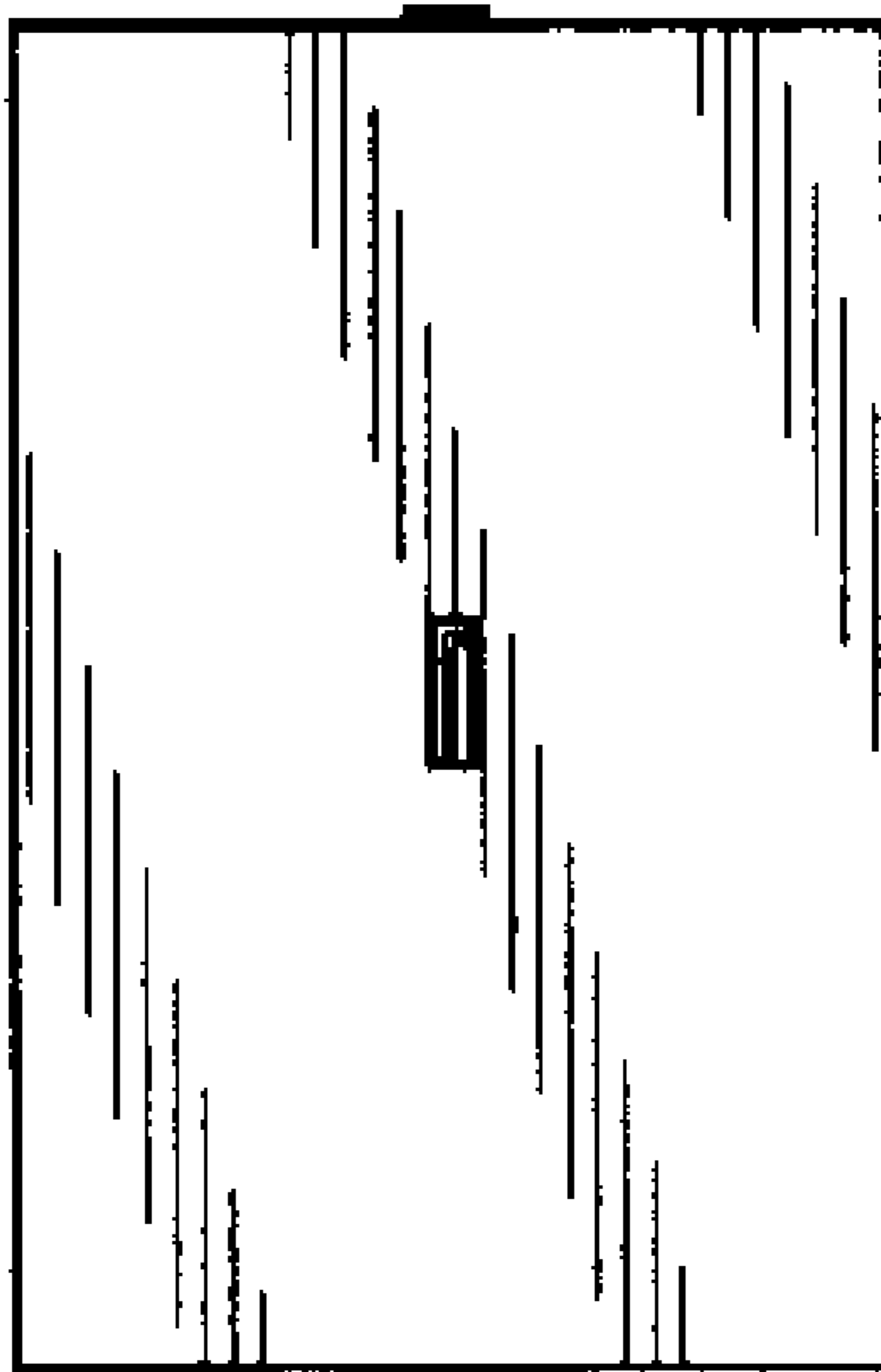
