(57) **CLAIM**

The ornamental design for a golf ball, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a golf ball showing my new design;

FIG. 2 is a front elevational view of the golf ball shown in FIG. 1;

FIG. 3 is a right elevational view of the golf ball shown in FIG. 1;

FIG. 4 is a left elevational view of the golf ball shown in FIG. 1;

FIG. 5 is a top view of the golf ball shown in FIG. 1;

FIG. 6 is a bottom view of the golf ball shown in FIG. 1;

FIG. 7 is a front perspective view of a second embodiment of a golf ball showing my new design;

FIG. 8 is a front elevational view of the golf ball shown in FIG. 7;

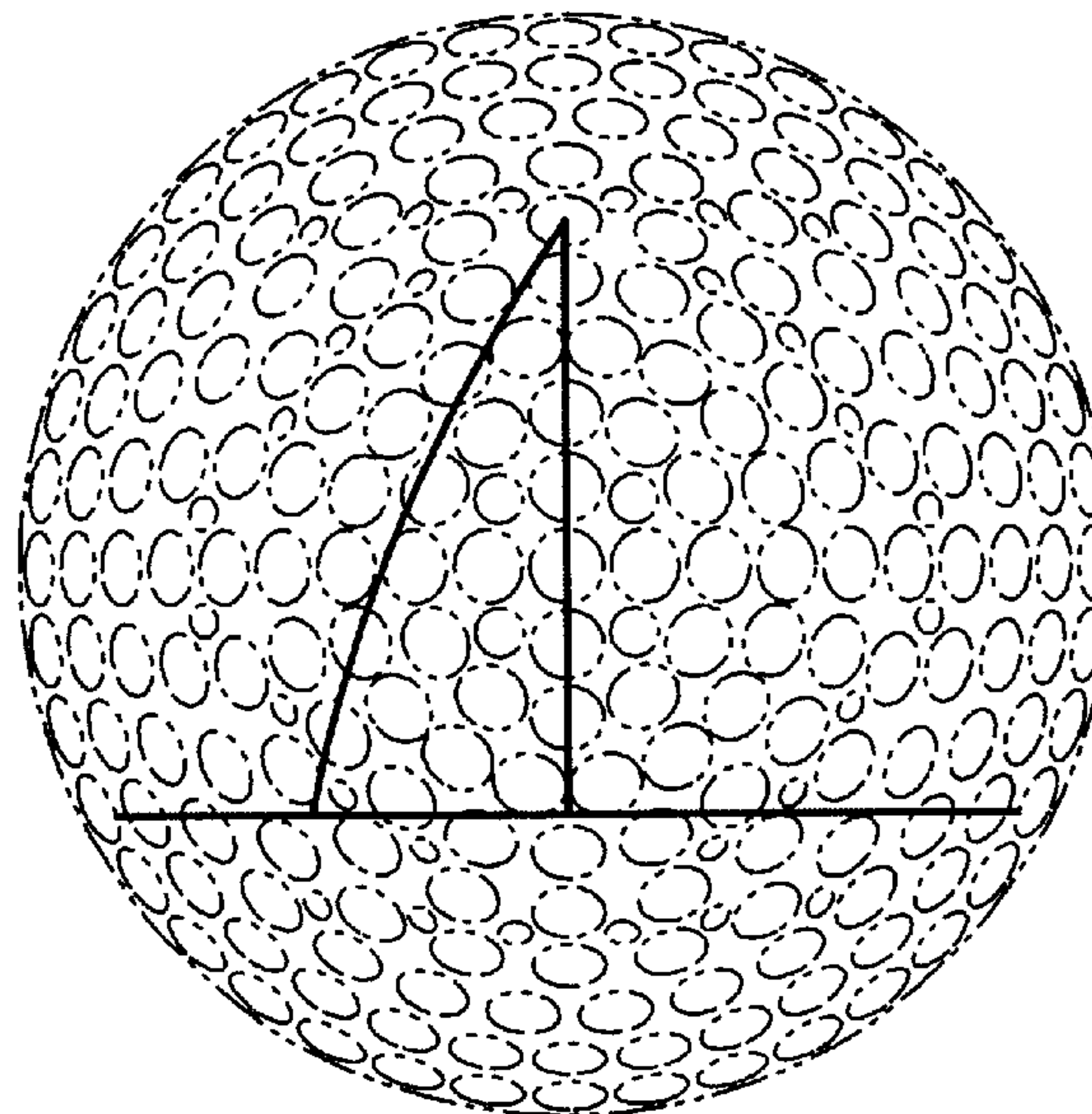
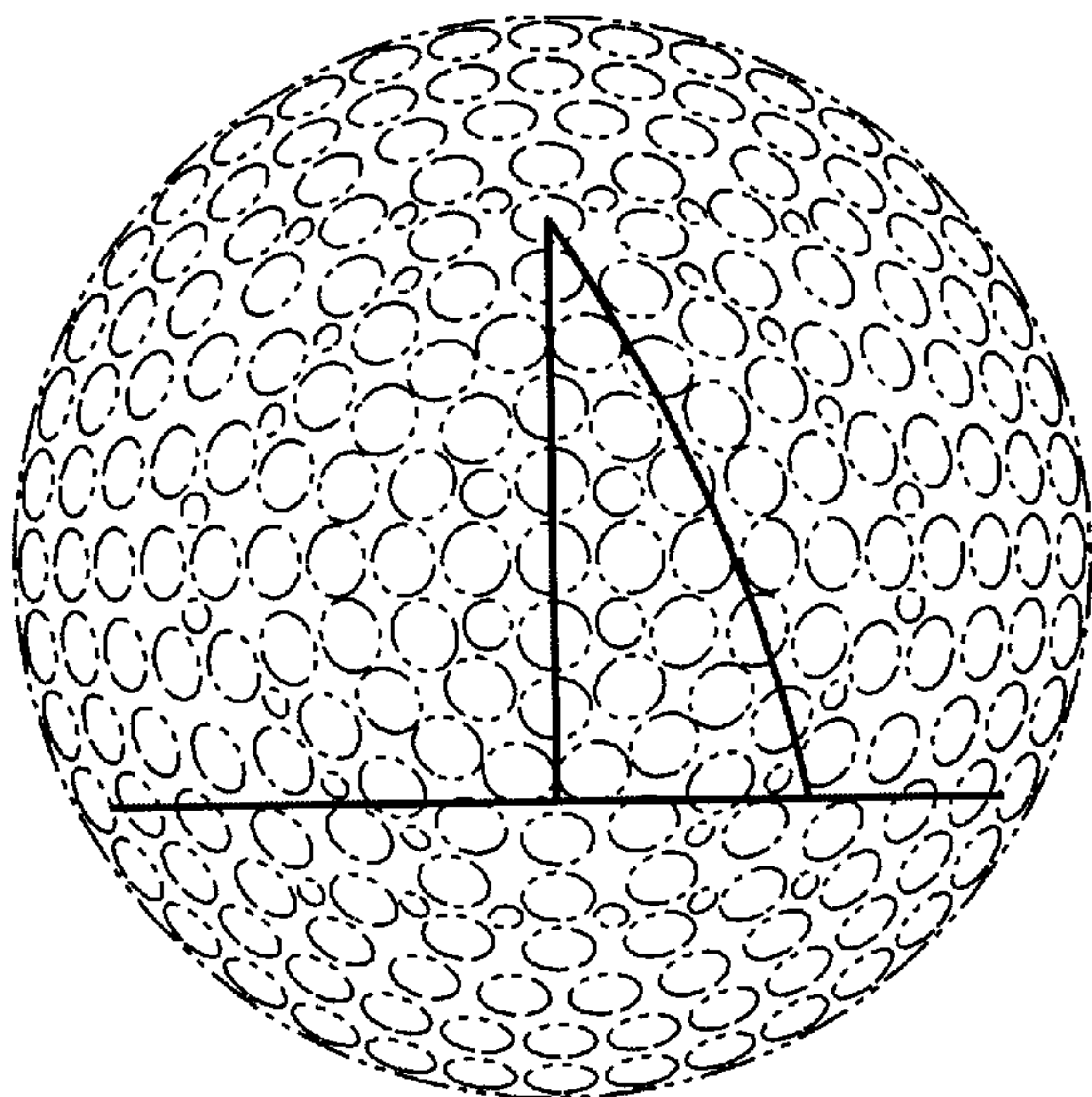
FIG. 9 is a left elevational view of the golf ball shown in FIG. 7;

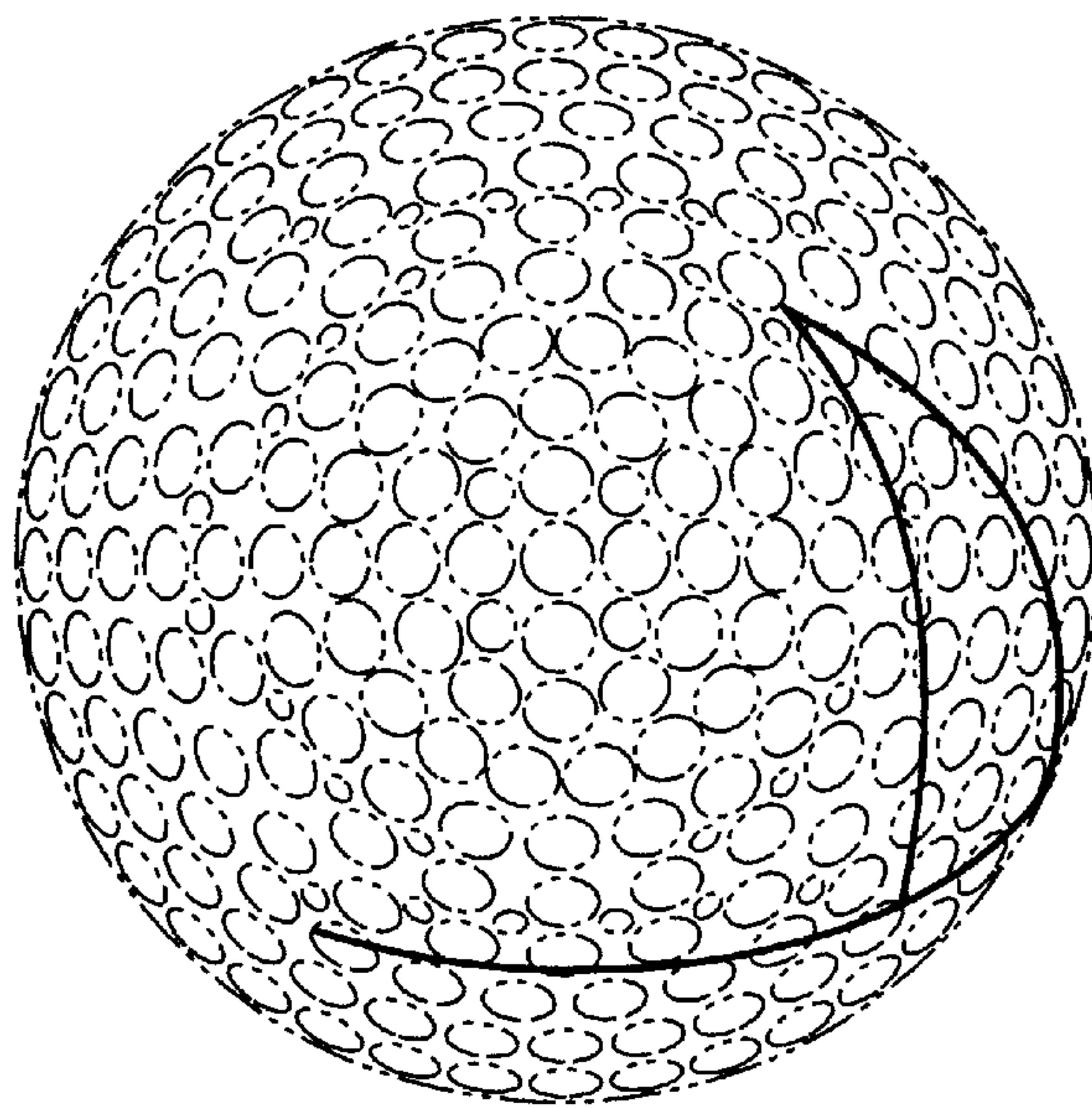

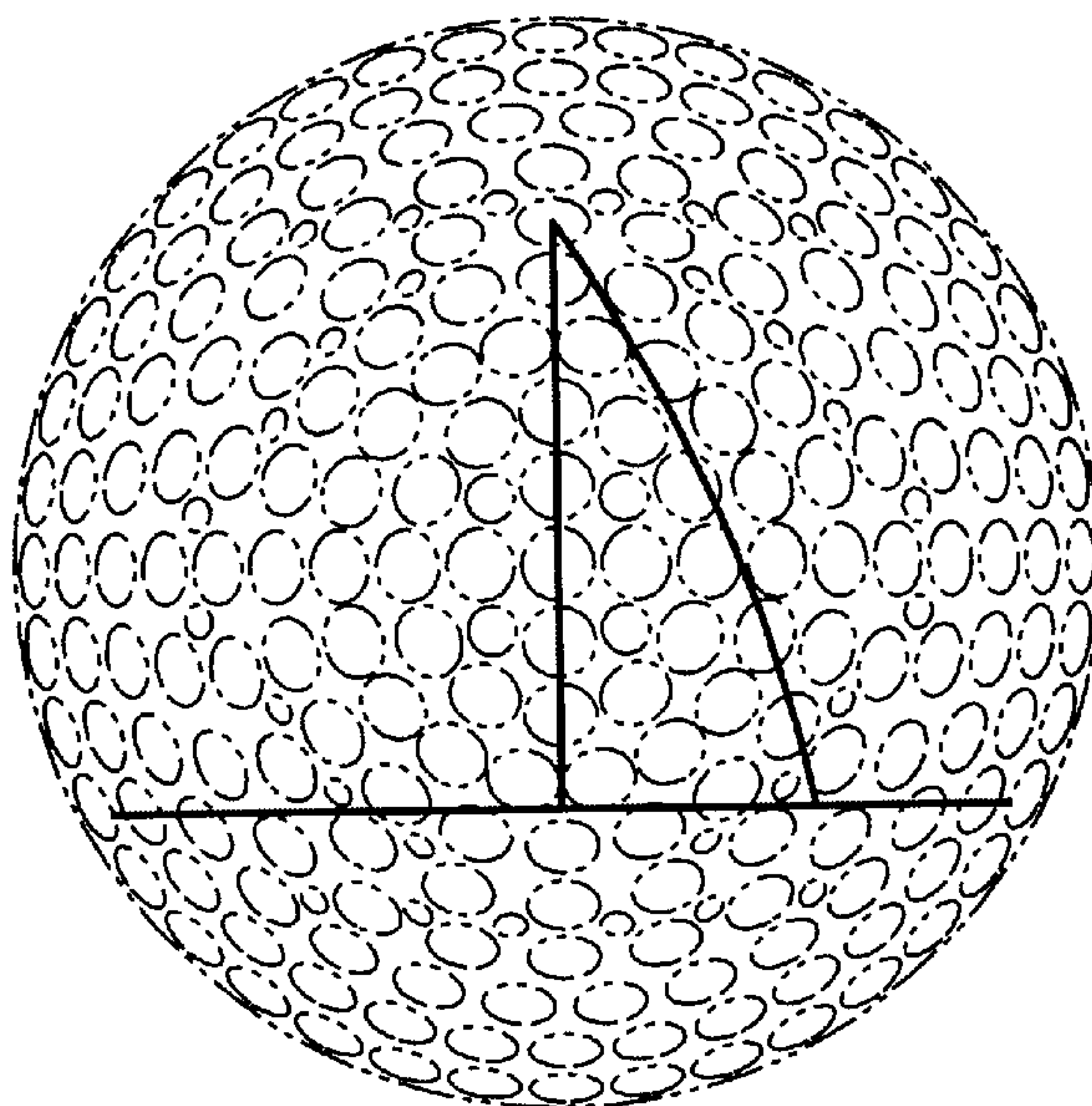

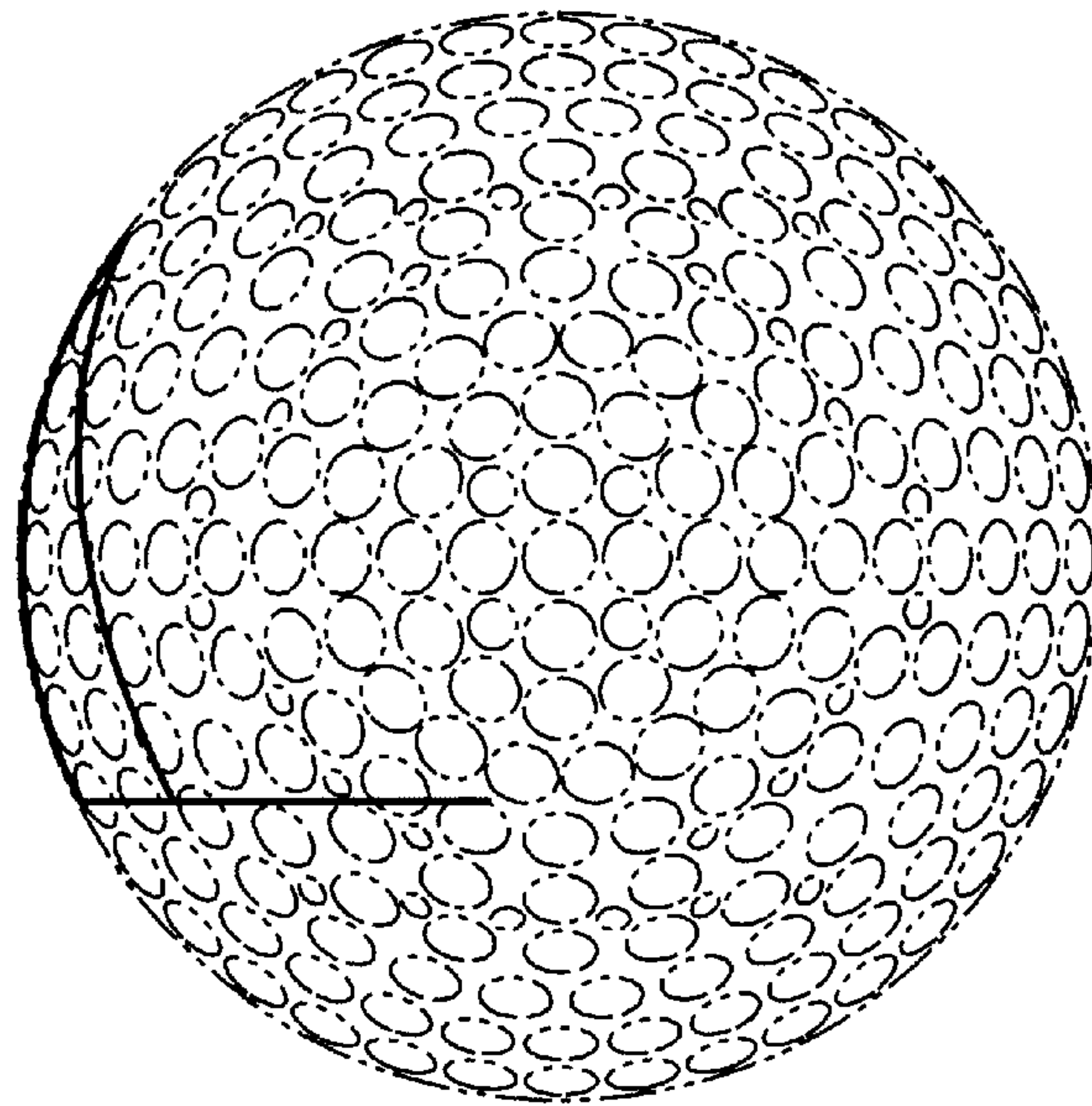

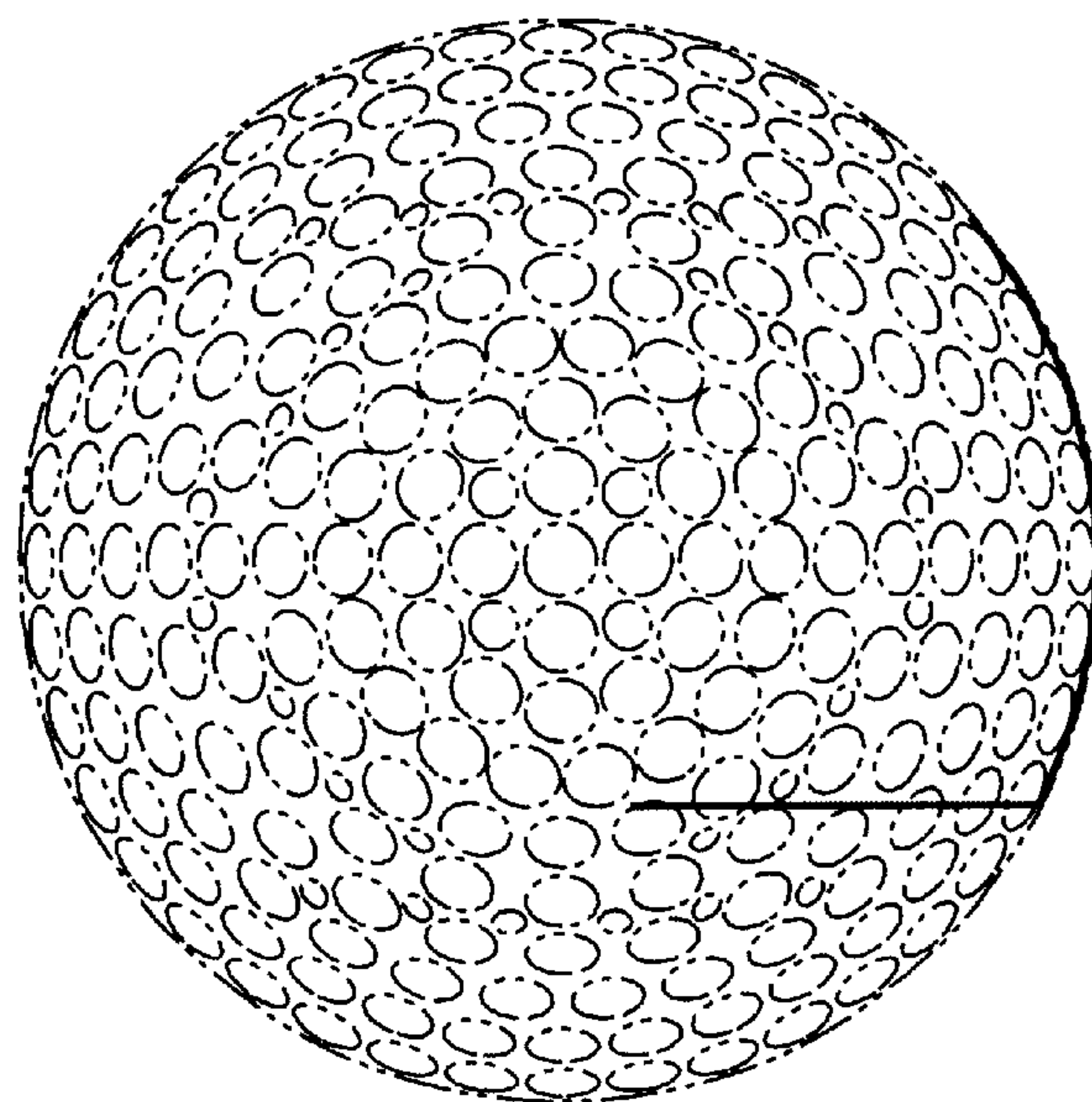

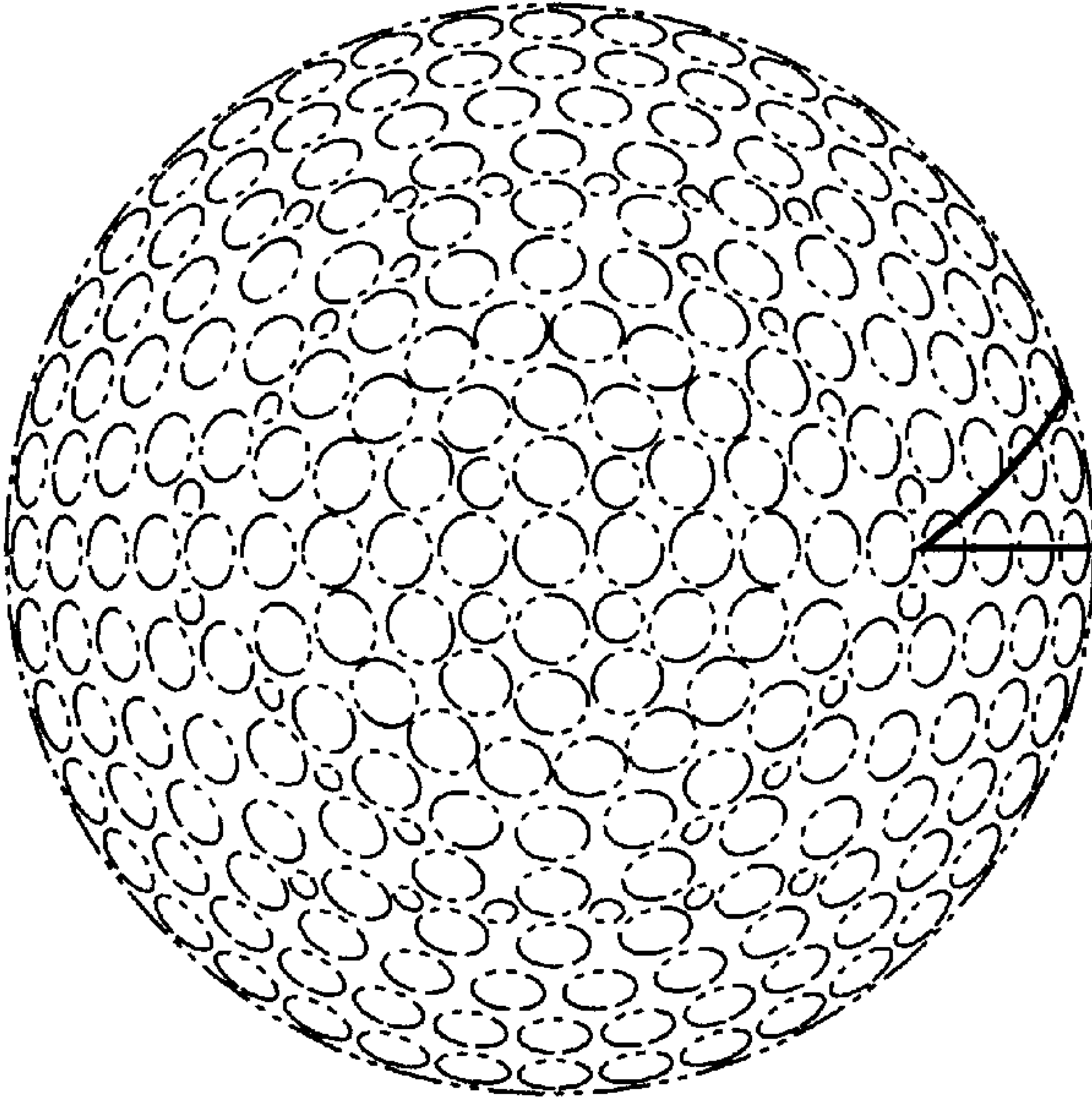

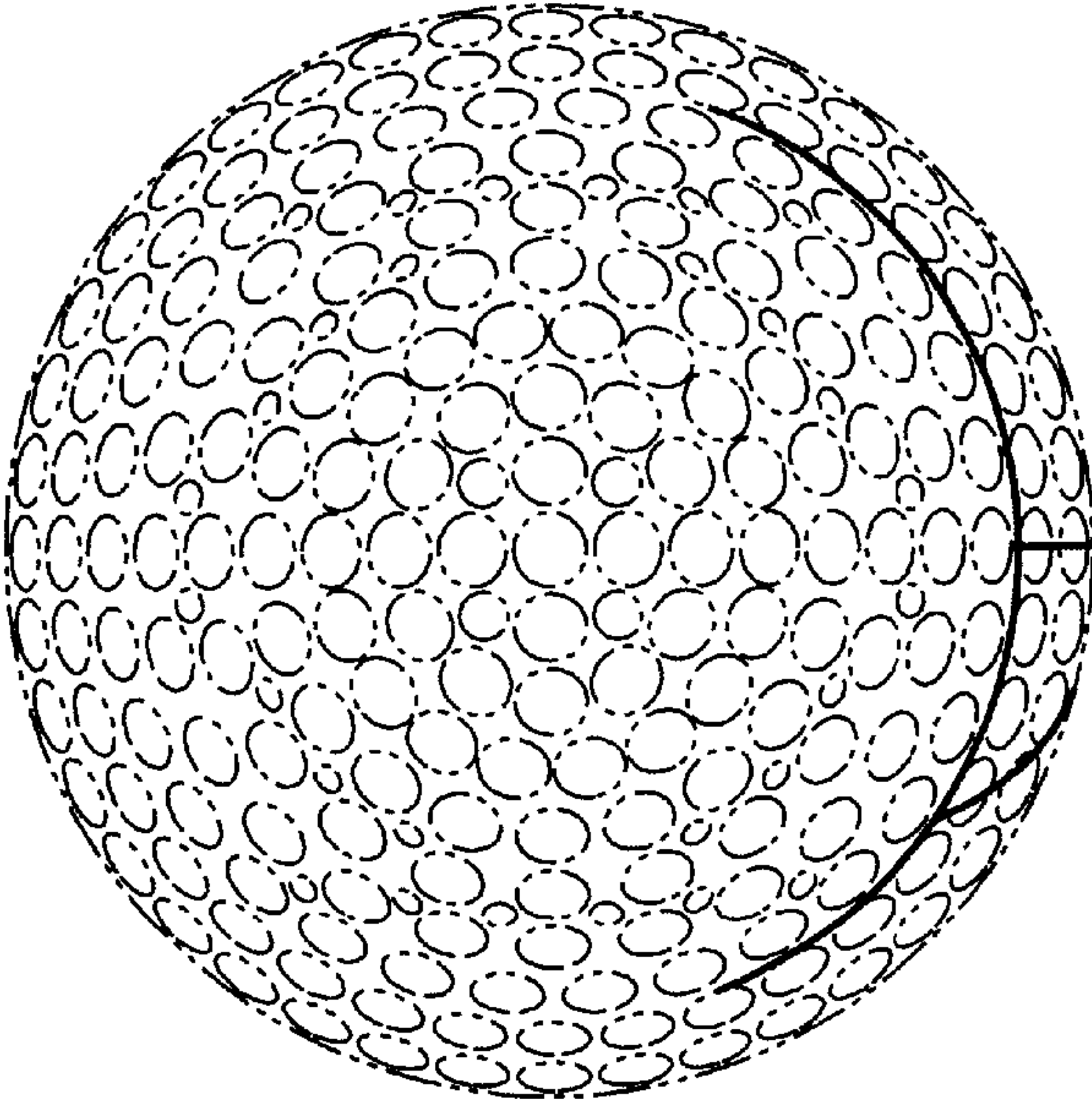

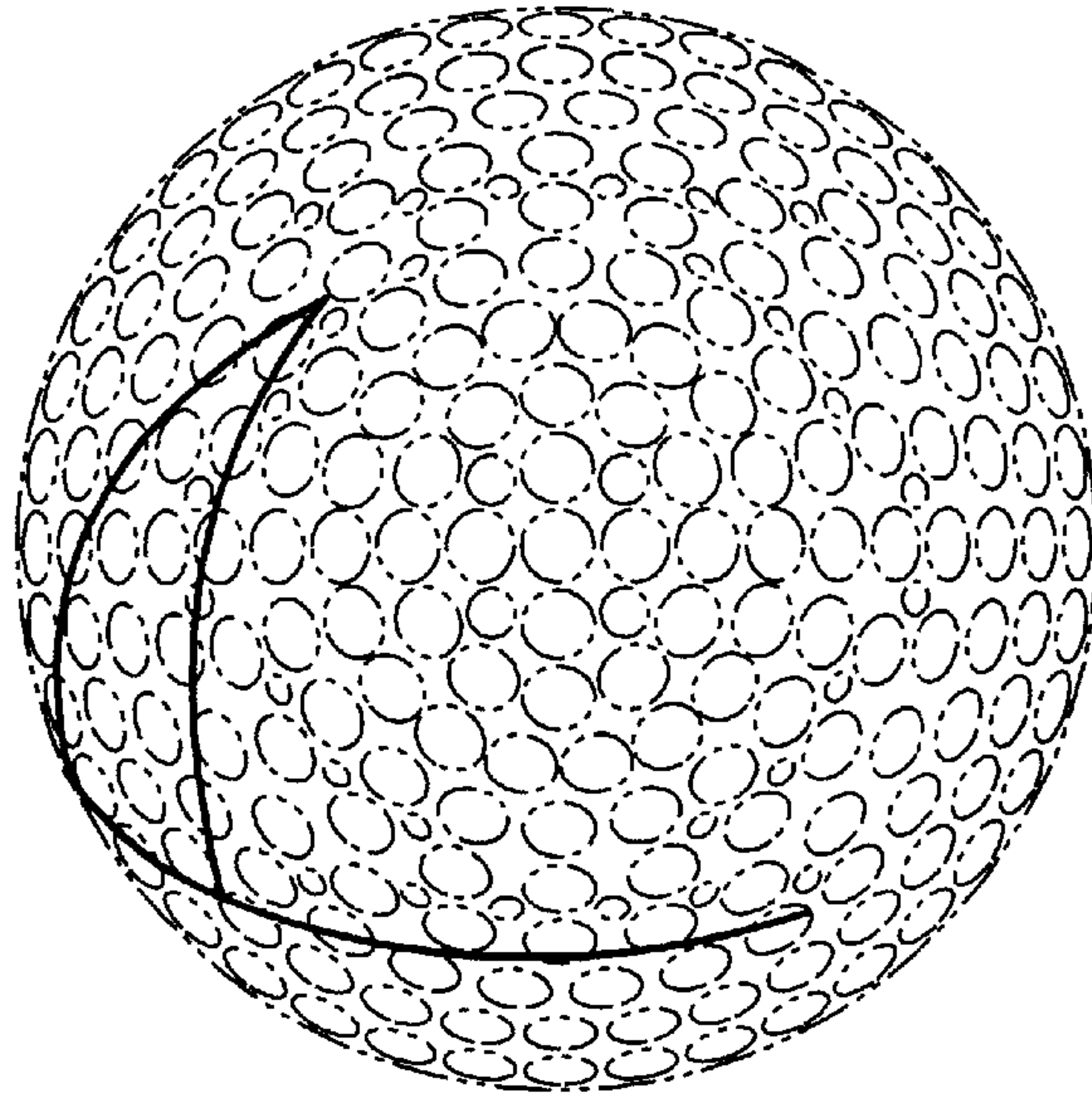

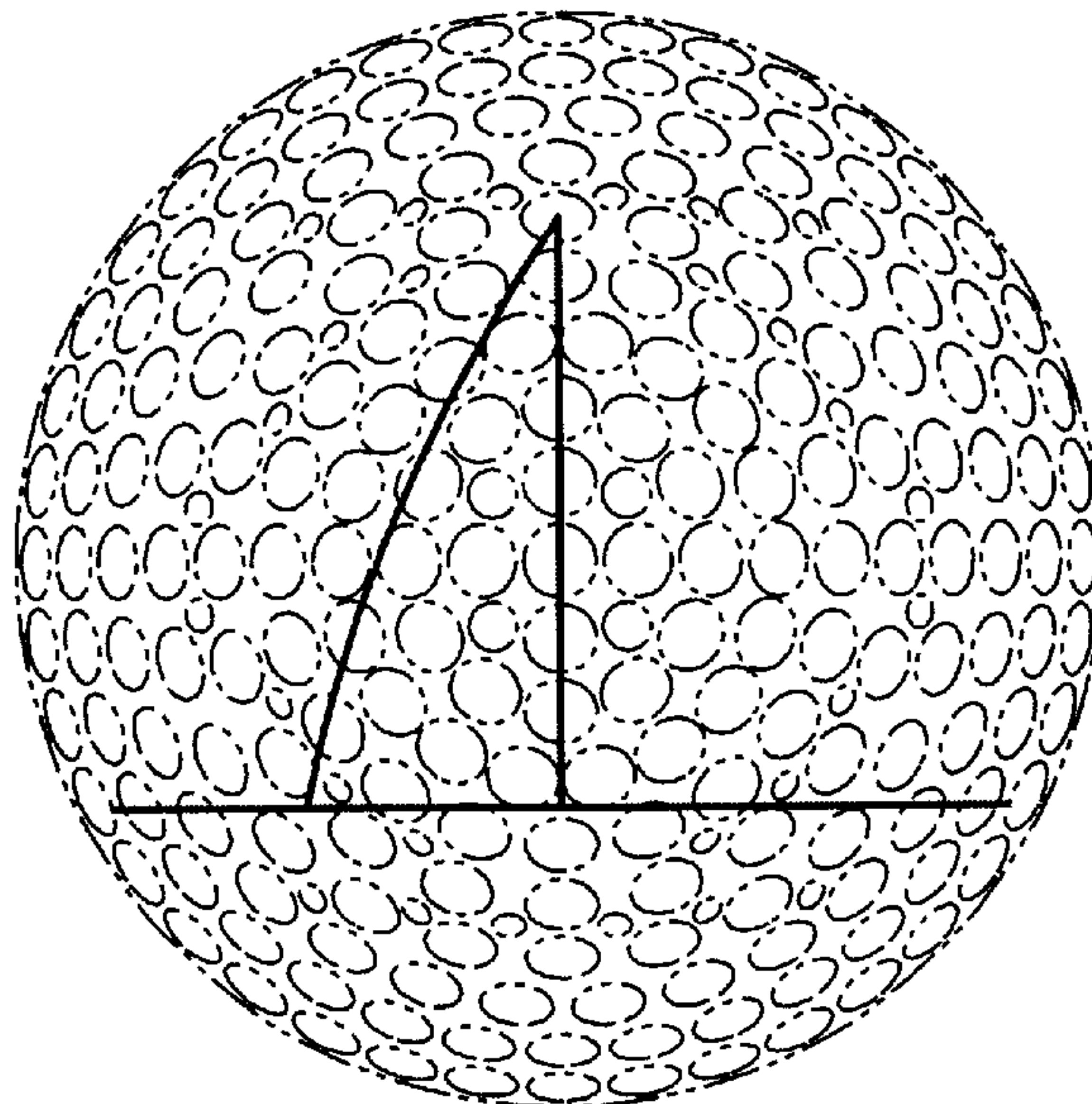

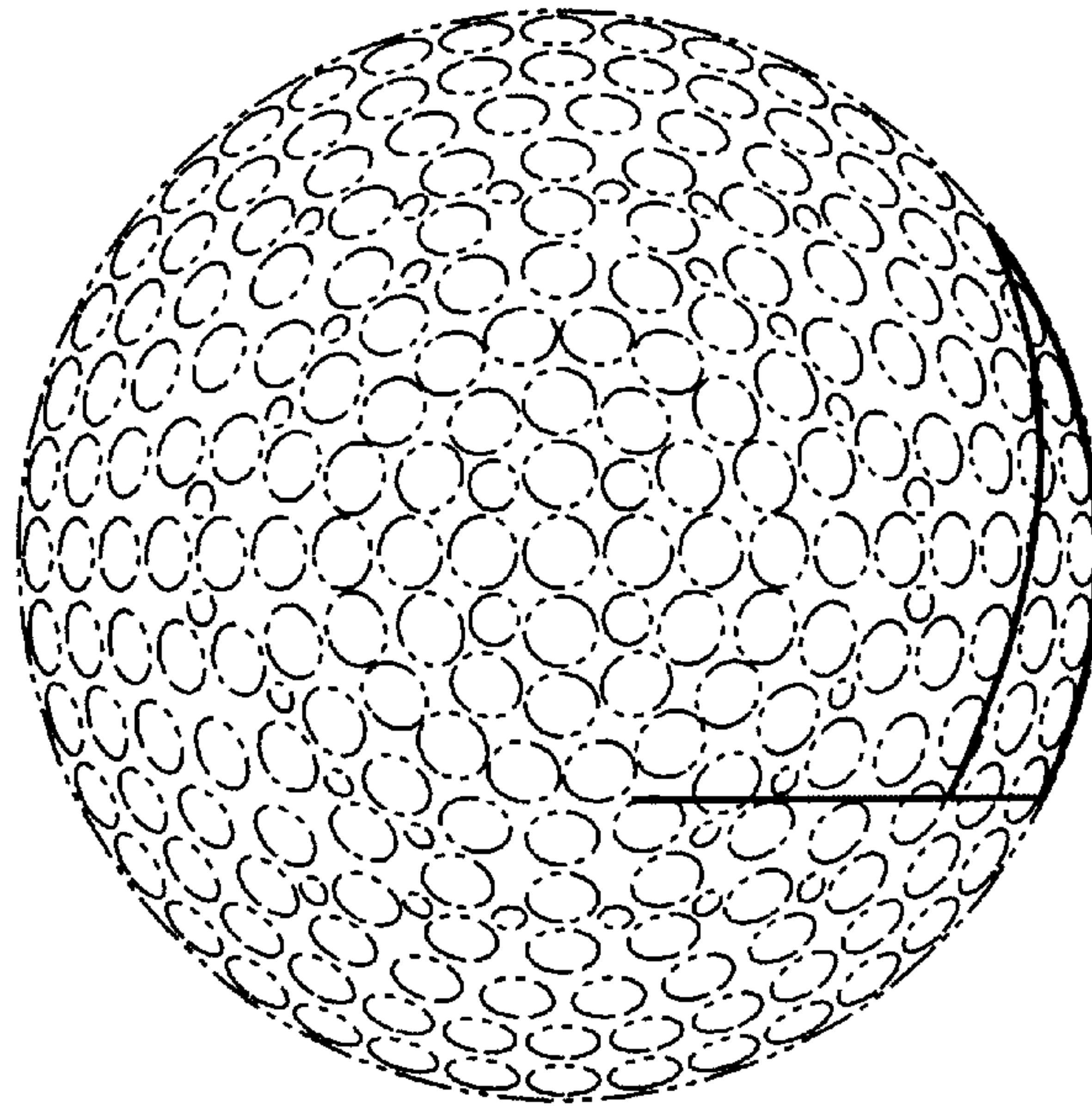

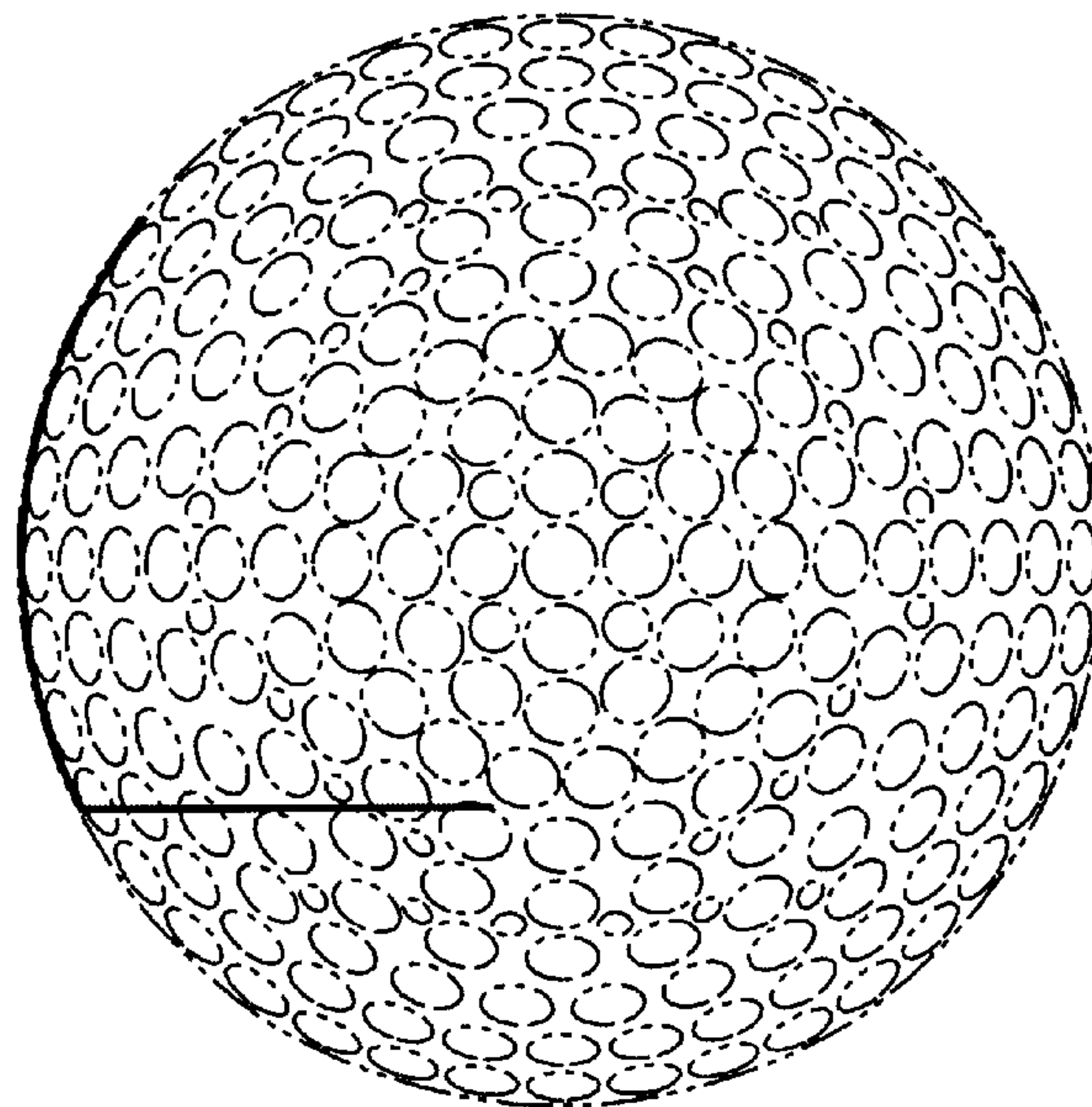

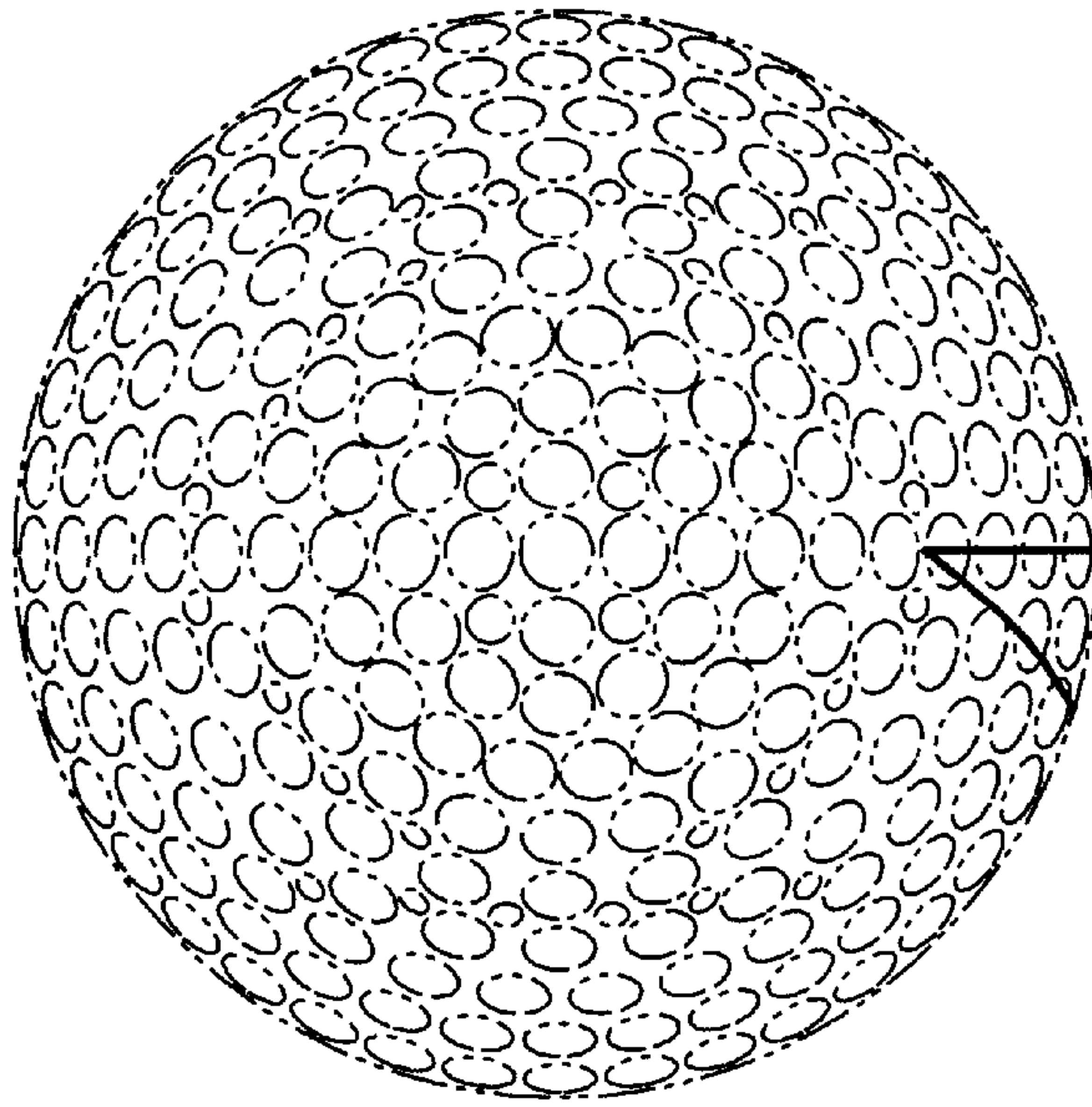

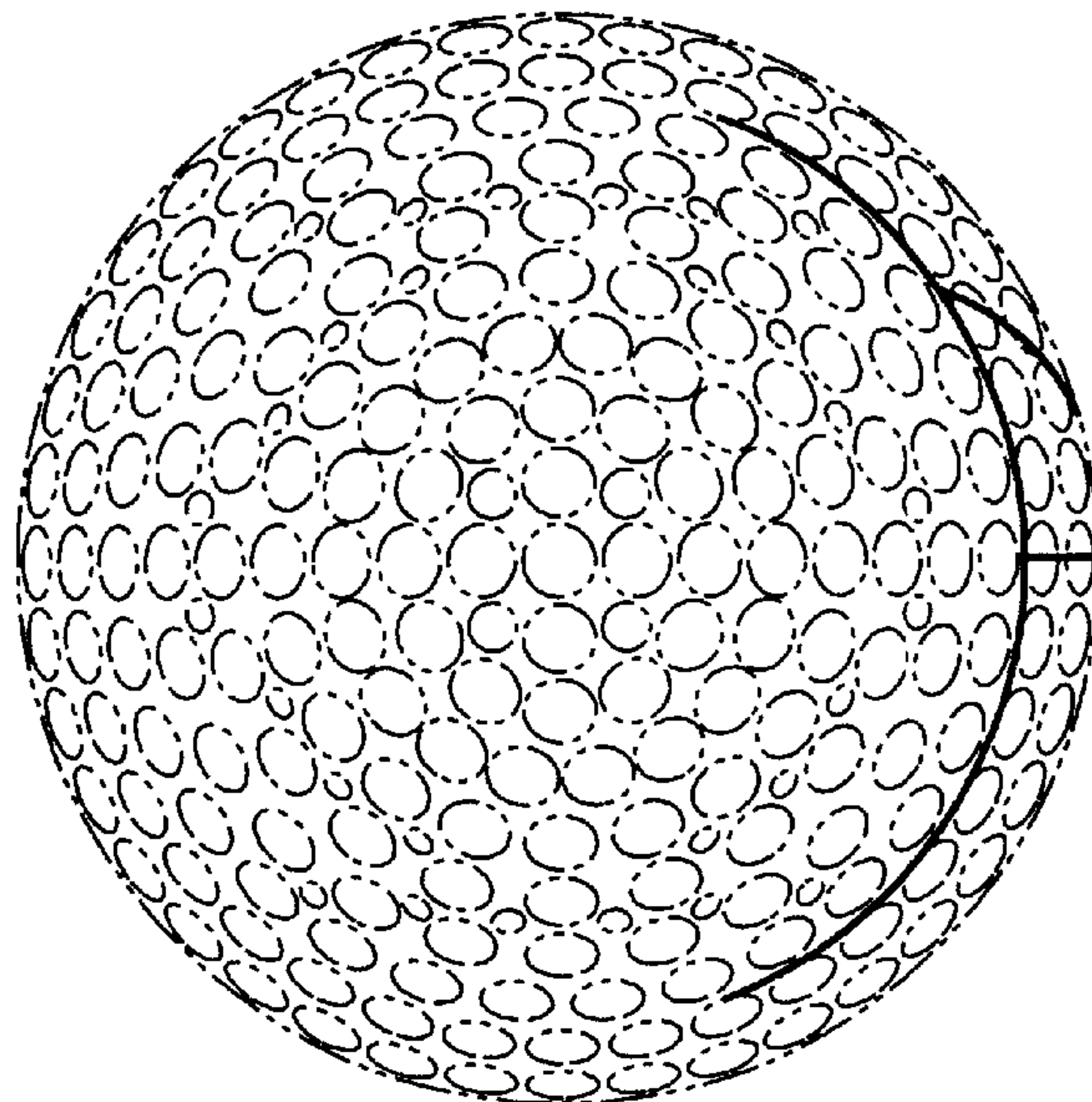
