(57) **CLAIM**

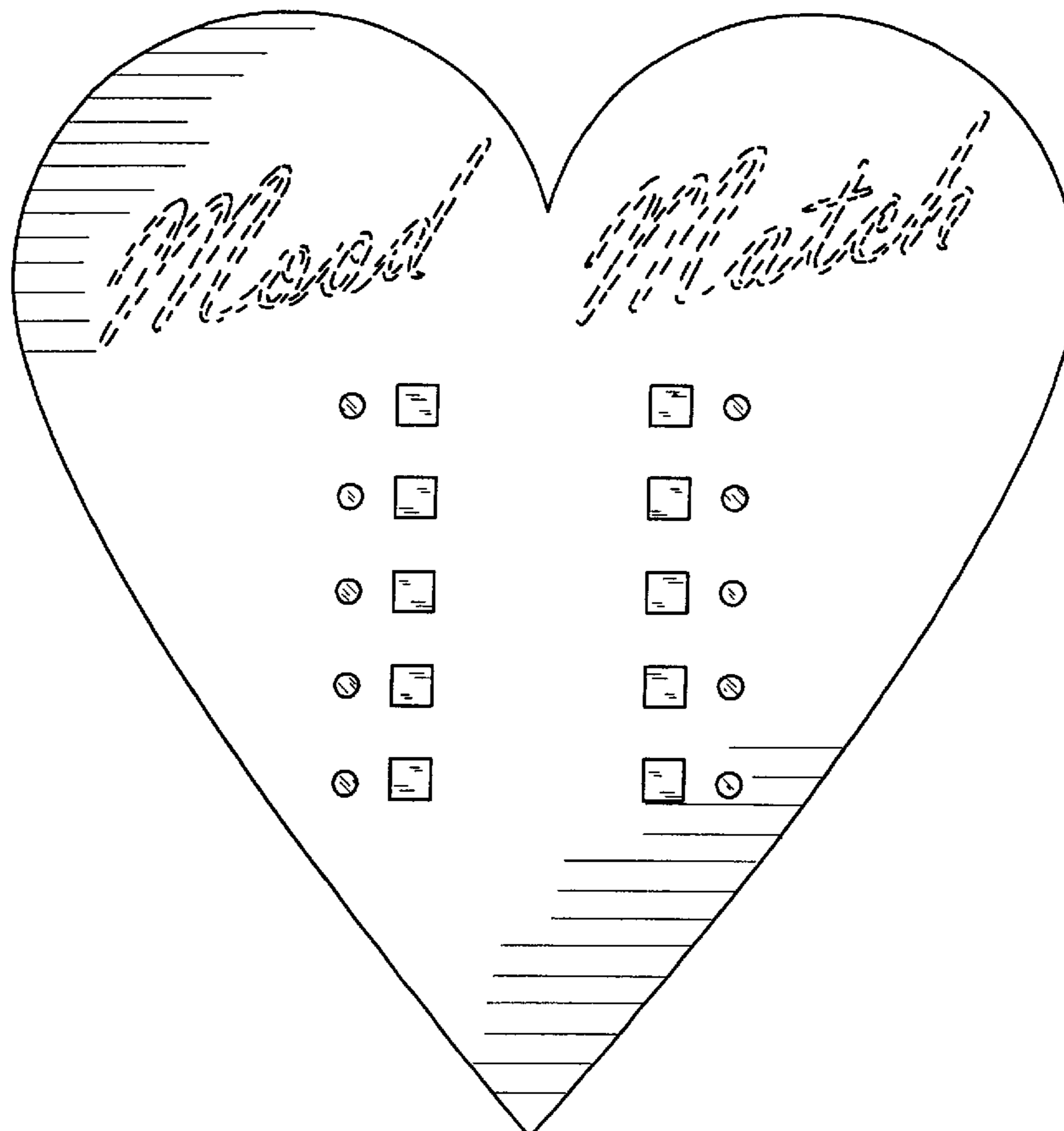
The ornamental design for a mood indicating device, as shown and described.

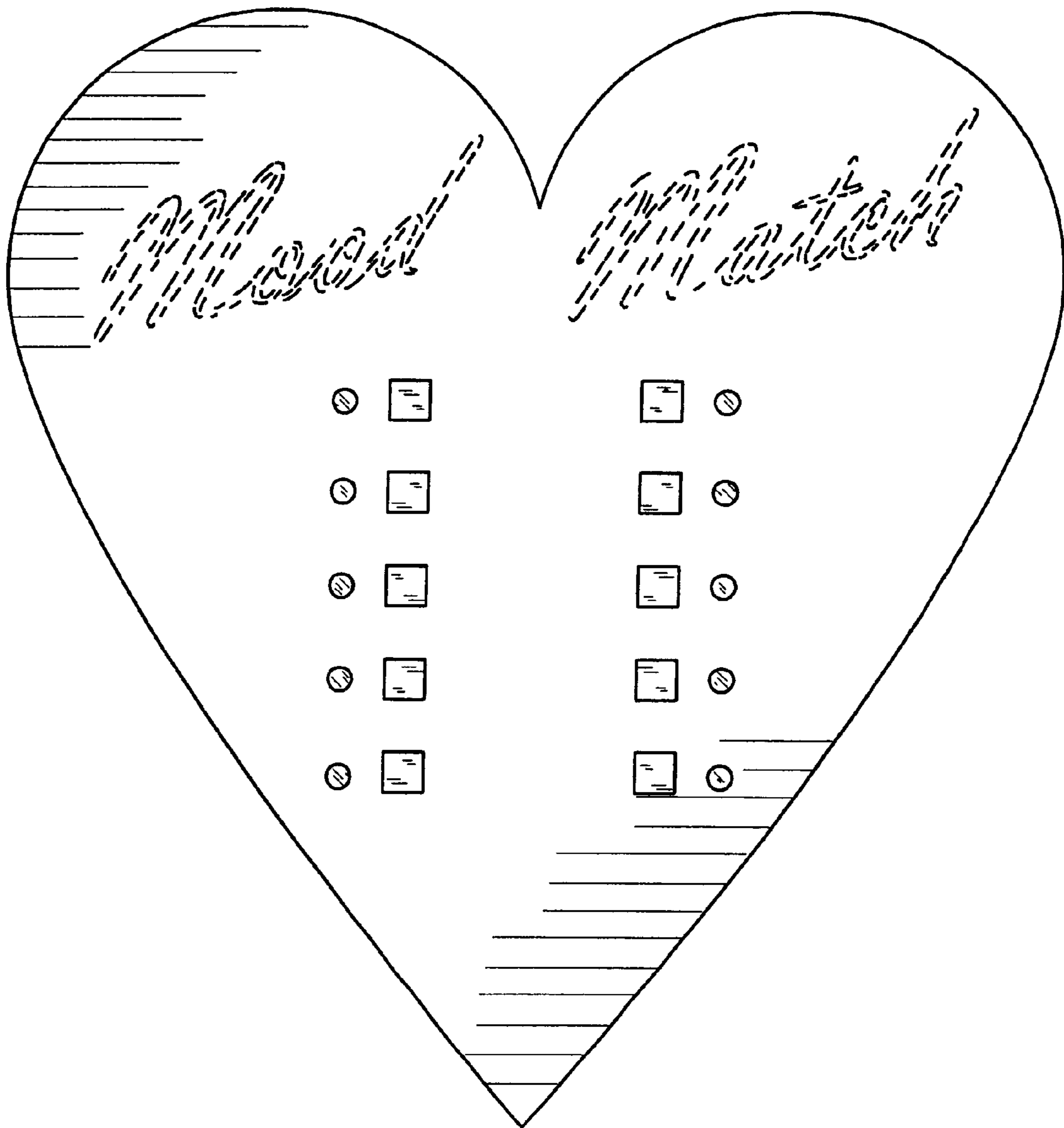

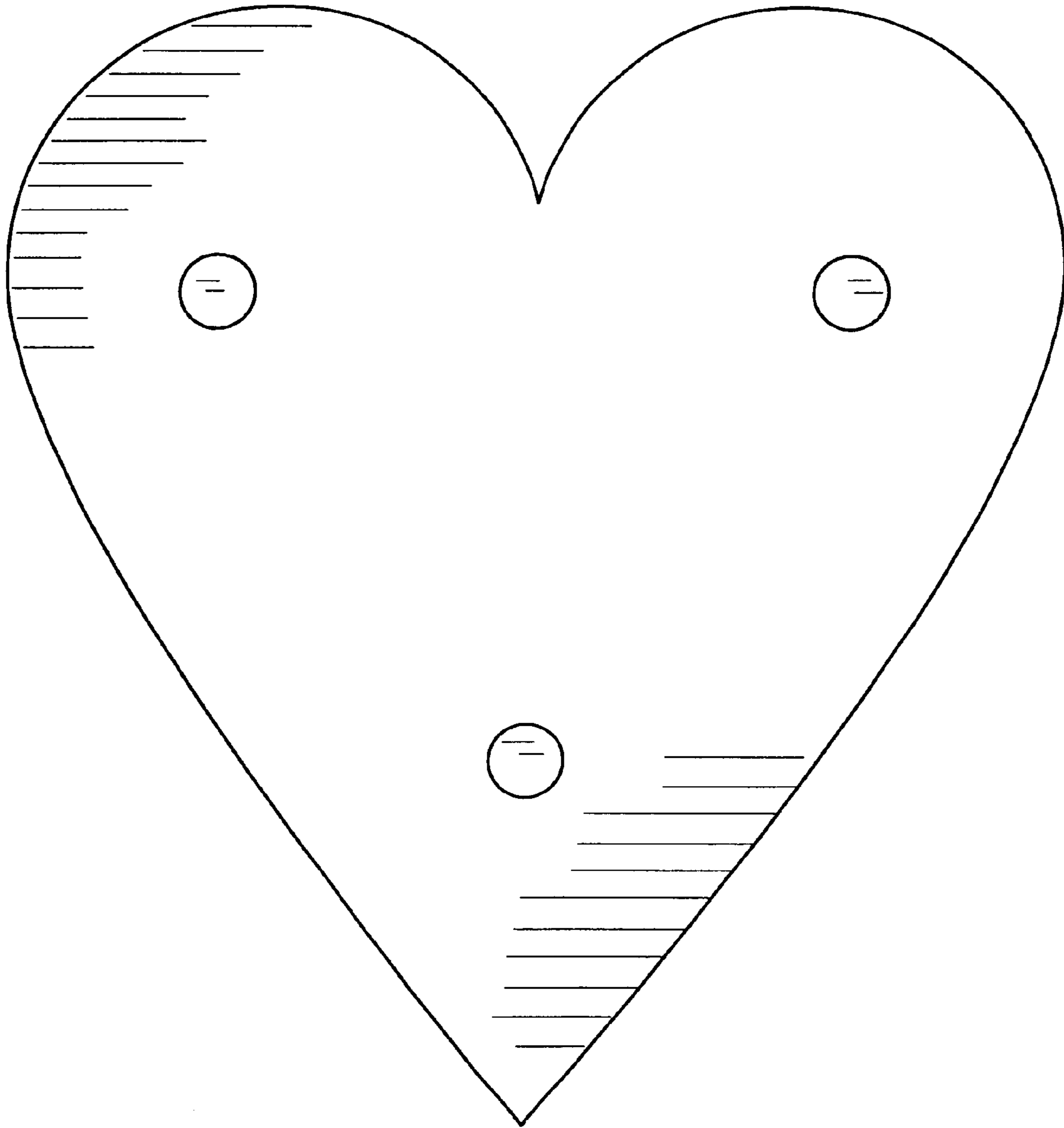

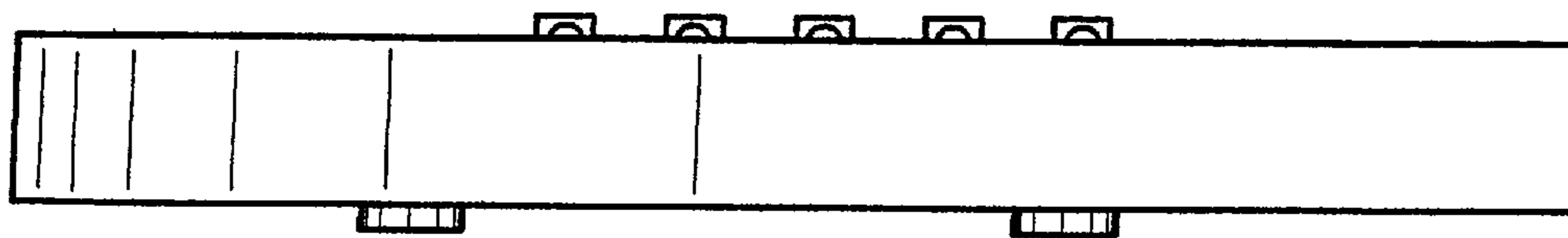

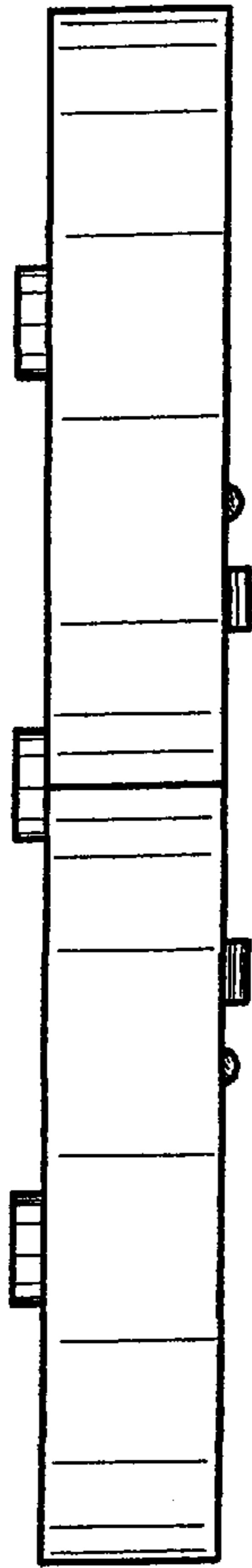

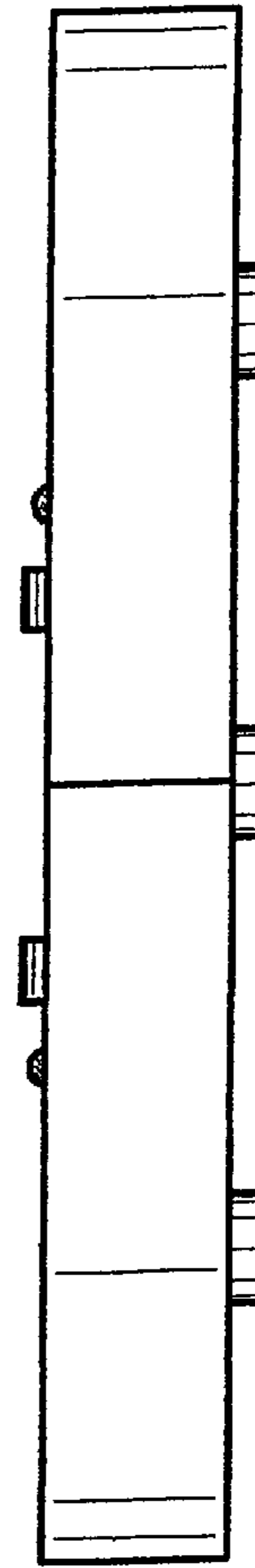
