a non-shaving head in orange.

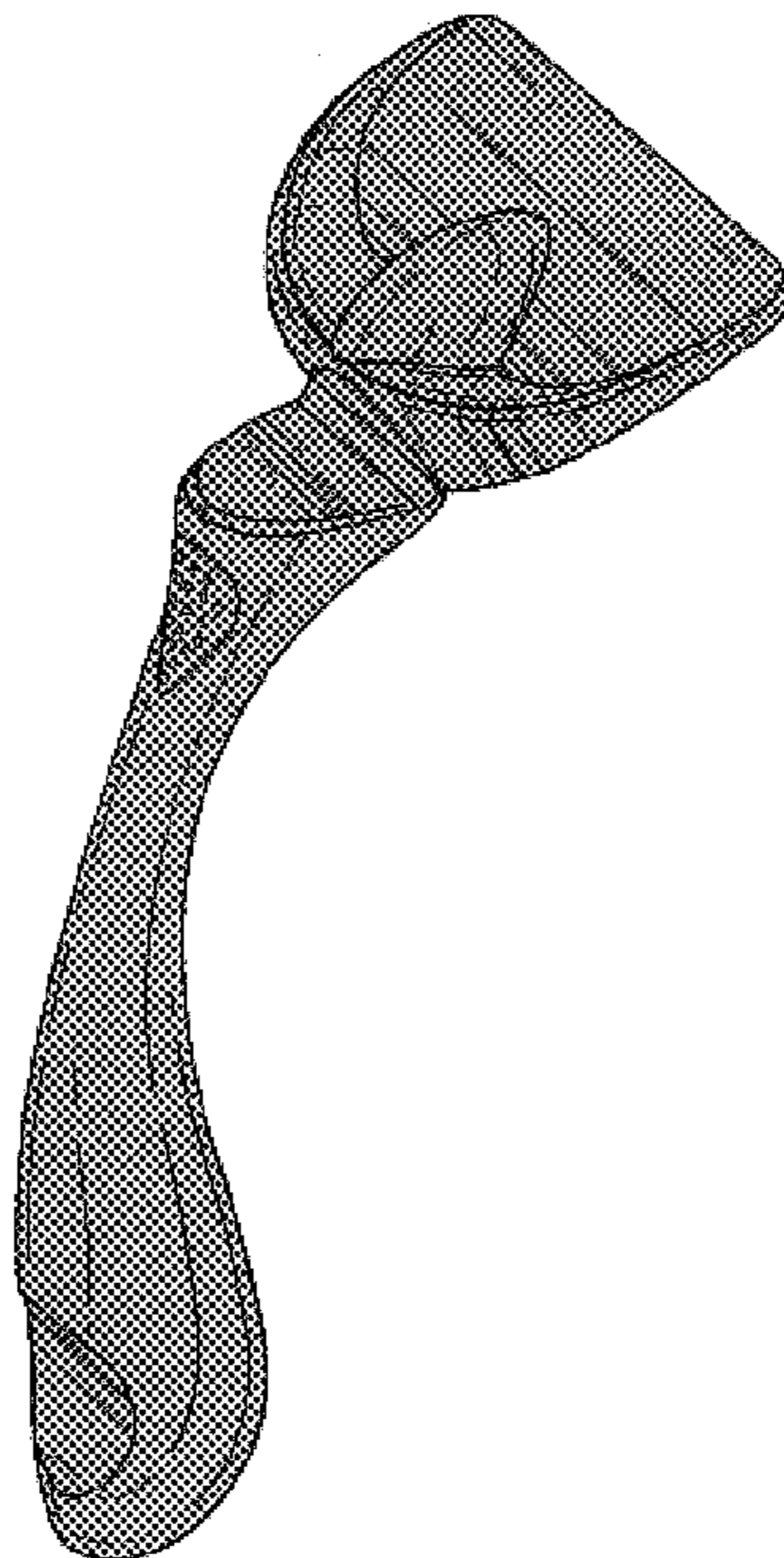
FIG. 4 is an elevation view of the front of the device having

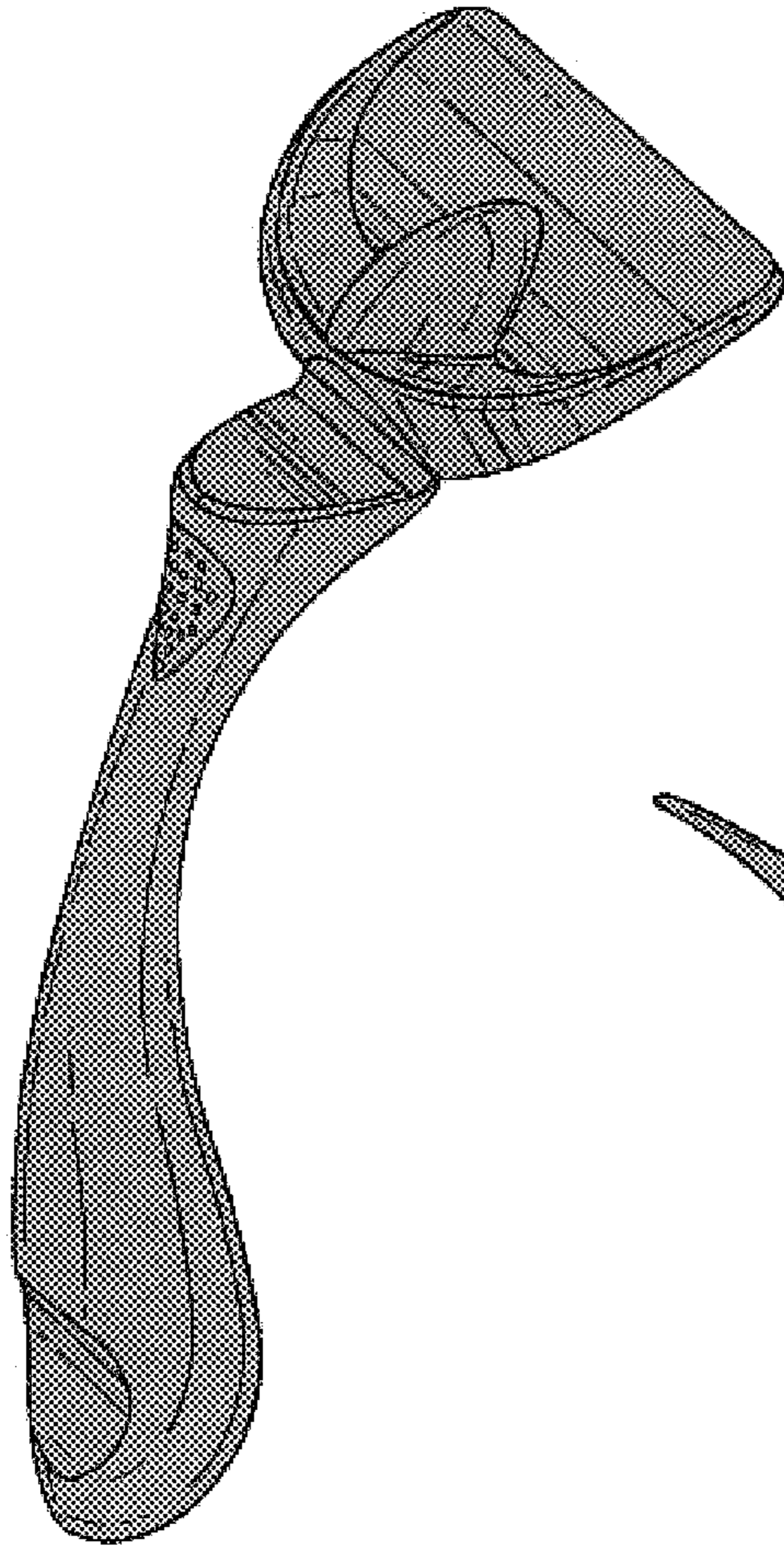

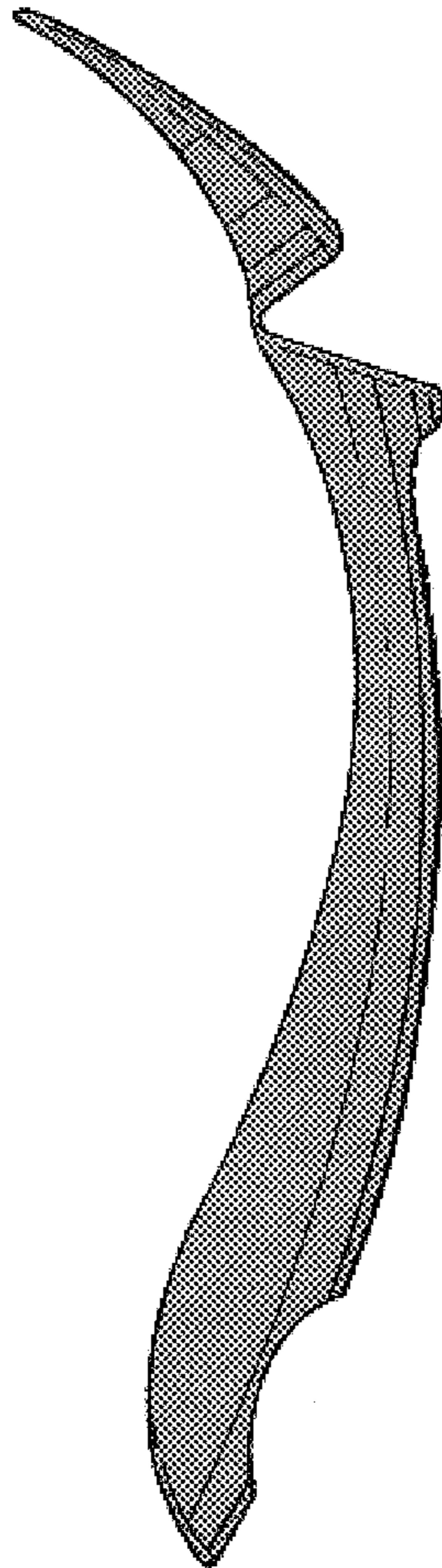

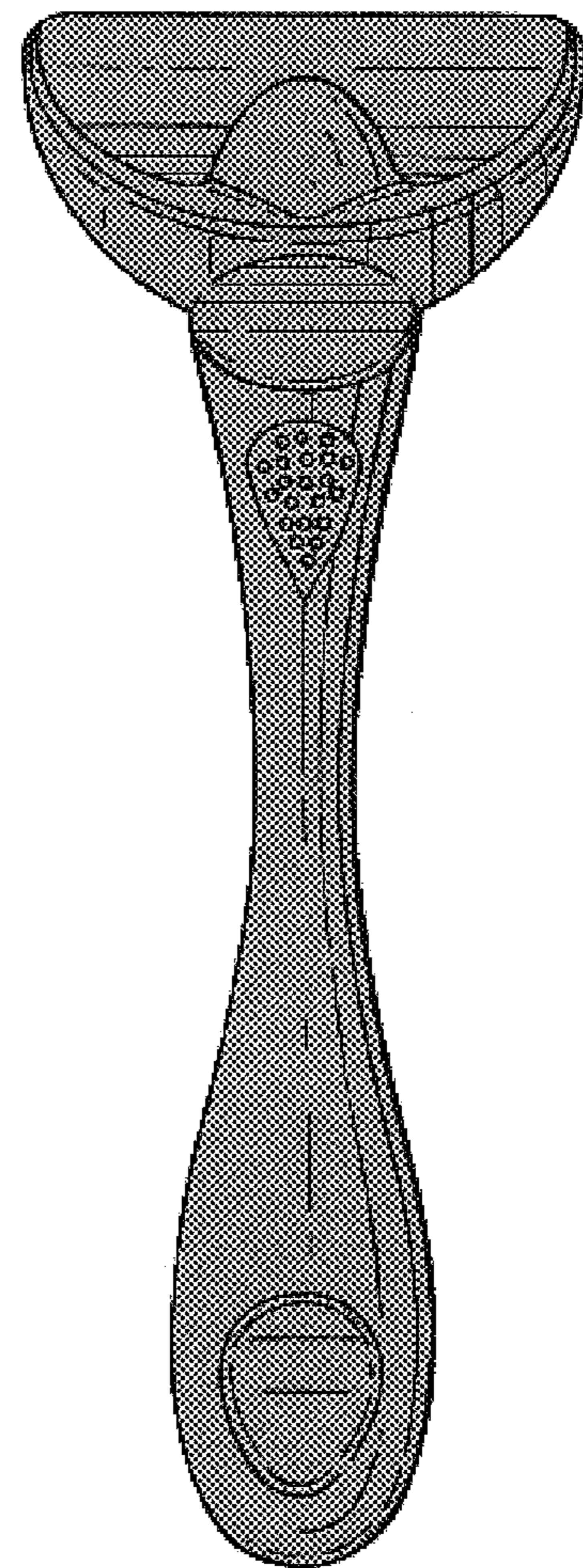

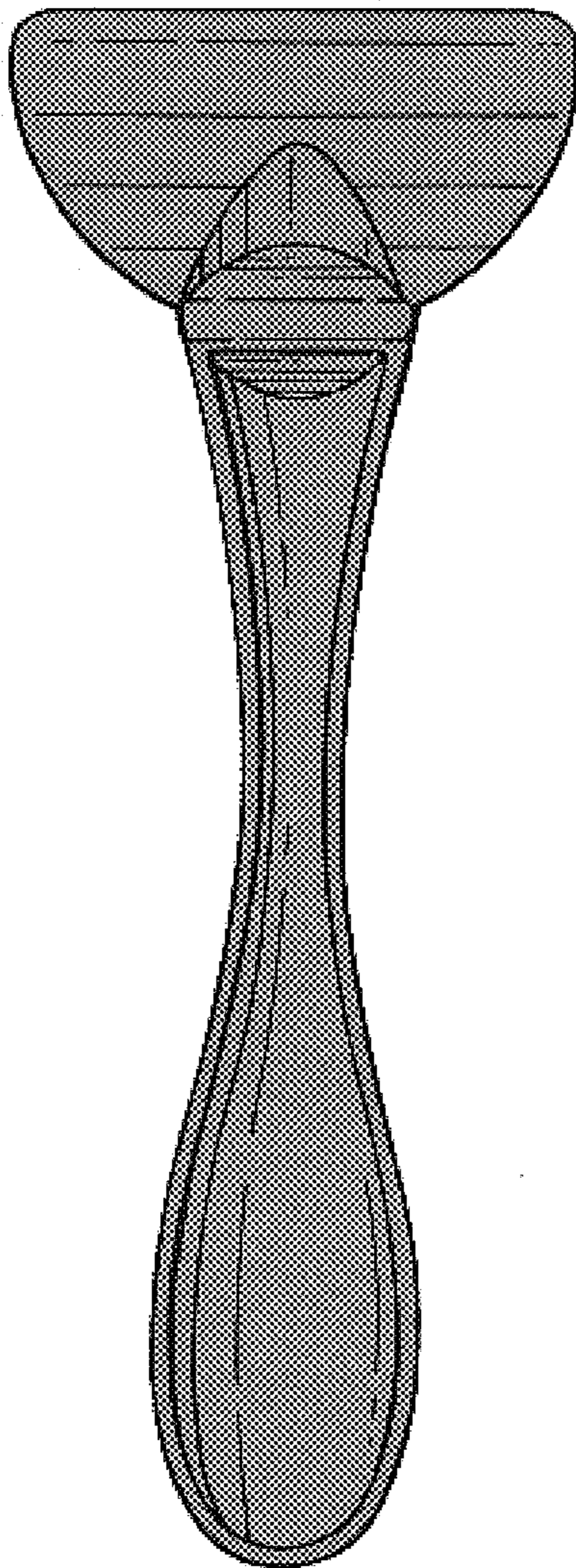

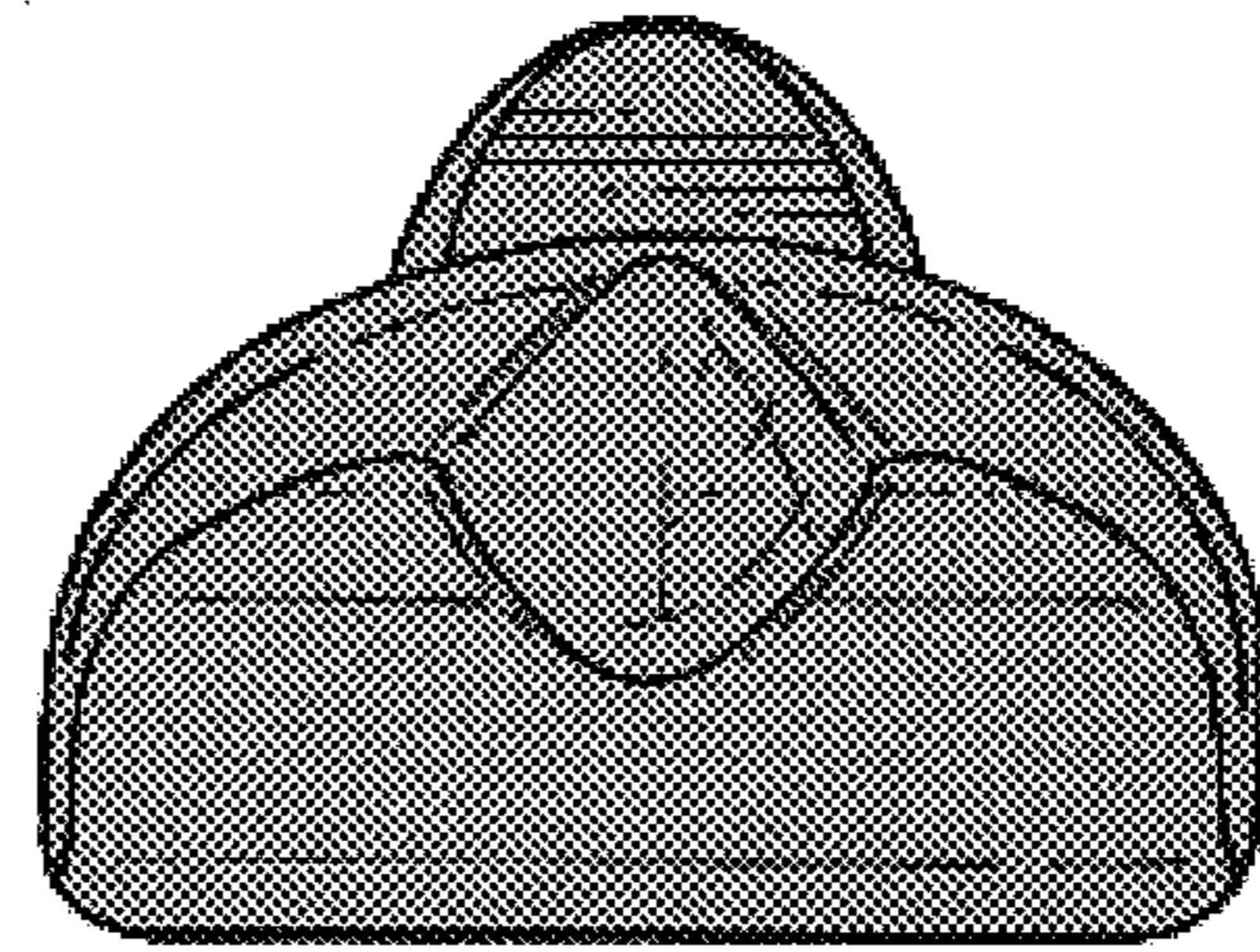

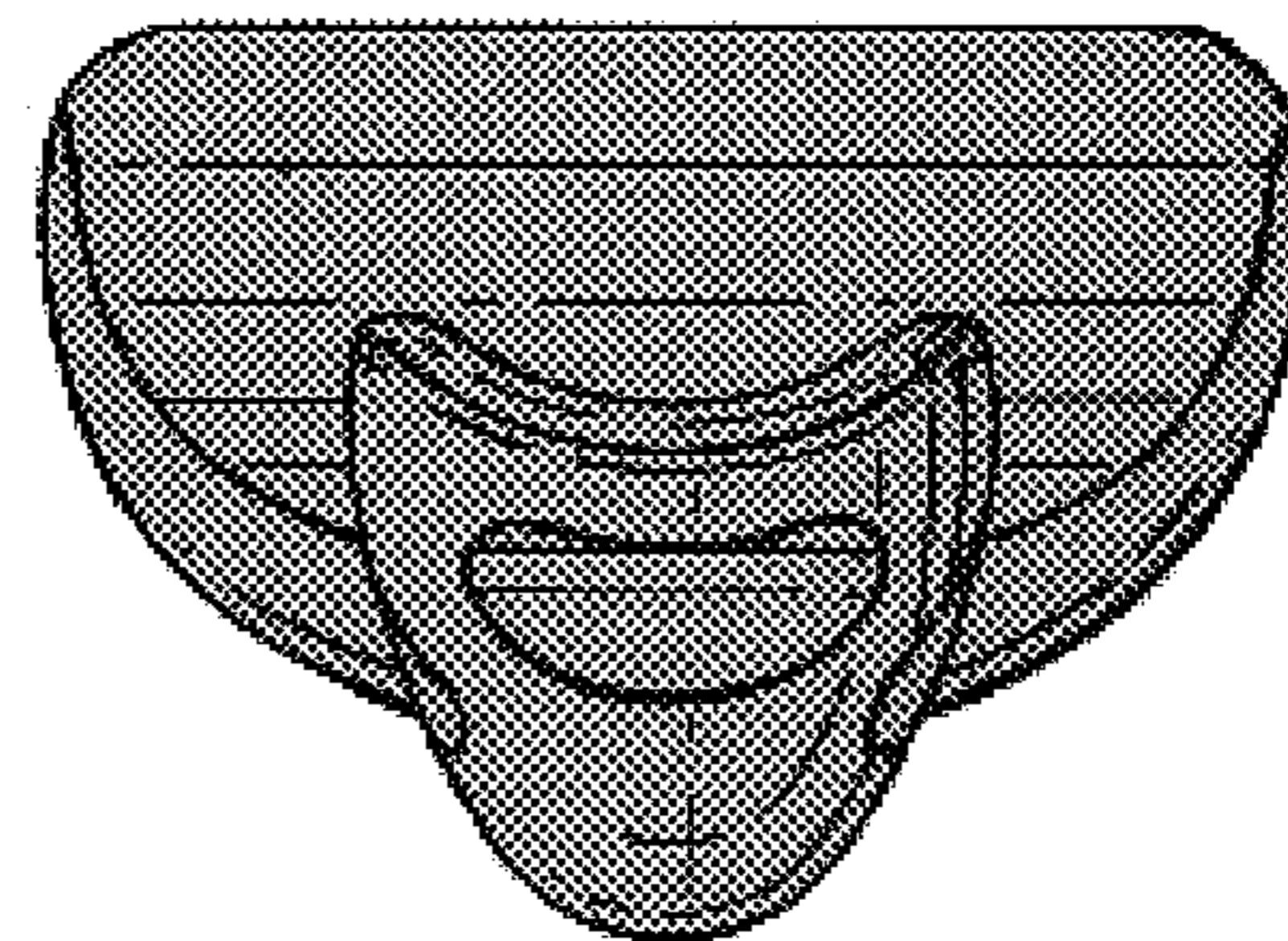
