I claim the ornamental design for a wand for a domestic appliance, as shown and described.

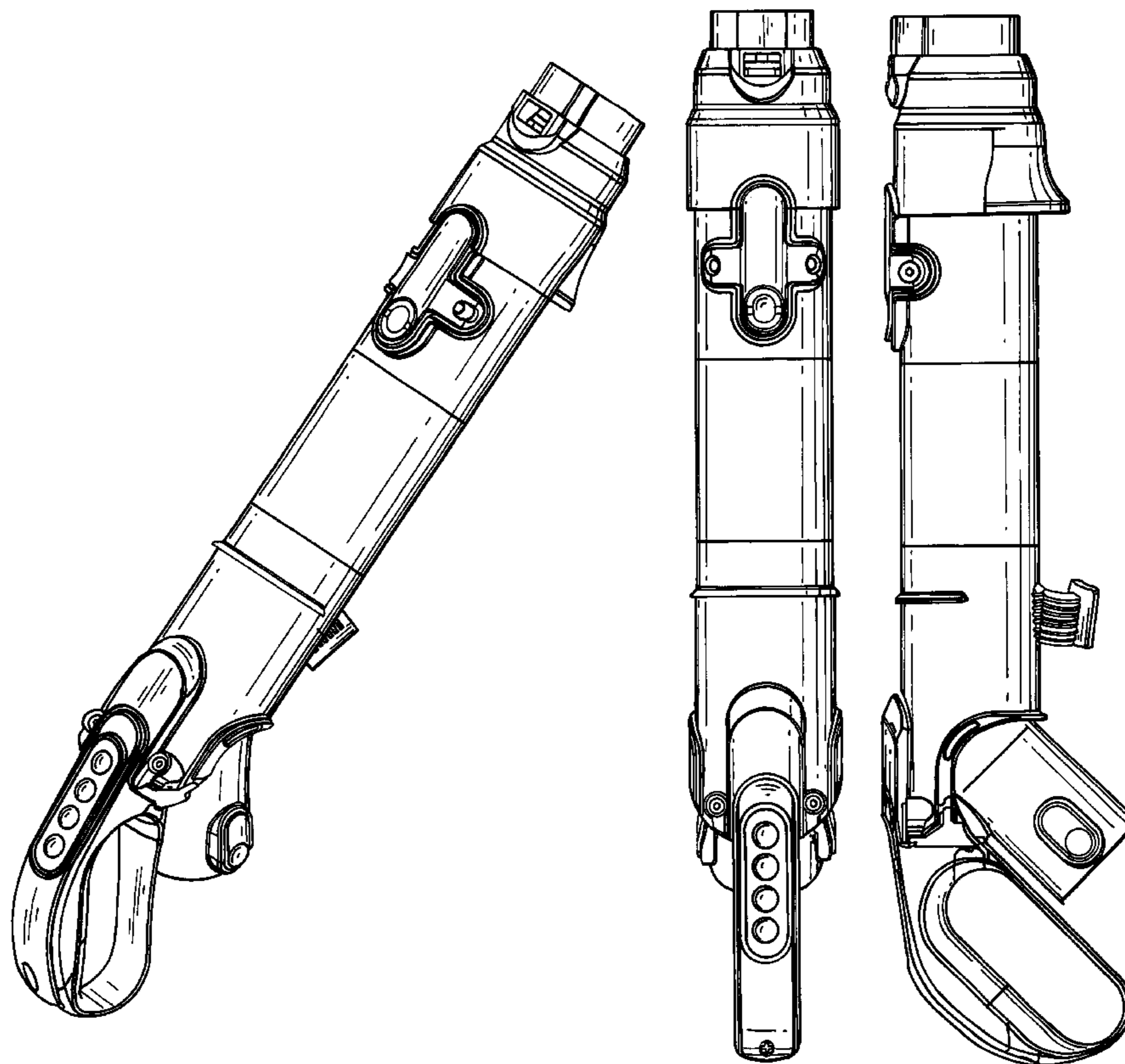
DESCRIPTION

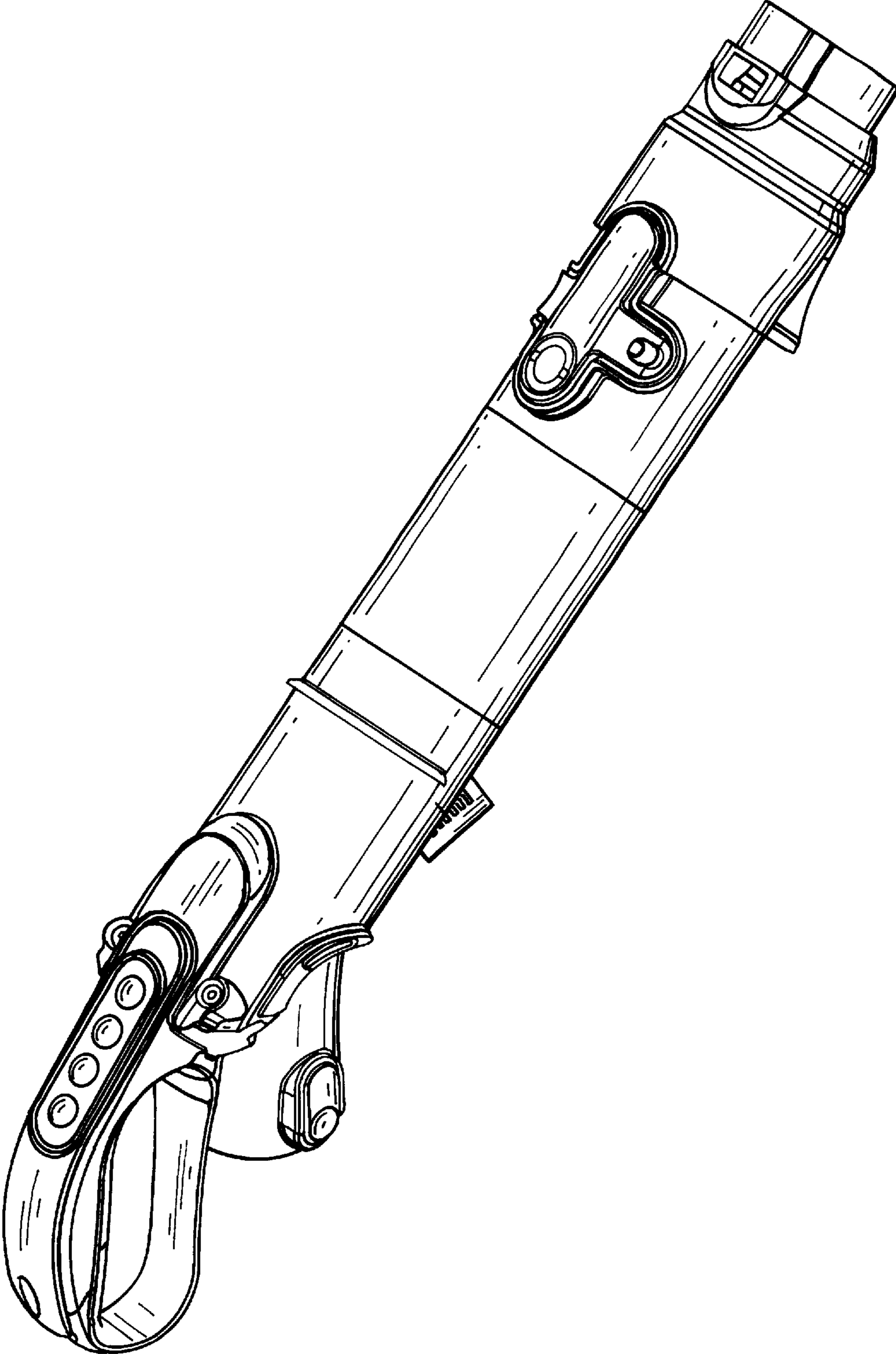

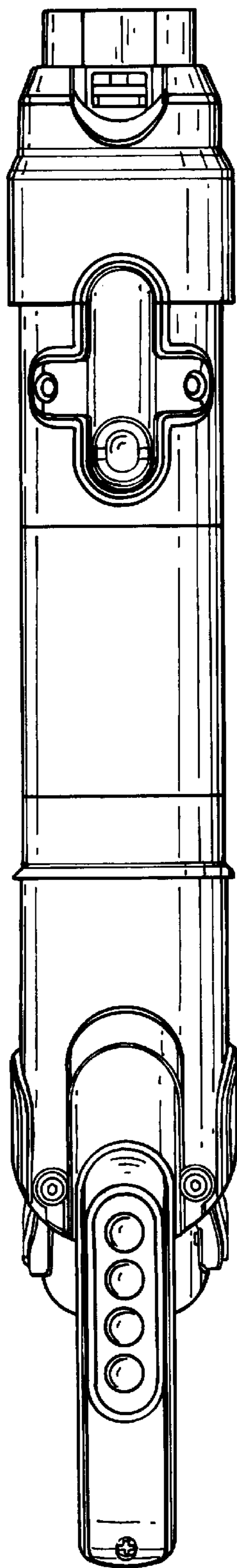

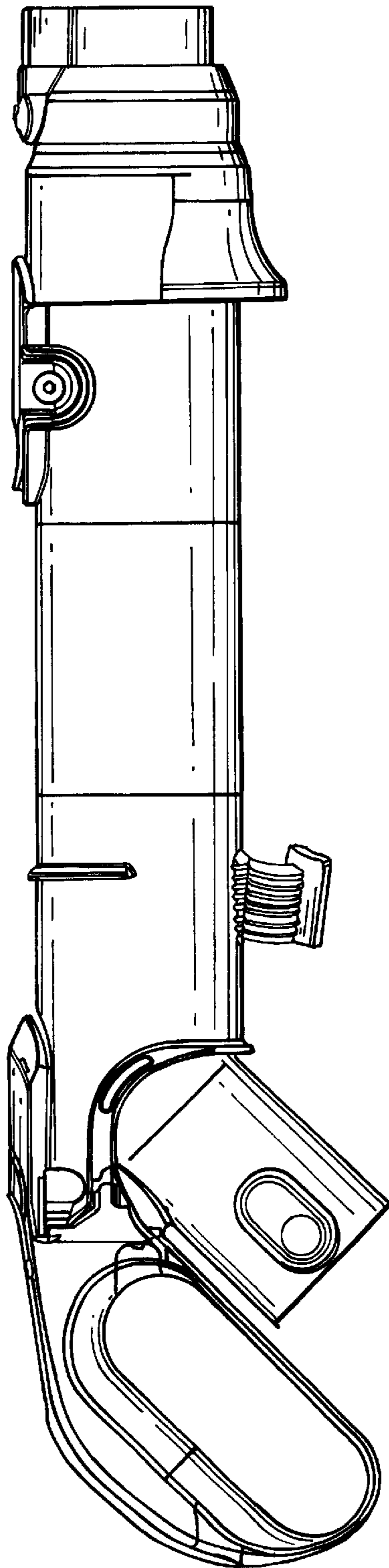

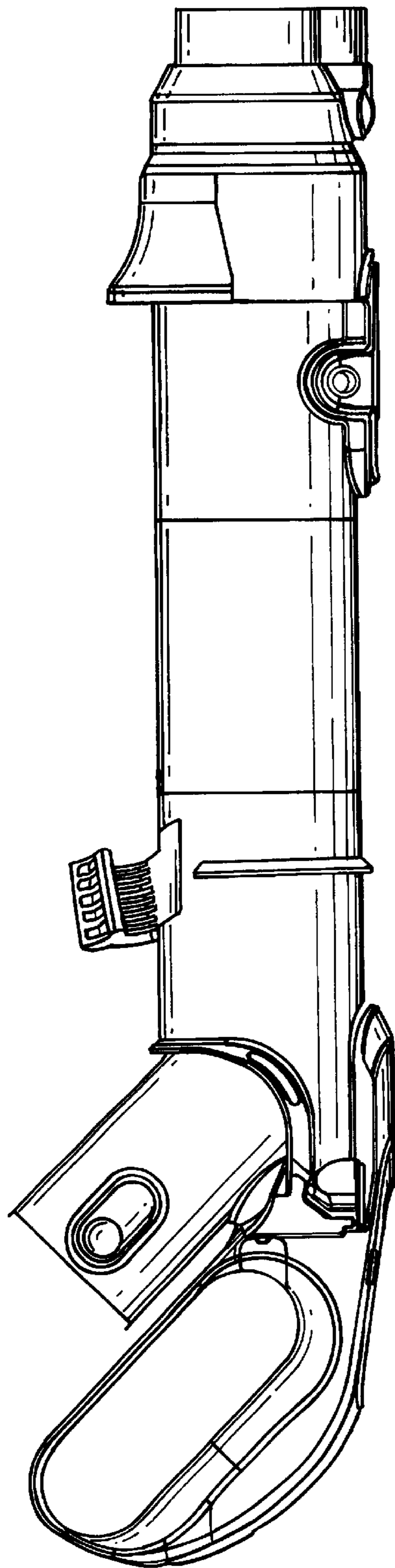

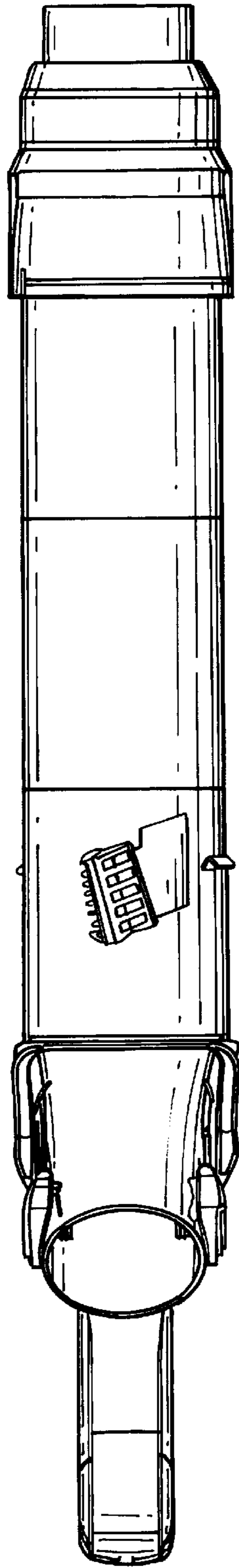
