(57) **CLAIM**

The ornamental design for daily pill reminder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the daily pill reminder according to the present invention, the container including seven sets of four compartments, a lid being associated with each compartment.

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a back view thereof;

FIG. 7 is a front view thereof with a lid of the container in an open position to provide viewing into the compartment associated with the lid; and,

FIG. 8 is a right side view of the container shown in FIG. 7. The broken line showing of environment in the drawings if for illustrative purposes only and forms no part of the claimed design.

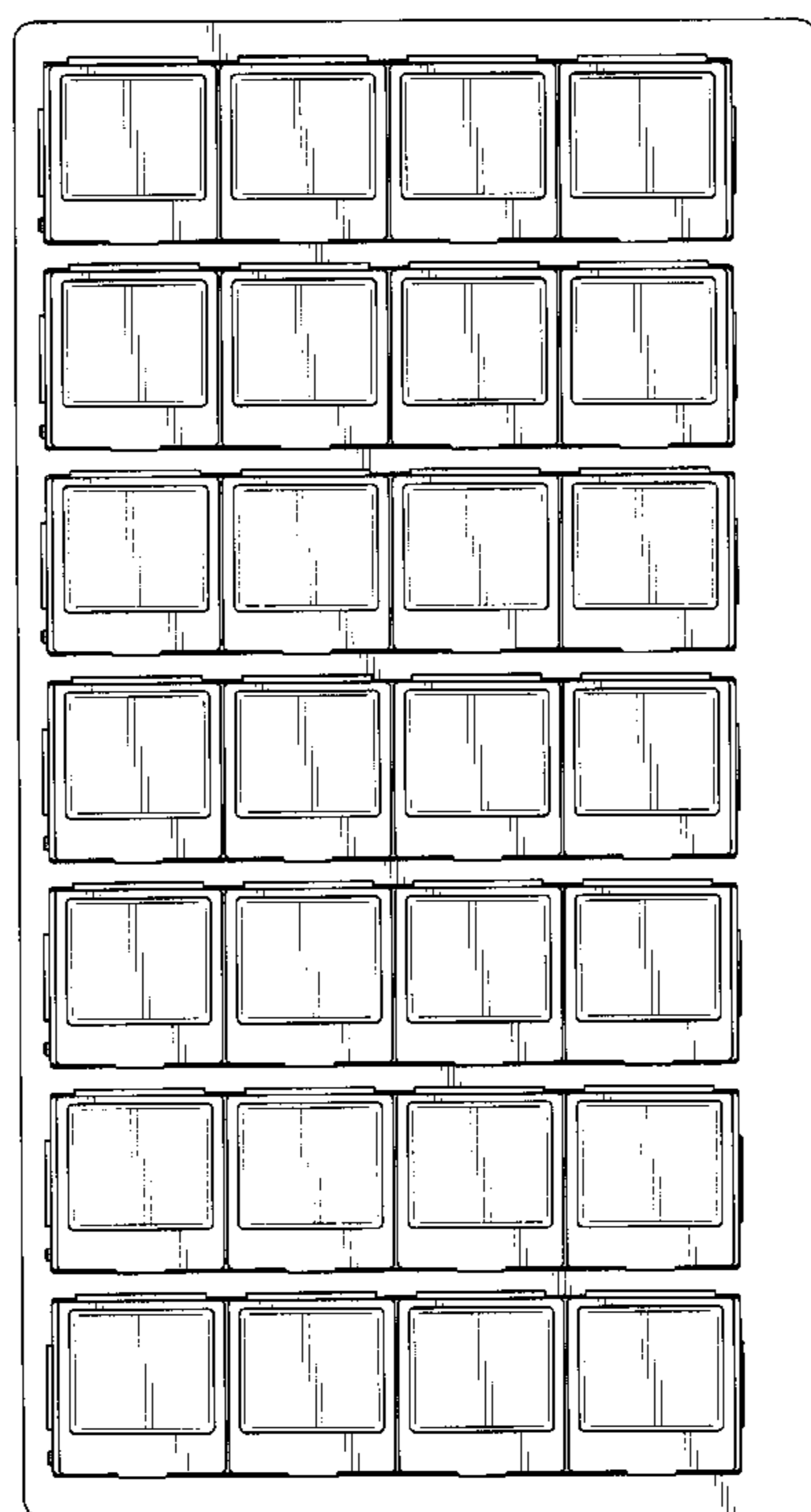

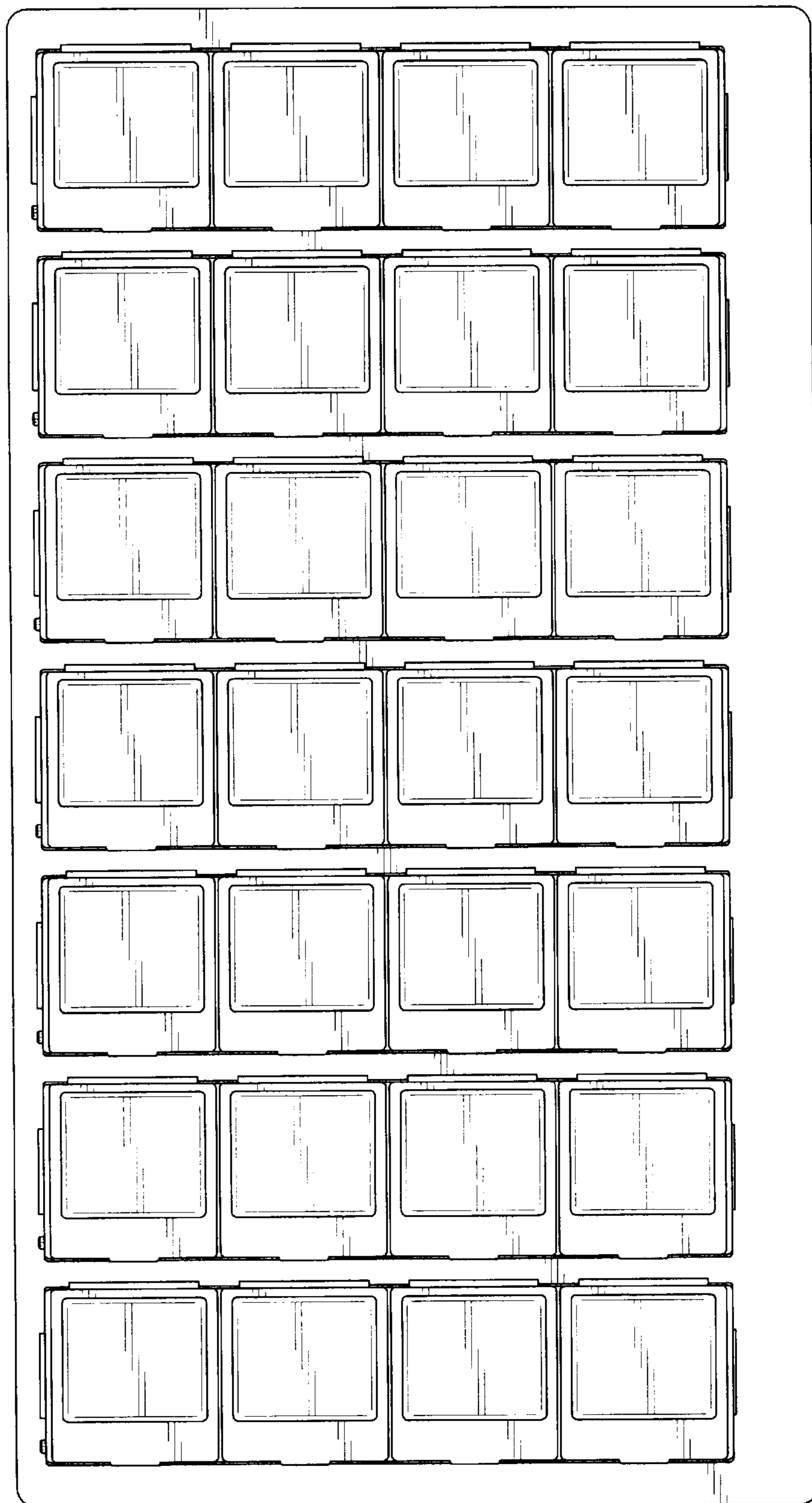

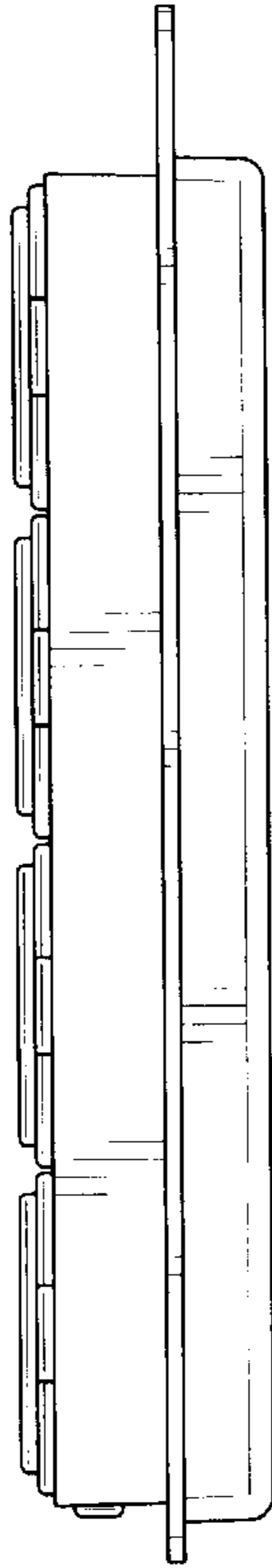

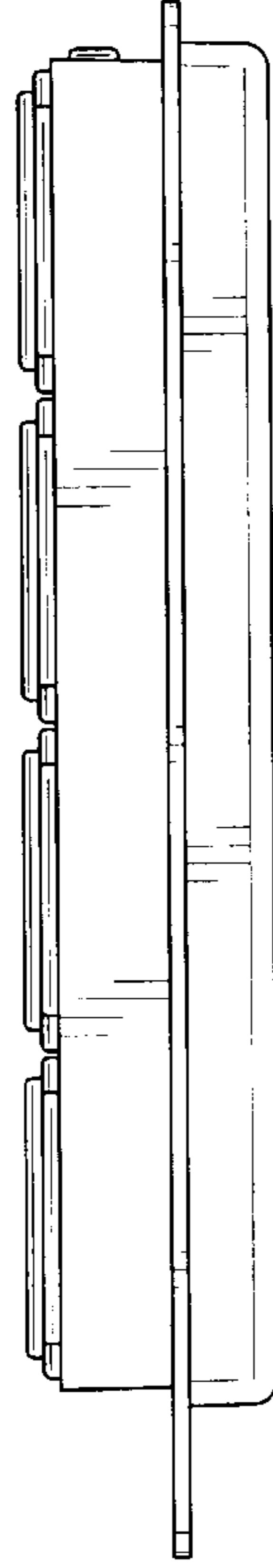

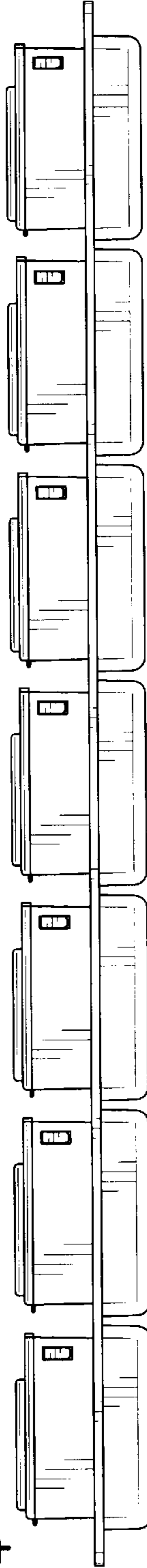

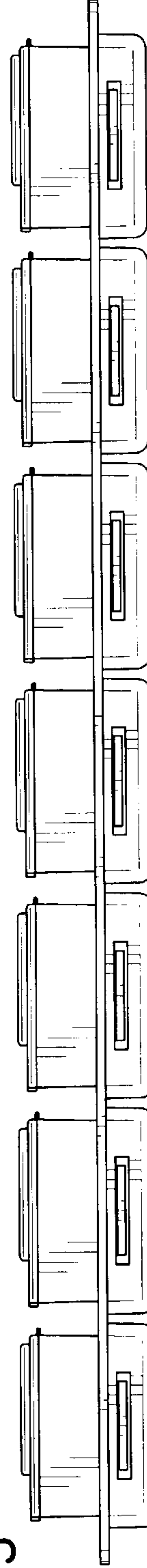

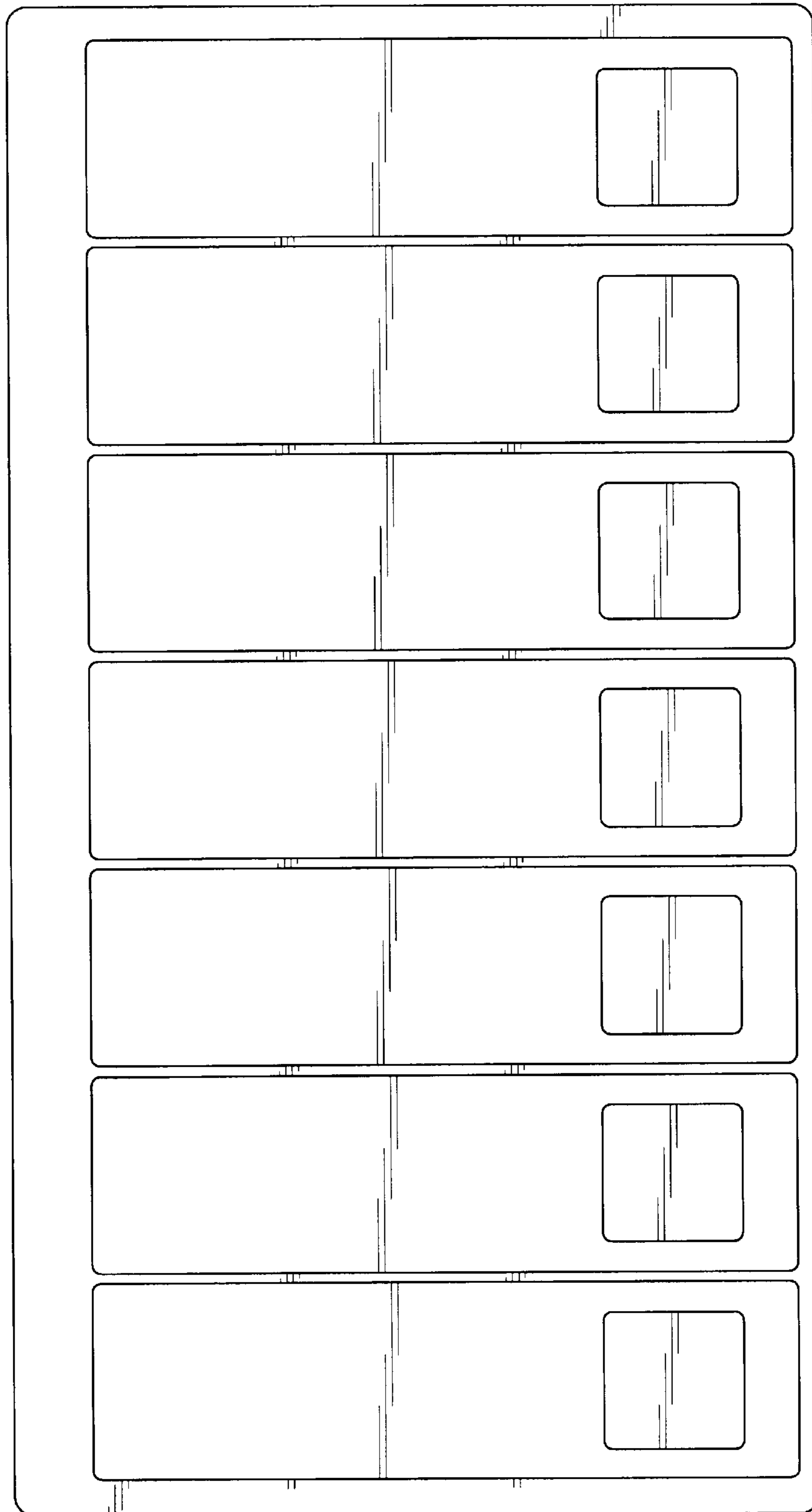
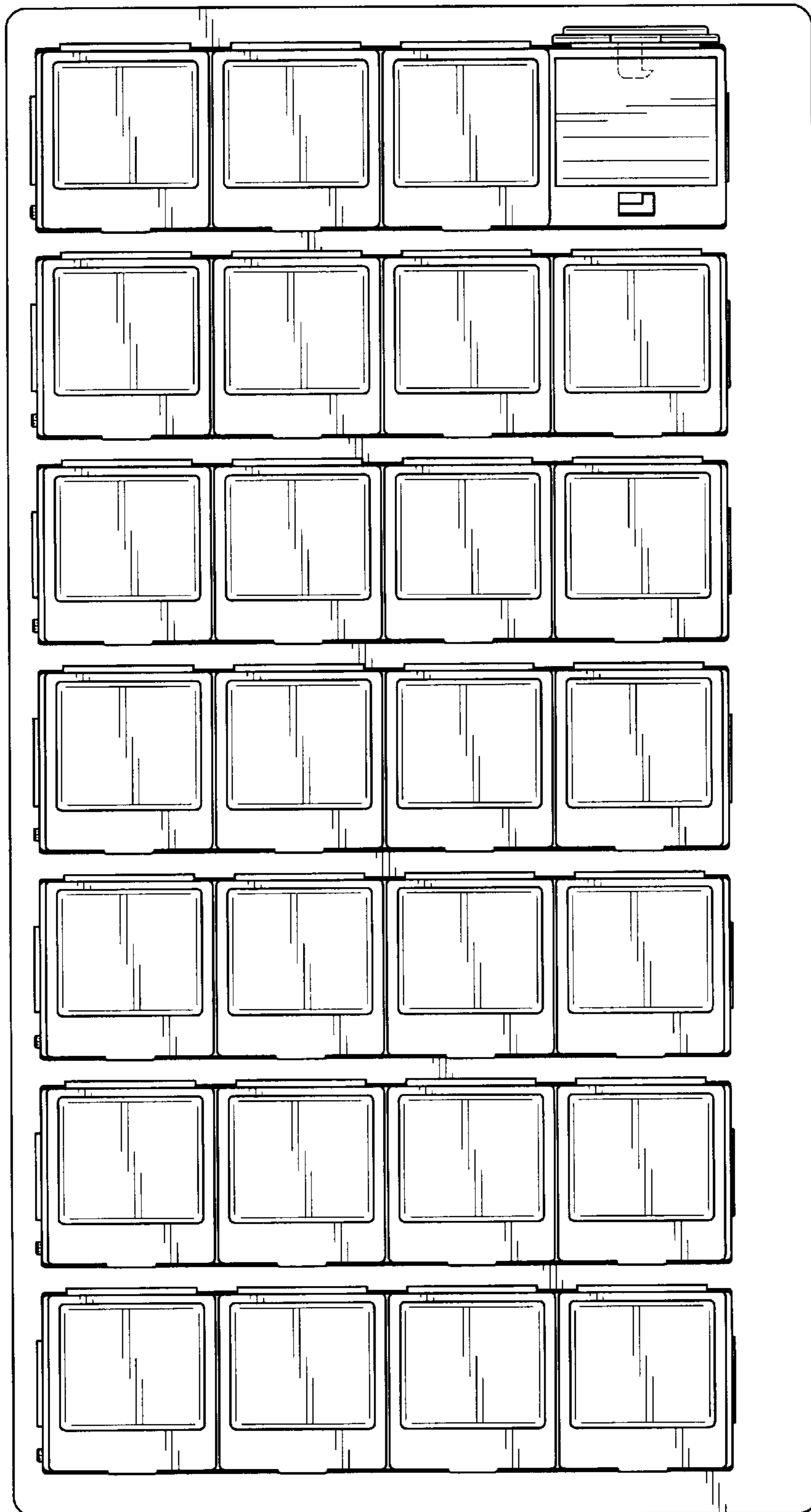

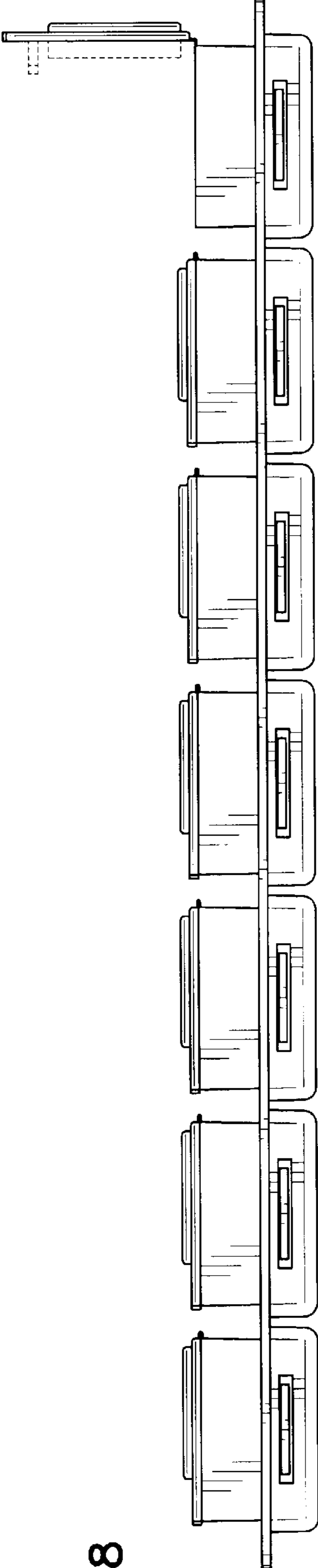
