(57) **CLAIM**

I claim the ornamental design appearance of a suspended storage structure, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the suspended storage structure, showing my new design;
 FIG. 2 is a lower perspective view of the suspended storage structure shown in FIG. 1;
 FIG. 3 is a top plan view of the suspended storage structure shown in FIG. 1;
 FIG. 4 is a bottom plan view of the suspended storage structure shown in FIG. 1;
 FIG. 5 is a front elevation view of the suspended storage structure shown in FIG. 1;
 FIG. 6 is a rear elevation view of the suspended storage structure shown in FIG. 1;
 FIG. 7 is a left side elevation view of the suspended storage structure shown in FIG. 1; and,
 FIG. 8 is a right side elevation view of the suspended storage structure shown in FIG. 1.

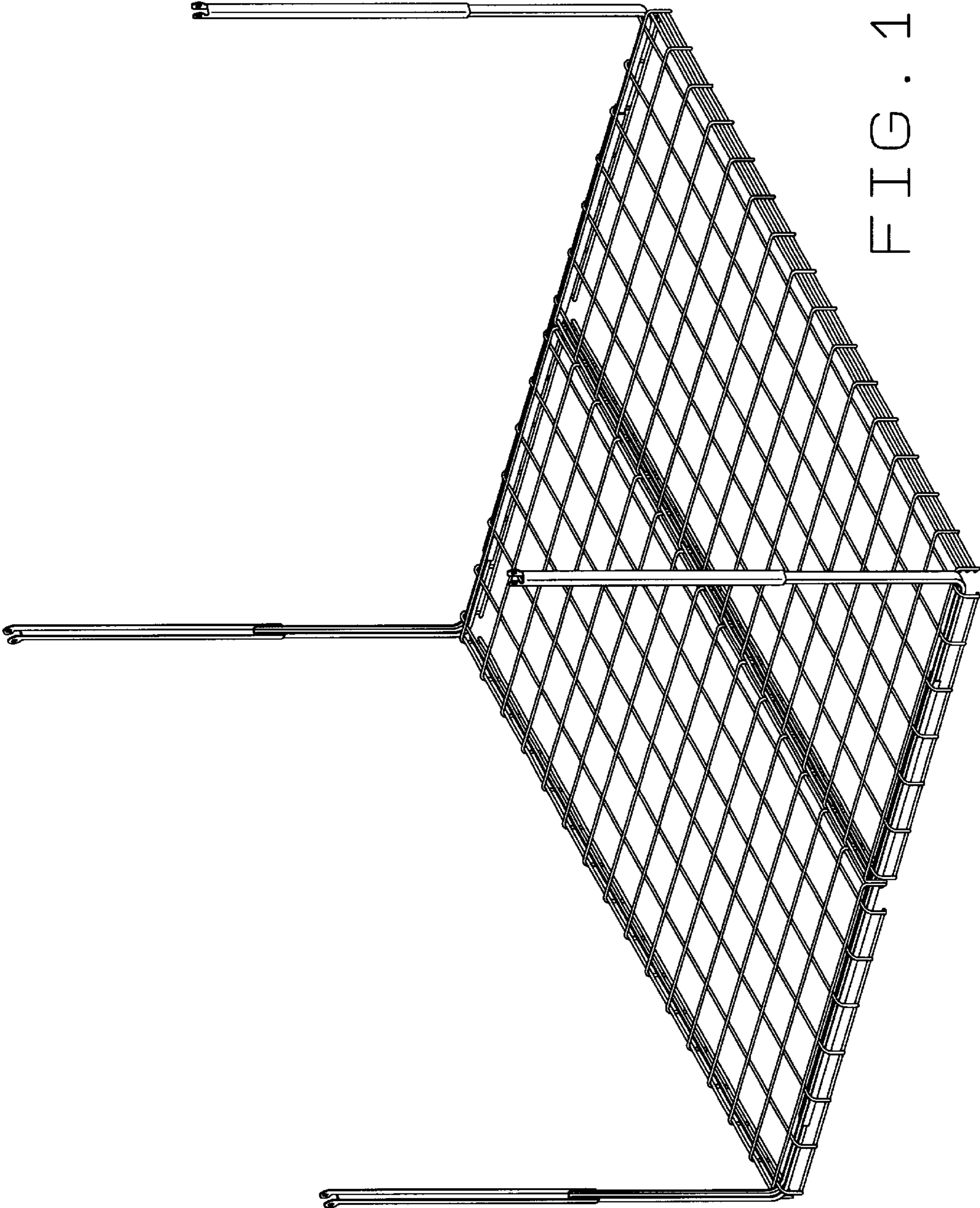

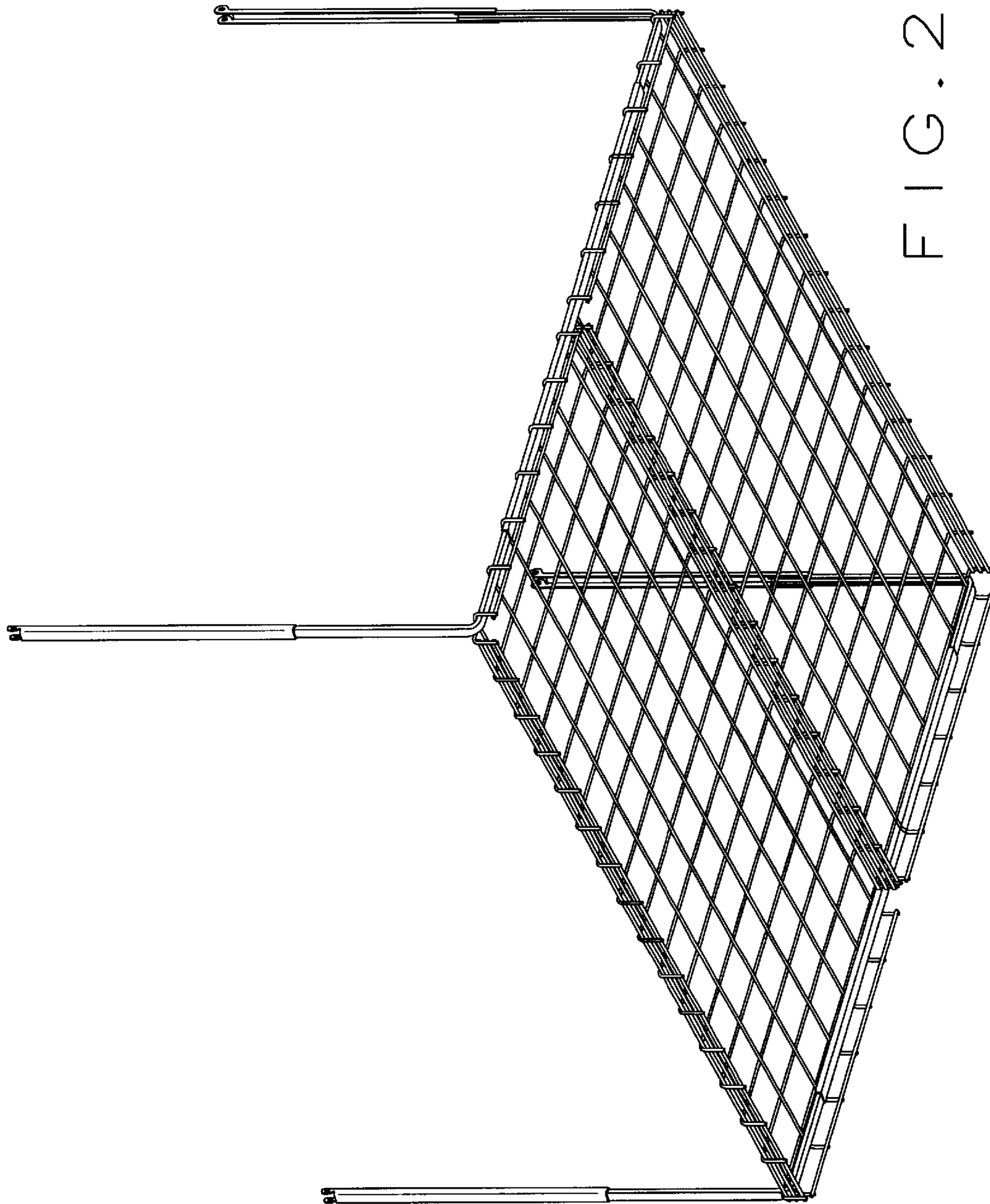

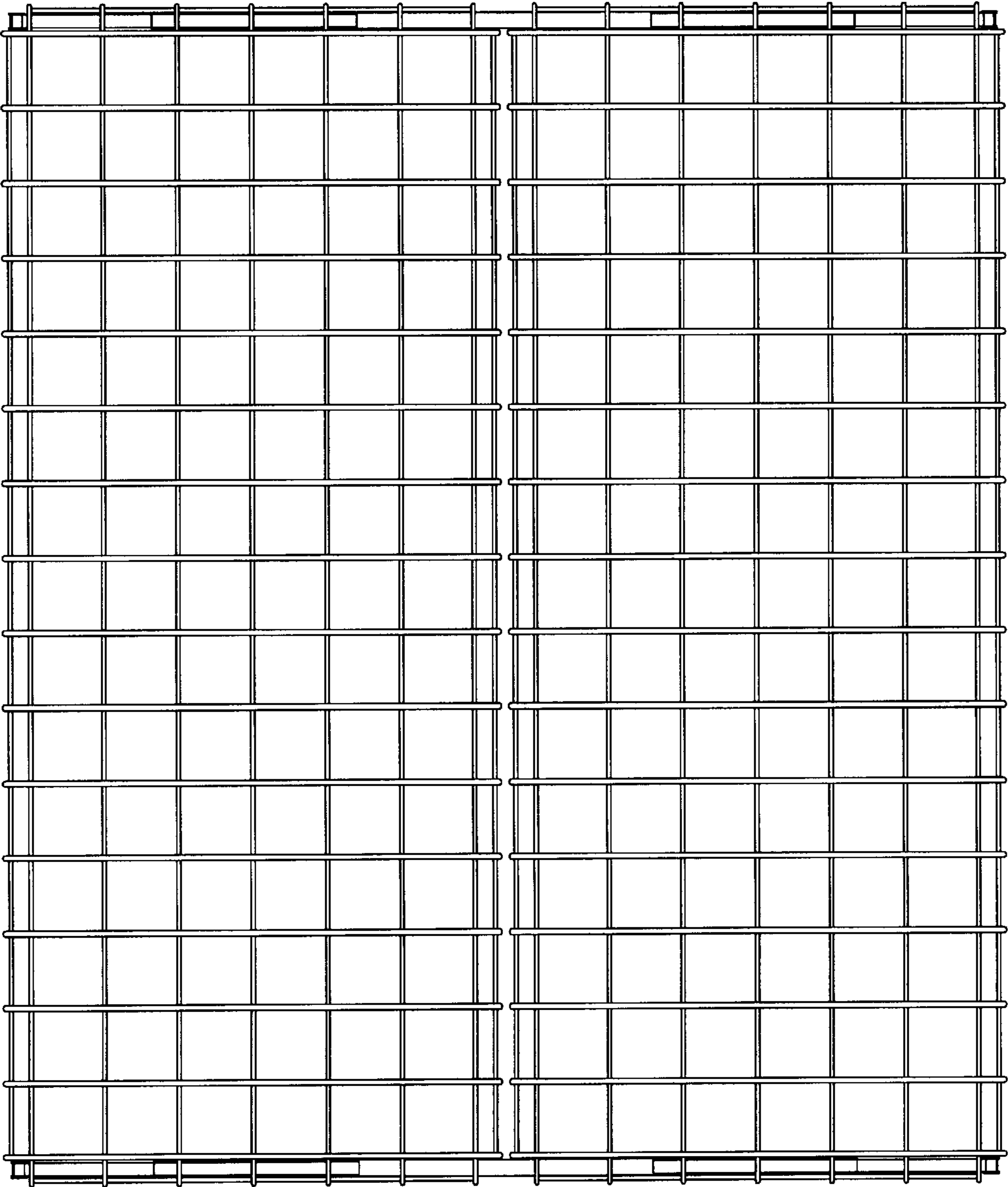

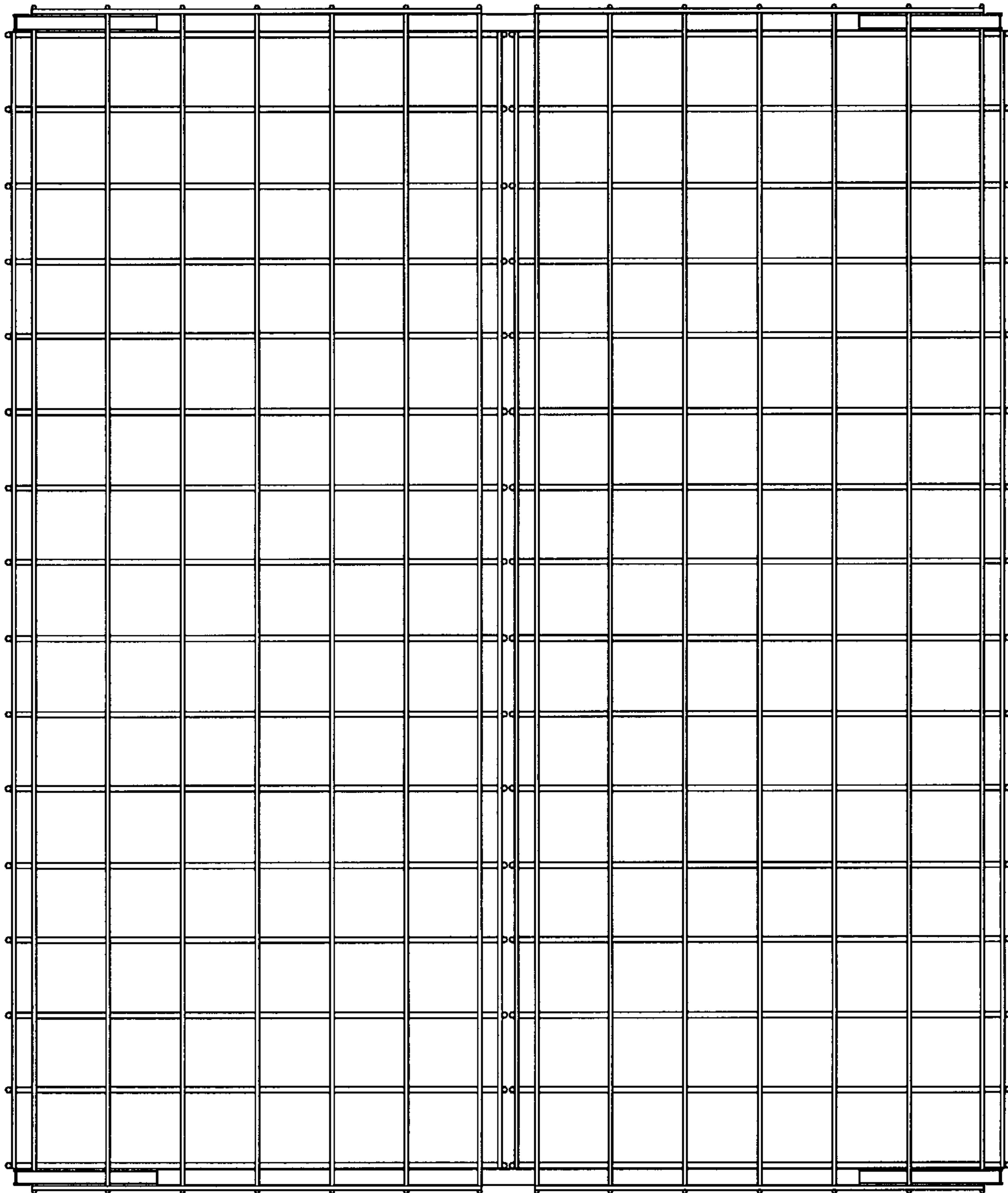

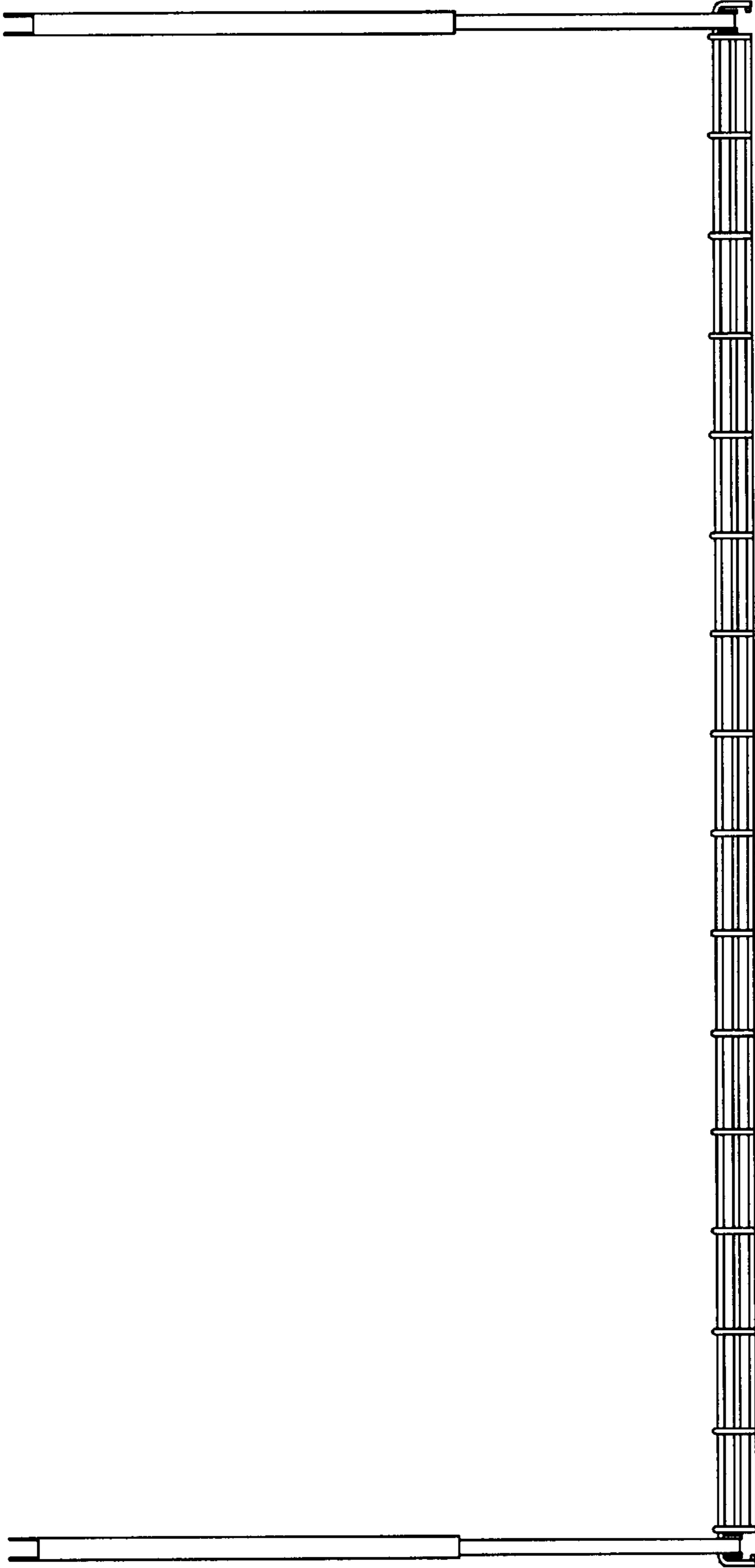

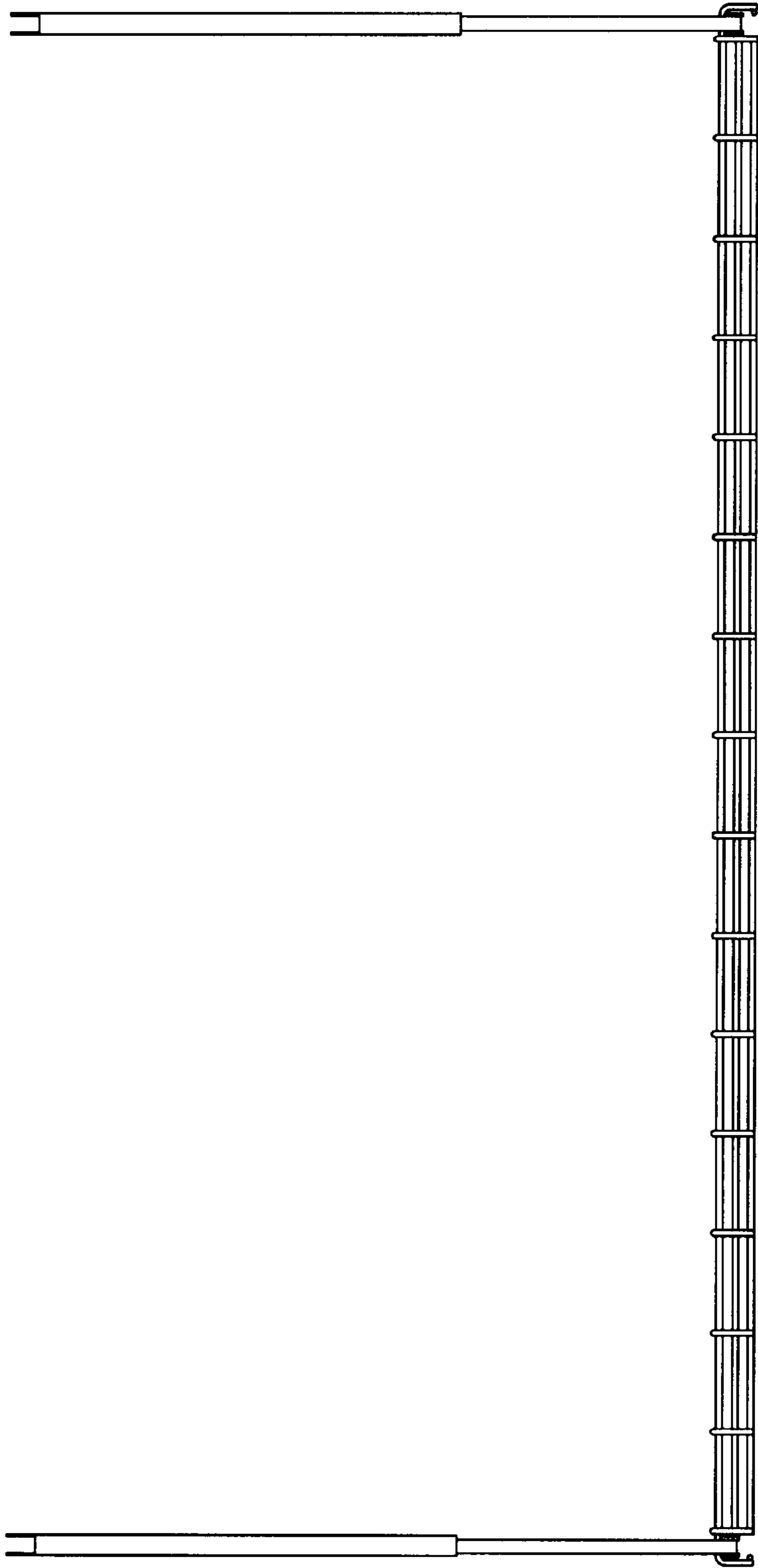

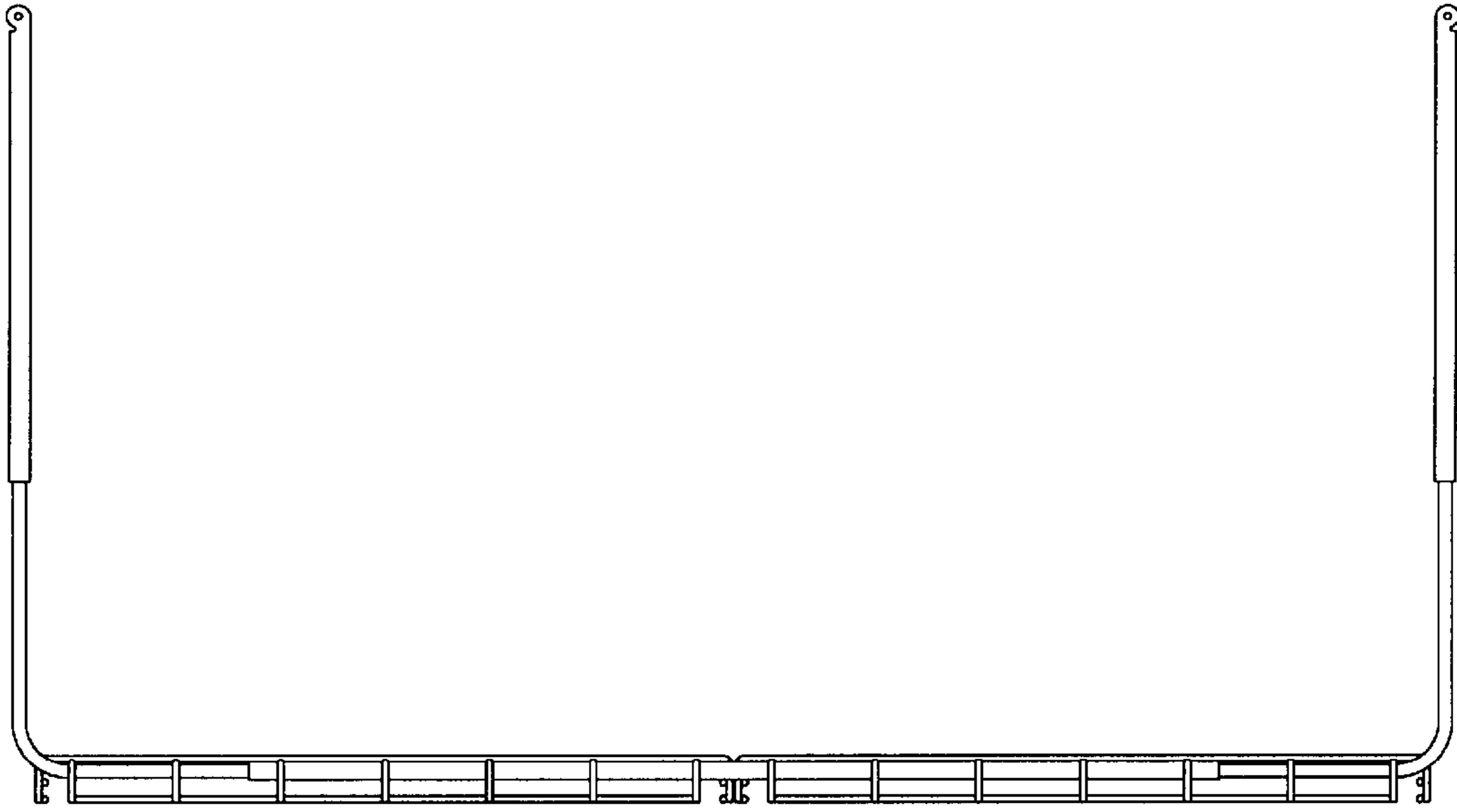
