FIG. 7 is a perspective view of the hinged lid in accordance with my design, in a partially open position.

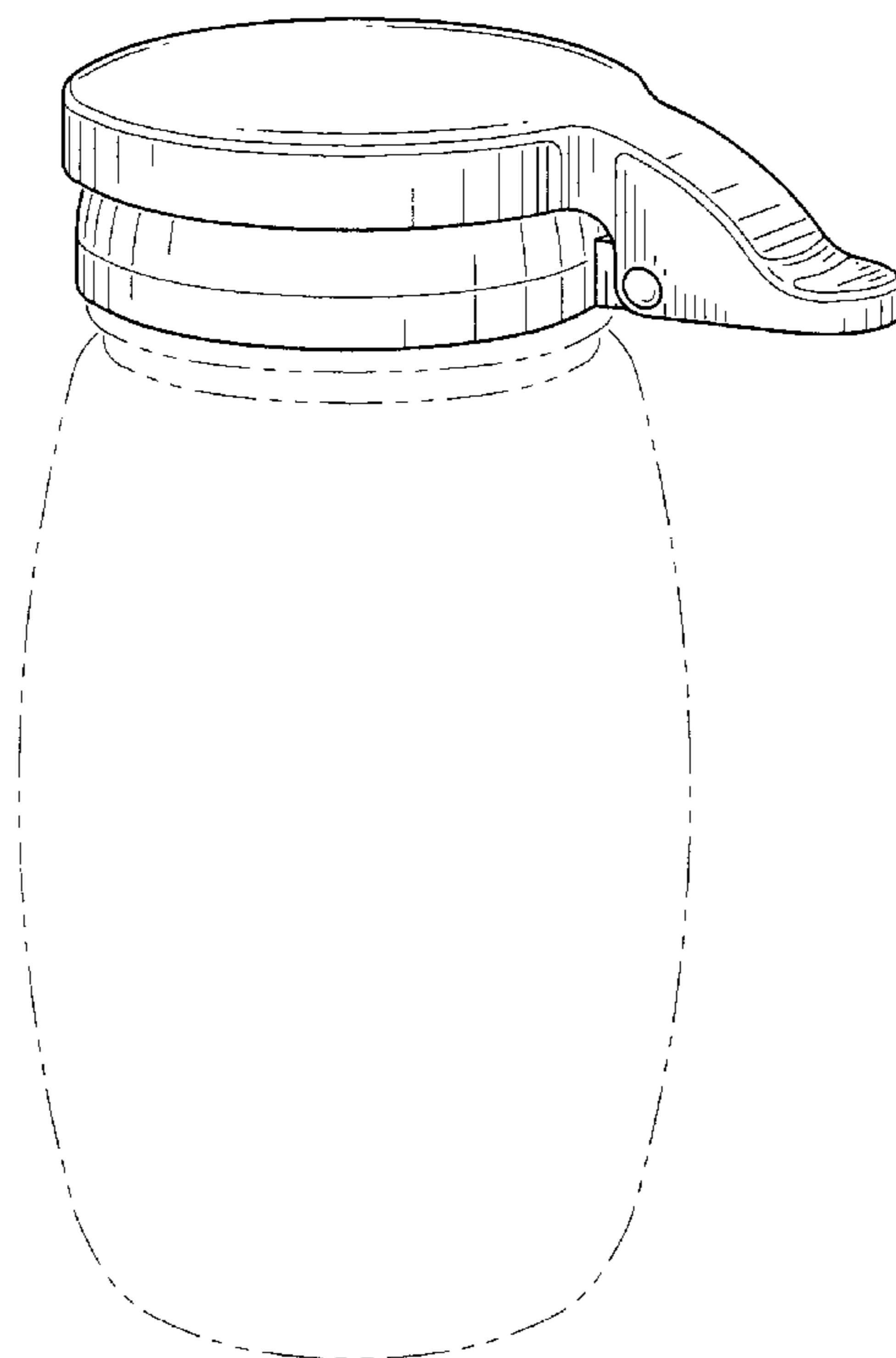

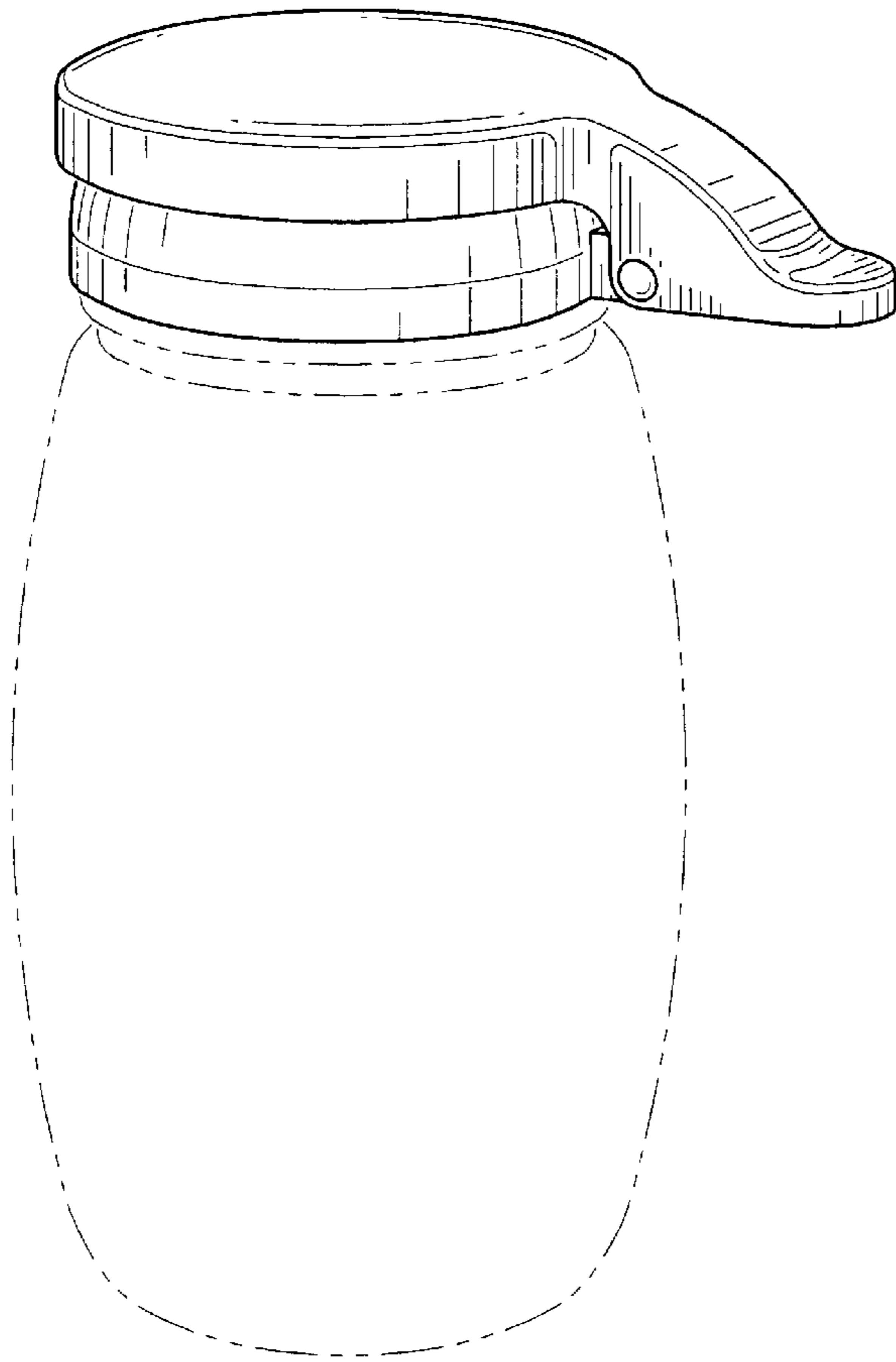

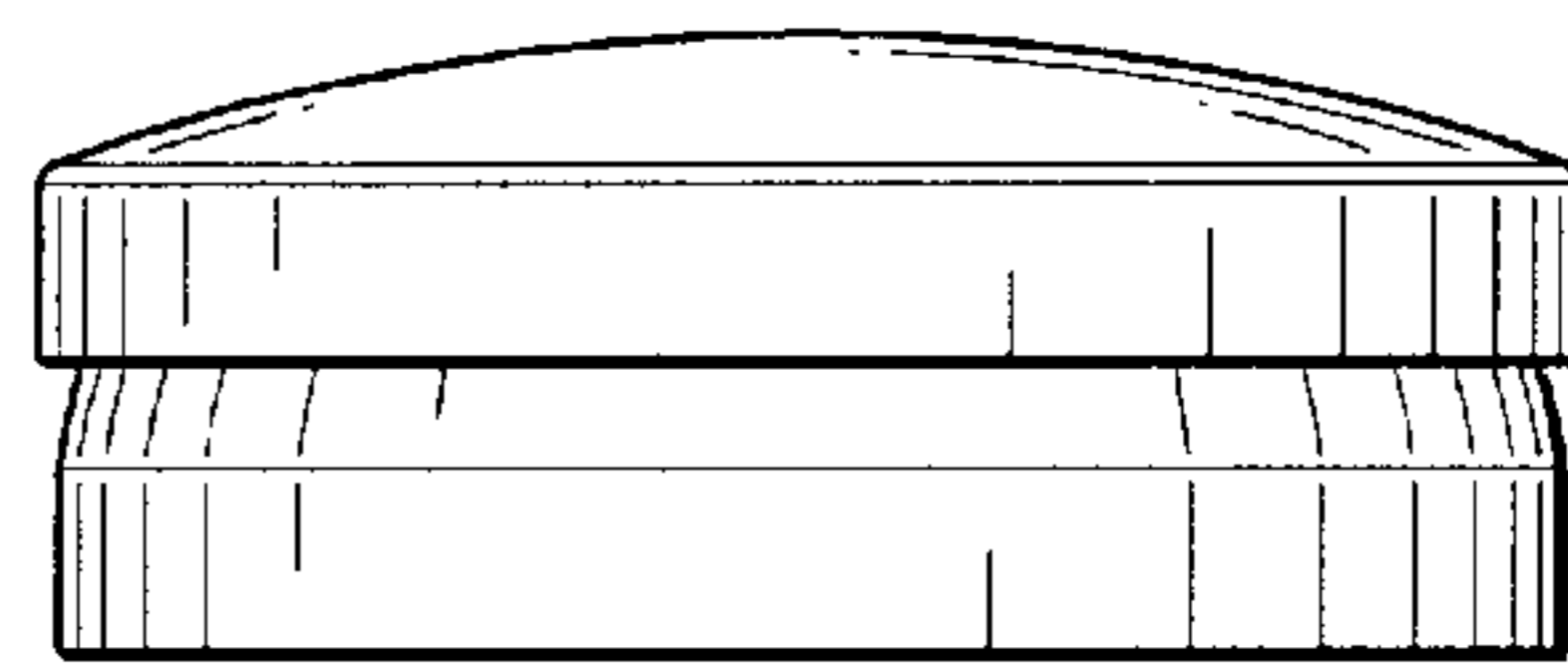

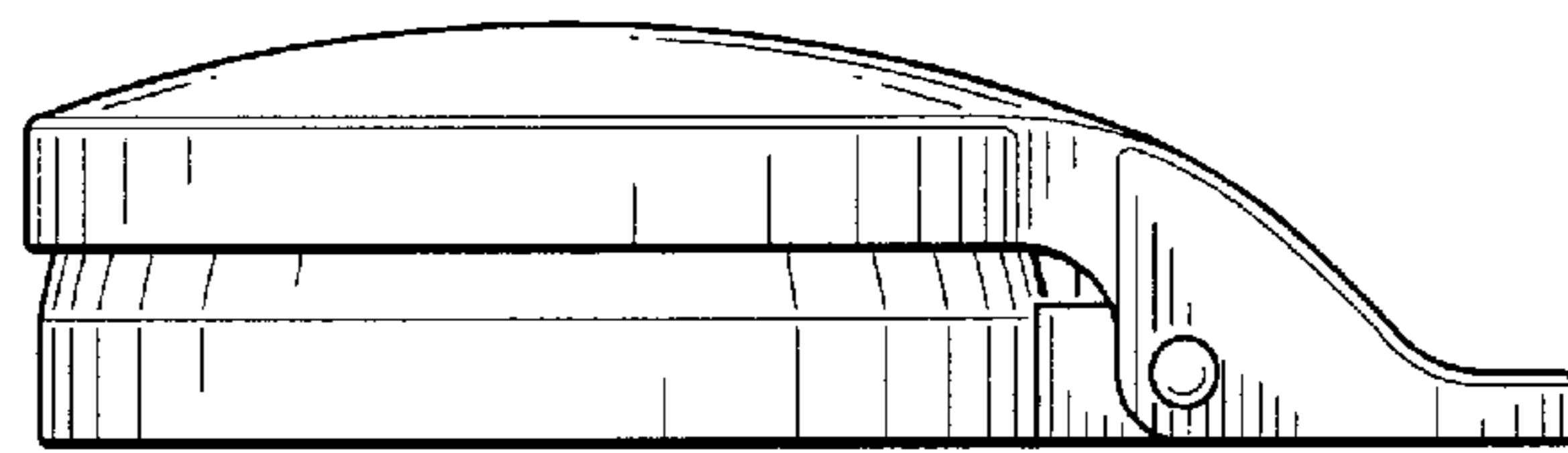

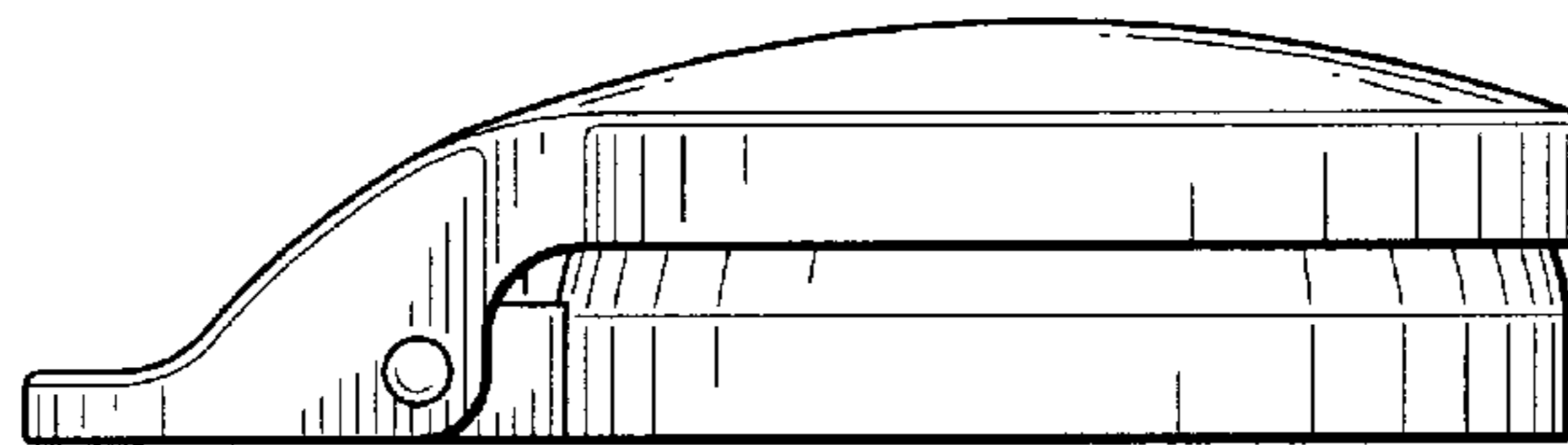

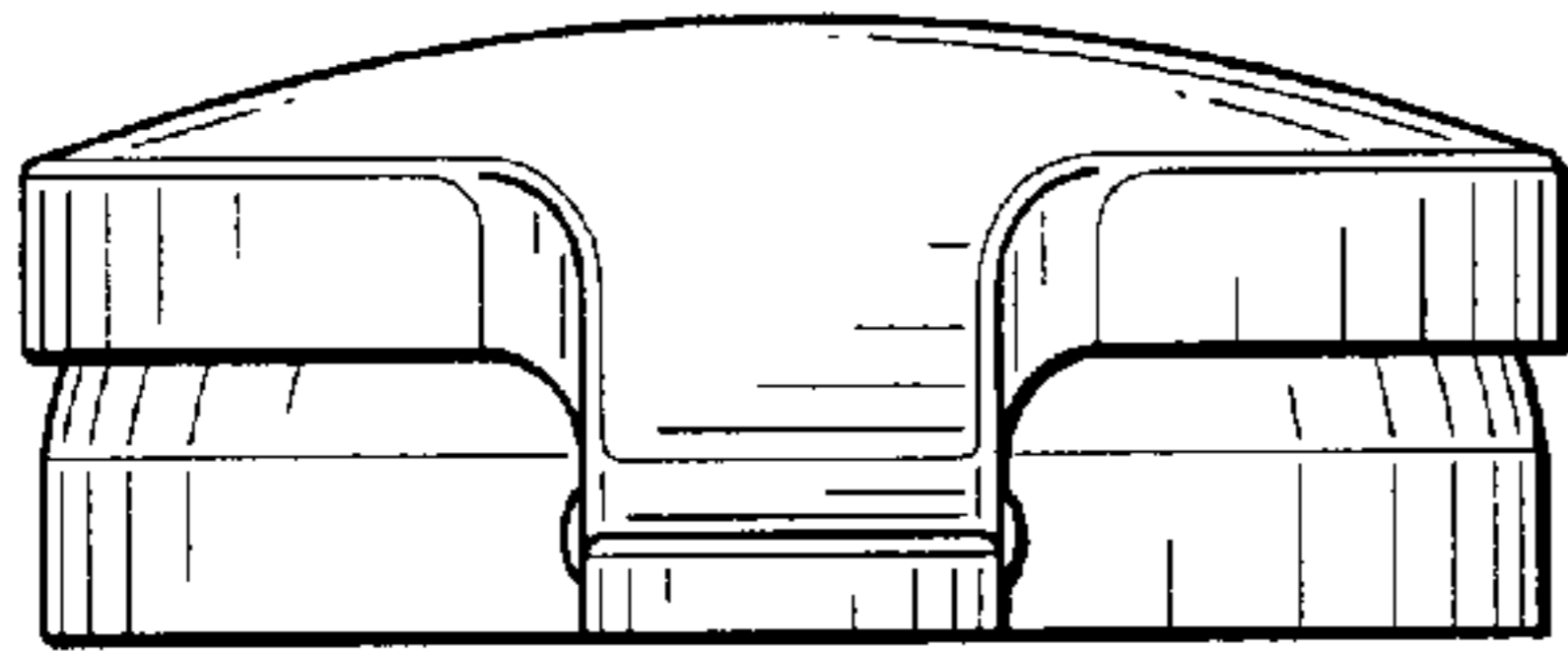

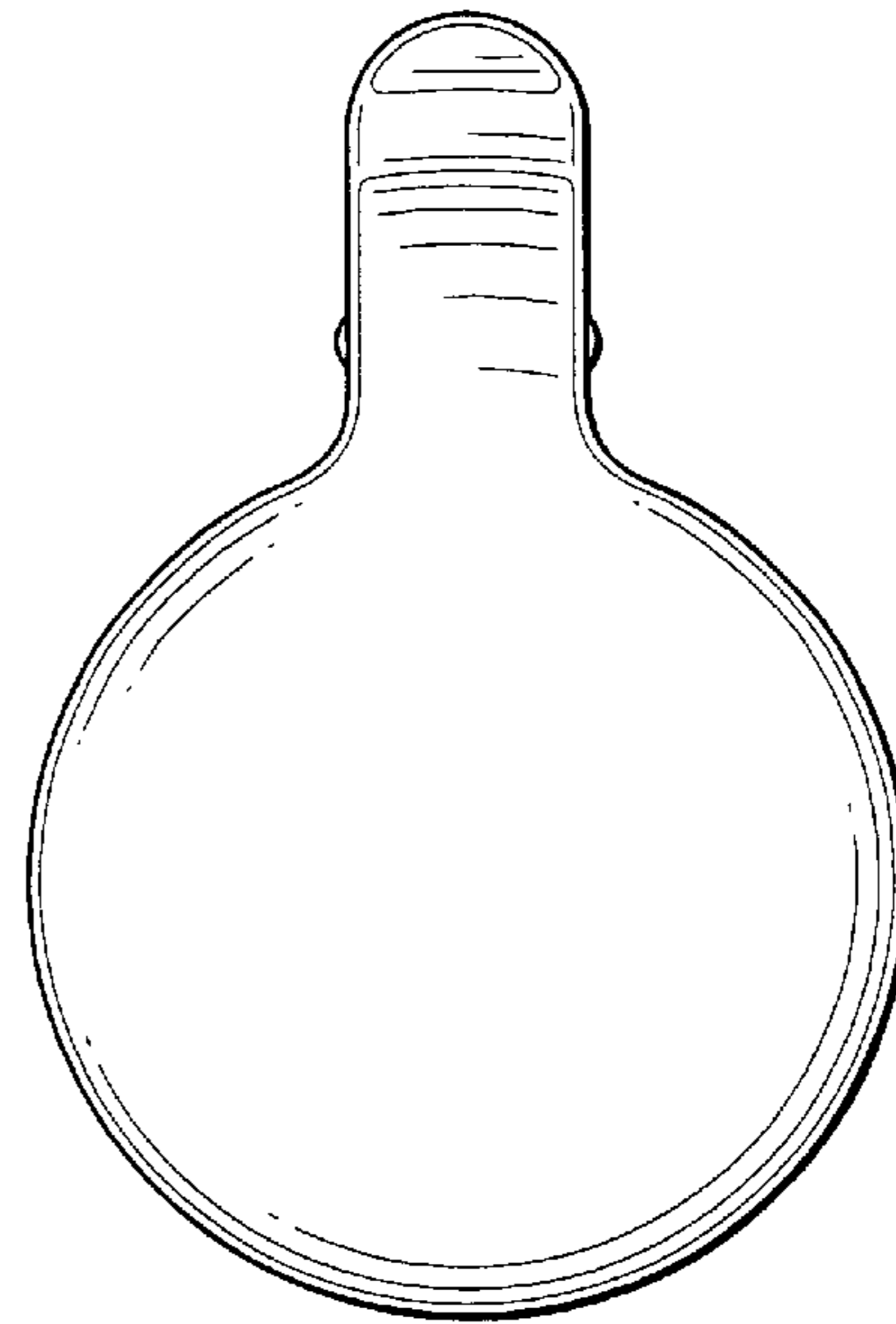

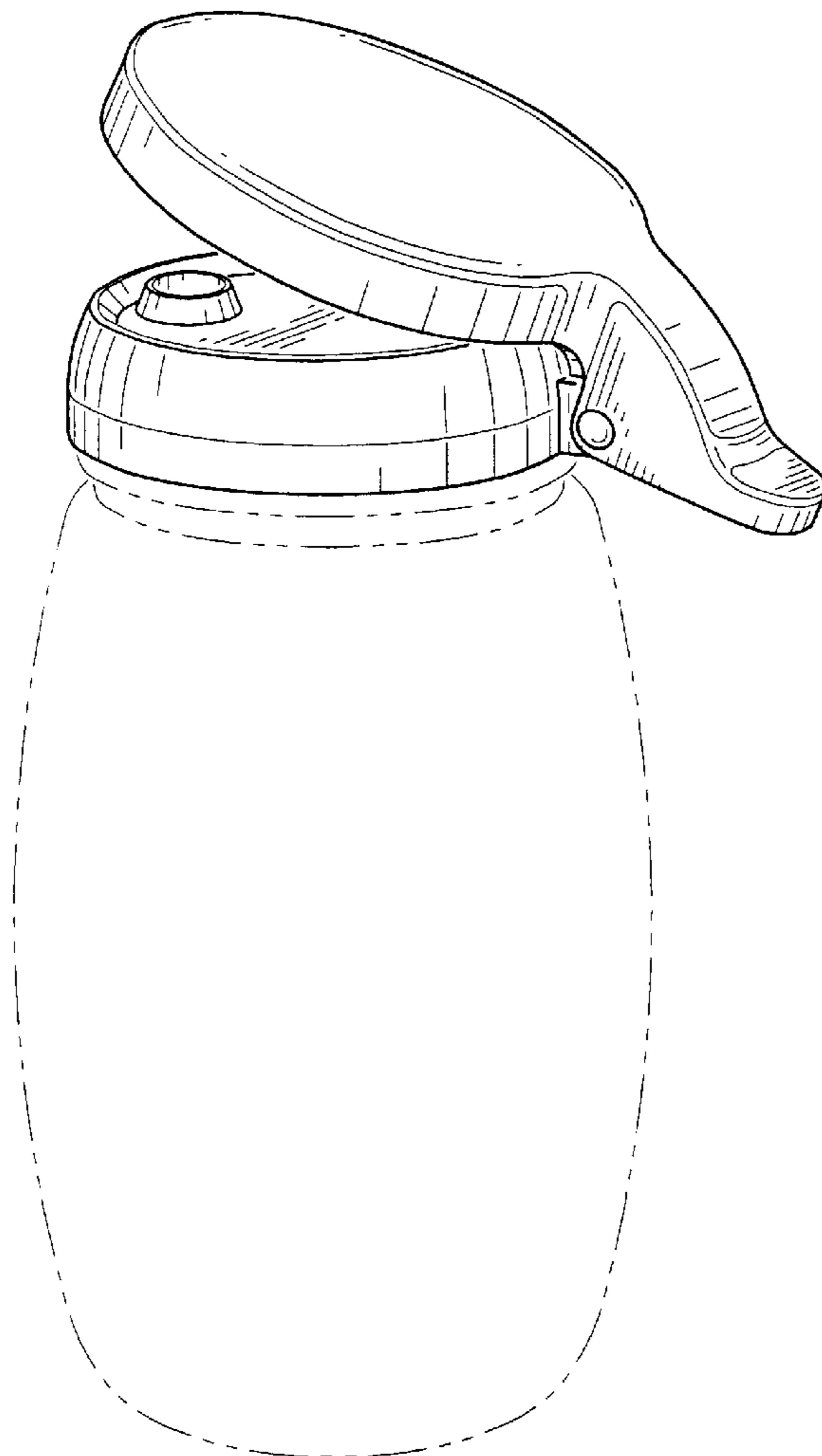
