**DESCRIPTION**

signal input device showing our new design;

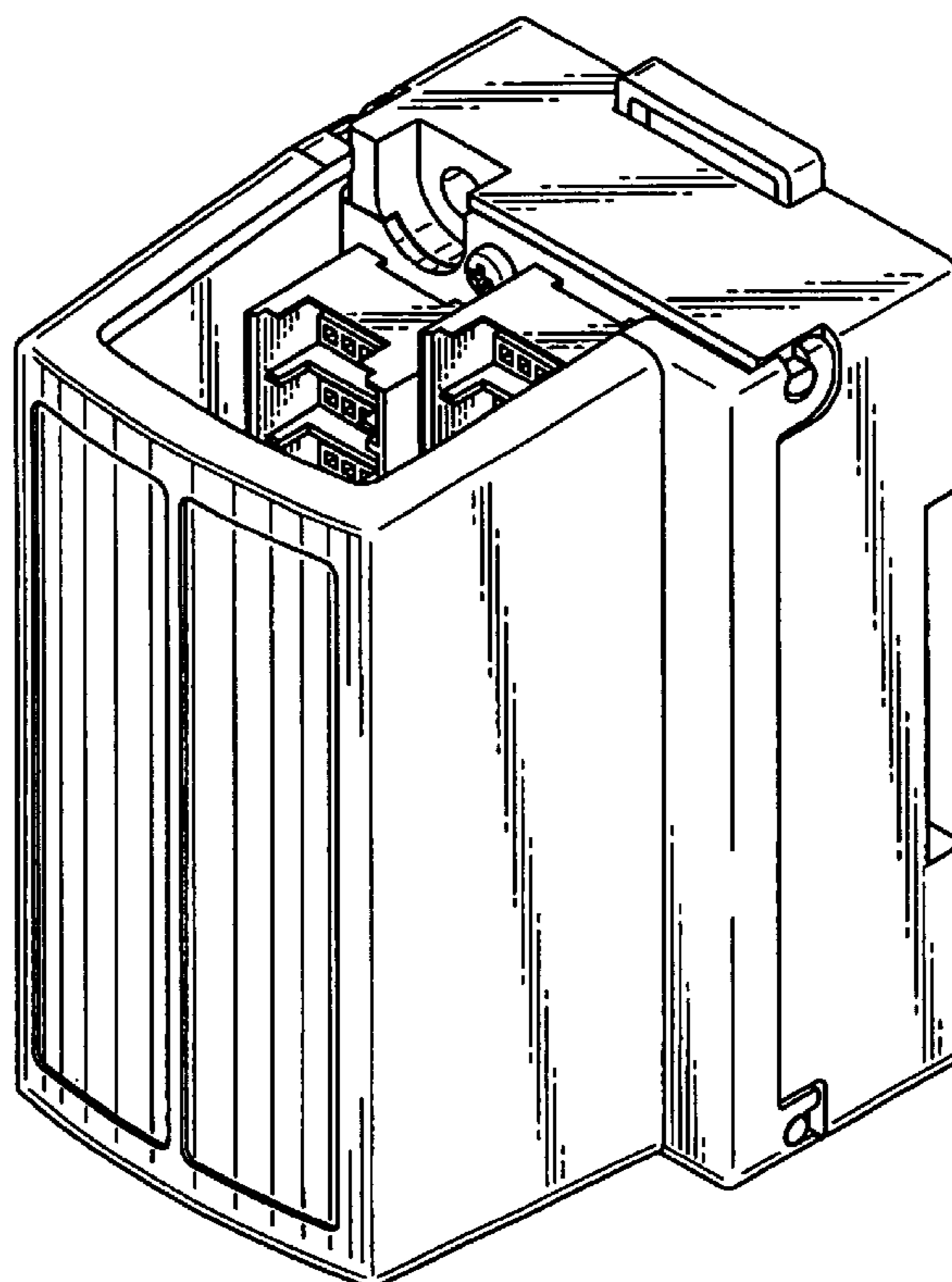

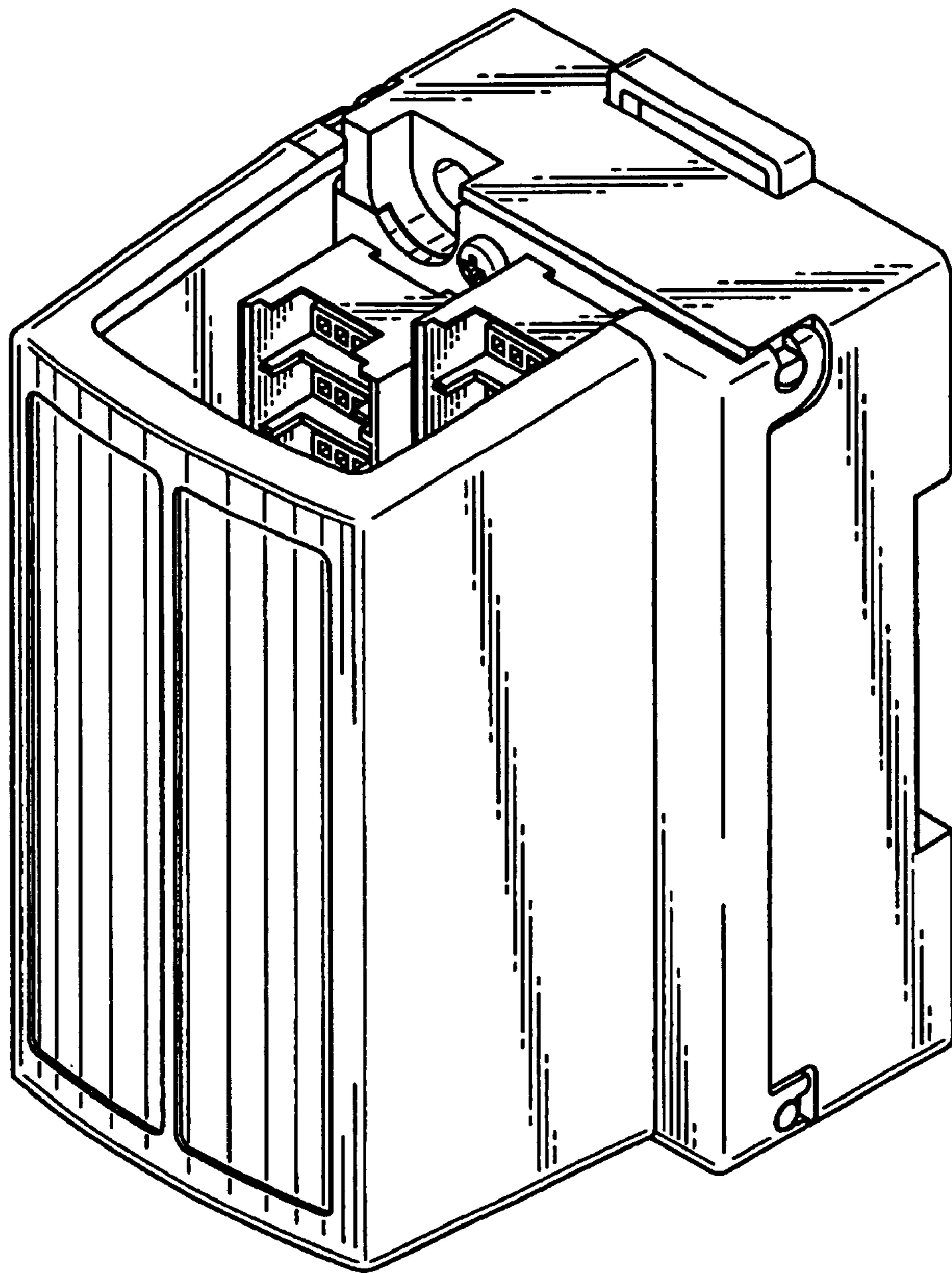

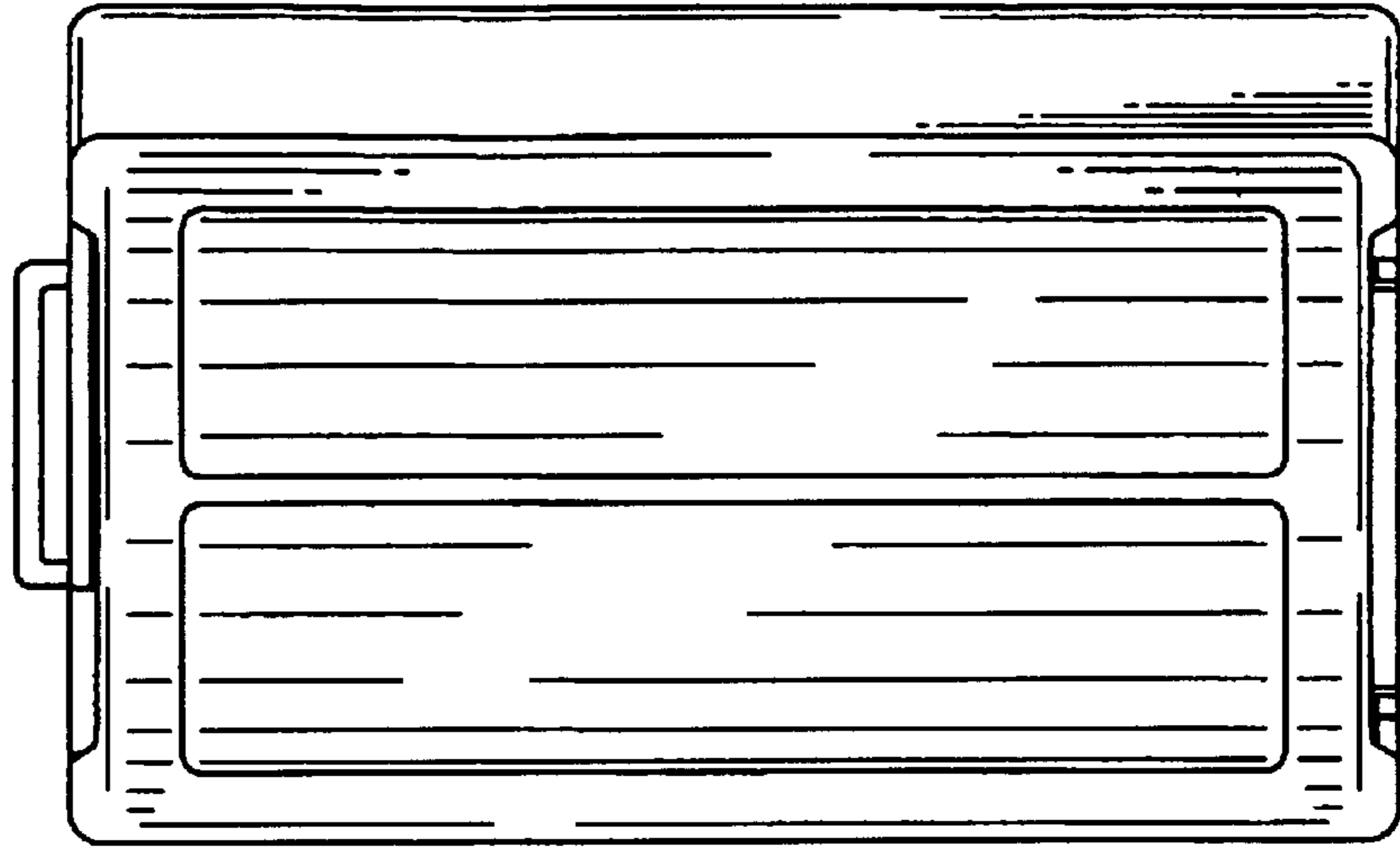

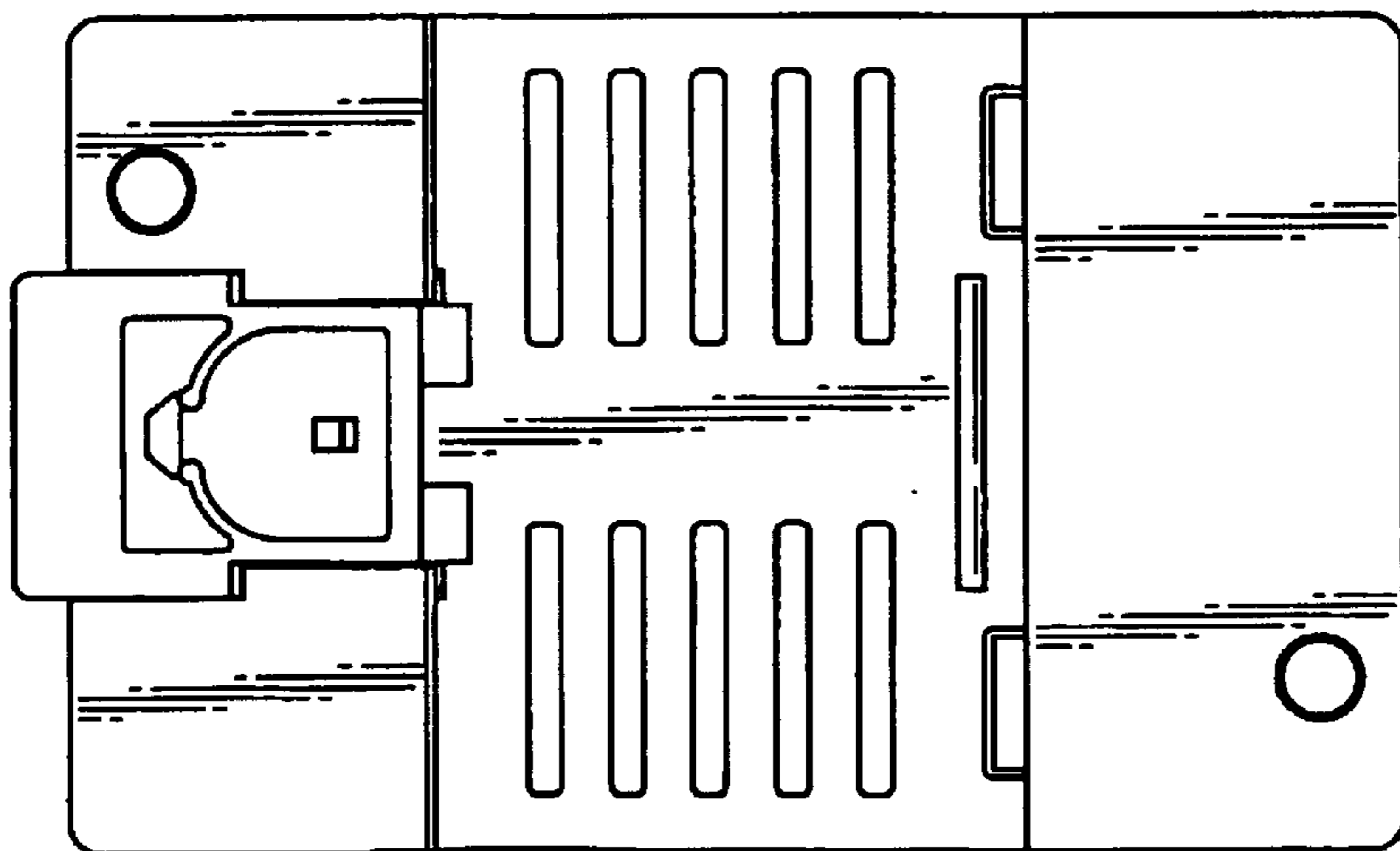

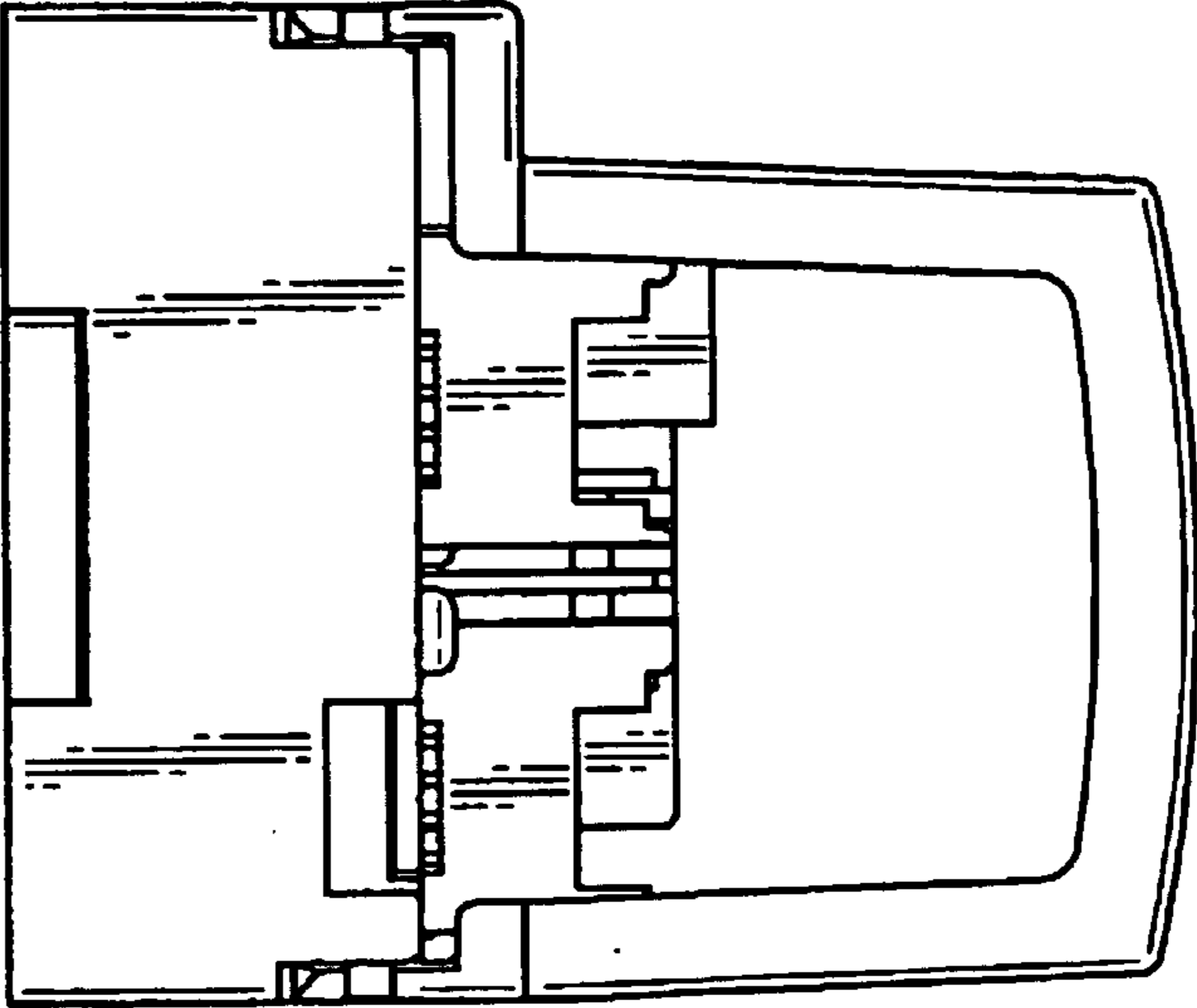

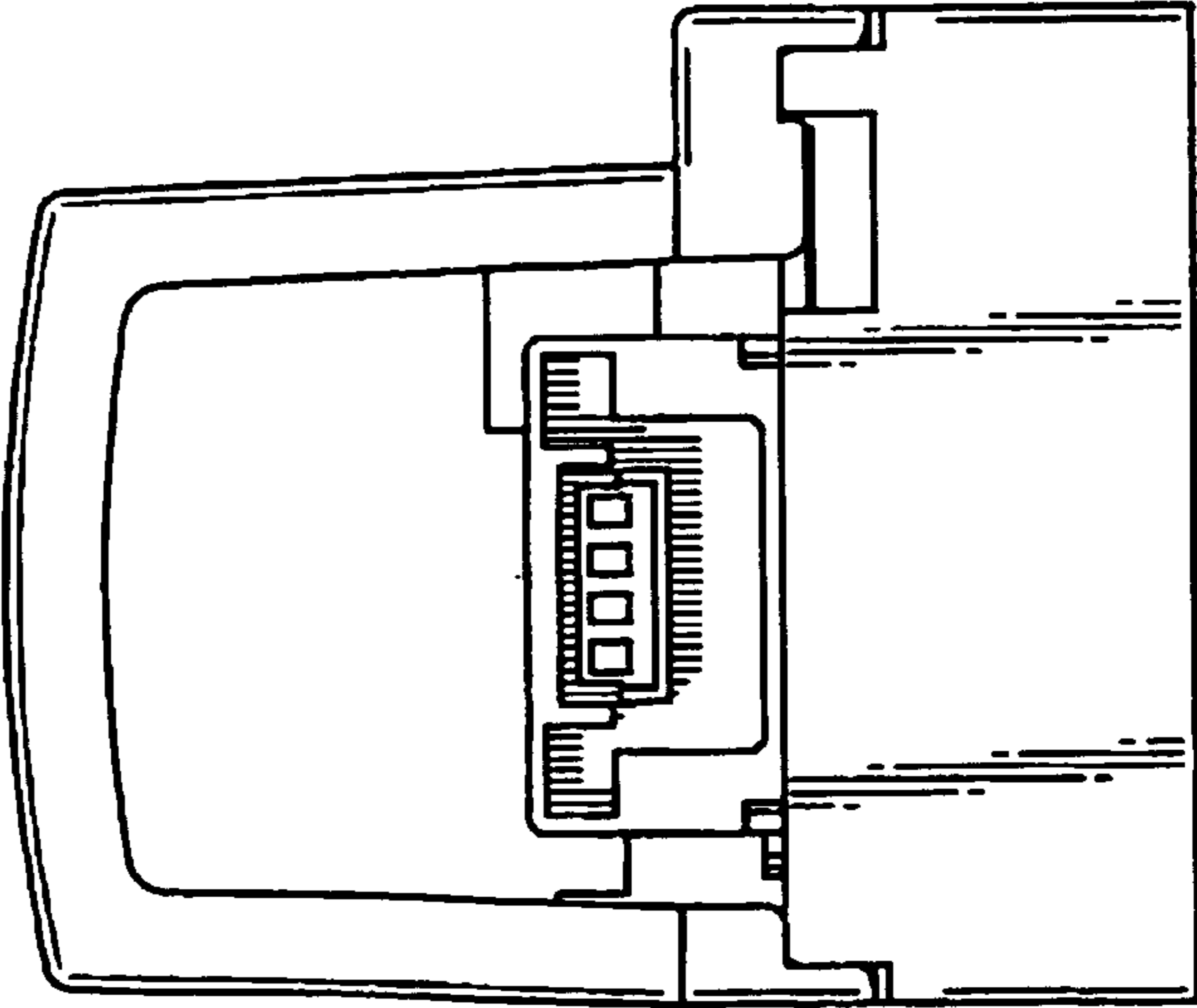

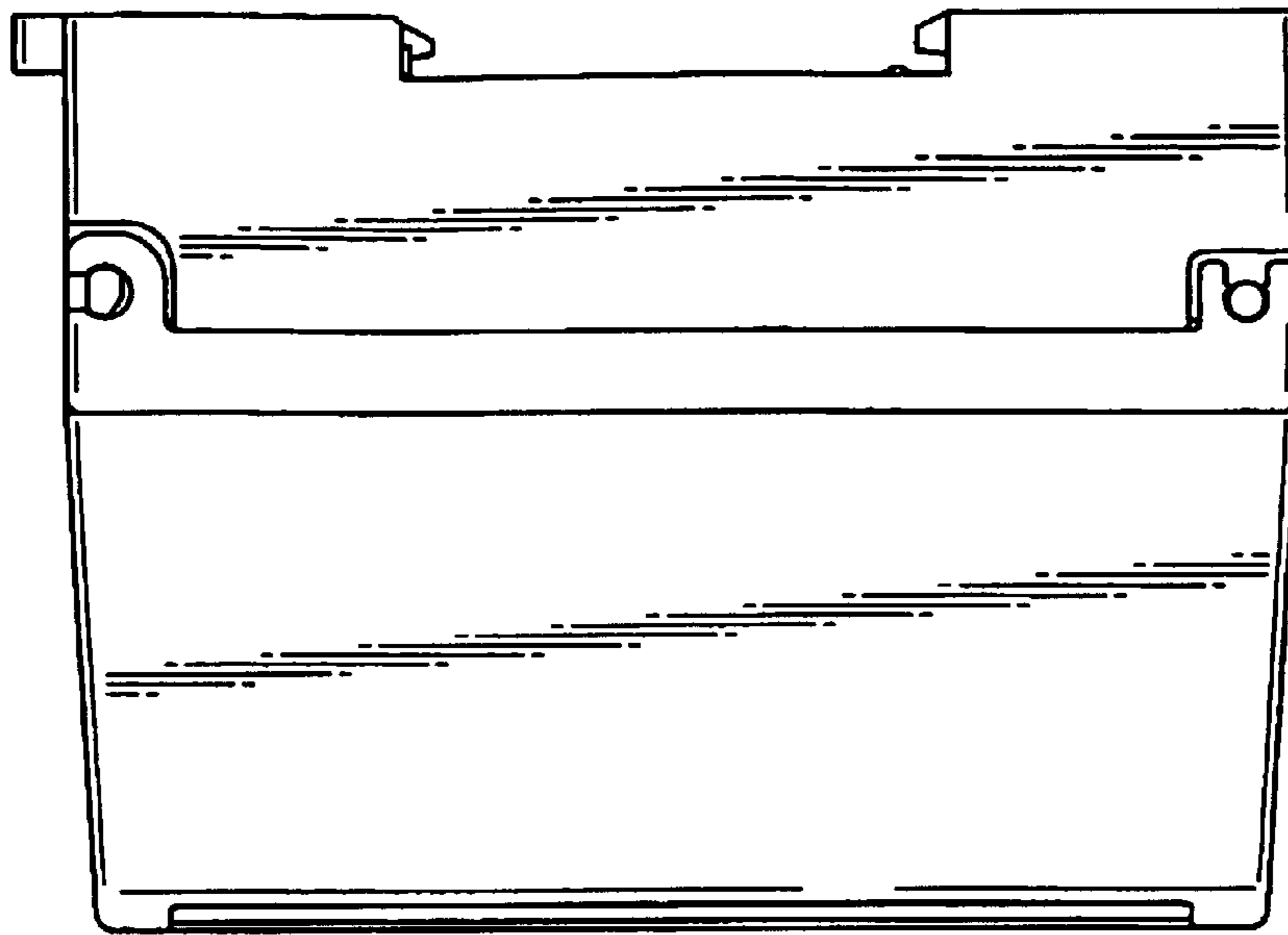
