We claim the ornamental design for a cigarette lighter adapter housing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the cigarette lighter adapter housing;

FIG. 4 is a bottom view thereof;

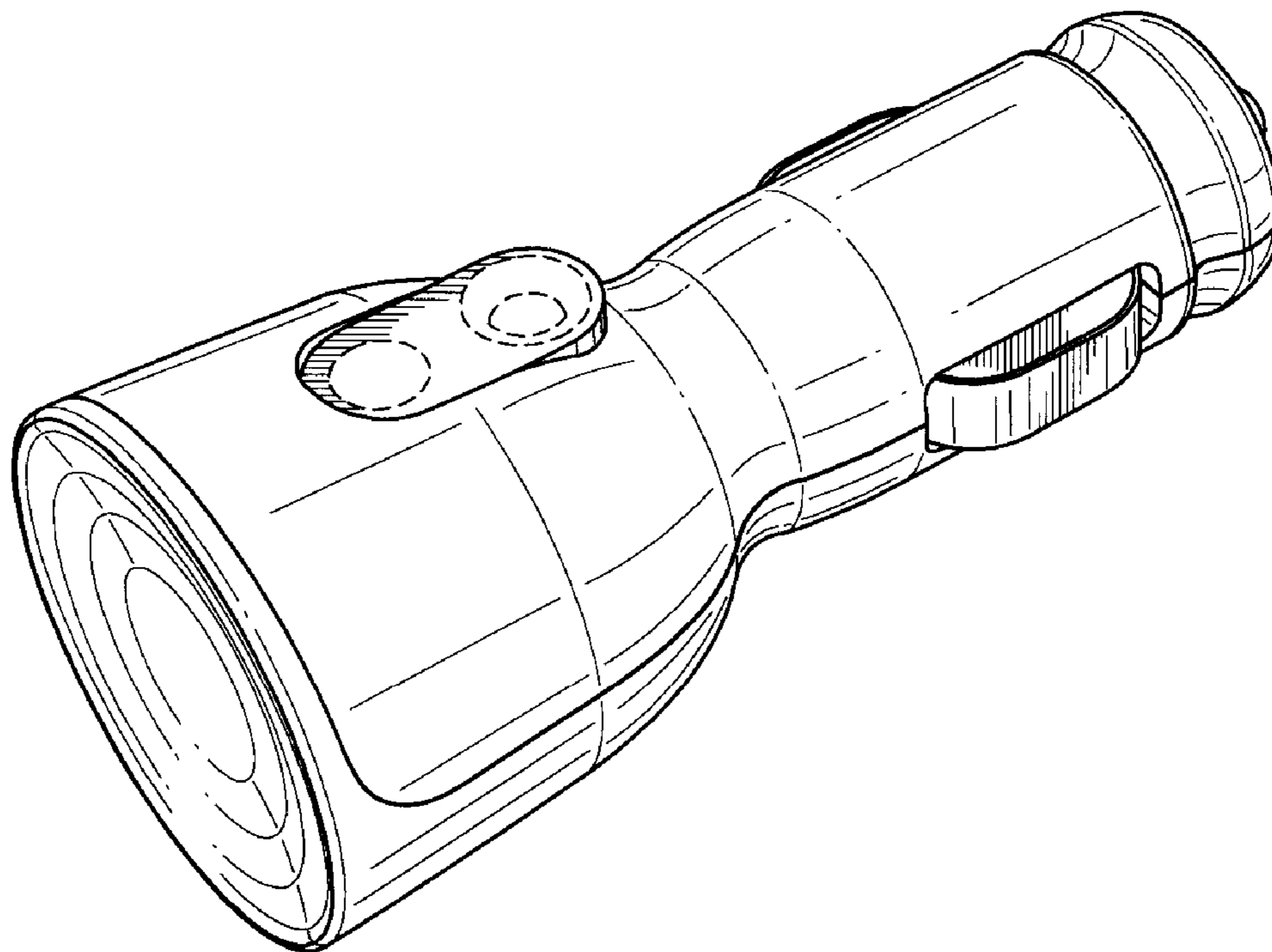
FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image of the left side elevational view;

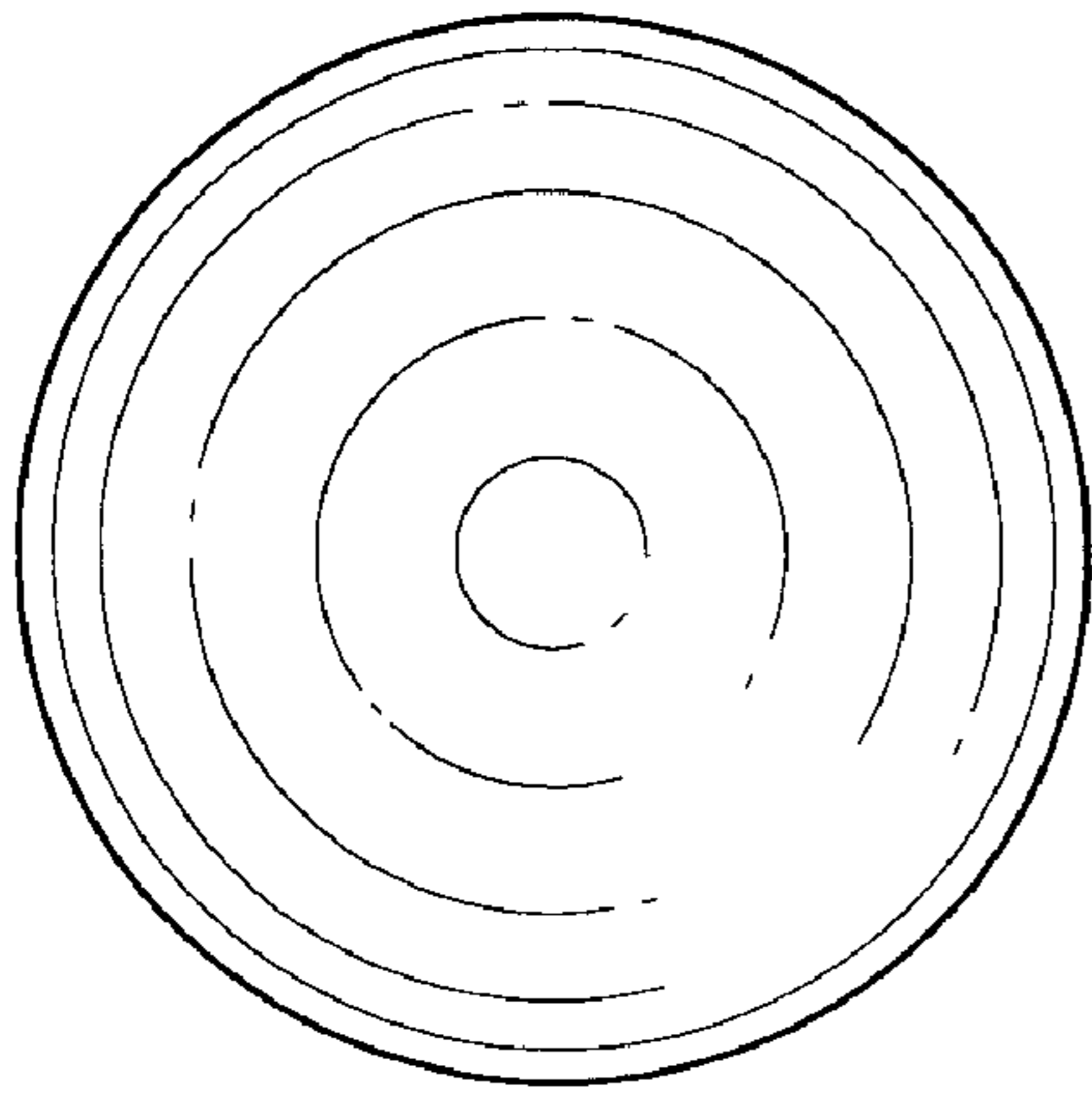

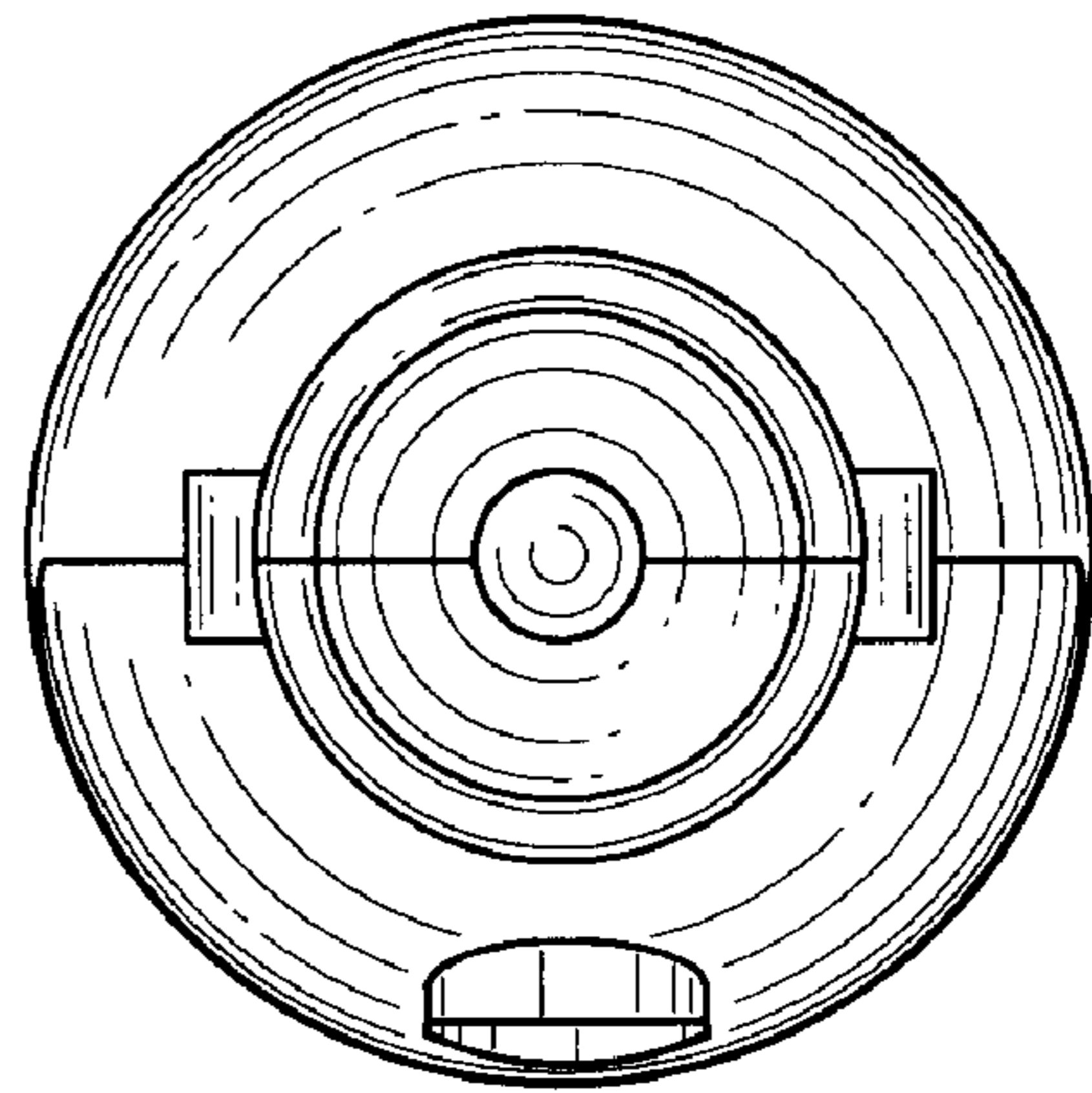

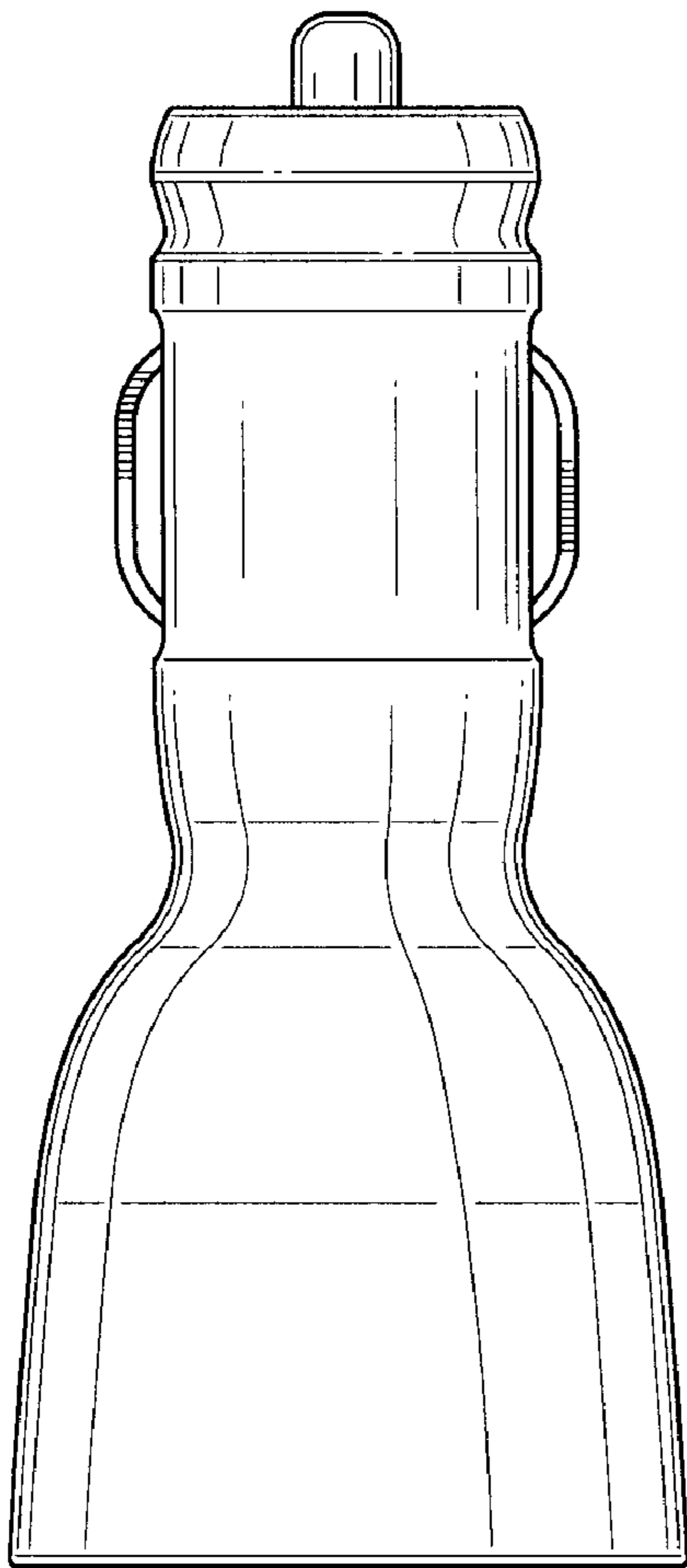

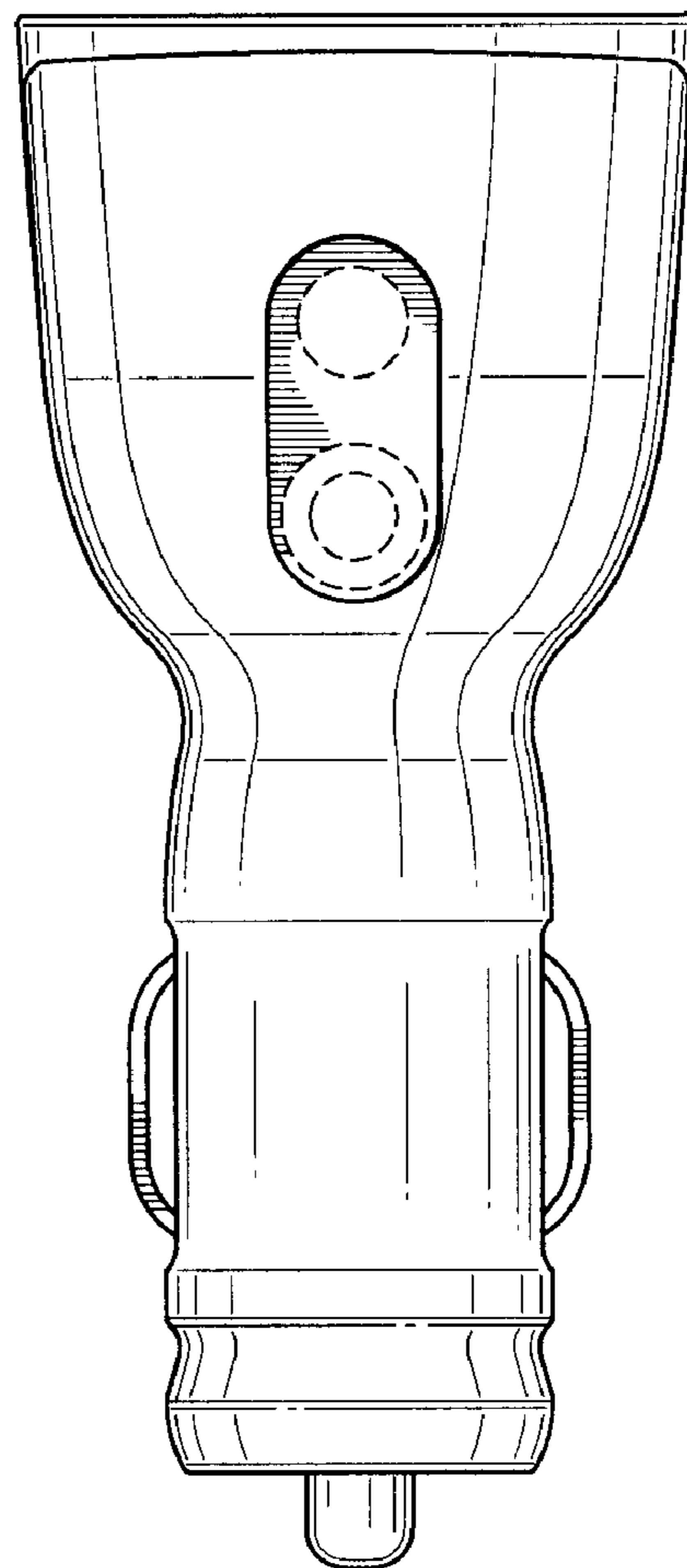

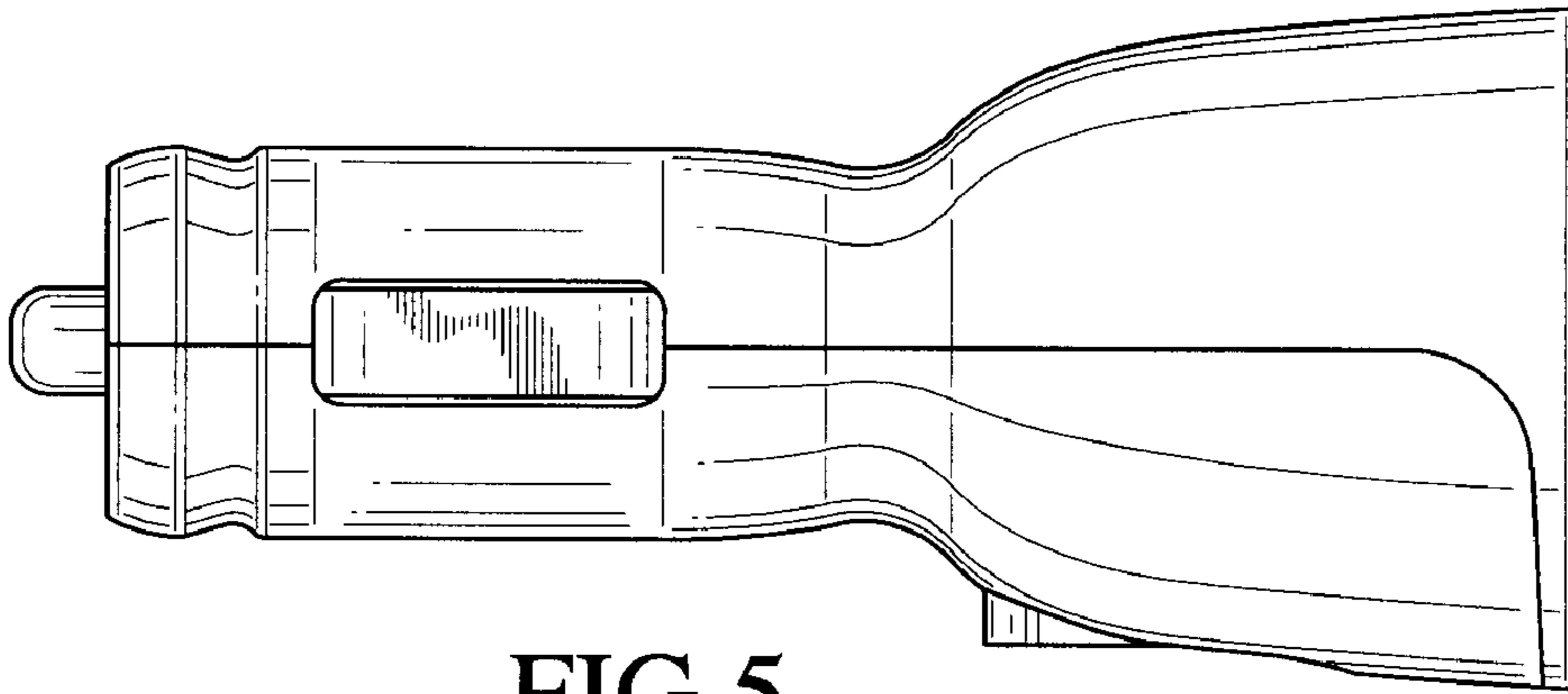

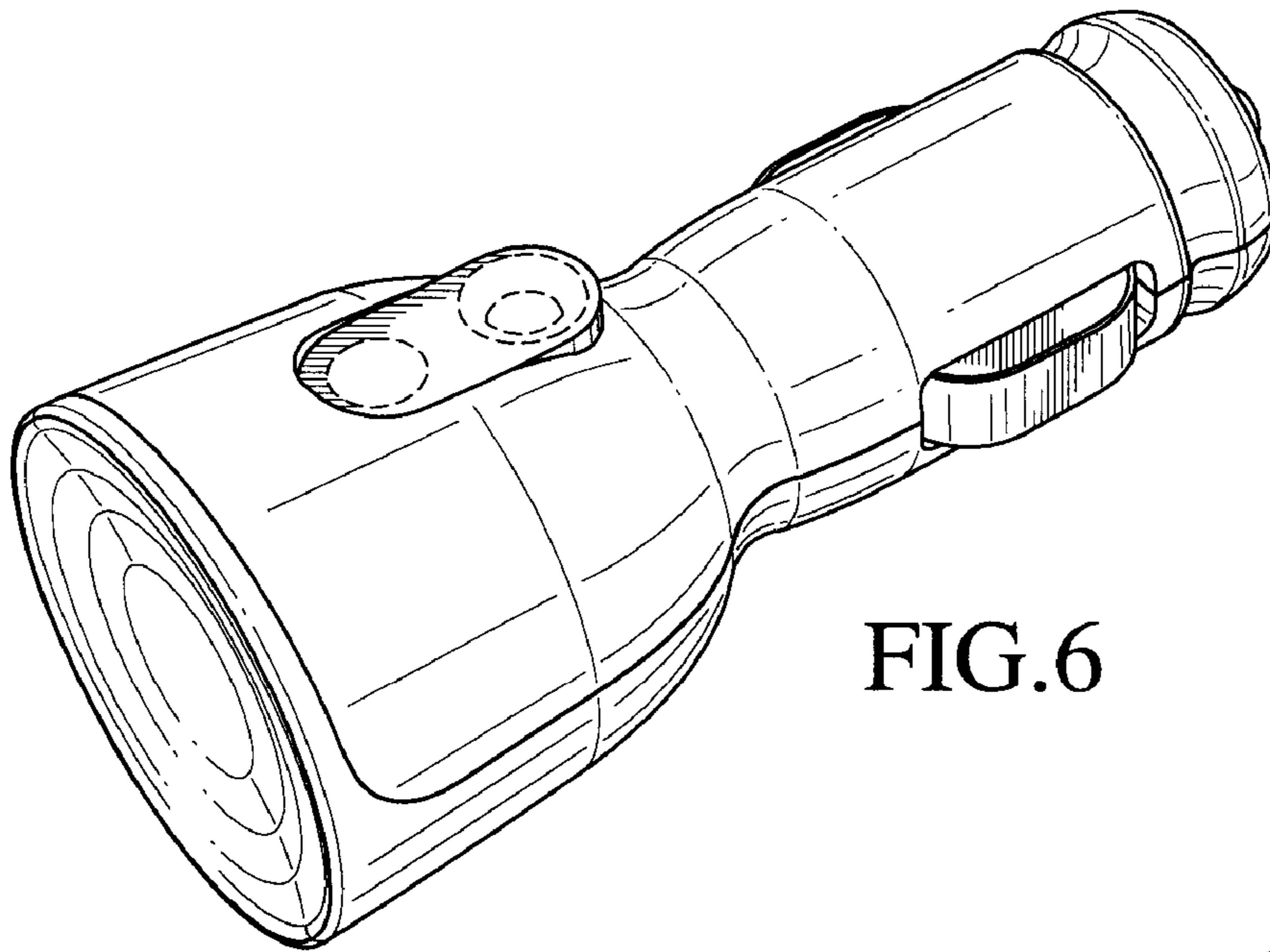

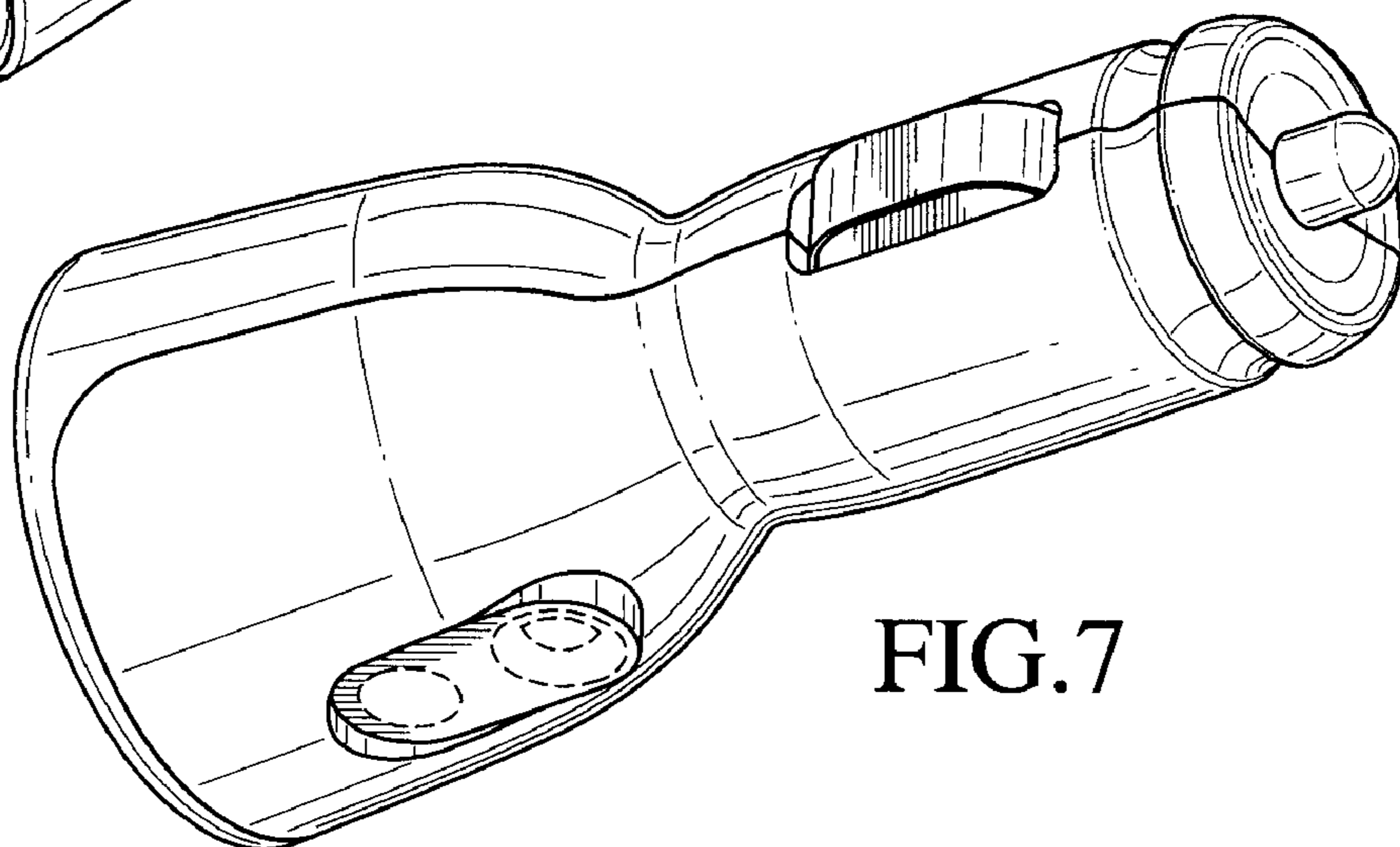
