FIG. 3. is a rear elevational view thereof.

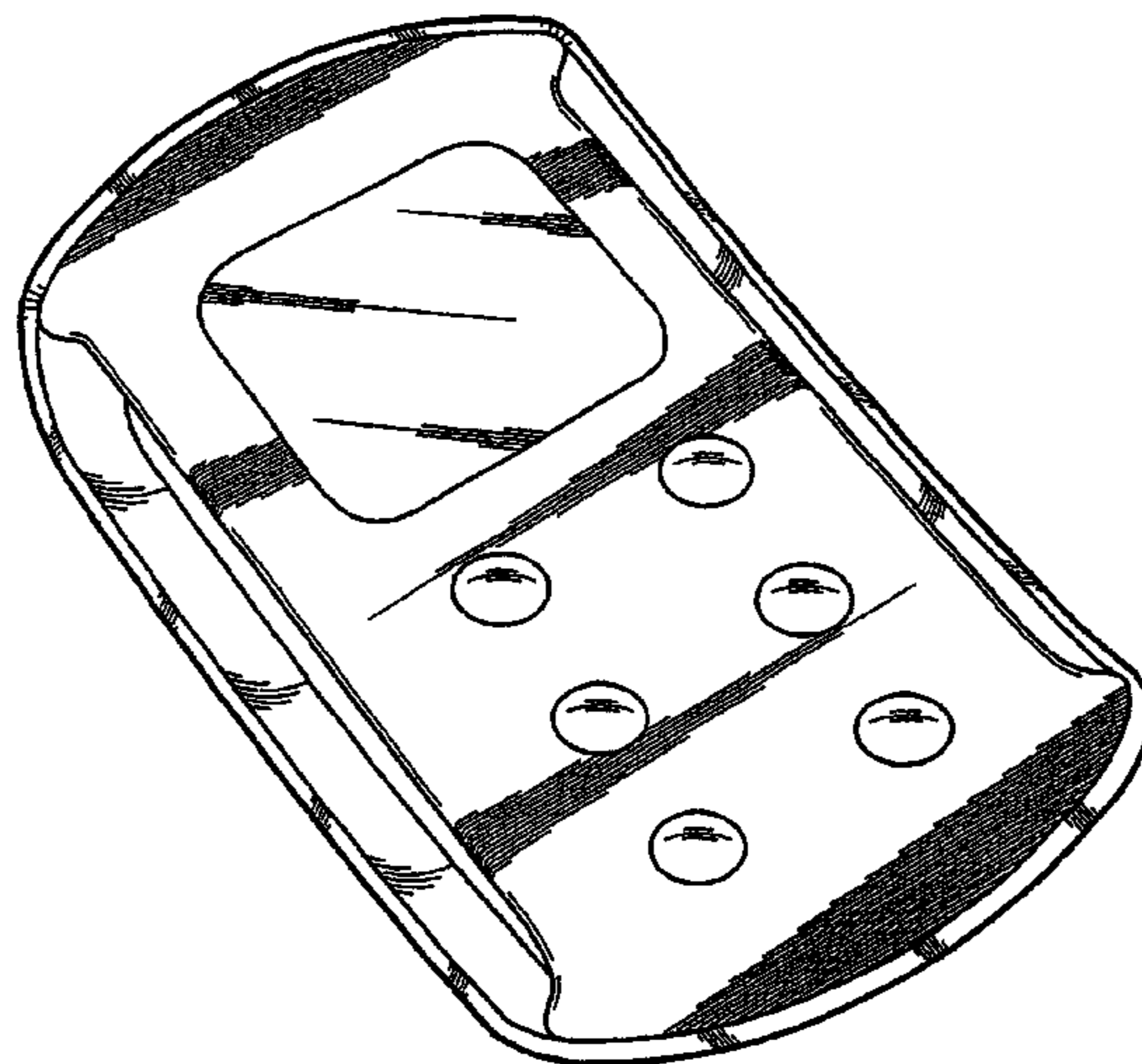
FIG. 4. is a left side elevational view thereof.

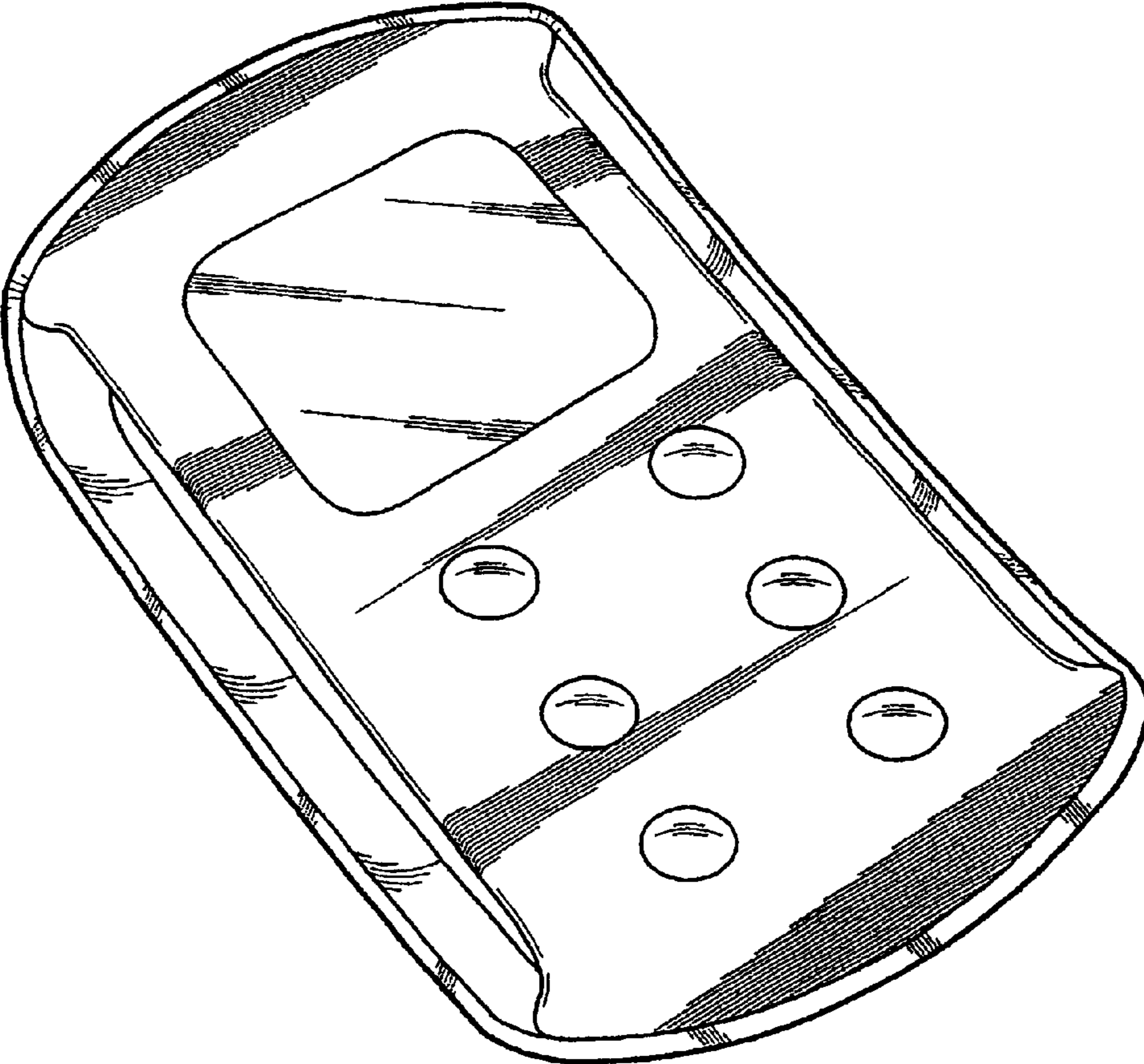

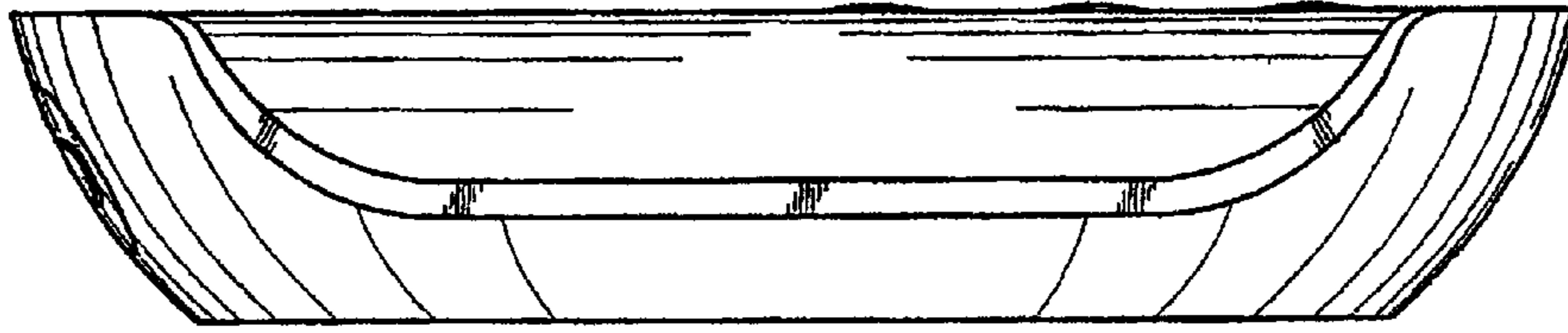

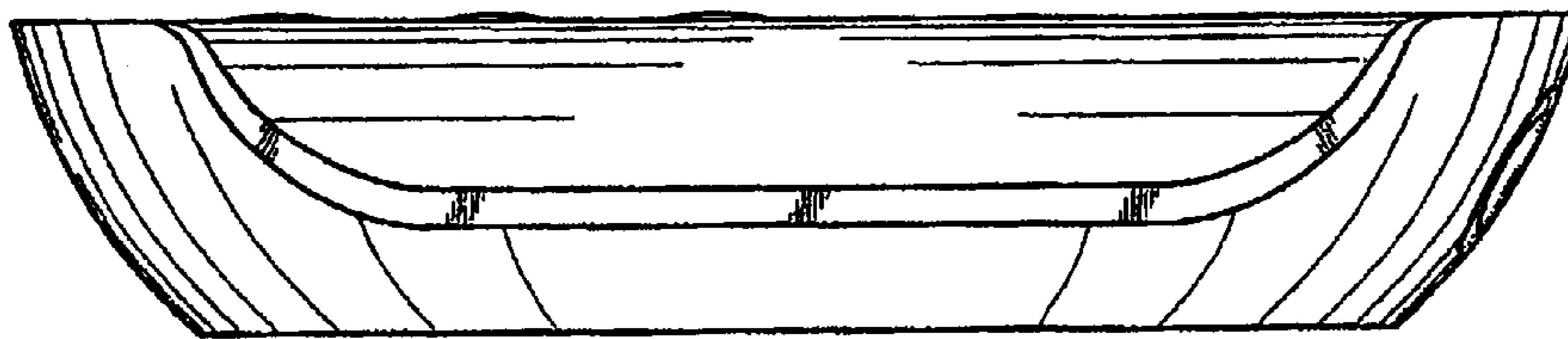

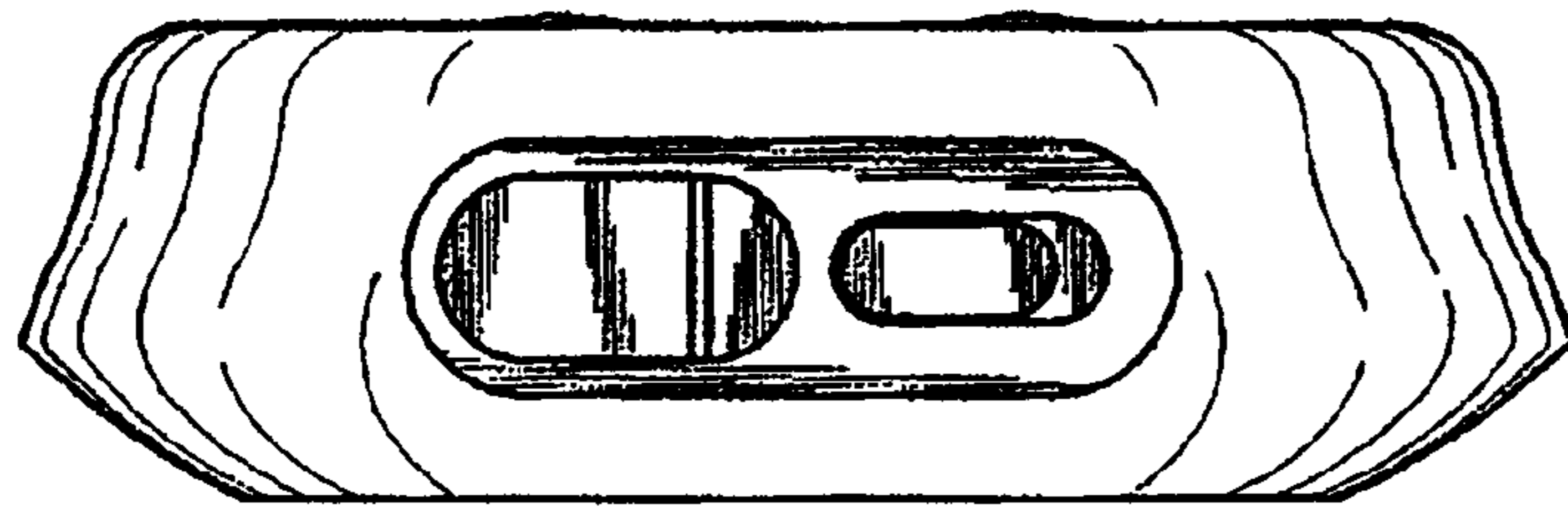

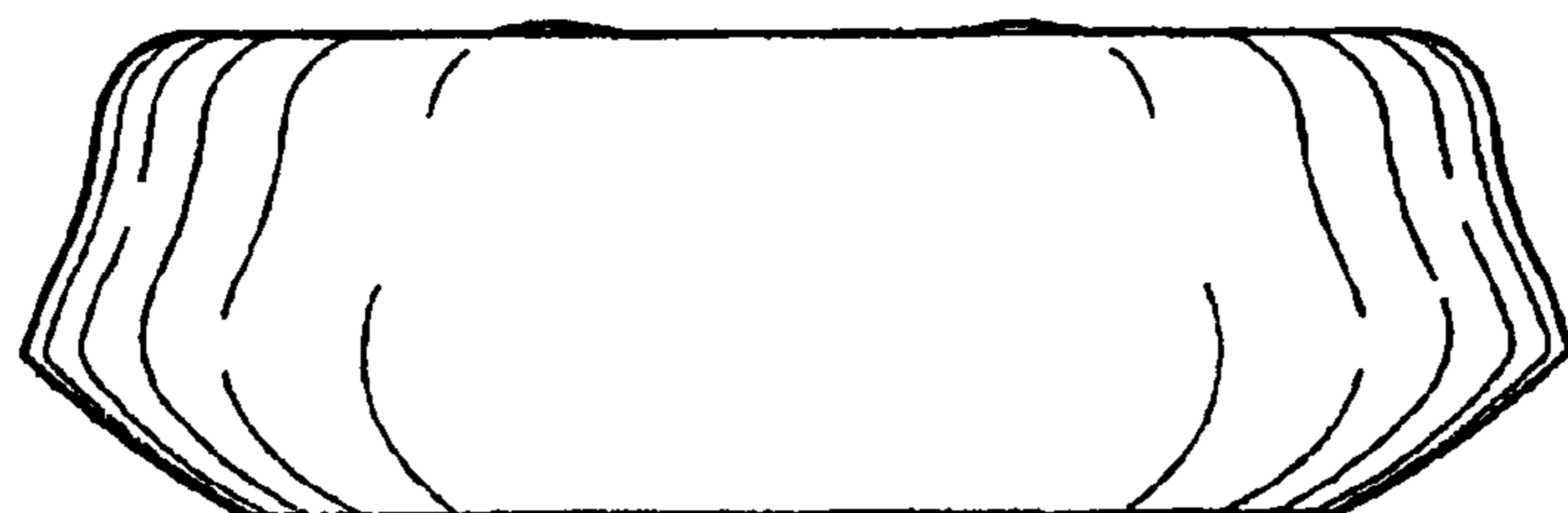

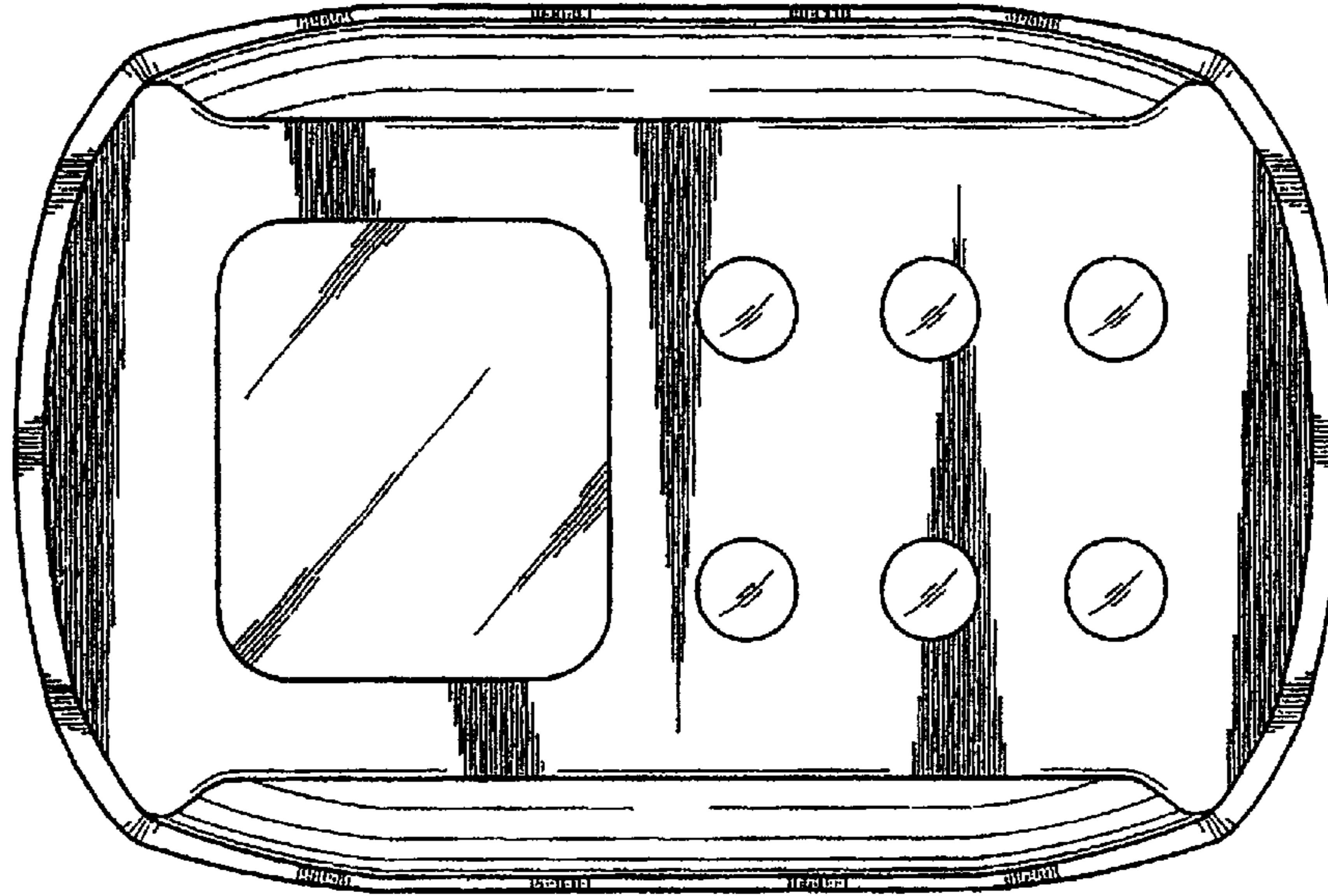

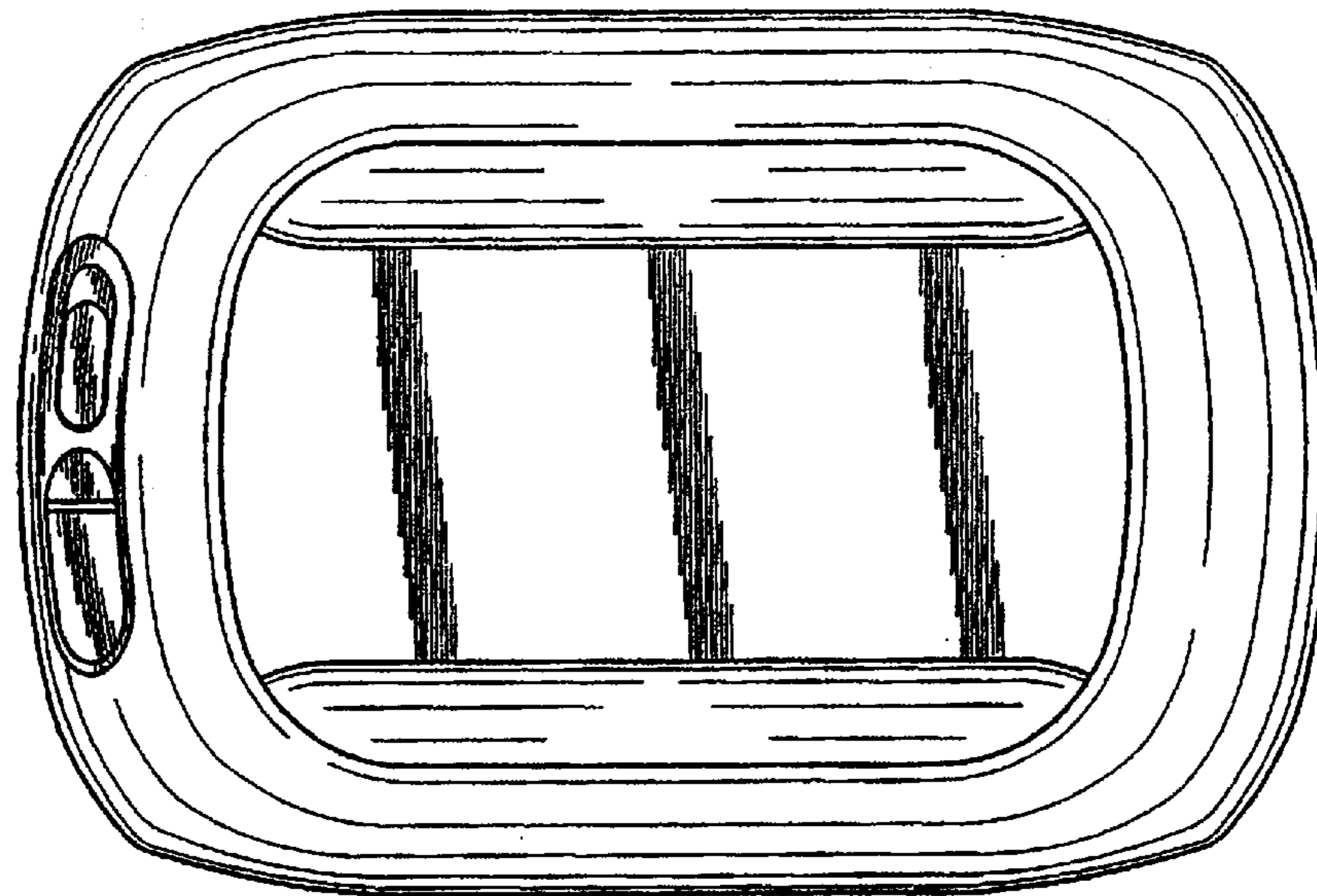
