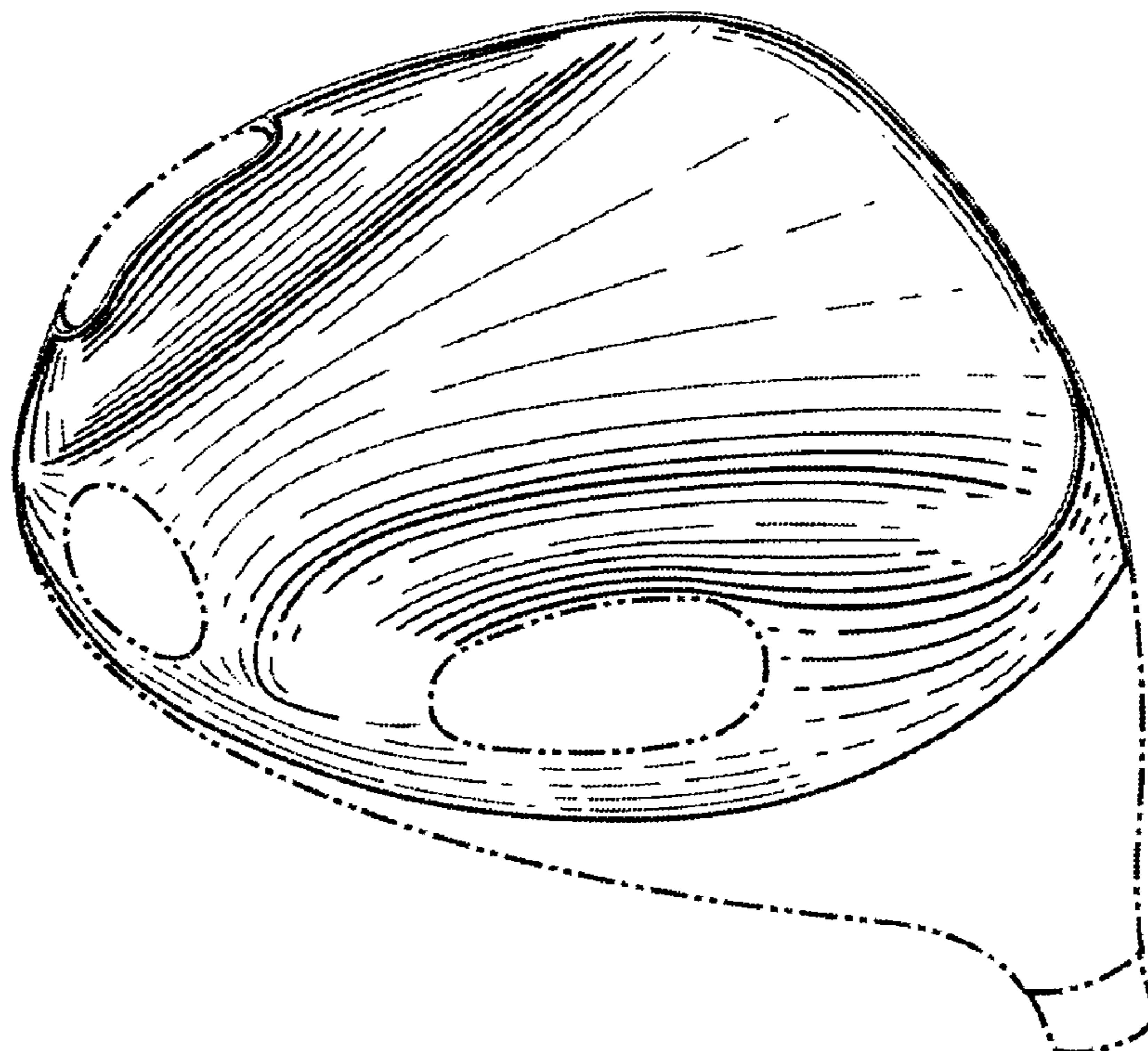
(57) **CLAIM**

The ornamental design for a metal wood sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective bottom view of the present invention. FIG. 2 is a bottom view thereof. FIG. 3 is a heel elevational view thereof. FIG. 4 is a front elevational view thereof. FIG. 5 is a rear view thereof; and, FIG. 6 is a toe elevational view thereof. The broken lines on the sole showing locations for weight members and logo, and the broken lines on the upper part of the metal wood throughout the views represent the portions of the design that form no part of the claim.

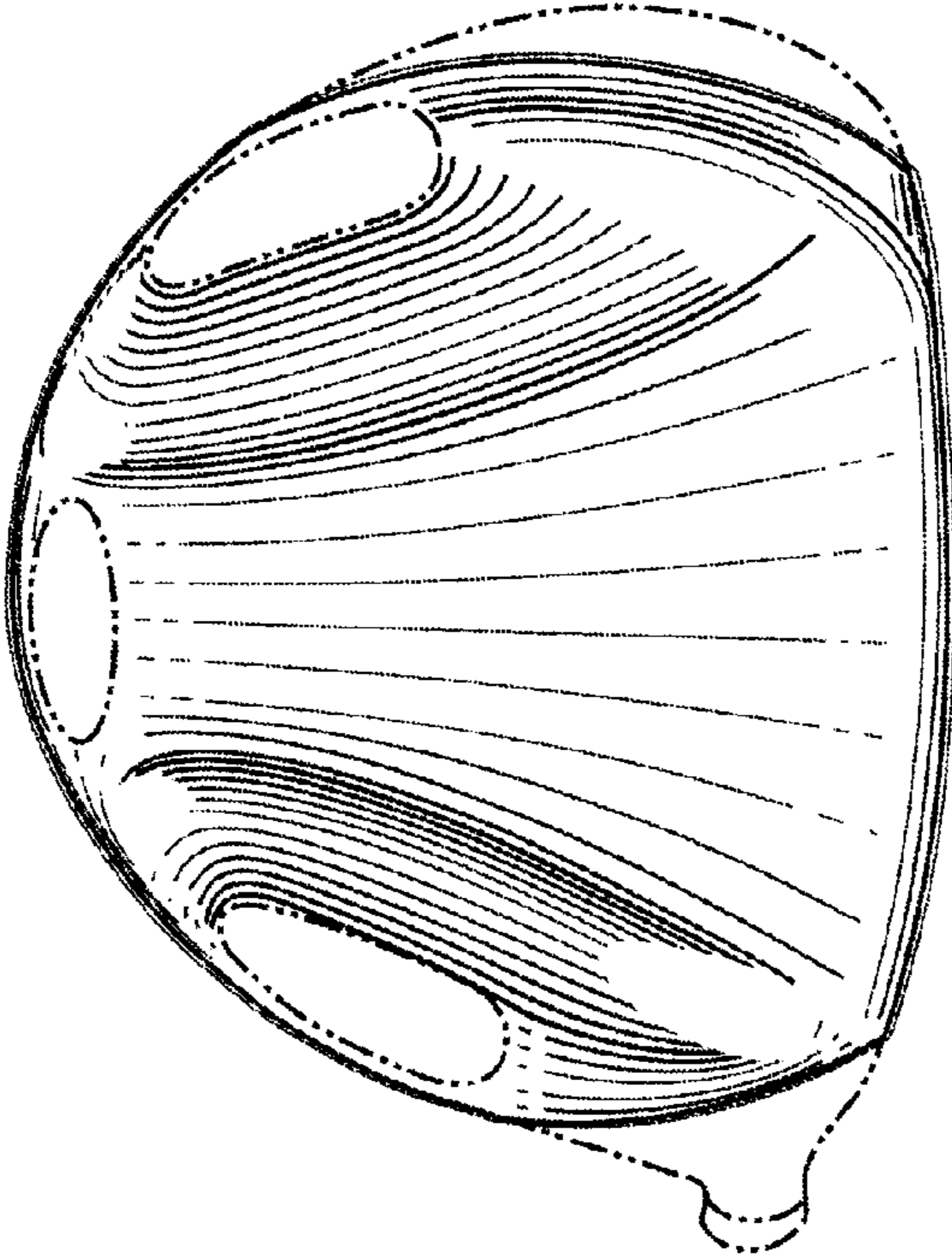

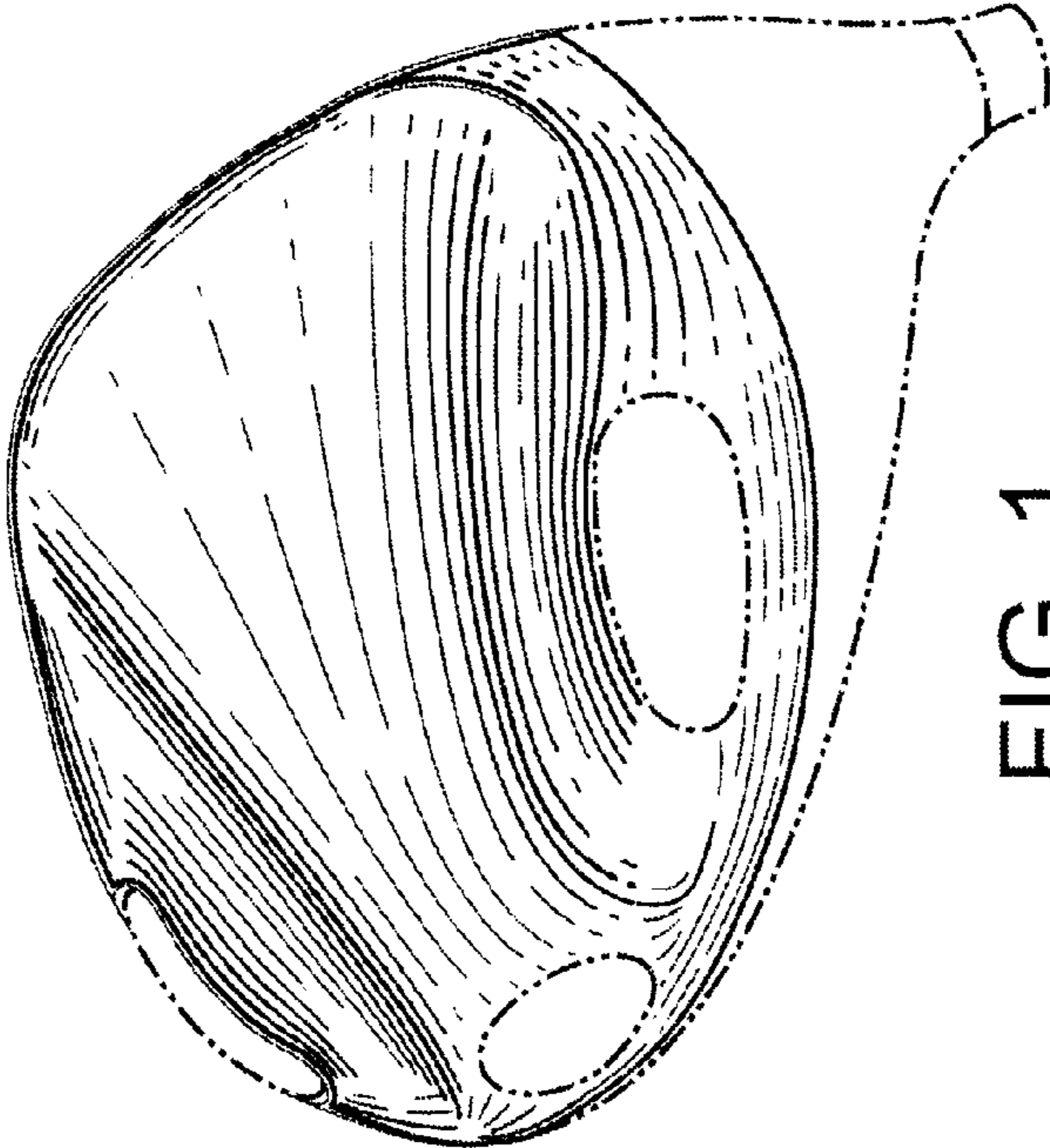

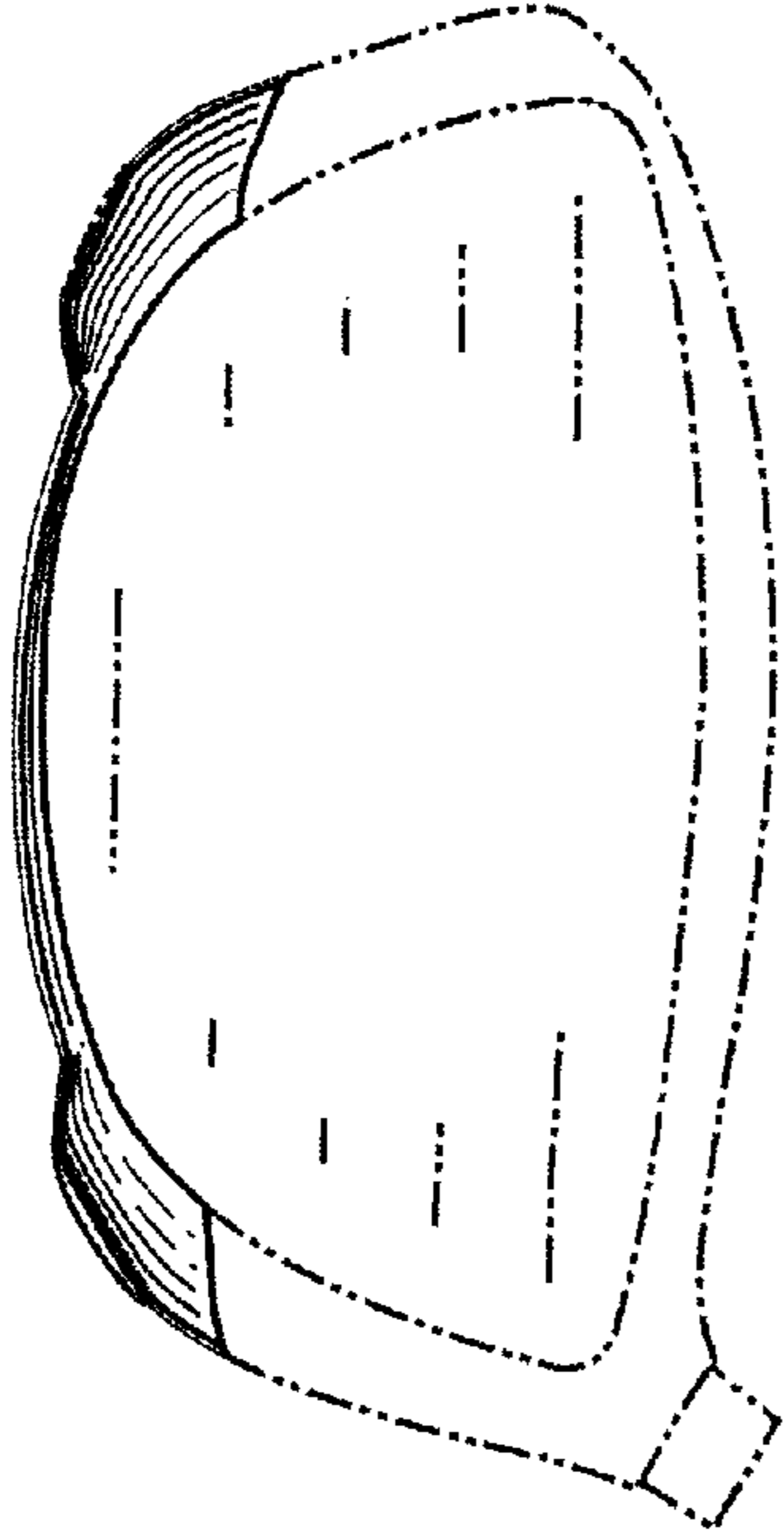

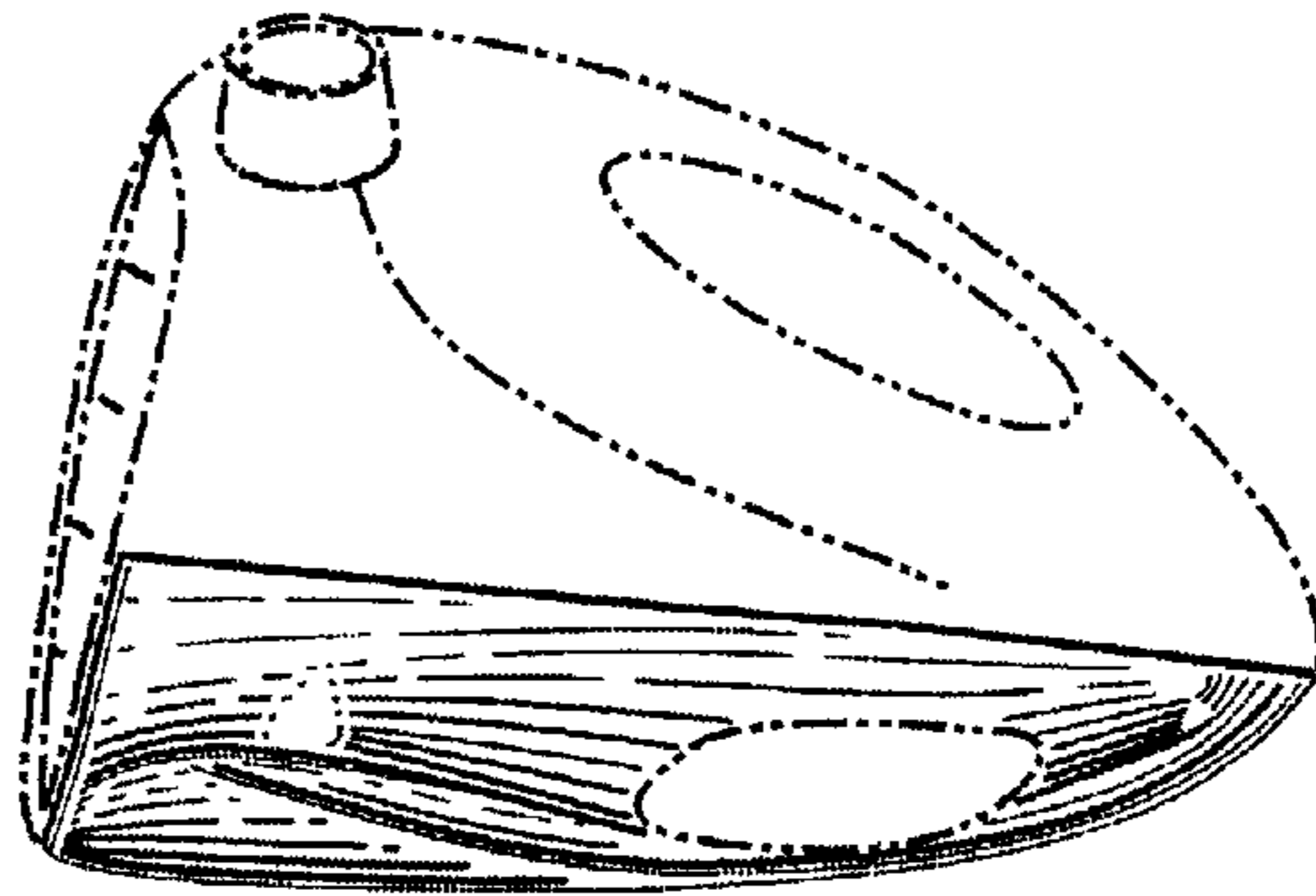

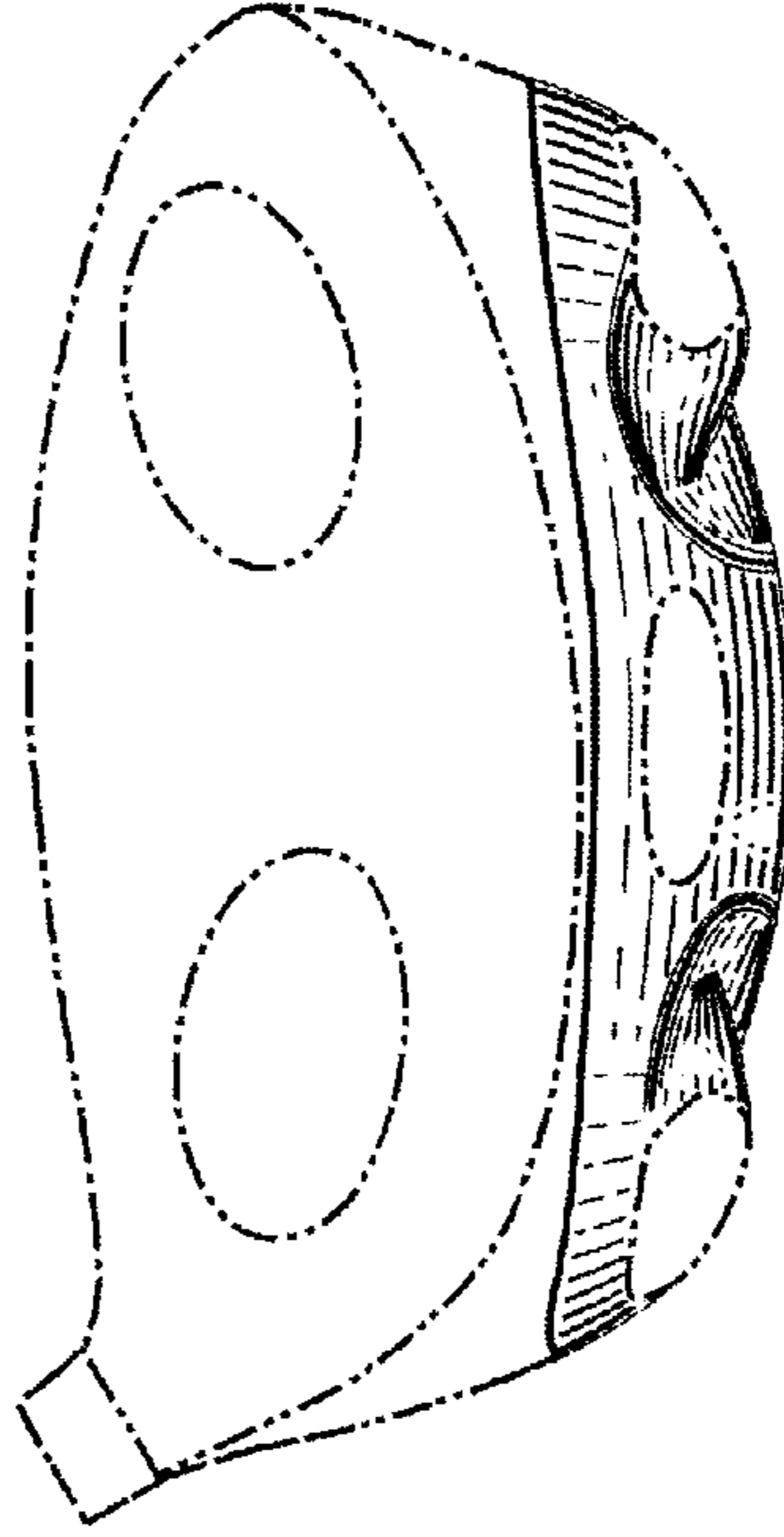

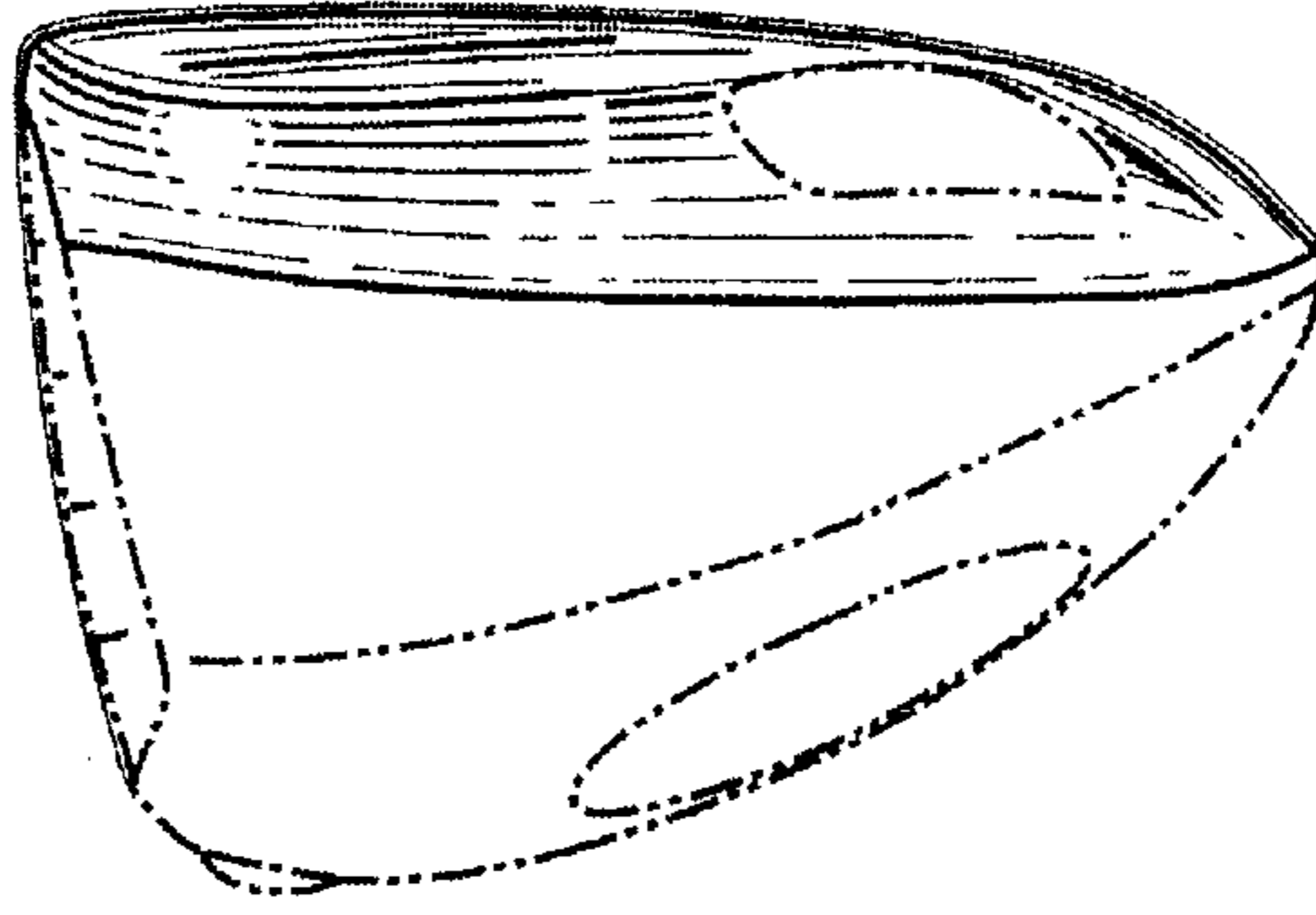
