(57) **CLAIM**

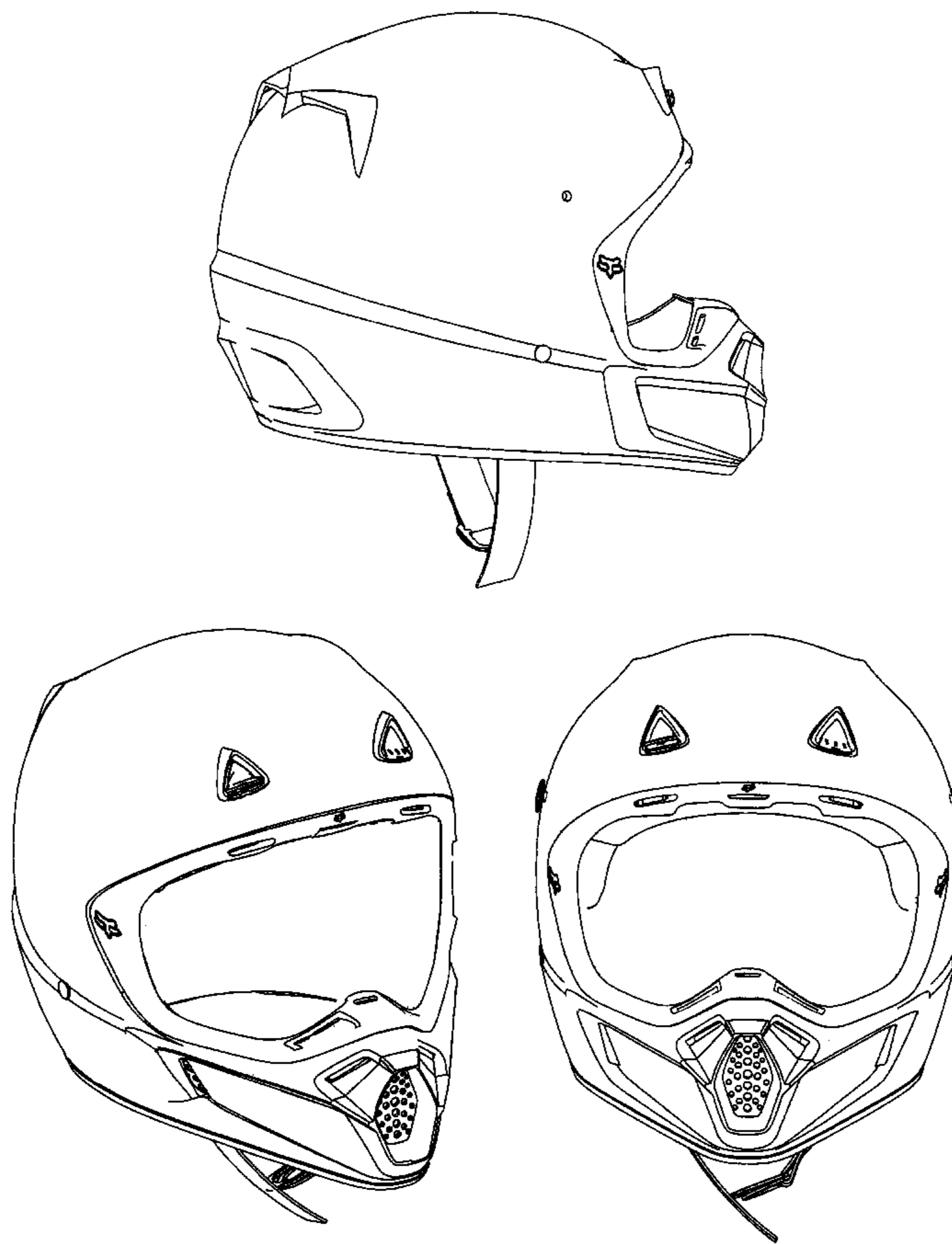
We claim the ornamental design for the motorcycle helmet, as shown and described.

DESCRIPTION

The claimed ornamental design for a helmet which embodies the design is for use as a motorcycle helmet.

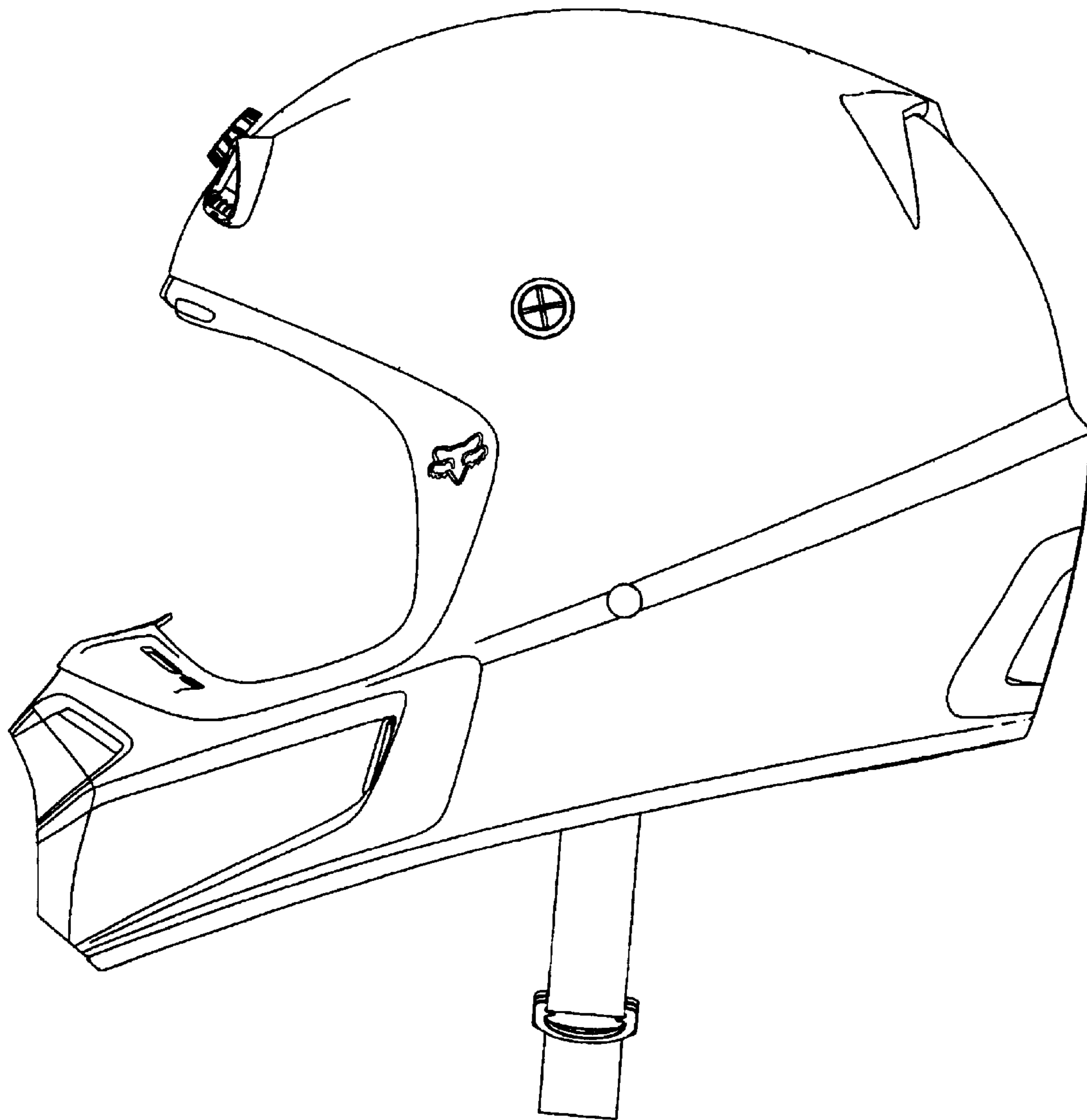

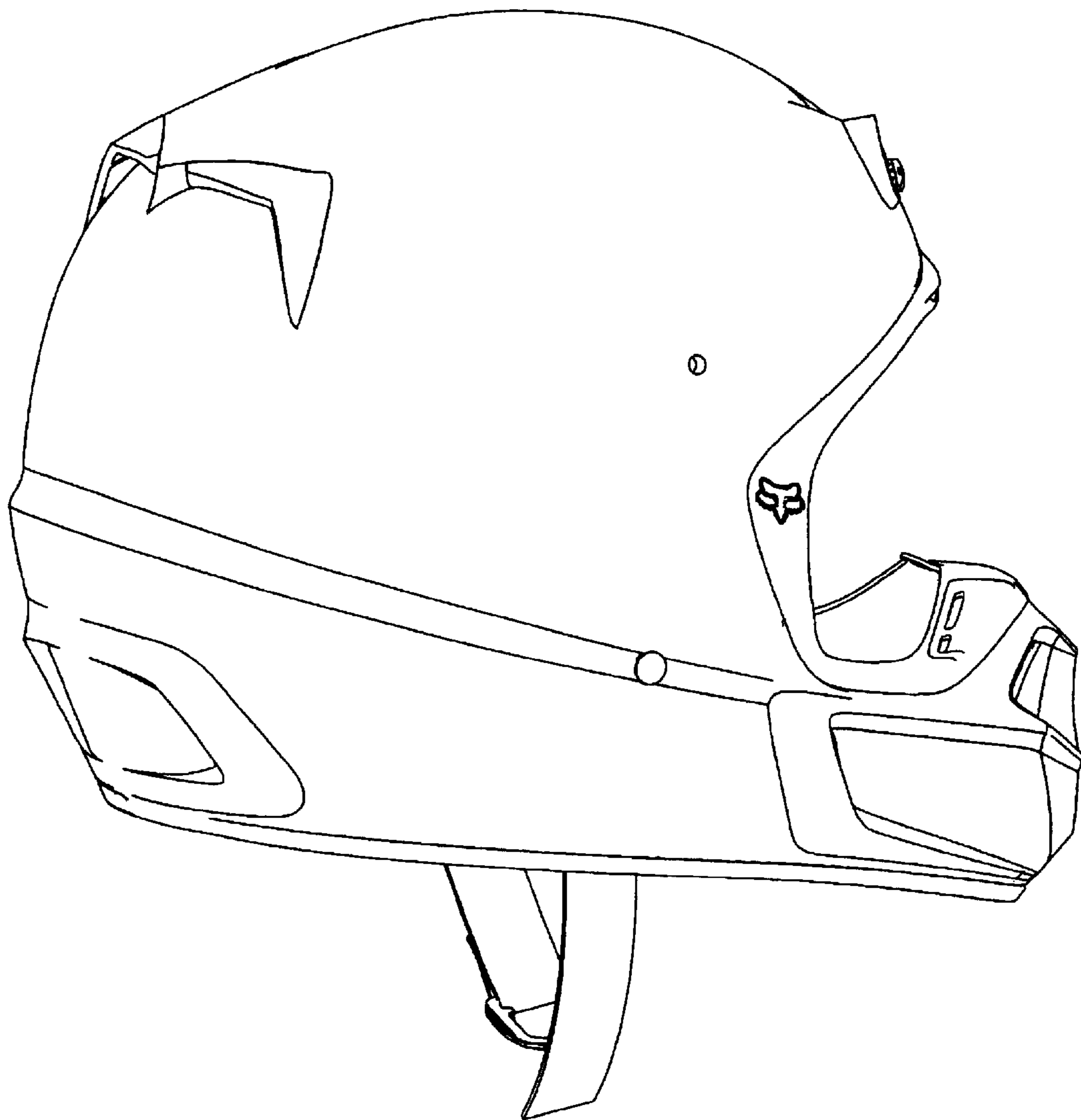

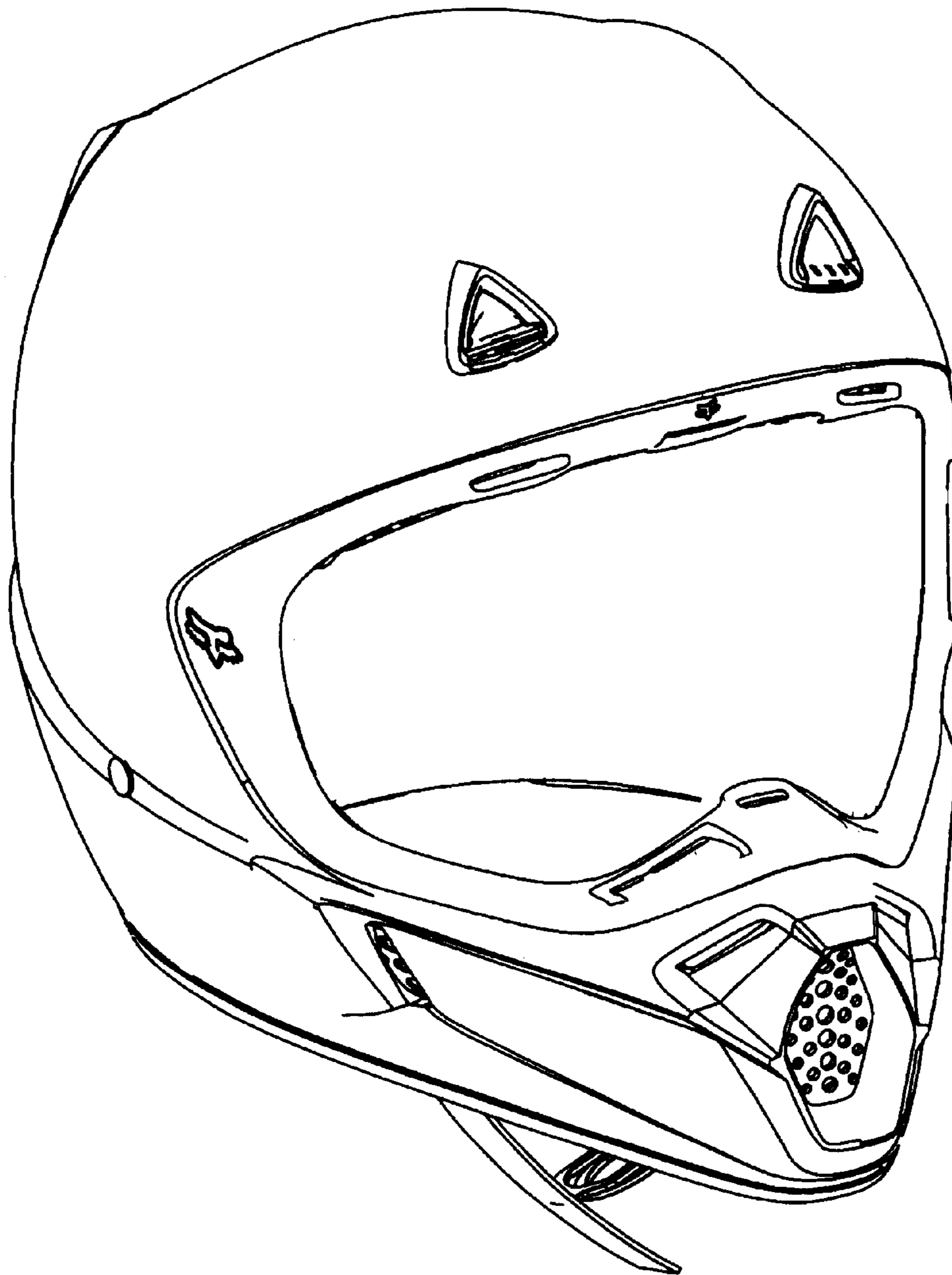

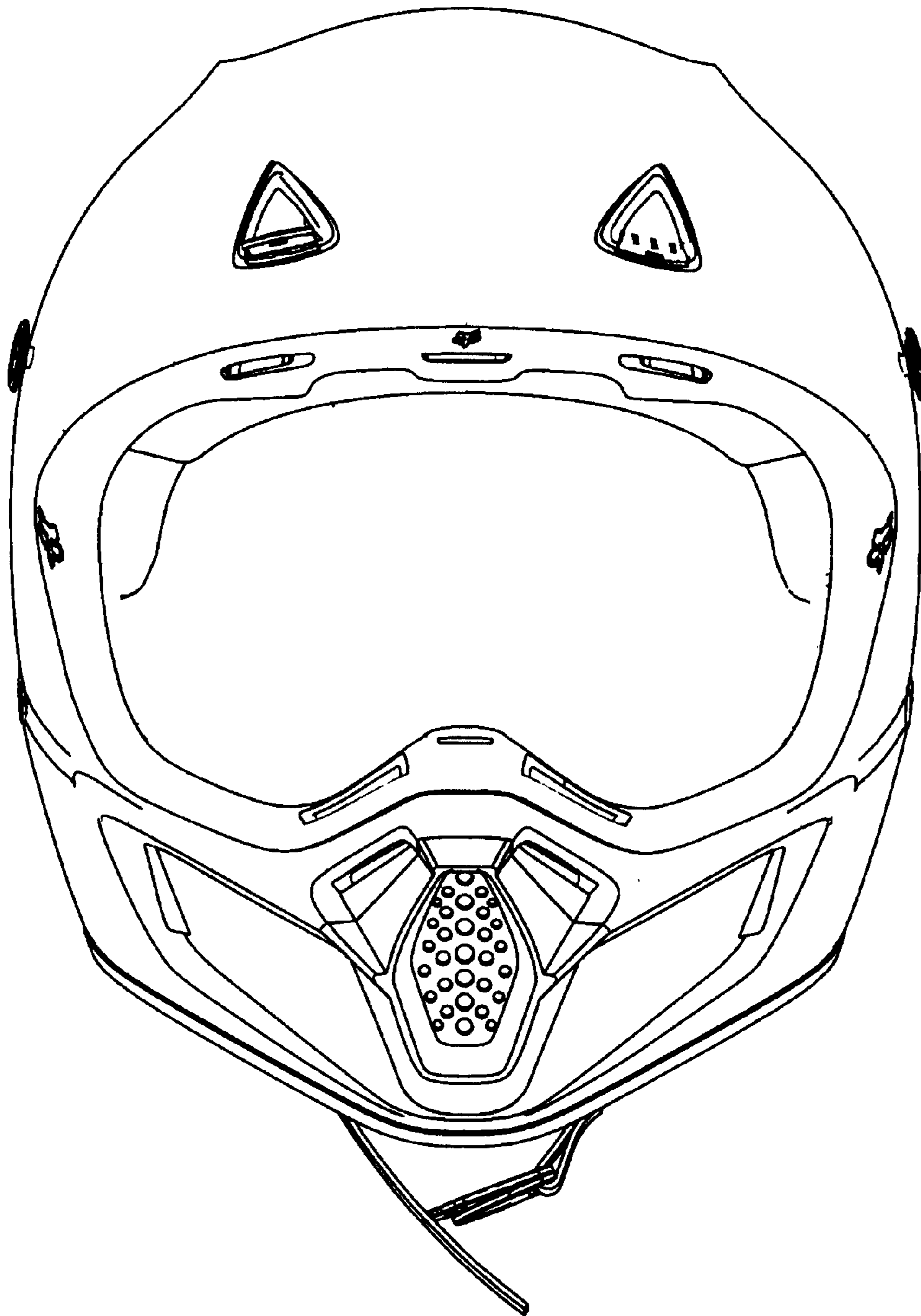

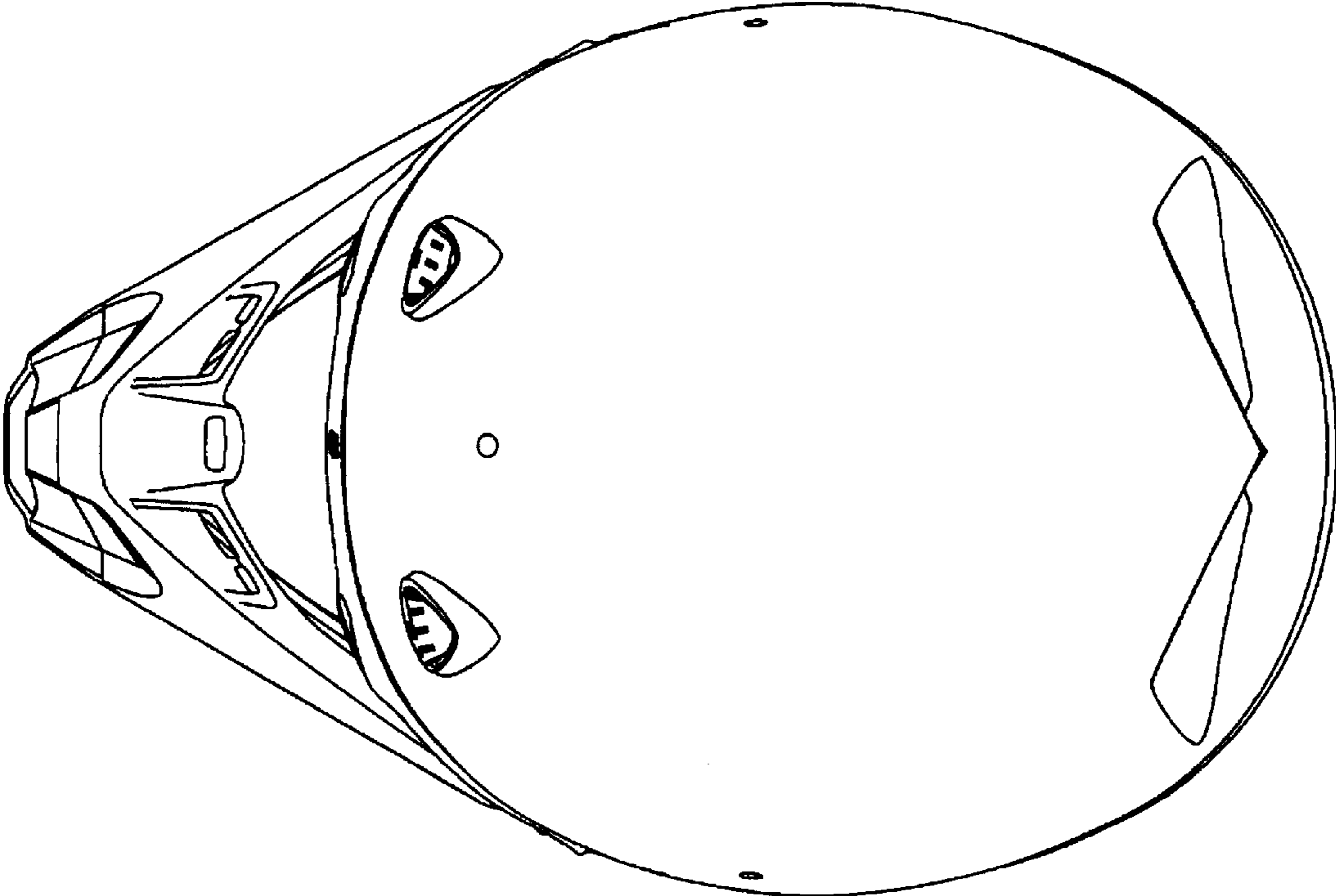

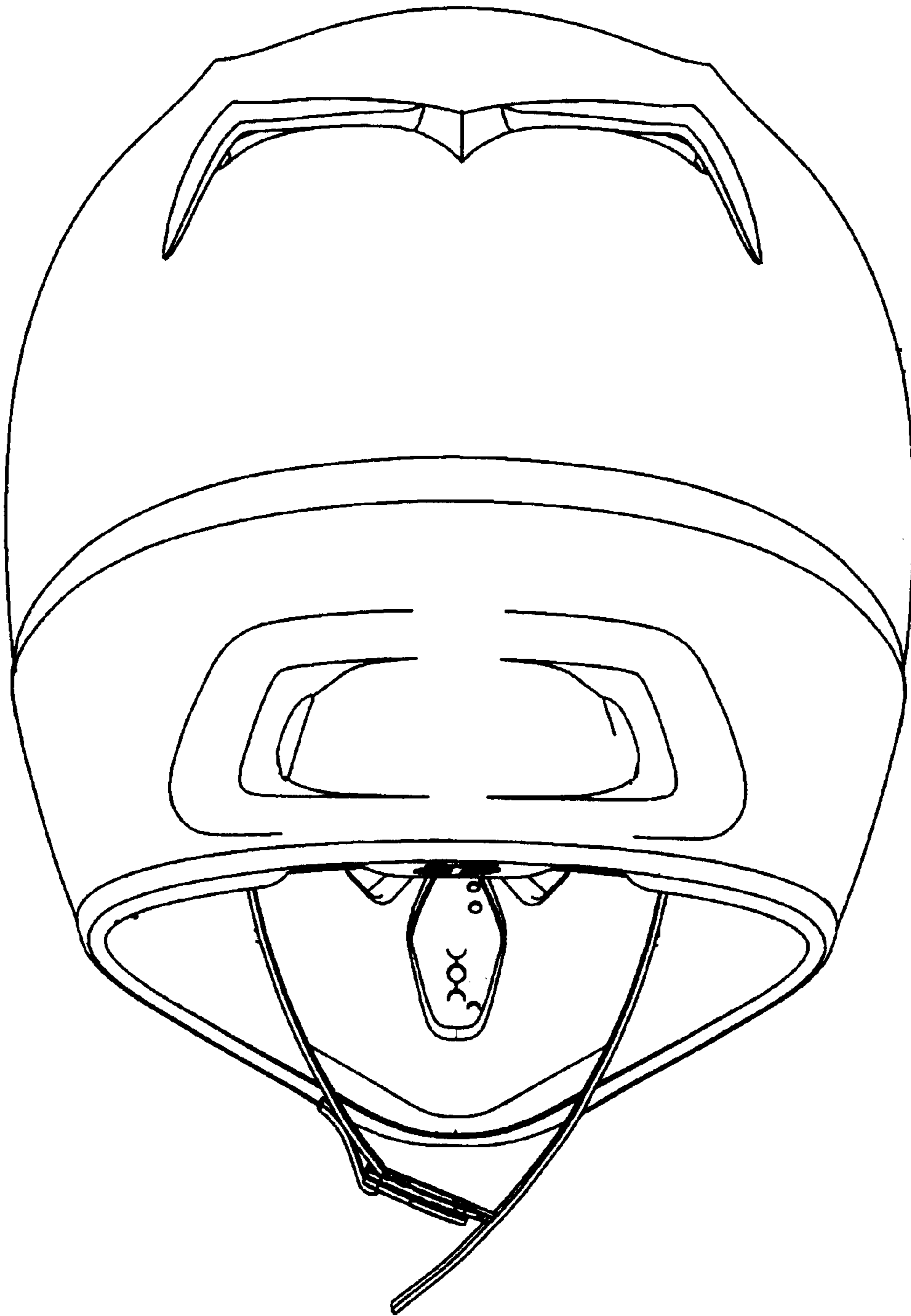

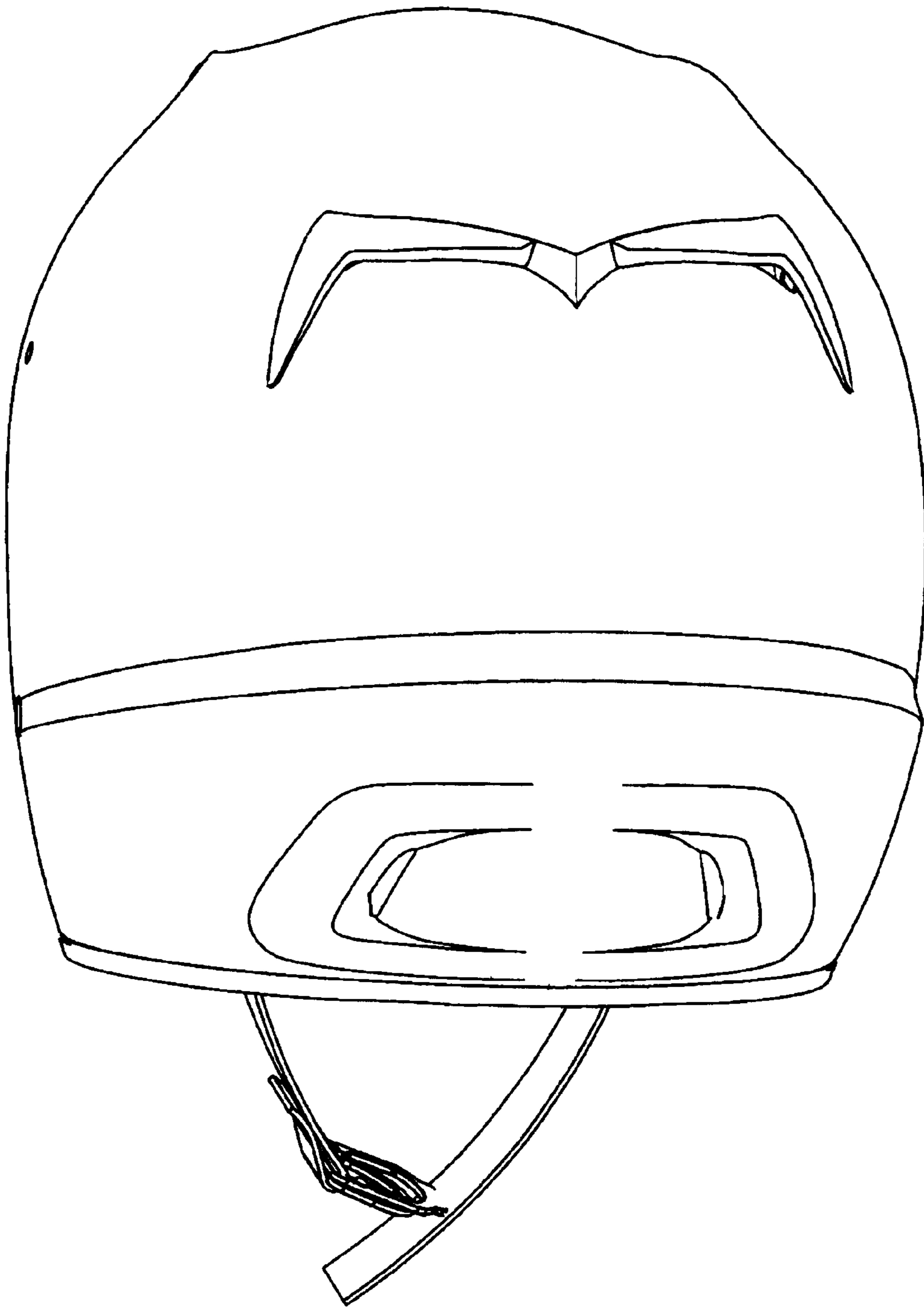

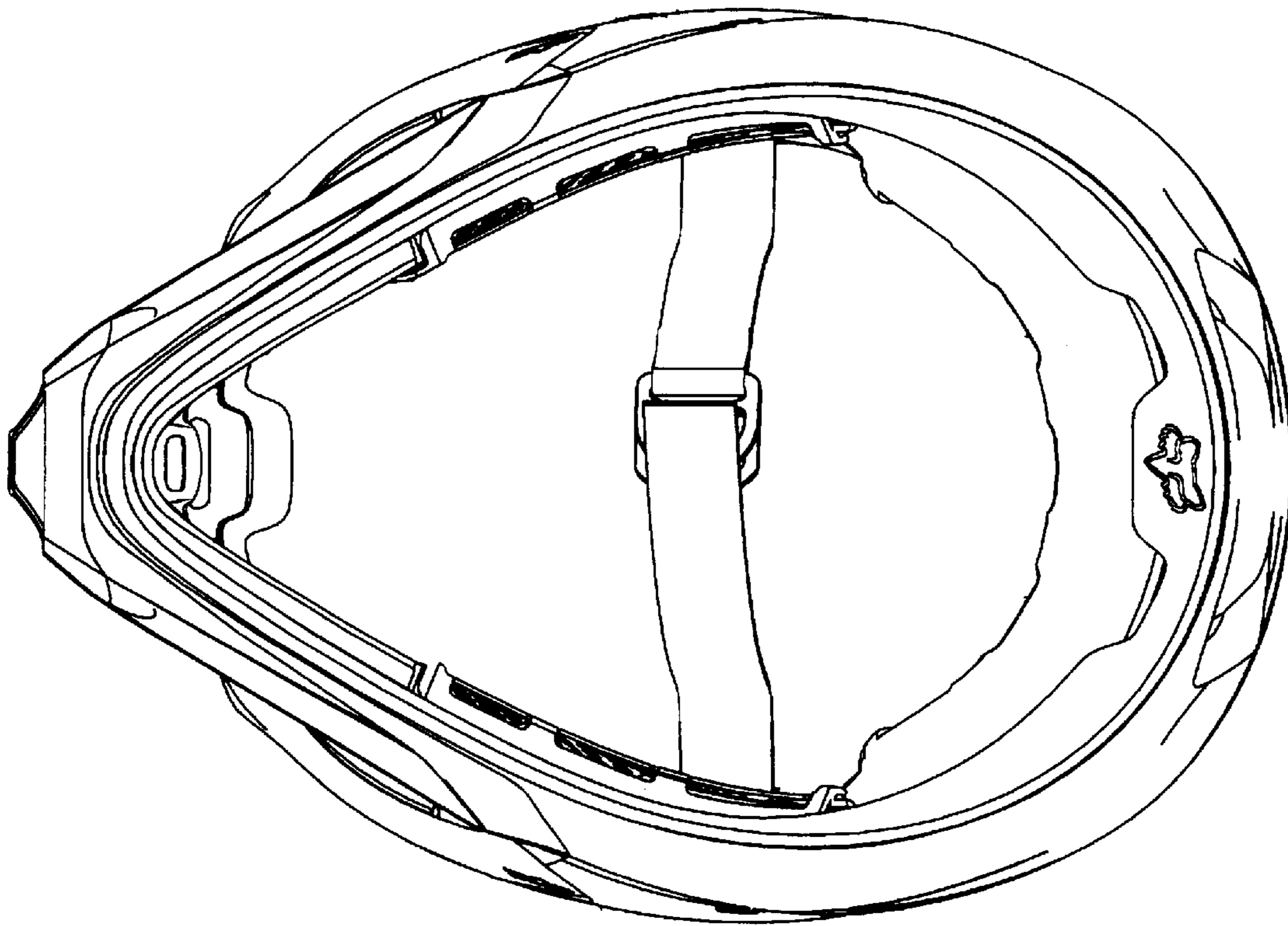
