(57) **CLAIM**

The ornamental design for a drum, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a drum according to a preferred embodiment of the invention;

FIG. 2 is a perspective view of a portion of the drum top according FIG. 1;

FIG. 3 is a perspective view of a another portion of the drum top according FIG. 1;

FIG. 4 is a plan view of the drum top of FIG. 1; and,

FIG. 5 is a side view of a portion of the drum top according FIG. 1.

The drum has been partially shown in FIGS. 2, 3 and 5 for convenience of illustration.

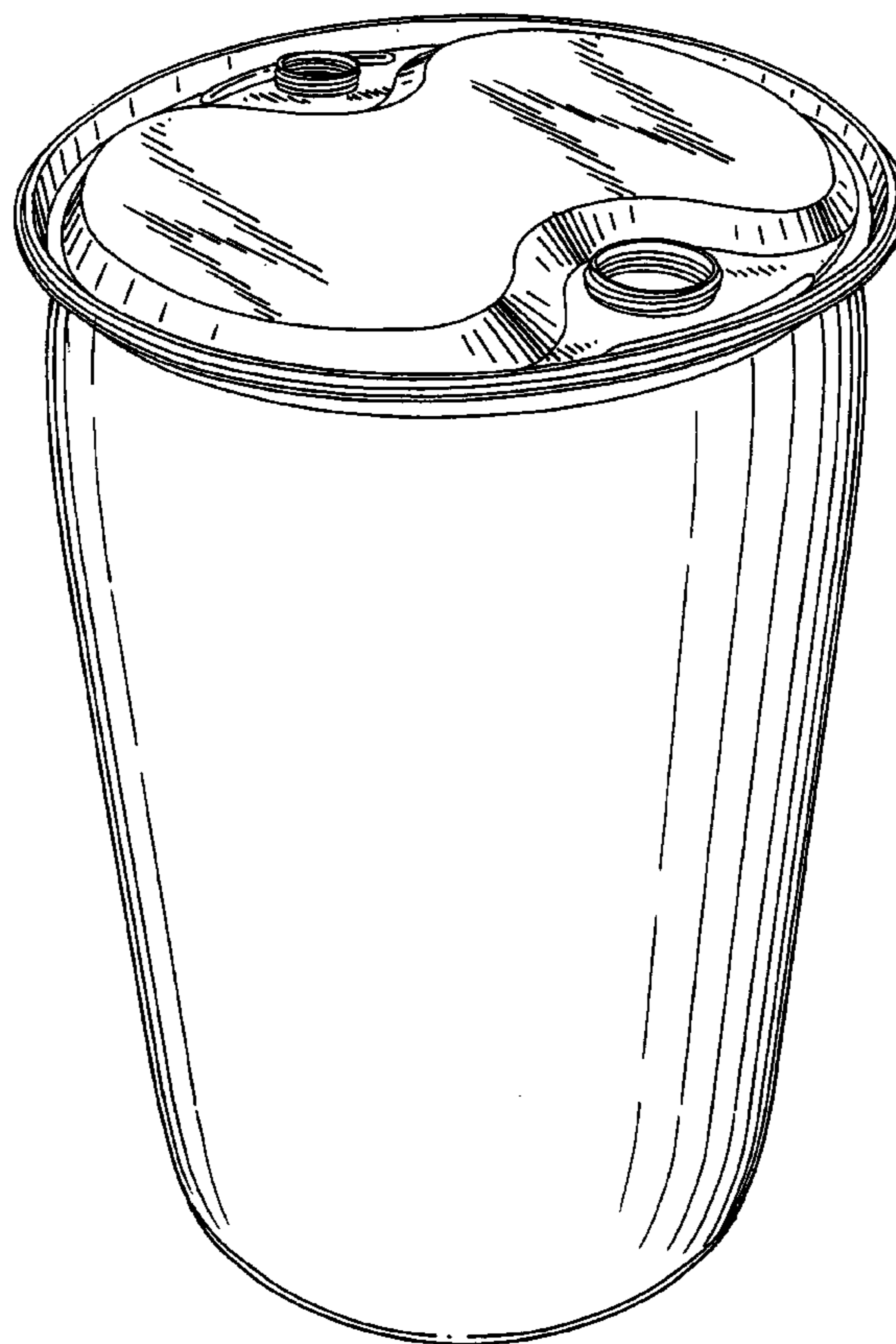
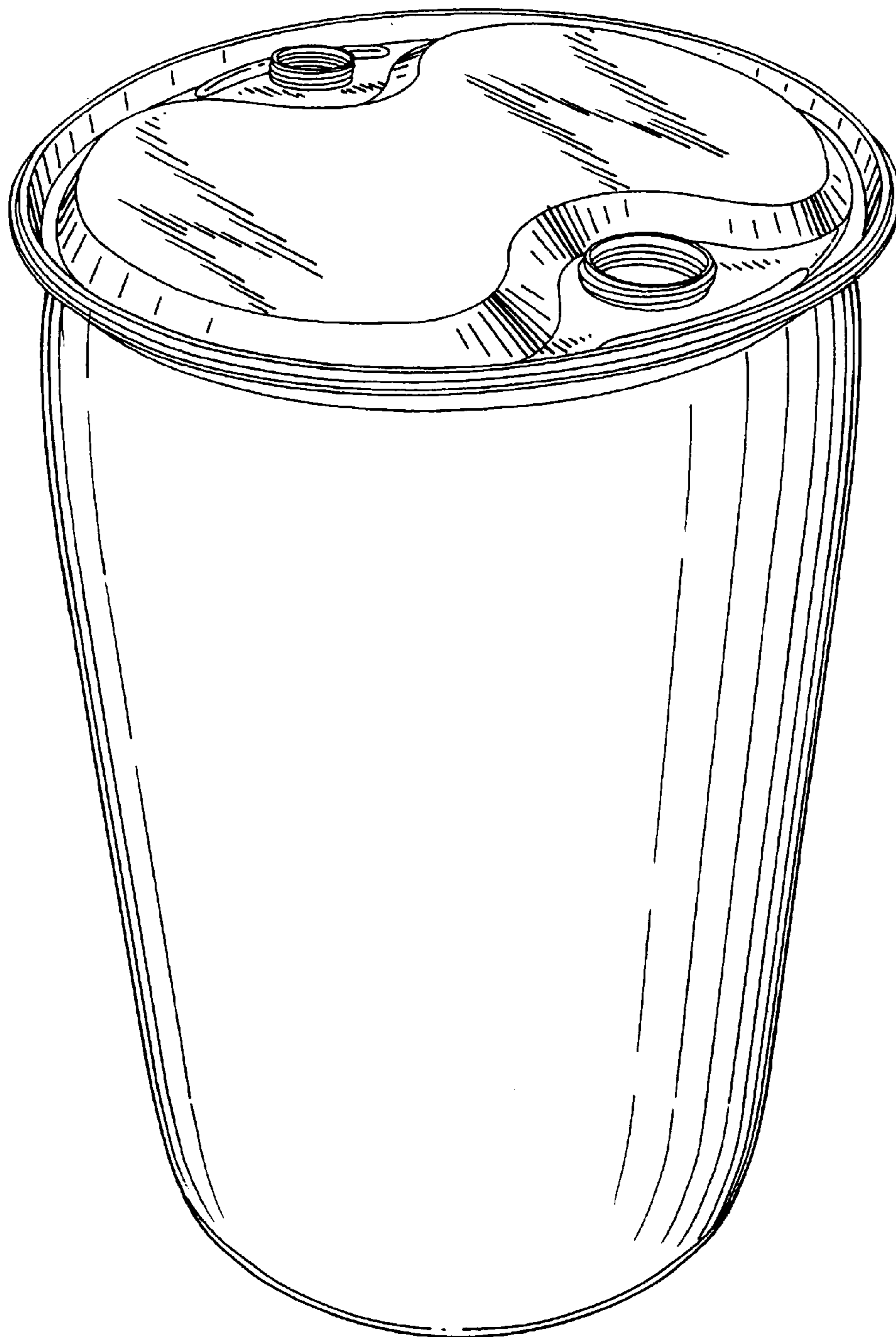

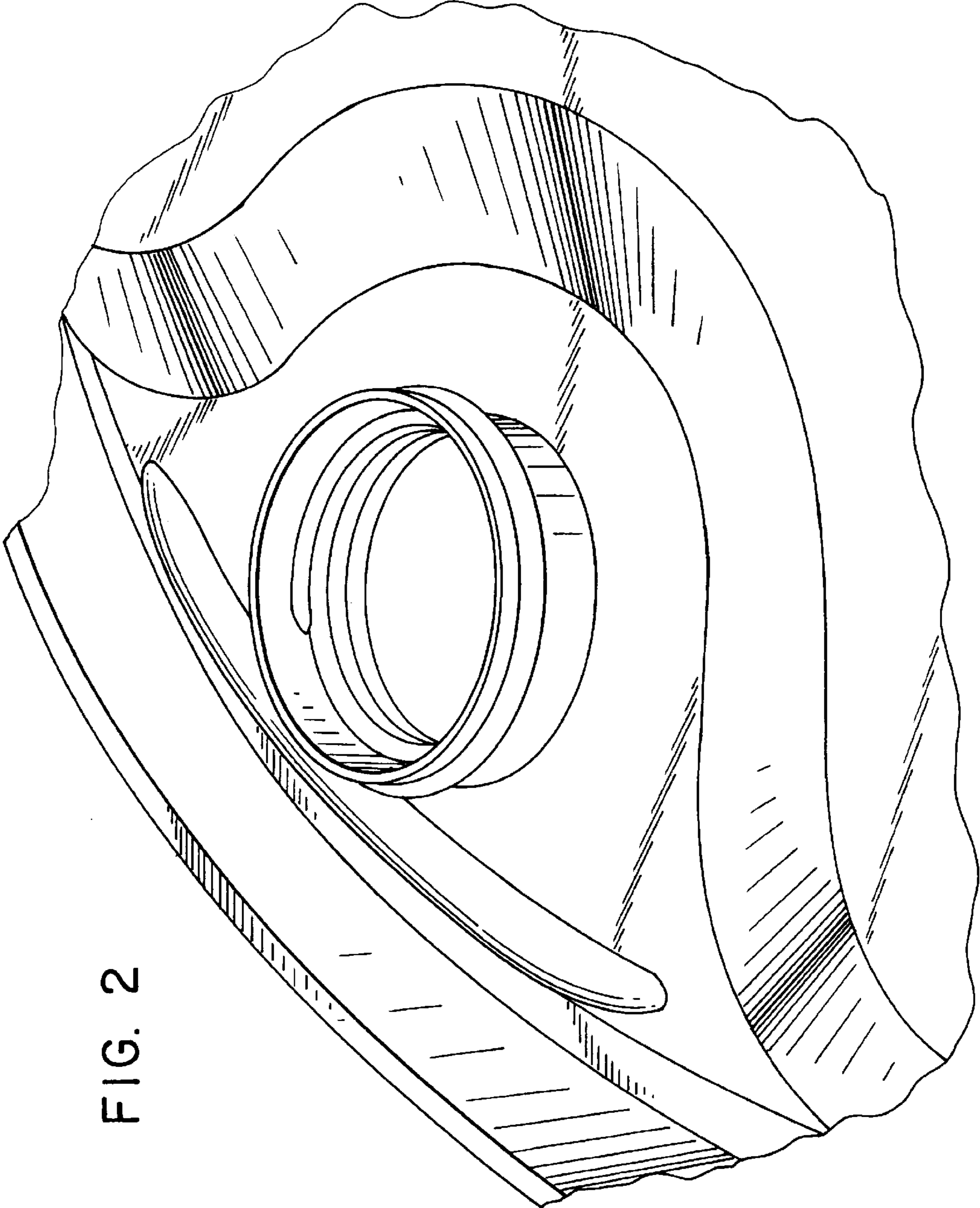

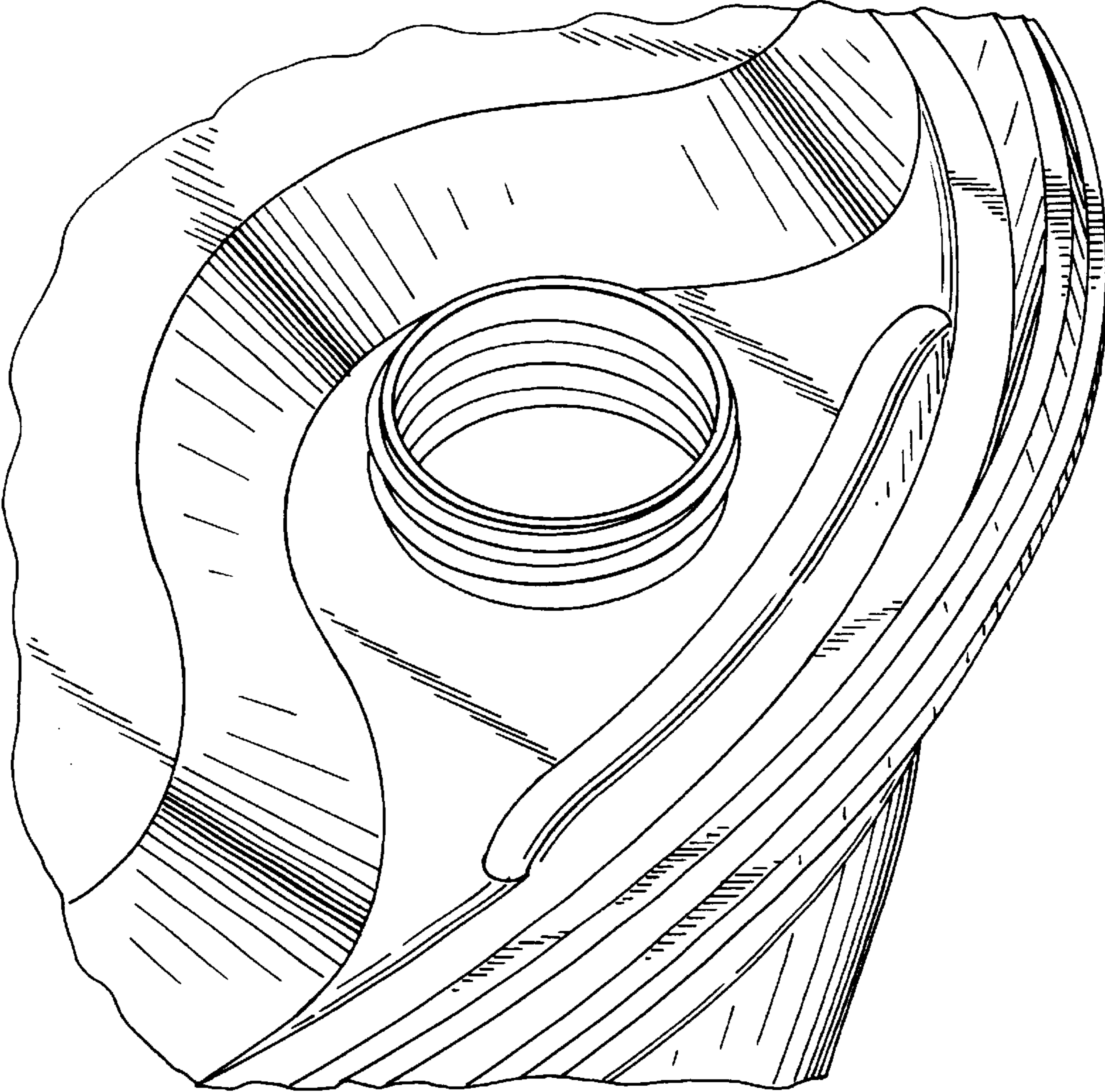

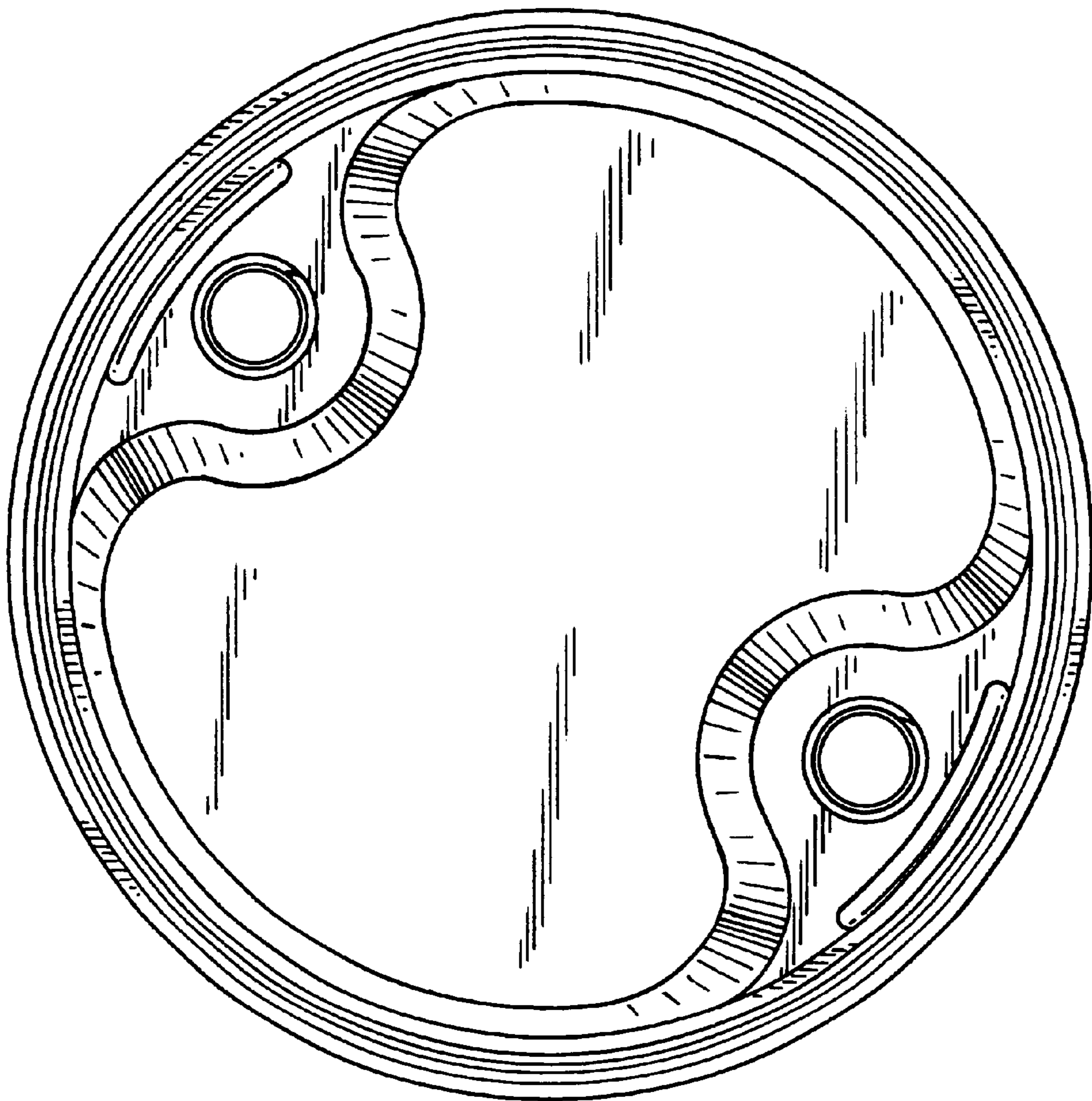
