FIG. 1 is a perspective view of a collapsible carrying bag with separable book carrying case showing our new design in an expanded configuration; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view thereof, wherein the book carrying case is shown separated from the collapsible bag; FIG. 9 is a perspective view of our collapsible carrying bag with separable book carrying case in a fully collapsed configuration; FIG. 10 a front elevational view of FIG. 9; FIG. 11 is a rear elevational of FIG. 9; FIG. 12 is a left elevational view of FIG. 9; FIG. 13 is a right elevational view of FIG. 9; FIG. 14 is a top plan view of FIG. 9; and, FIG. 15 is a bottom plan view of FIG. 9.

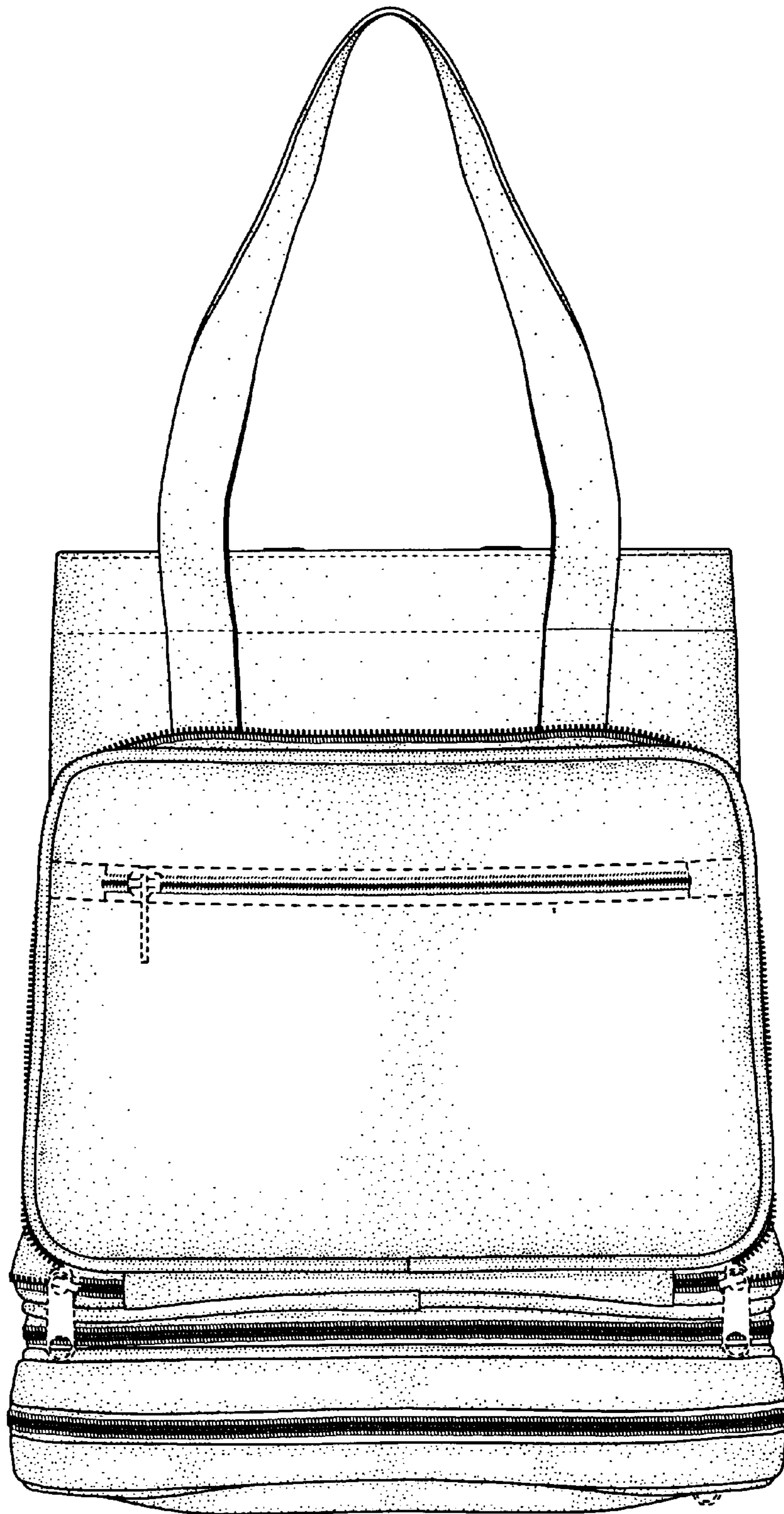

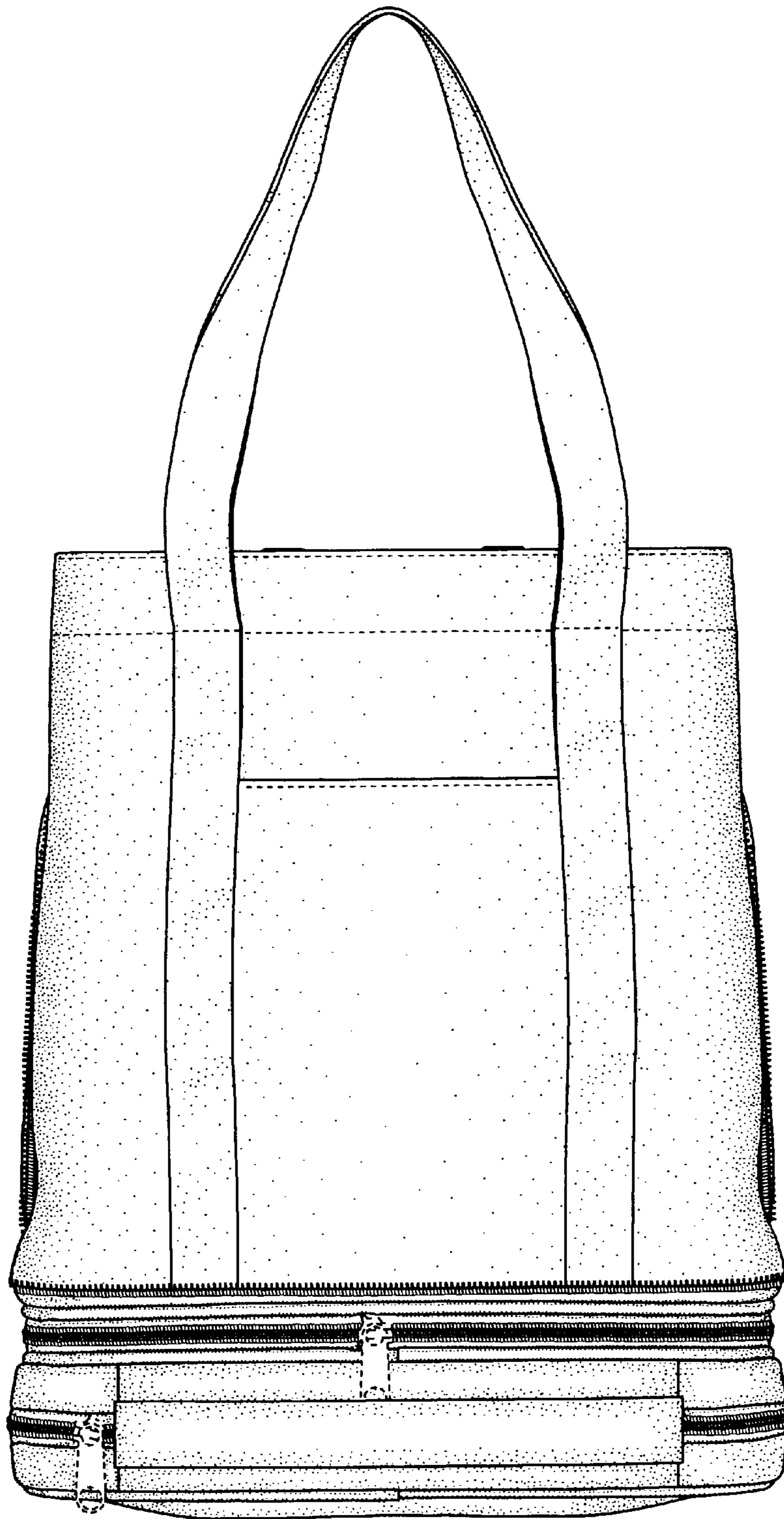

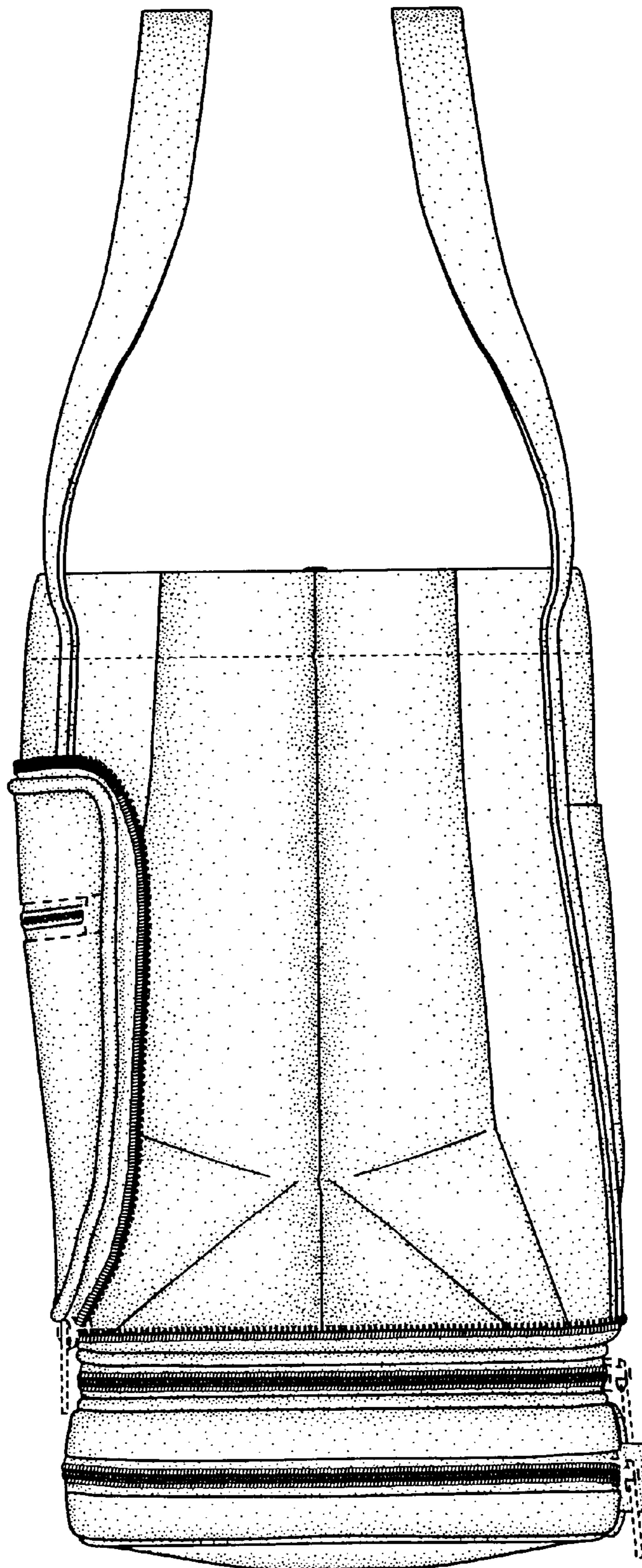

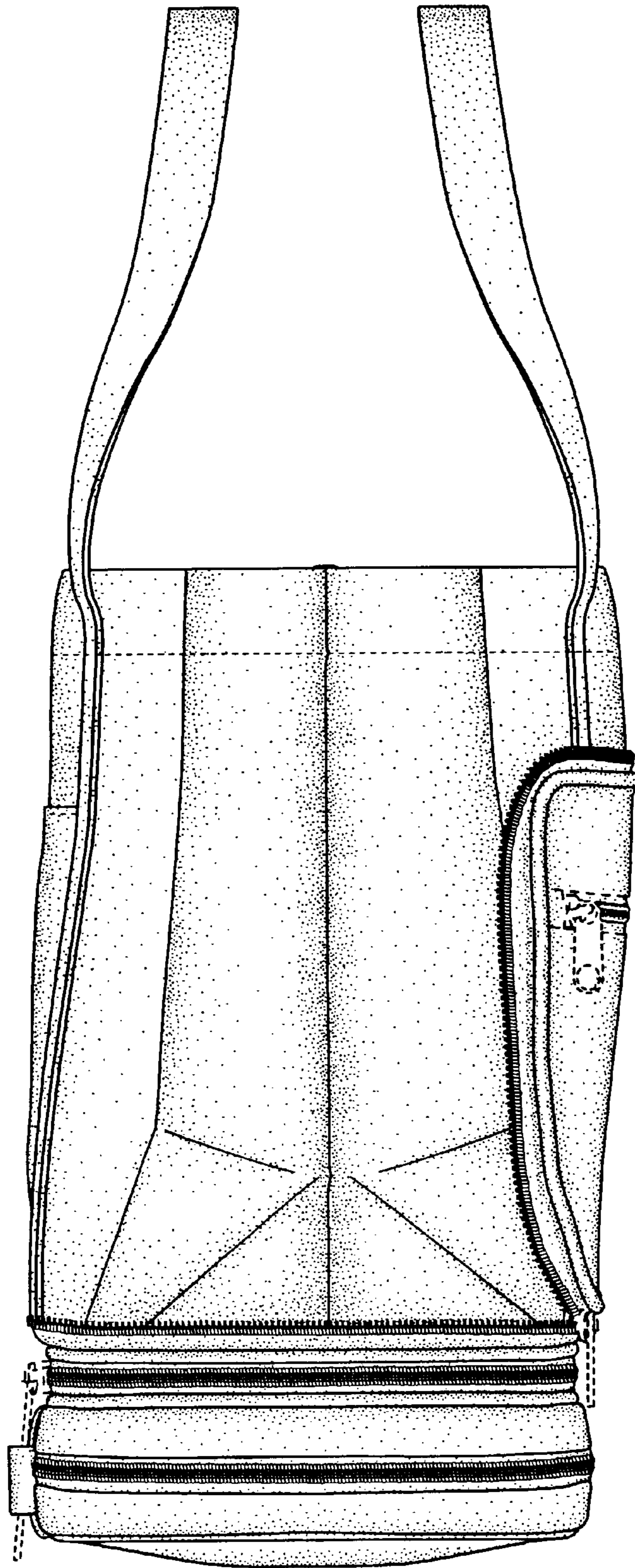

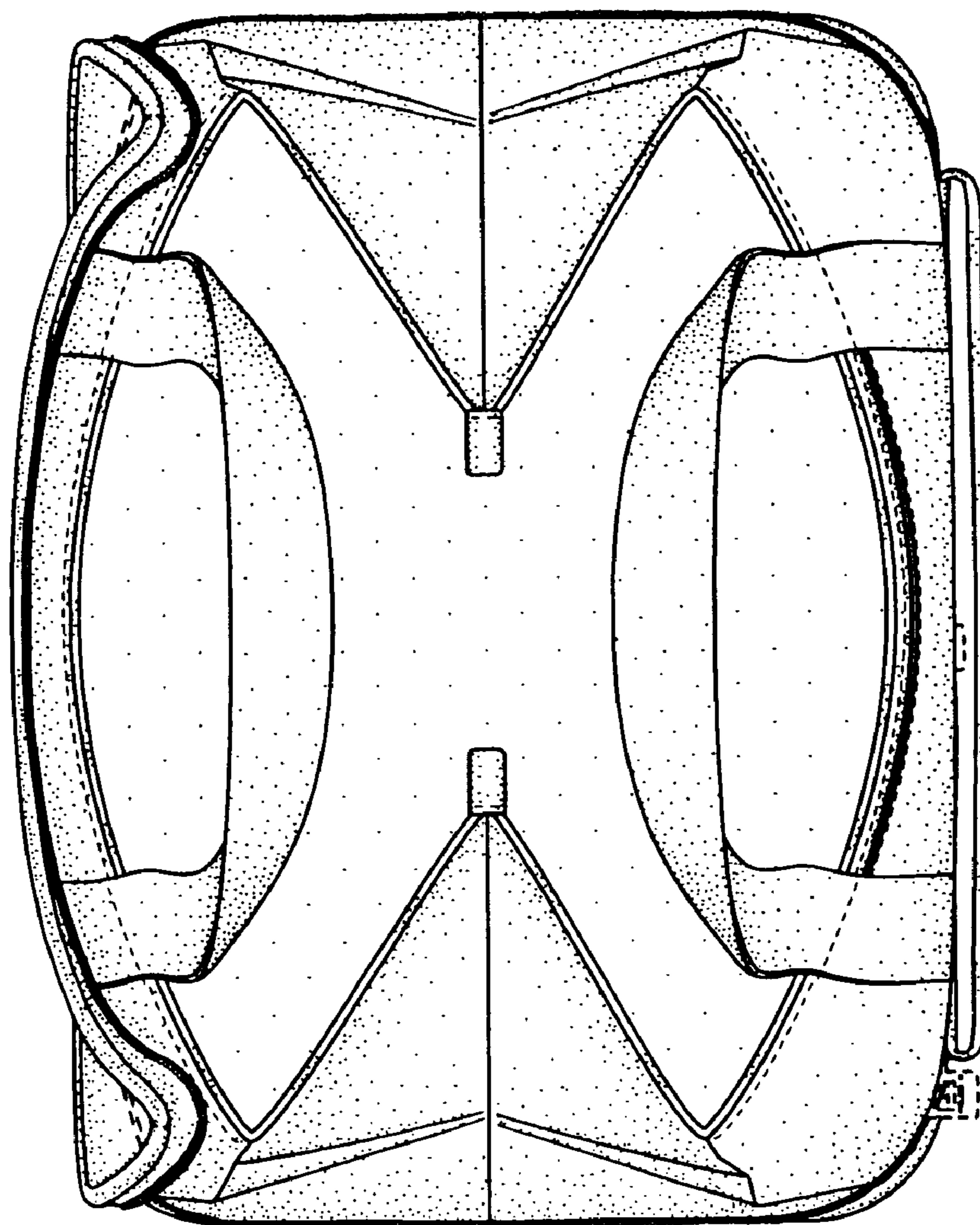

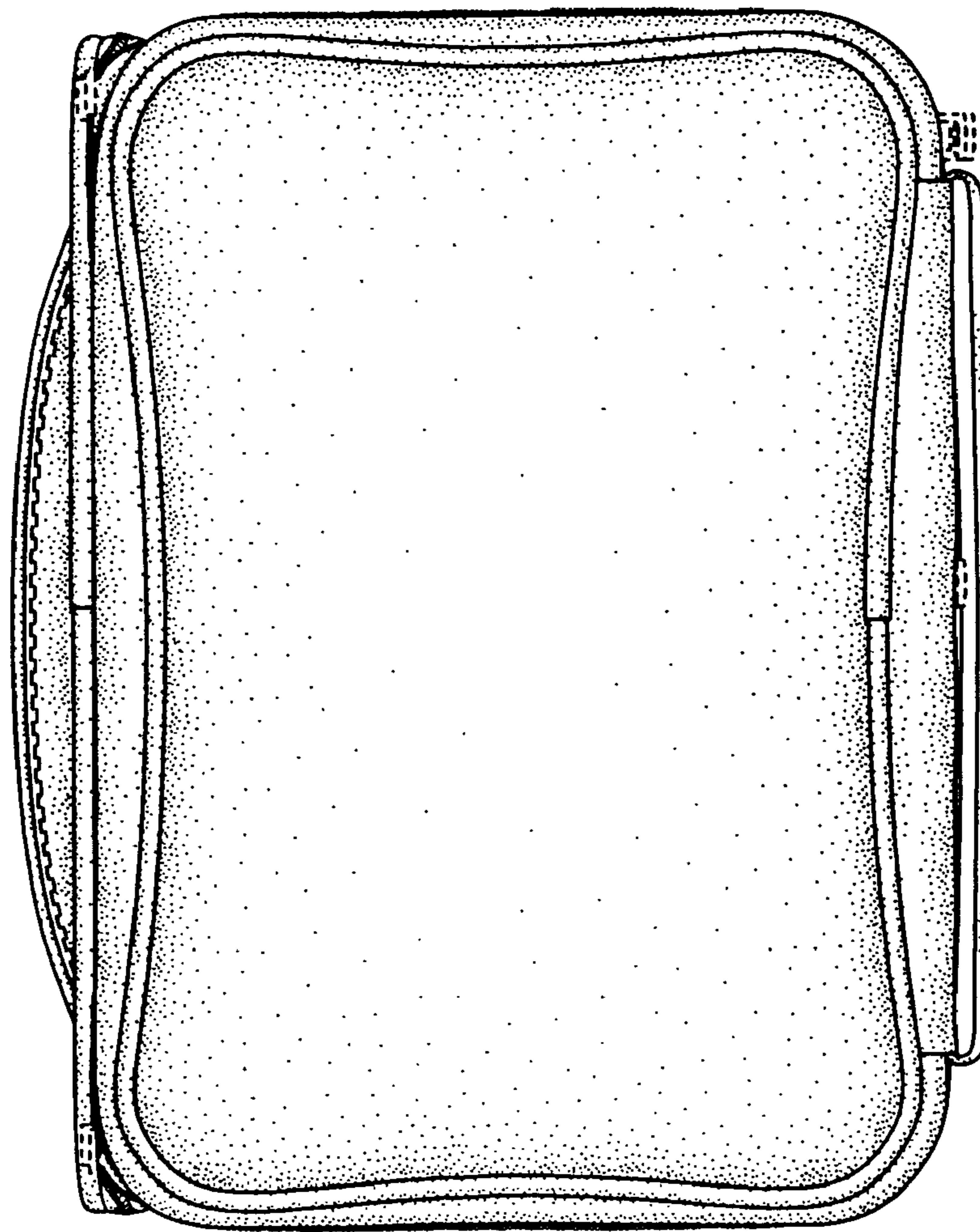

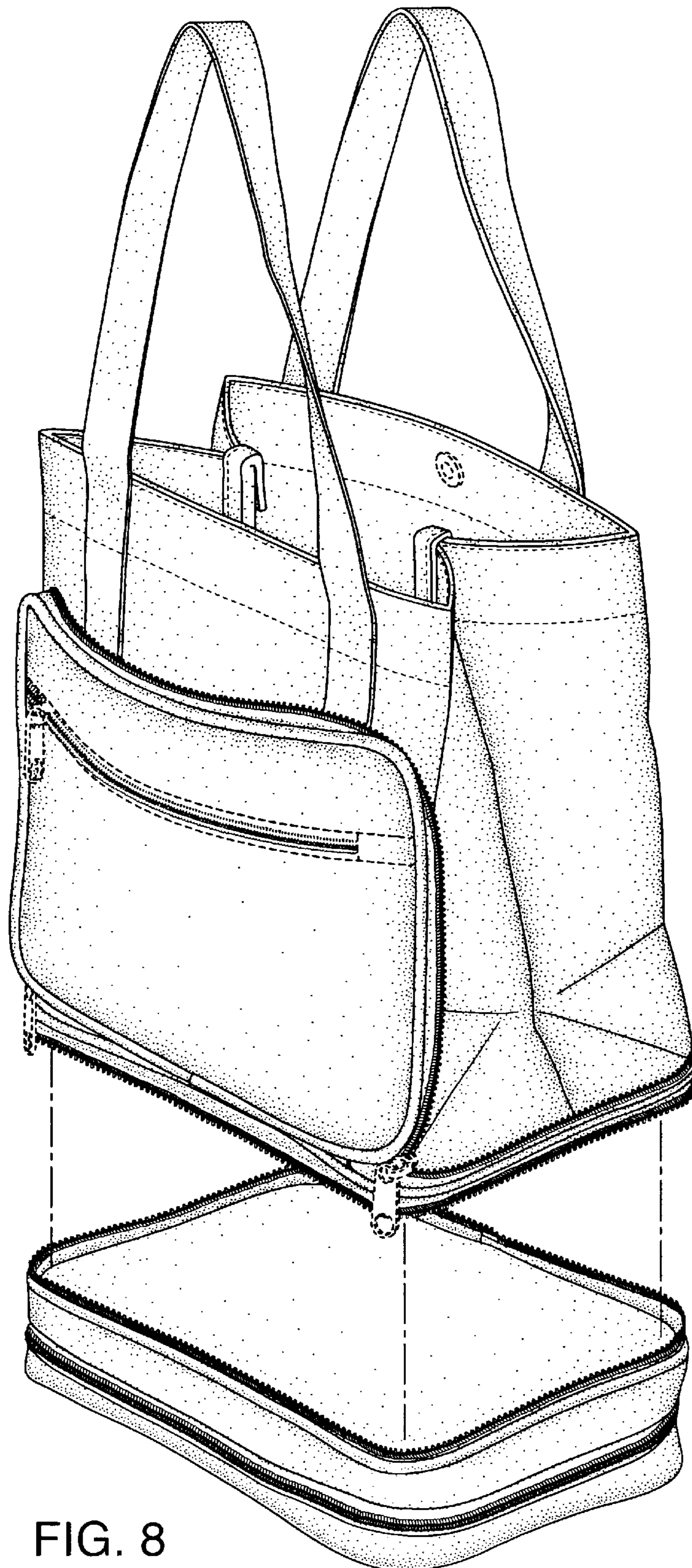

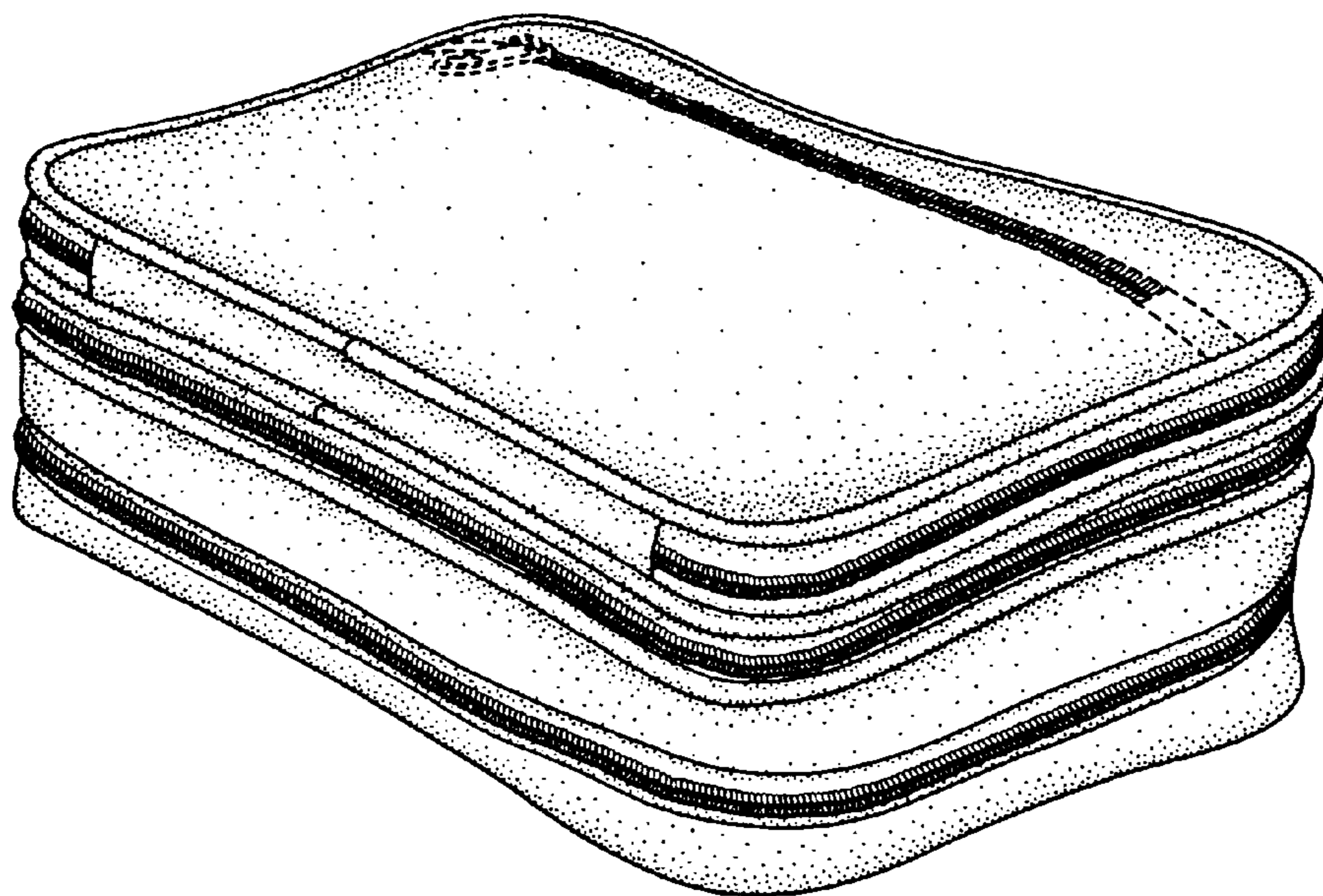

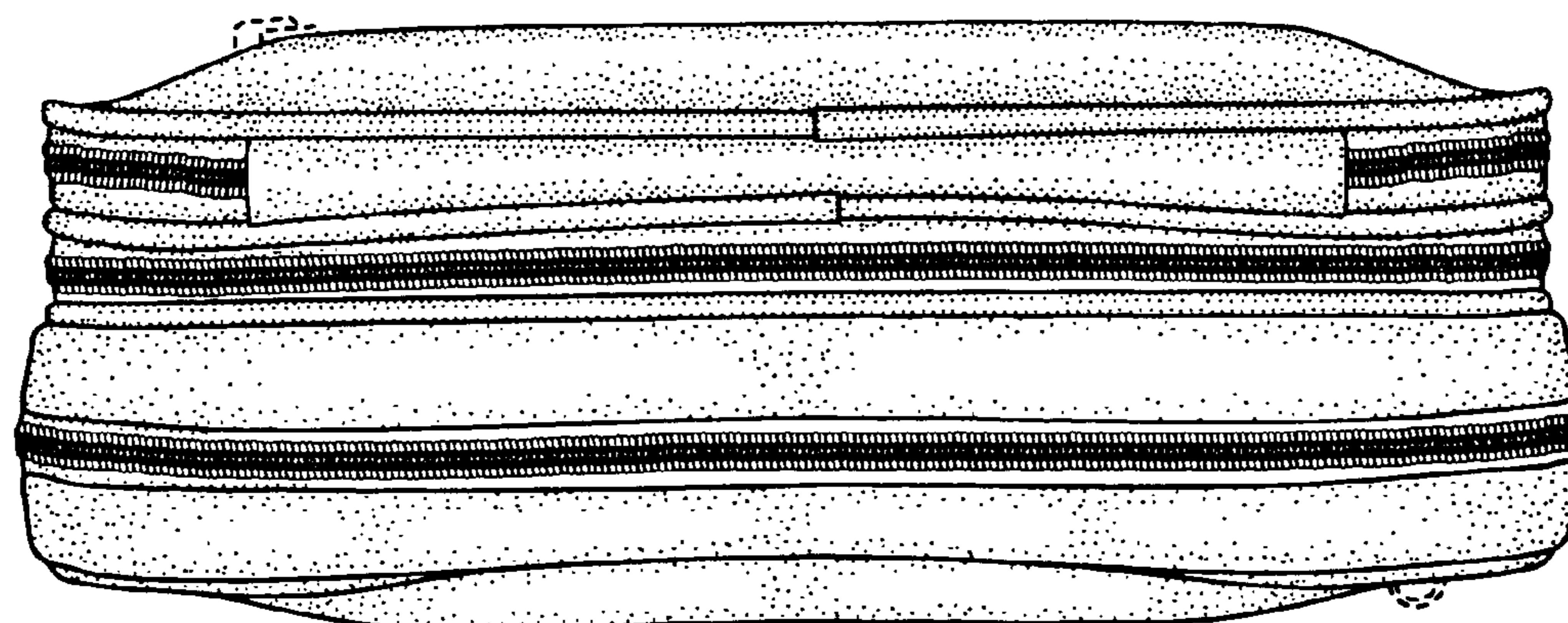

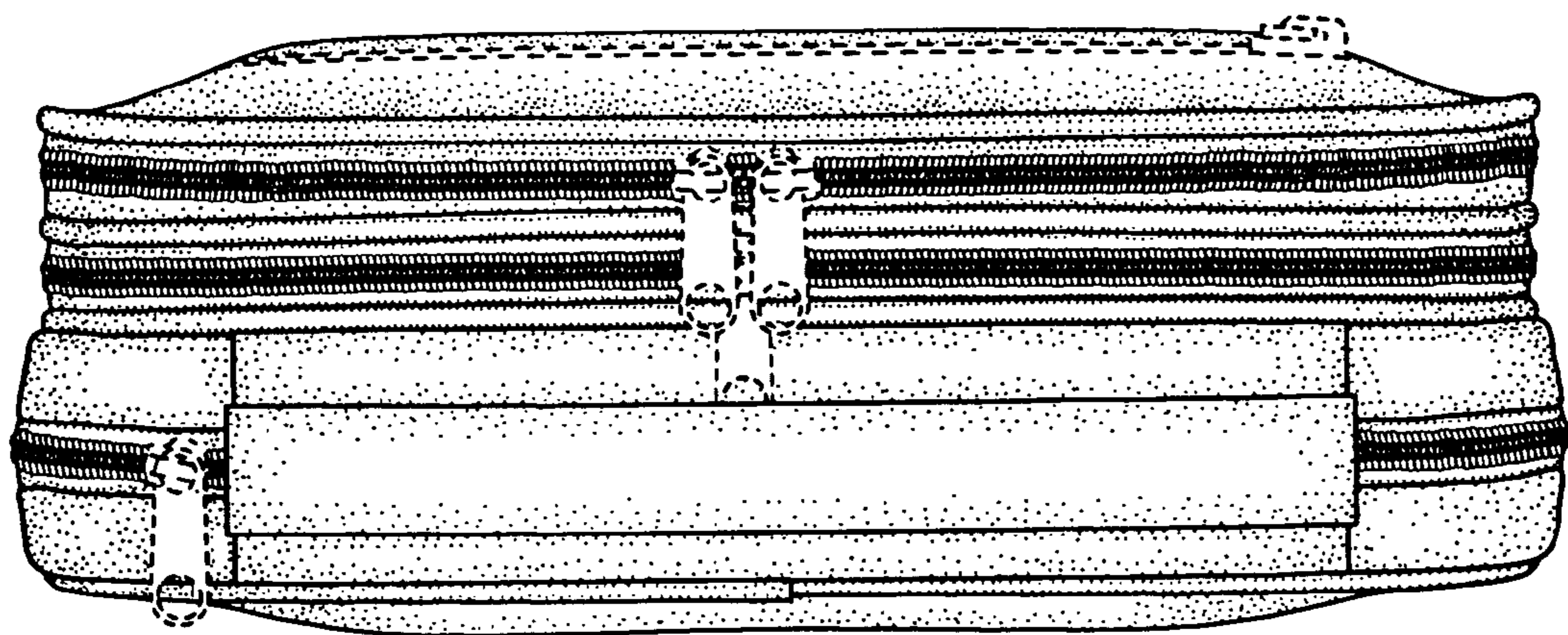

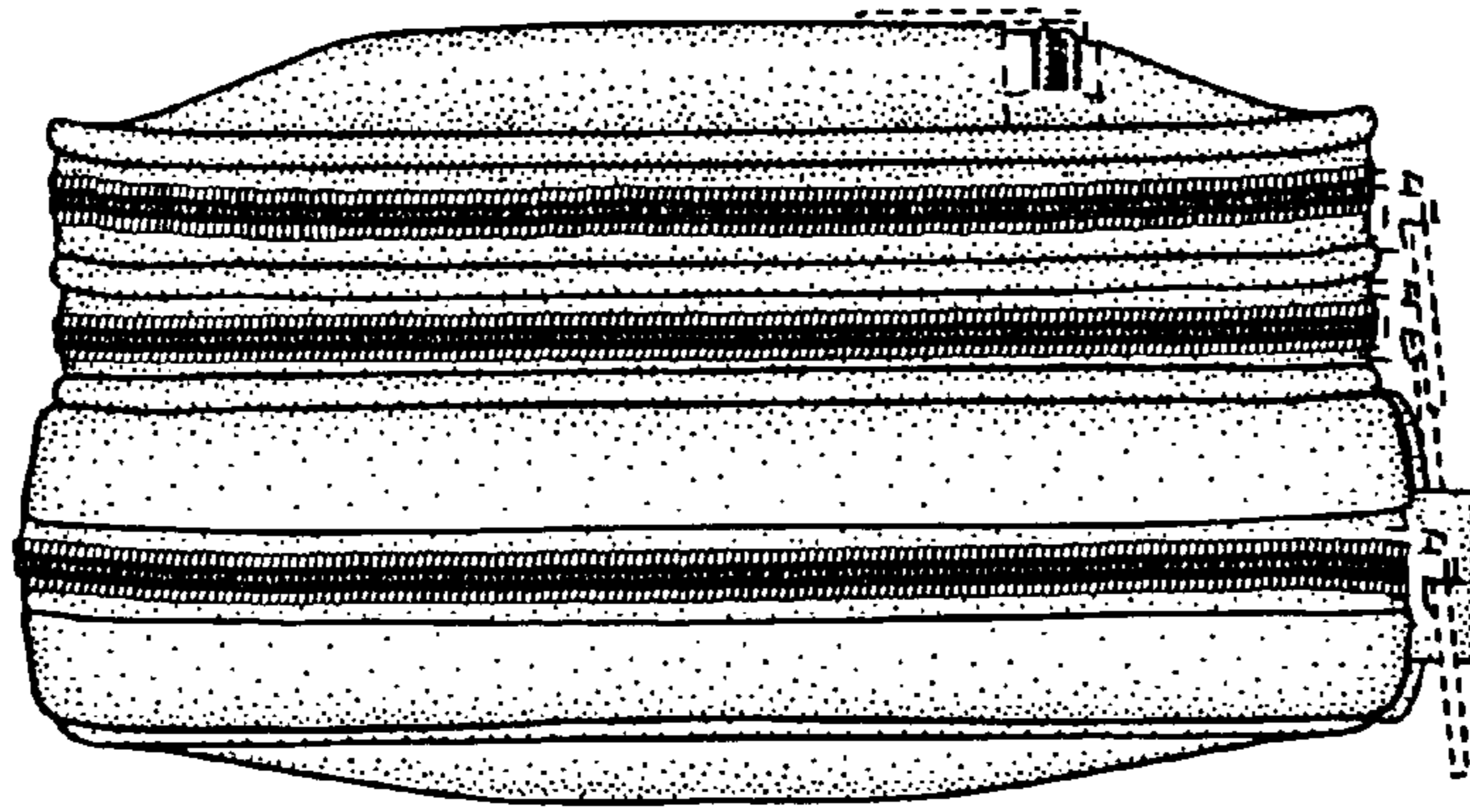

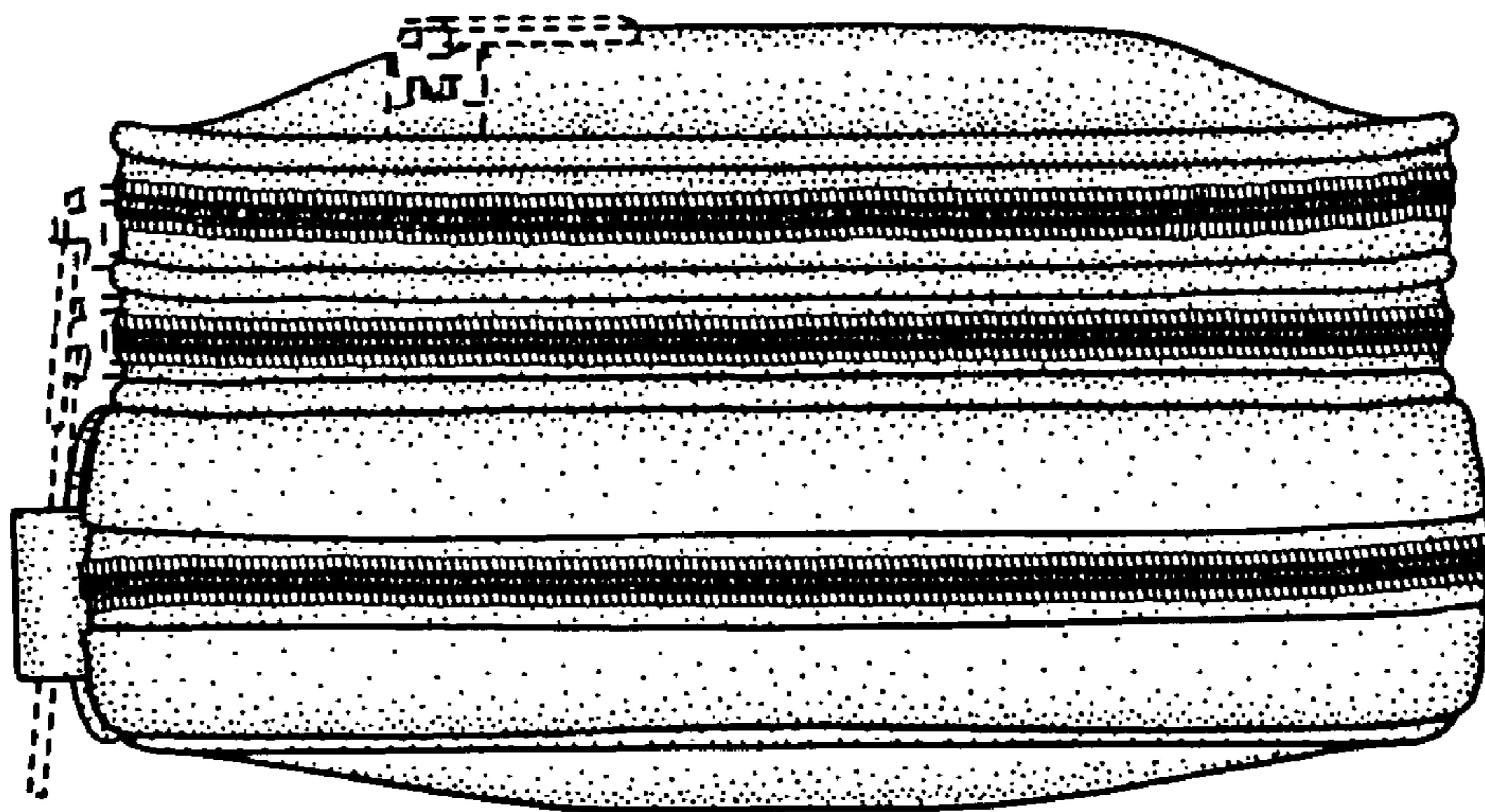

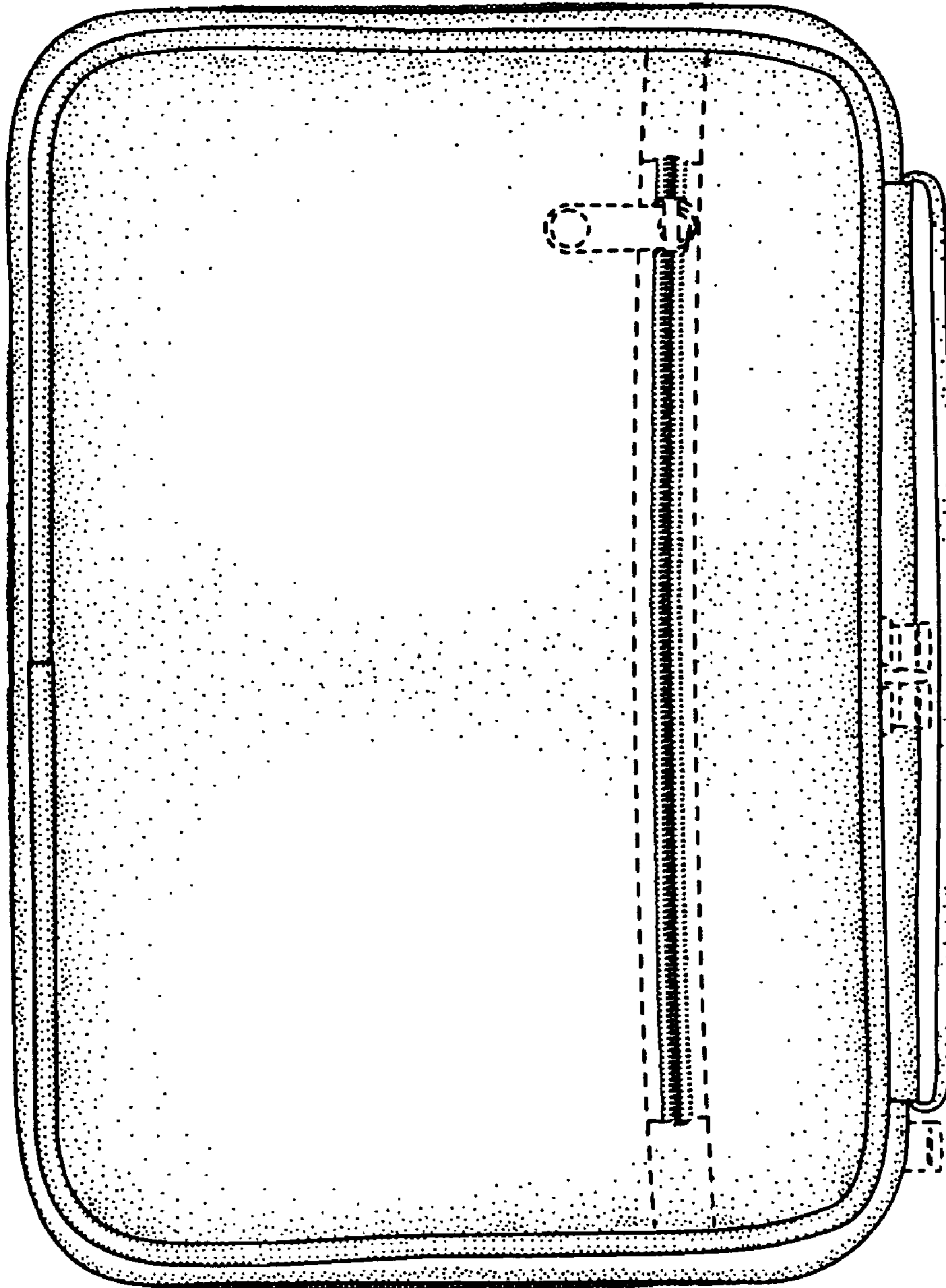

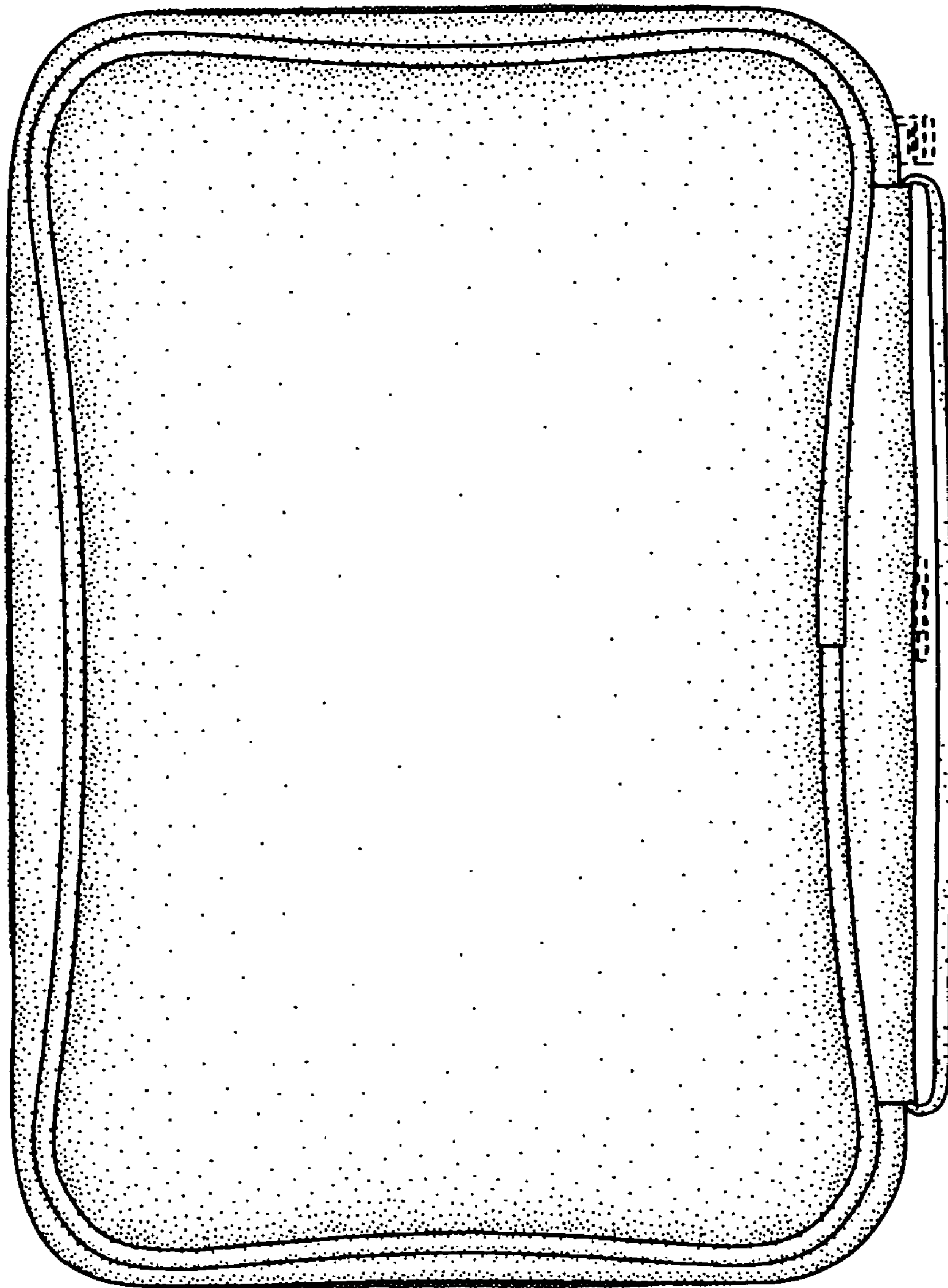
