(57) **CLAIM**

The ornamental design for a nonwoven fabric, as shown and described.

**DESCRIPTION**

The sole FIGURE is a plan view of a nonwoven fabric showing my new design.

The nonwoven fabric, which extends indeterminately in width and in length, shows my new design in a repeating pattern having raised portions.

The surfaces or portions of the article that would normally be visible but are not shown in the photograph or described in the specification form no part of the claimed design.
