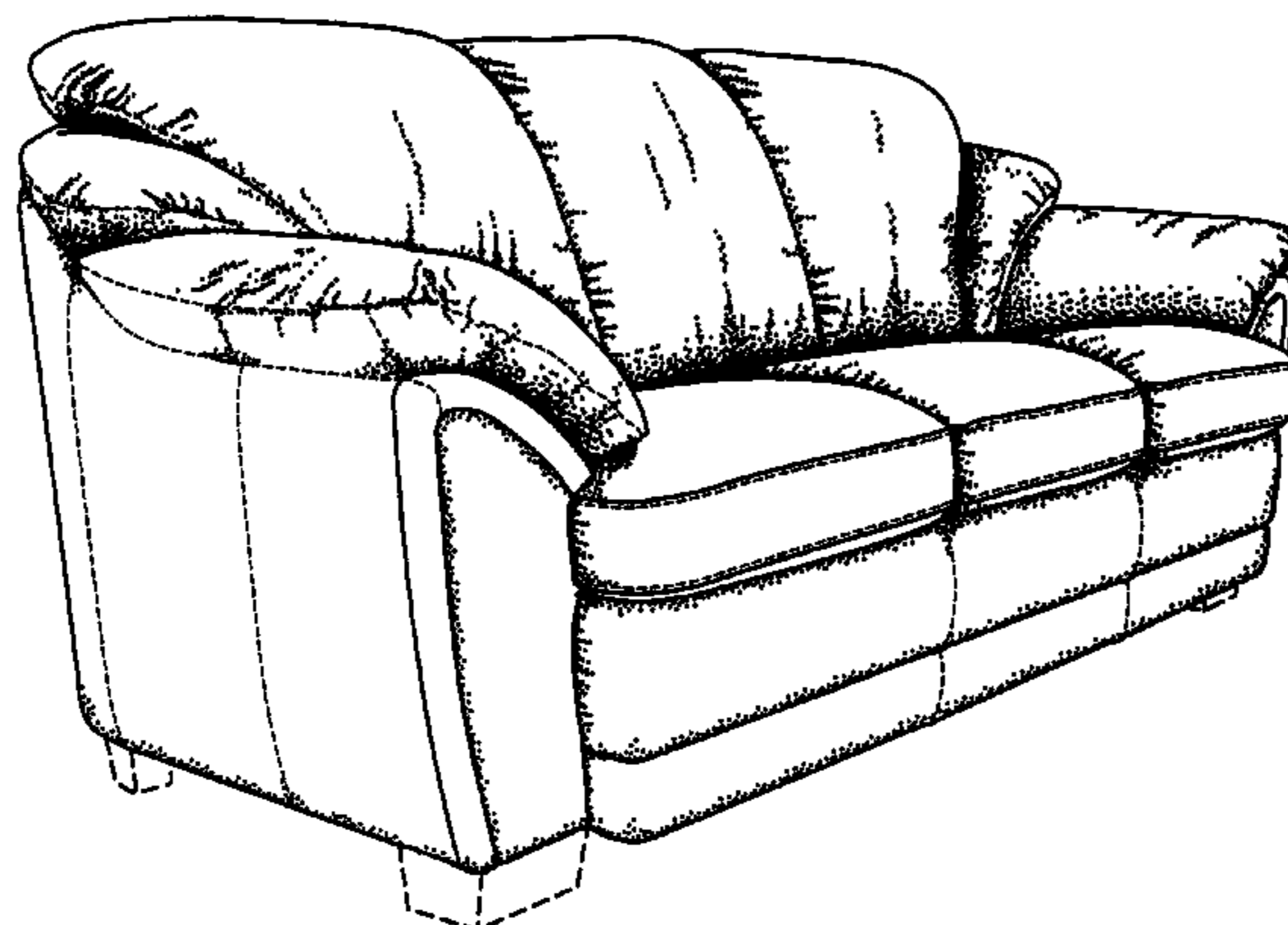
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of my new sofa design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a left, side elevation view, with the right side elevational view being a mirror image thereof; and,
FIG. 4 is a rear elevation view thereof.

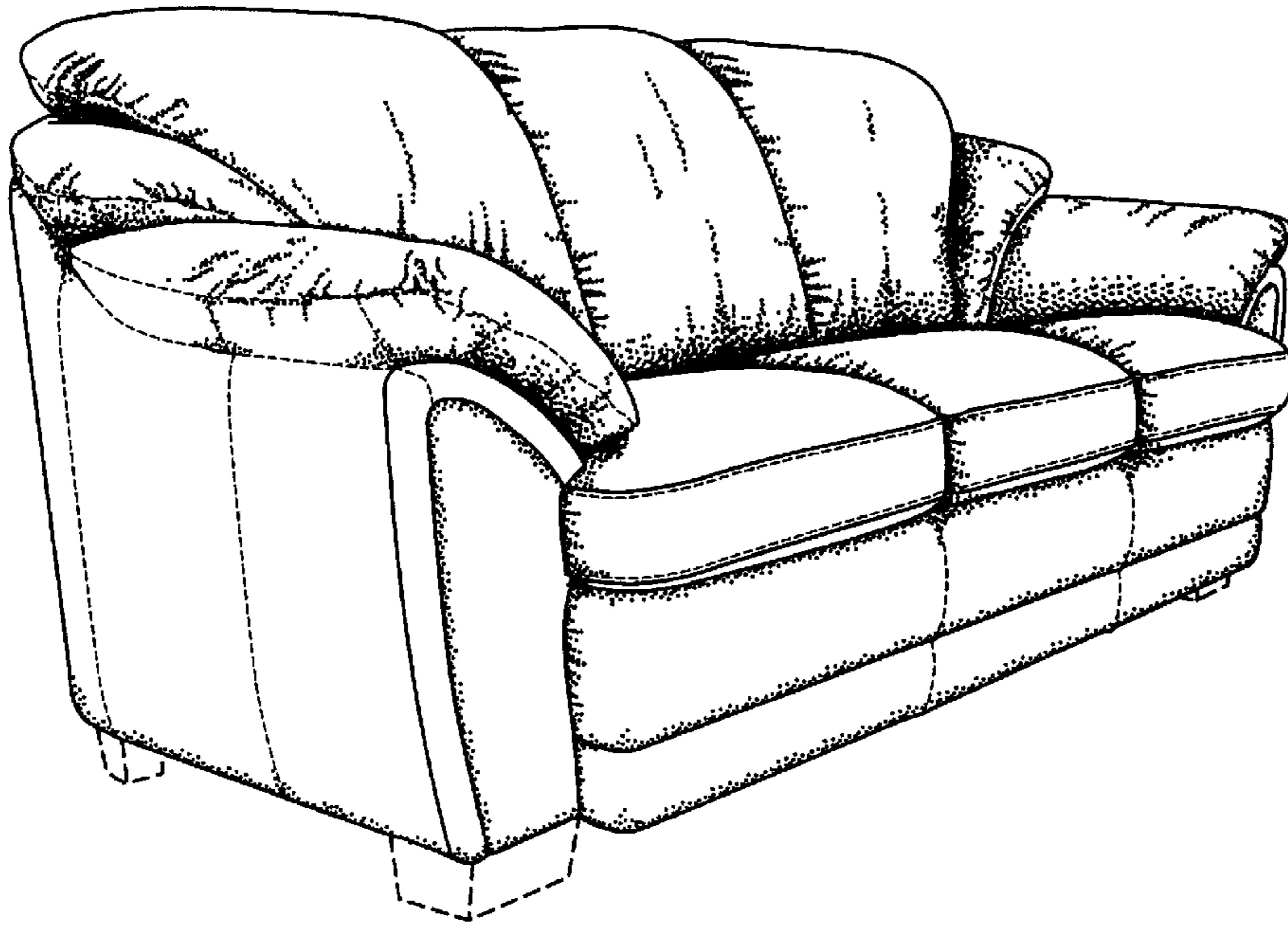

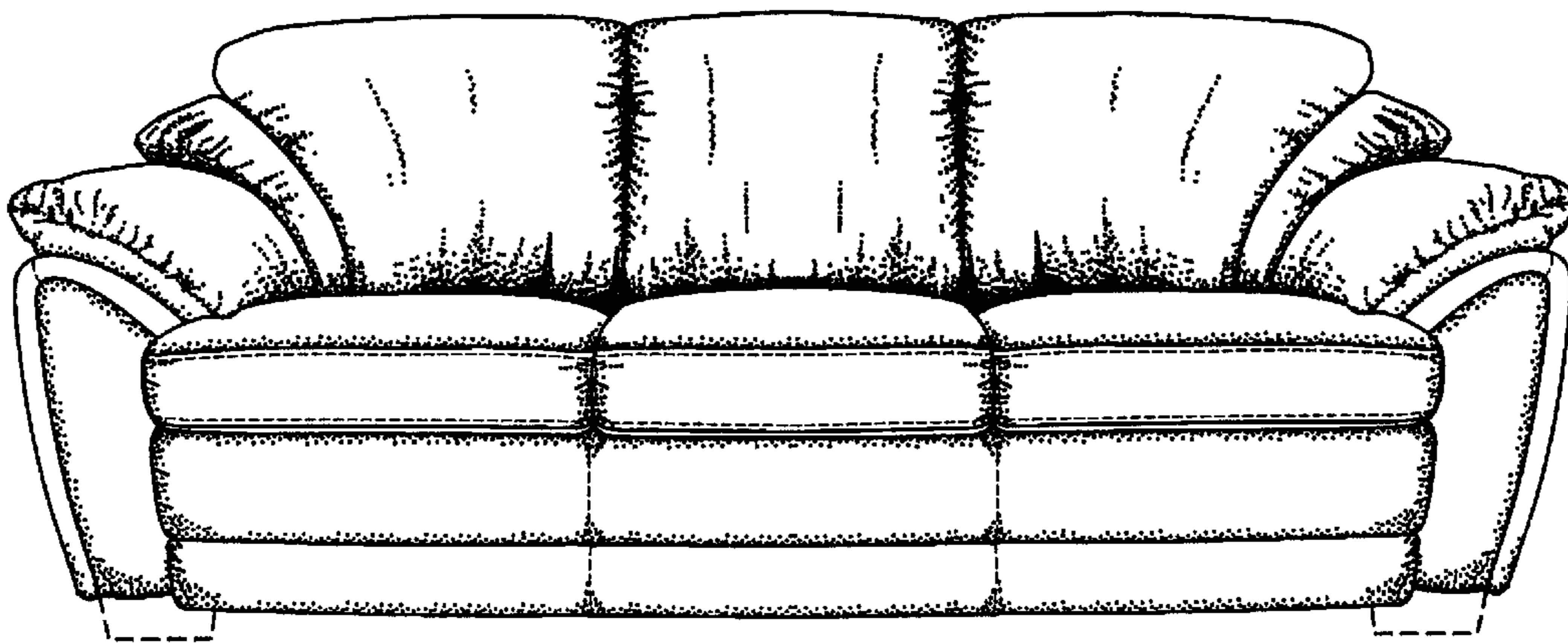

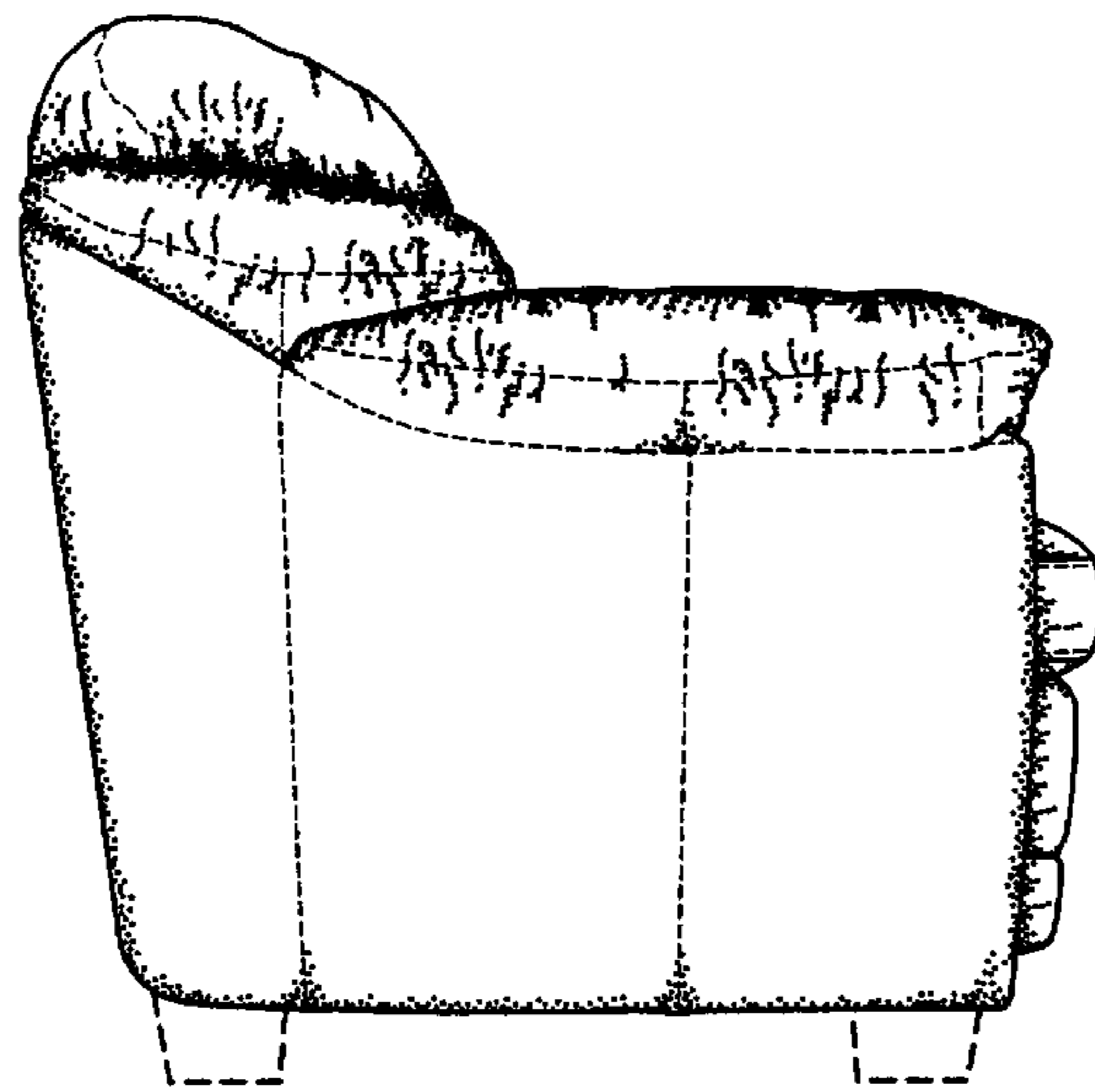

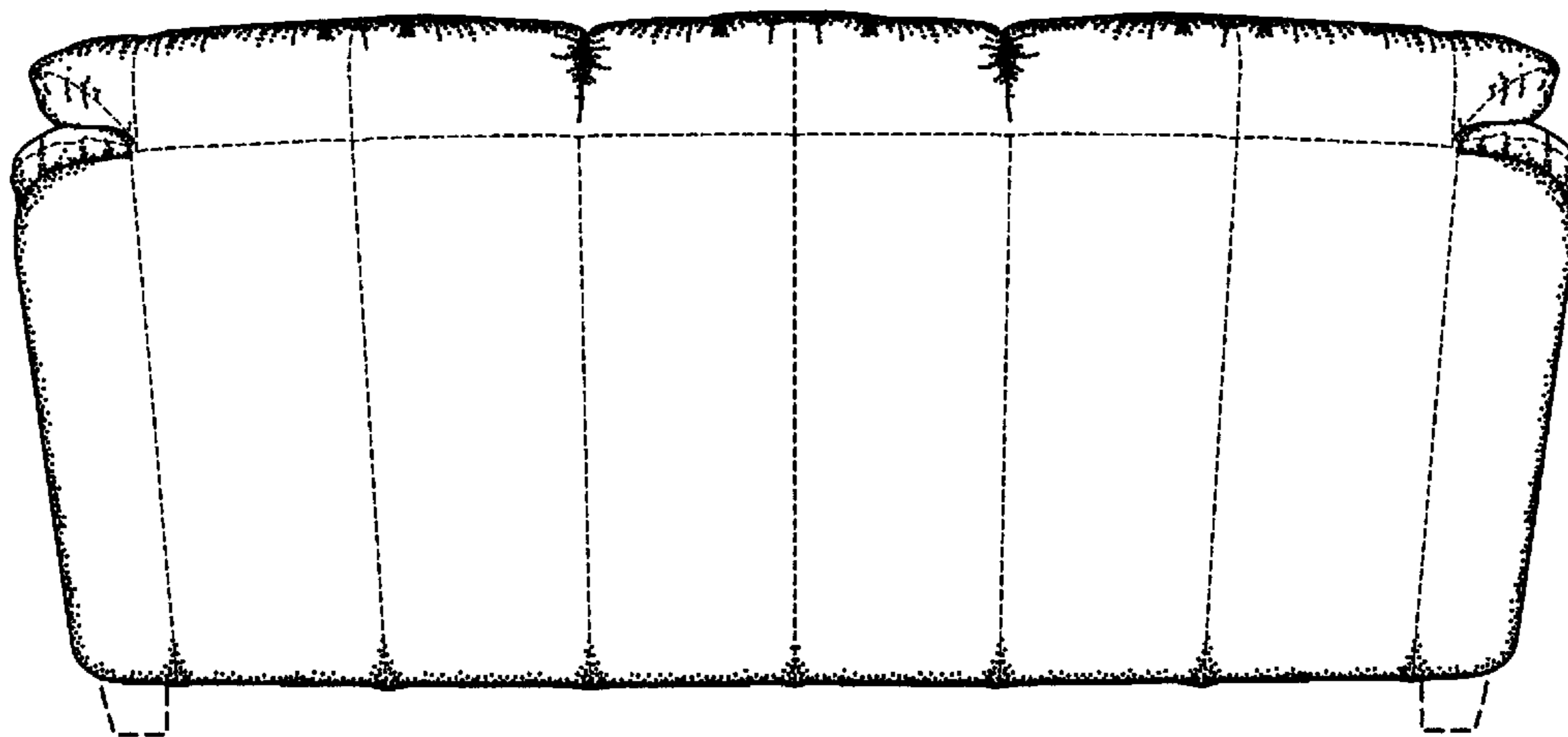
