(57) **CLAIM**

The ornamental design for container with a hinged lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a container with a hinged lid showing my new design, wherein the lid is closed;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof, the right-side view being a mirror image;

FIG. 5 is a top view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a perspective view of the first embodiment, wherein the lid is open;

FIG. 8 is a front view of a second embodiment of a container with a hinged lid showing my new design;

FIG. 9 is a rear view thereof;

FIG. 10 is a left-side view thereof, the right-side view being a mirror image;

FIG. 11 is a top view thereof;

FIG. 12 is a bottom view thereof;

FIG. 13 is a front view of a third embodiment of a container with a hinged lid showing my new design;

FIG. 14 is a rear view thereof;

FIG. 15 is a left-side view thereof, the right-side view being a mirror image;

FIG. 16 is a top view thereof;

FIG. 17 is a bottom view thereof;

FIG. 18 is an enlarged, front view of a fourth embodiment of a container with a hinged lid showing my new design;

FIG. 19 is an enlarged, rear view thereof;

FIG. 20 is an enlarged, left-side view thereof, the right-side view being a mirror image;

FIG. 21 is an enlarged, top view thereof;

FIG. 22 is an enlarged, bottom view thereof;

FIG. 23 is an enlarged, front view of a fifth embodiment of a container with a hinged lid showing my new design;

FIG. 24 is an enlarged, rear view thereof;

FIG. 25 is an enlarged, left-side view thereof, the right-side view being a mirror image;

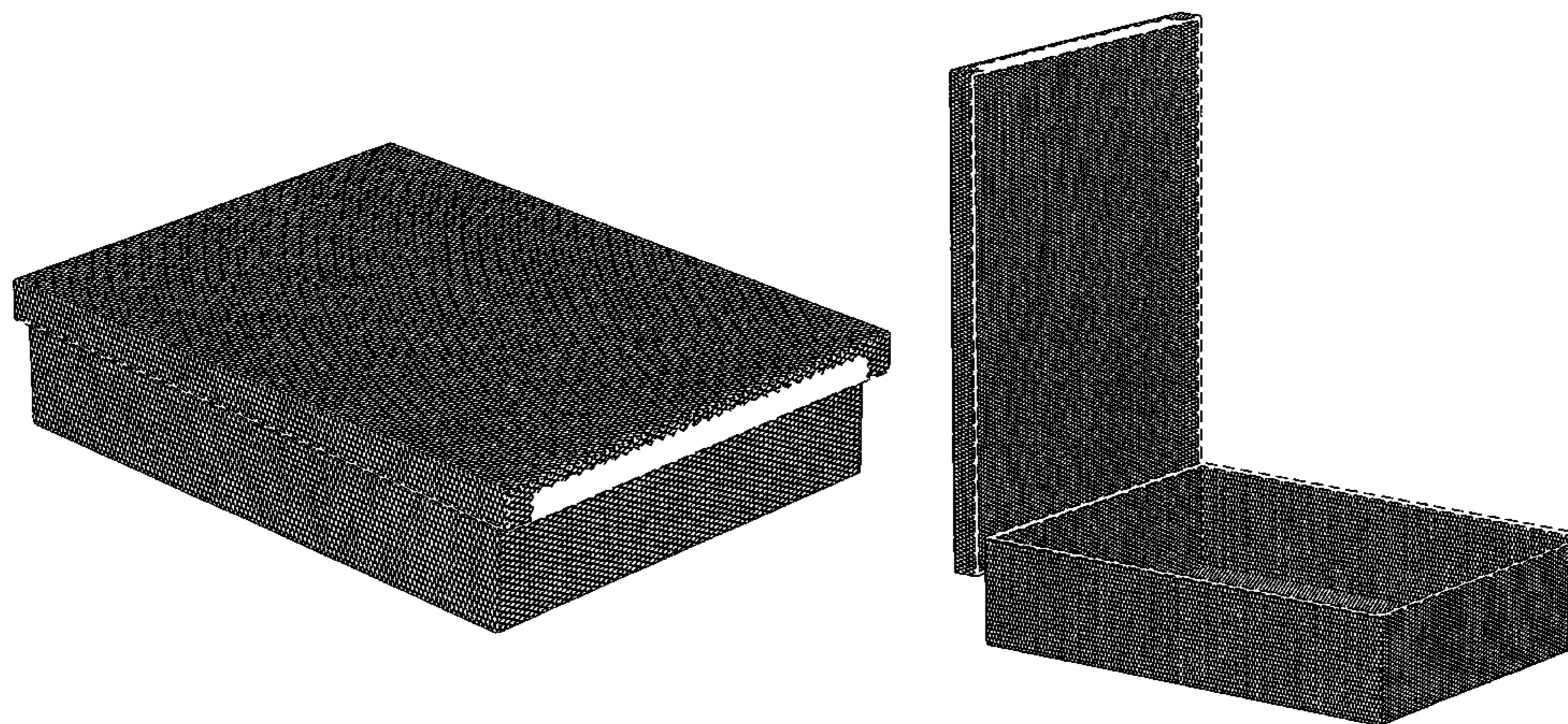
FIG. 26 is an enlarged, top view thereof; and,

The mesh material that may be visible through each of the somewhat U-shaped openings and through the holes in the mesh has been removed for clarity.

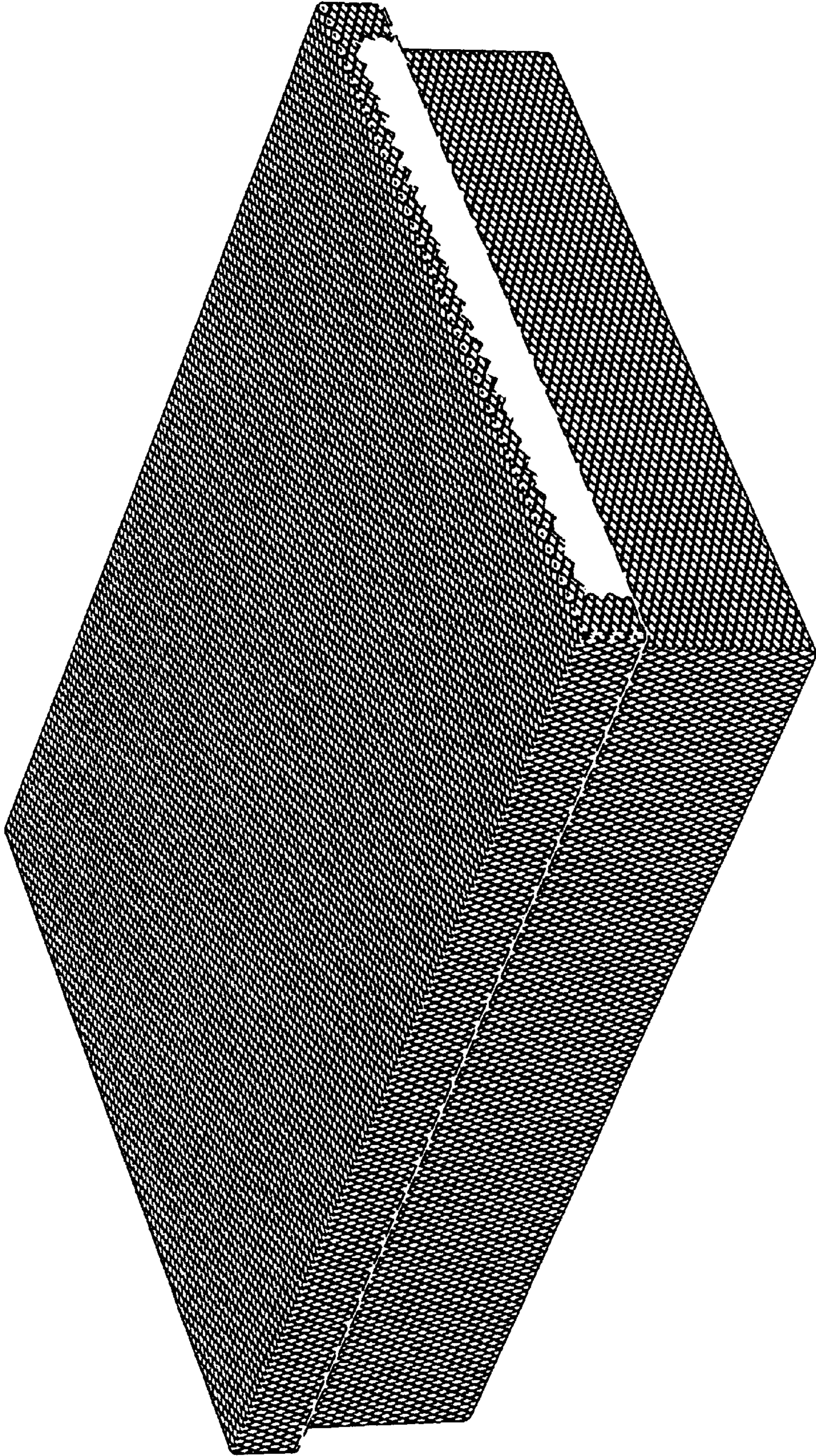

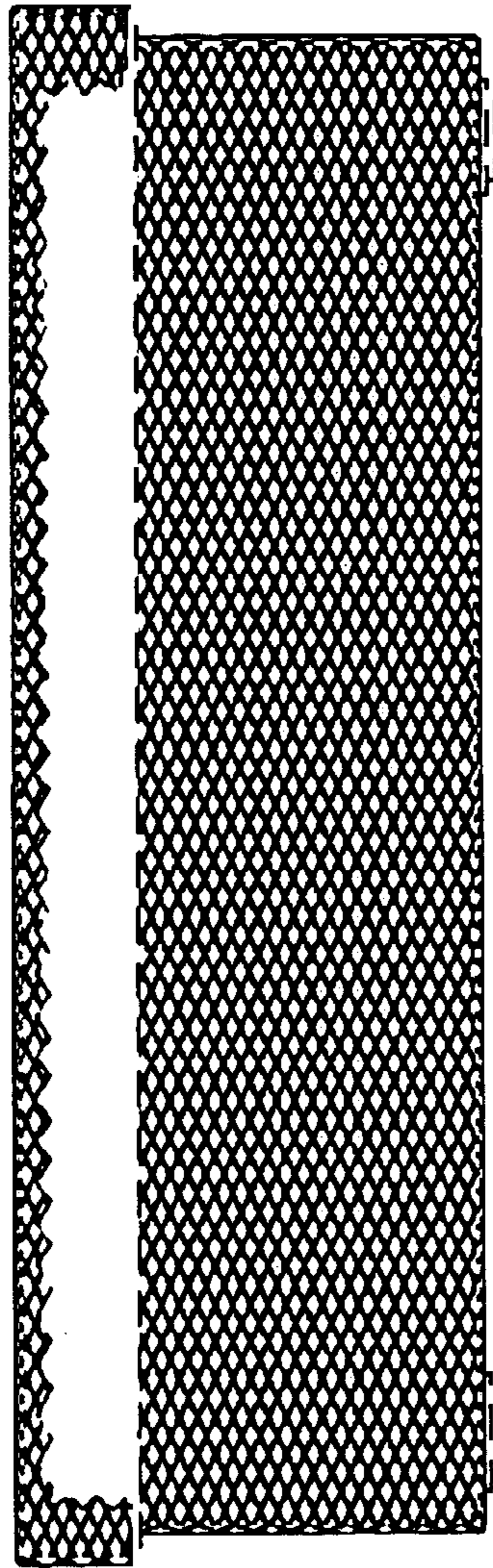

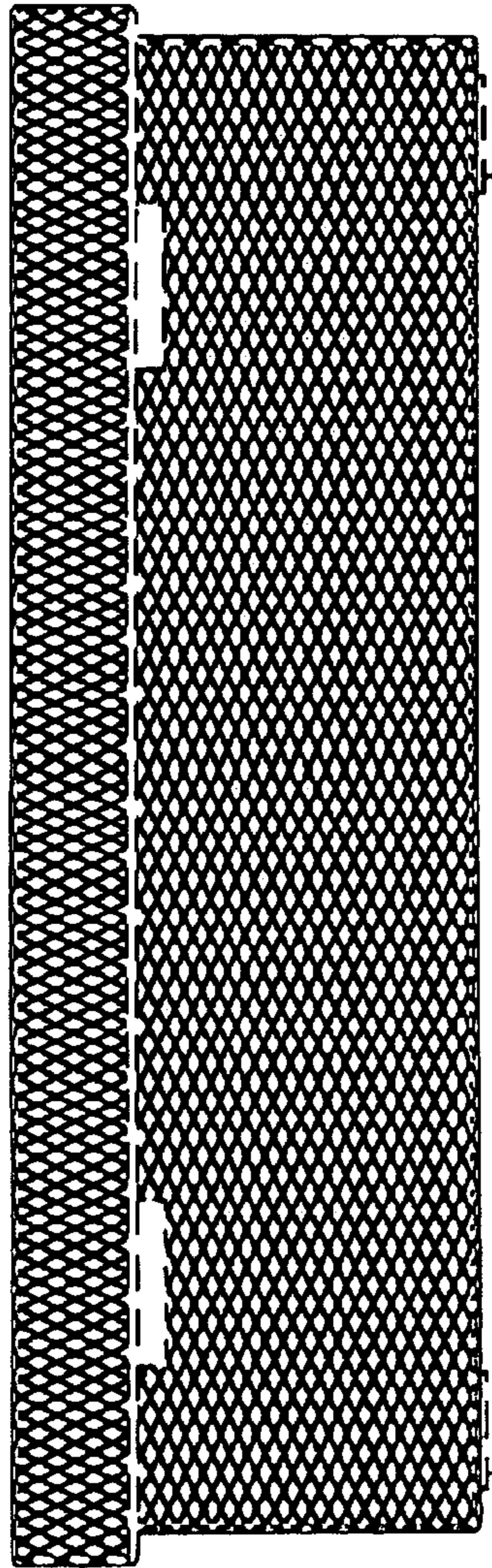

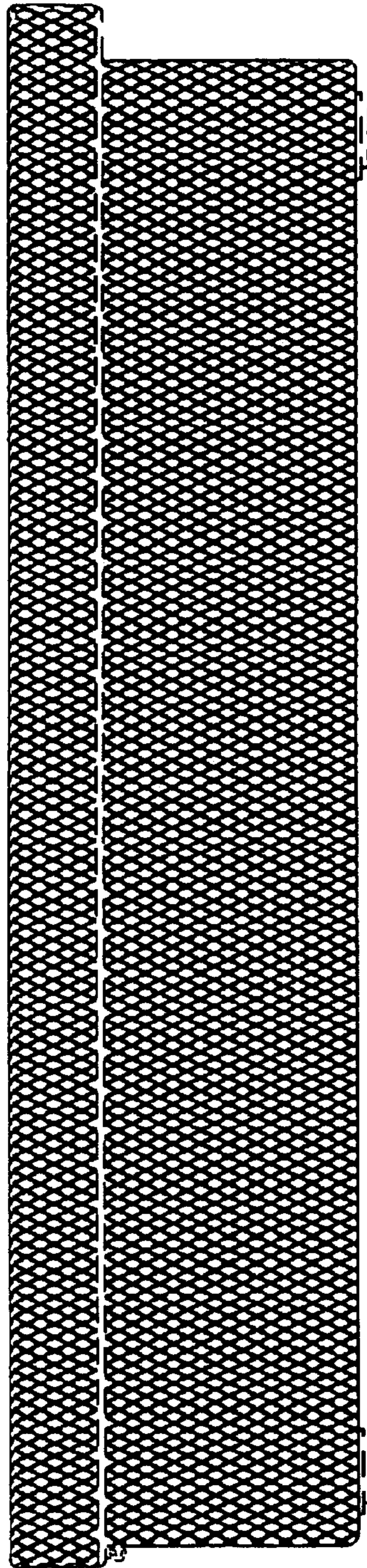

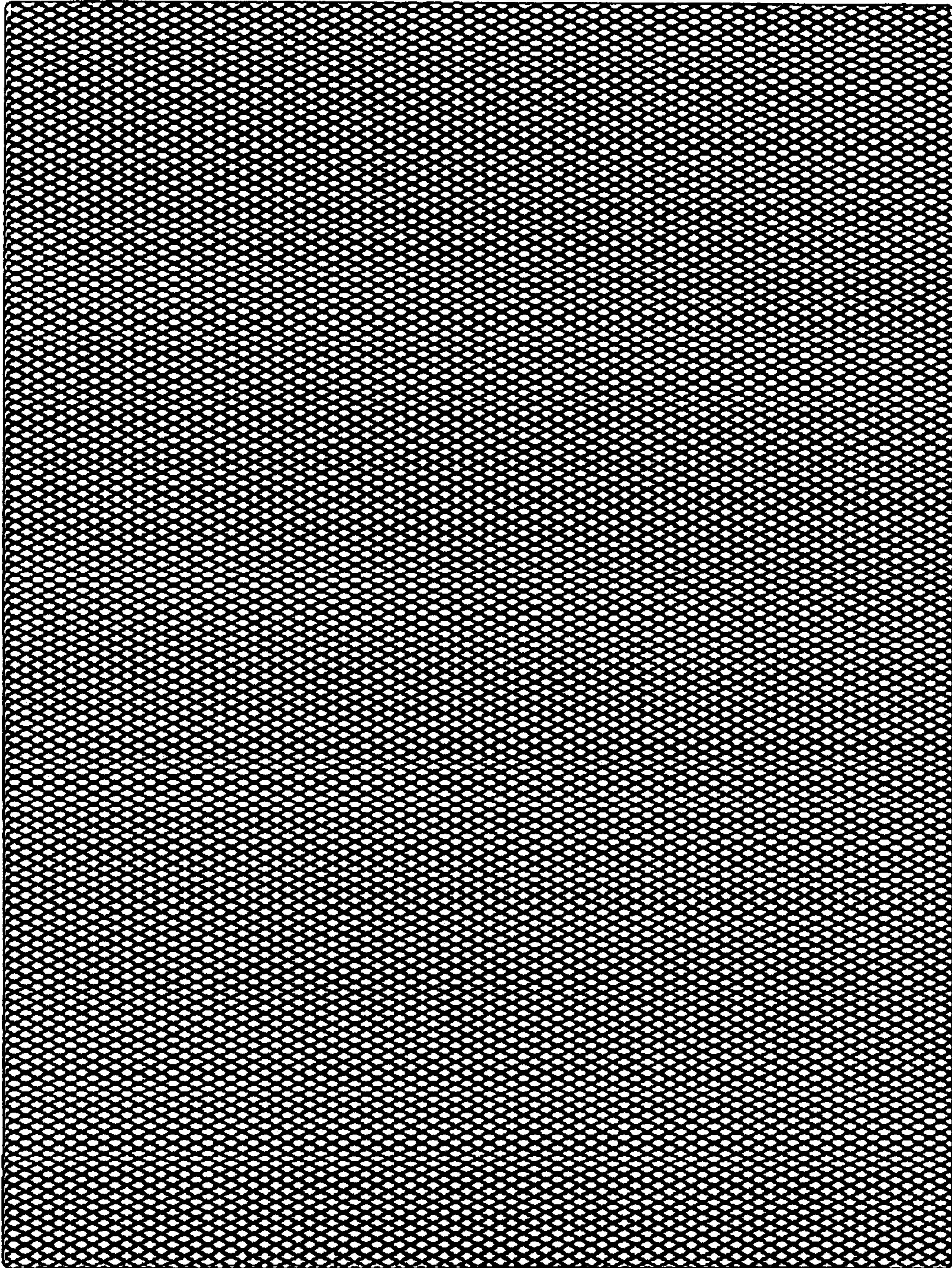

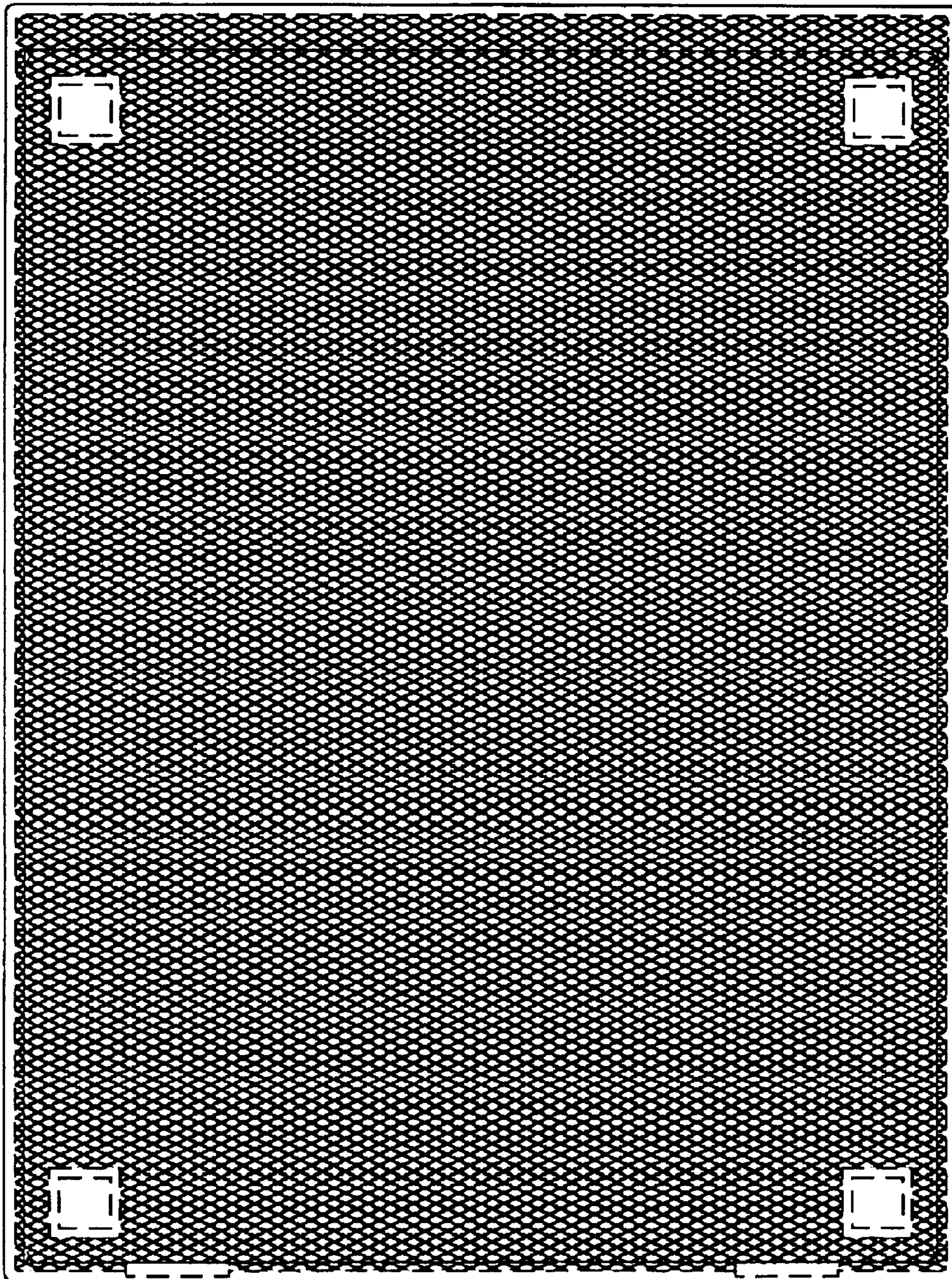

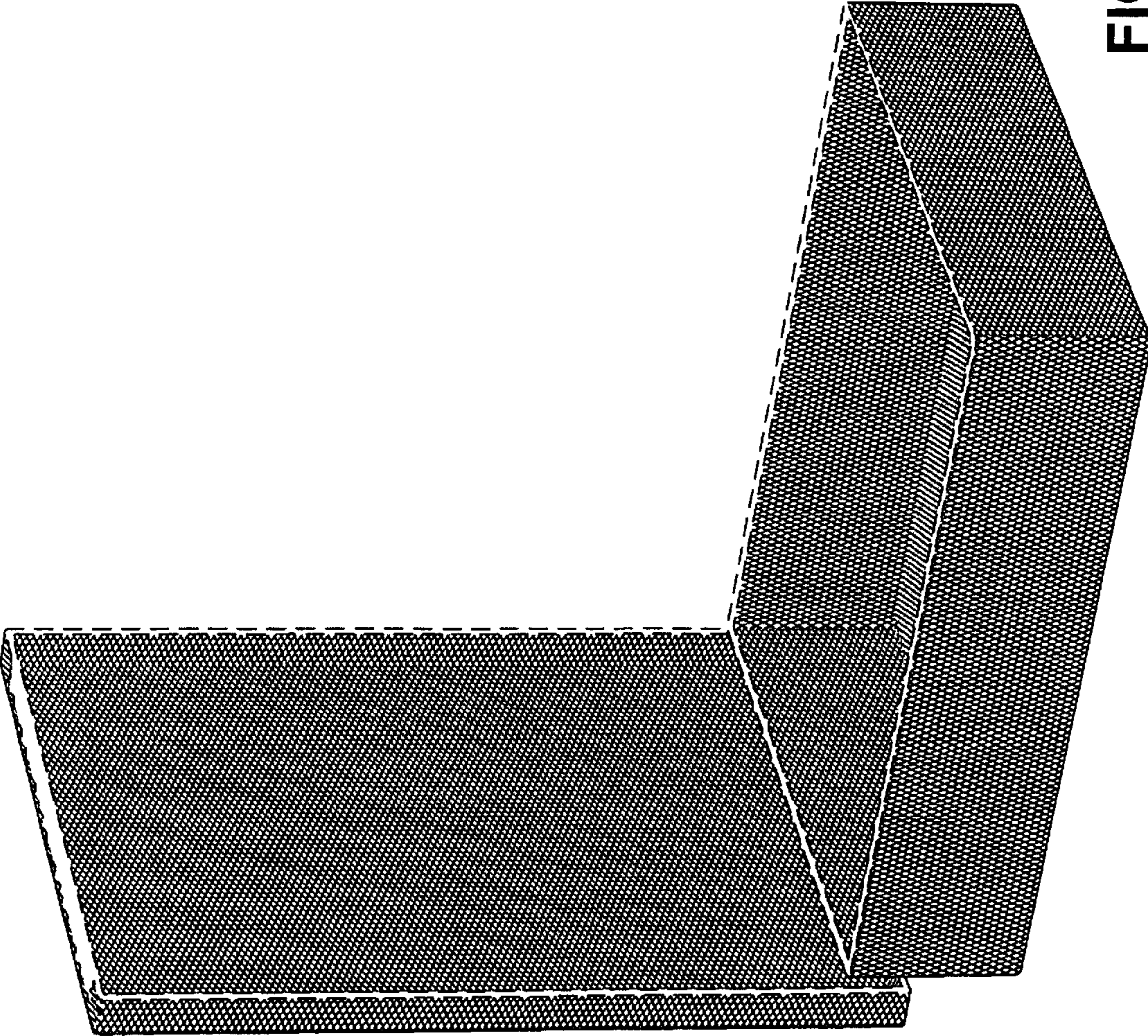

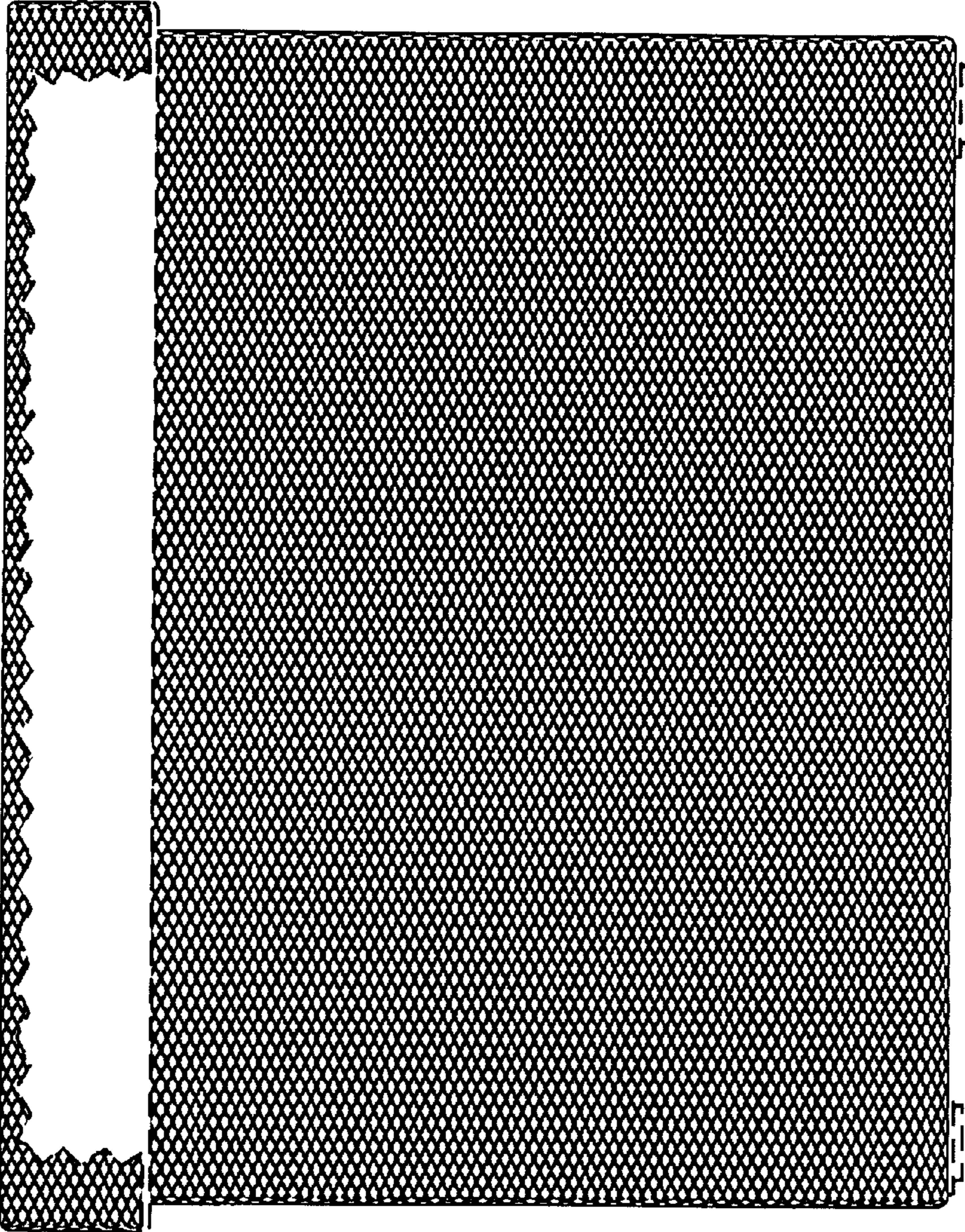

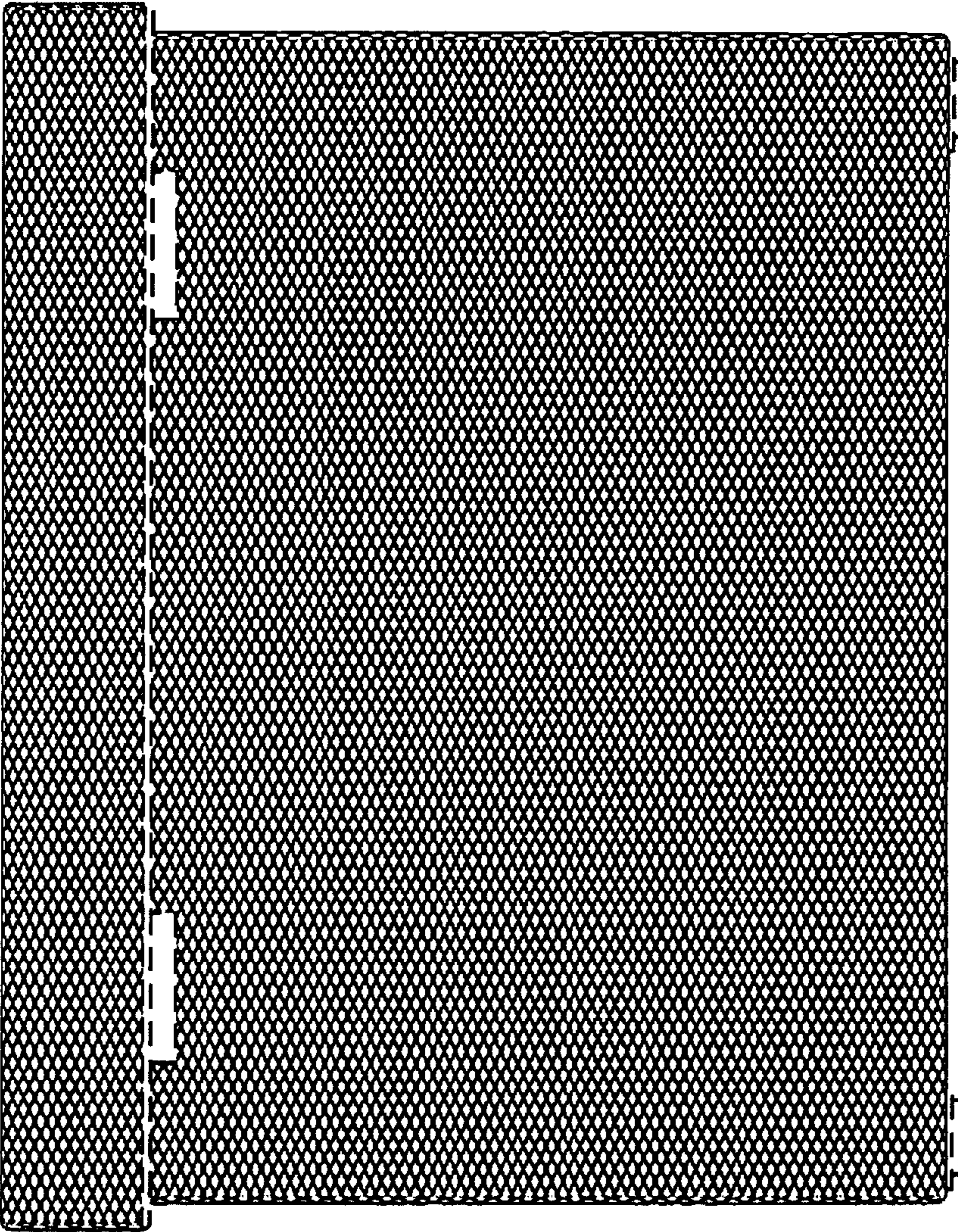

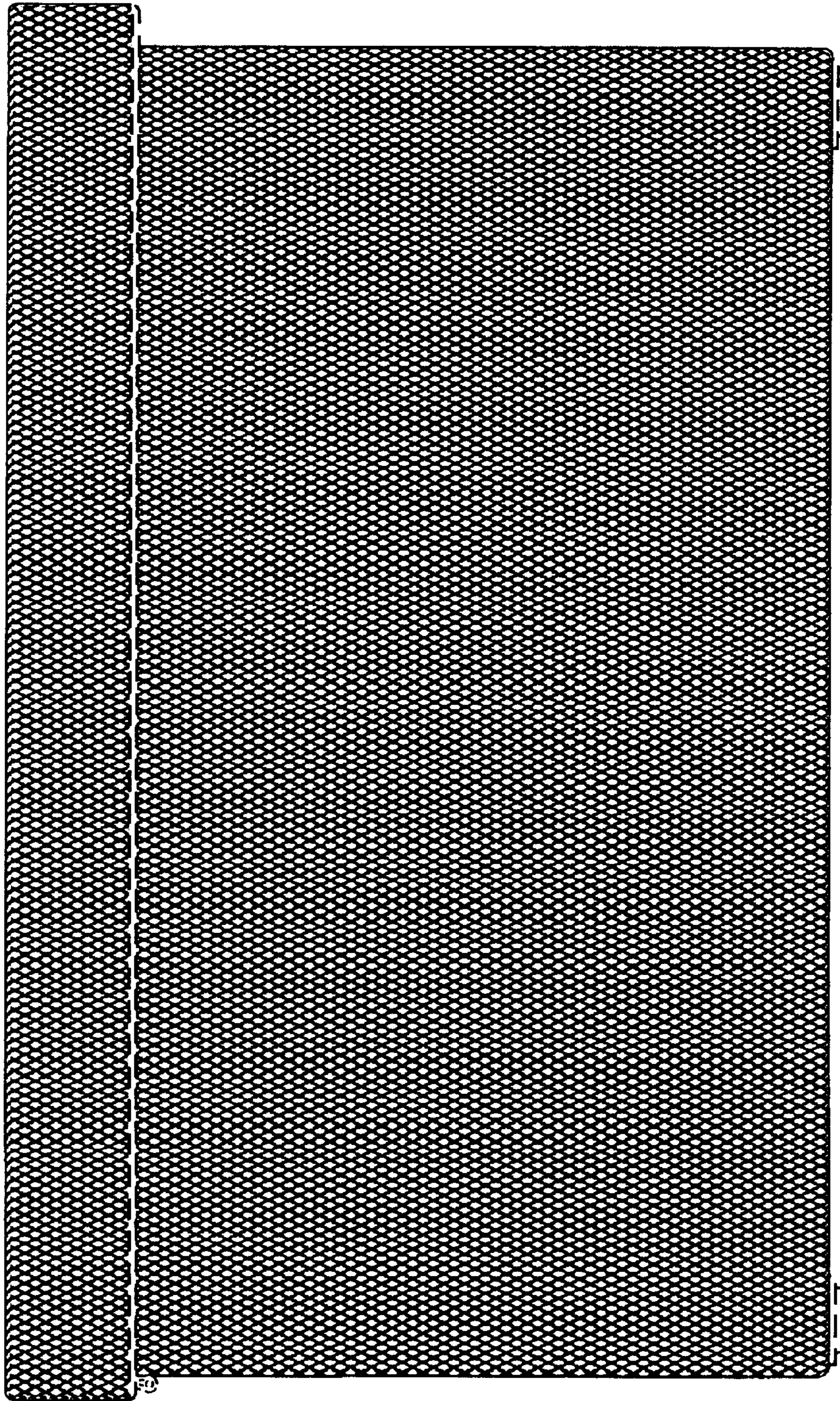

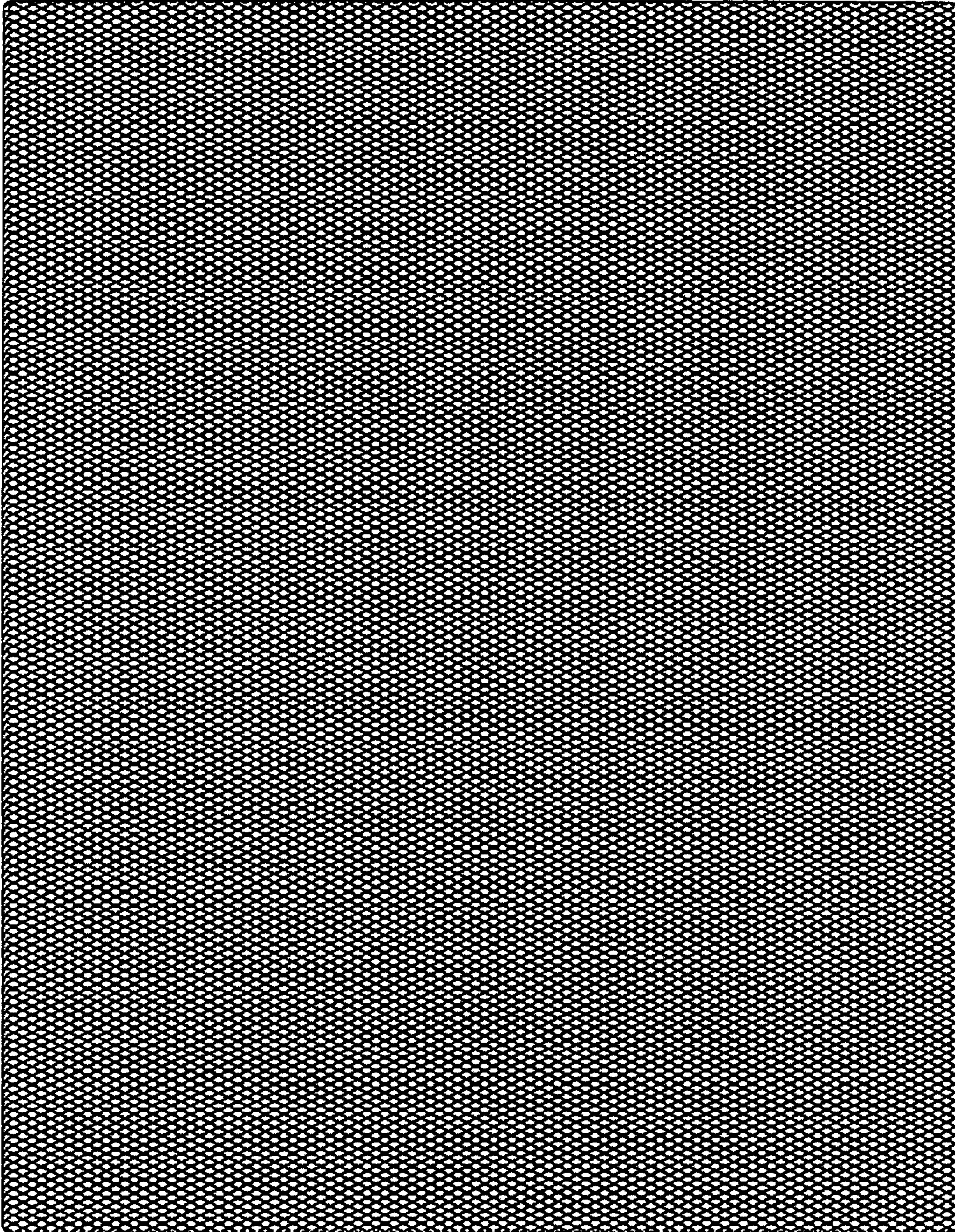

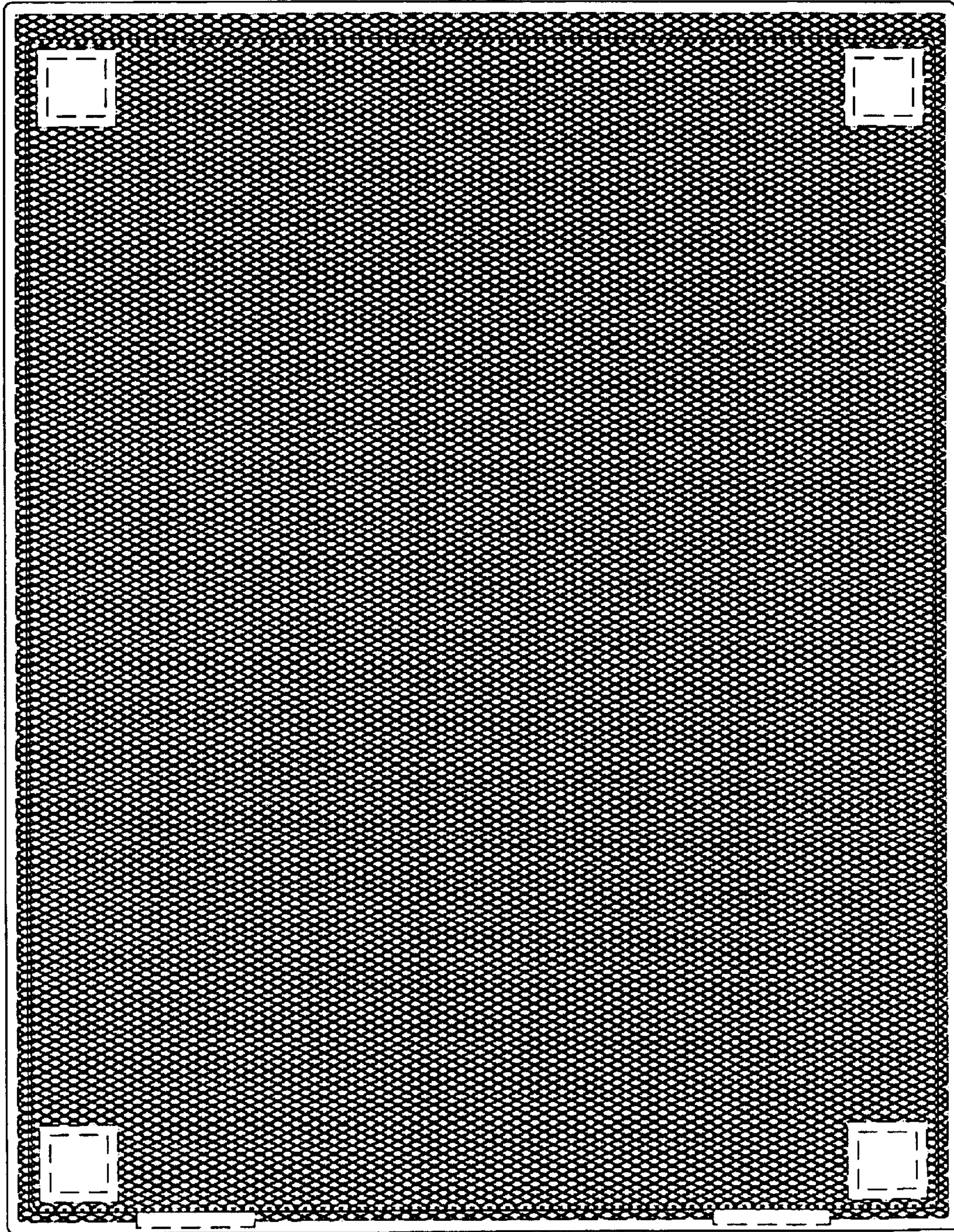

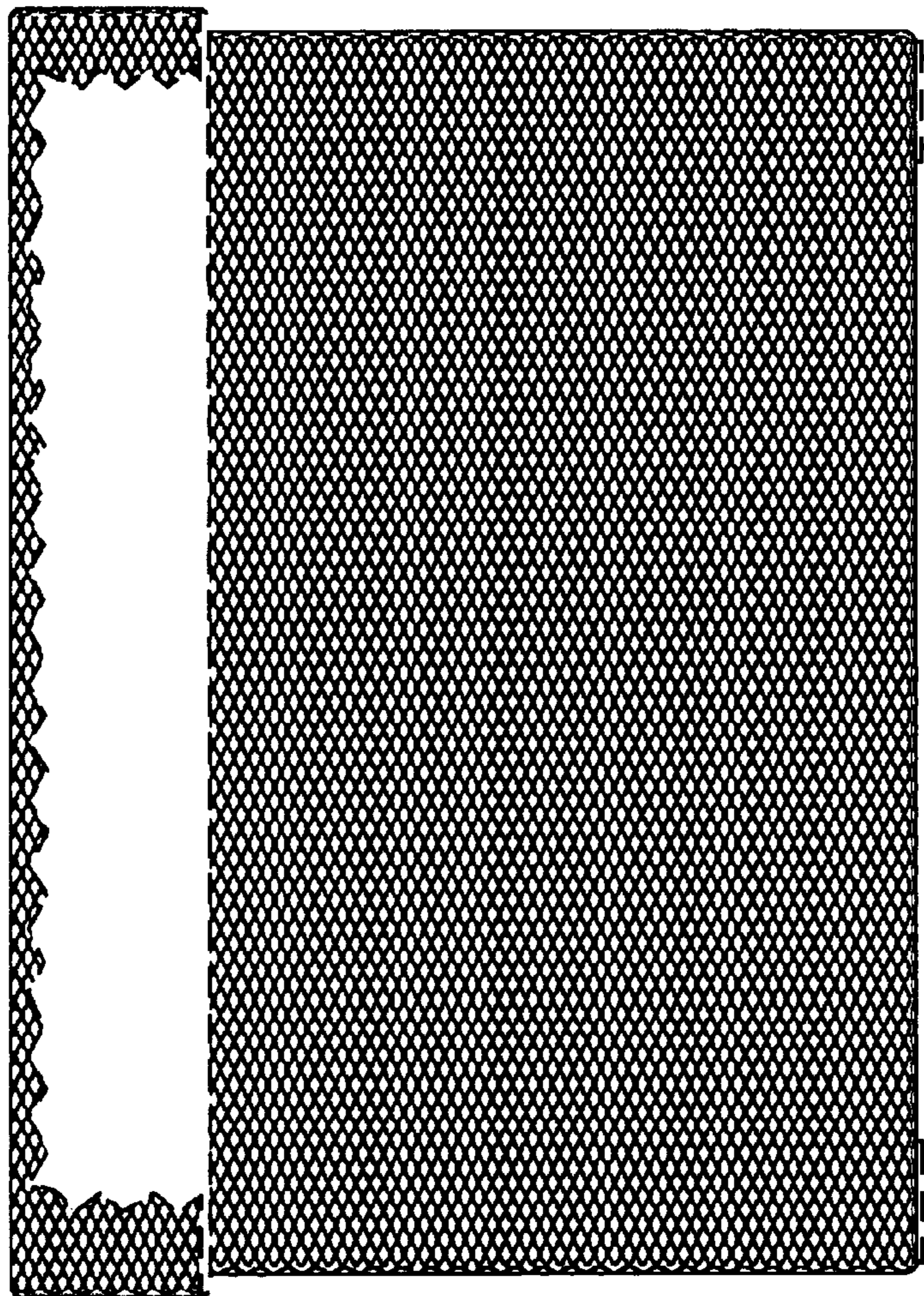

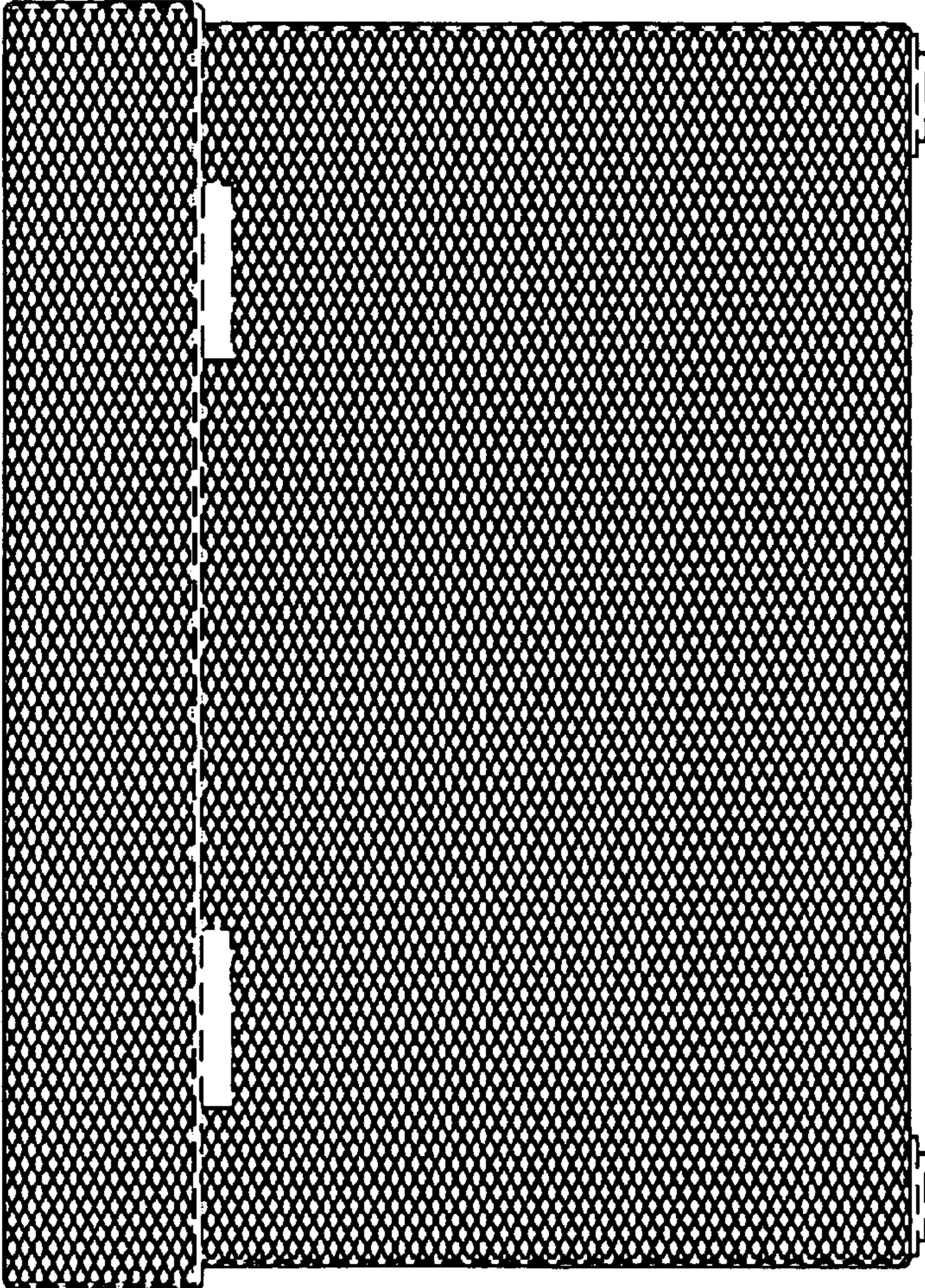

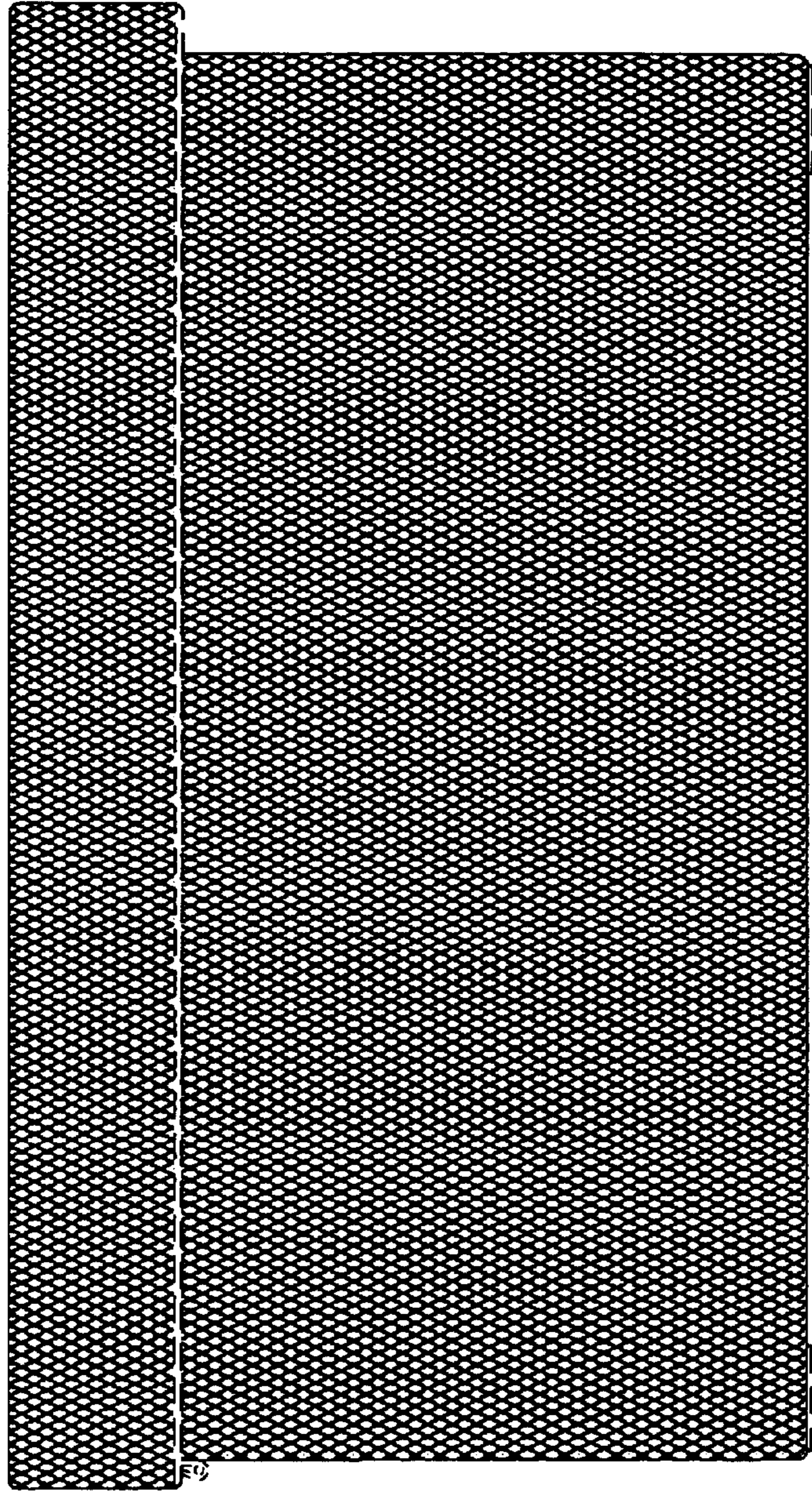

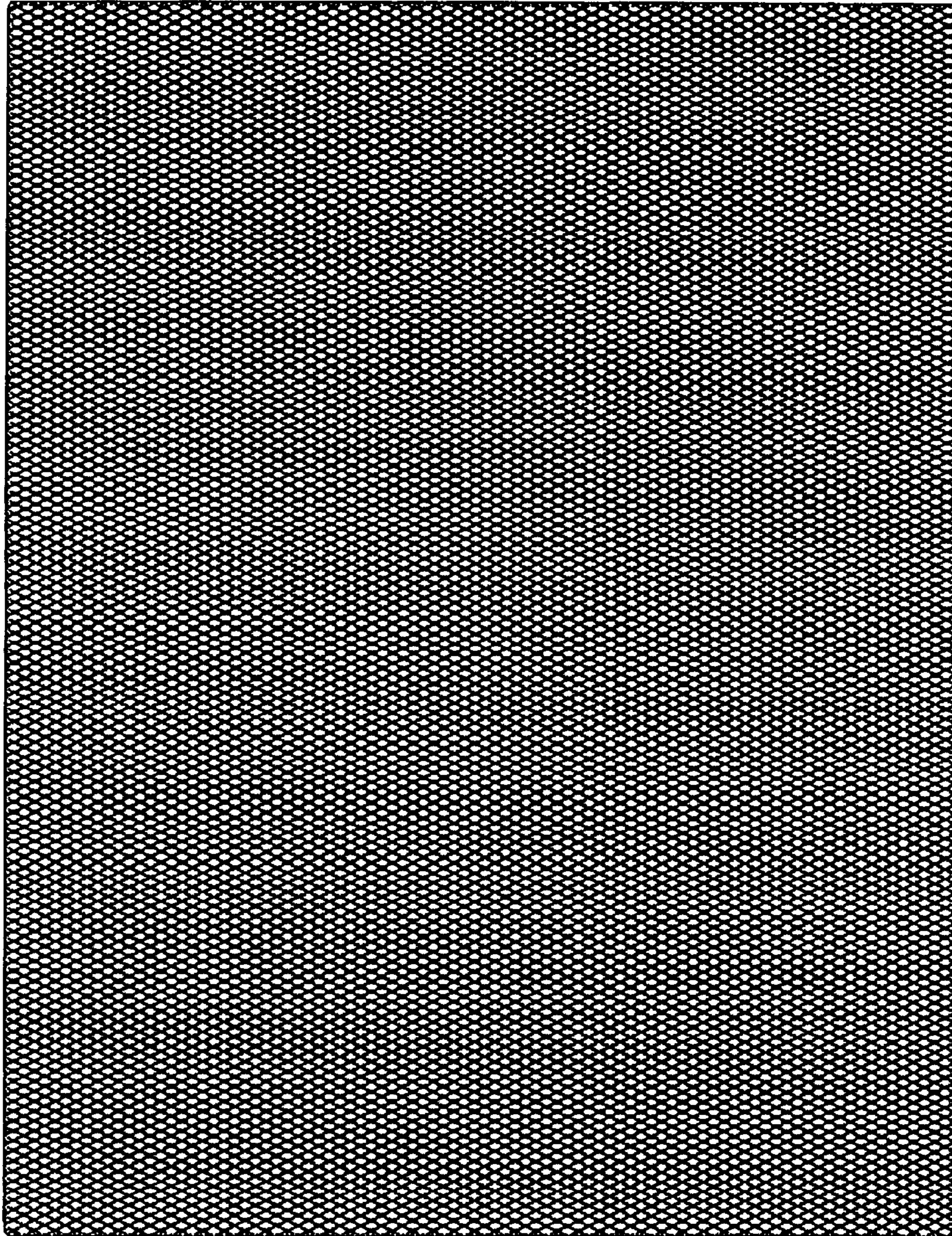

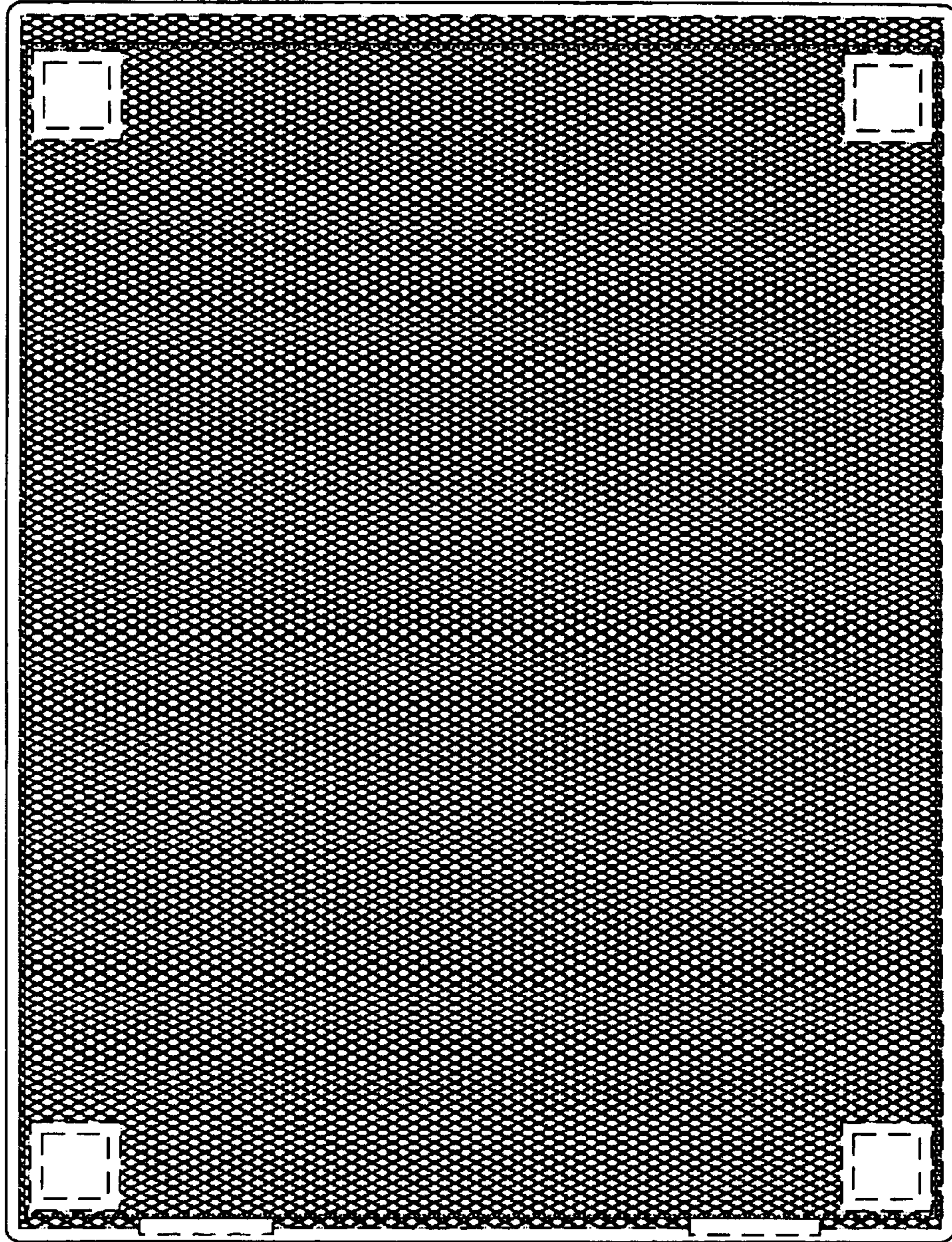

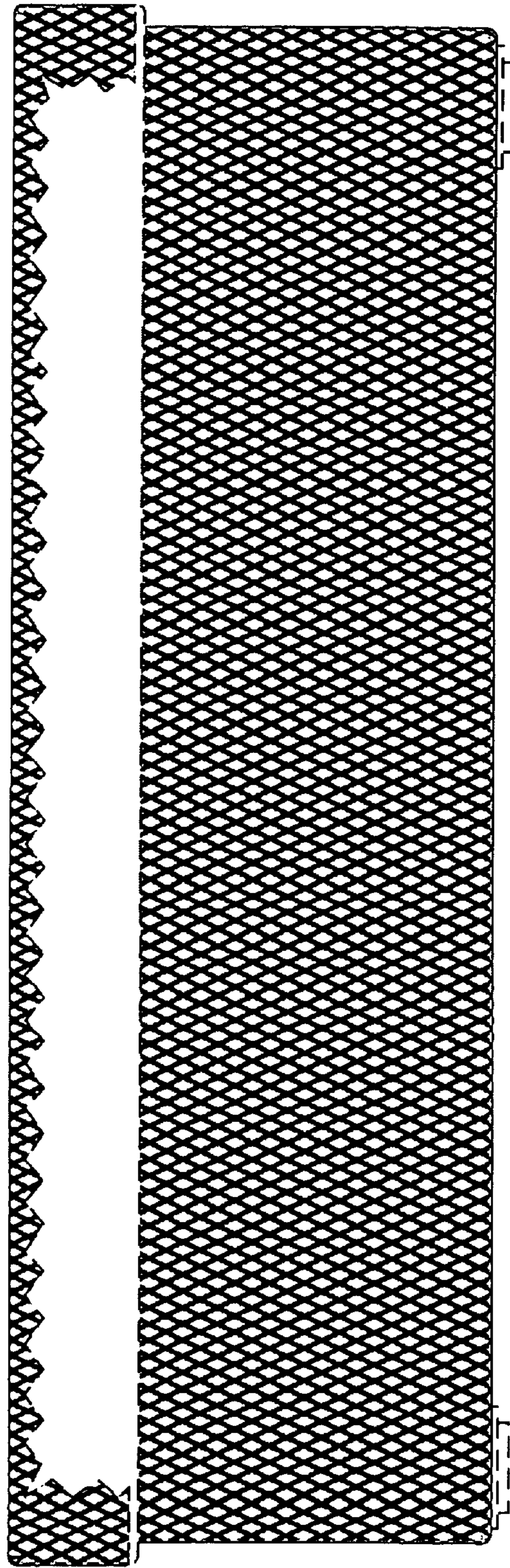

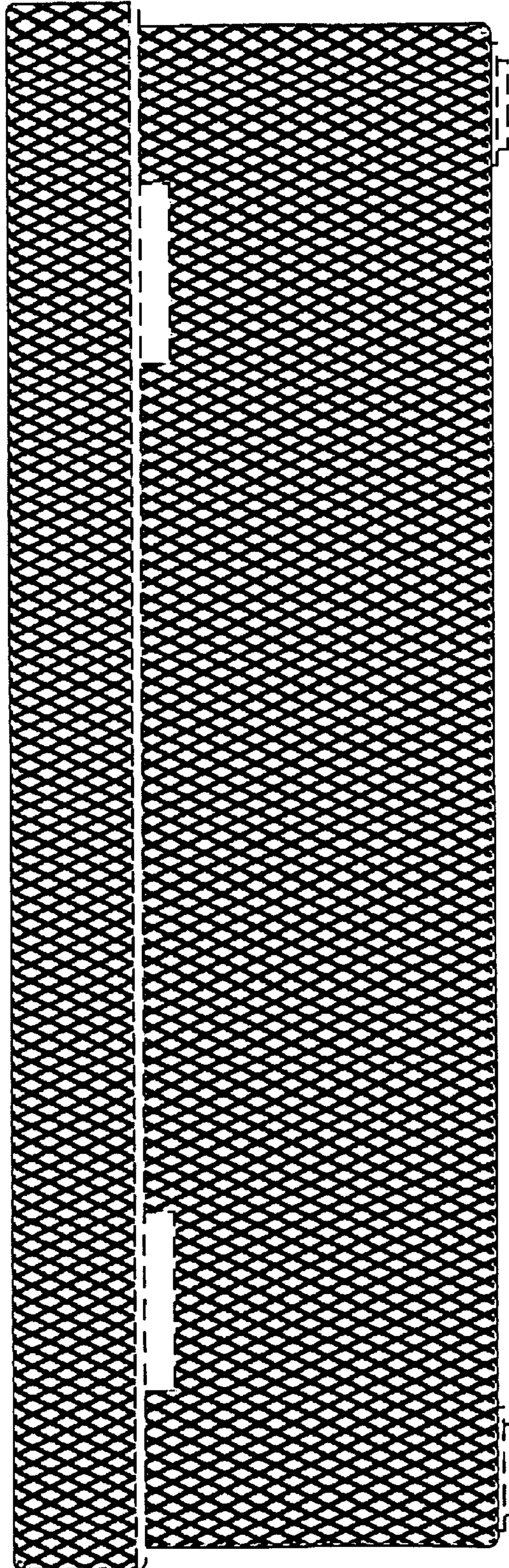

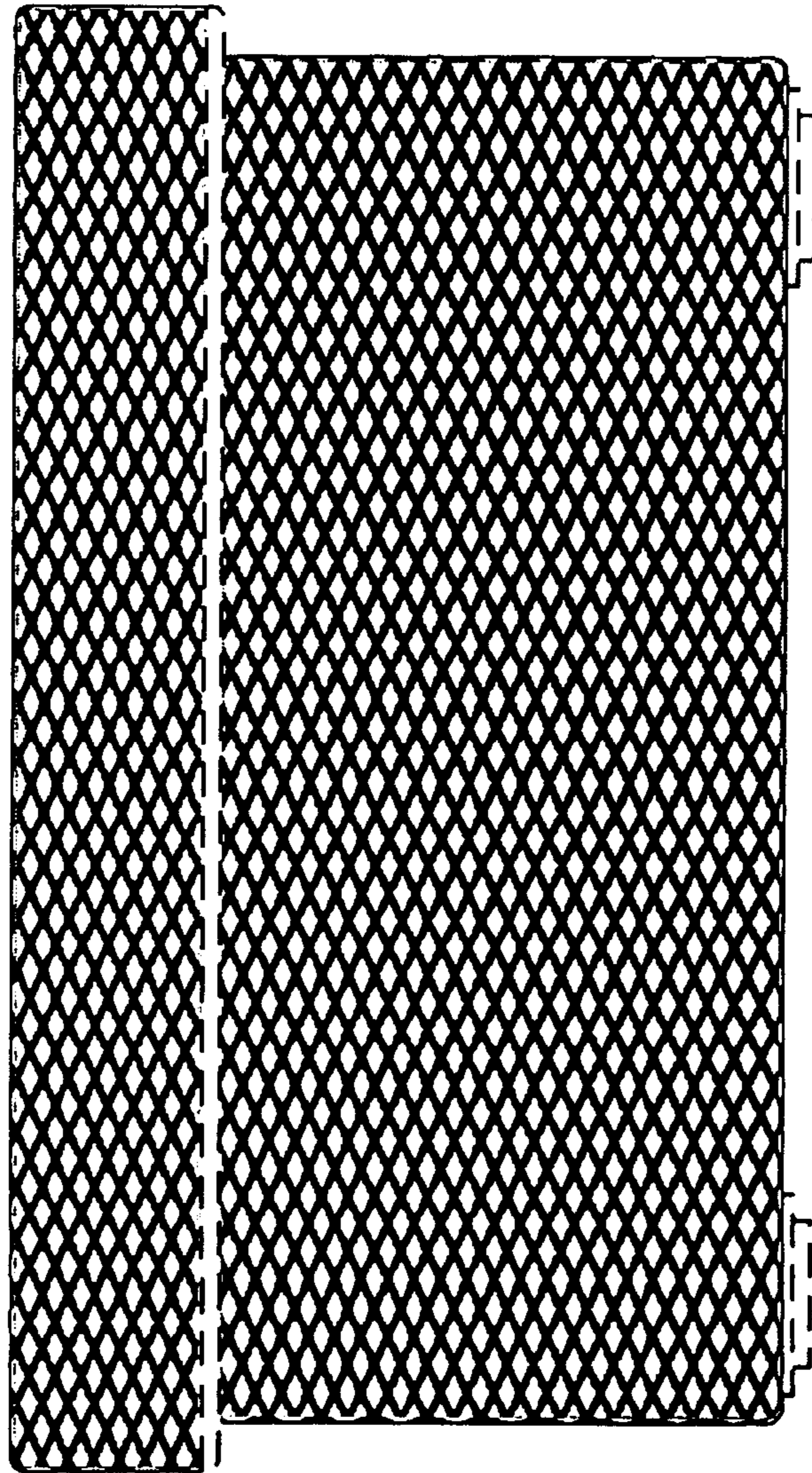

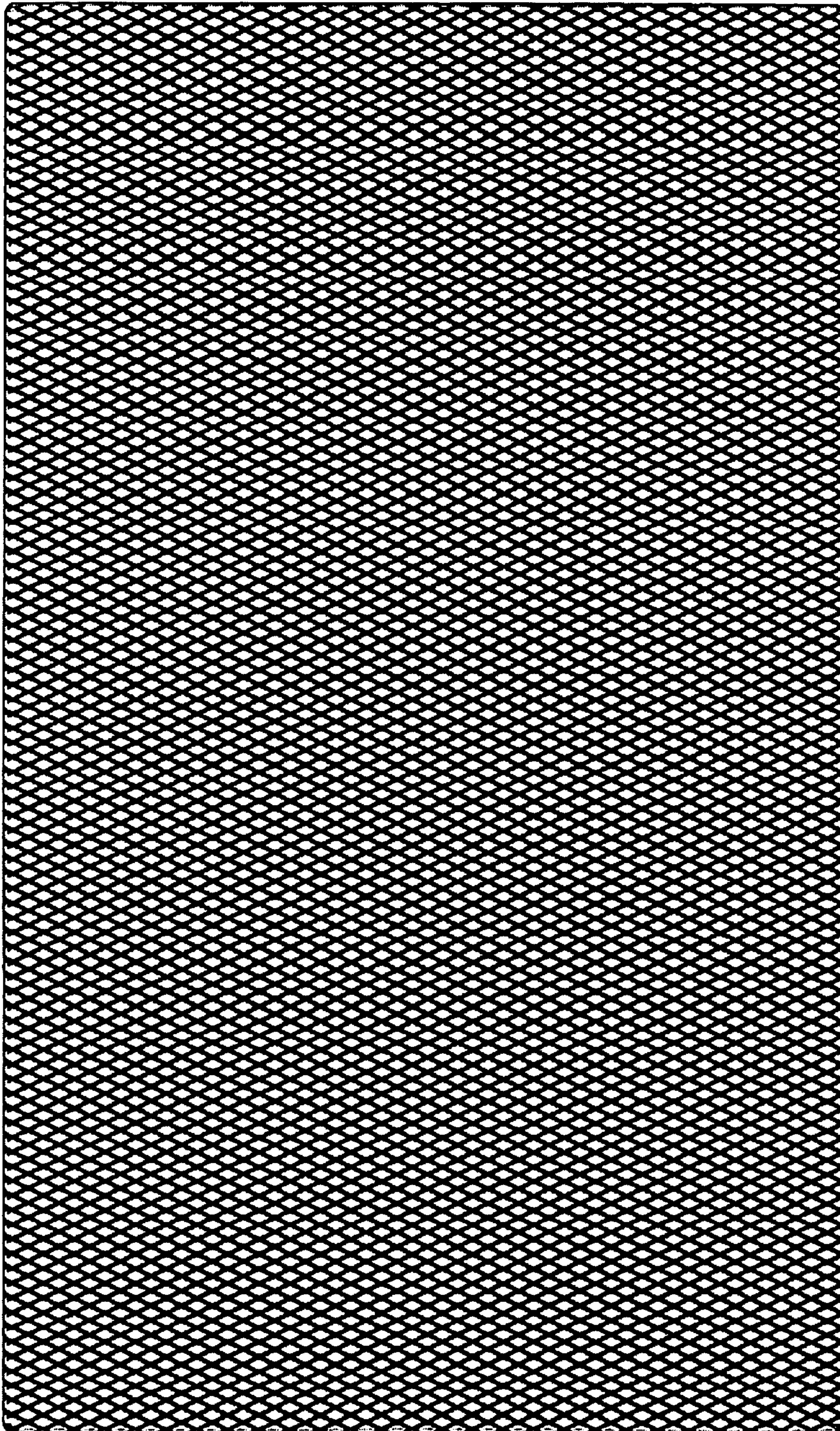

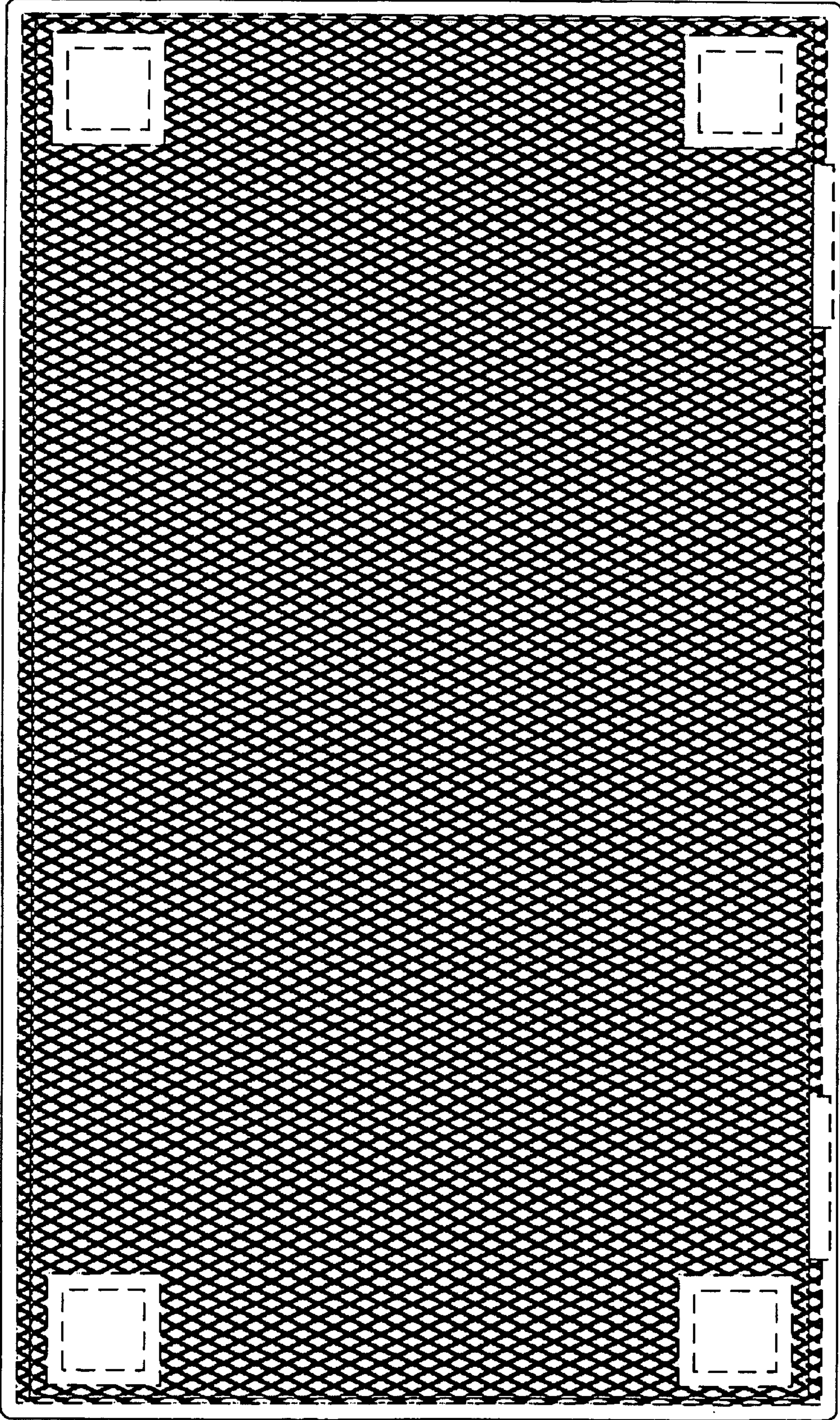

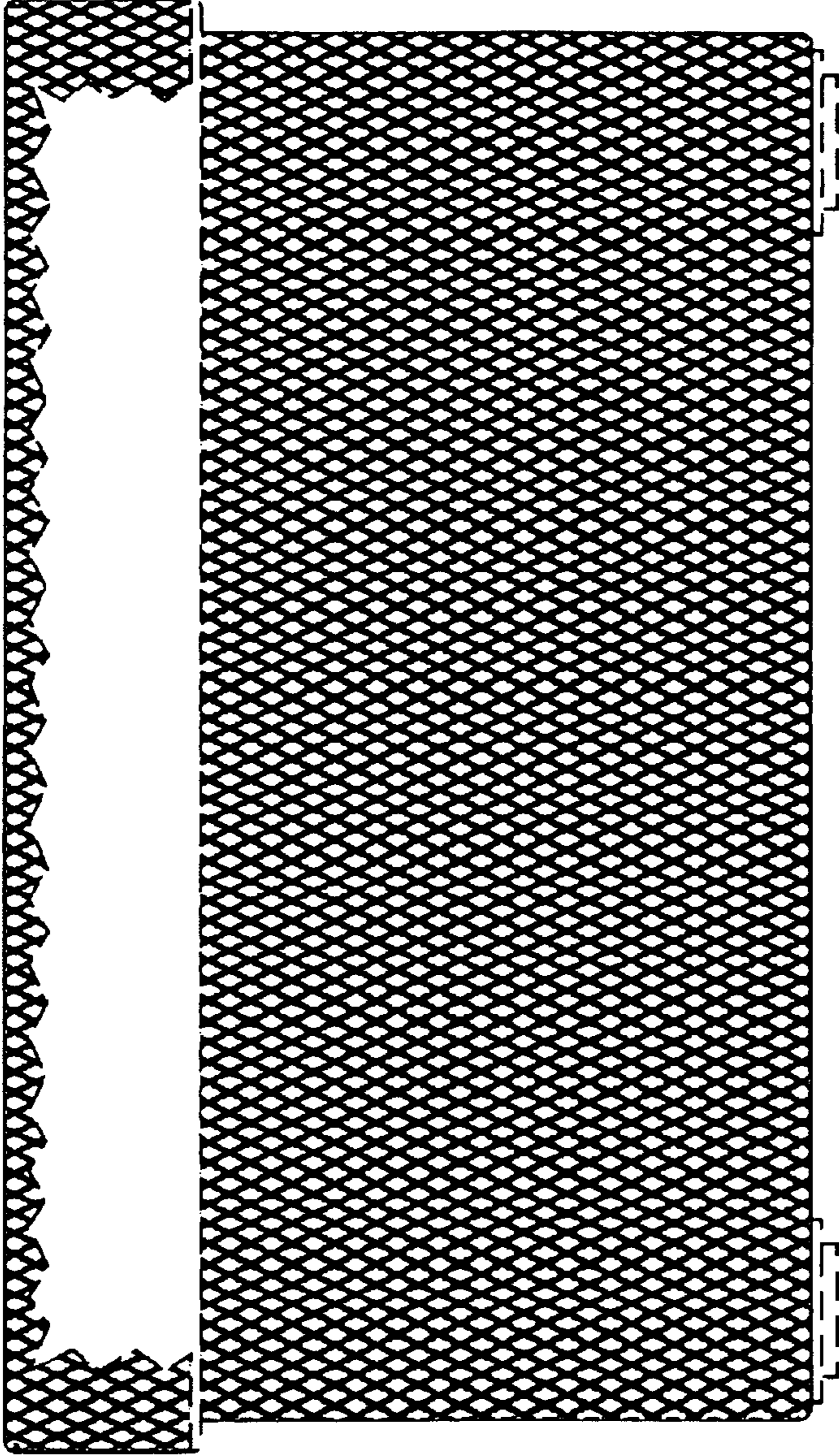

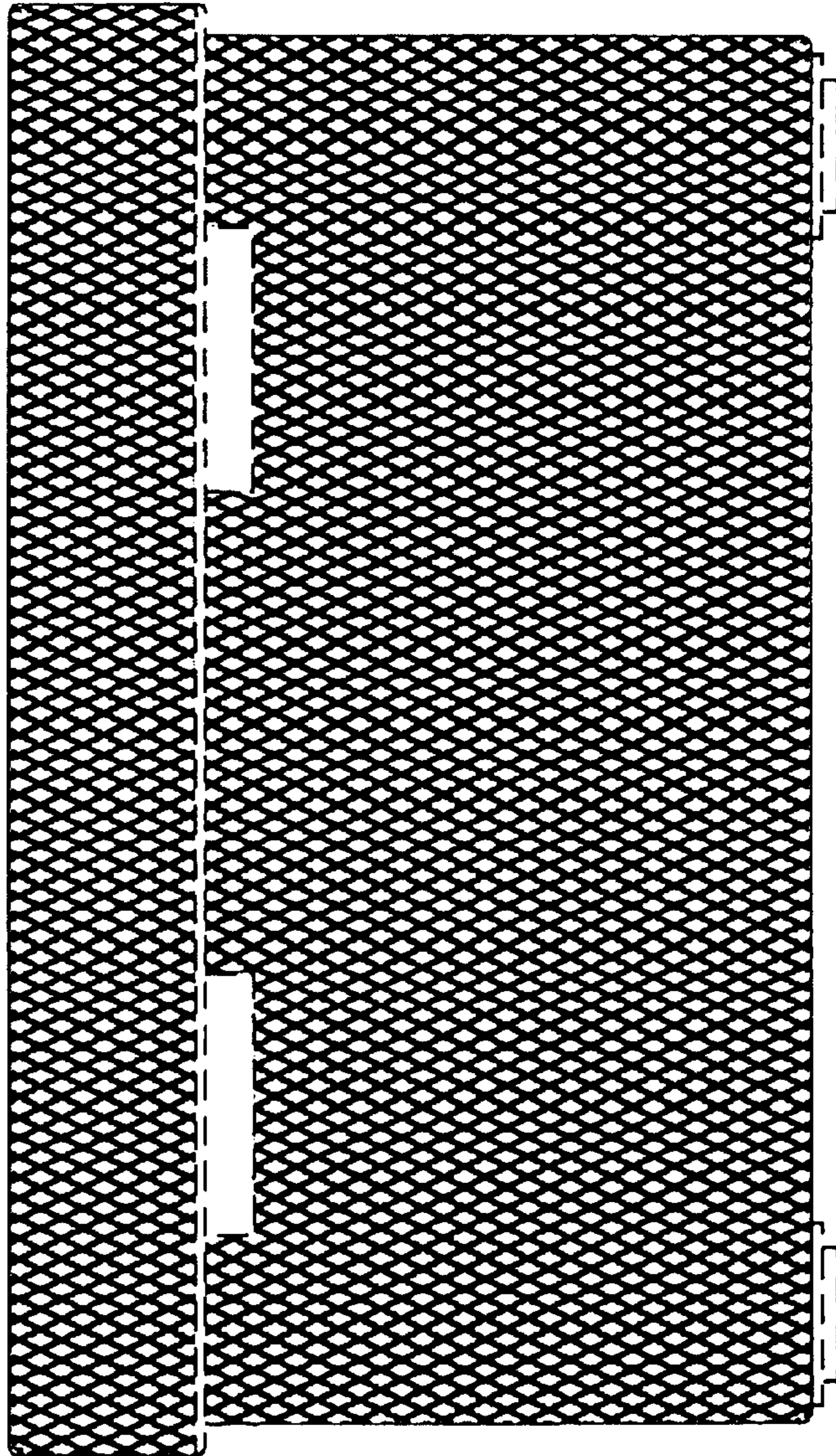

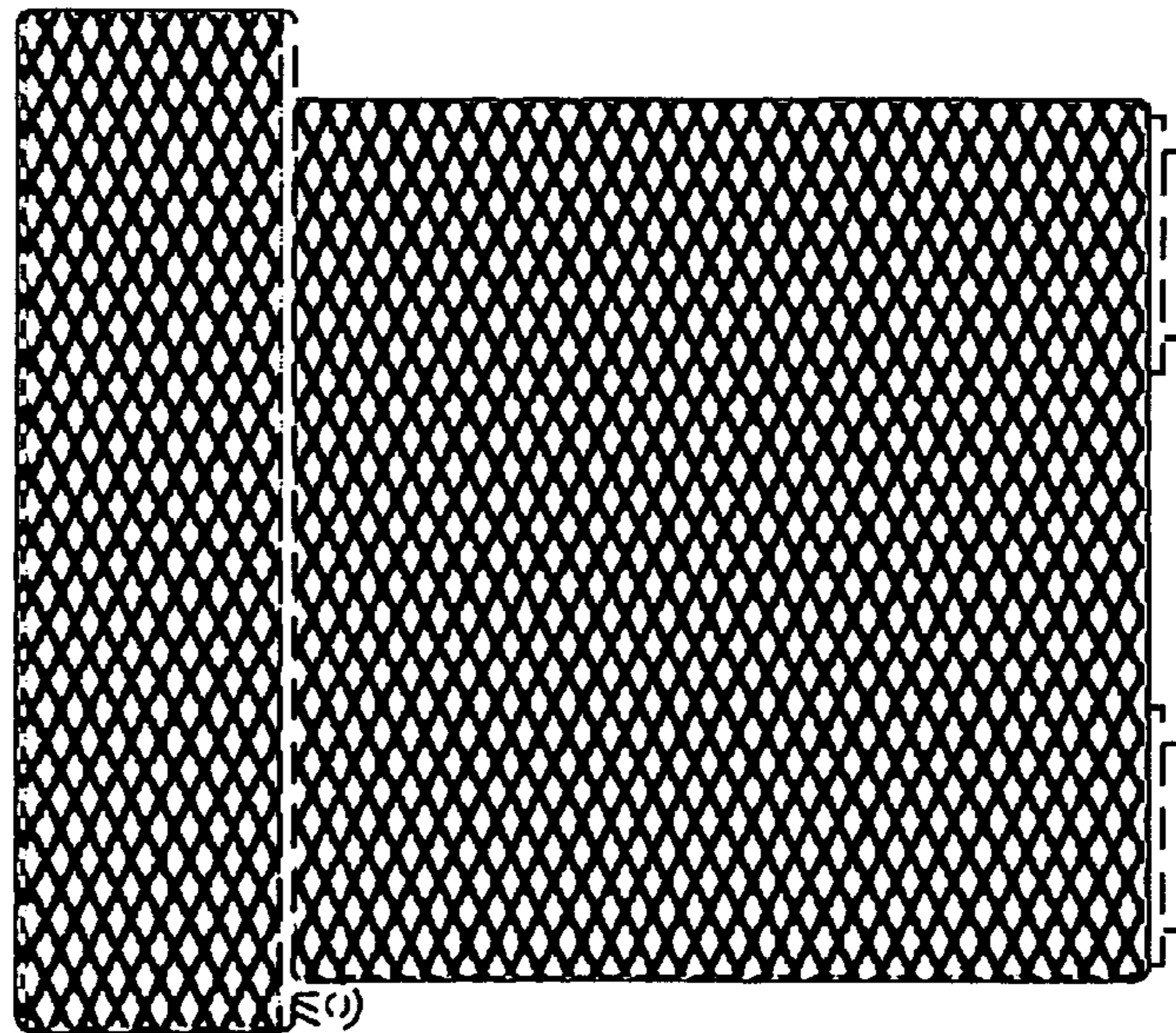

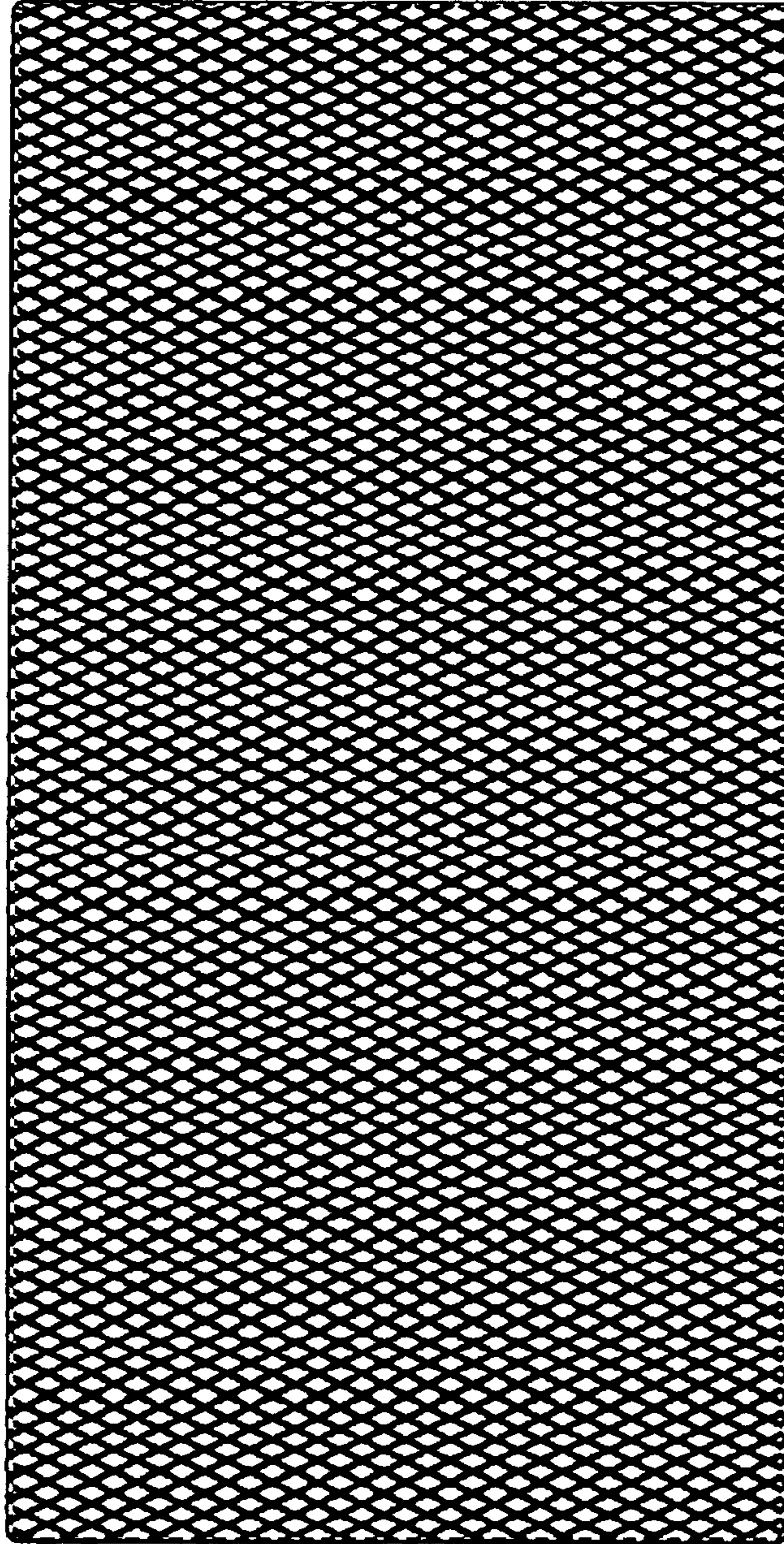

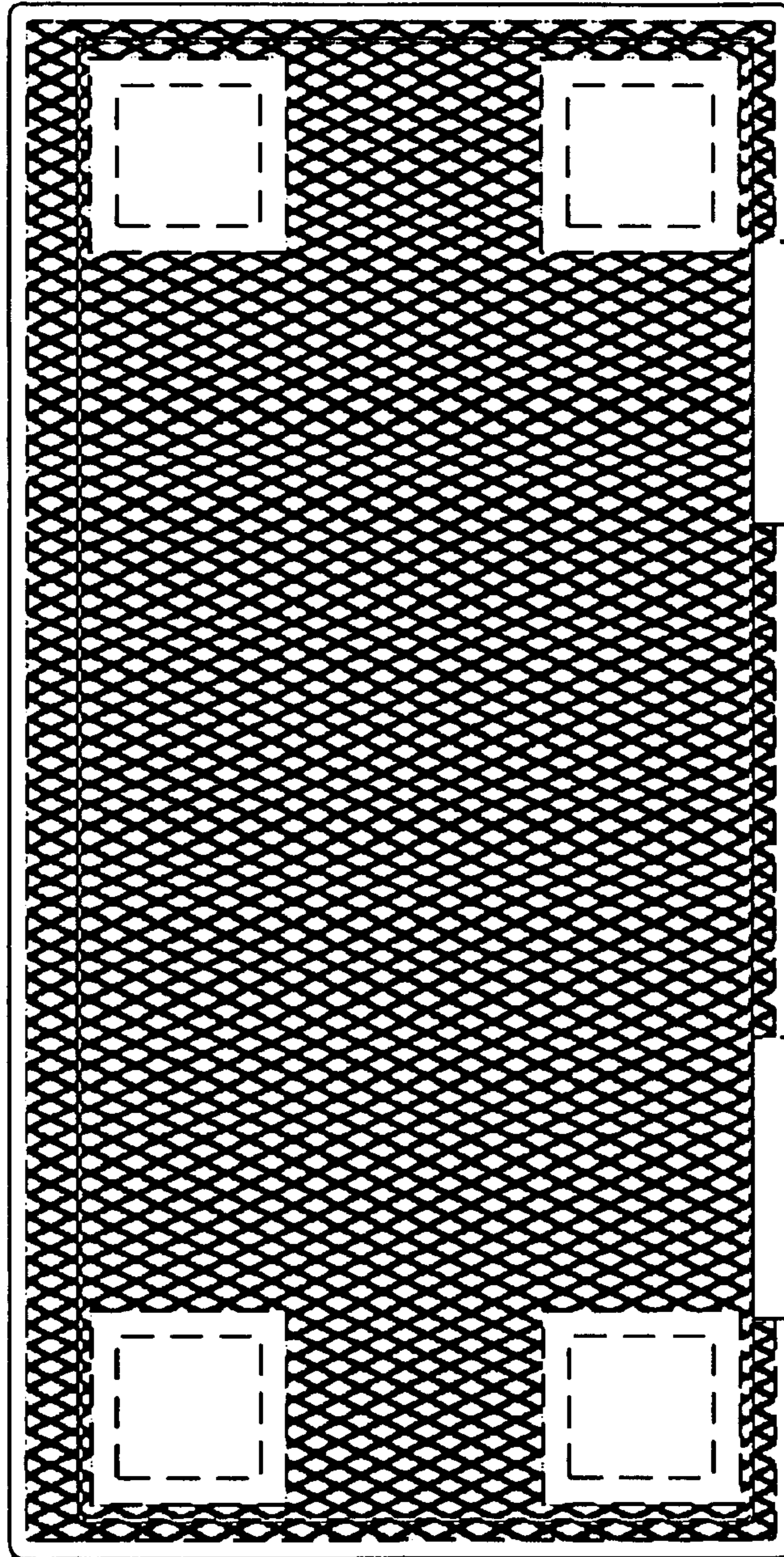
