FIG. 2 is a front view thereof, wherein the rear view is a mirror image thereof;

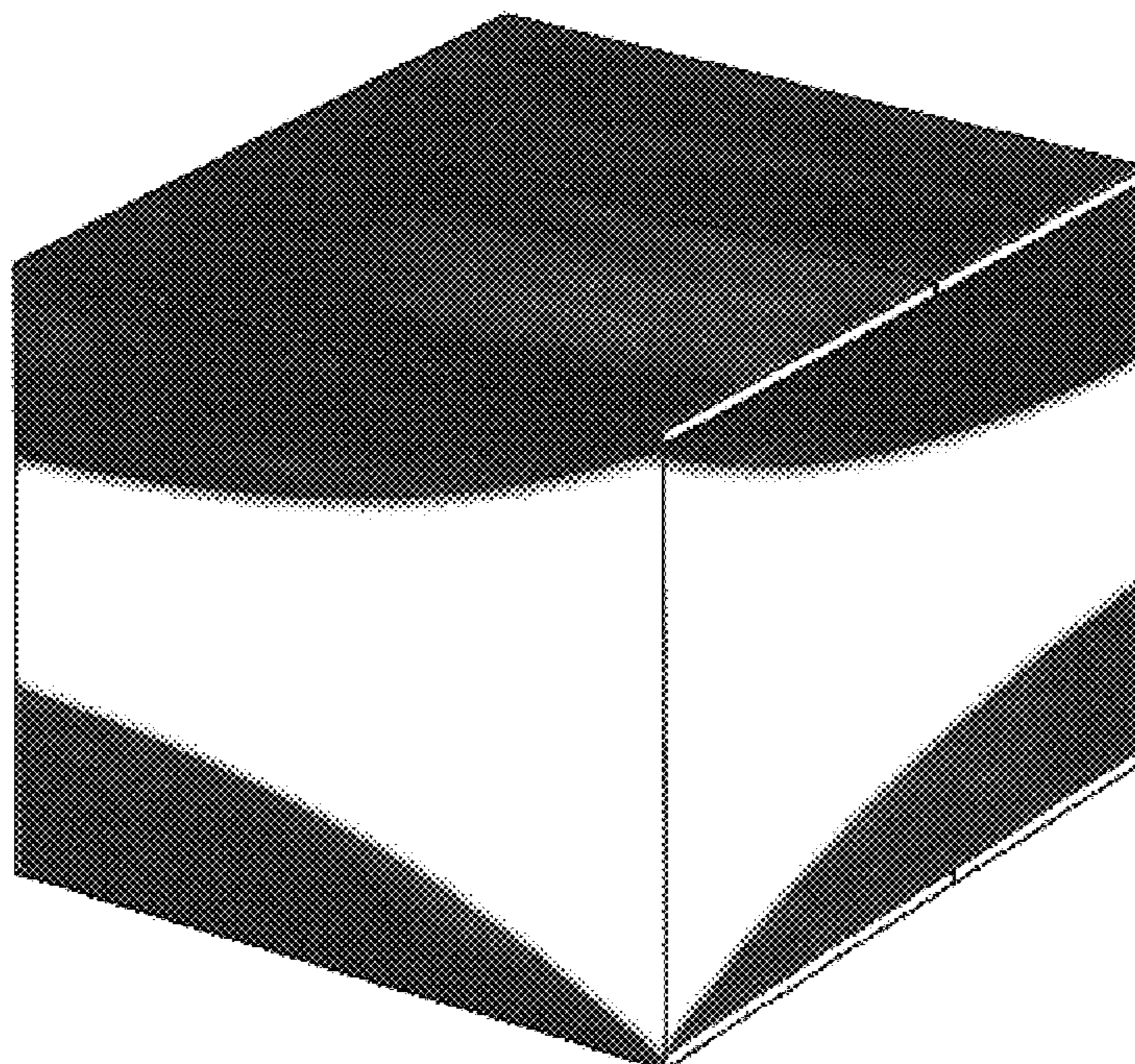
FIG. 3 is a right side view thereof, wherein the left side view is a mirror image thereof;

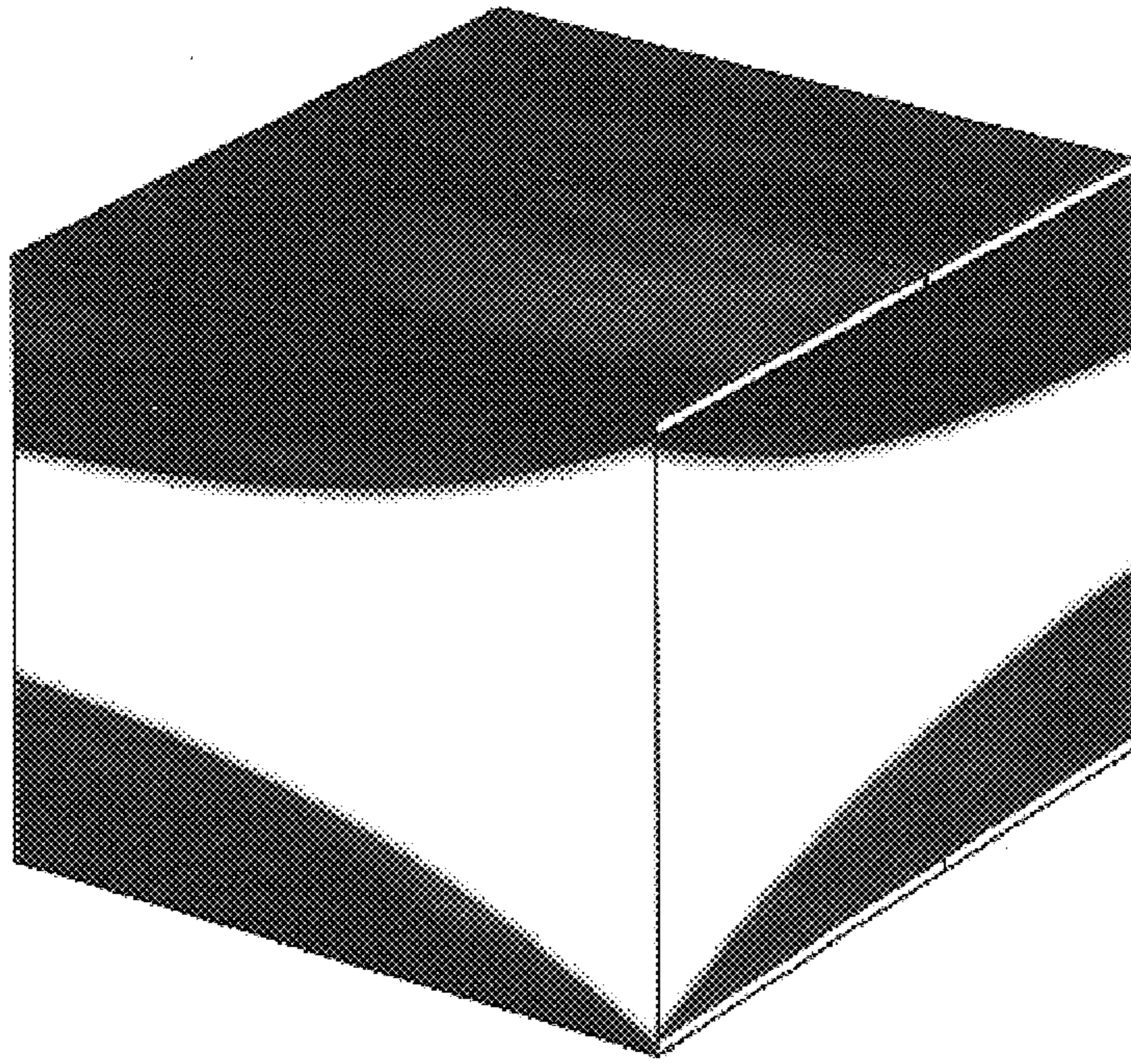

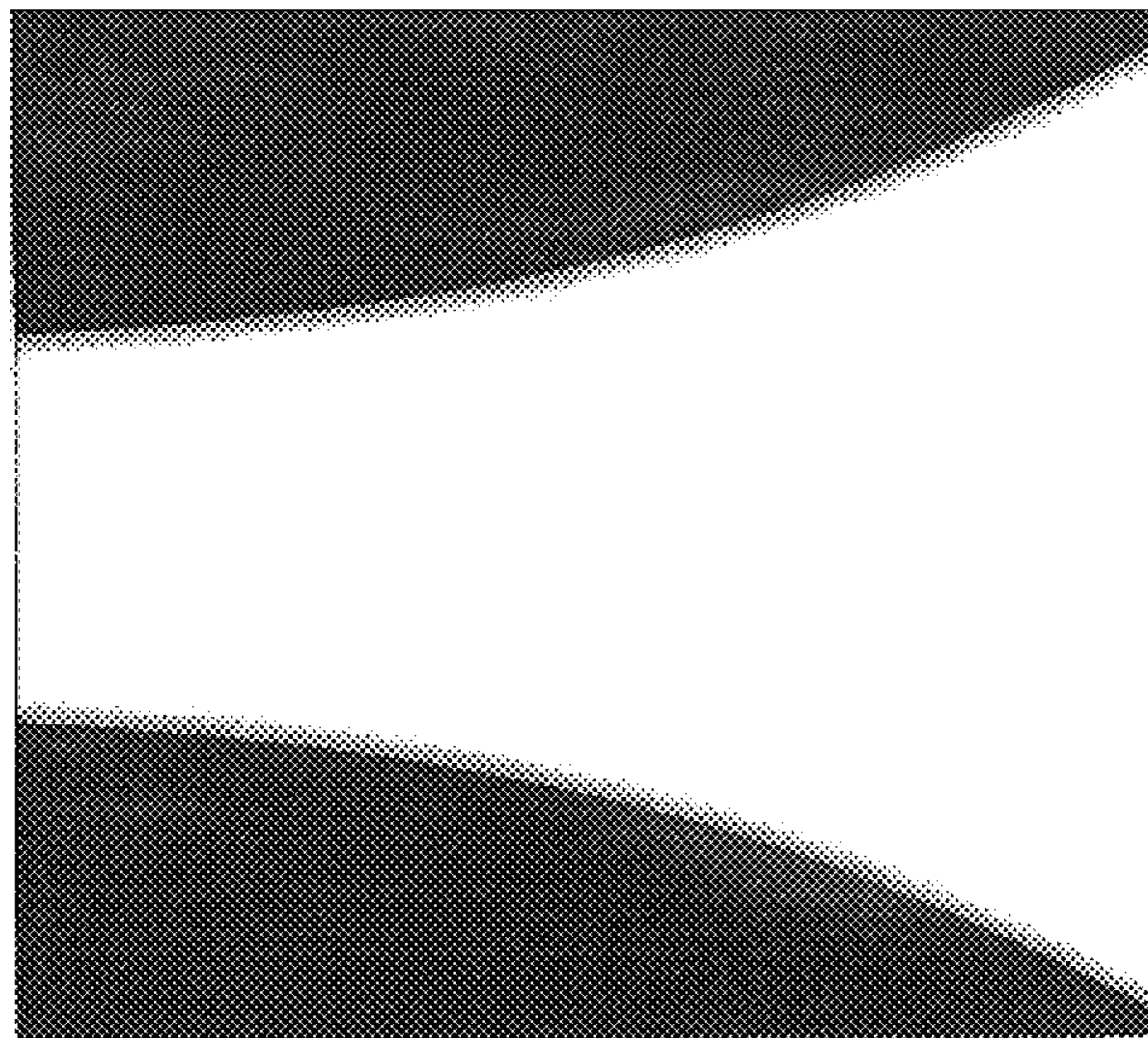

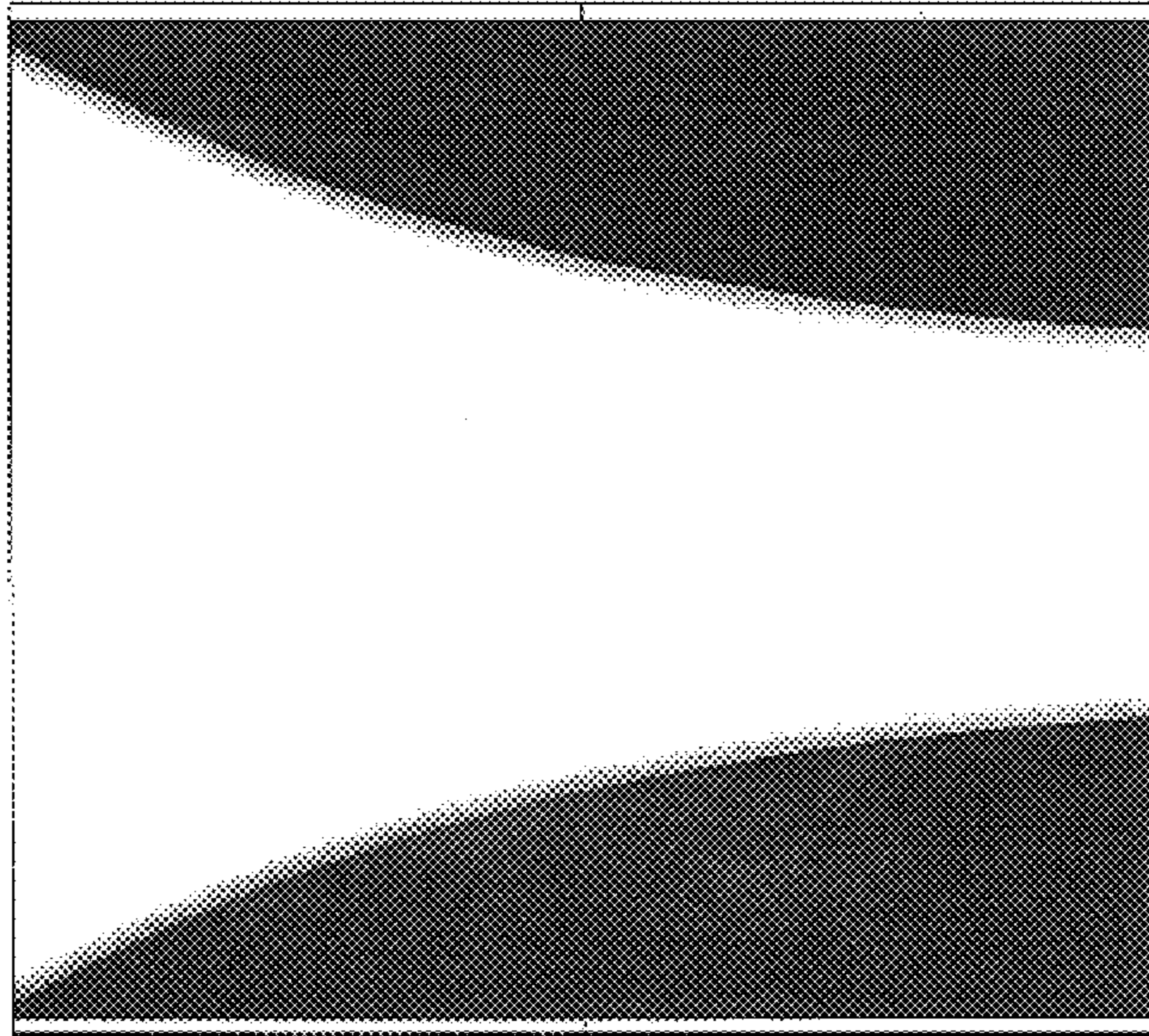

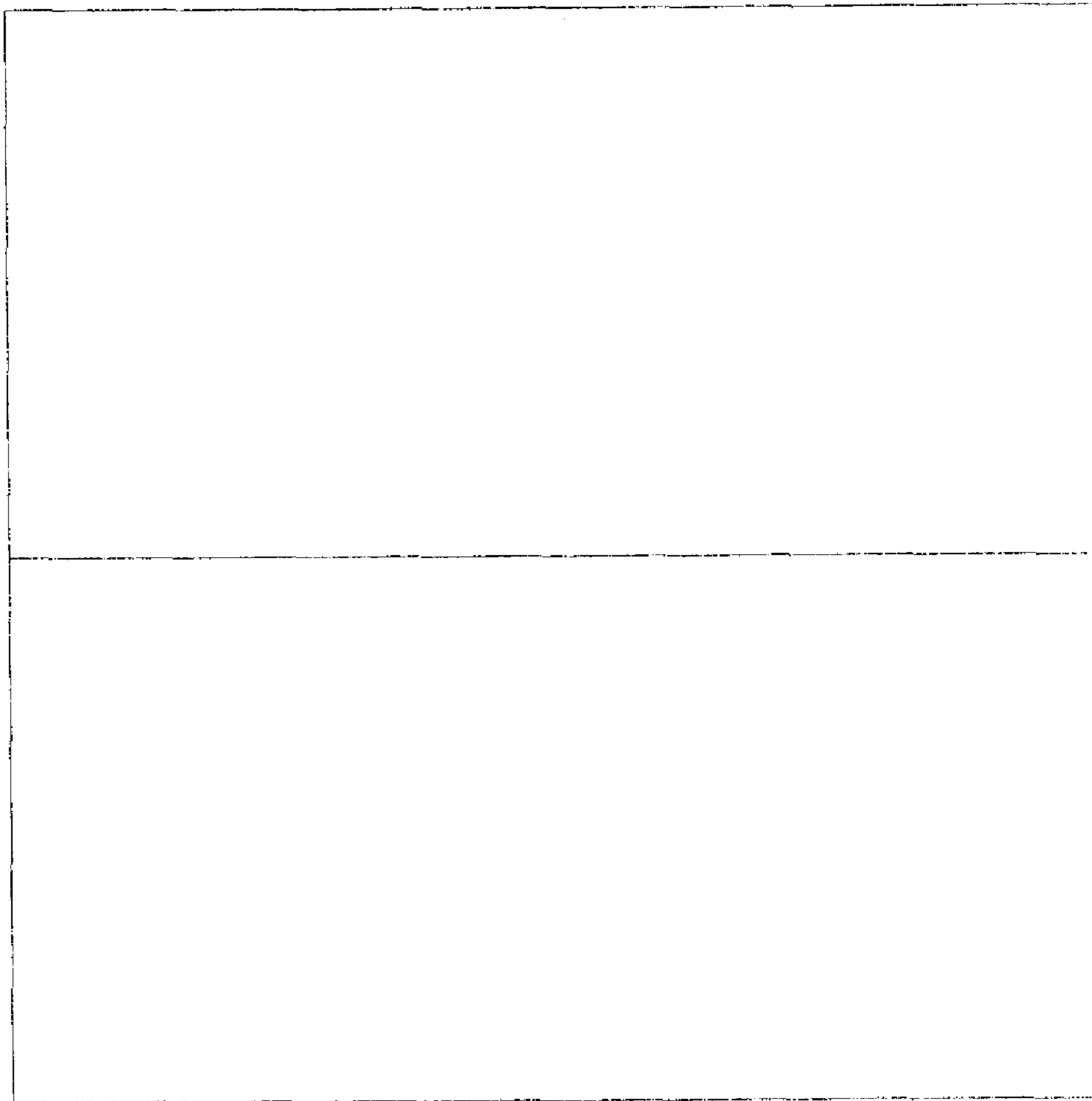
