(57) **CLAIM**

The ornamental design of a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage container in accordance with a first embodiment of our design;

FIG. 2 is a top plan view of the beverage container of FIG. 1;

FIG. 3 is a right side elevational view of the beverage container of FIG. 1;

FIG. 4 is a bottom plan view of the beverage container of FIG. 1;

FIG. 5 is a front elevational view of the beverage container of FIG. 1;

FIG. 6 is a rear elevational view of the beverage container of FIG. 1;

FIG. 7 is a left side elevational view of the beverage container of FIG. 1;

FIG. 8 is a perspective view of a beverage container in accordance with a second embodiment of our design;

FIG. 9 is a top plan view of the beverage container of FIG. 8;

FIG. 10 is a right side elevational view of the beverage container of FIG. 8;

FIG. 11 is a bottom plan view of the beverage container of FIG. 8;

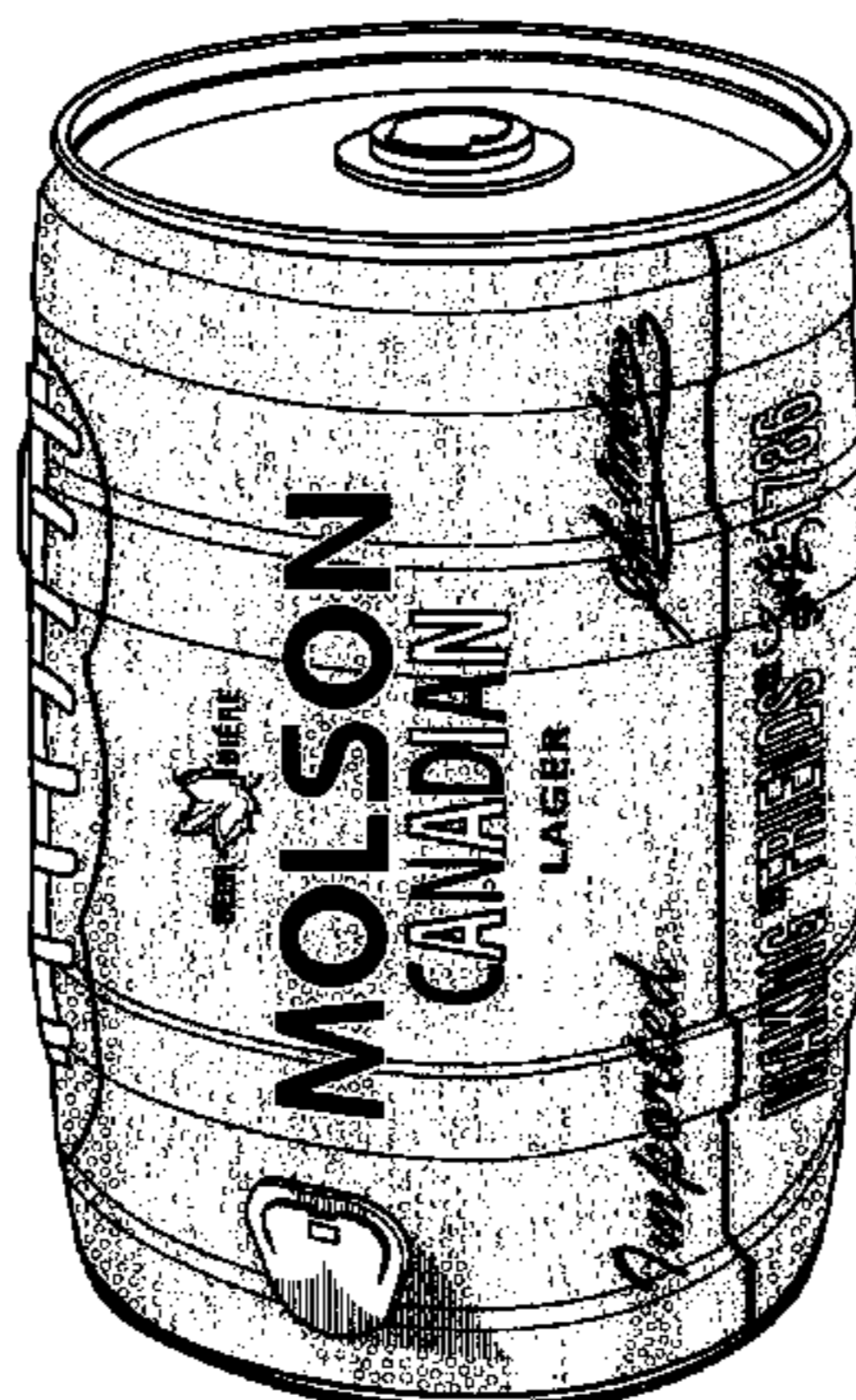
FIG. 12 is a front elevational view of the beverage container of FIG. 8;

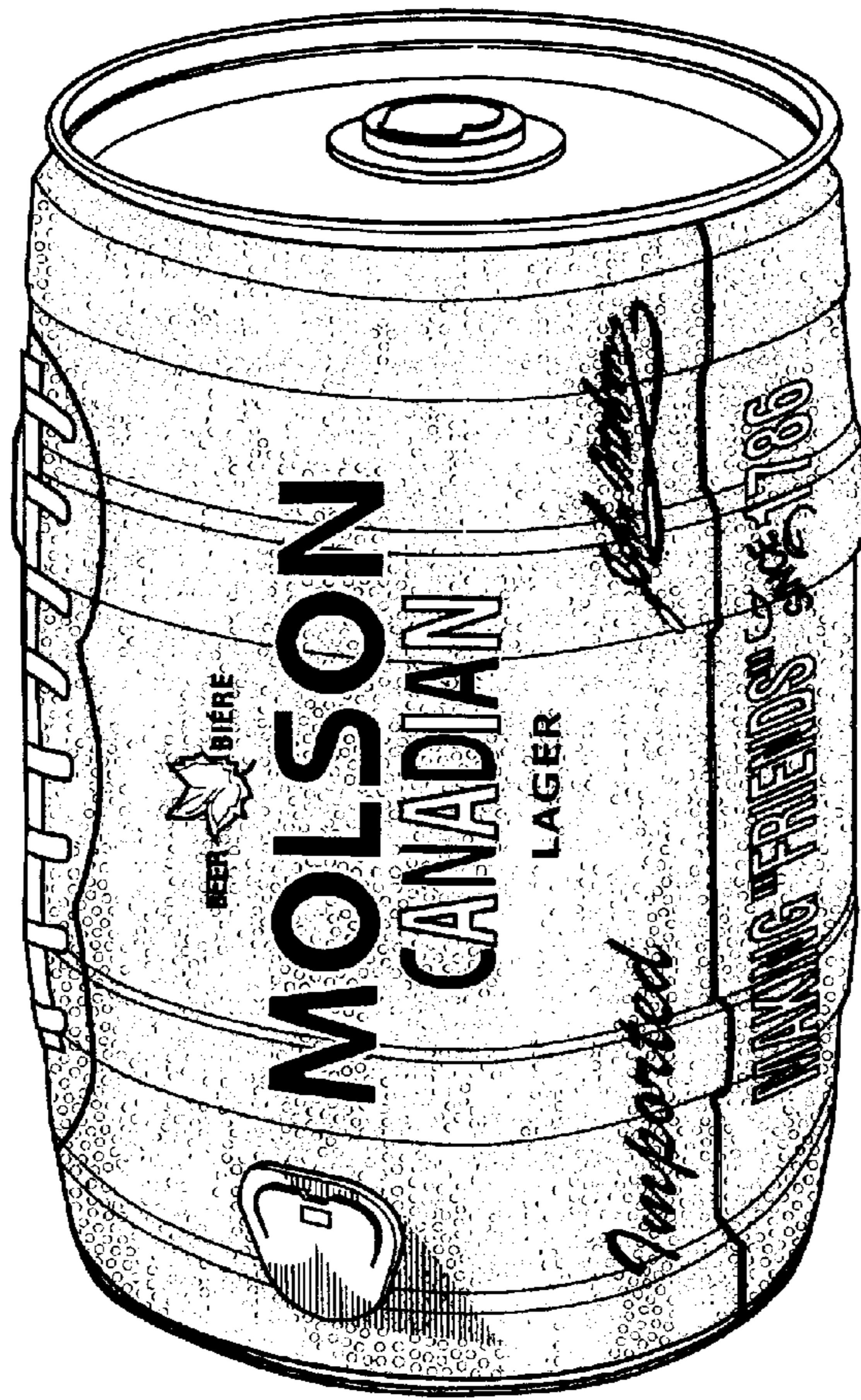

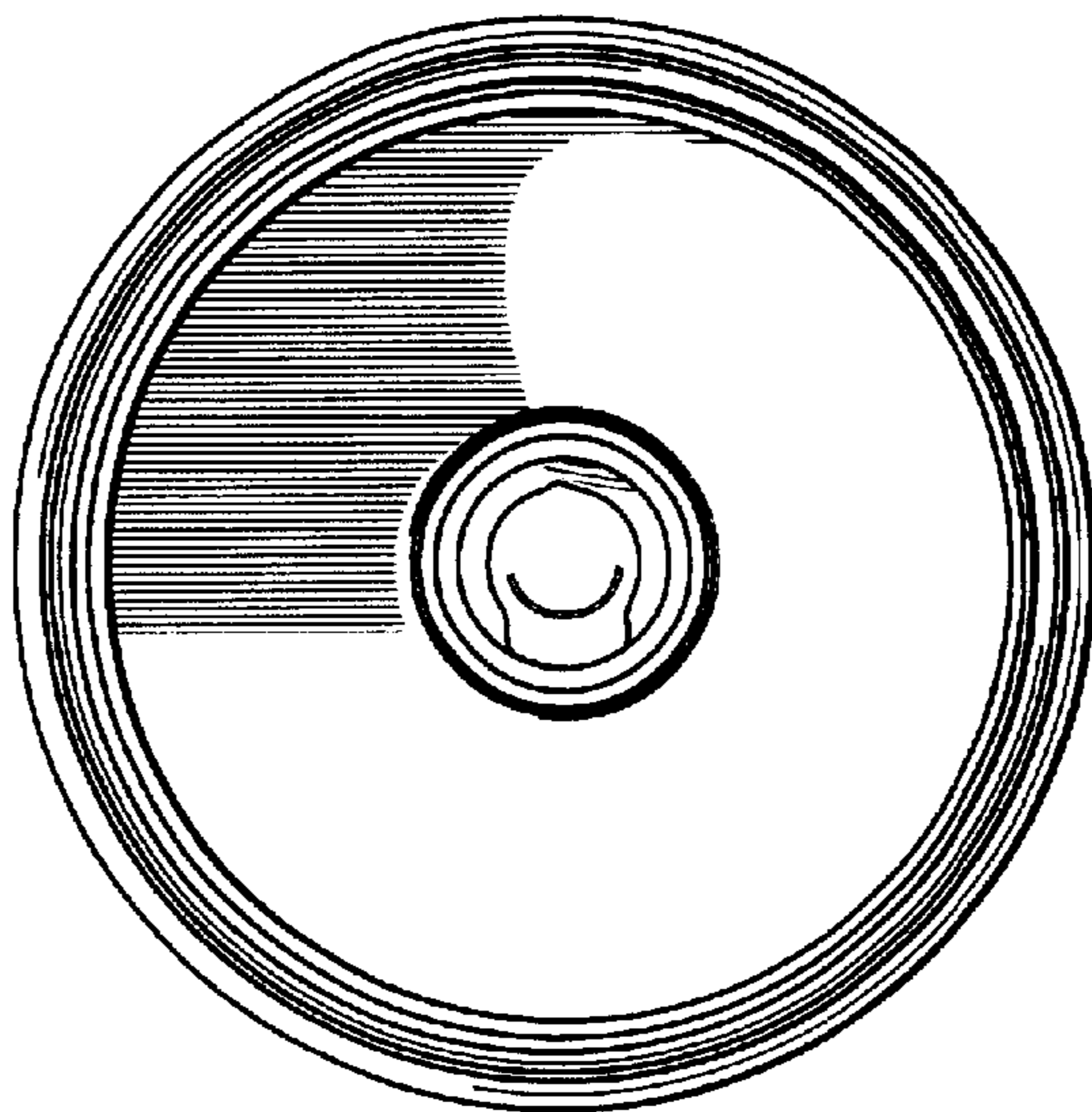

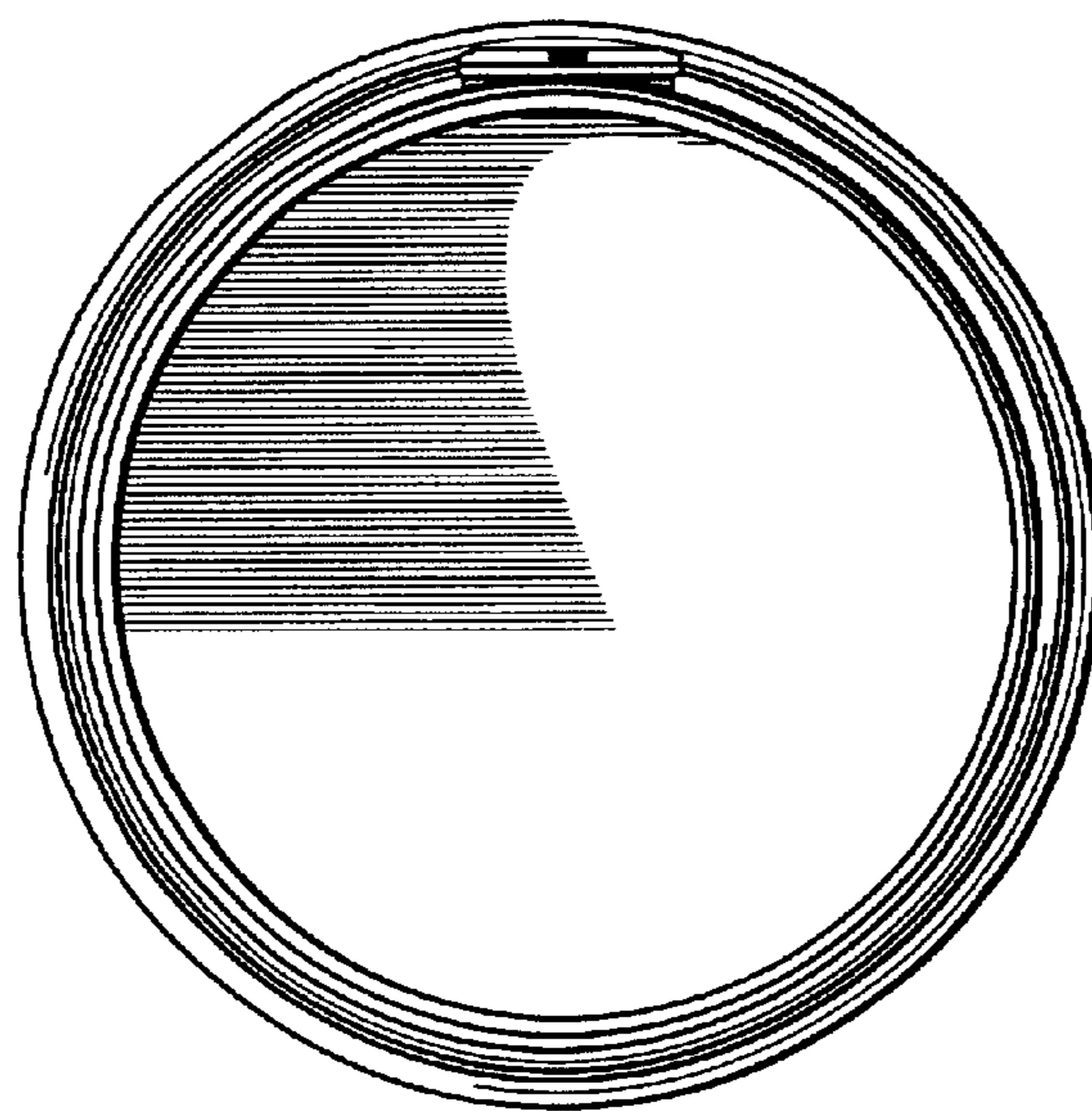

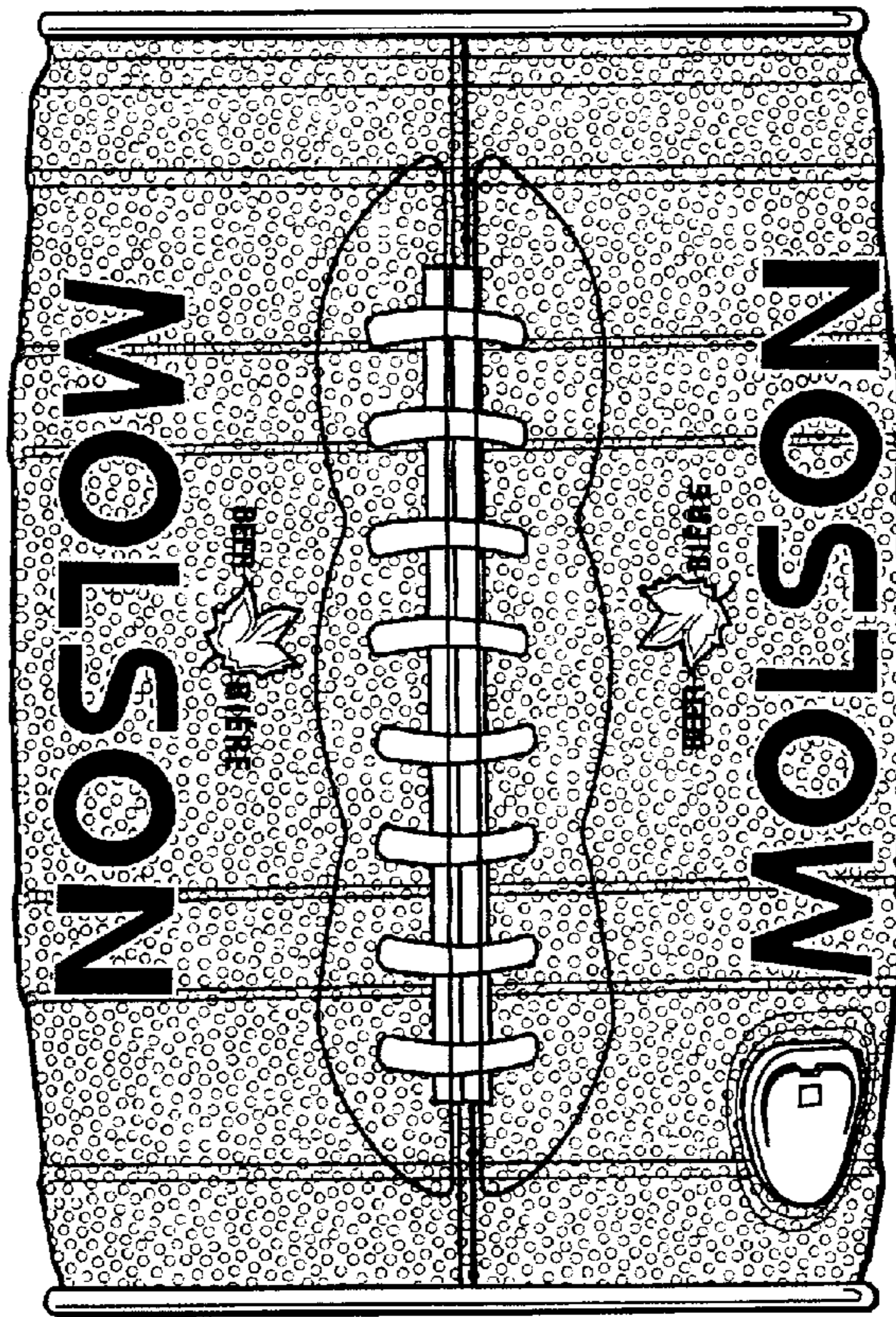

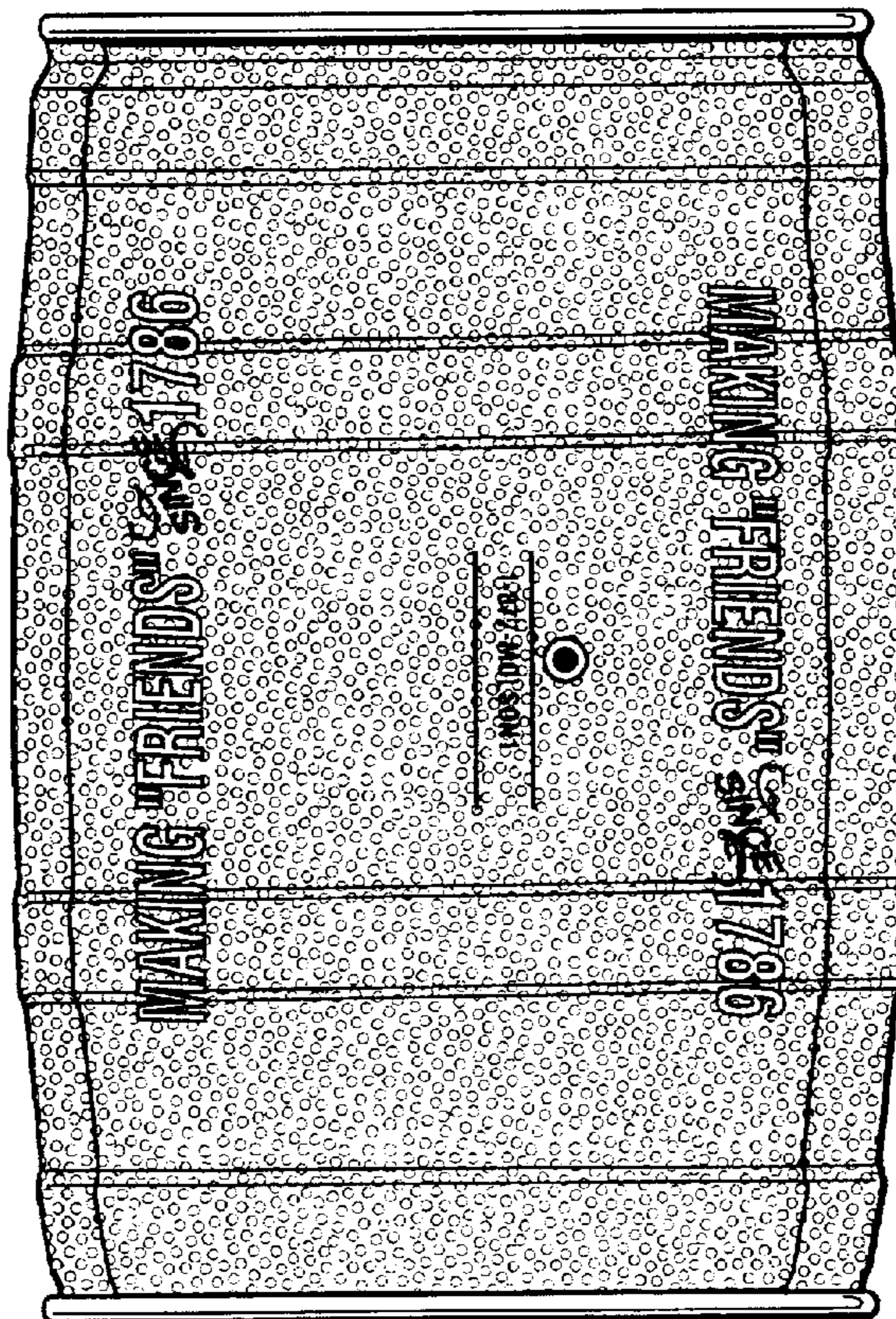

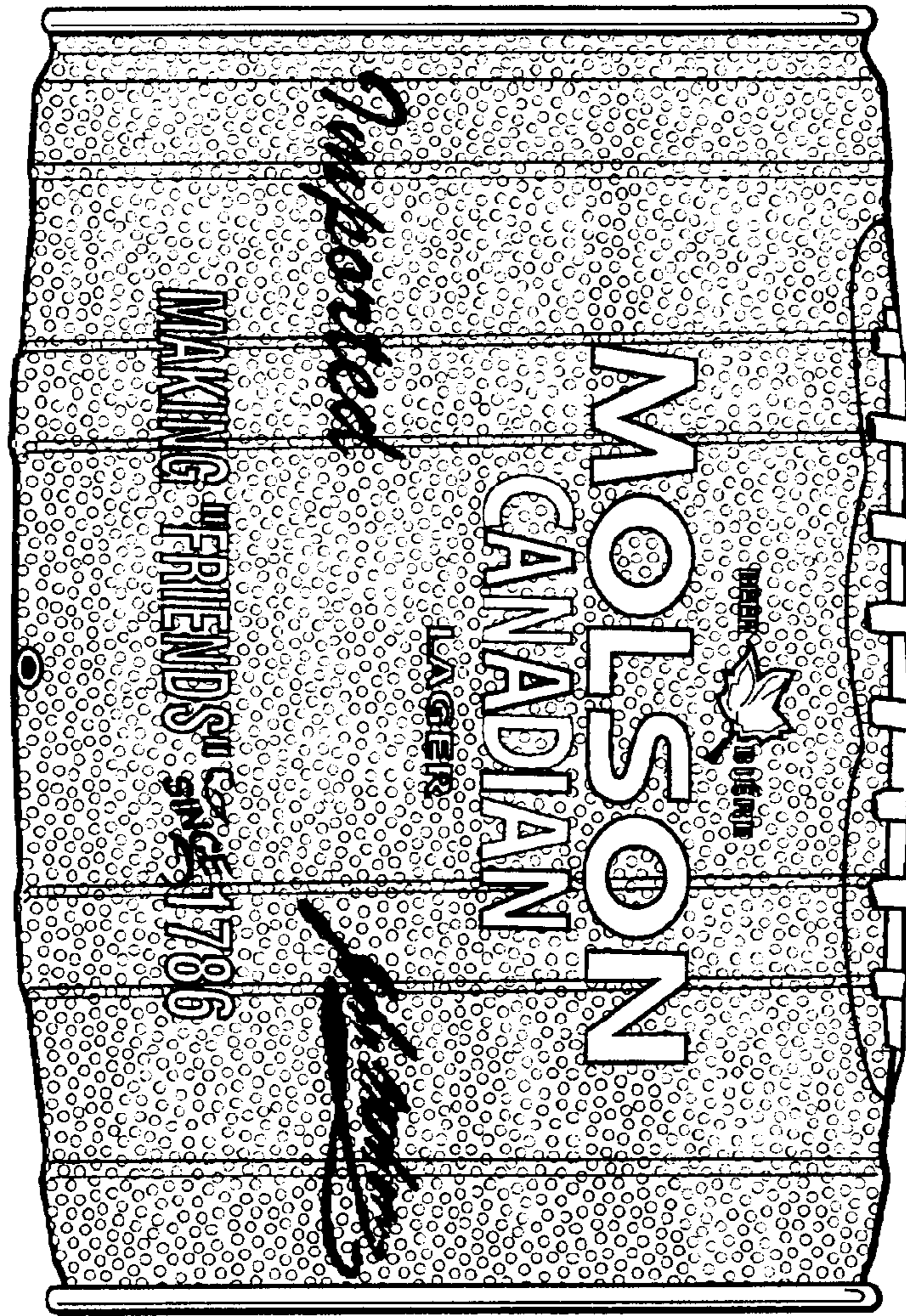

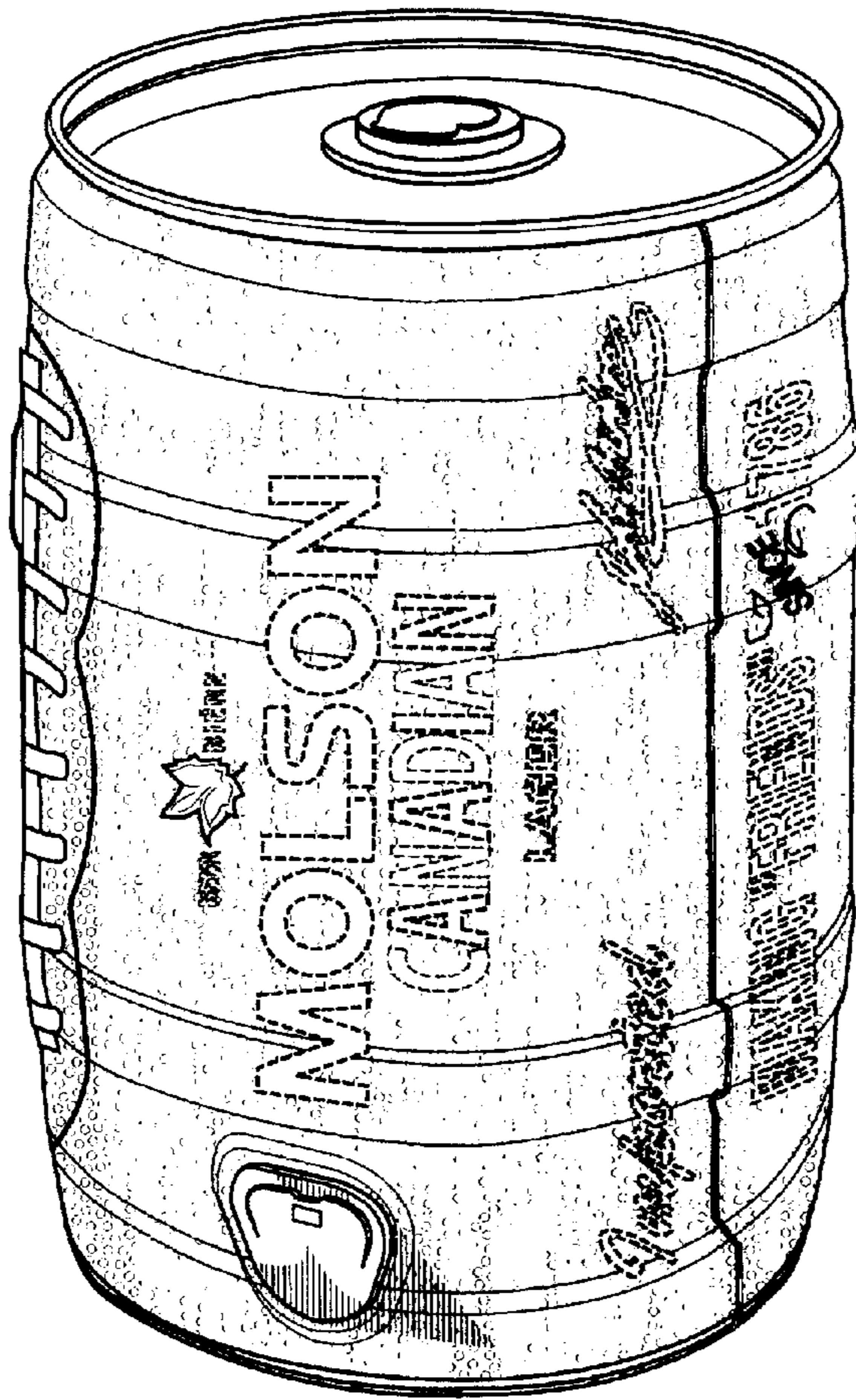

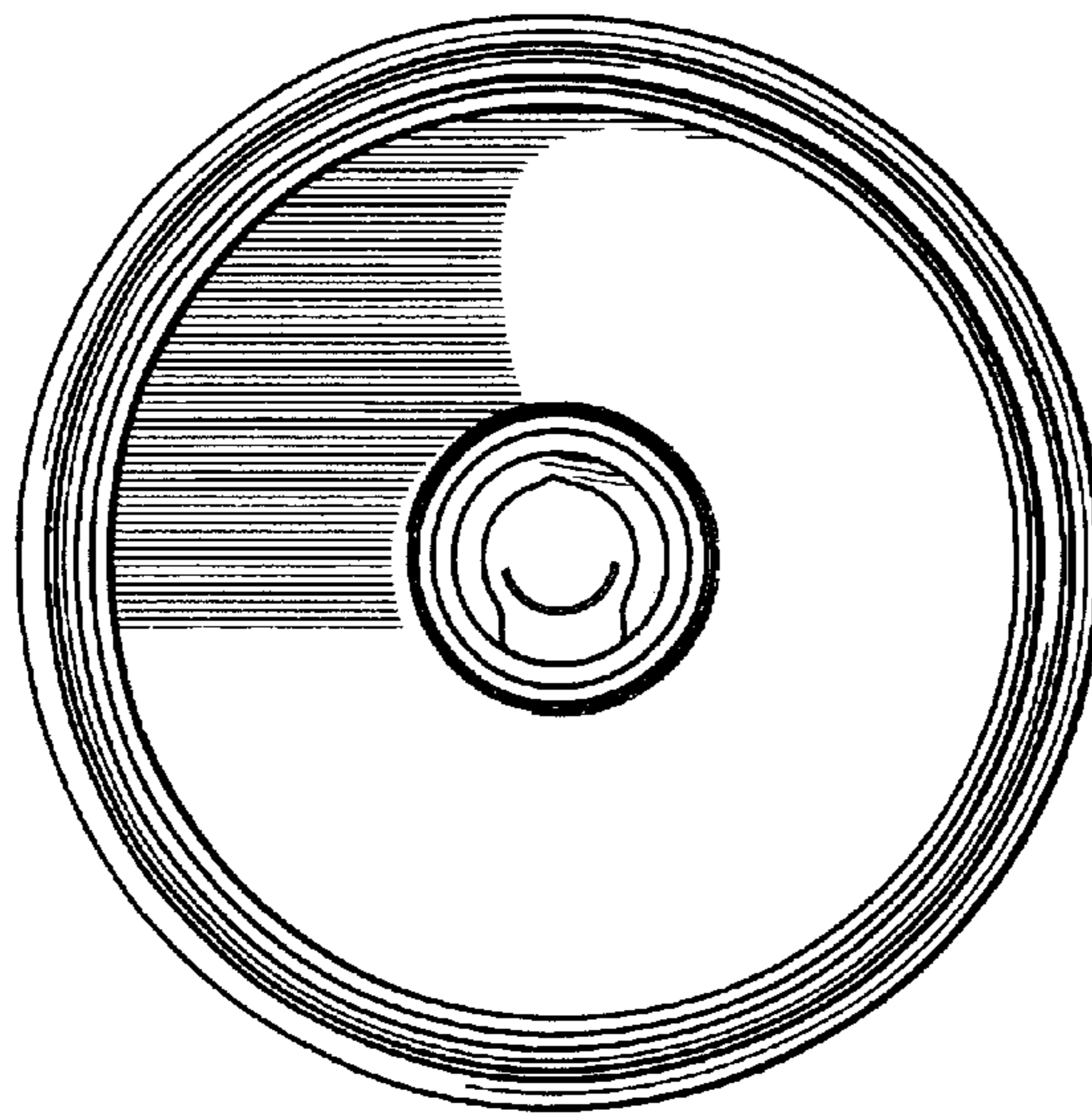

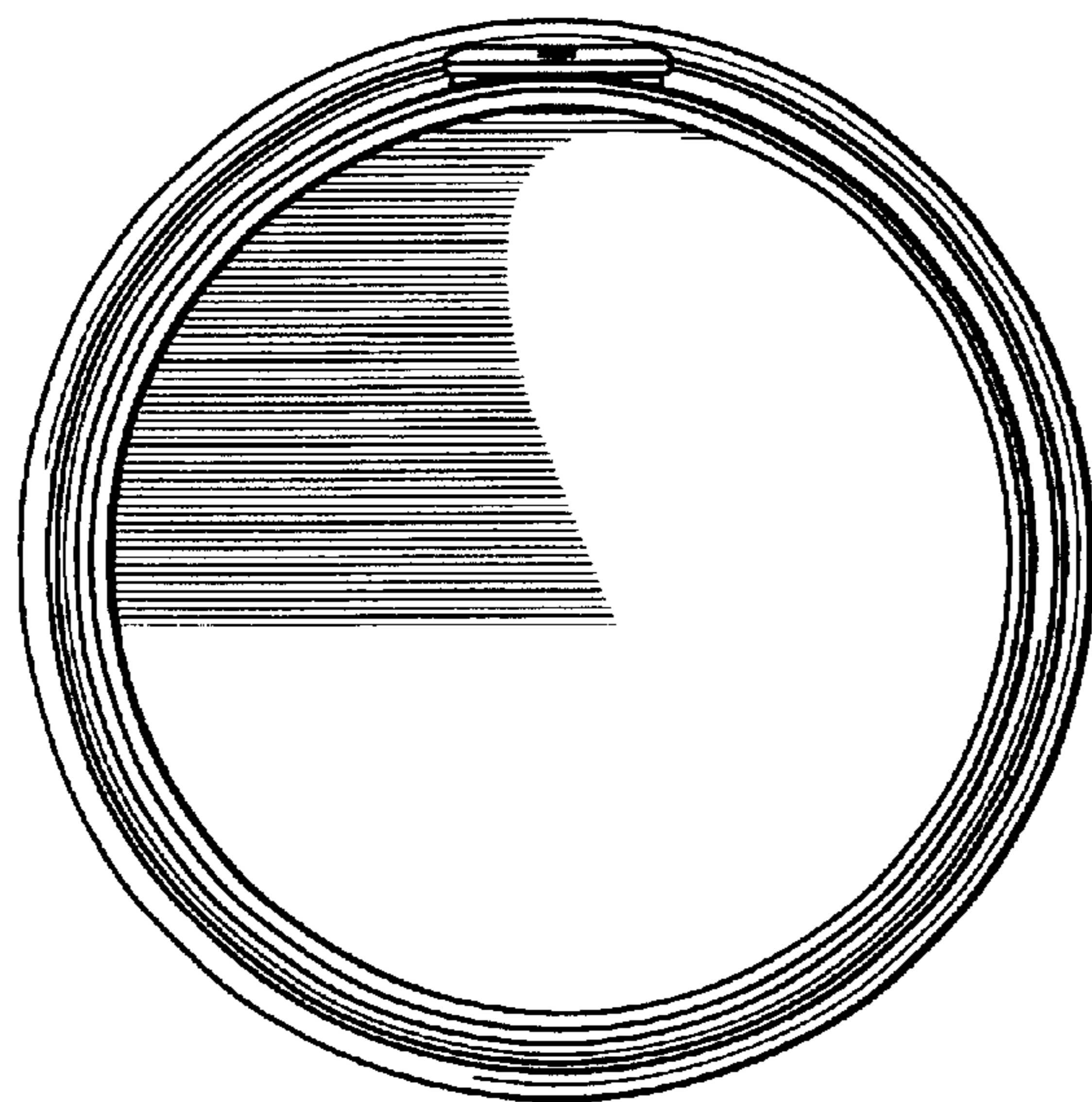

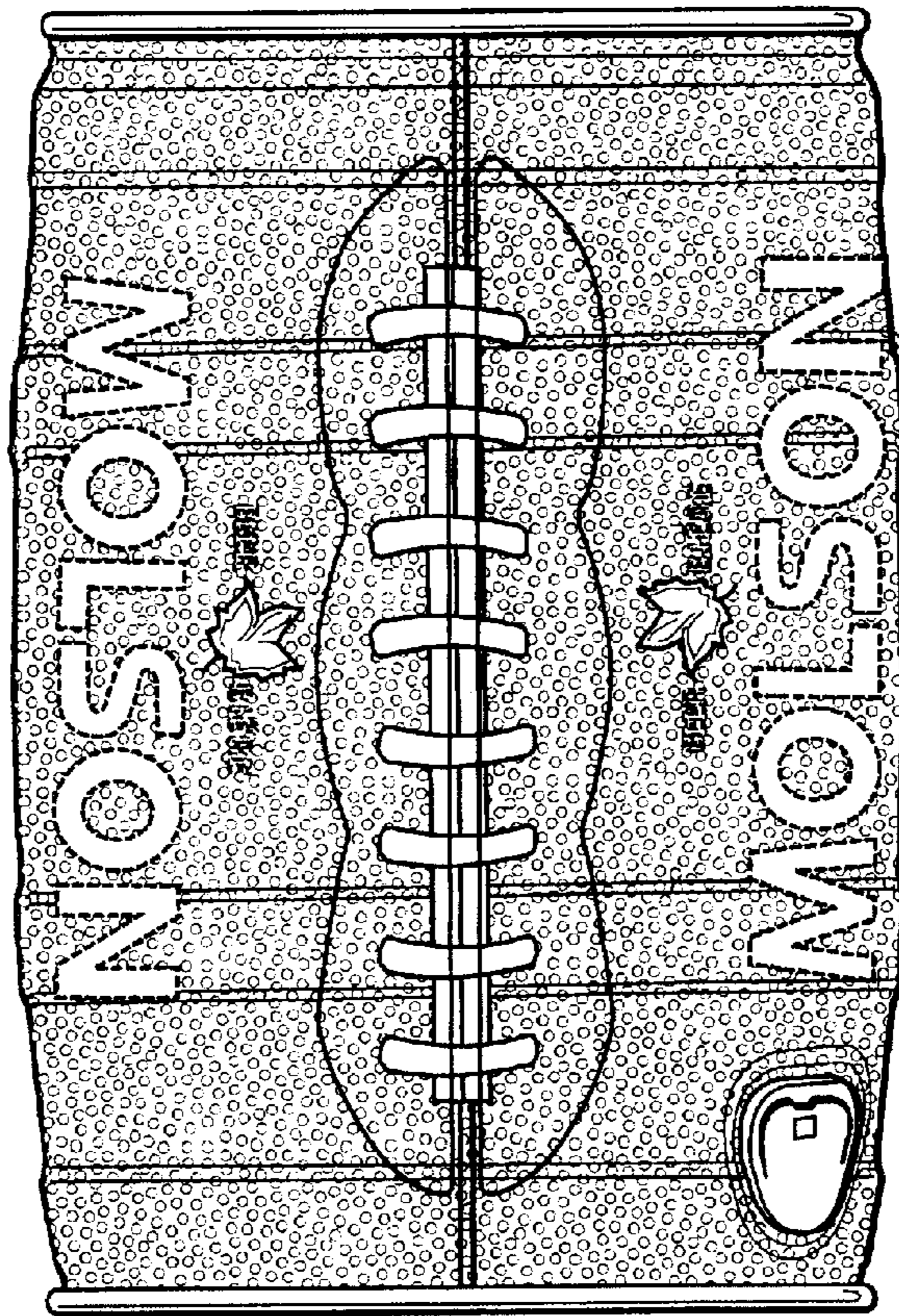

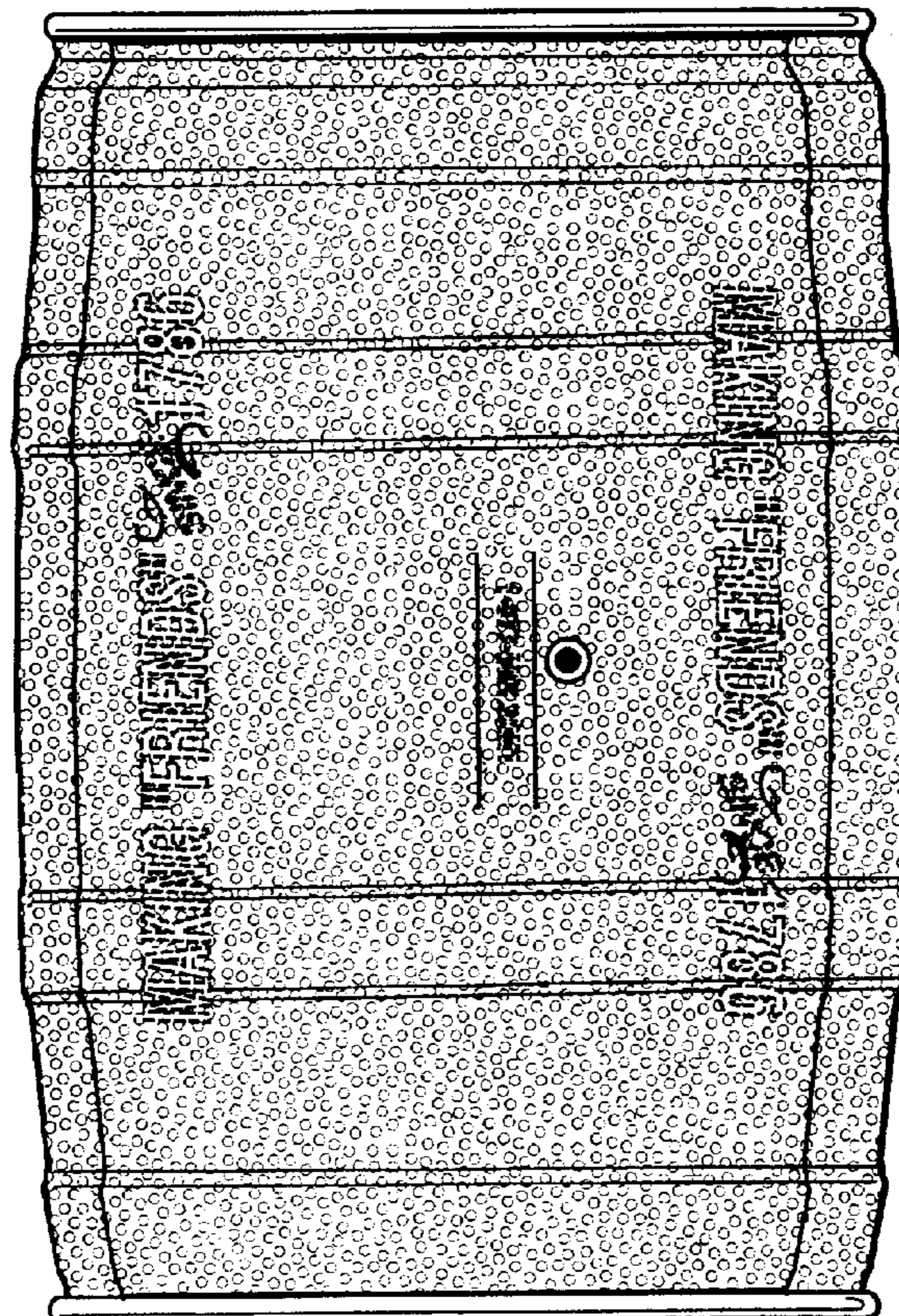

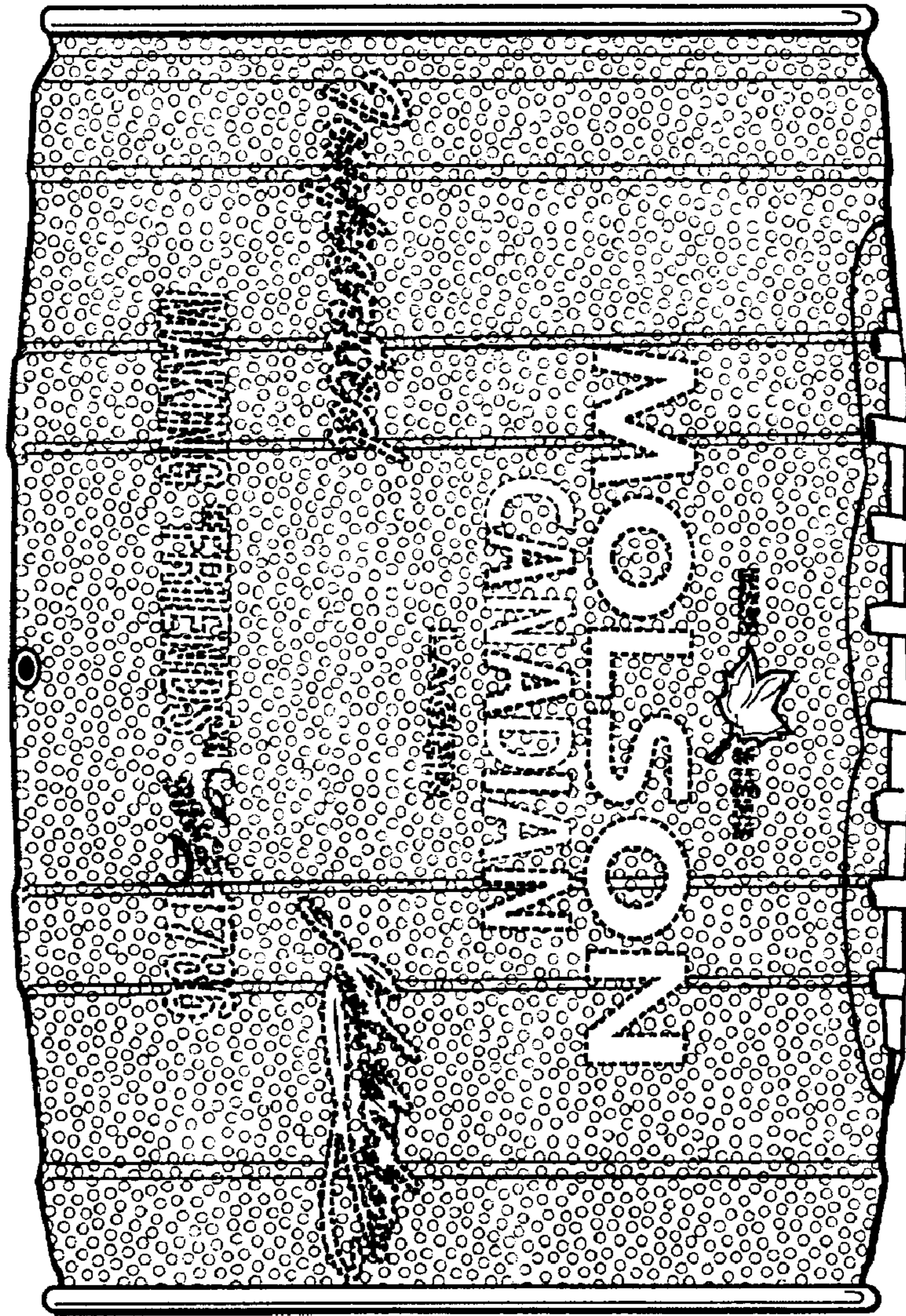
