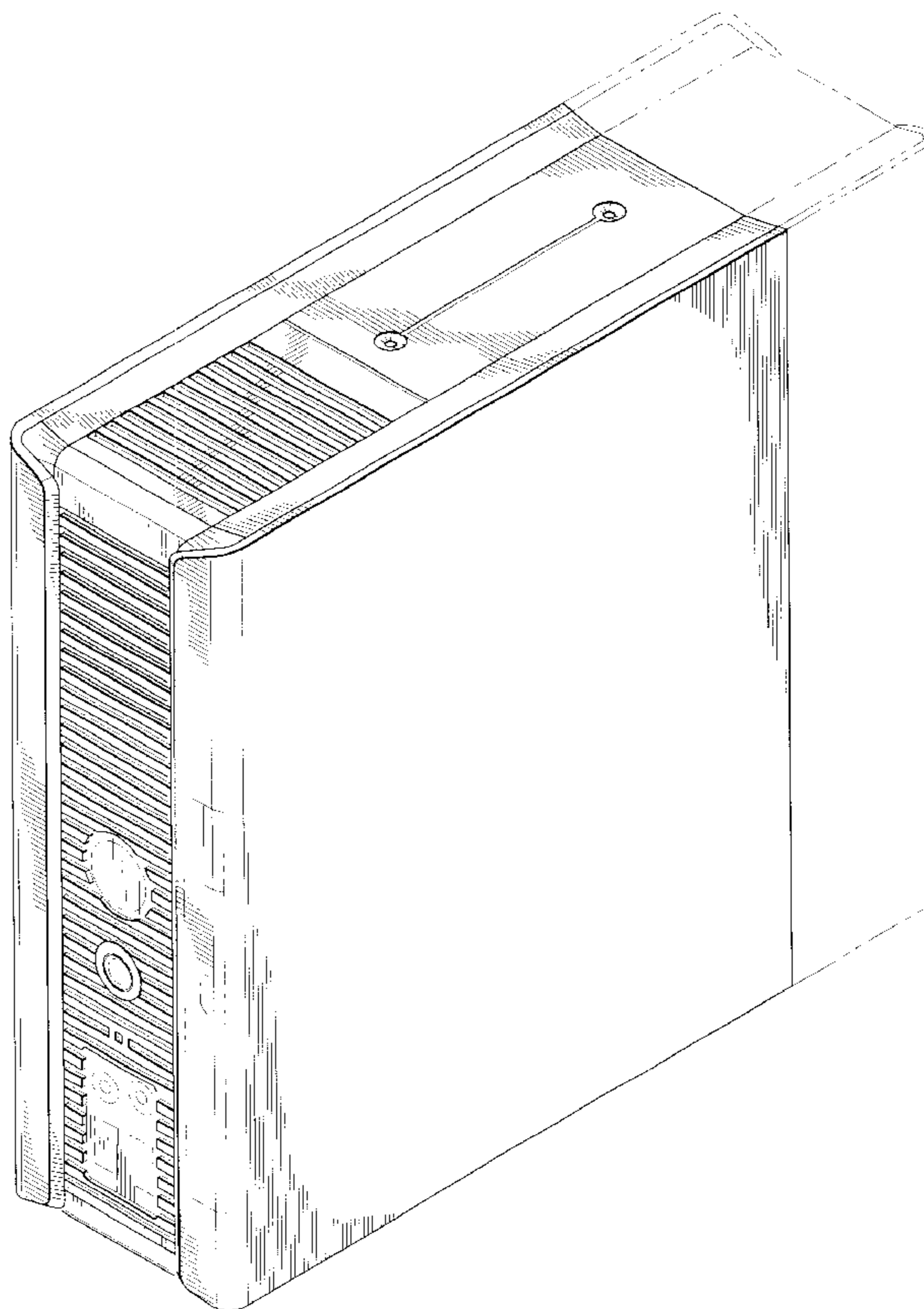
(57) **CLAIM**

The ornamental design for an information handling system housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a frontal angled perspective view of the information handling system housing comprising the present invention, the broken lines are shown for illustrative purposes only and form no part of the claimed design; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a back elevation view thereof; and, FIG. 6 is a top plan view thereof.

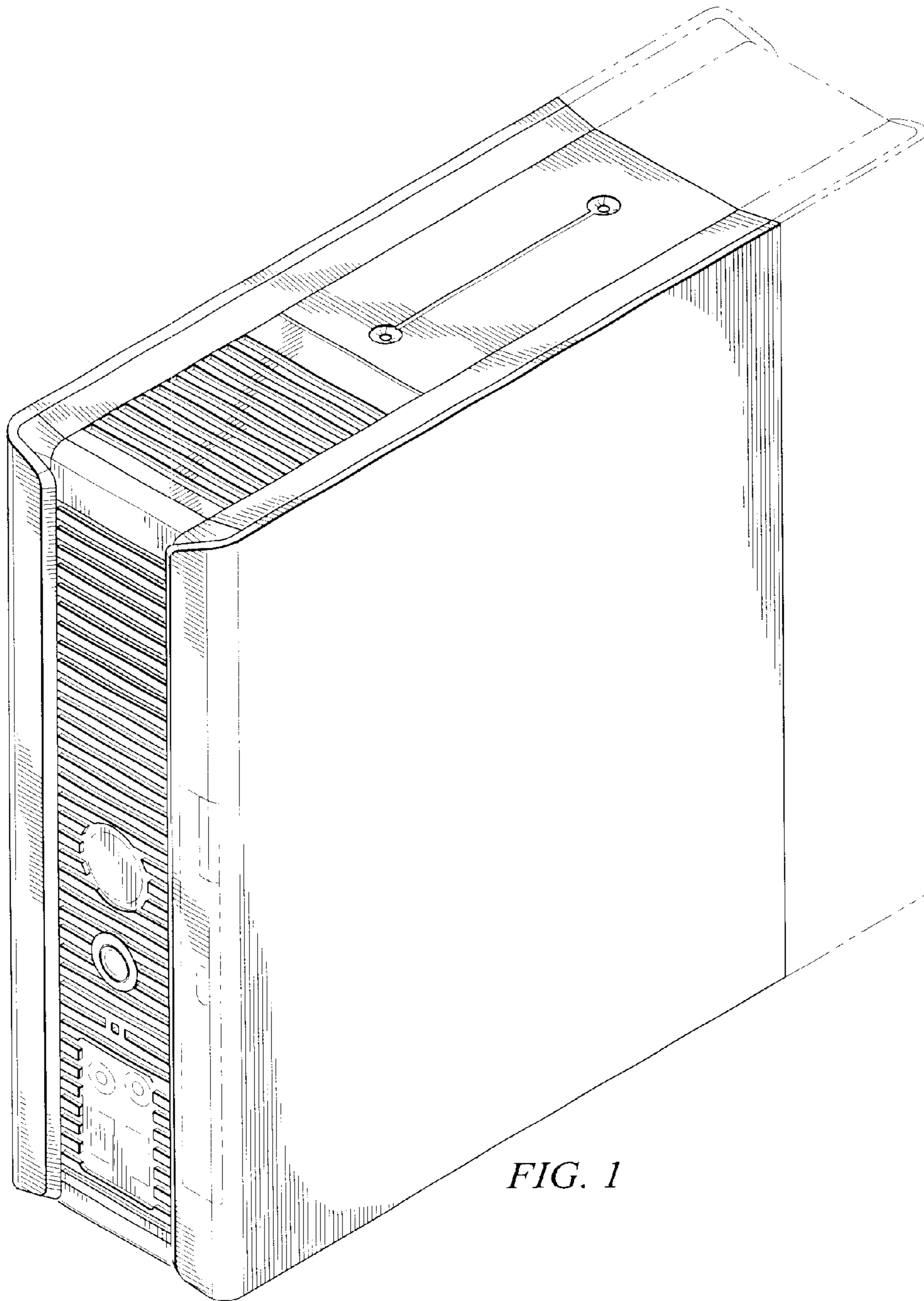

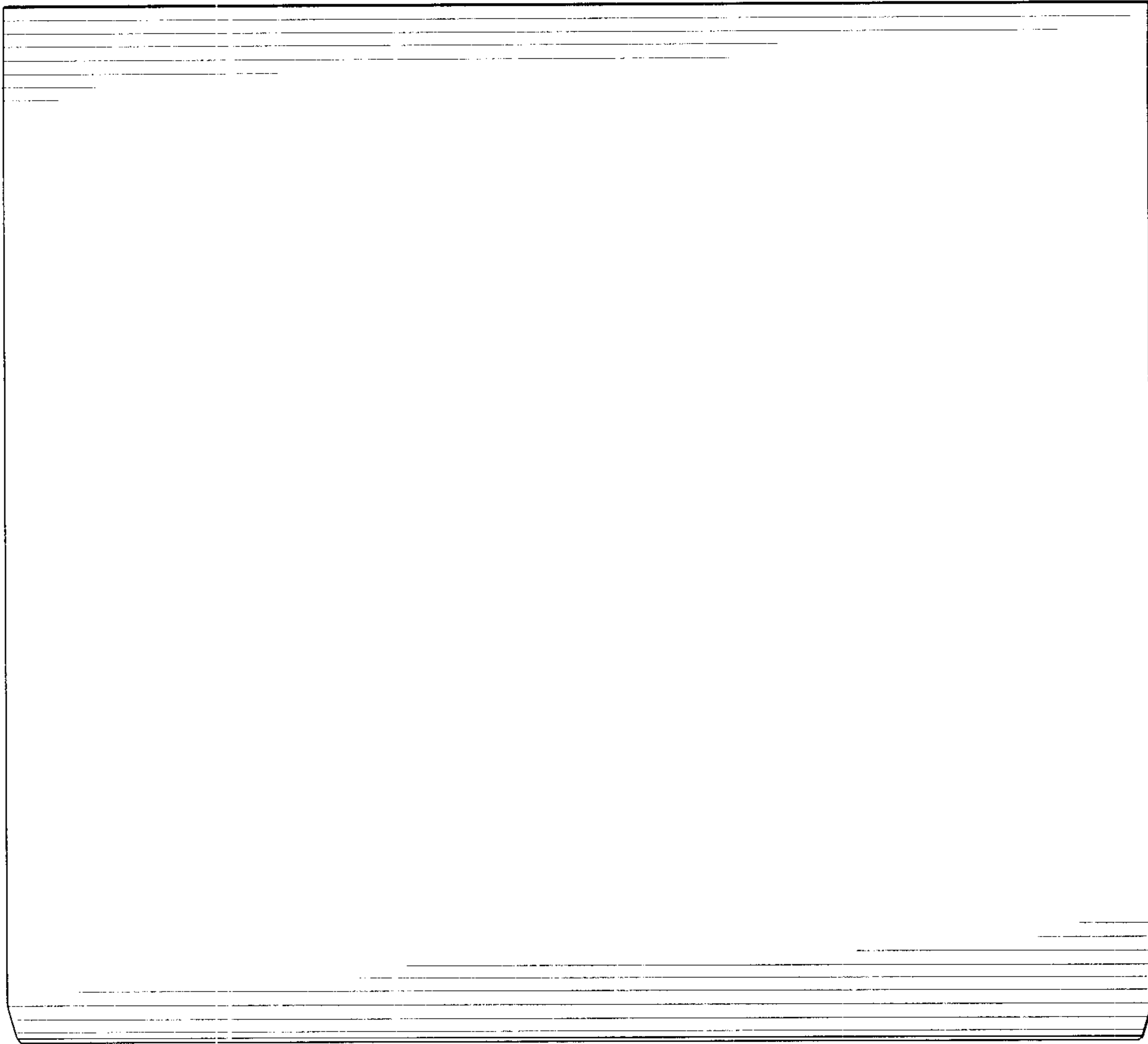

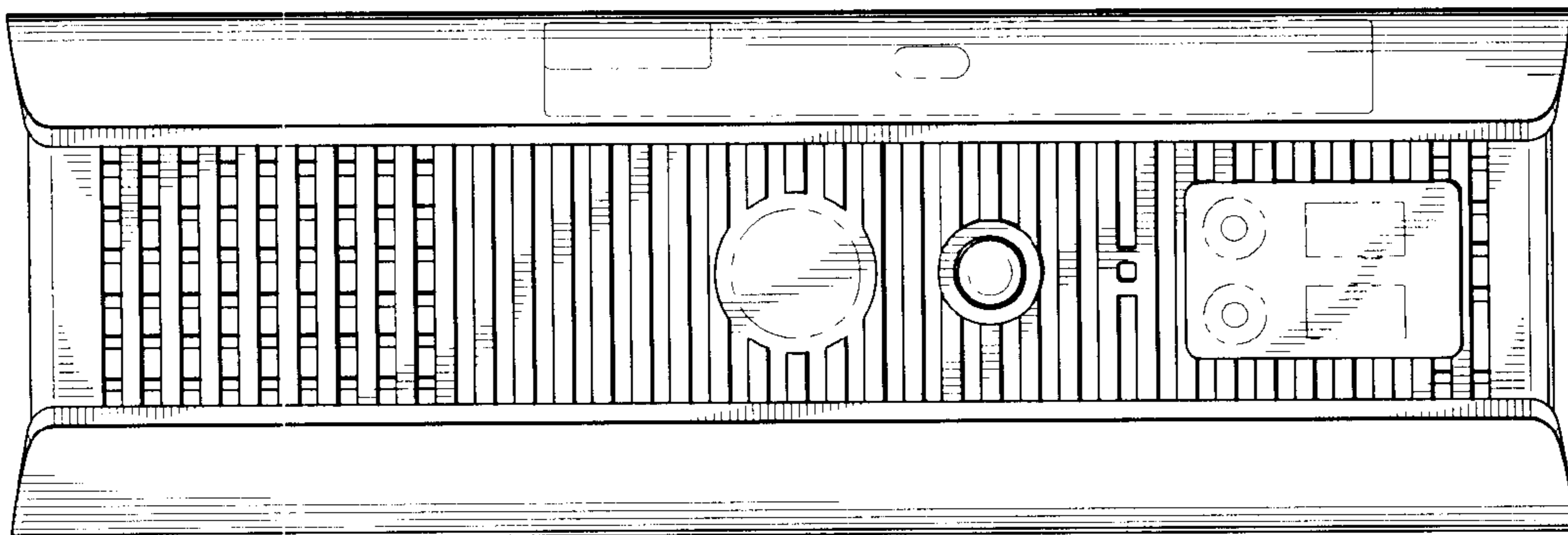

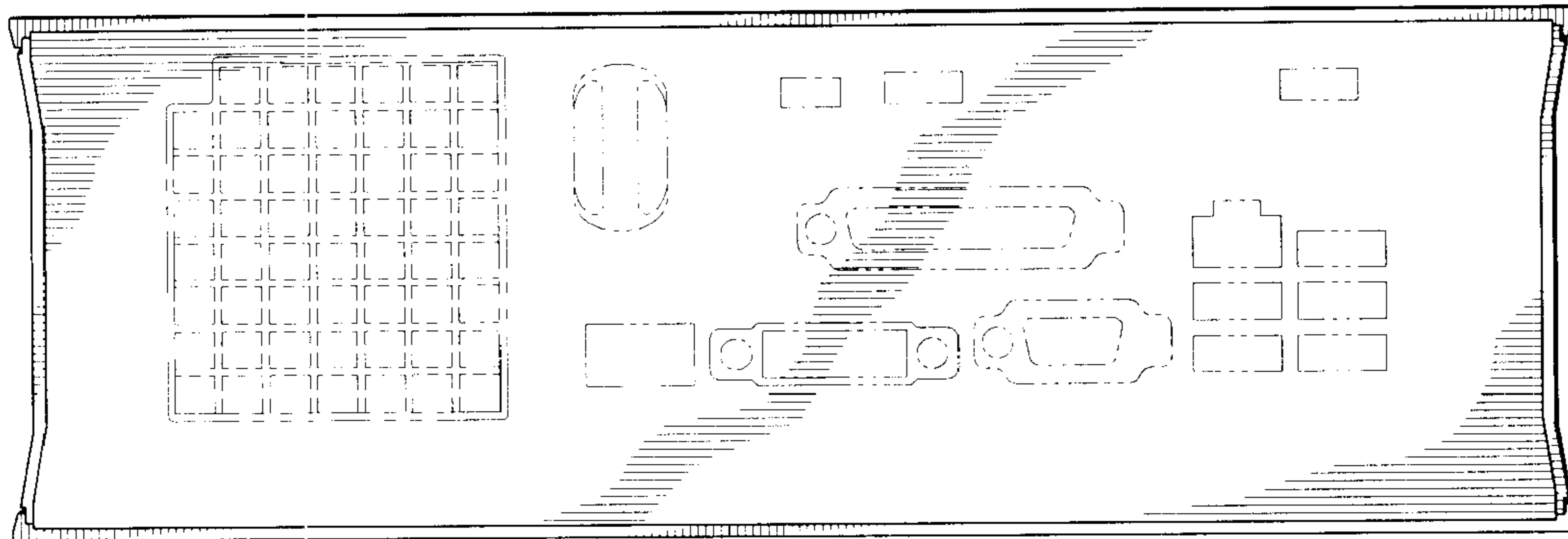

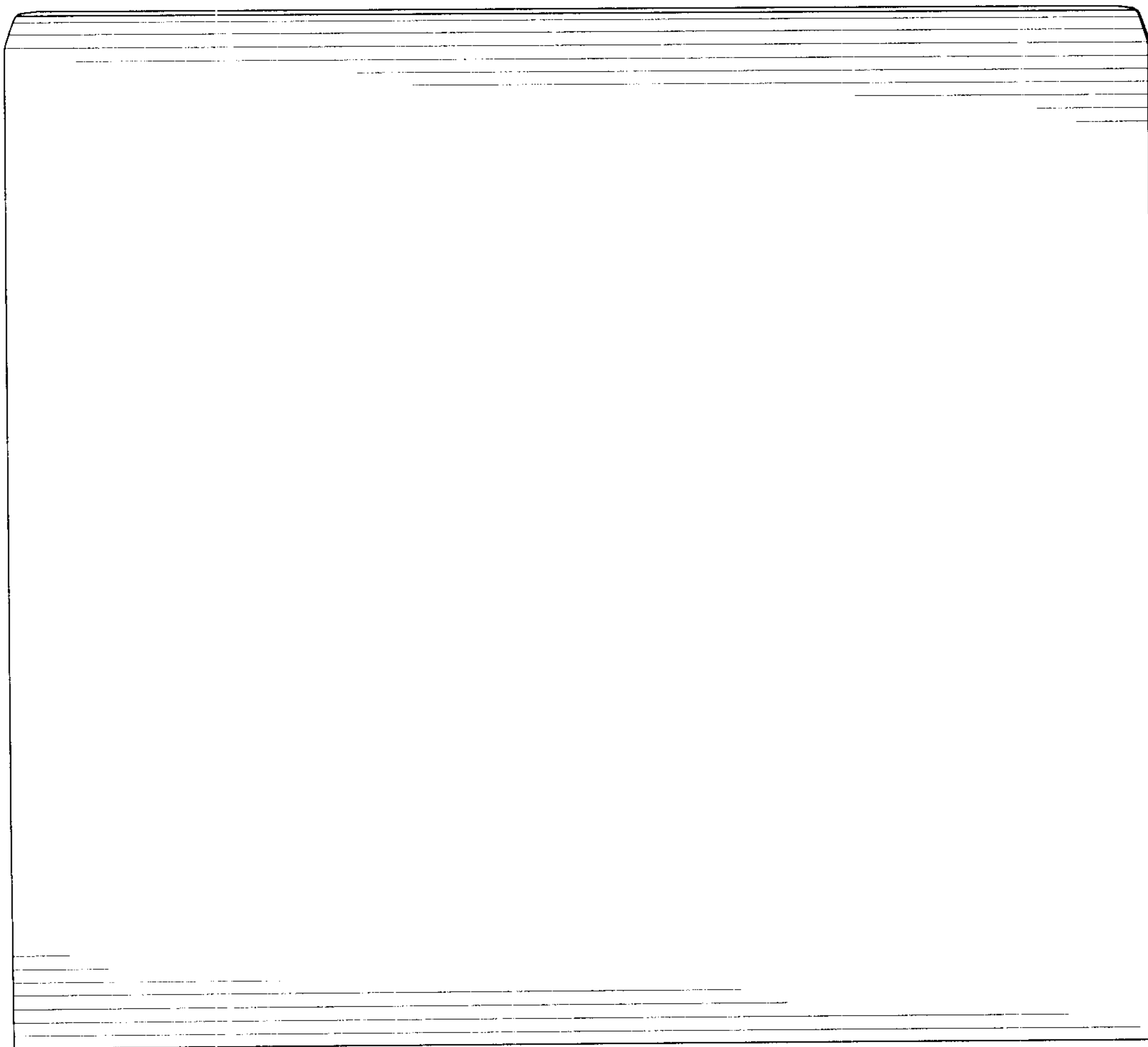
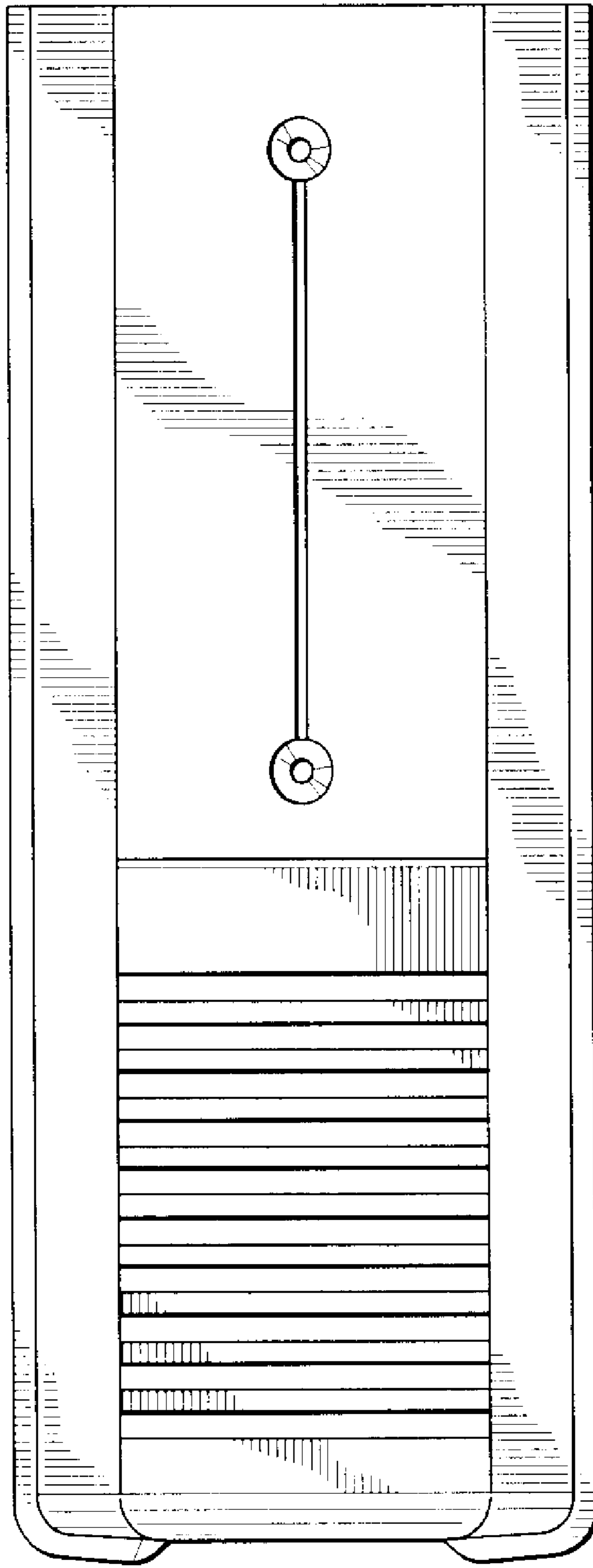
