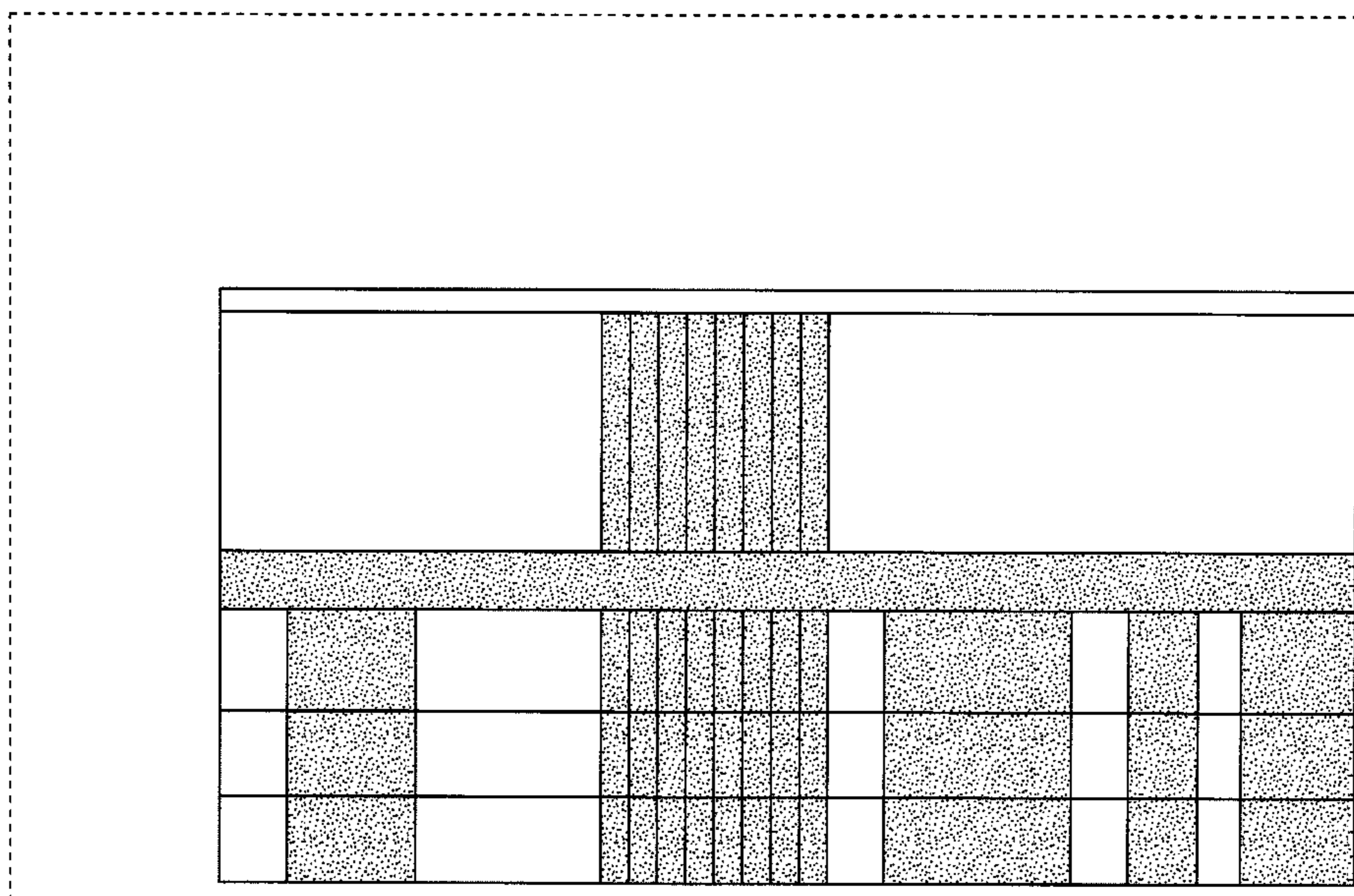
The ornamental design for a graphic for a portion of a computer display screen, substantially as shown and described.

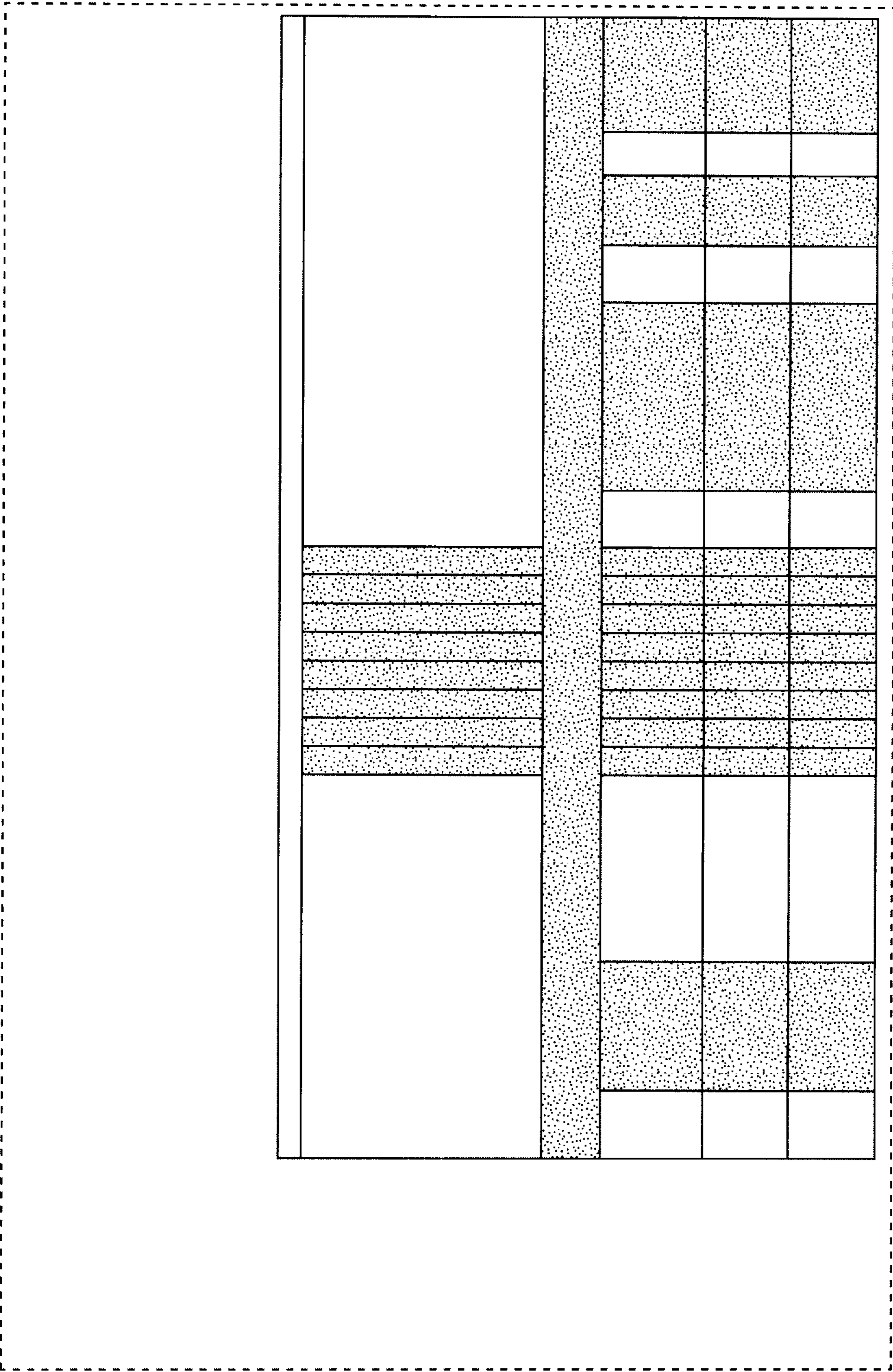
