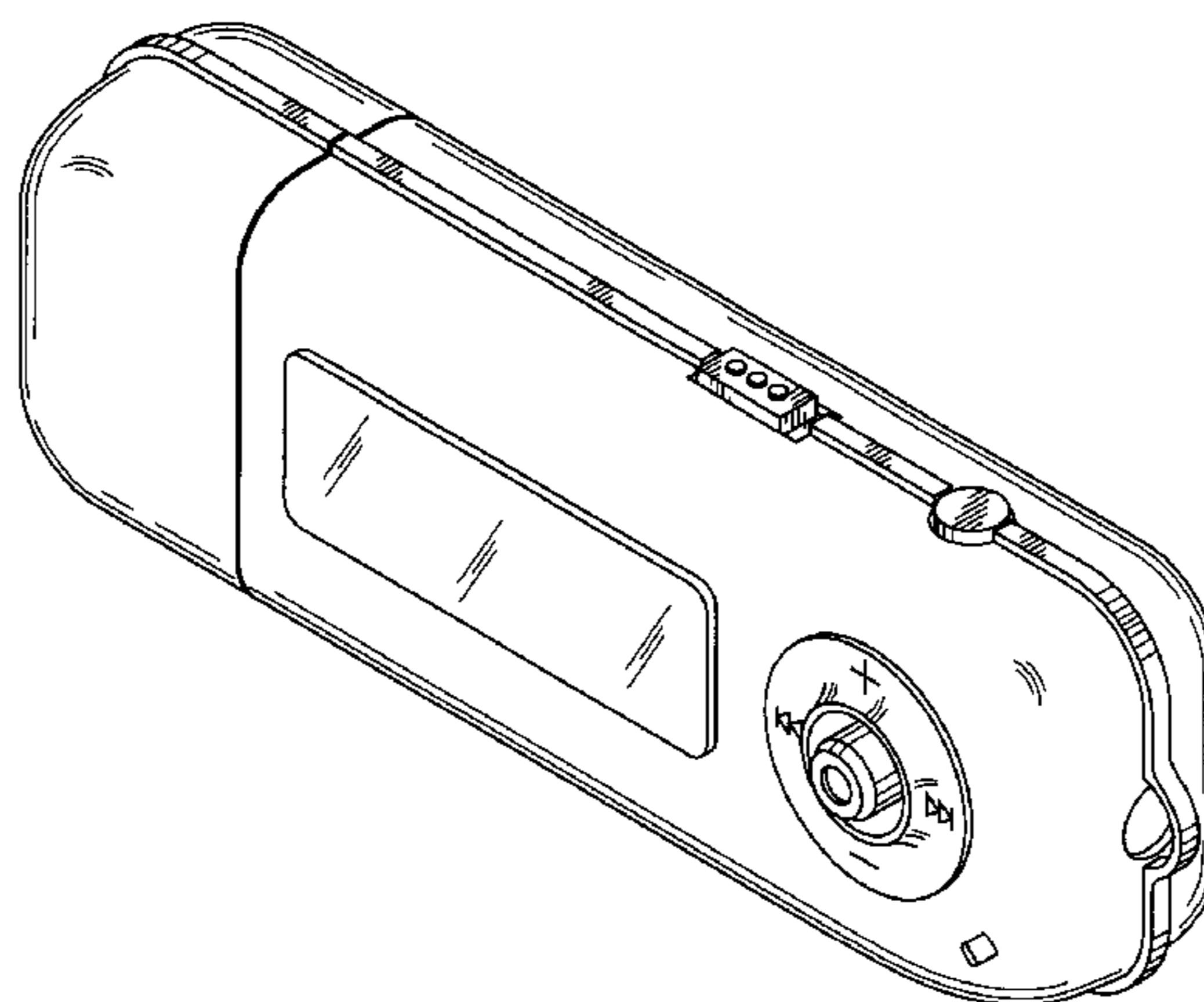
The ornamental design for a portable digital media player, as shown and described.

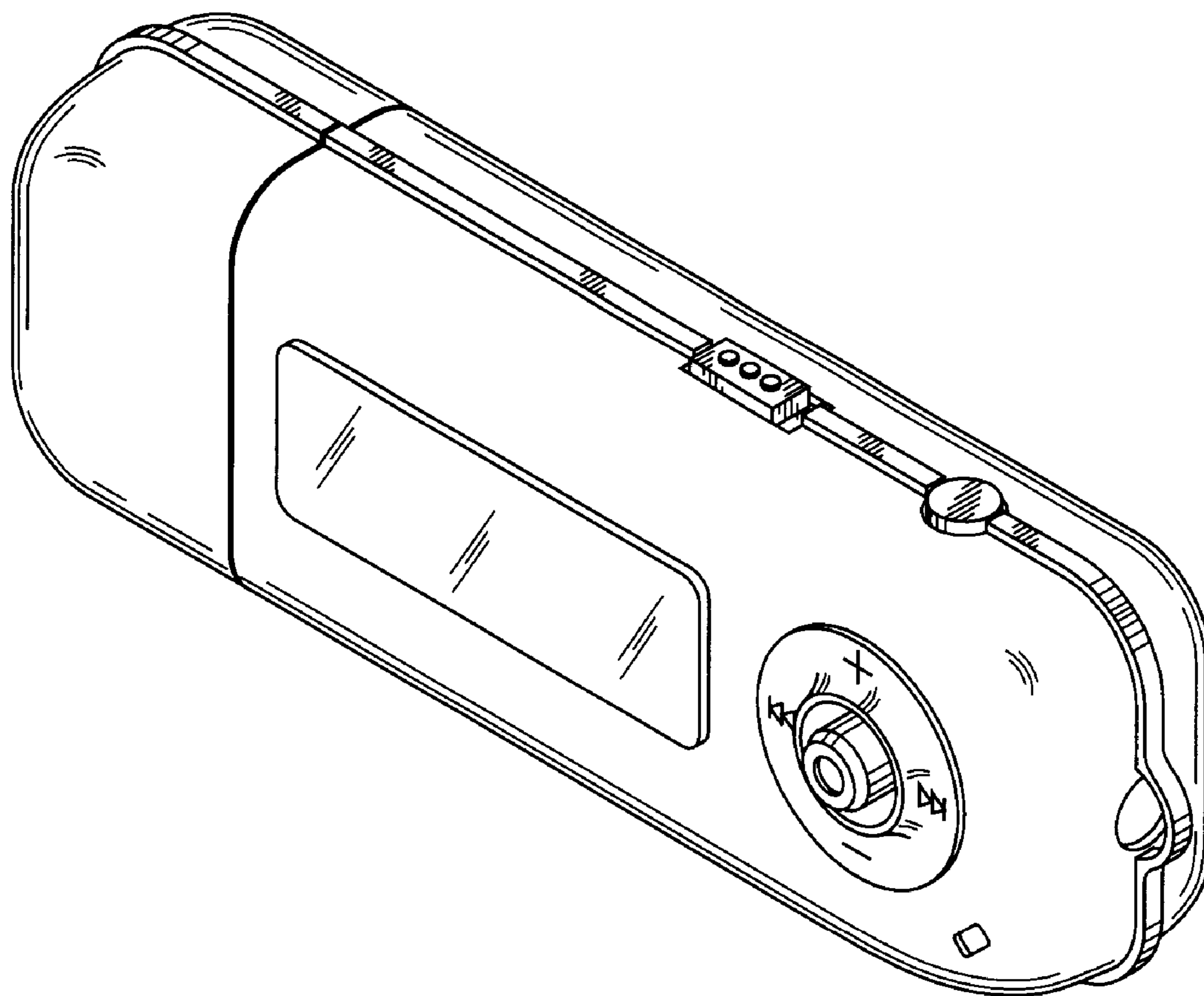

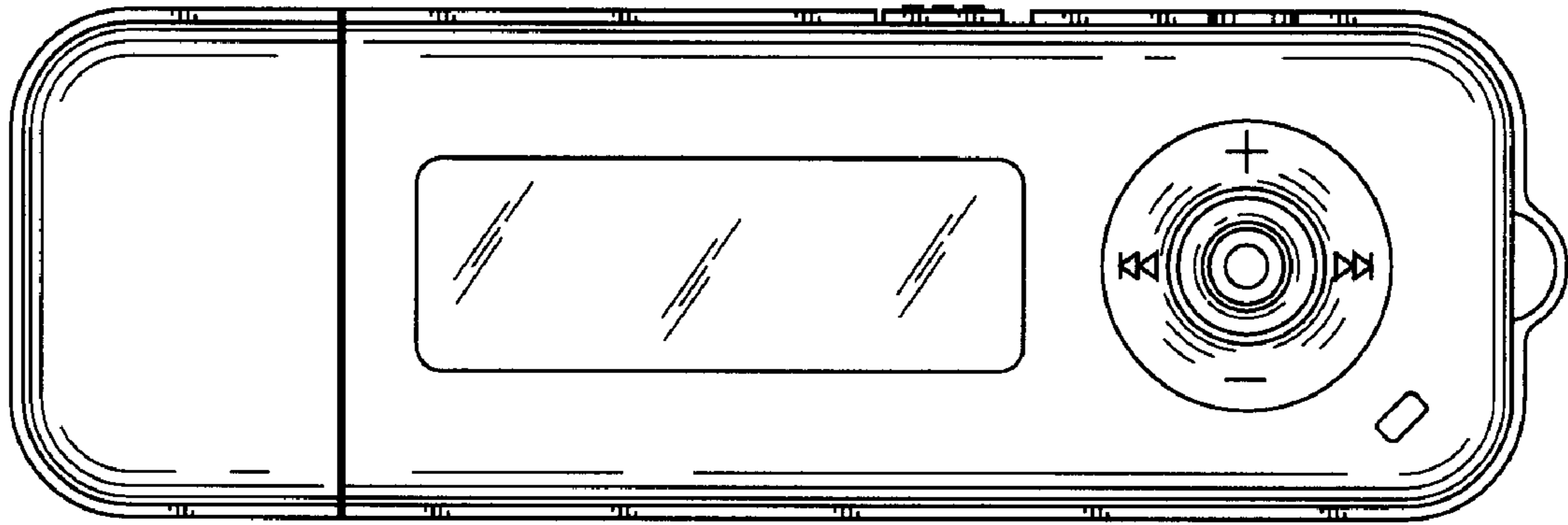

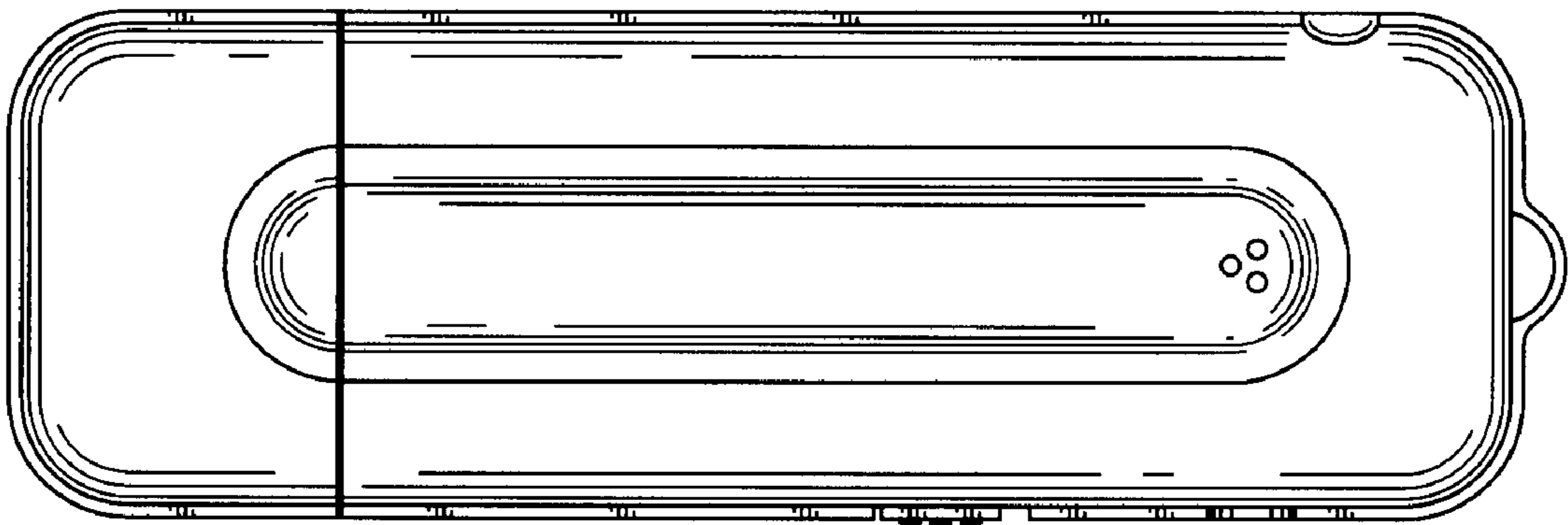

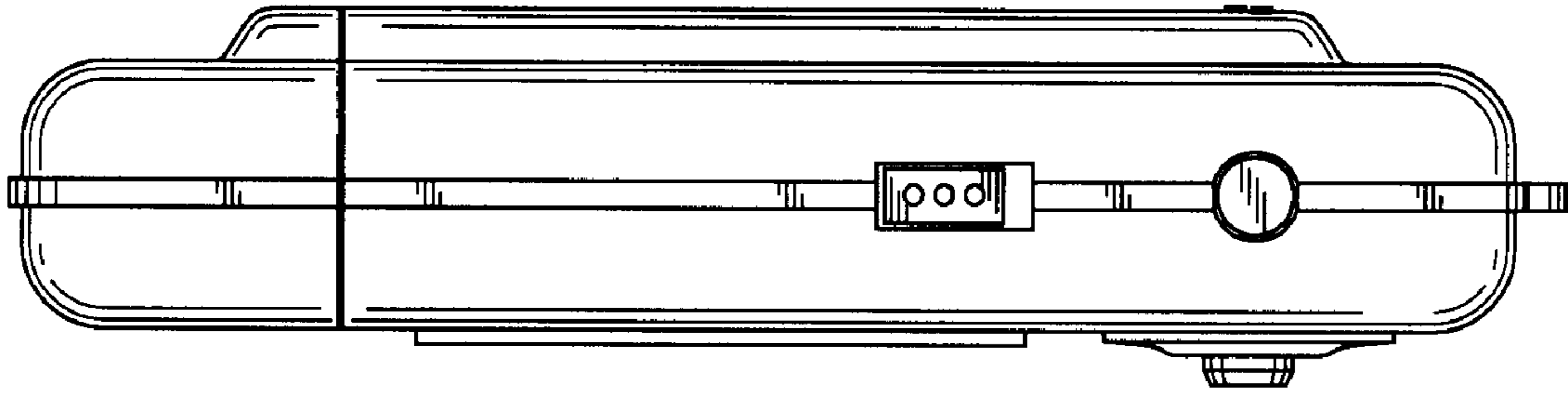

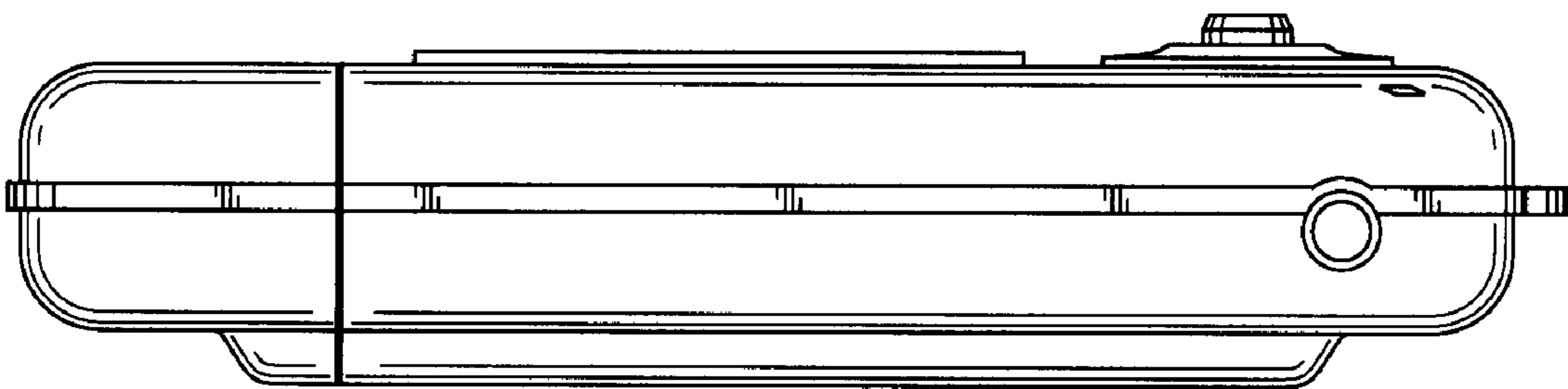

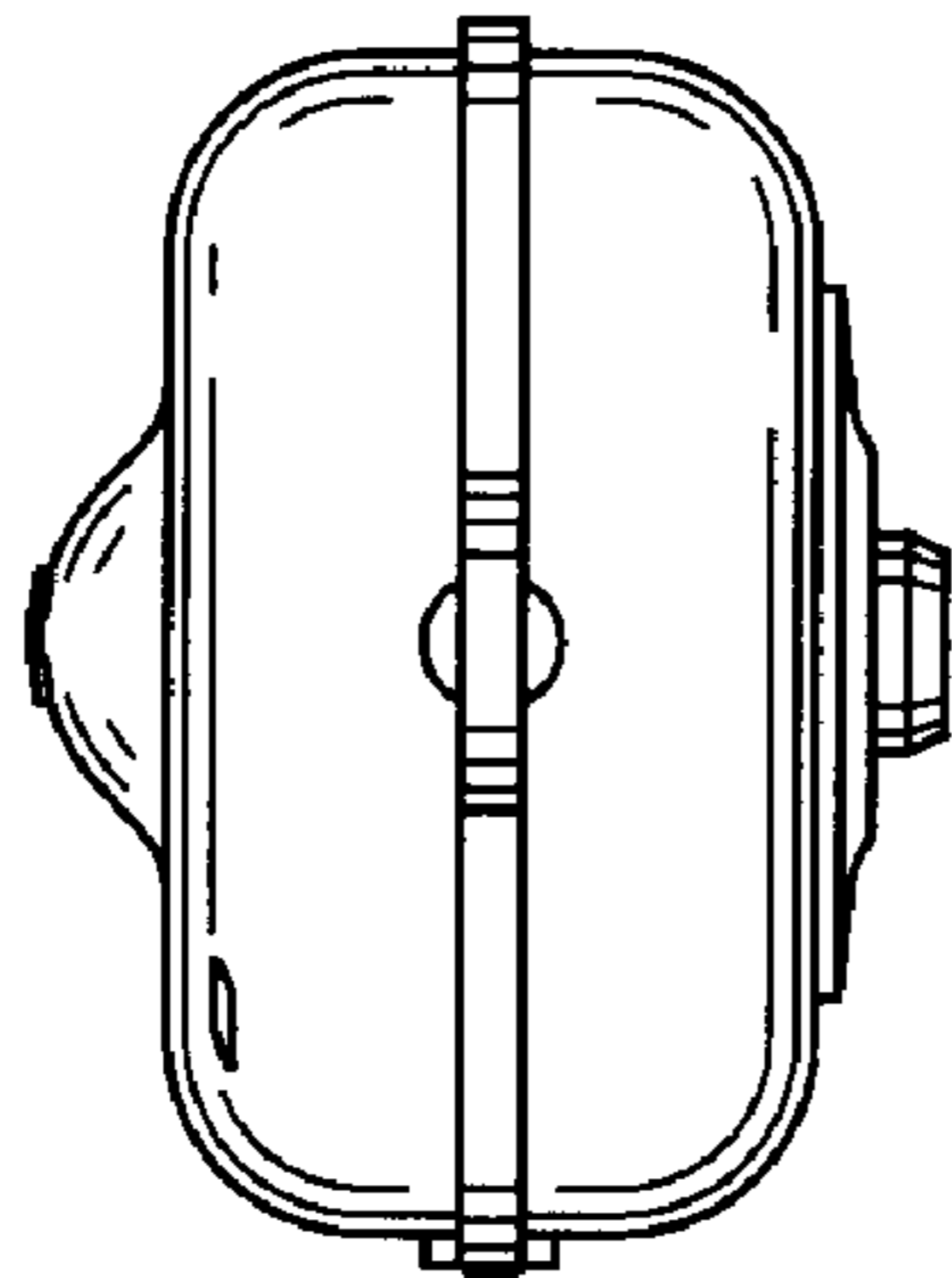
