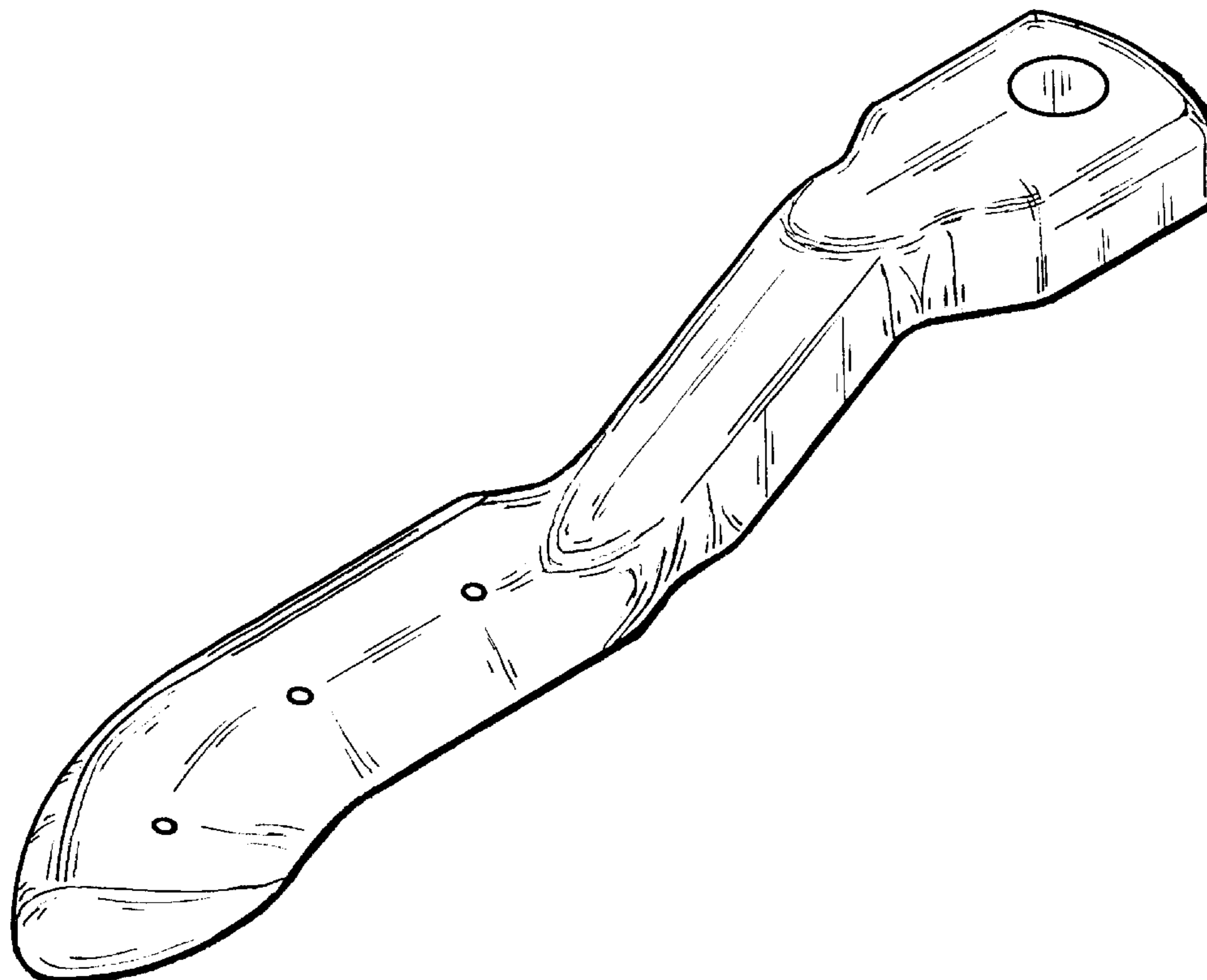
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of the mower blade of the present invention;

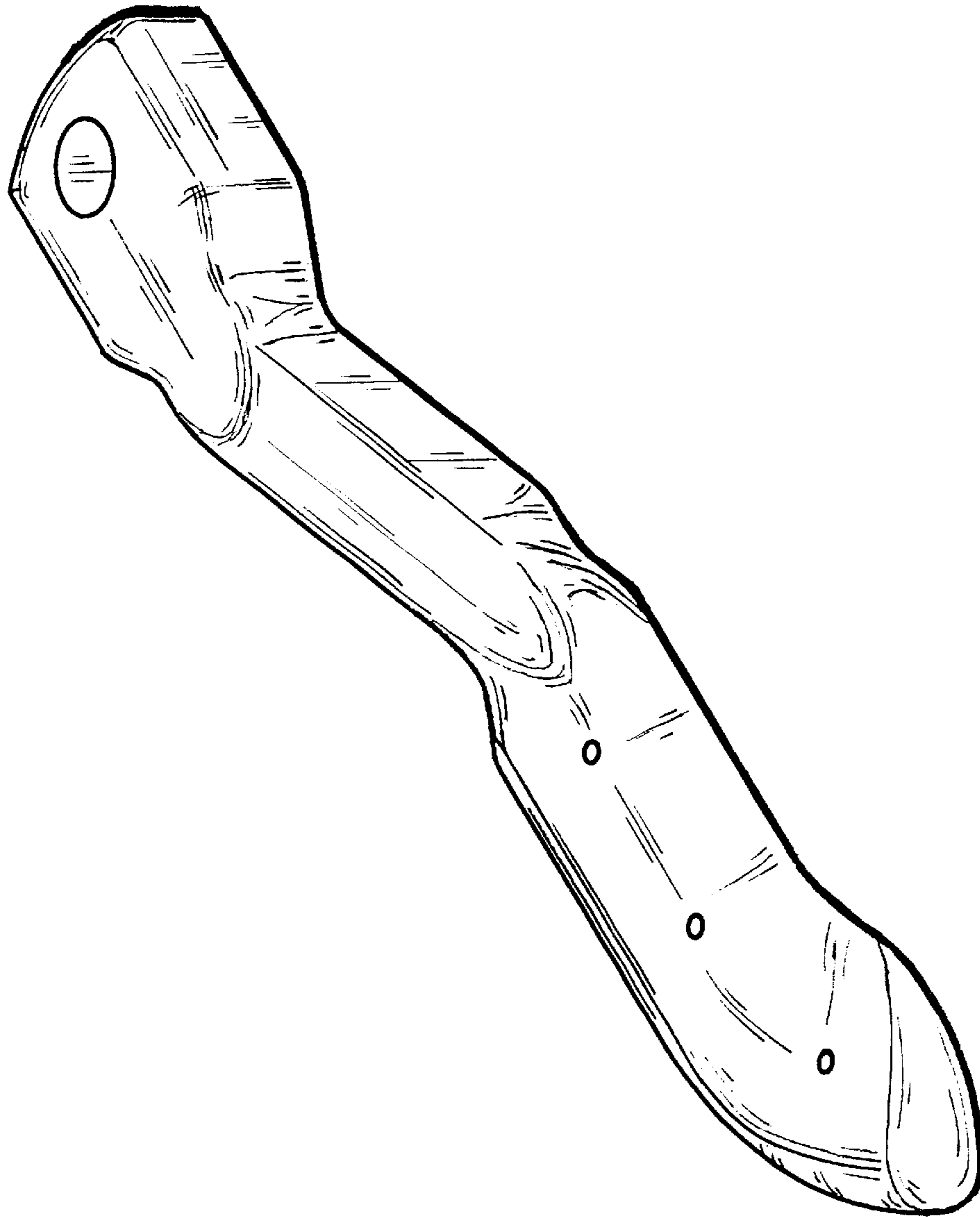

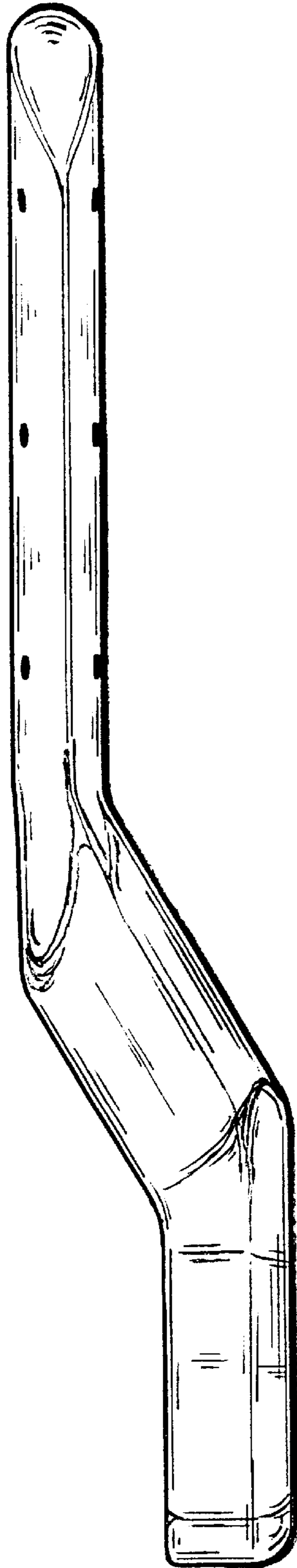

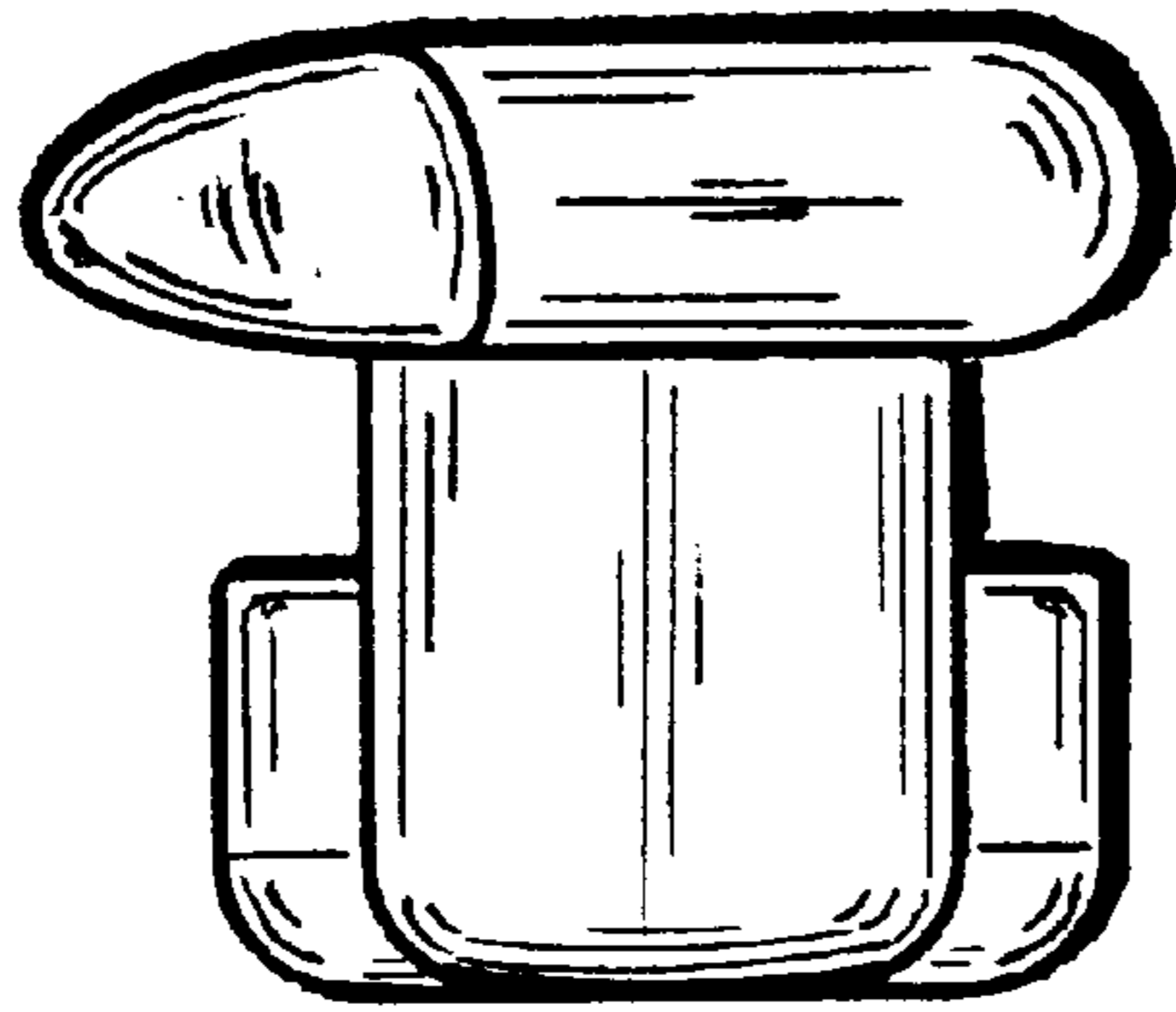

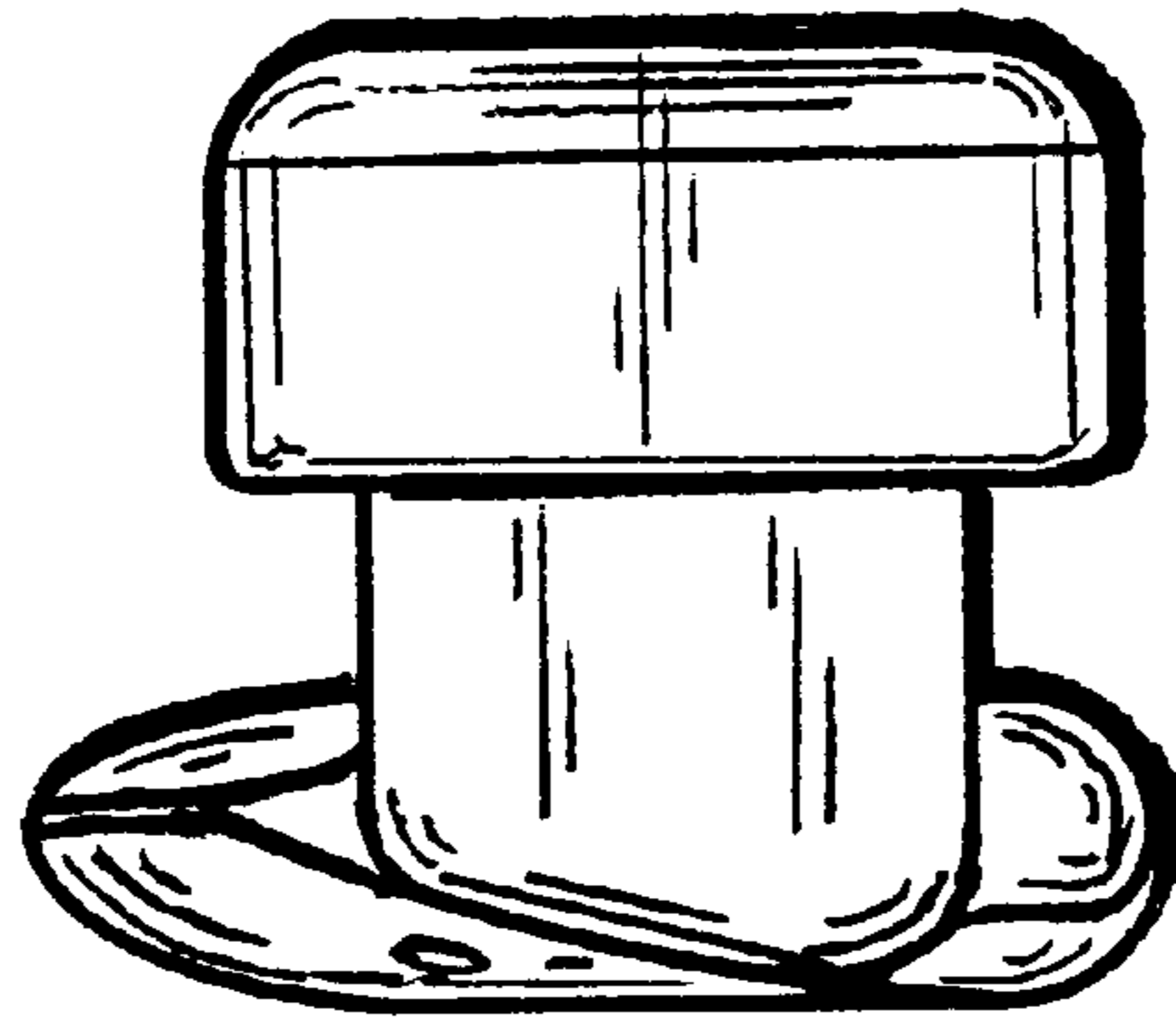

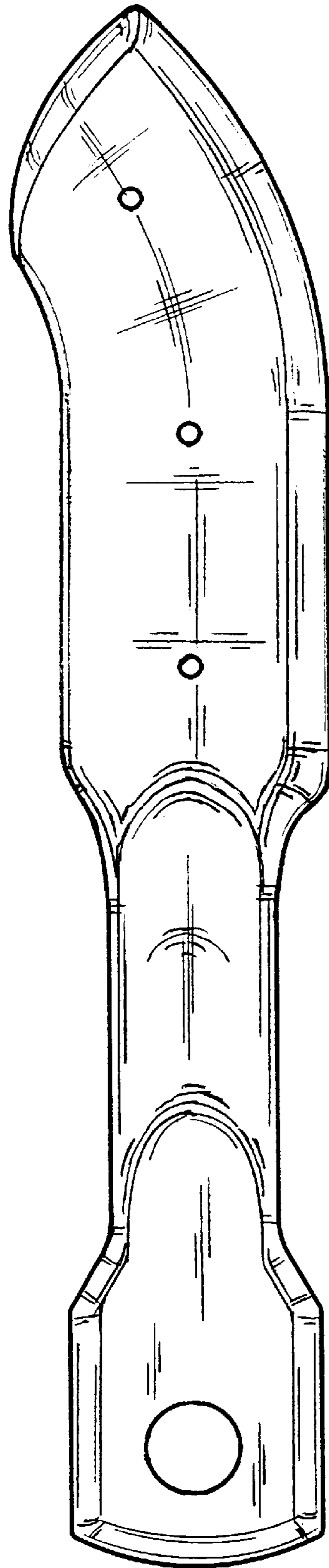

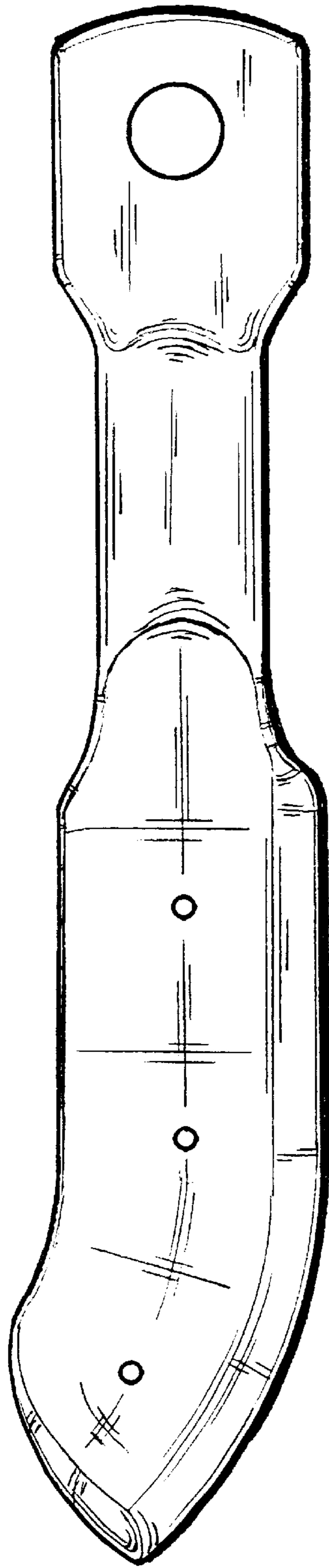
