(57) **CLAIM**

The ornamental design for a fishing rod roller guide, sub-
stantially as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of the fishing rod roller
guide showing my new design, the opposite side elevational
view being a mirror image thereof.

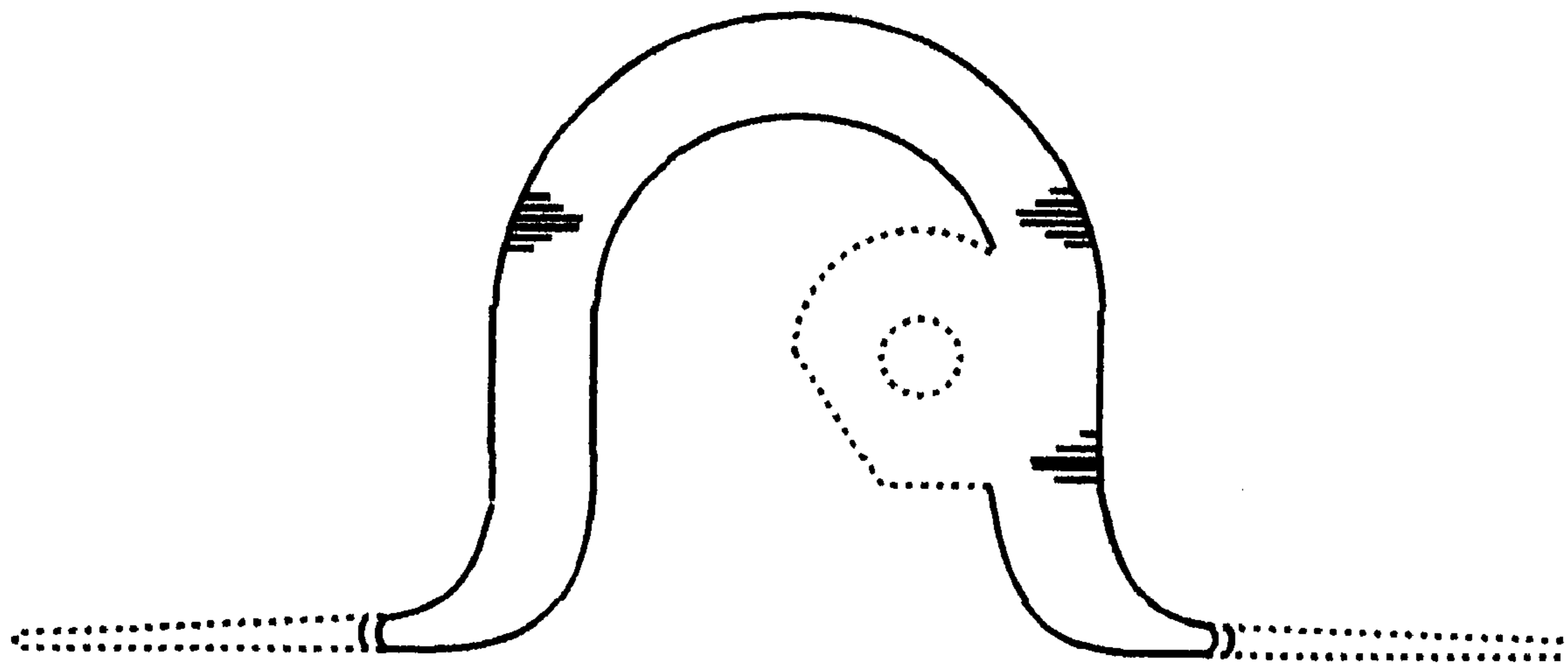
FIG. 2 is a front elevational view of the fishing rod roller

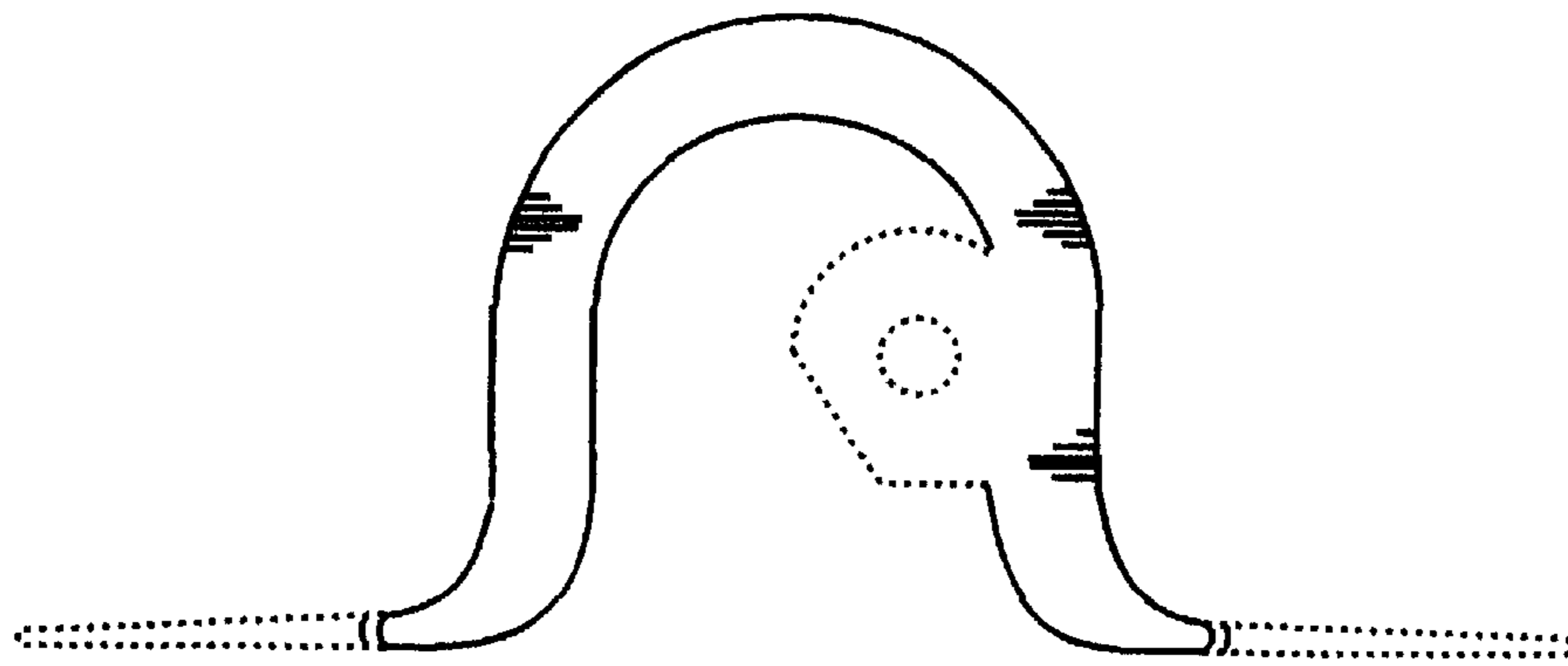

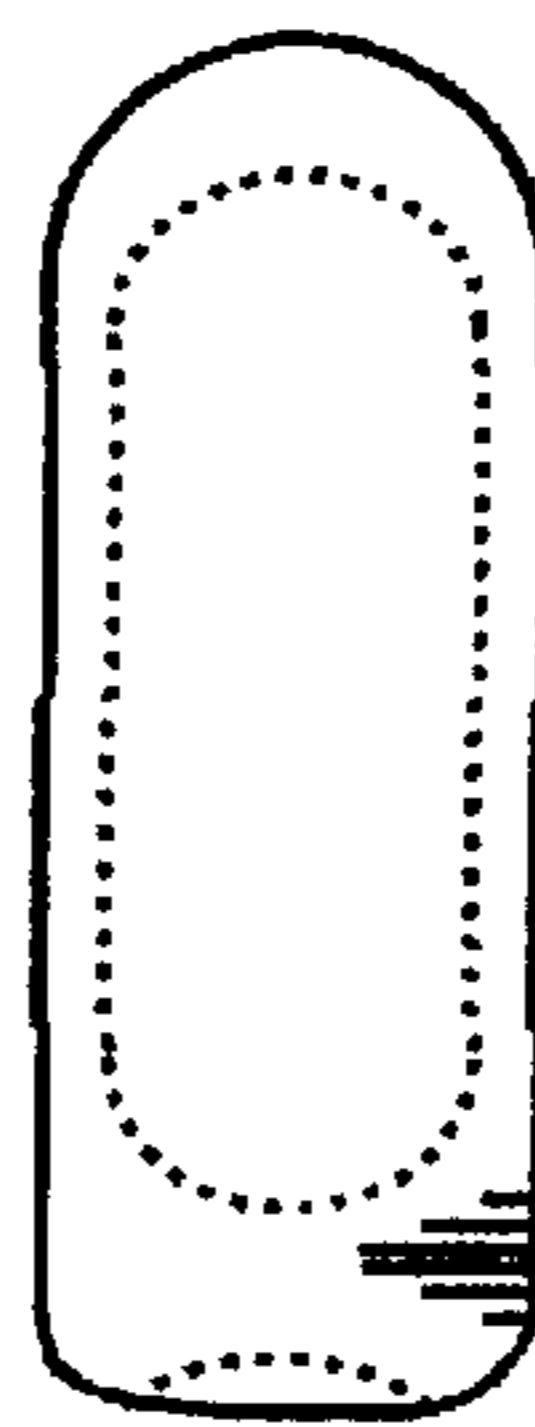

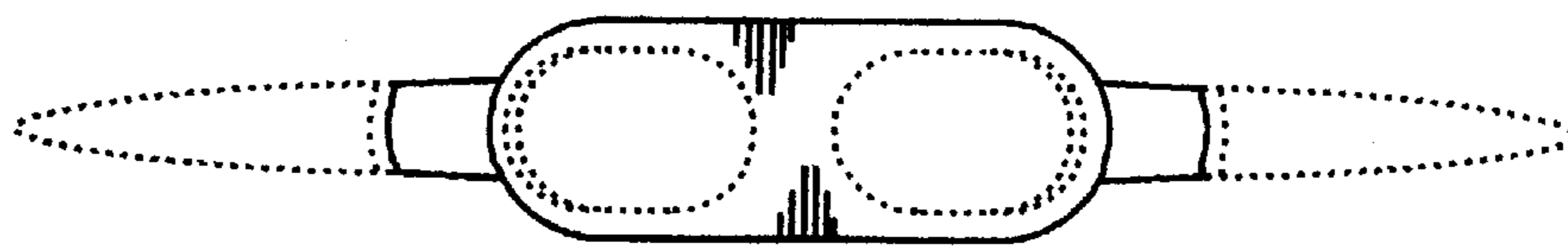

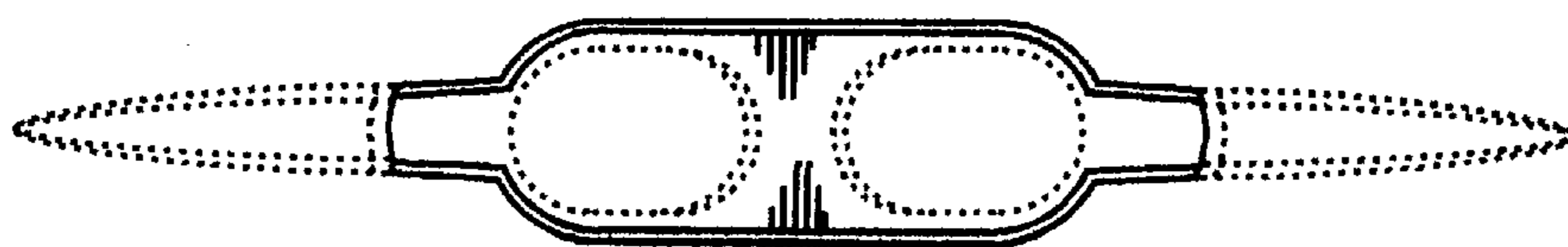
