DESCRIPTION

FIG. 4 is a bottom plan view of the lavatory of FIG. 1.

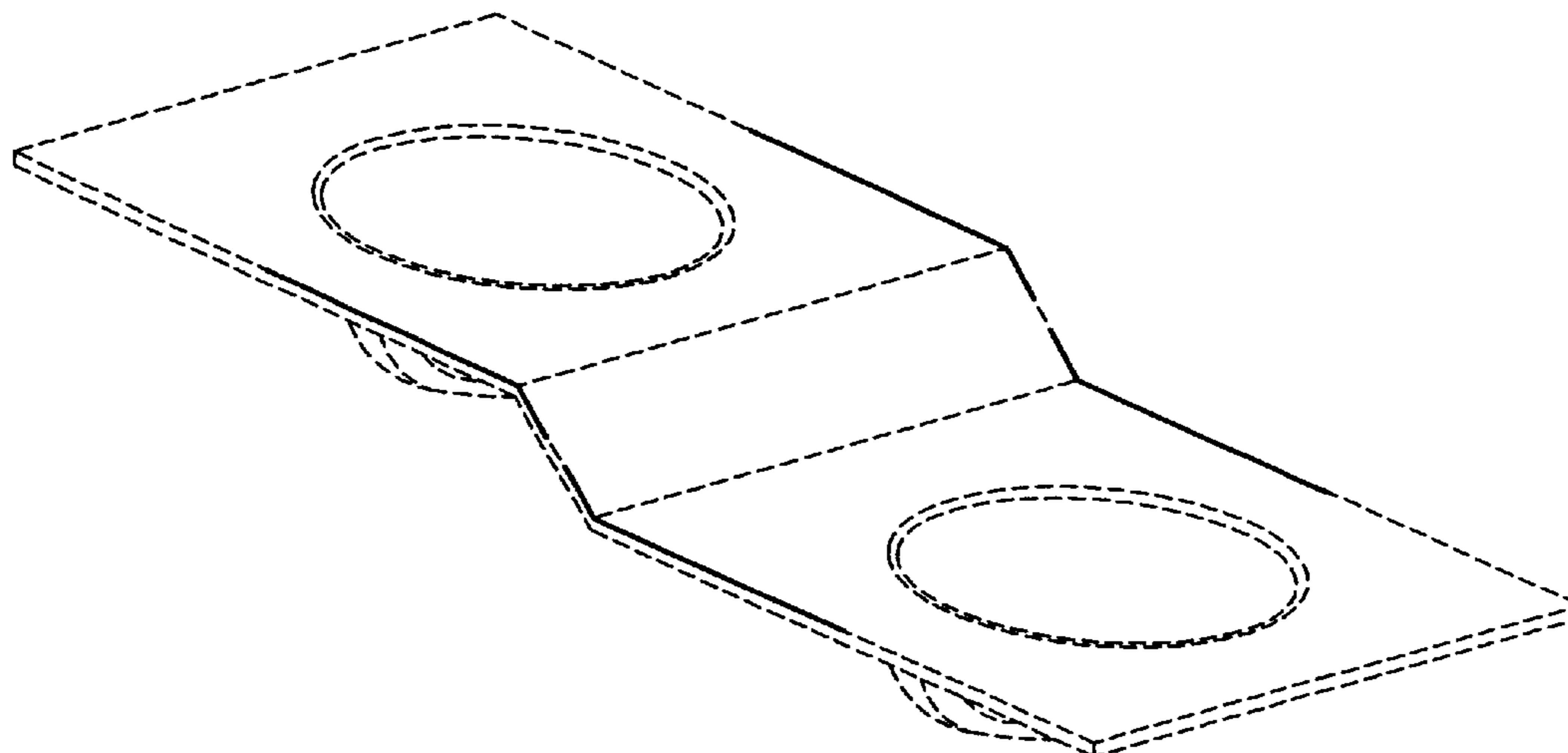
FIG. 5 is a rear elevation view of the lavatory of FIG. 1.

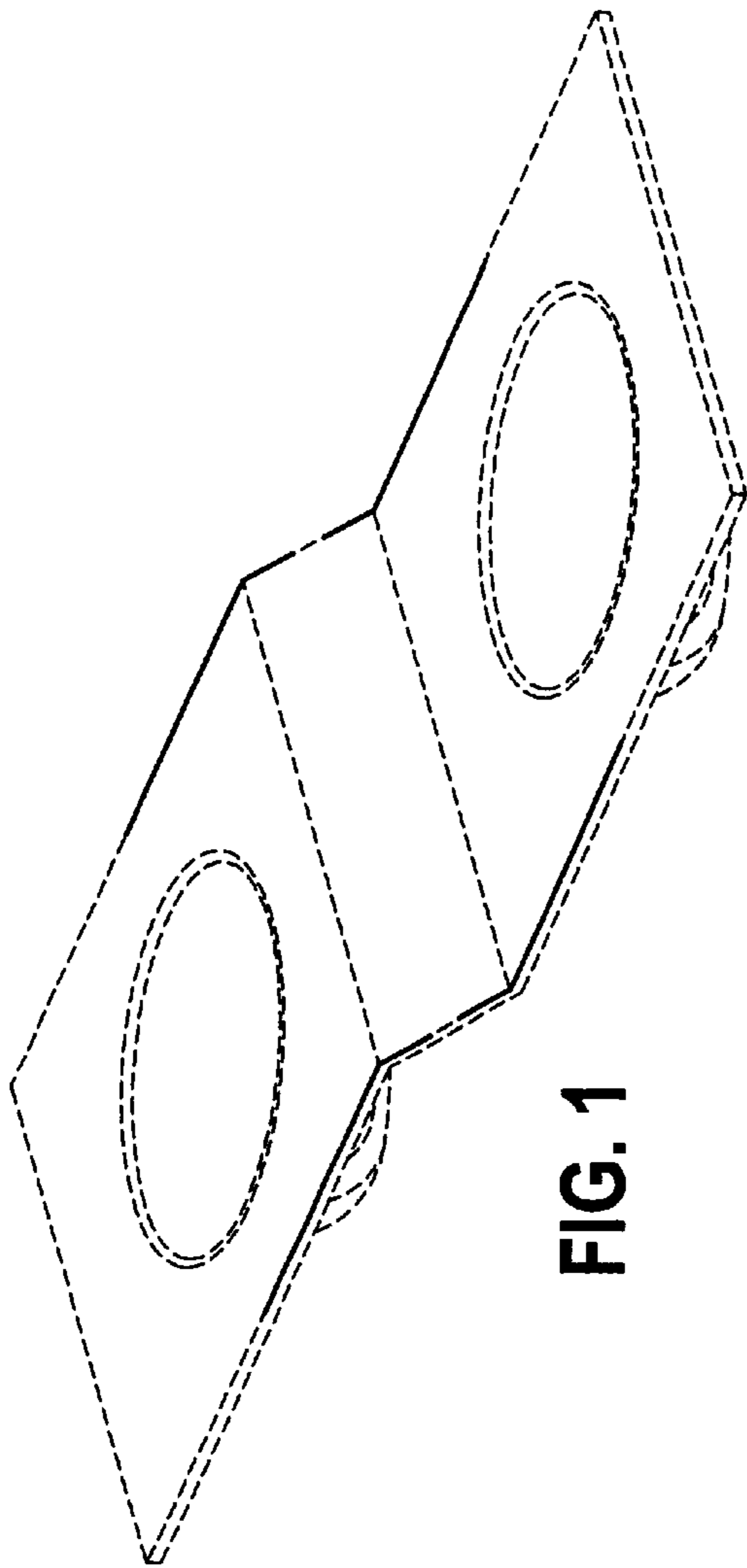

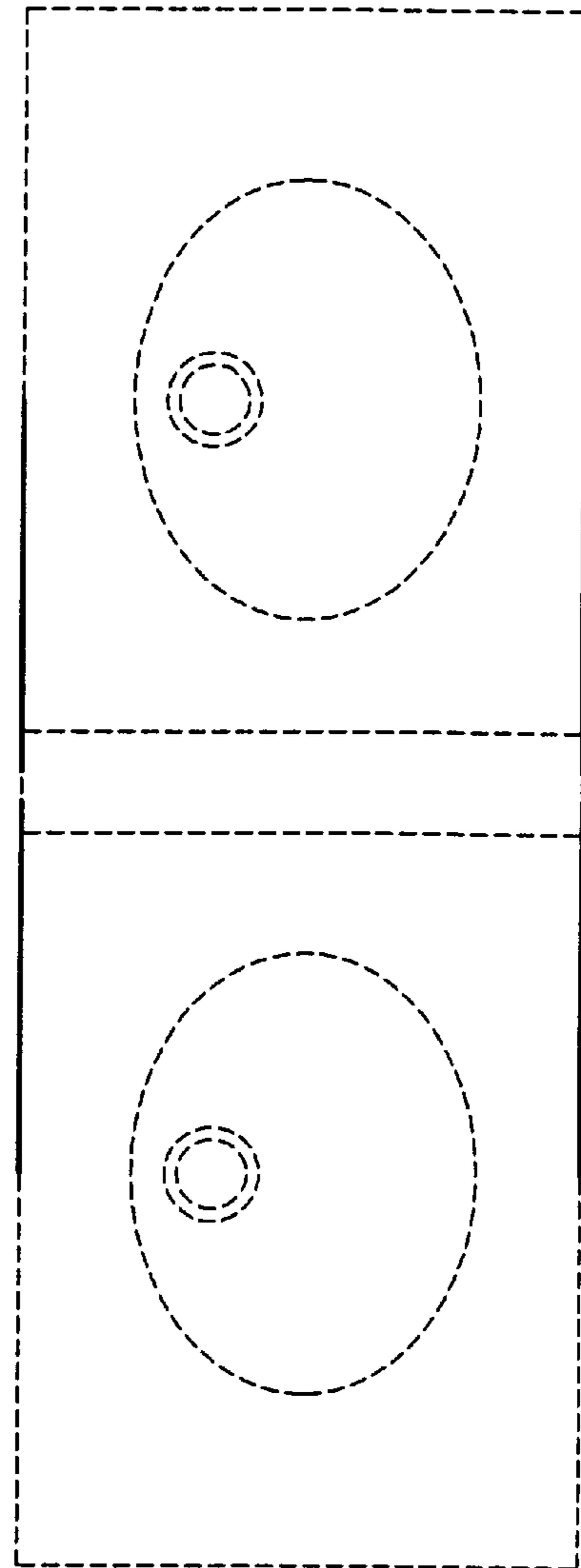

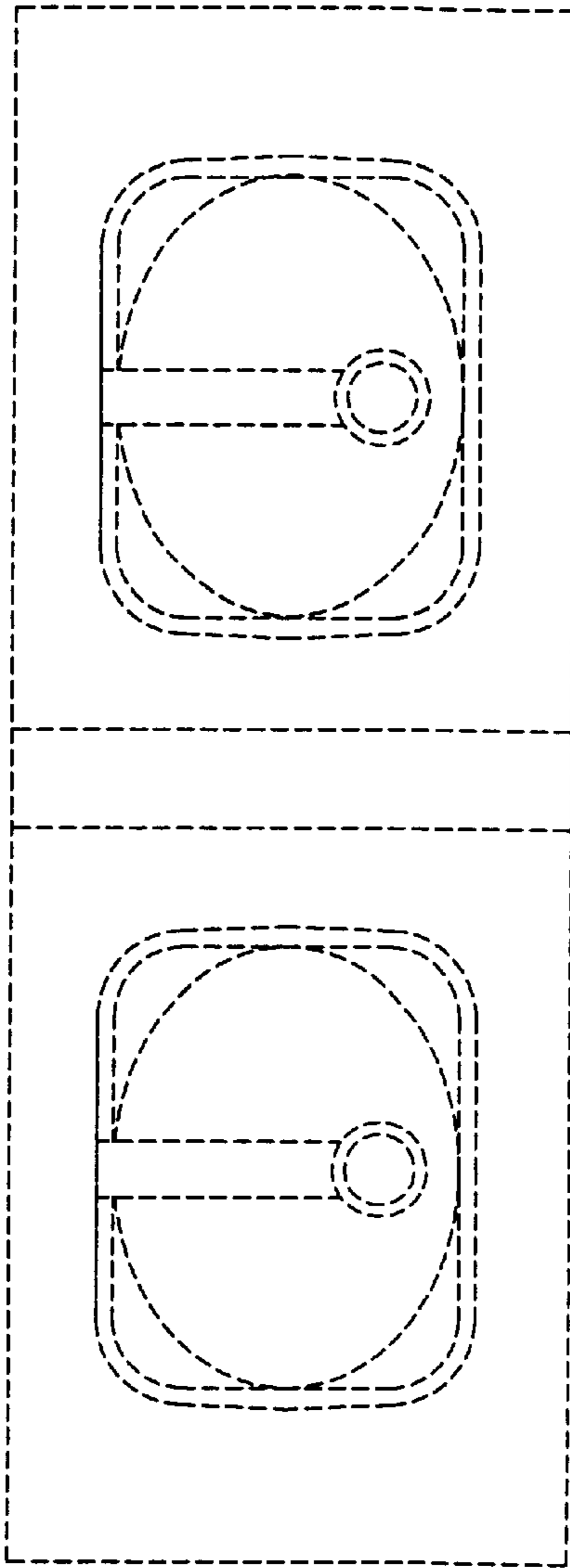

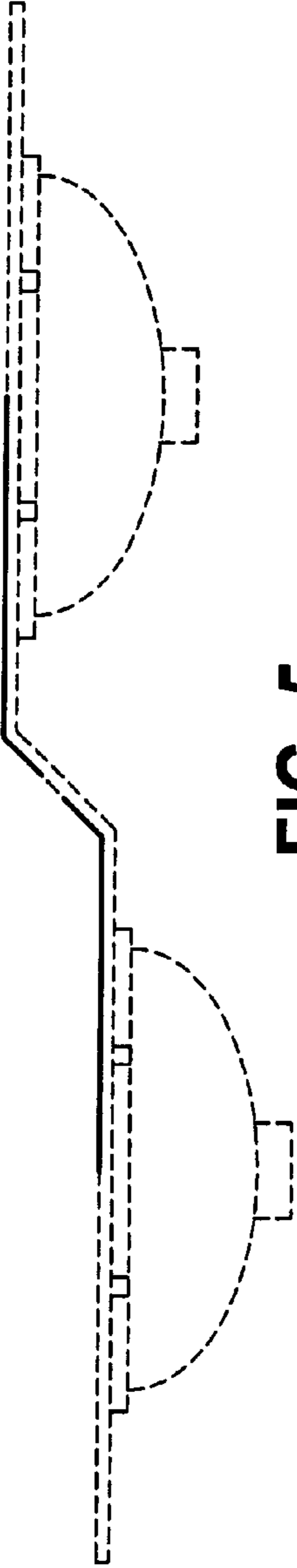

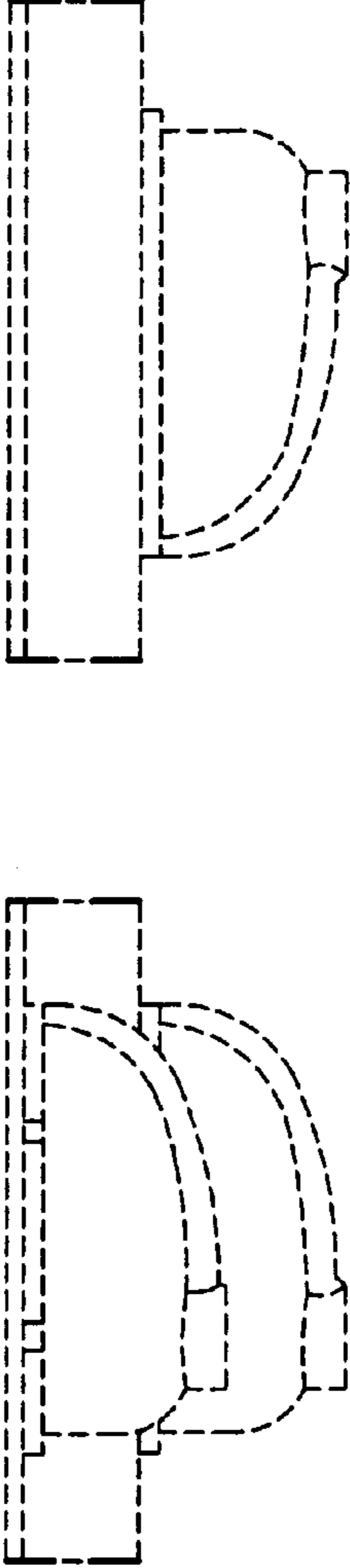
