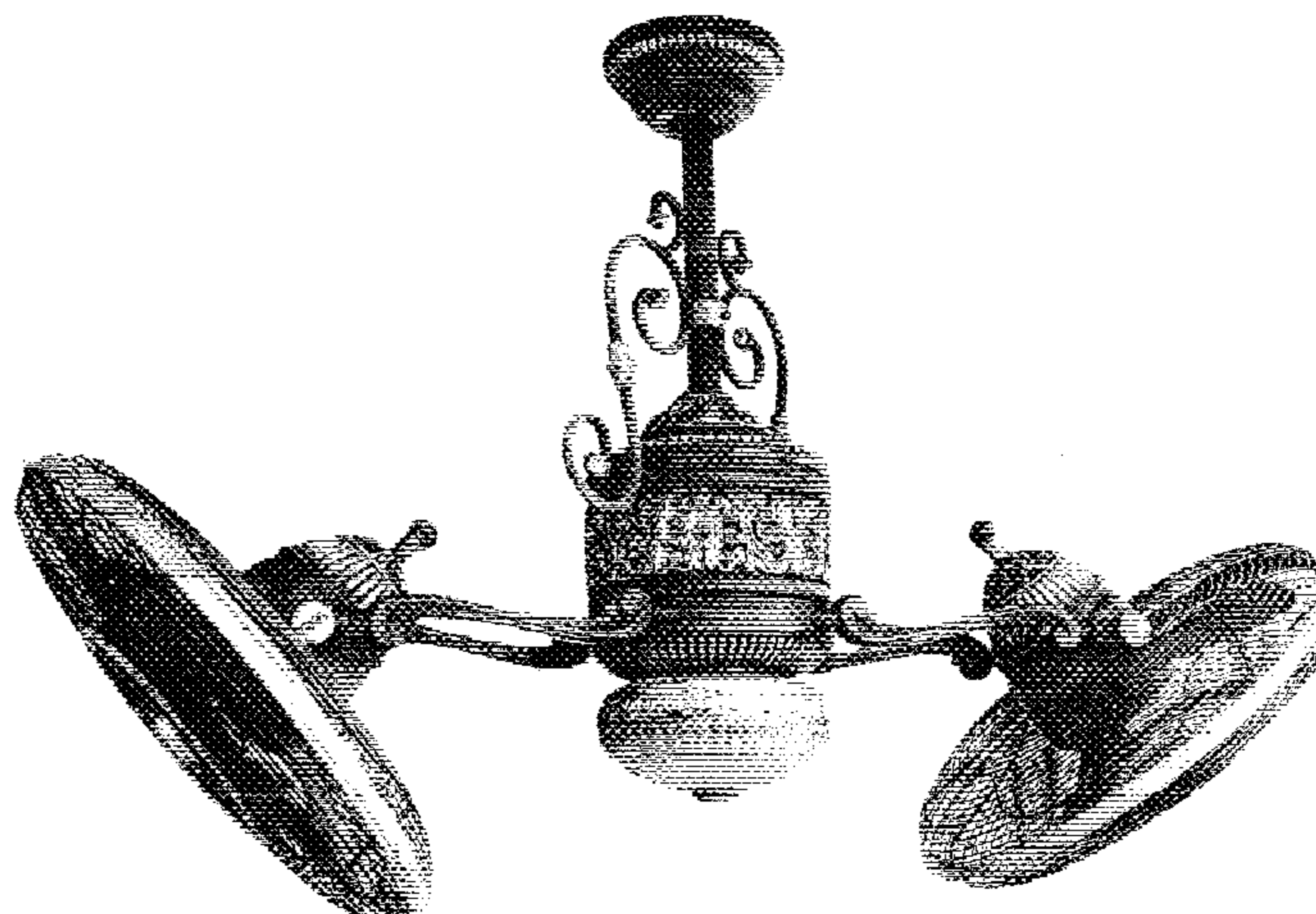
(57) **CLAIM**

The ornamental design for a combination ceiling fan and light fixture, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from below of a combination ceiling fan and light fixture in accordance with our design; FIG. 2 is a top plan view of the combination ceiling fan and light fixture in accordance with our design; FIG. 3 is a bottom plan view of the combination ceiling fan and light fixture in accordance with our design; FIG. 4 is a side elevation view of the combination ceiling fan and light fixture in accordance with our design, the opposite side being a mirror image of that shown; and, FIG. 5 is a front perspective view from below of the combination ceiling fan and light fixture in accordance with our design.

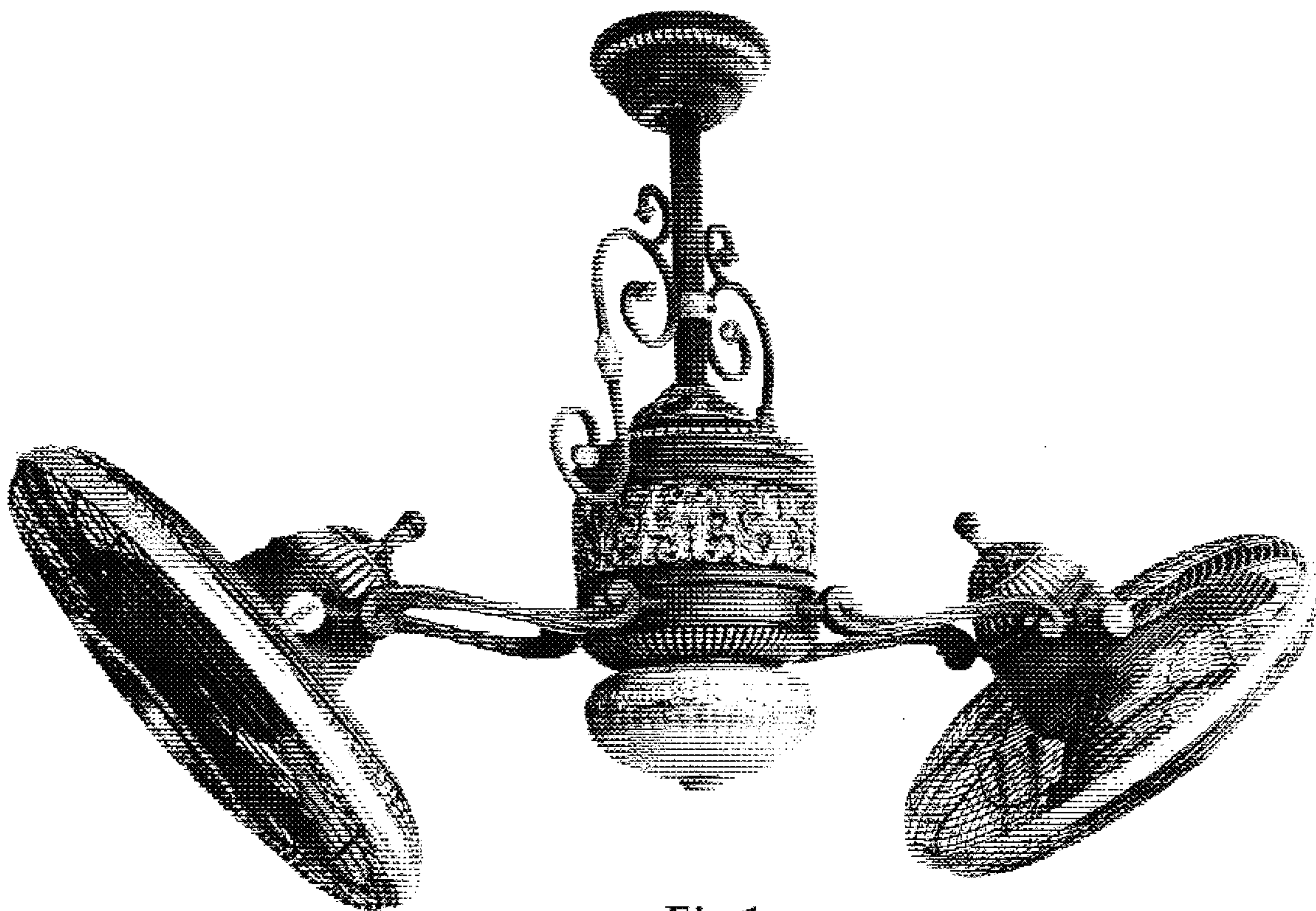

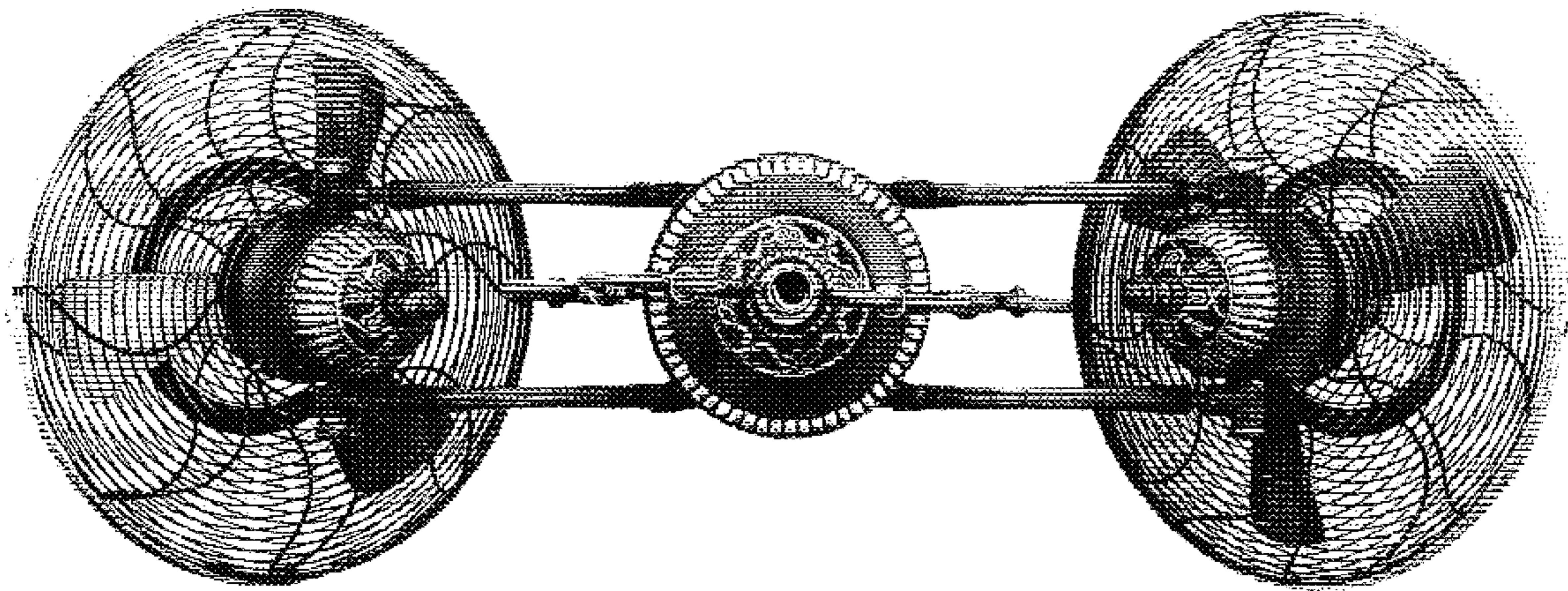

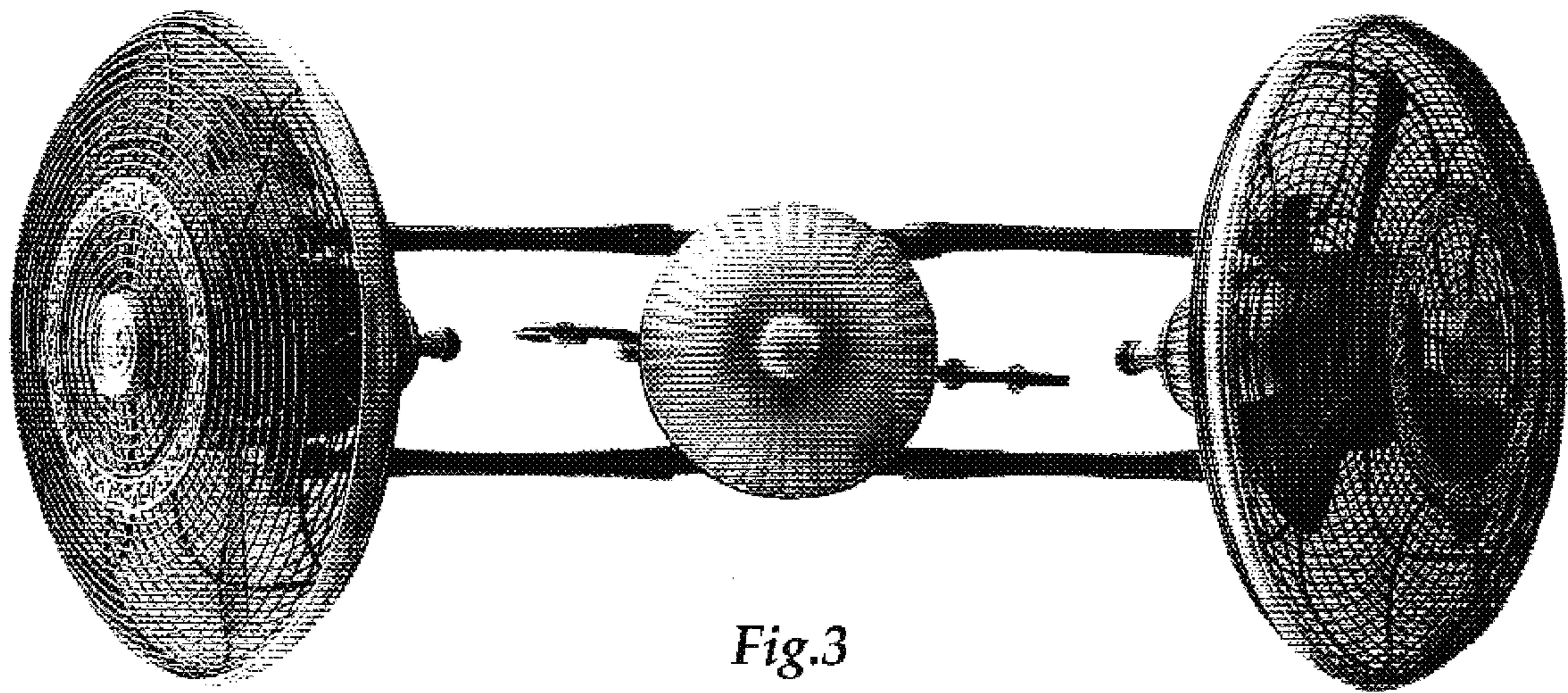

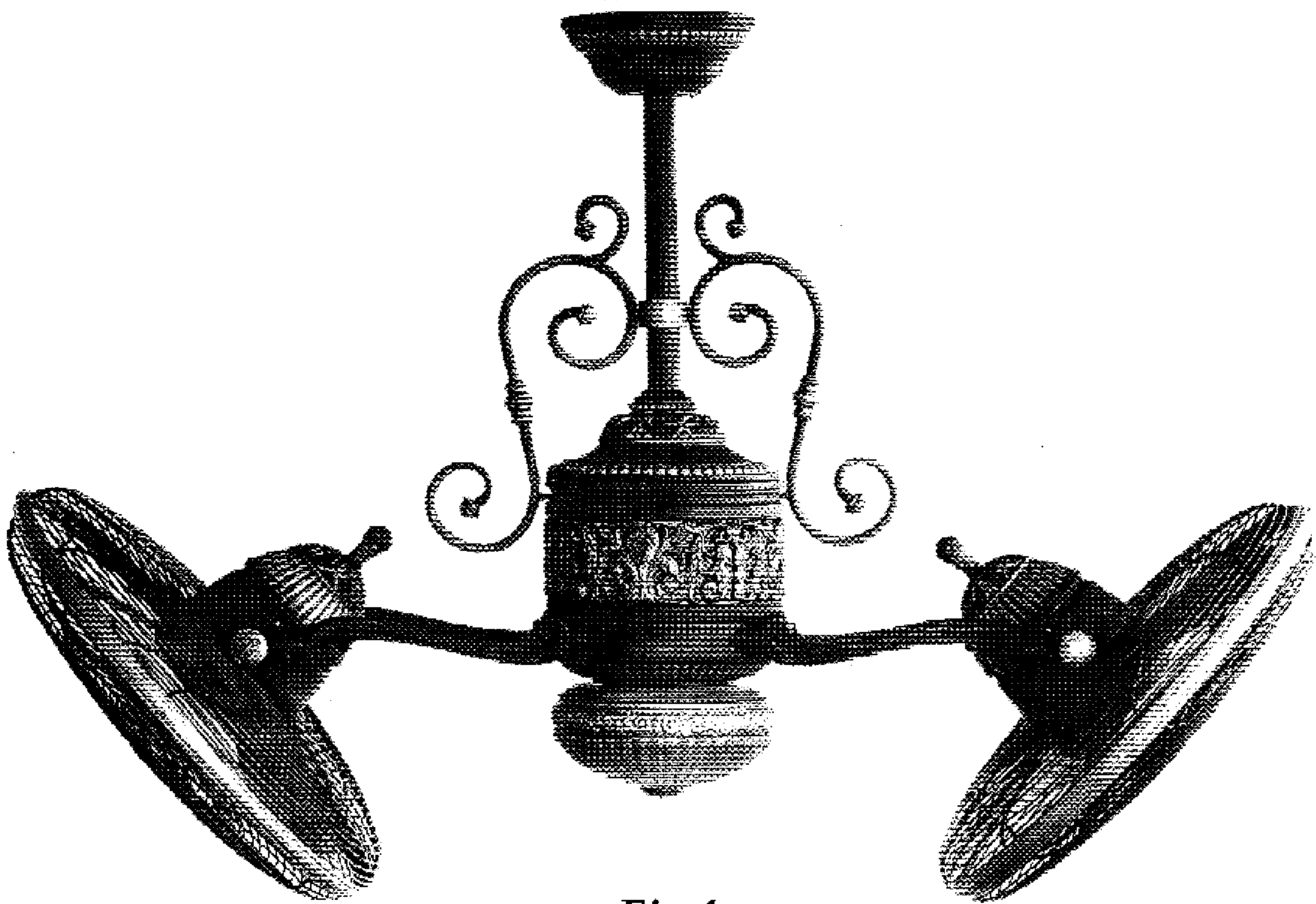
