**DESCRIPTION**

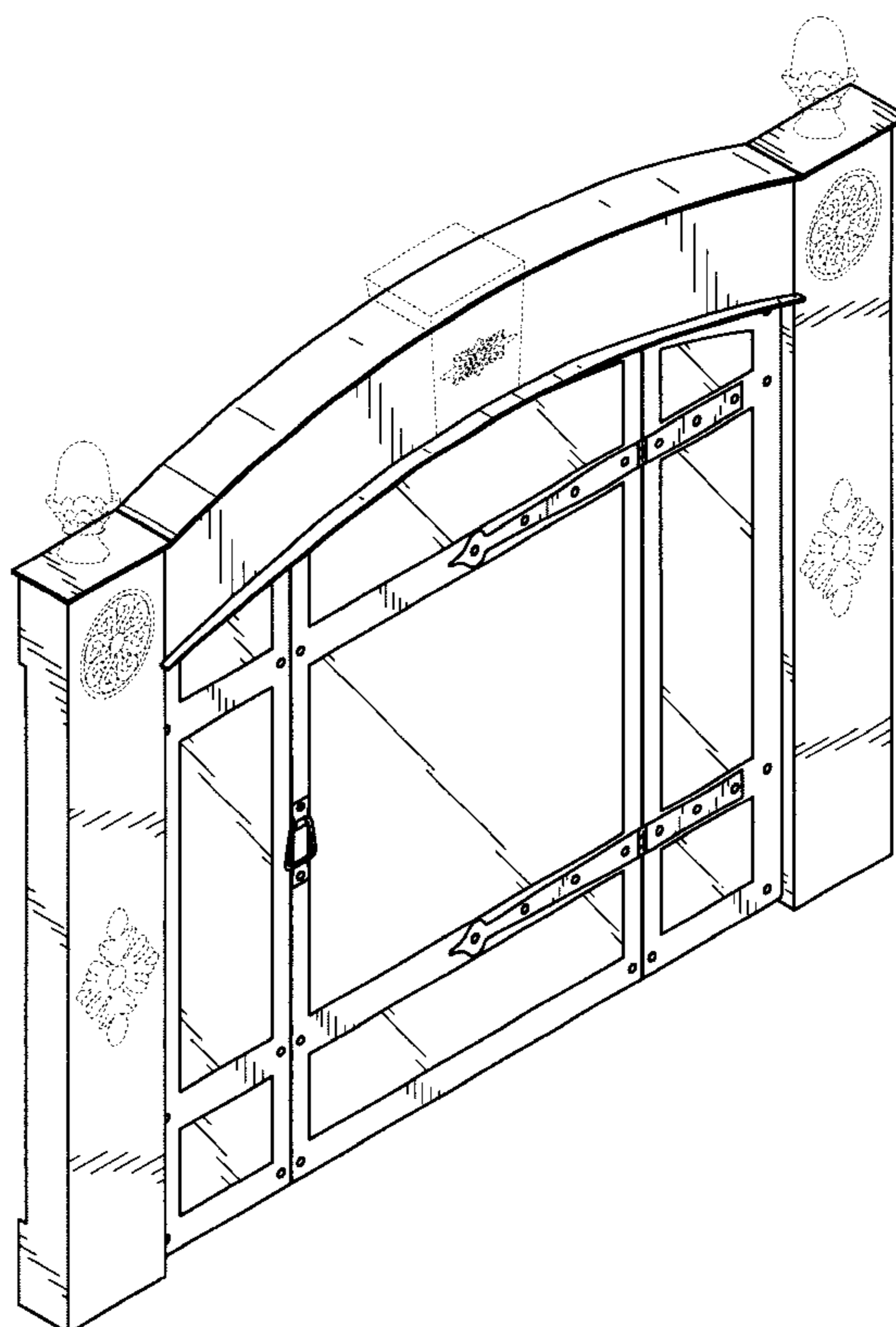
FIG. 1 is a perspective view depicting a new design for a decorative fireplace, with no claim being made to the bottom or rear of the fireplace;

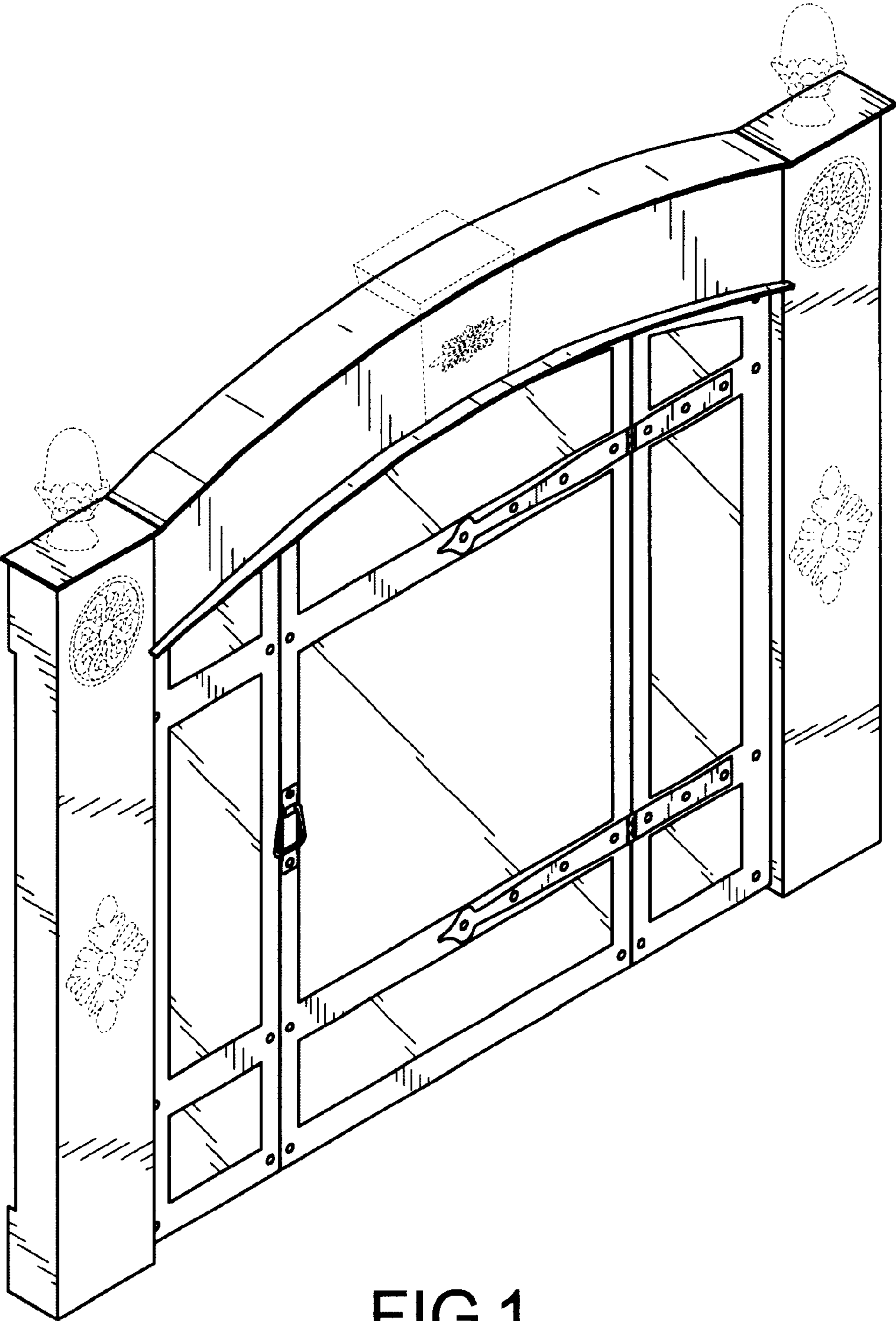

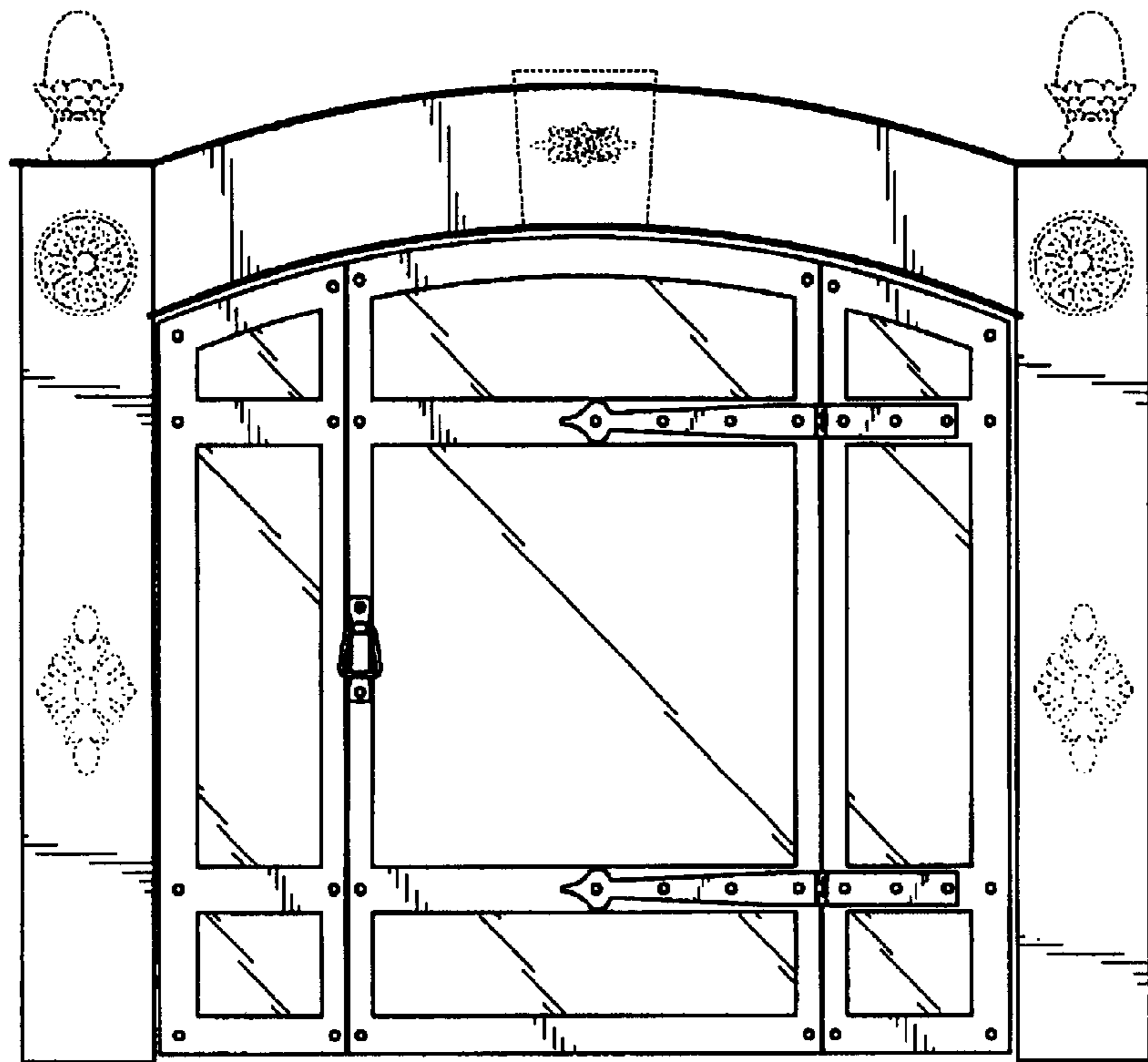

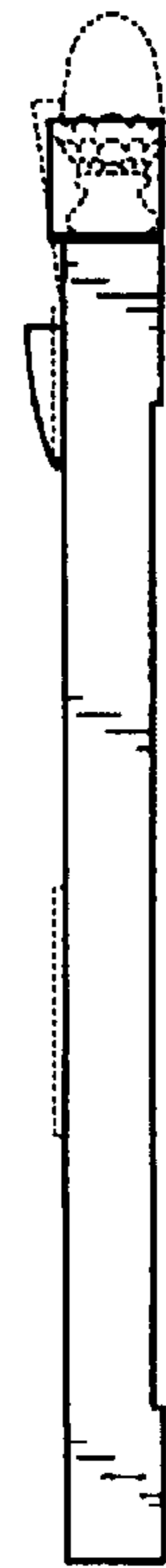
