**DESCRIPTION**

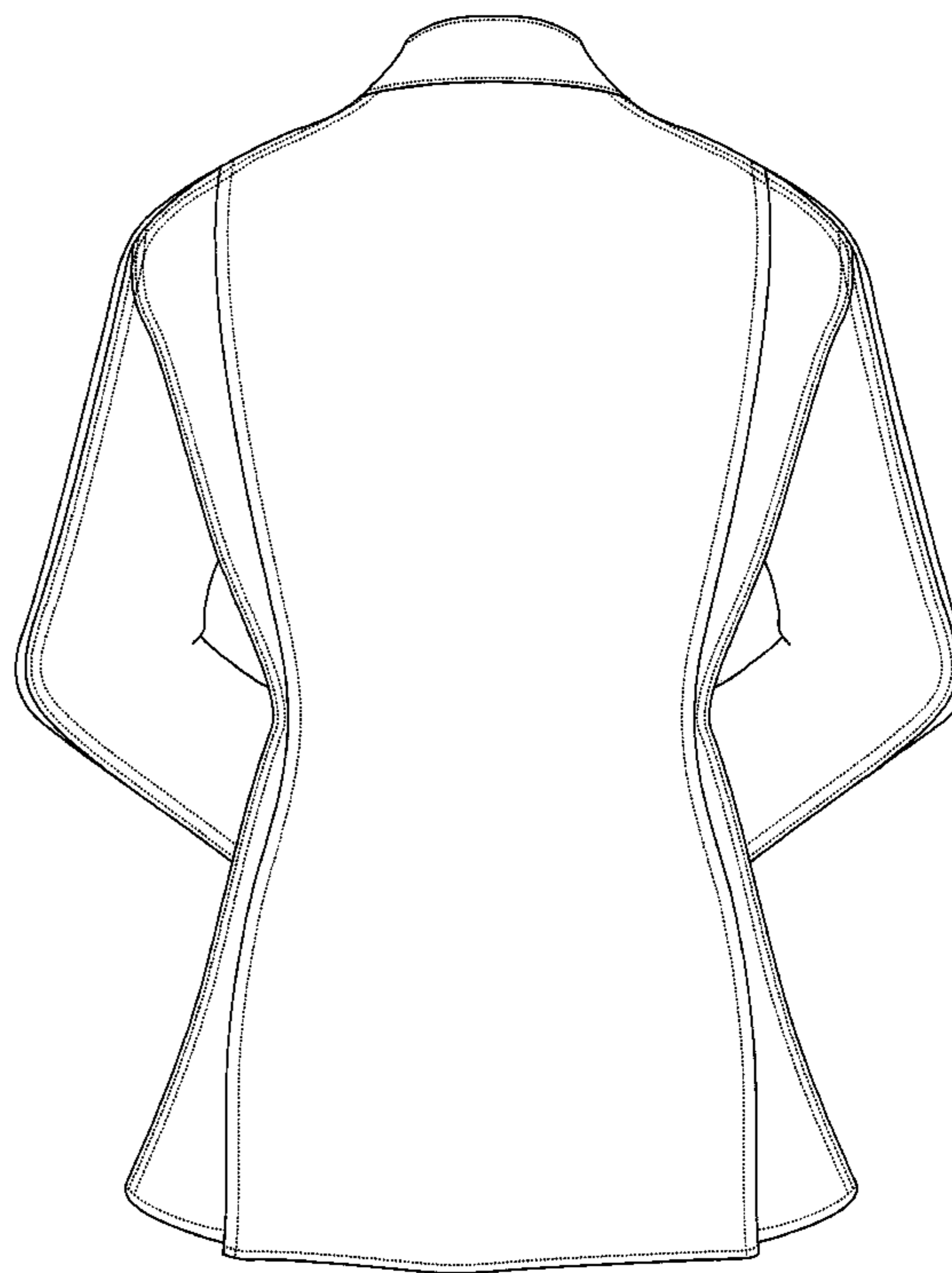
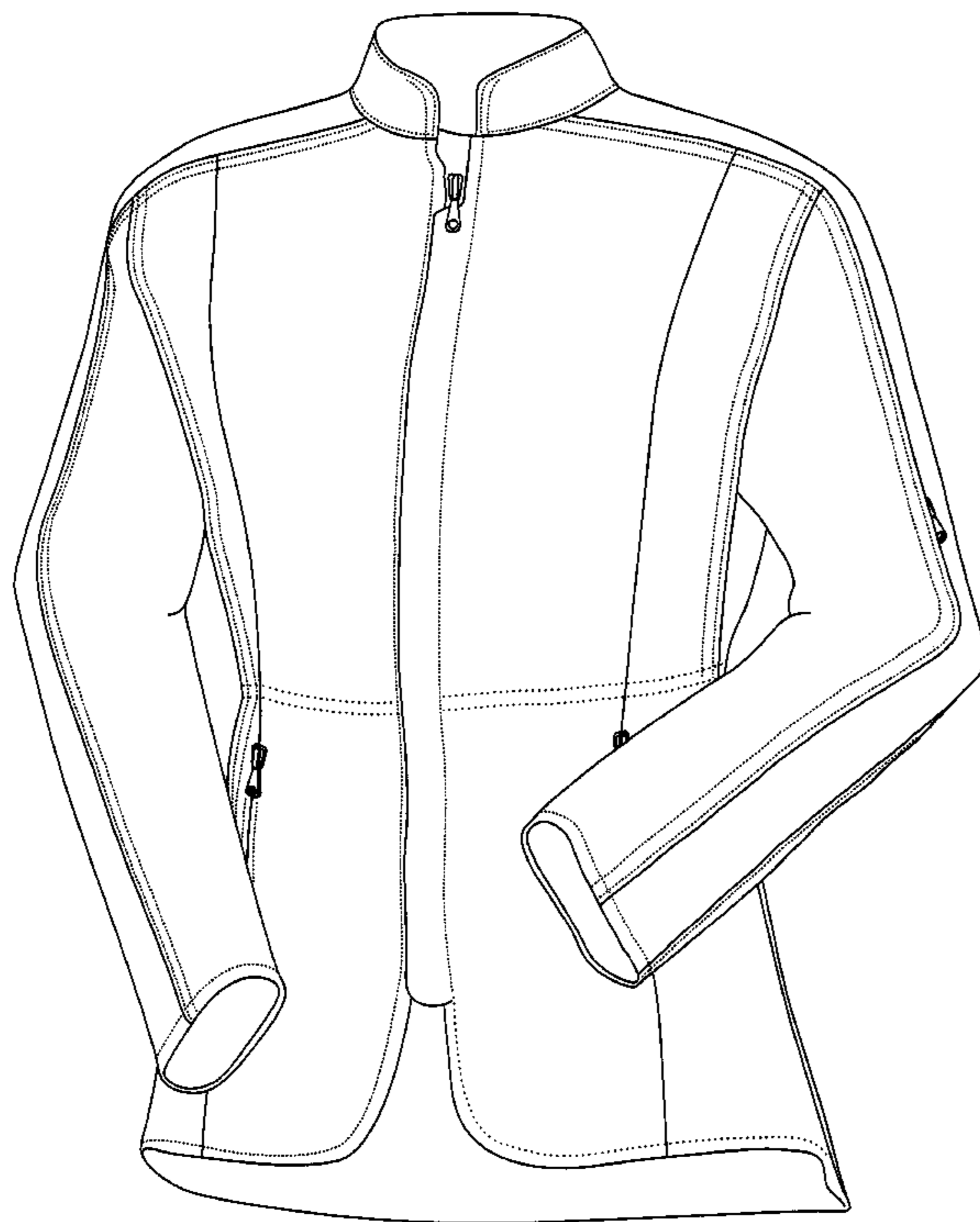
FIG. 1 is a front view of an equestrian riding coat showing my new design;

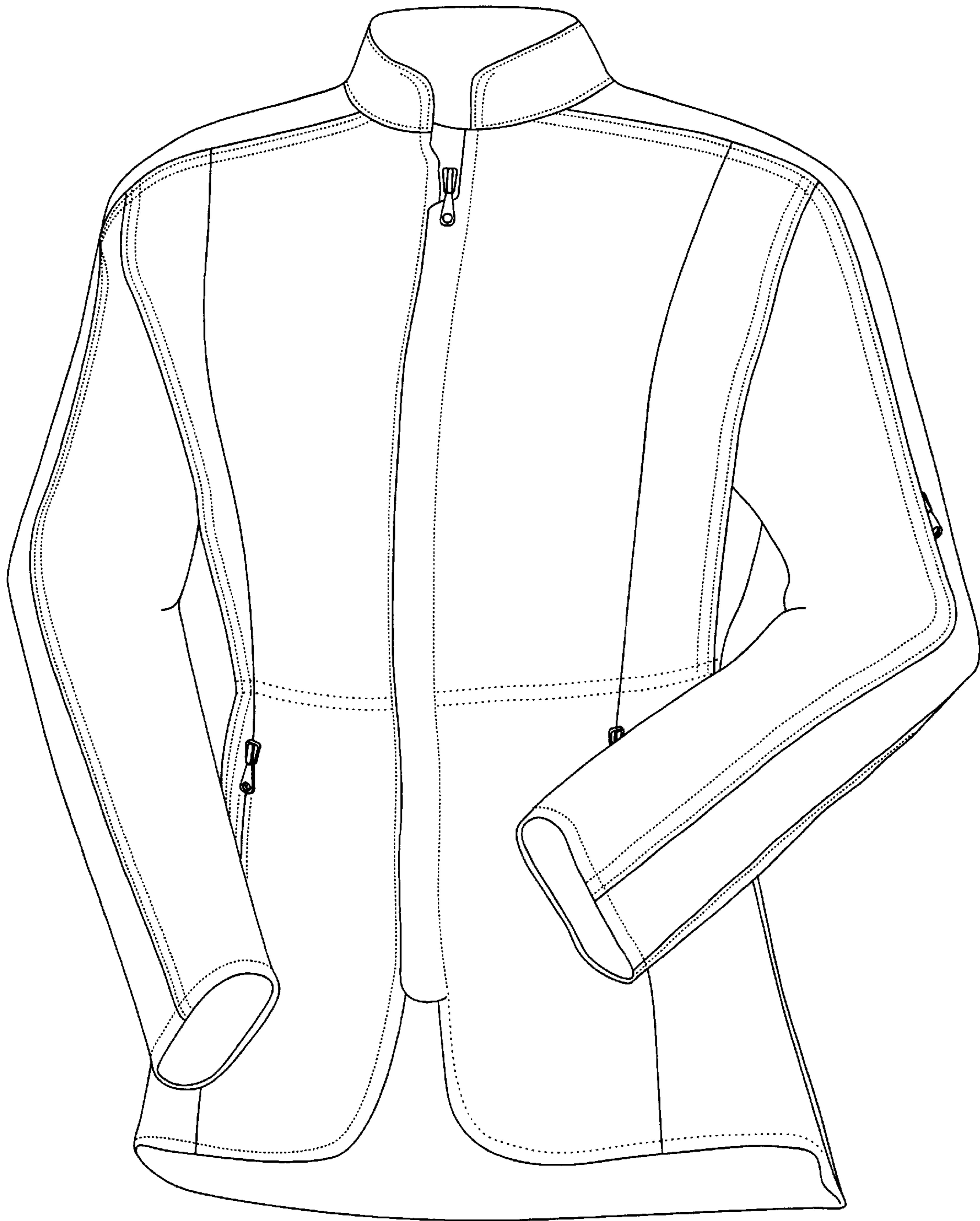

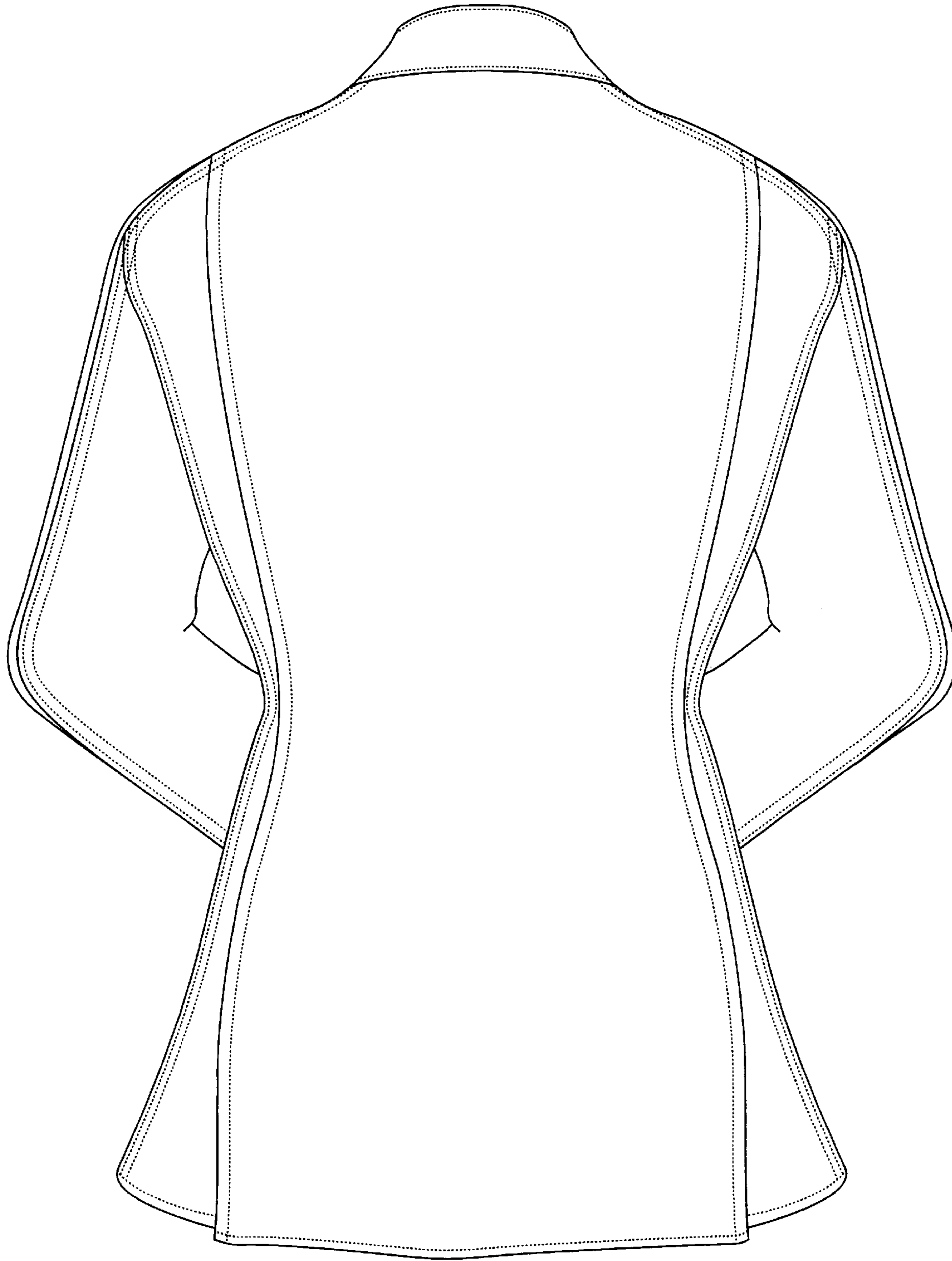

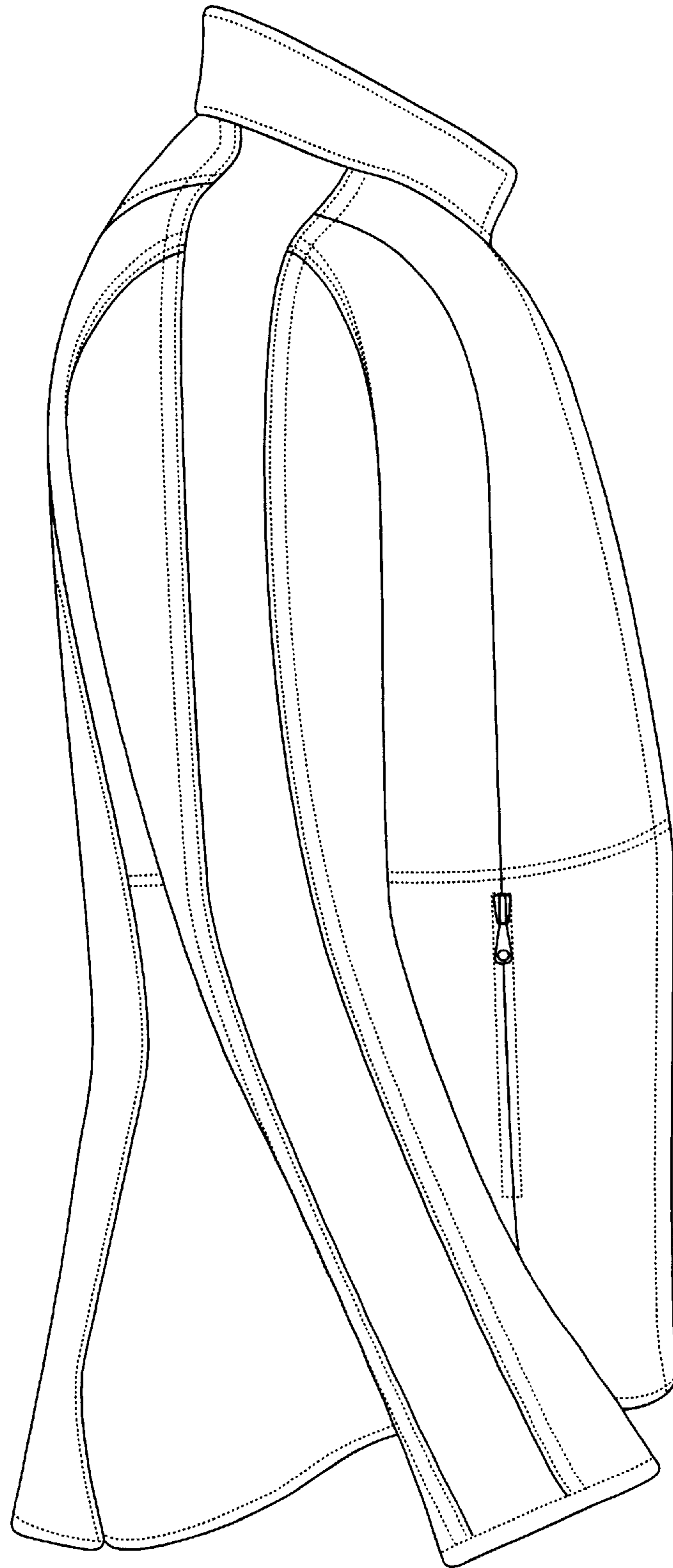
