(57) **CLAIM**

The ornamental design for an adult feeding apron, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an adult feeding apron showing my new design in use; the broken lines showing the human form do not form part of the claim;

FIG. 2 is a perspective view of the front side of the apron, illustrating two front pockets and attachment means; thereof;

FIG. 3 is a perspective view of the rear side of the apron, illustrating the attachment means; thereof;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

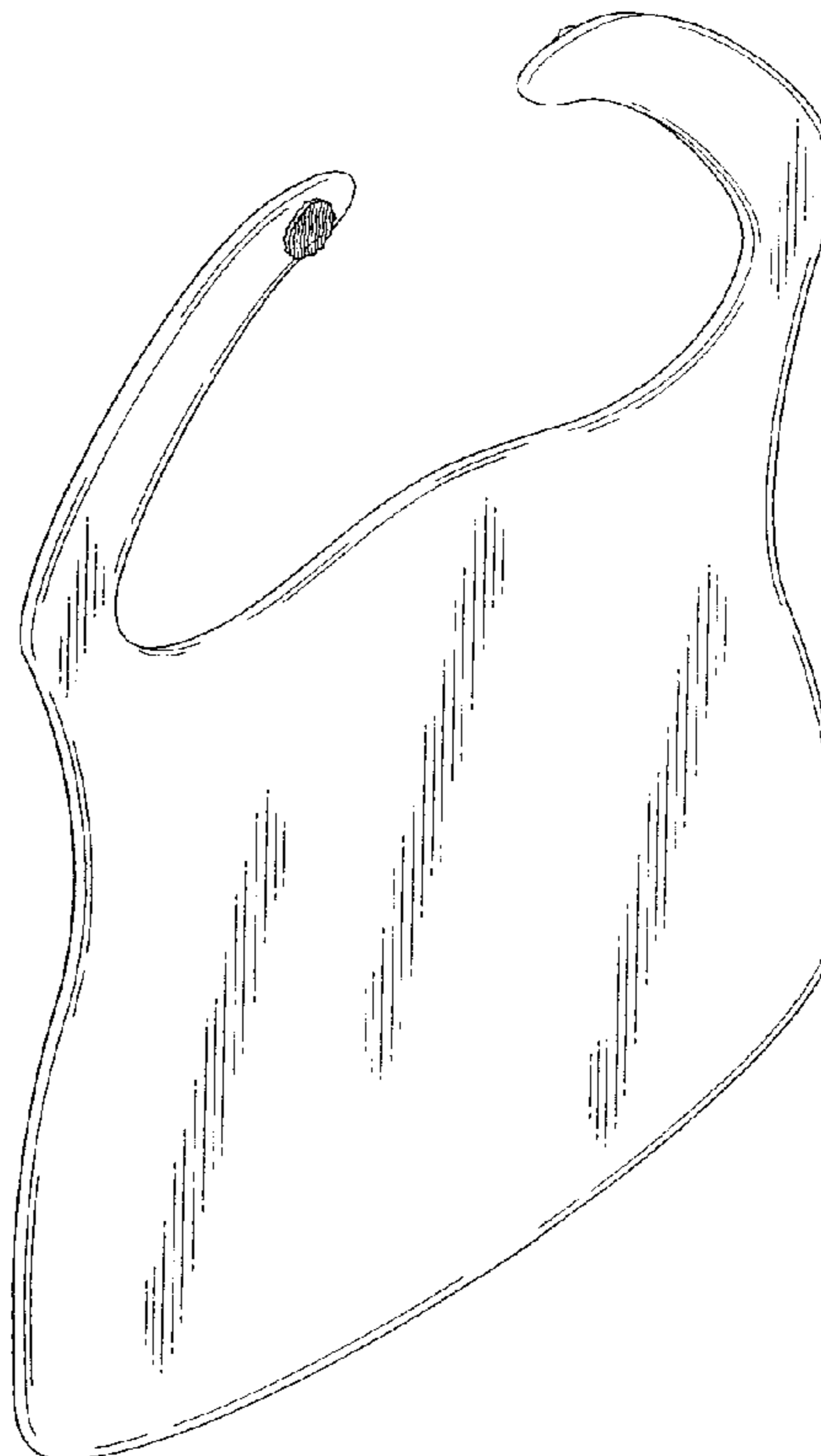
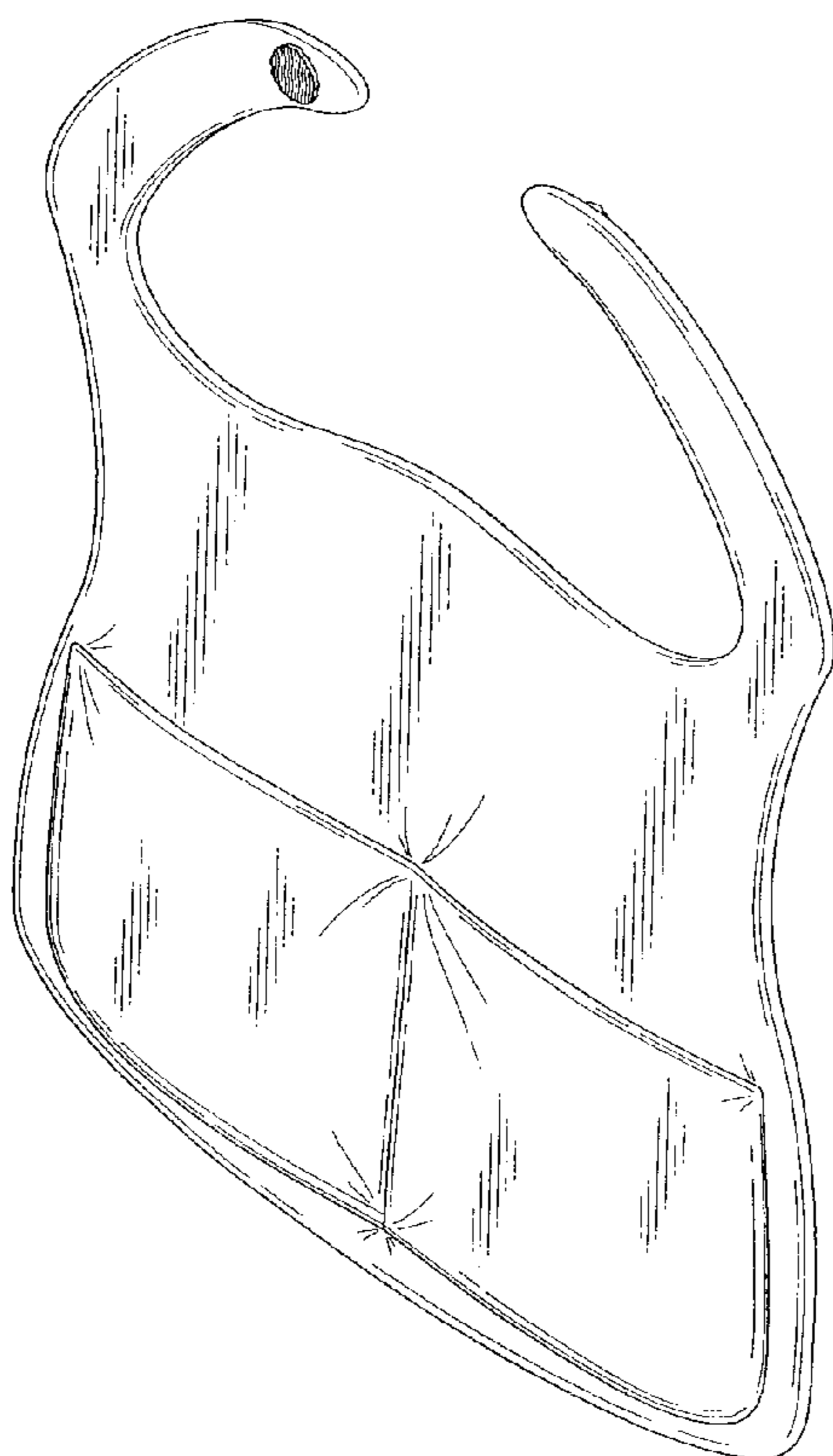

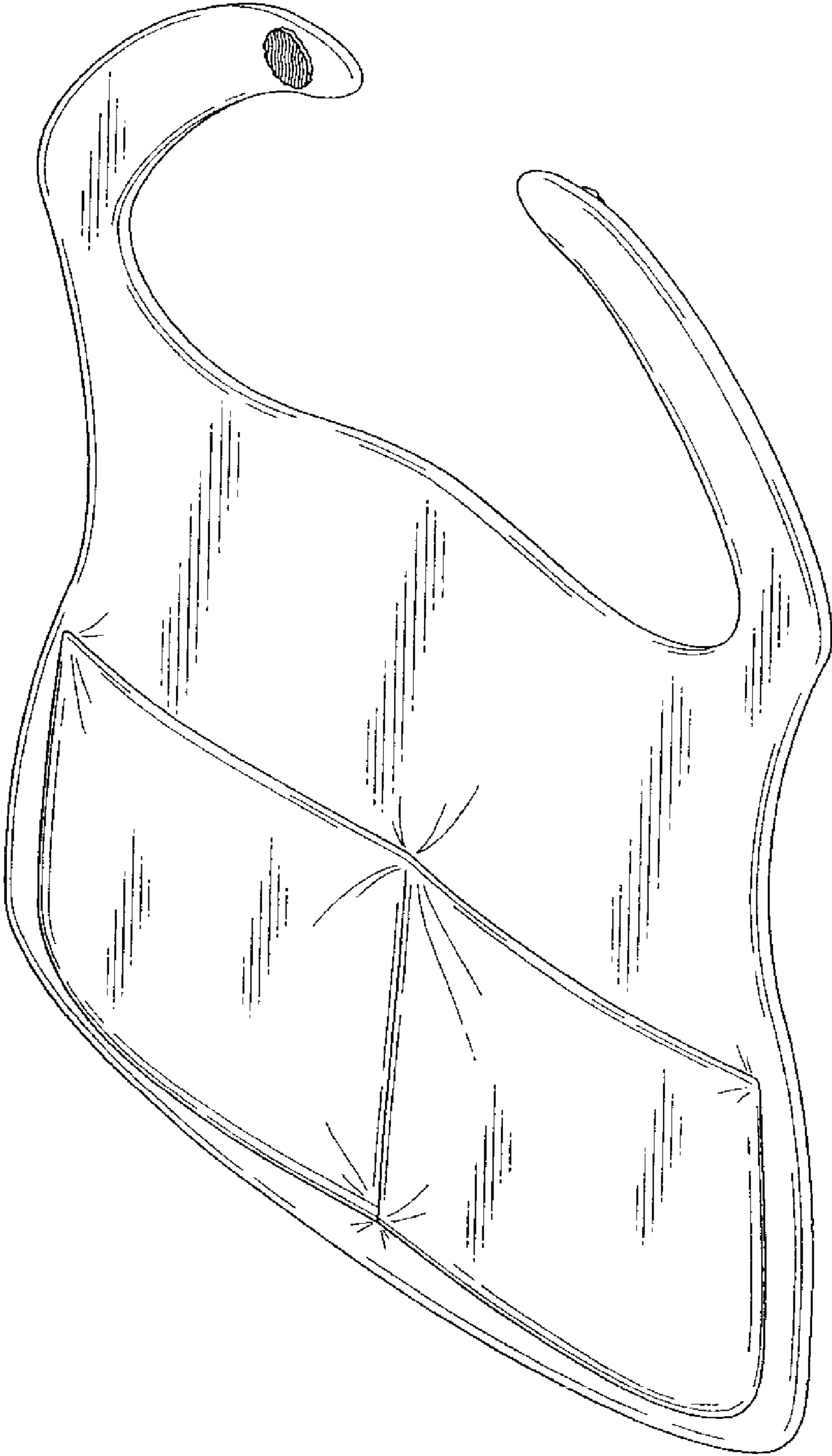

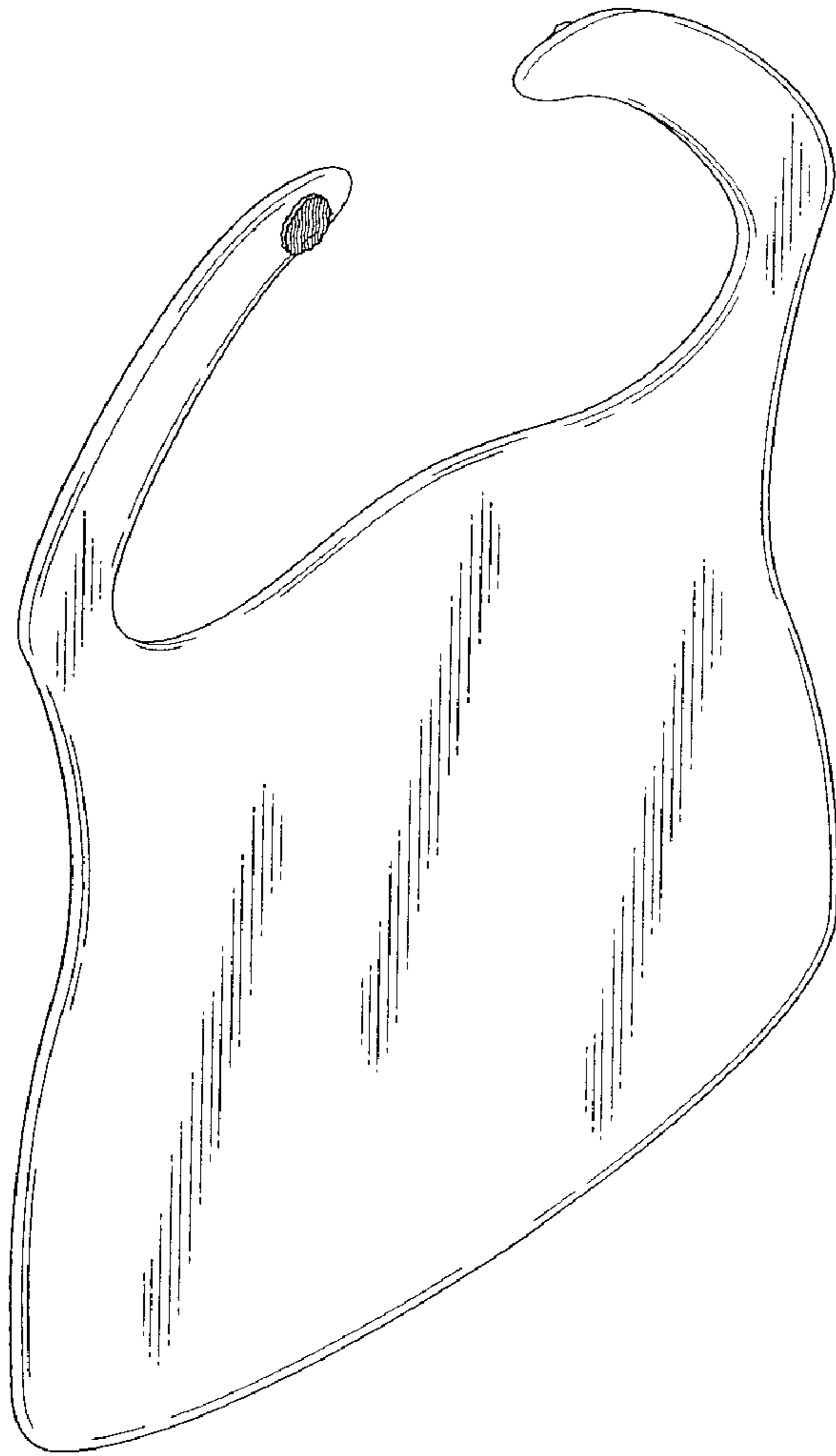
