The ornamental design for a toothbrush, as shown.

DESCRIPTION

FIG. 1 is a right side view of a first embodiment of a toothbrush showing my new design;

FIG. 10 is a rear view of FIG. 8;

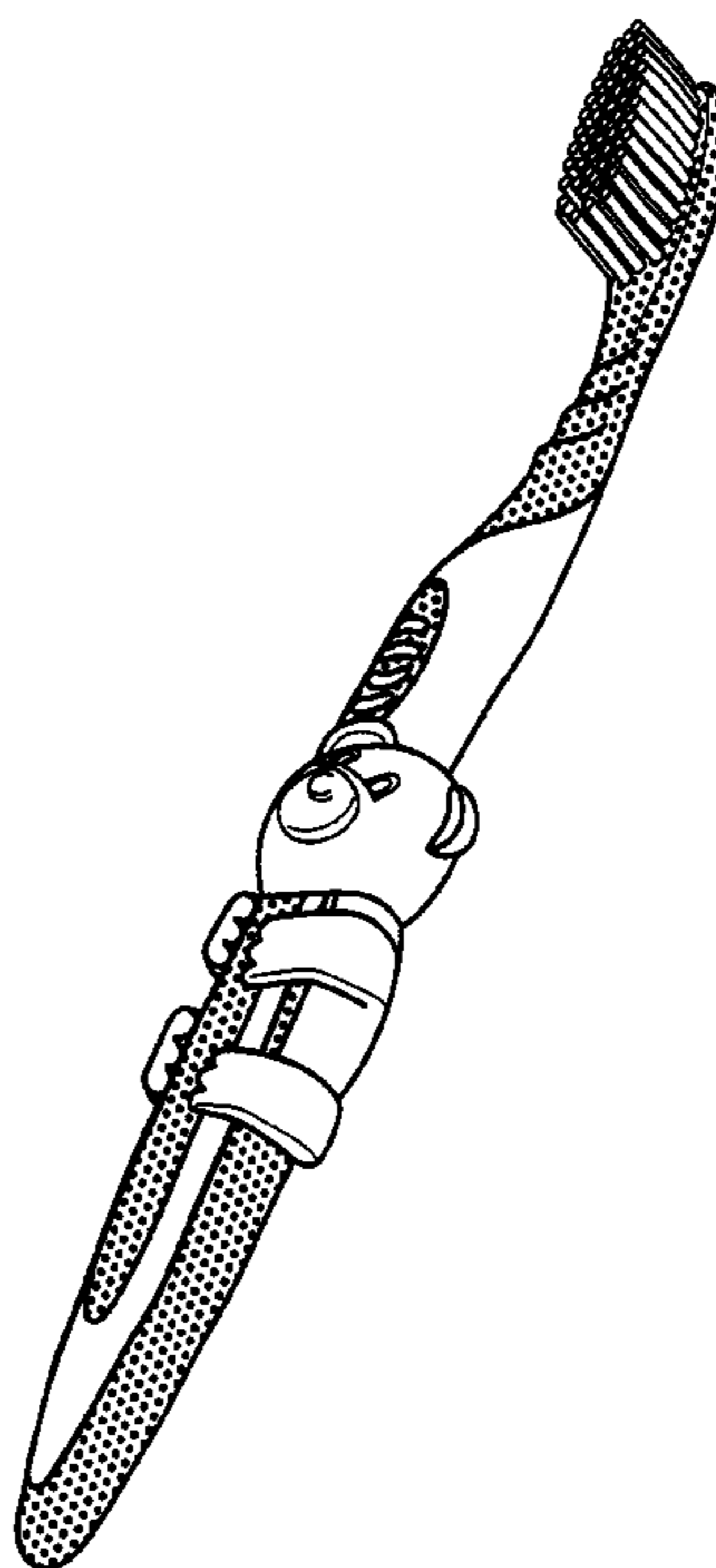
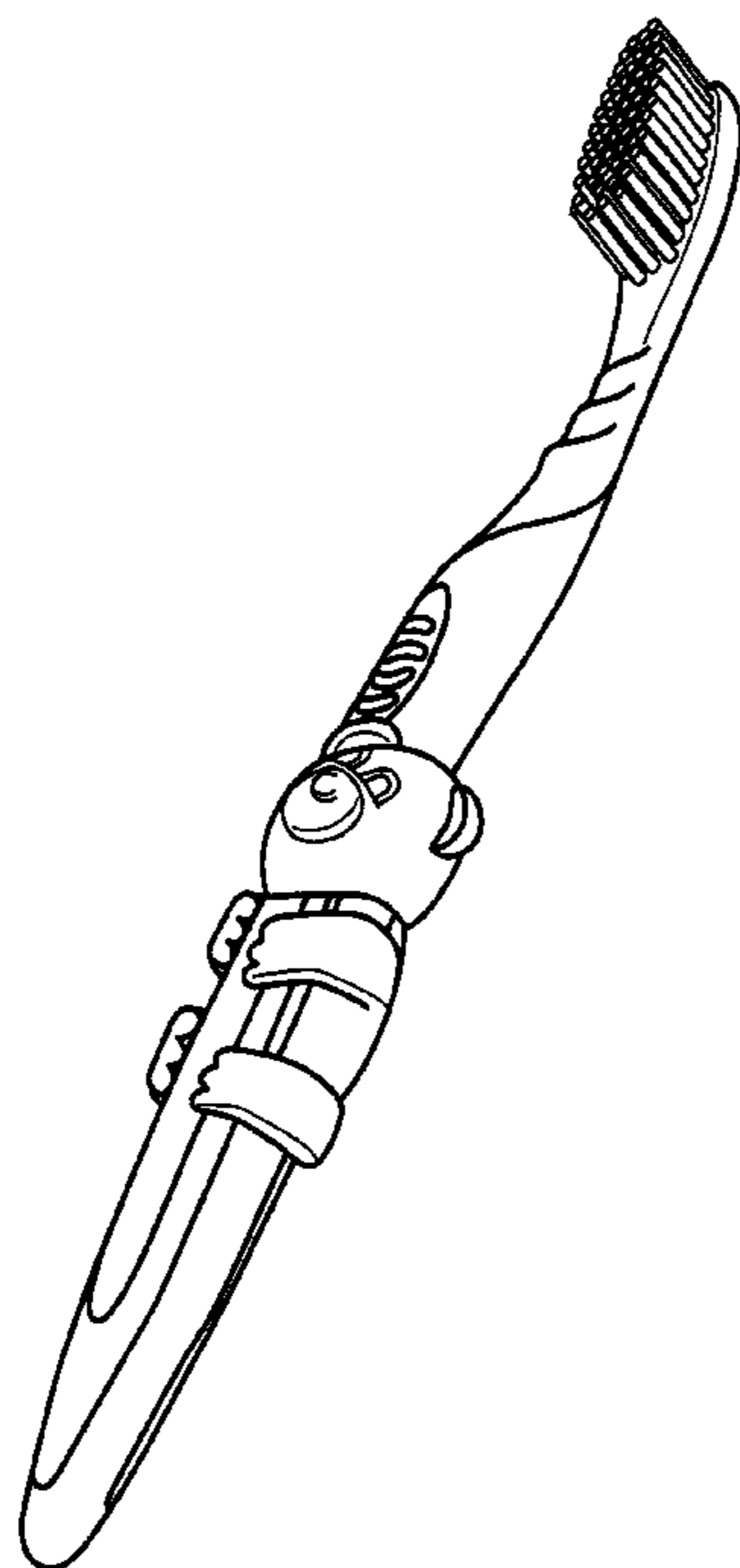
FIG. 11 is a front view of FIG. 8;

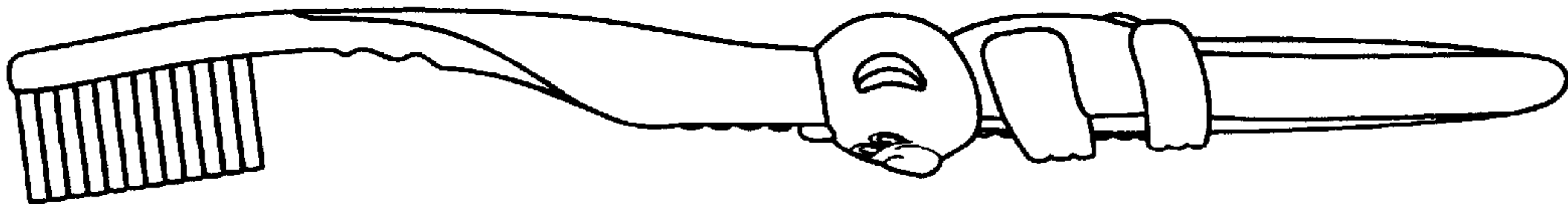

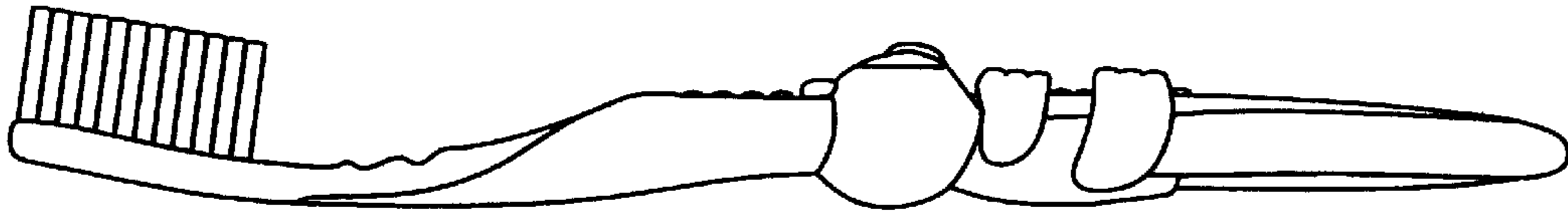

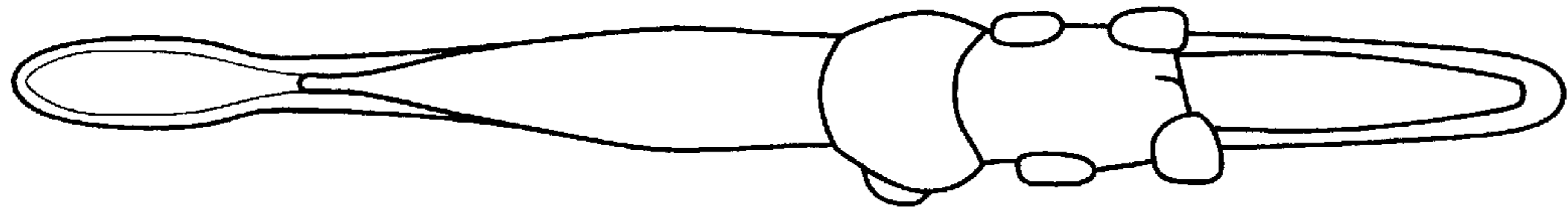

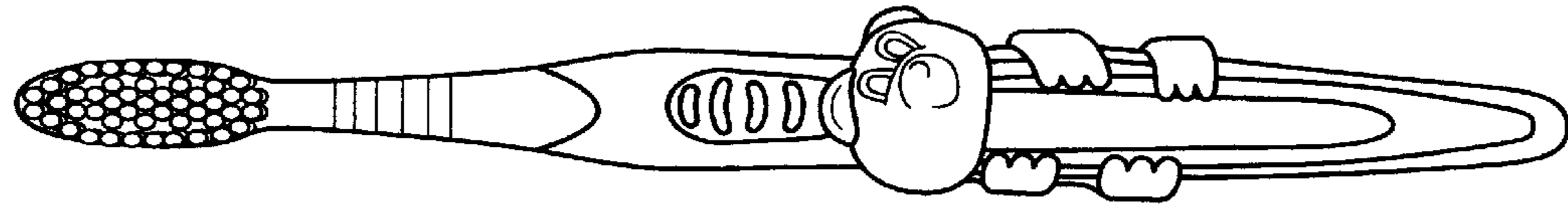

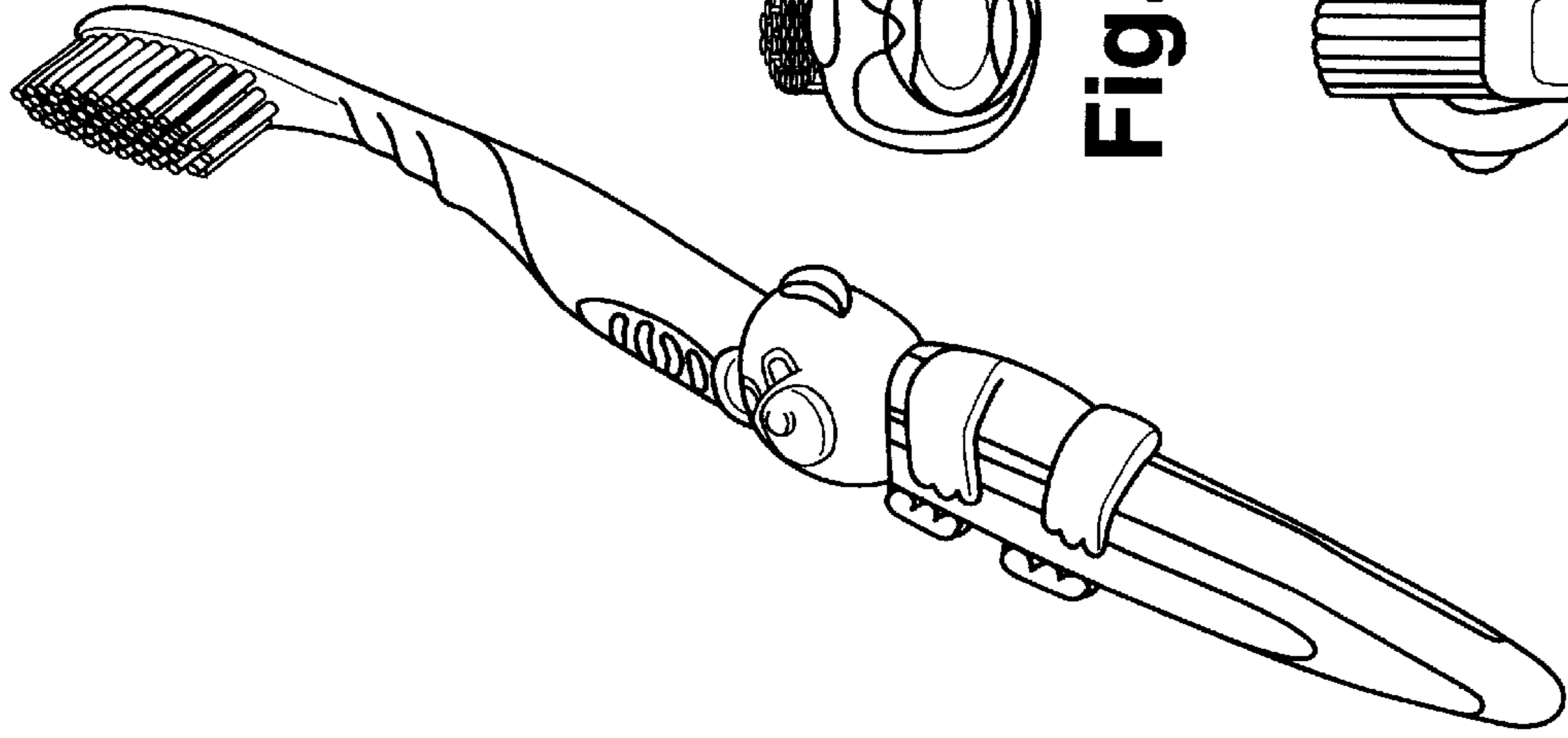

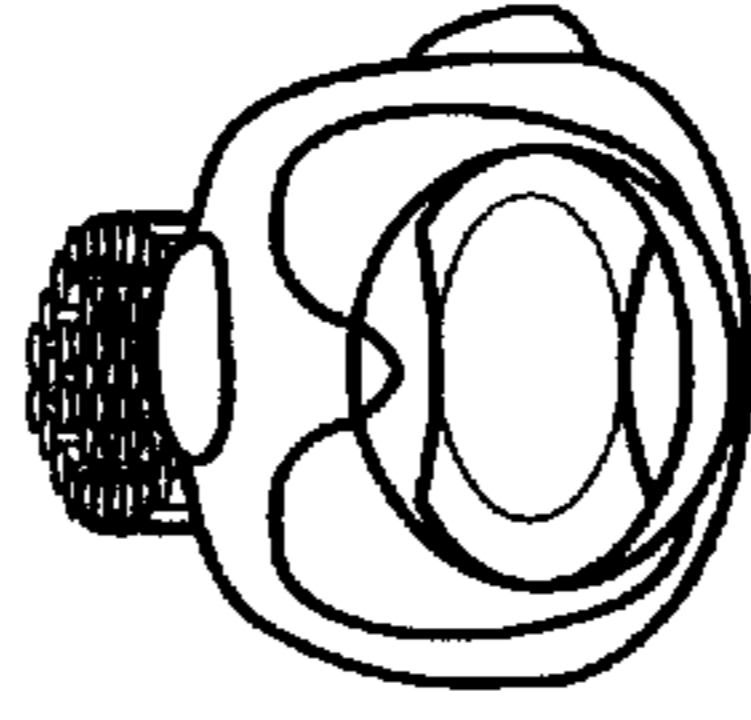

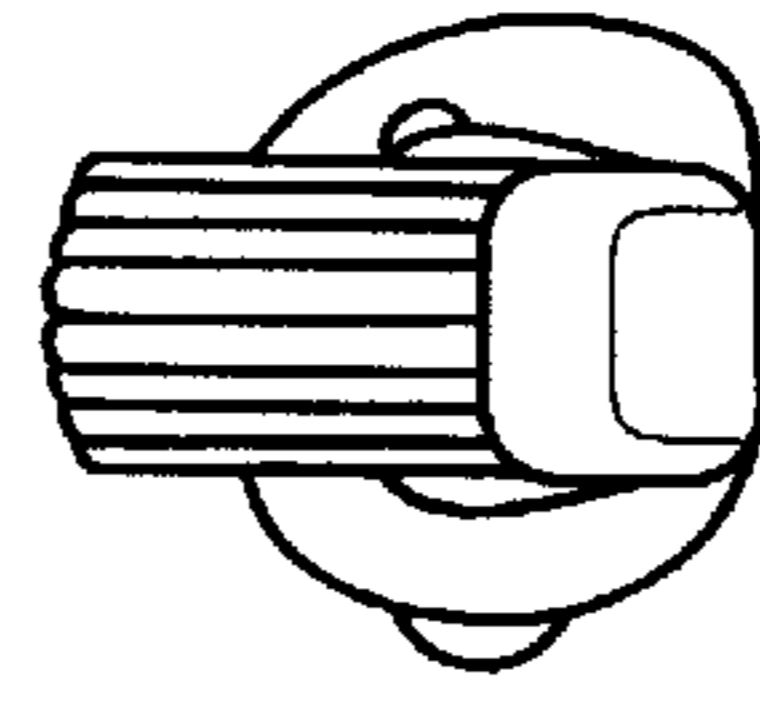
