(57) **CLAIM**

The ornamental design for a chair with checker/chess board motif and game pieces, as shown.

DESCRIPTION

A decorative chair featuring: a) a seat with a checkerboard pattern; b) game pieces affixed onto the chair framework and seat; and c) a frame bisected by two colors.

The FIGURE is a perspective view of a chair with checker/chess board motif and game pieces showing my new design.
