DESCRIPTION

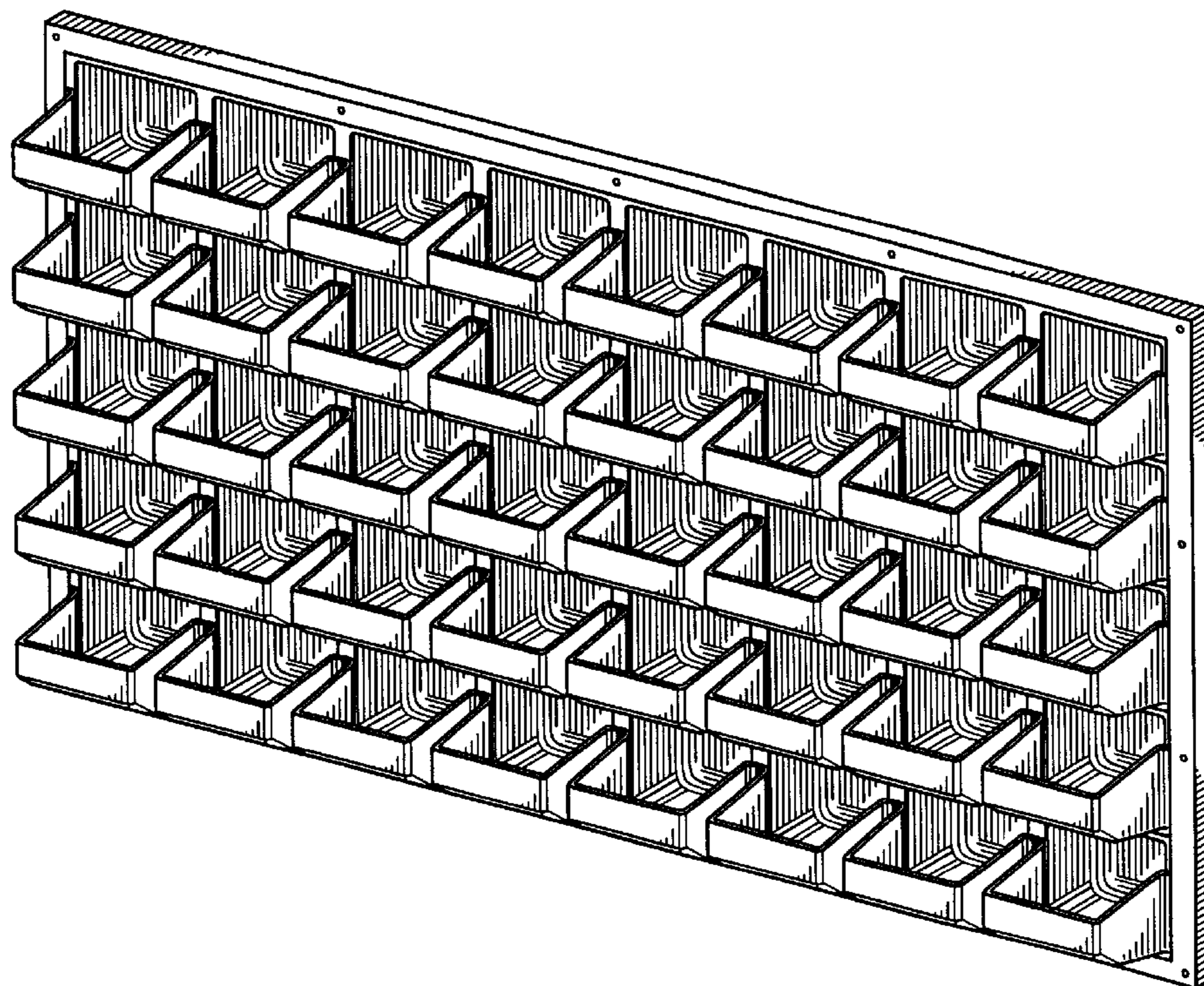
FIG. 1 is a perspective view from the front, top and right side of the bin assembly;

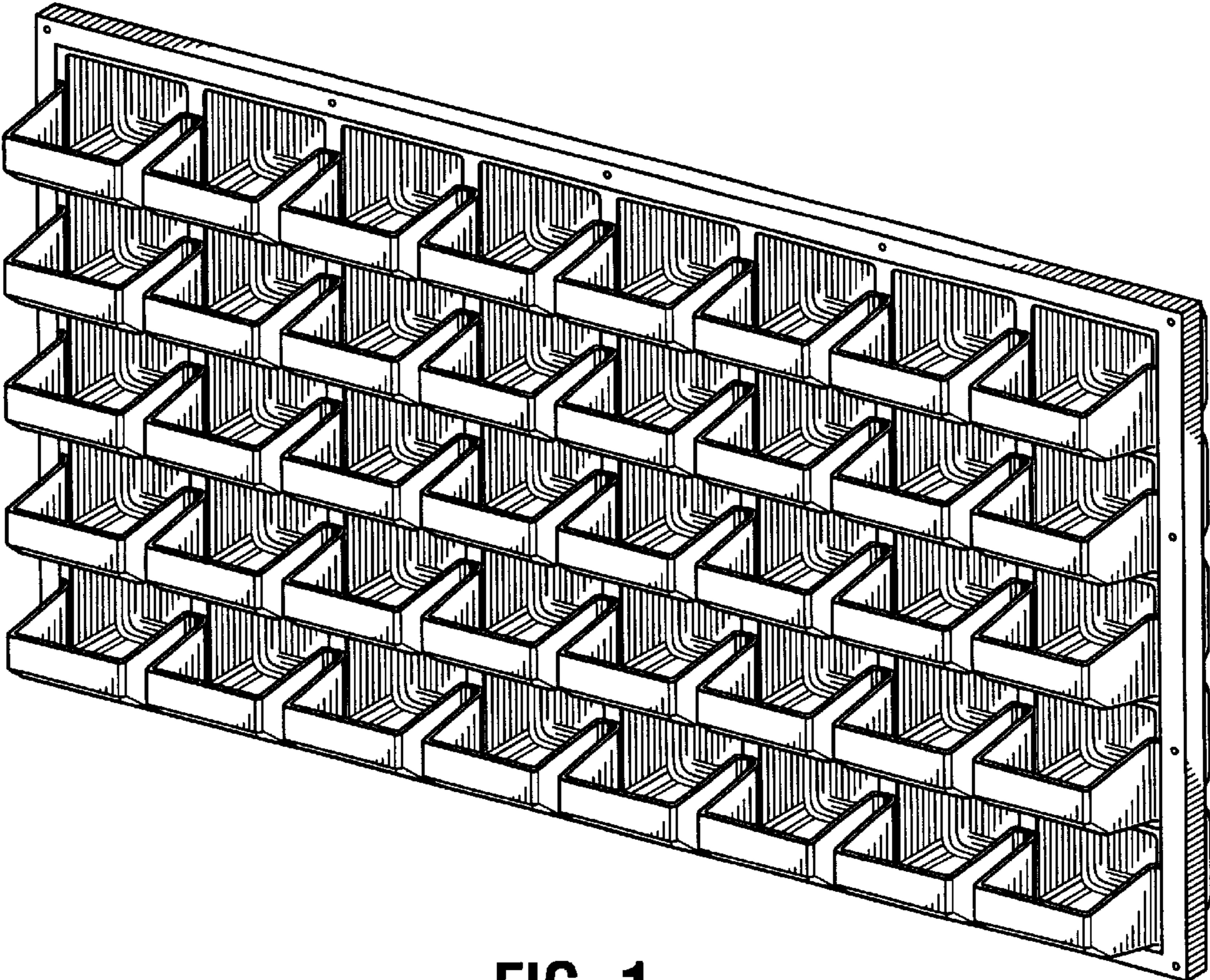

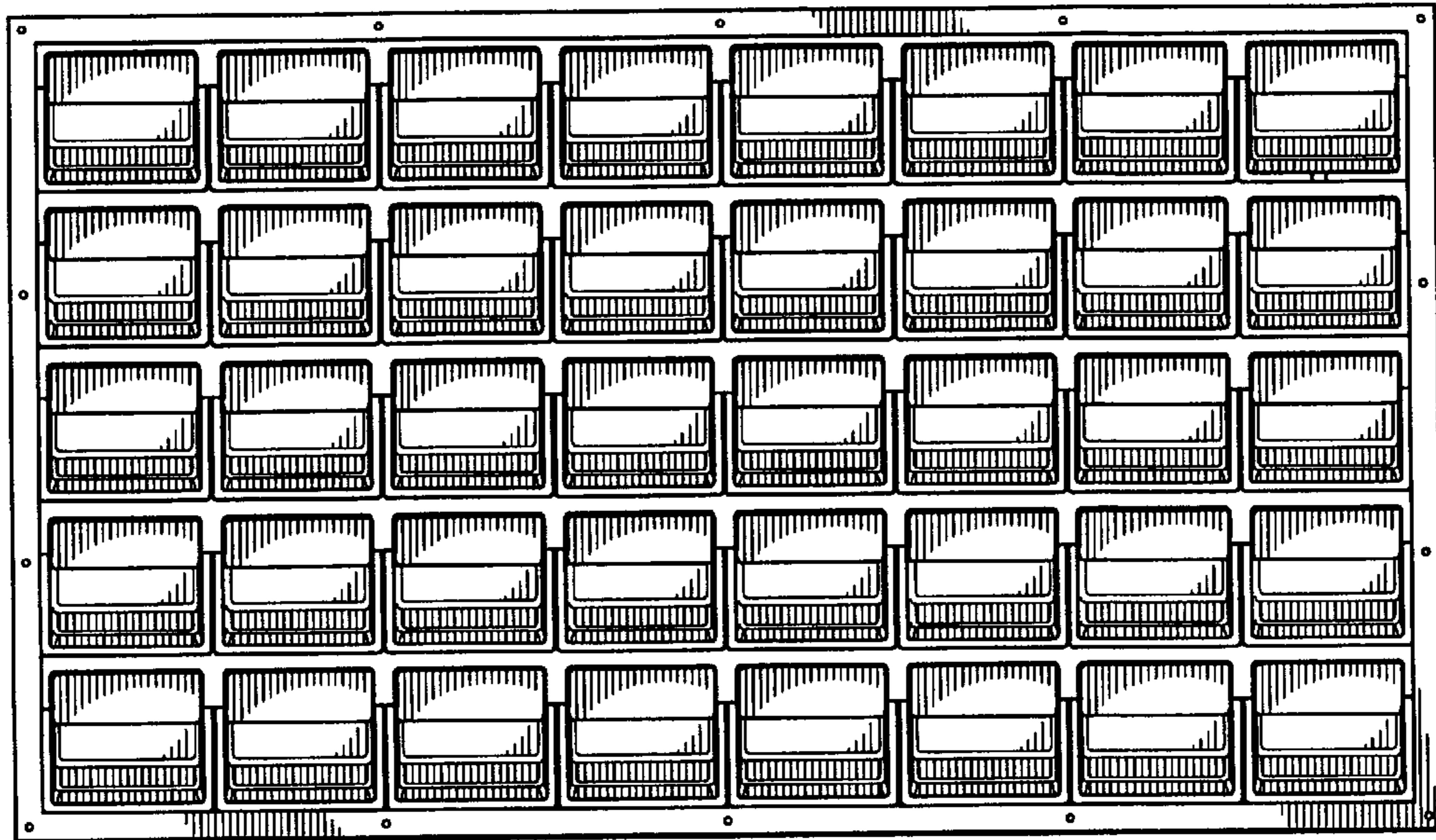

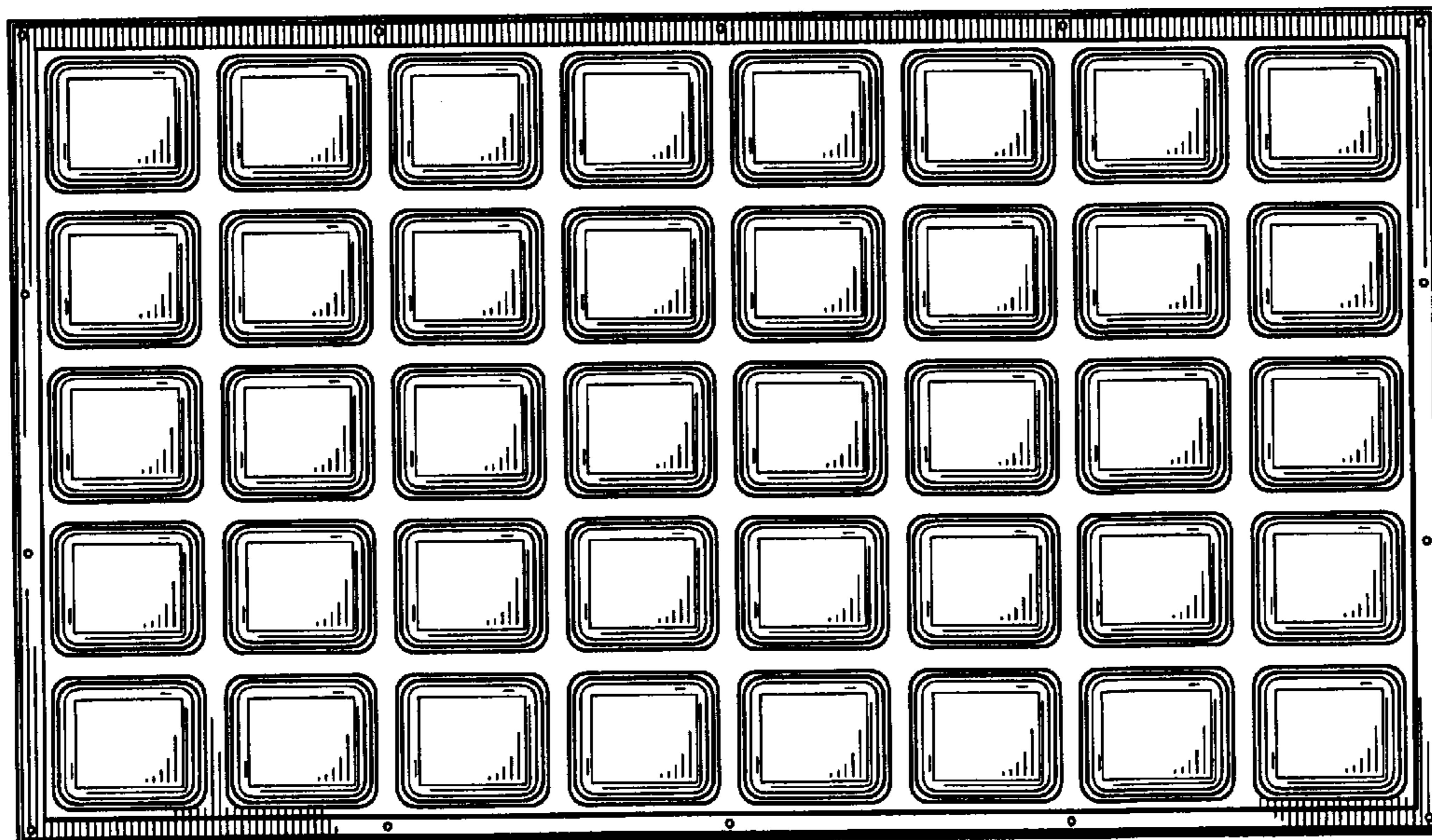

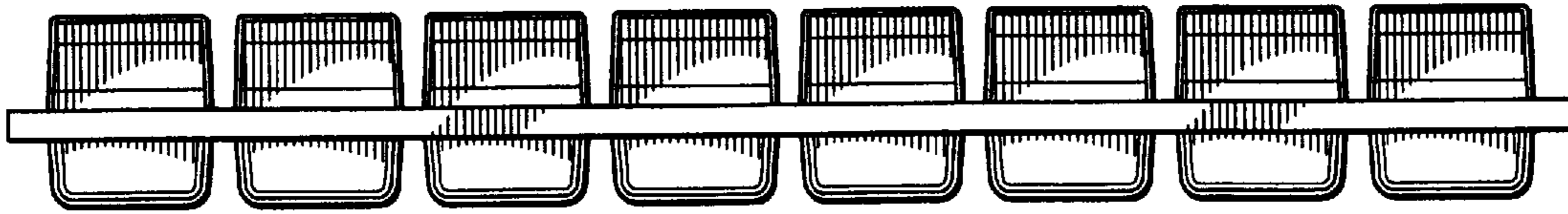

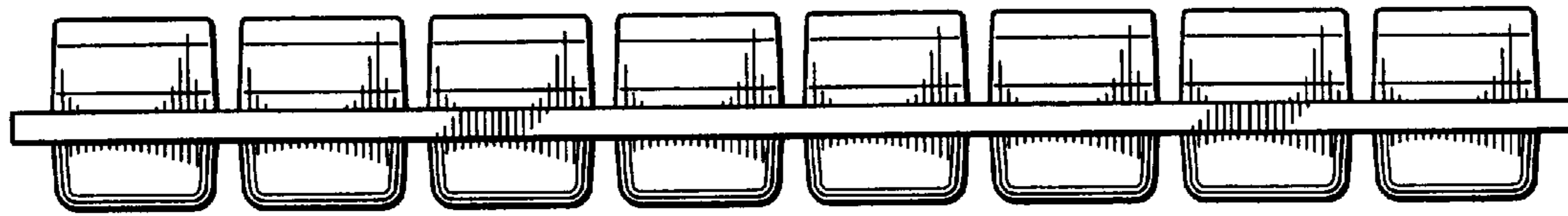

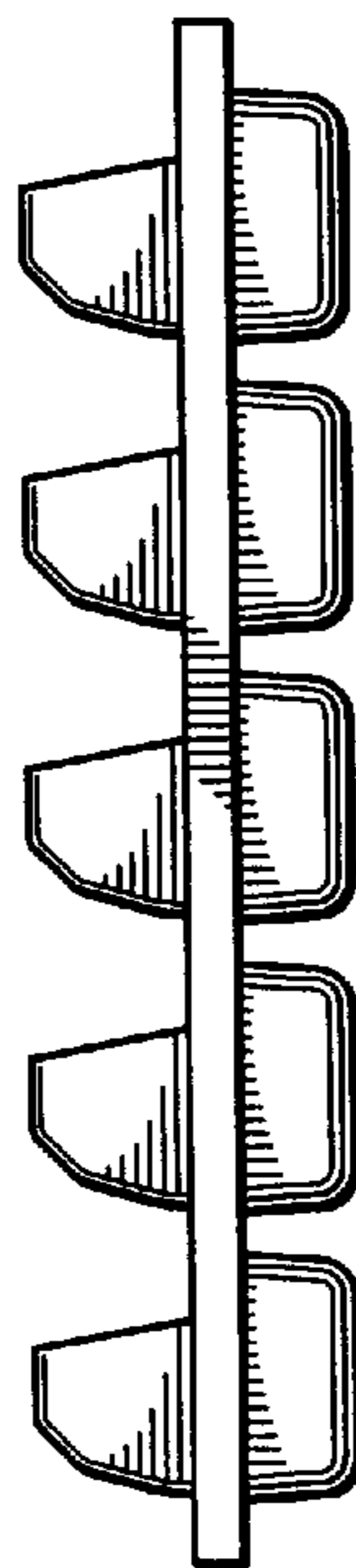

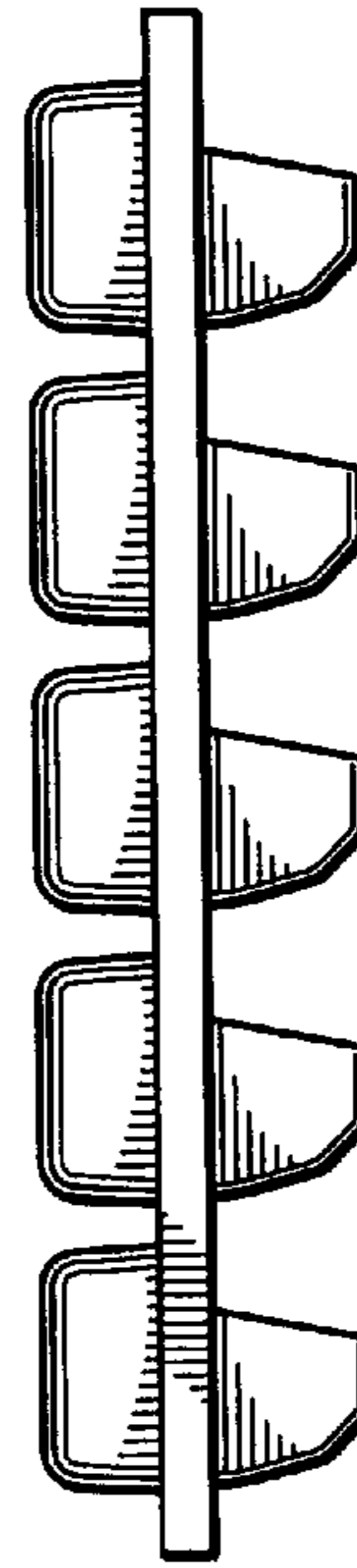
