The ornamental design for a car including toy-car, motor-car, replica-car and scale-model-car, as shown and described.

DESCRIPTION

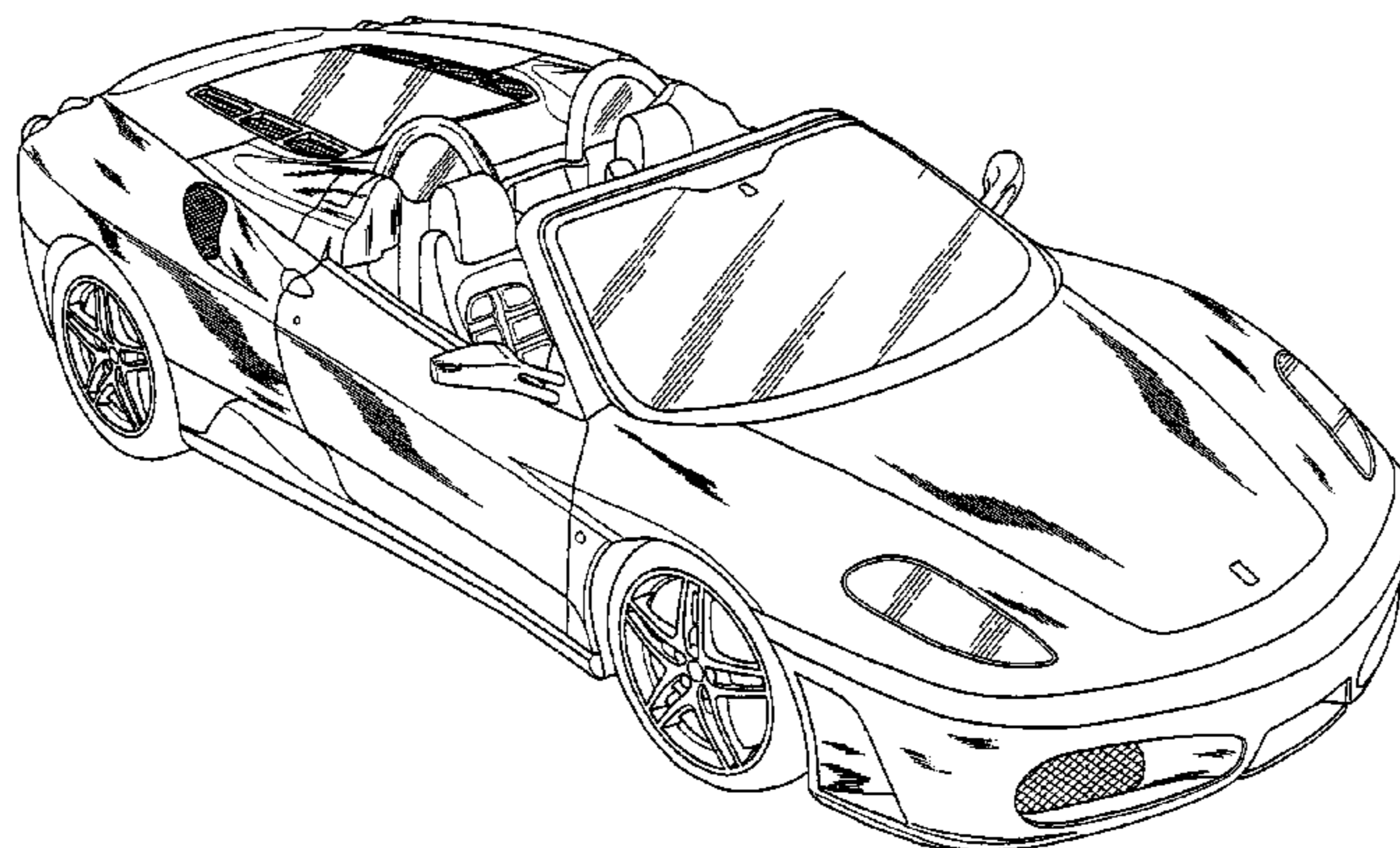
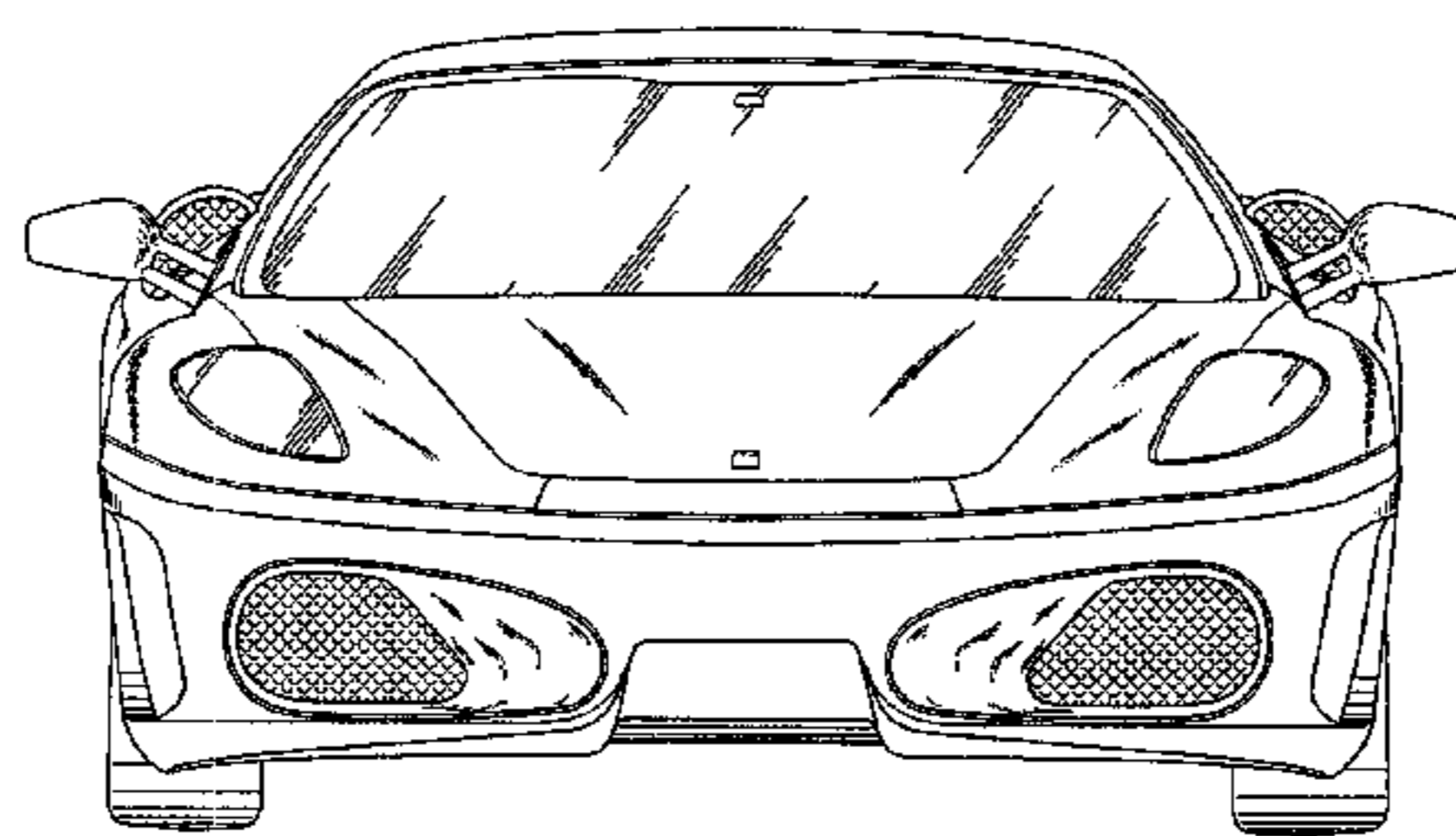

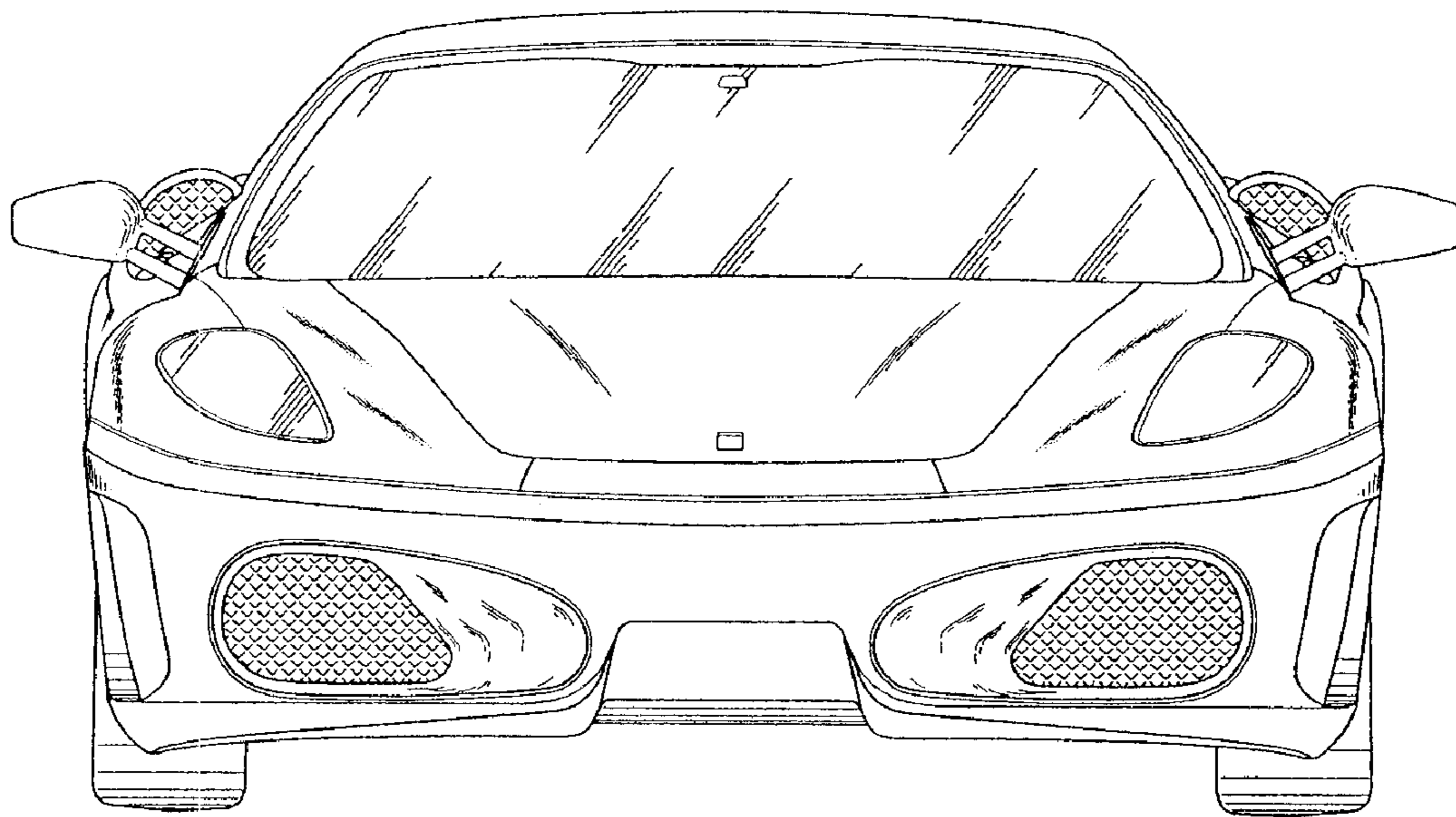

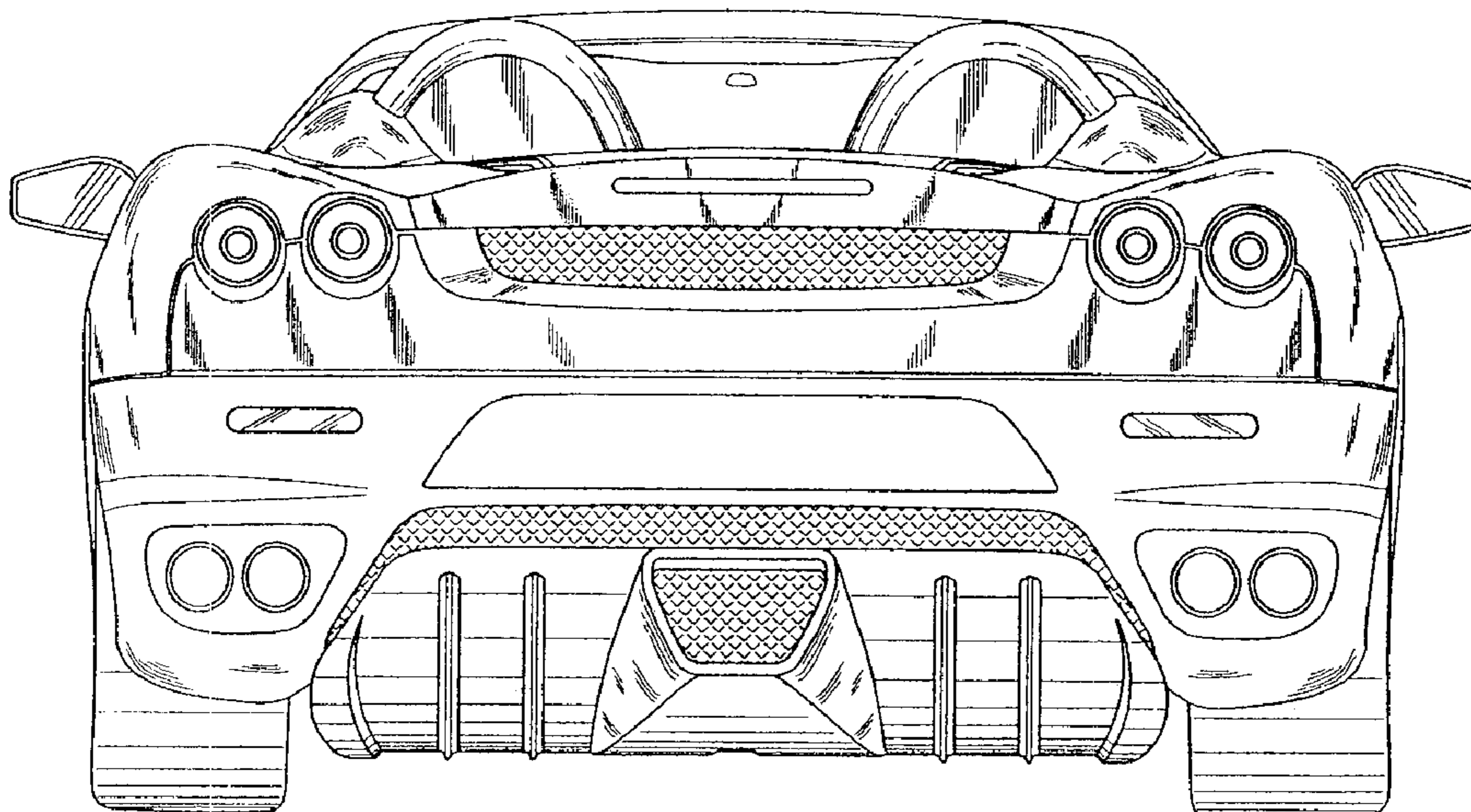

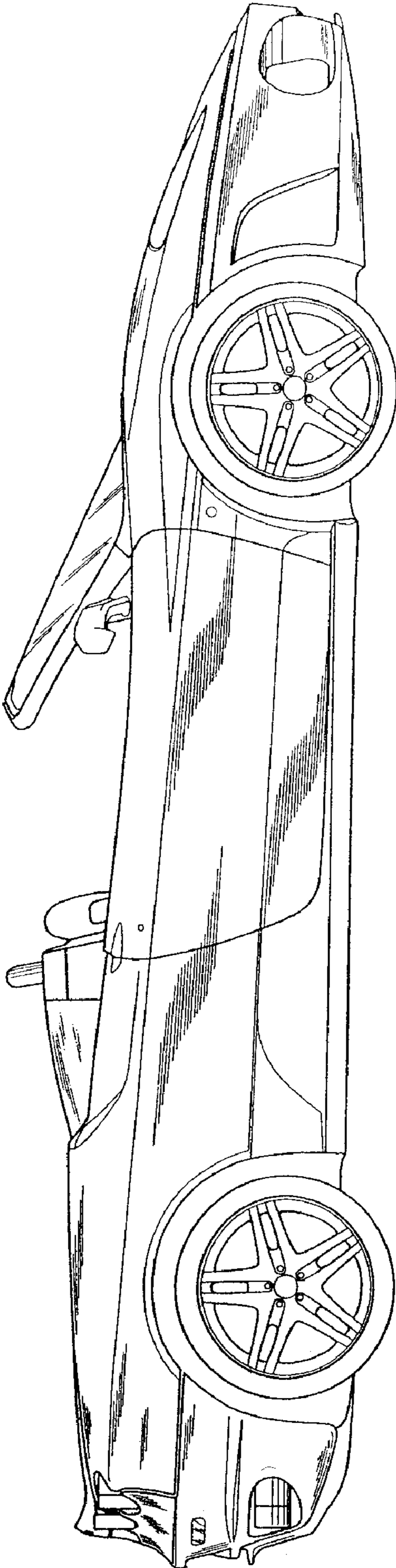

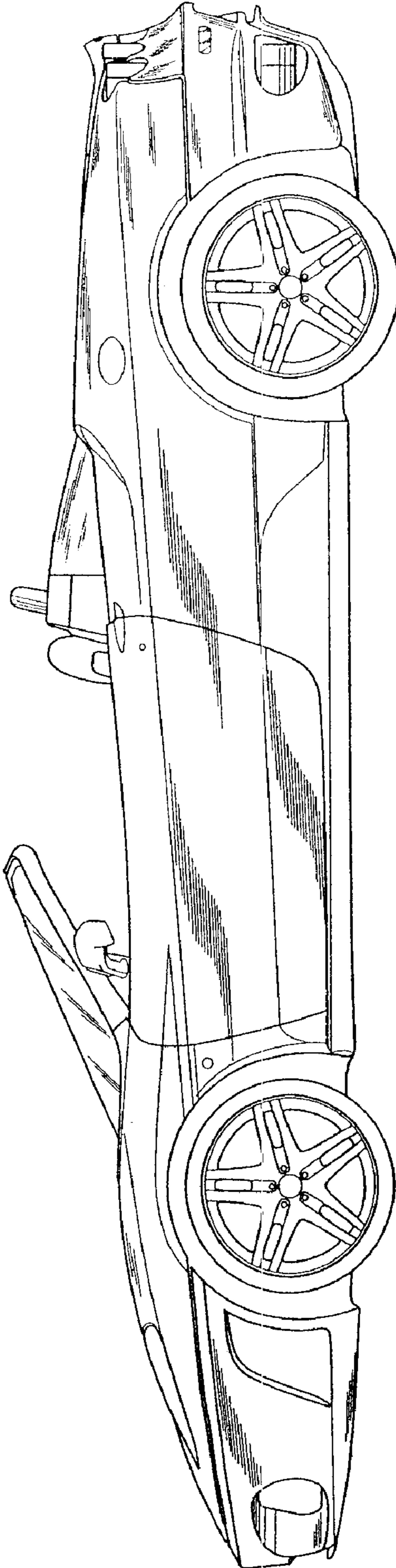

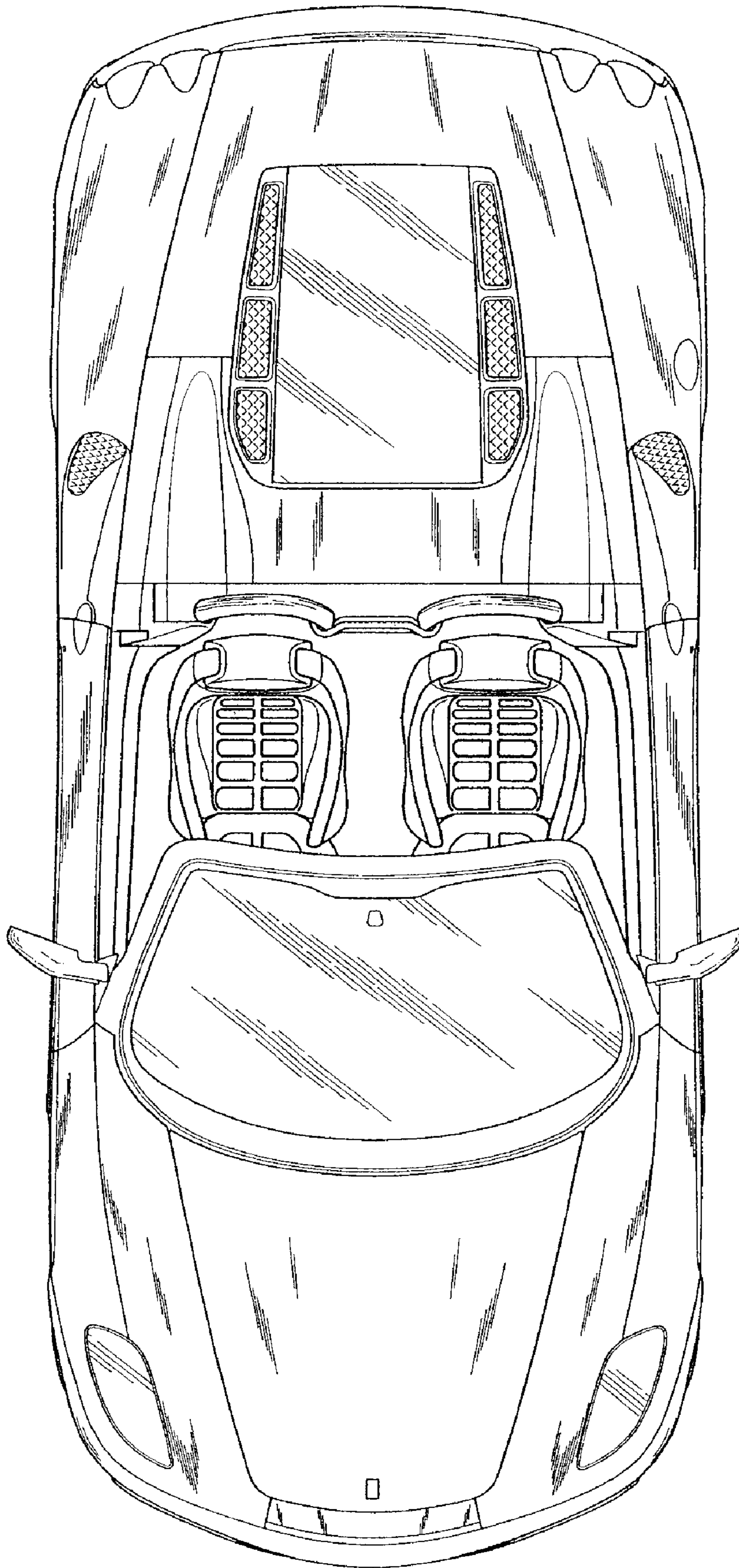

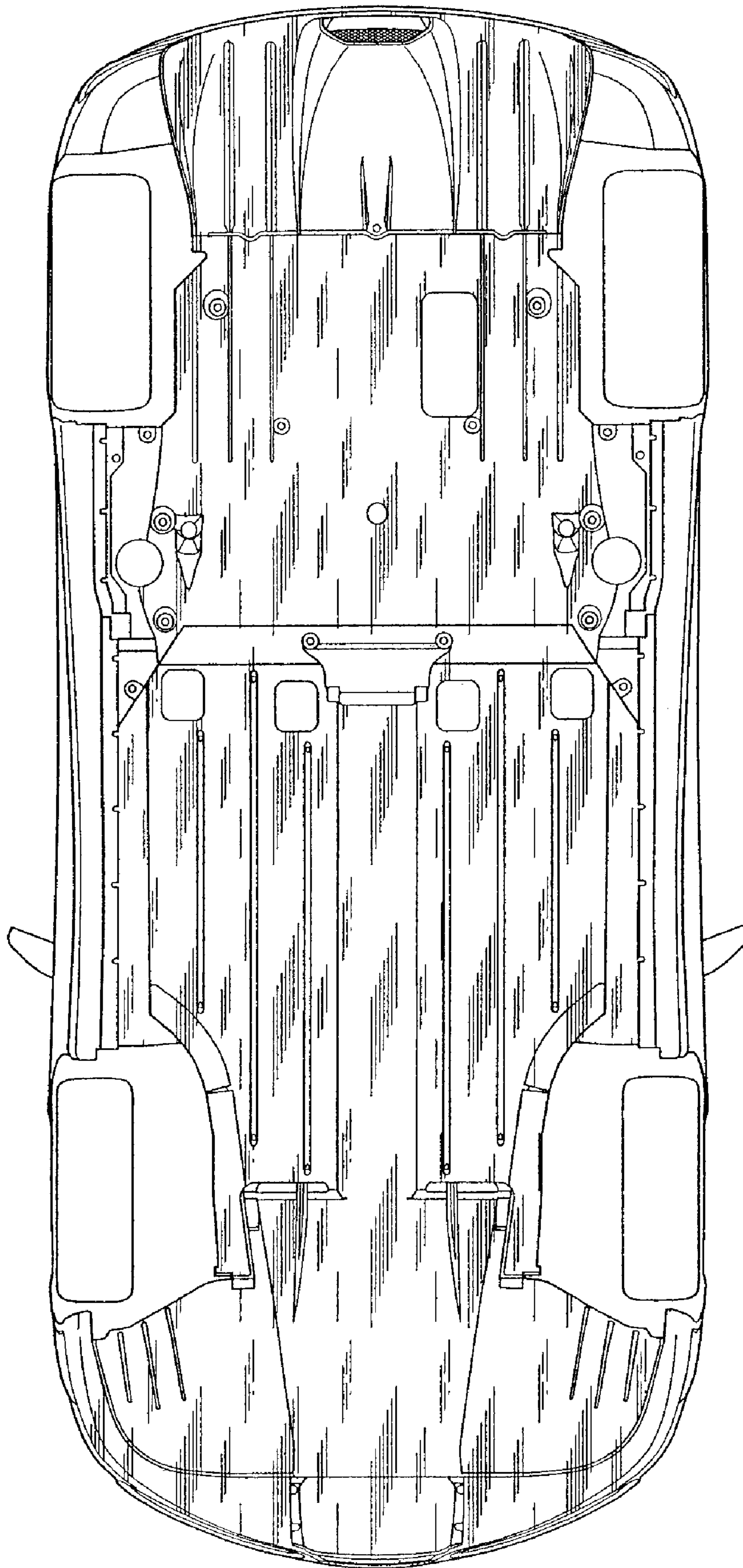

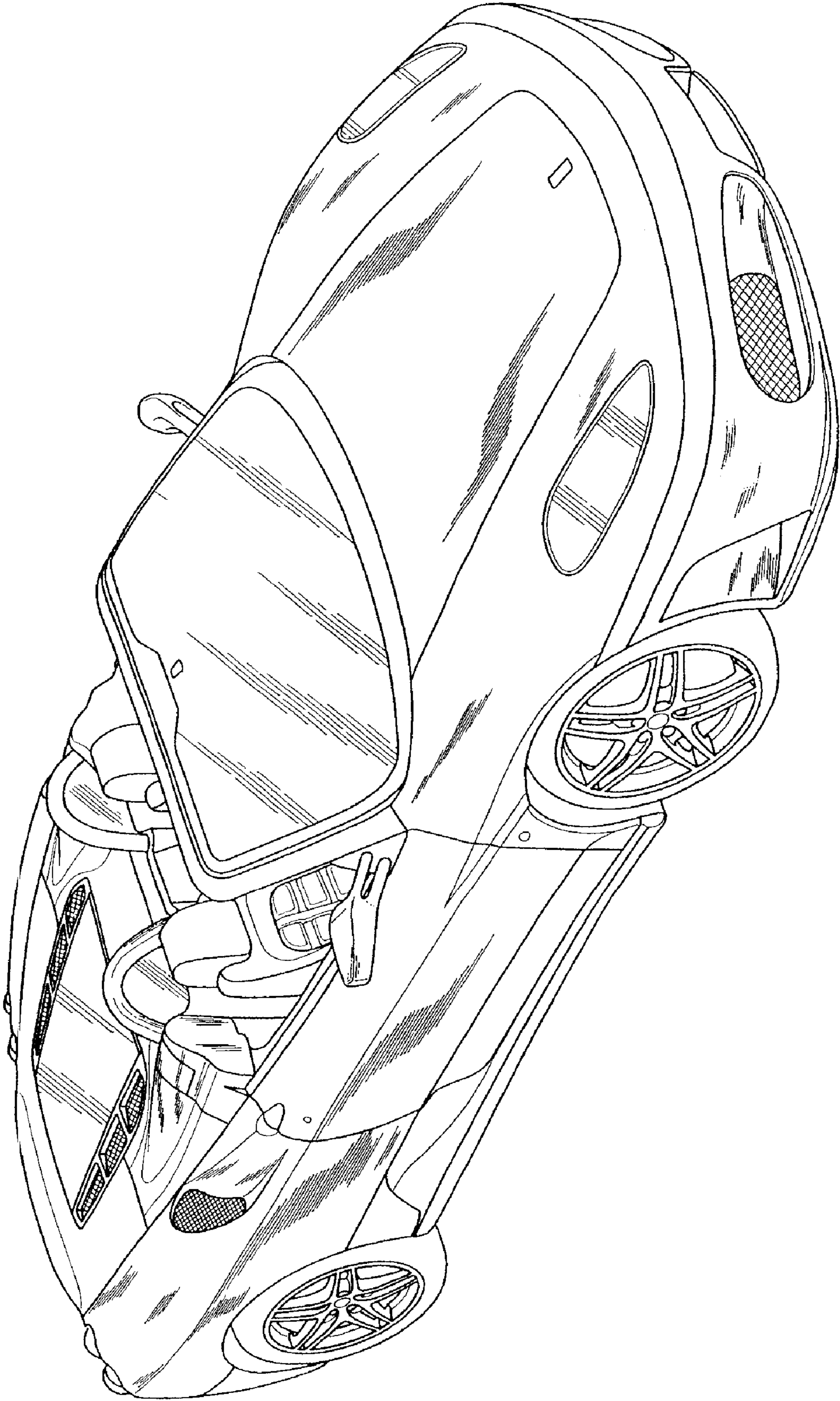

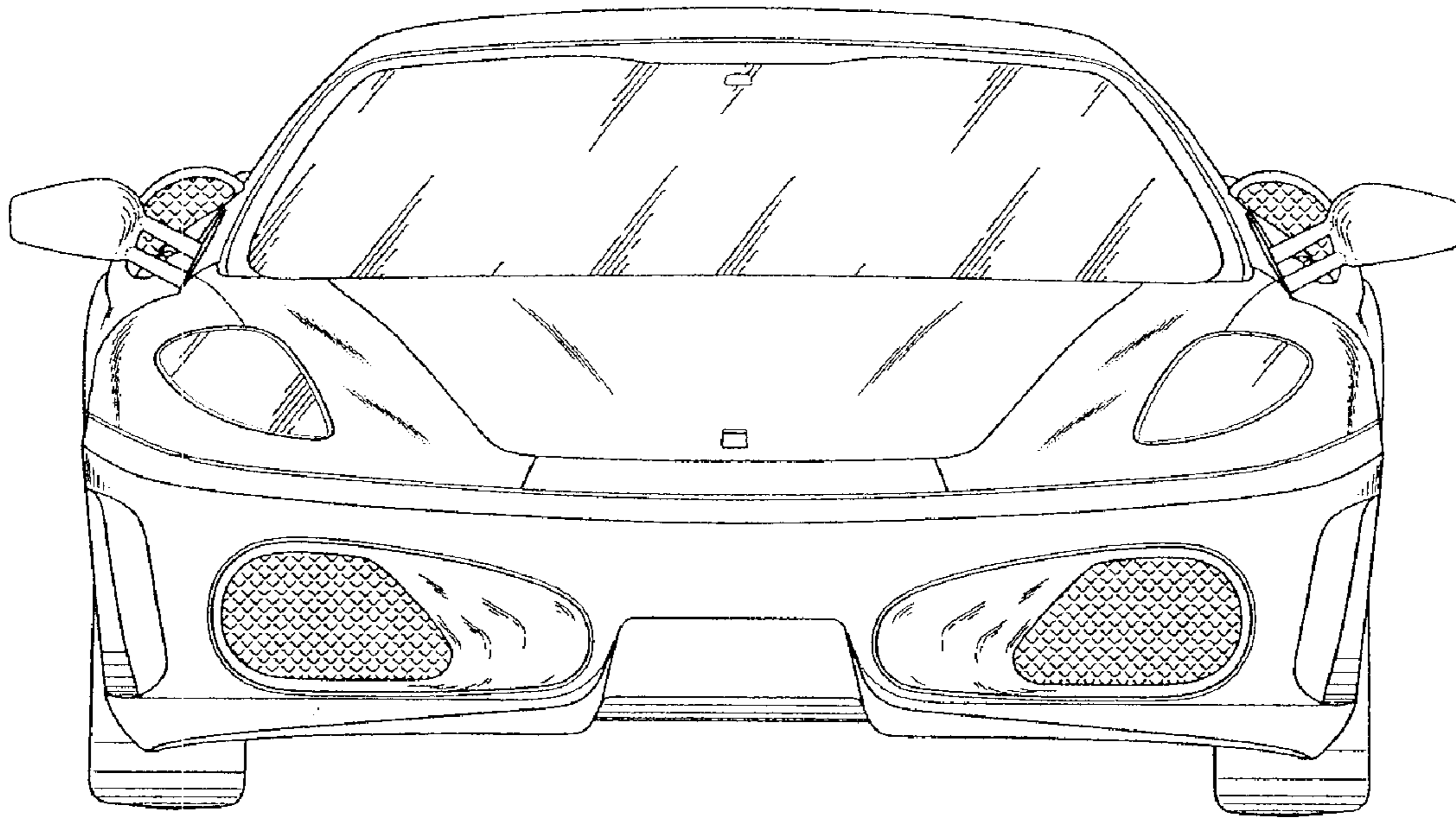

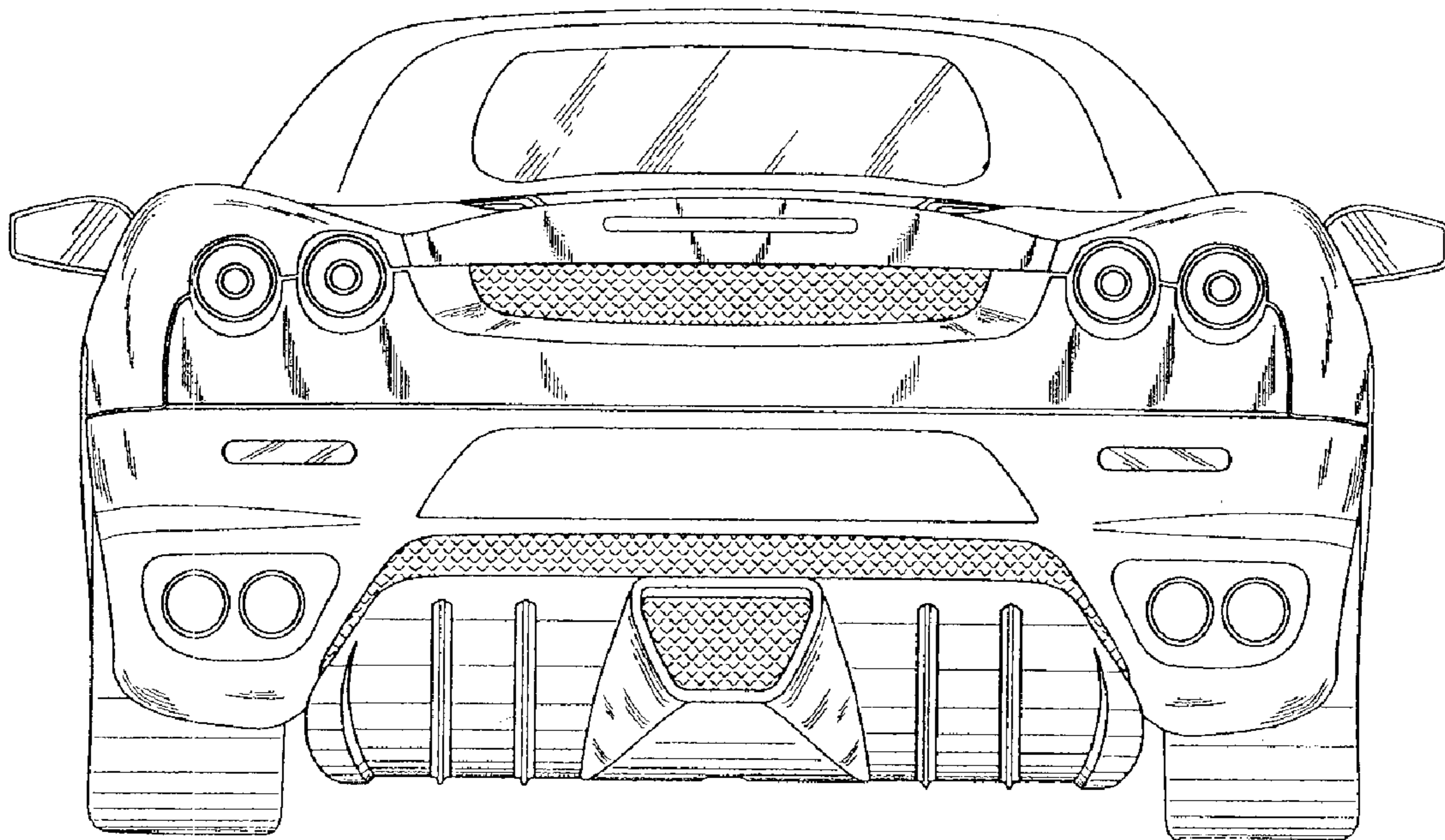

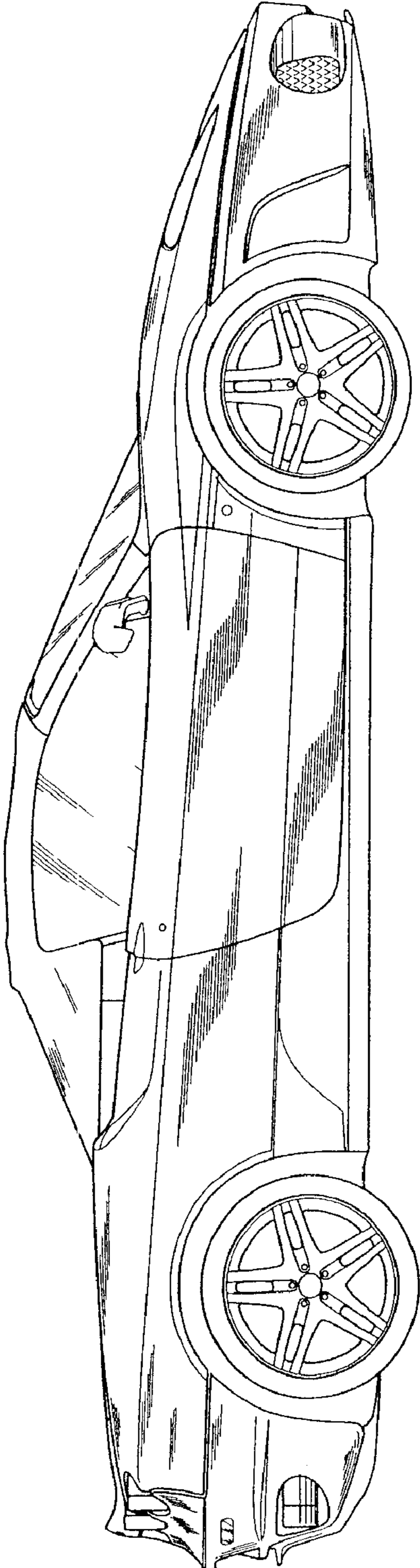

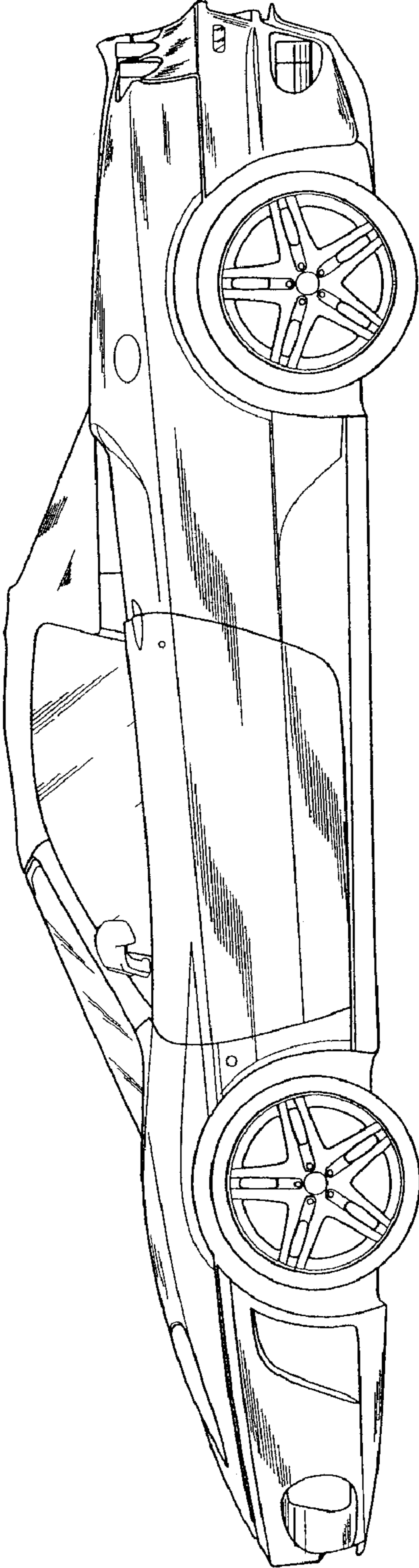

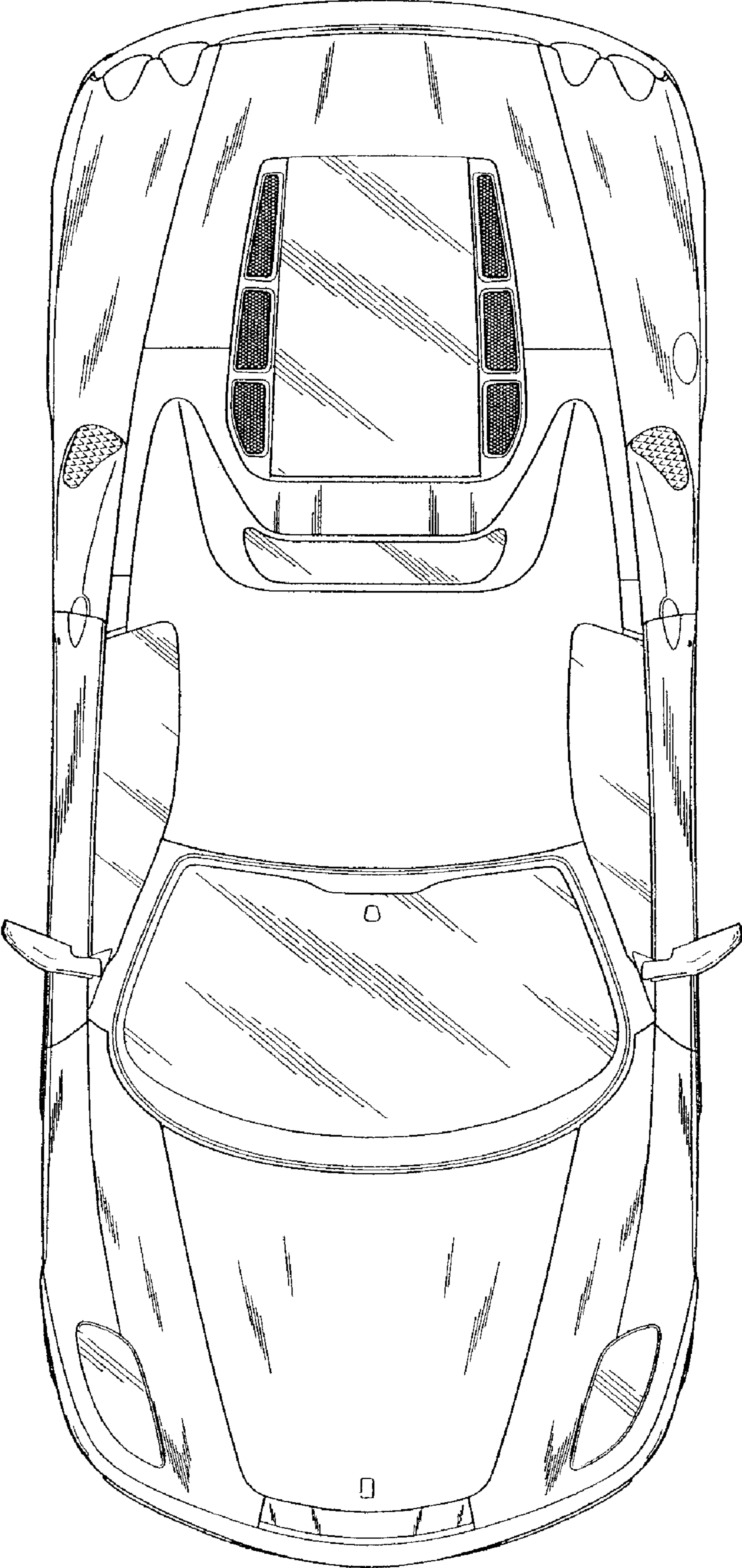

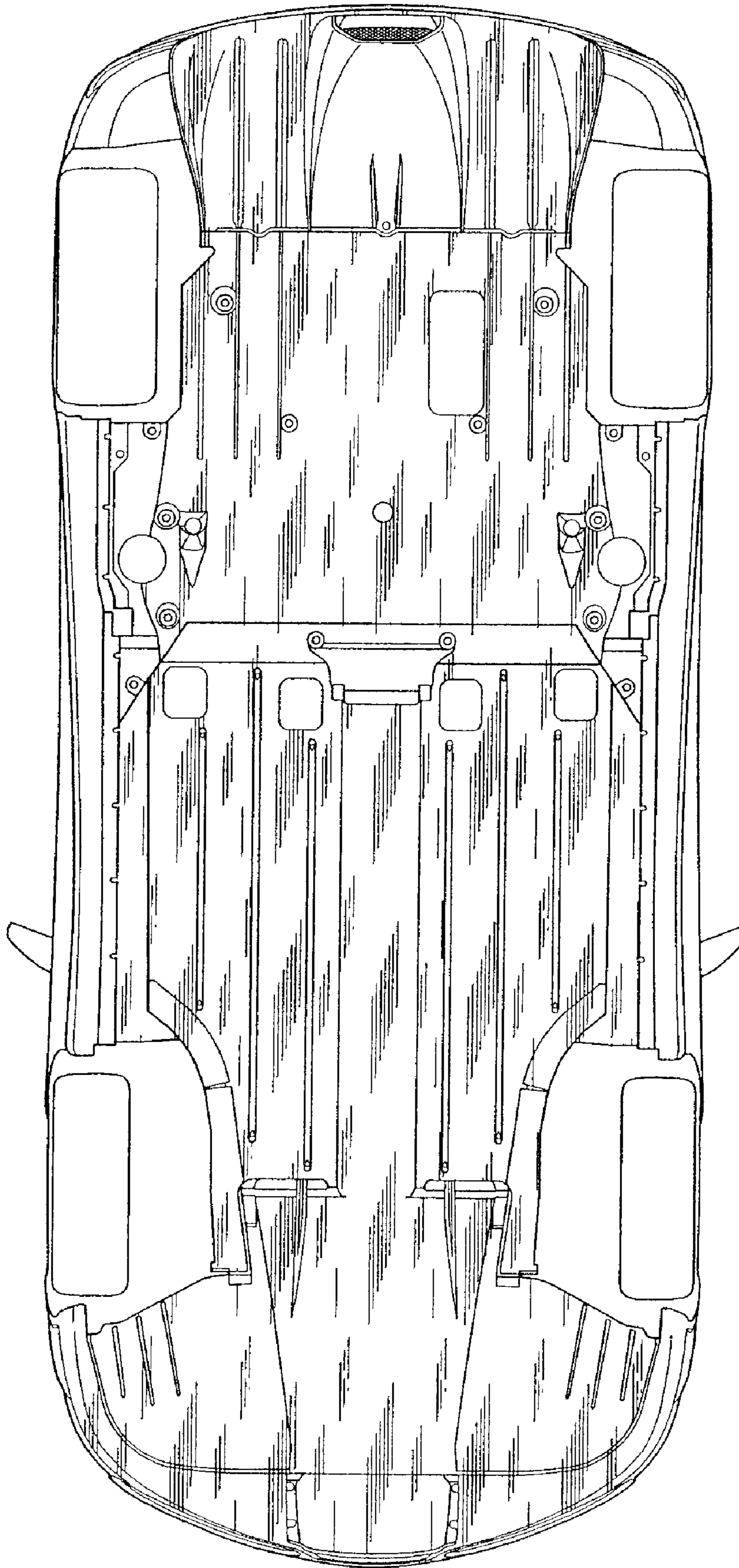
