DESCRIPTION

FIG. 1 is a front elevation view of a wire mount connector showing our new design;

FIG. 3 is a right side elevation view thereof;

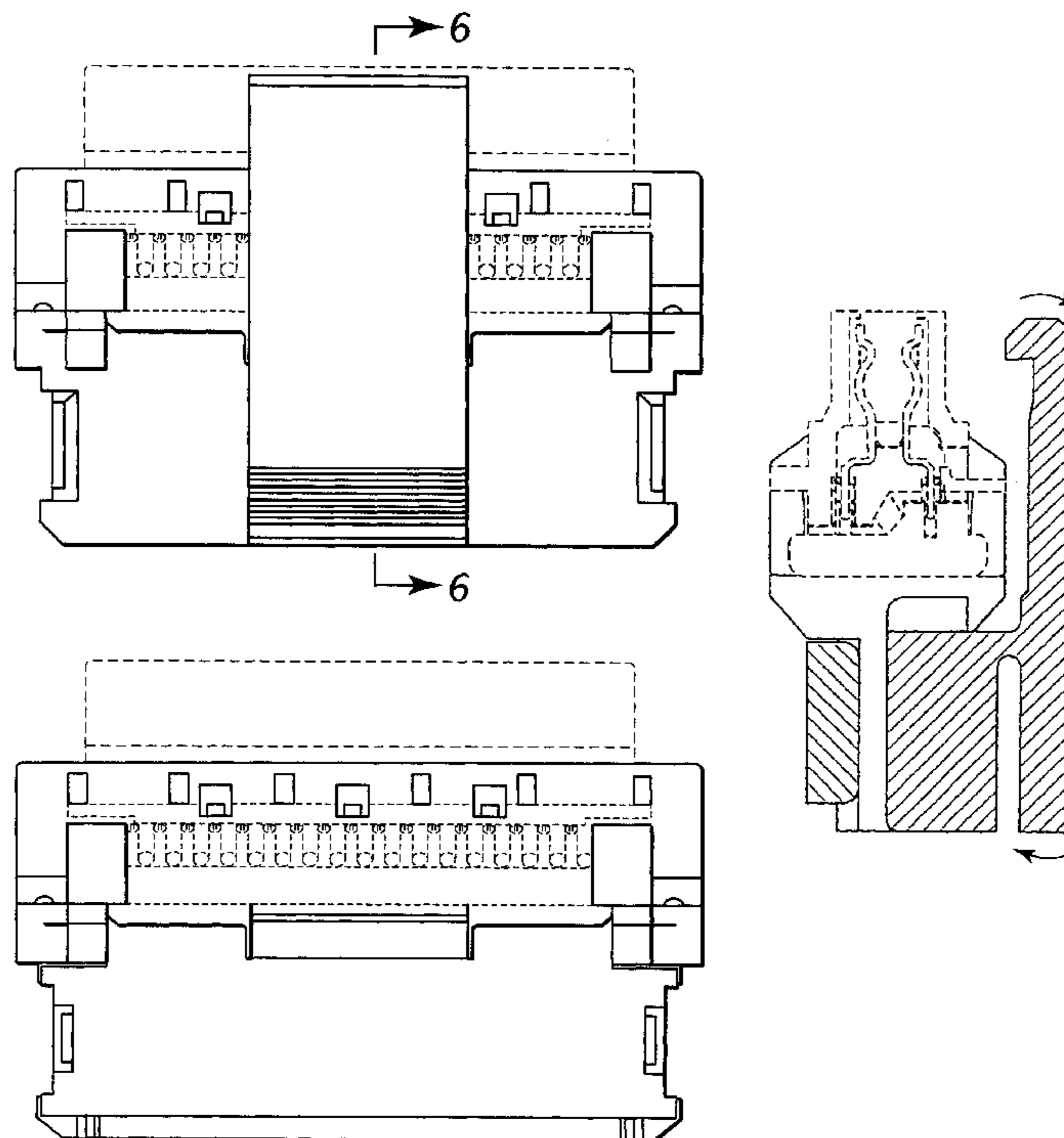
FIG. 4 is a top plan view thereof;

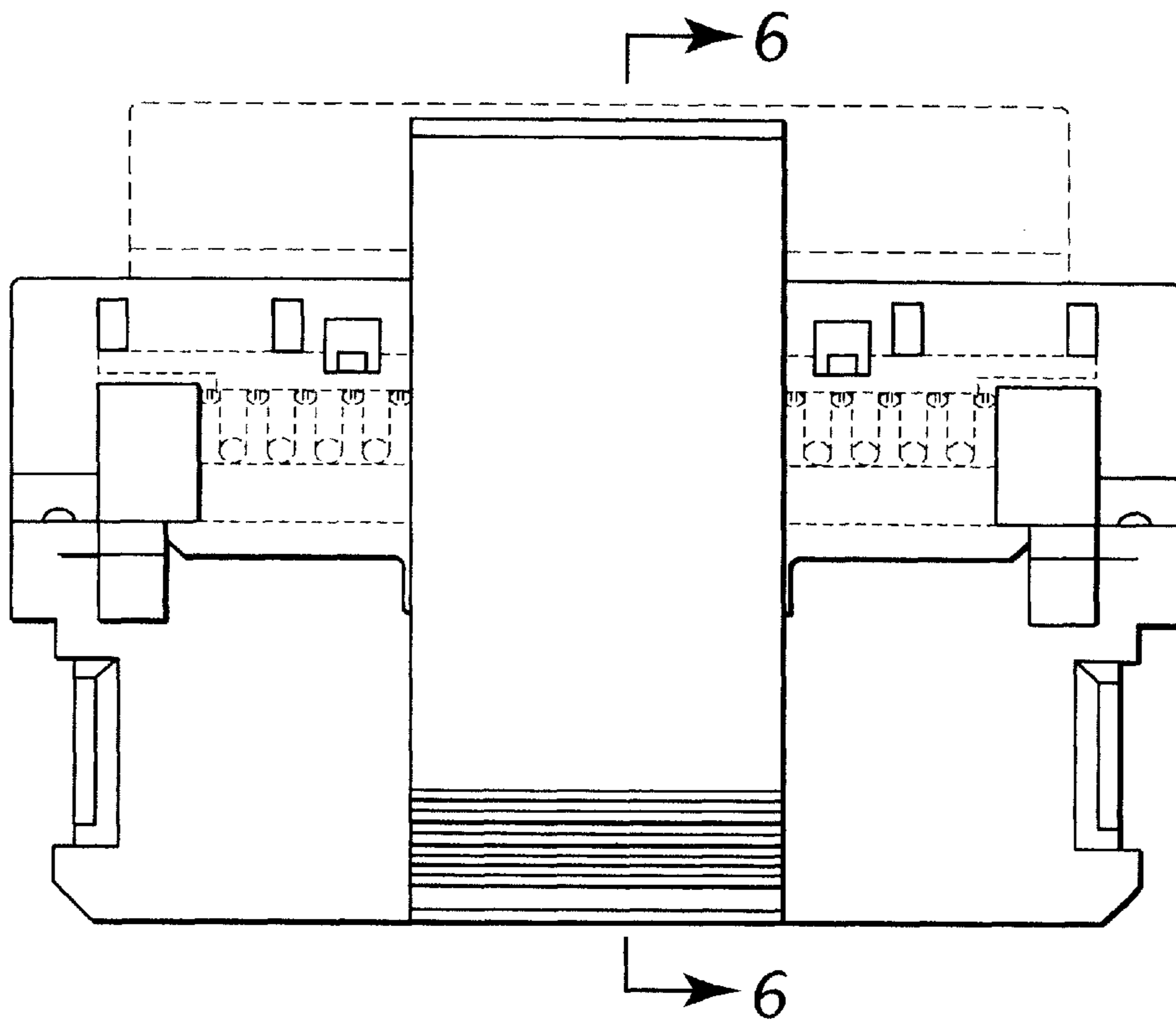

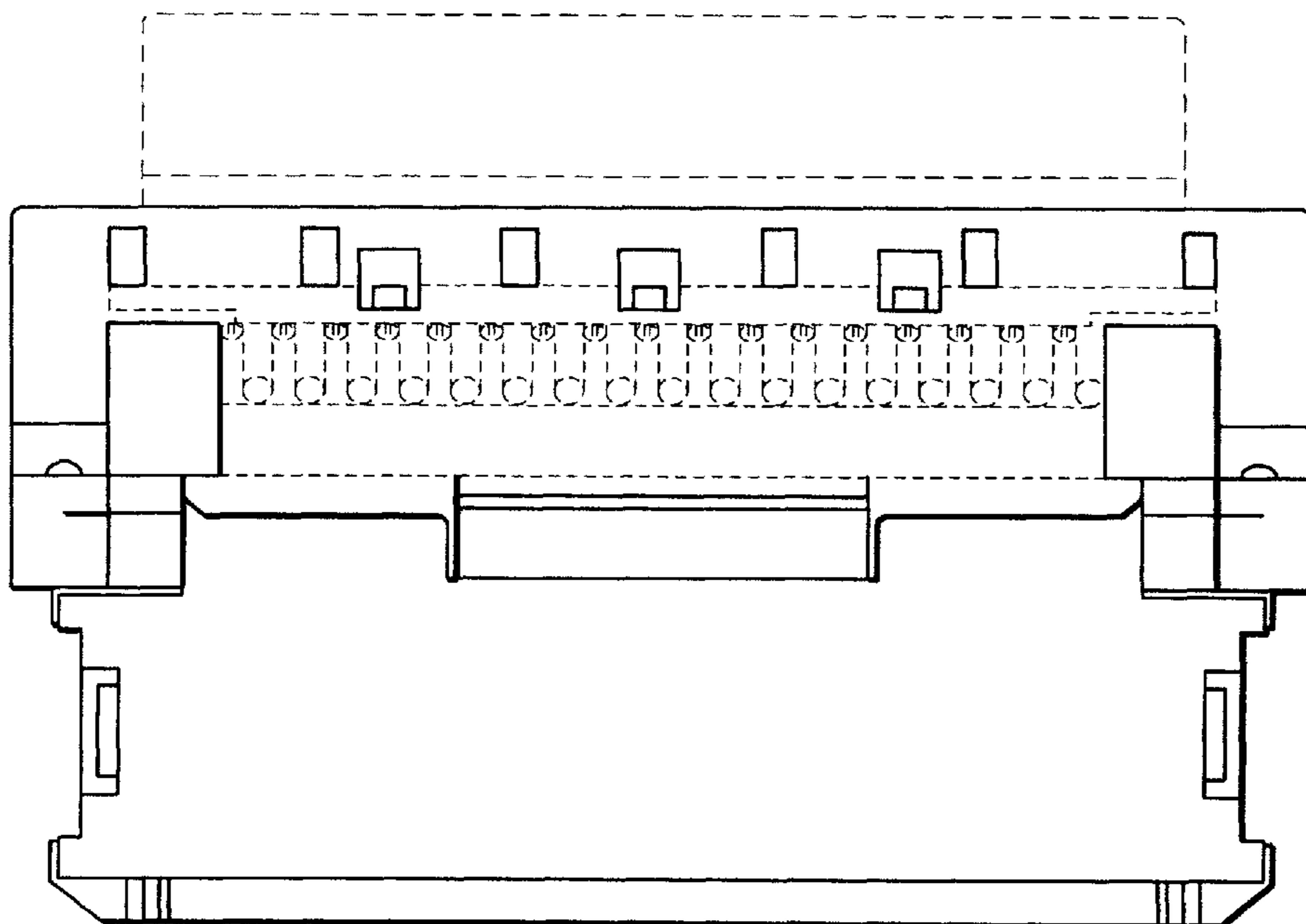

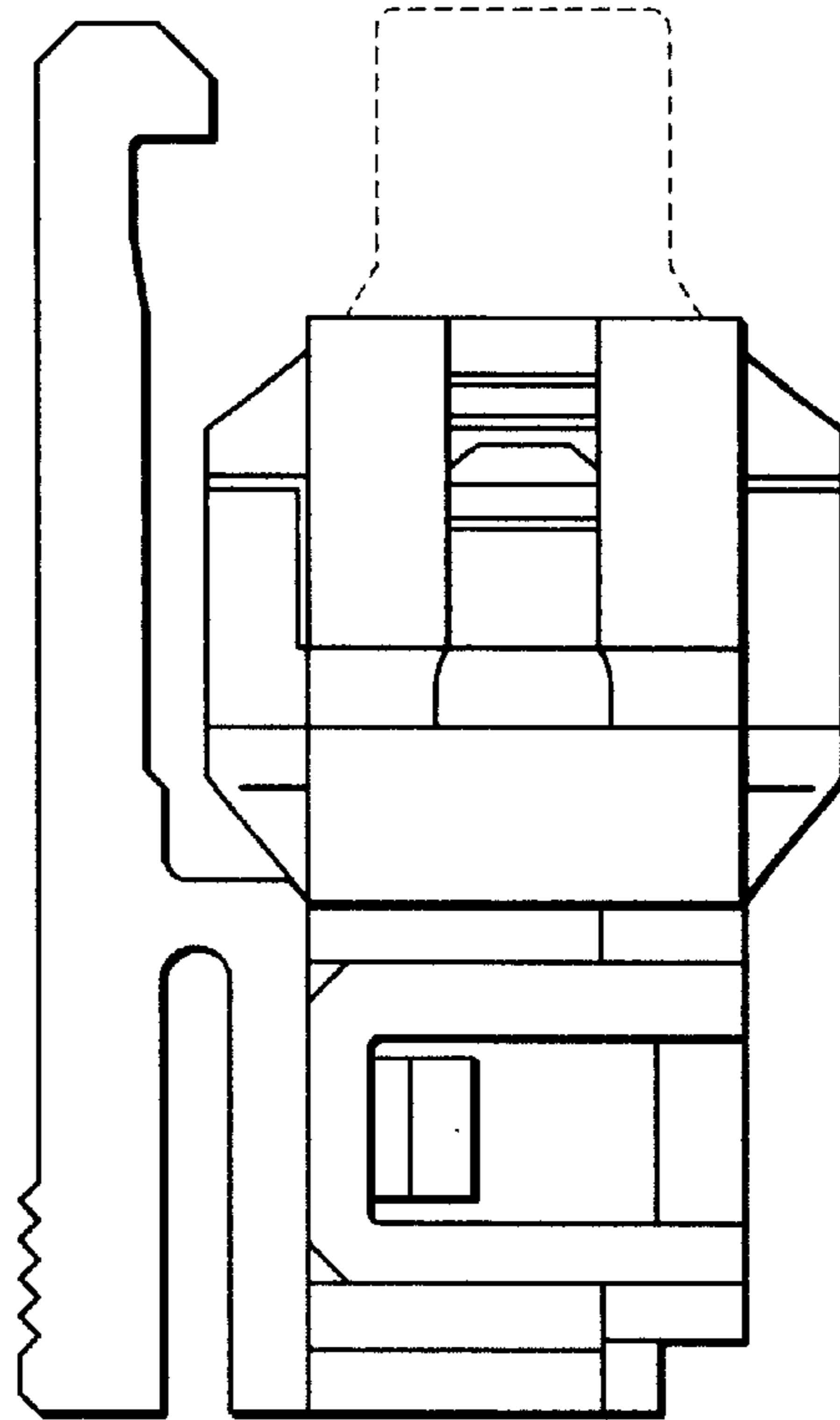

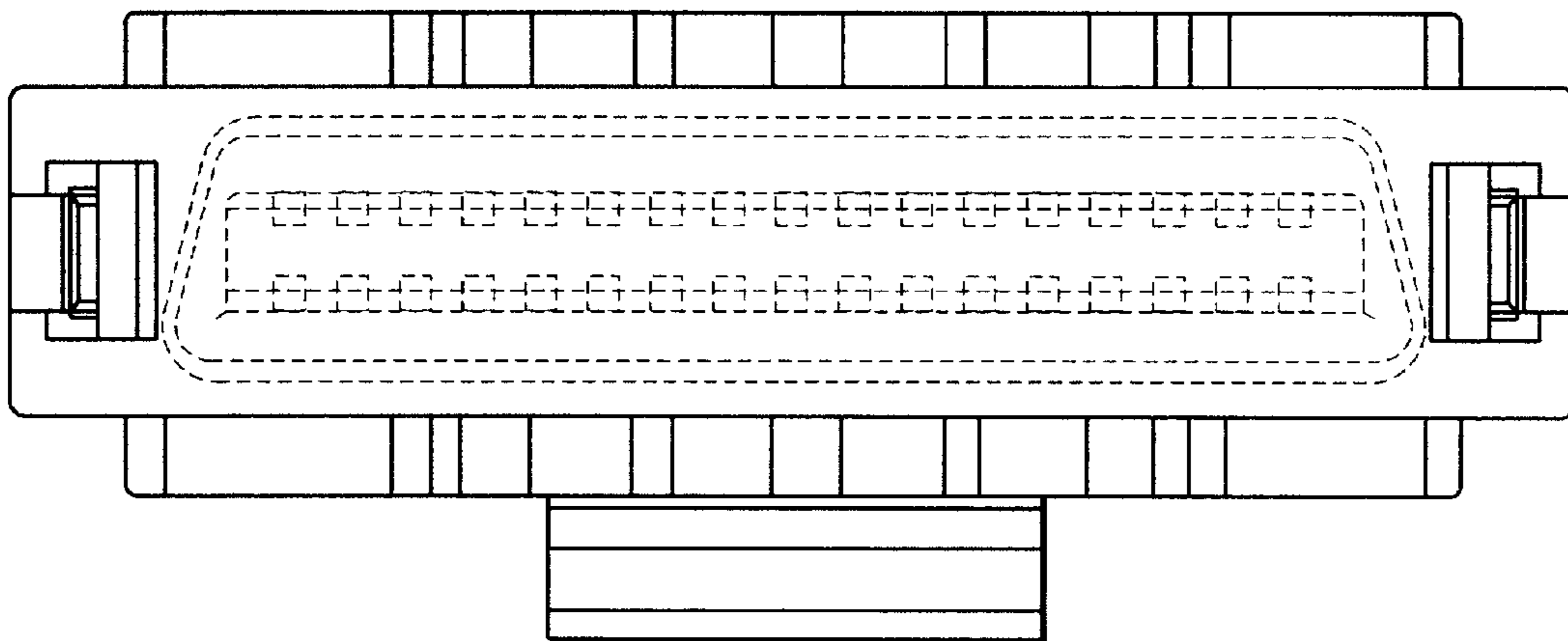

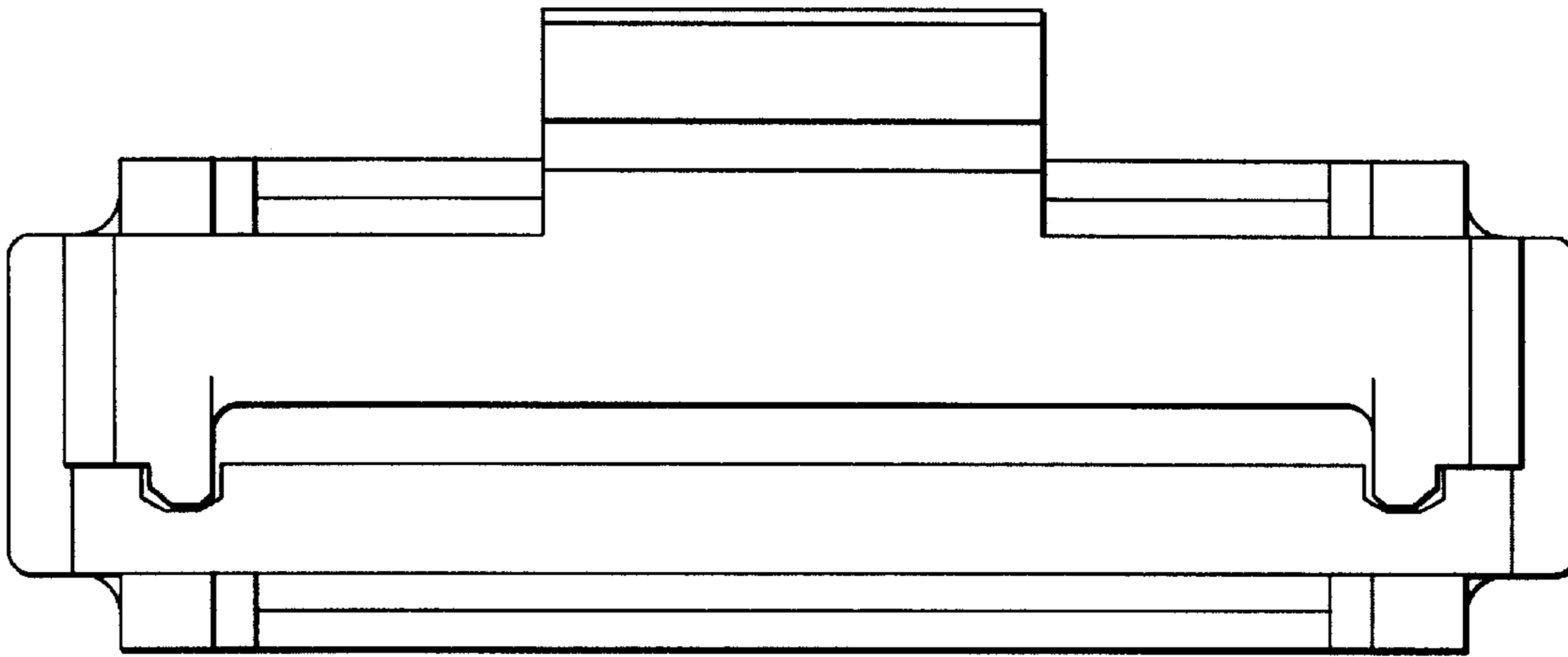

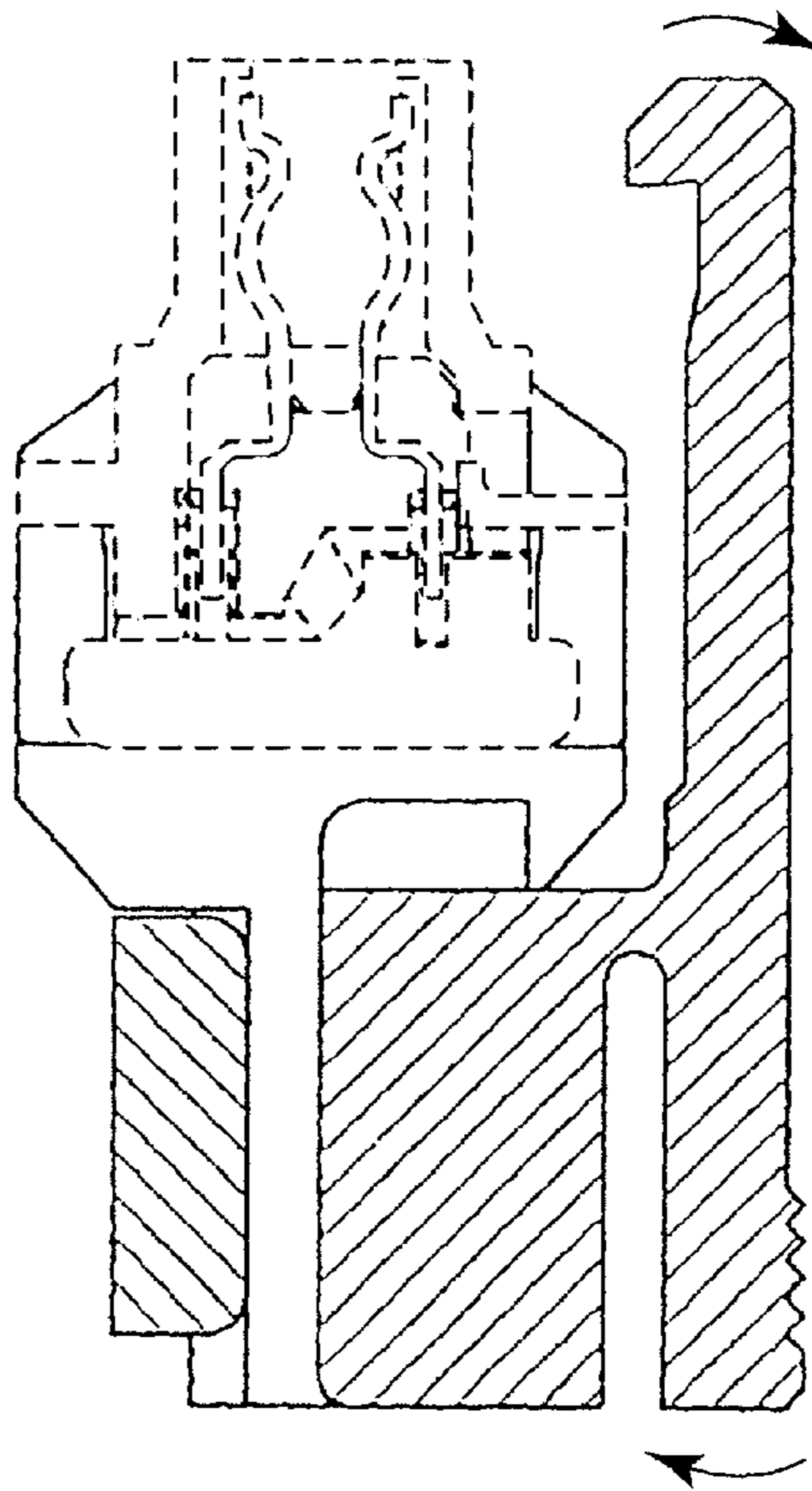
