The ornamental design for a controller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the controller showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof, and the left side is a mirror image;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a top plan view thereof; and,

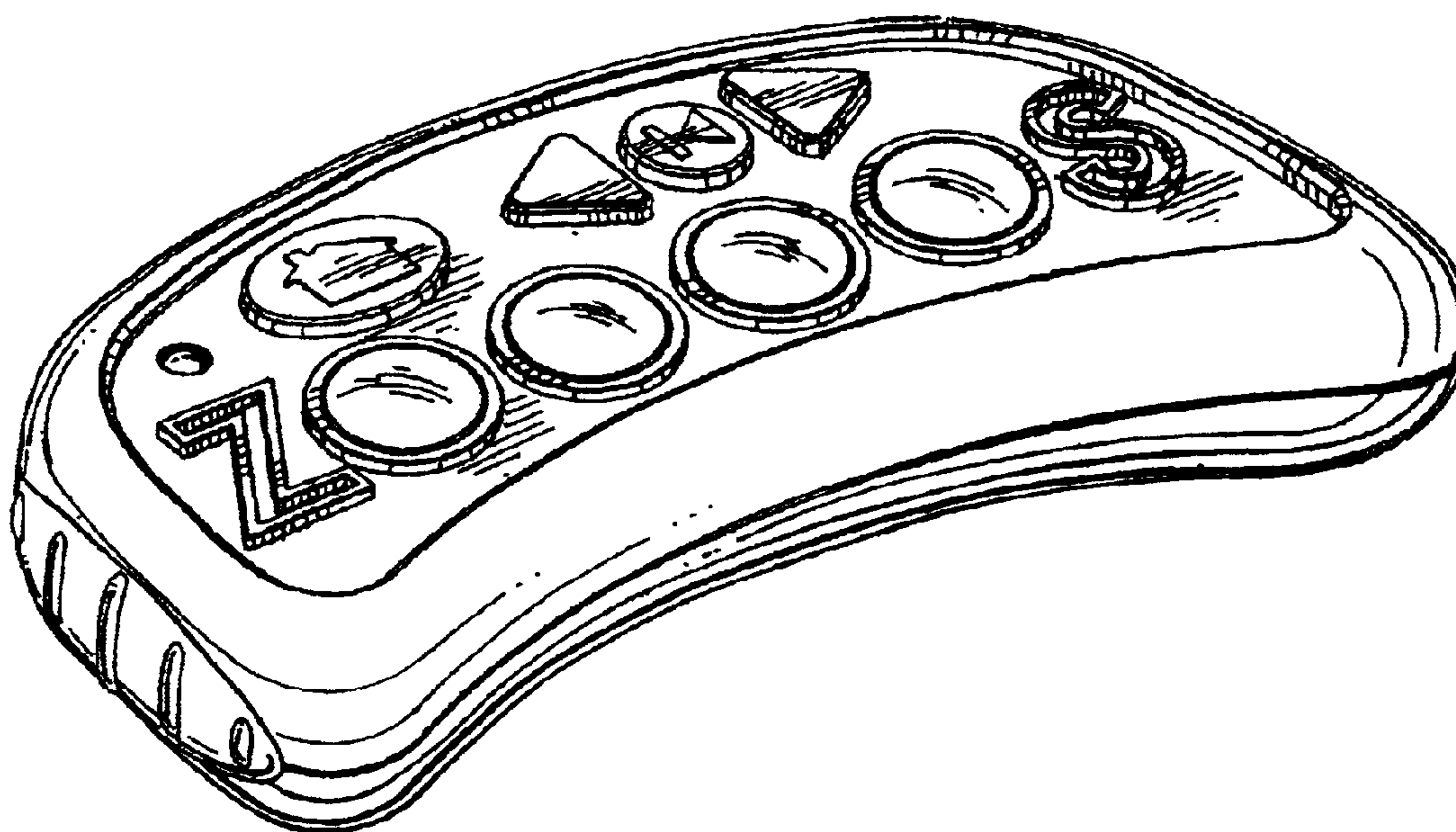

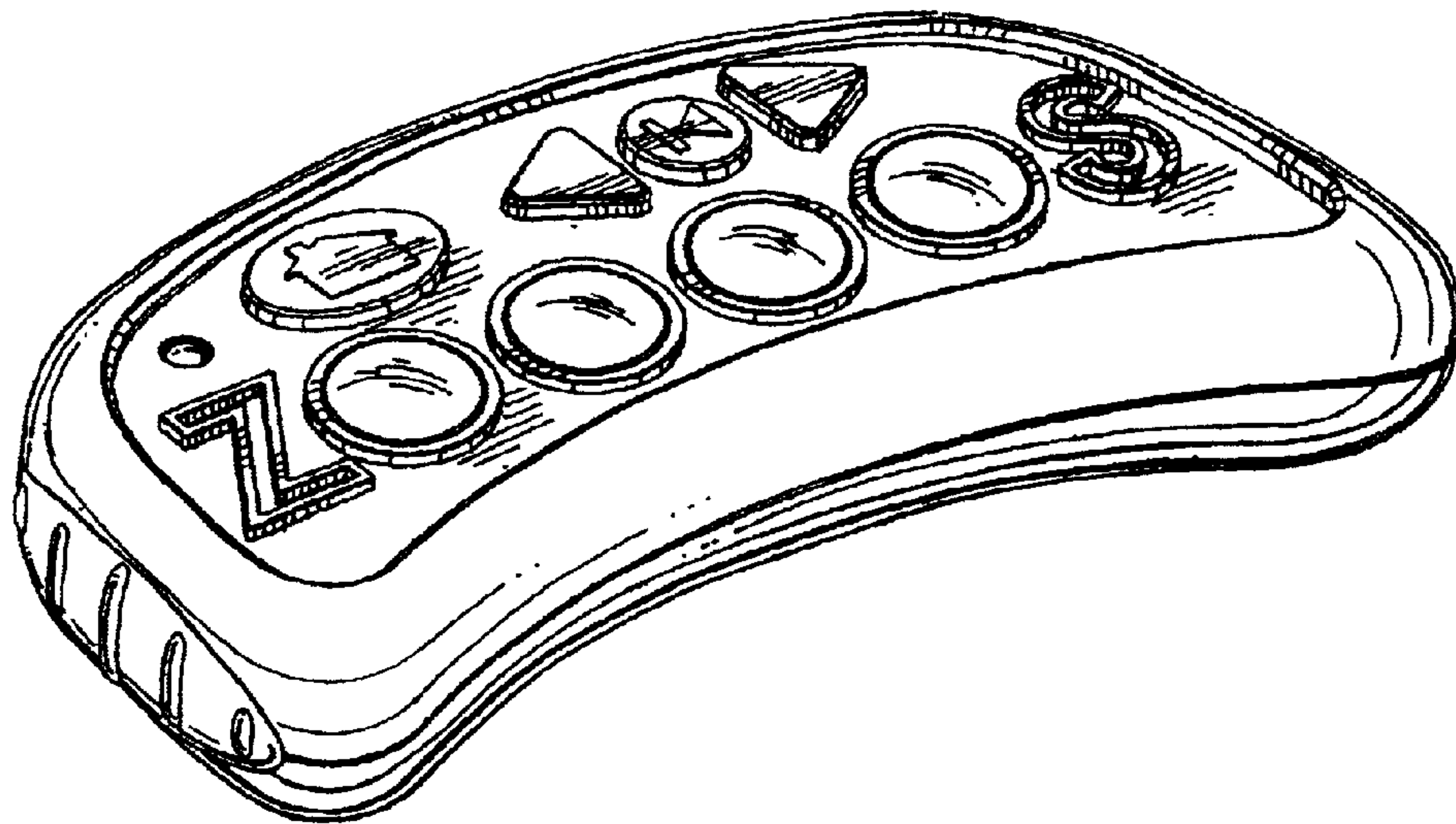

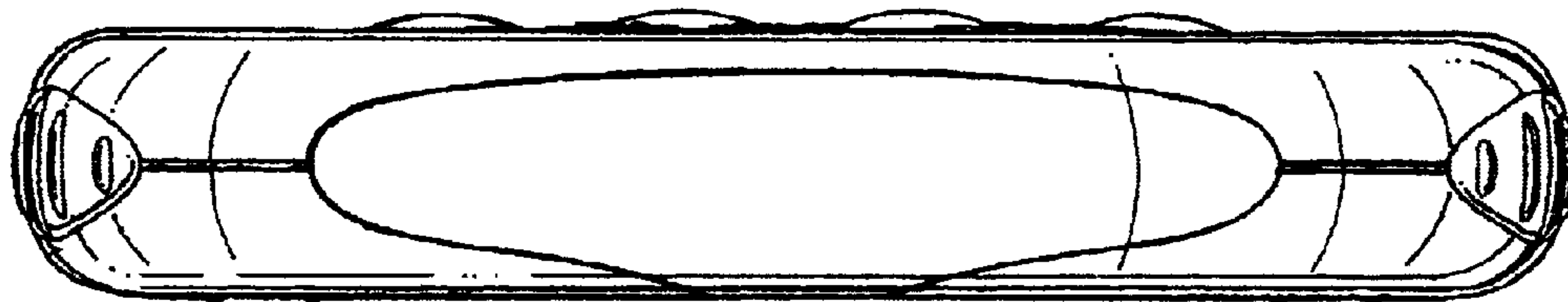

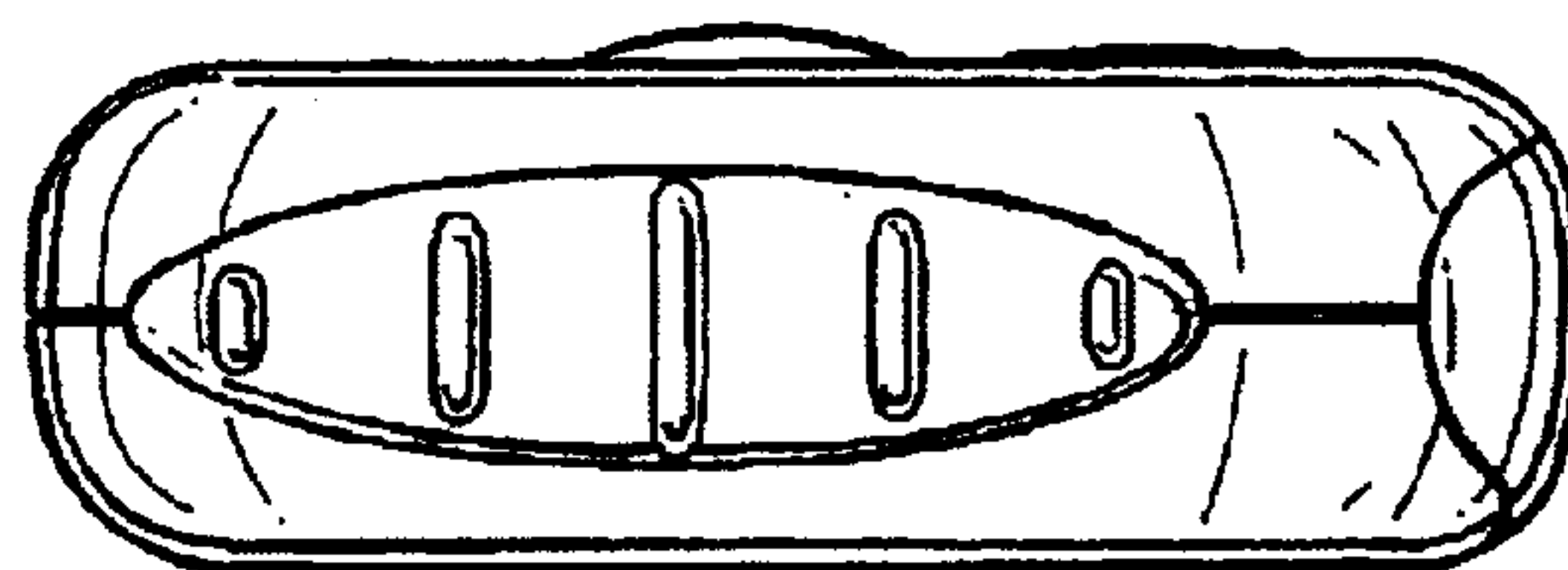

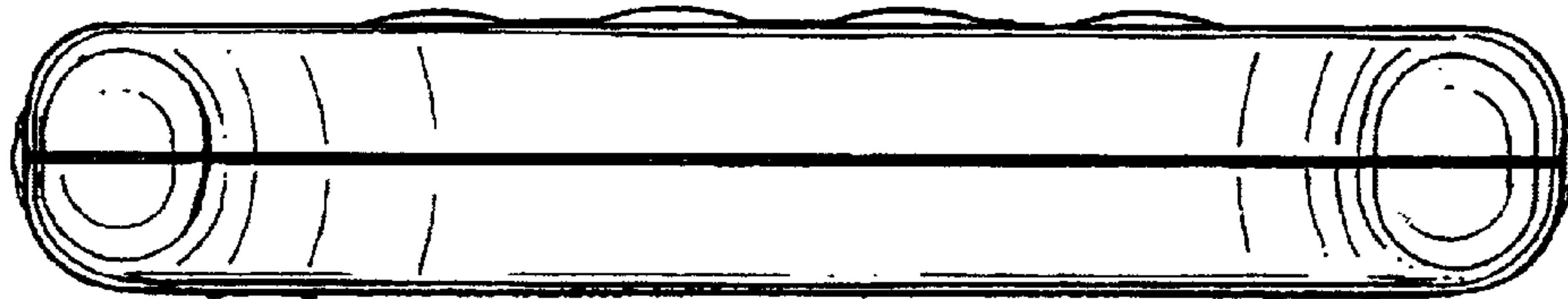

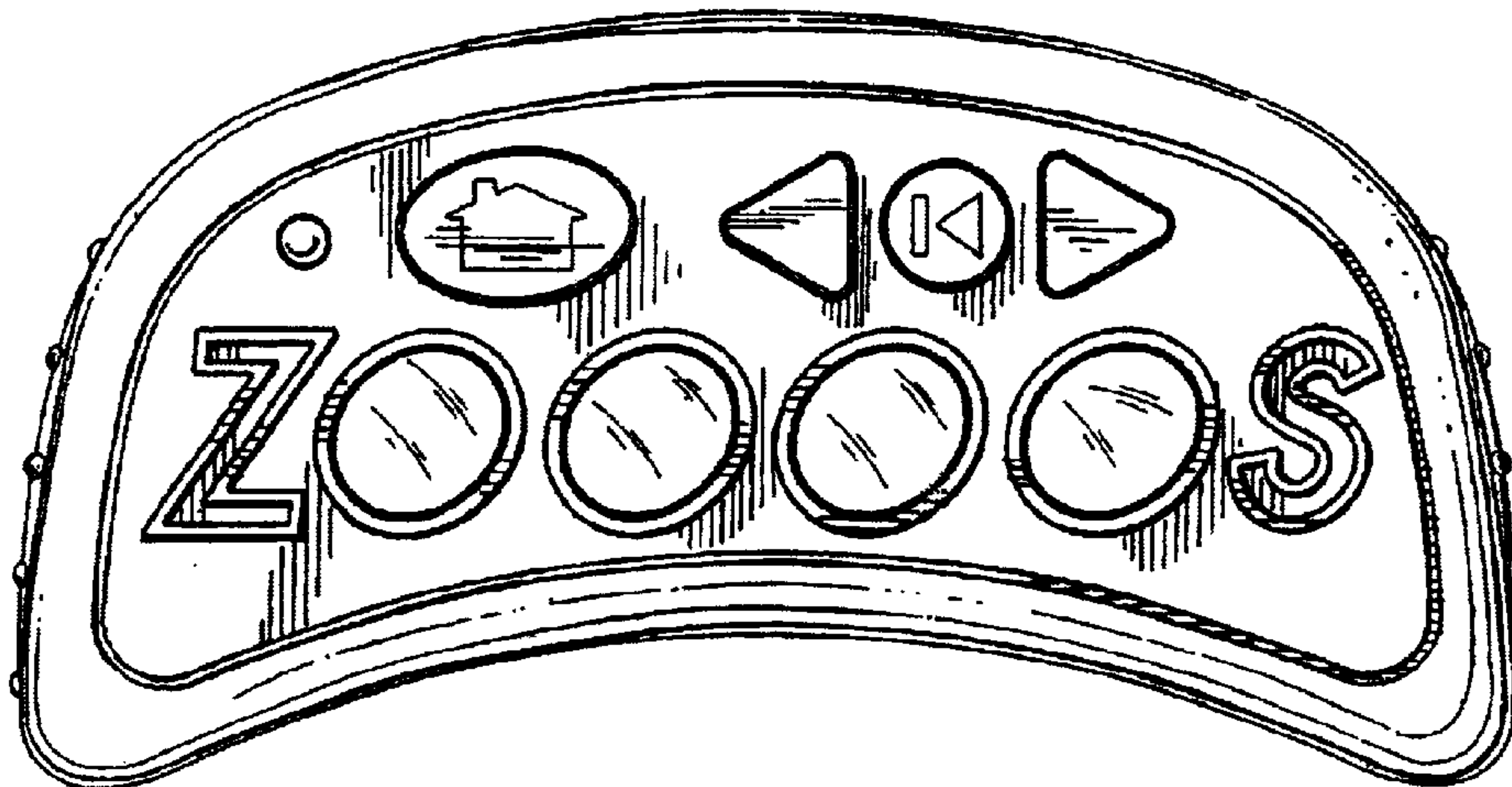
