The ornamental design for portions of a table saw, as shown and described.

#### DESCRIPTION

FIG. 1 is a right side elevational view of a first embodiment of portions of a table saw showing our new design; and, FIG. 2 is a rear perspective view from the right side of the first embodiment.

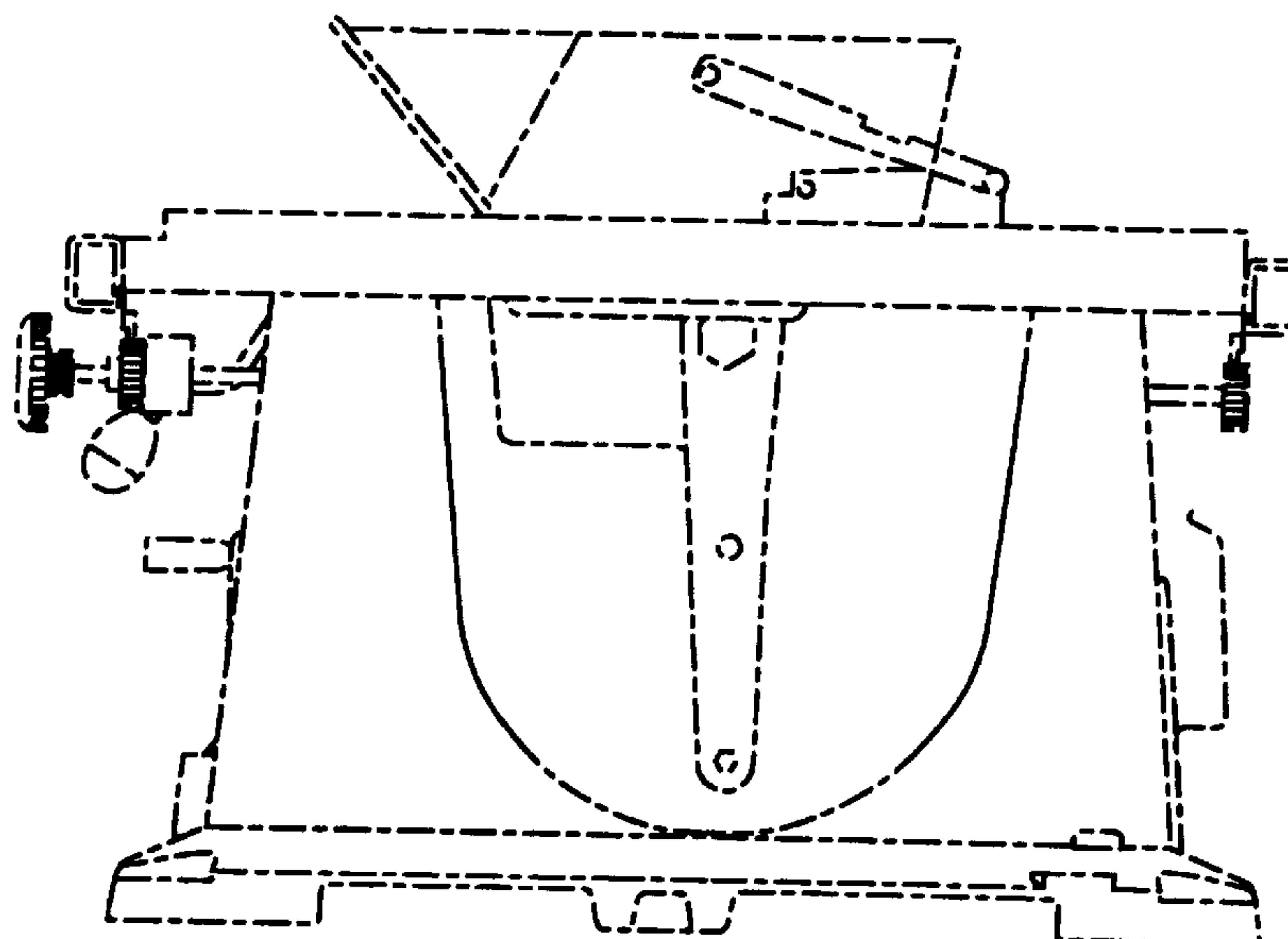

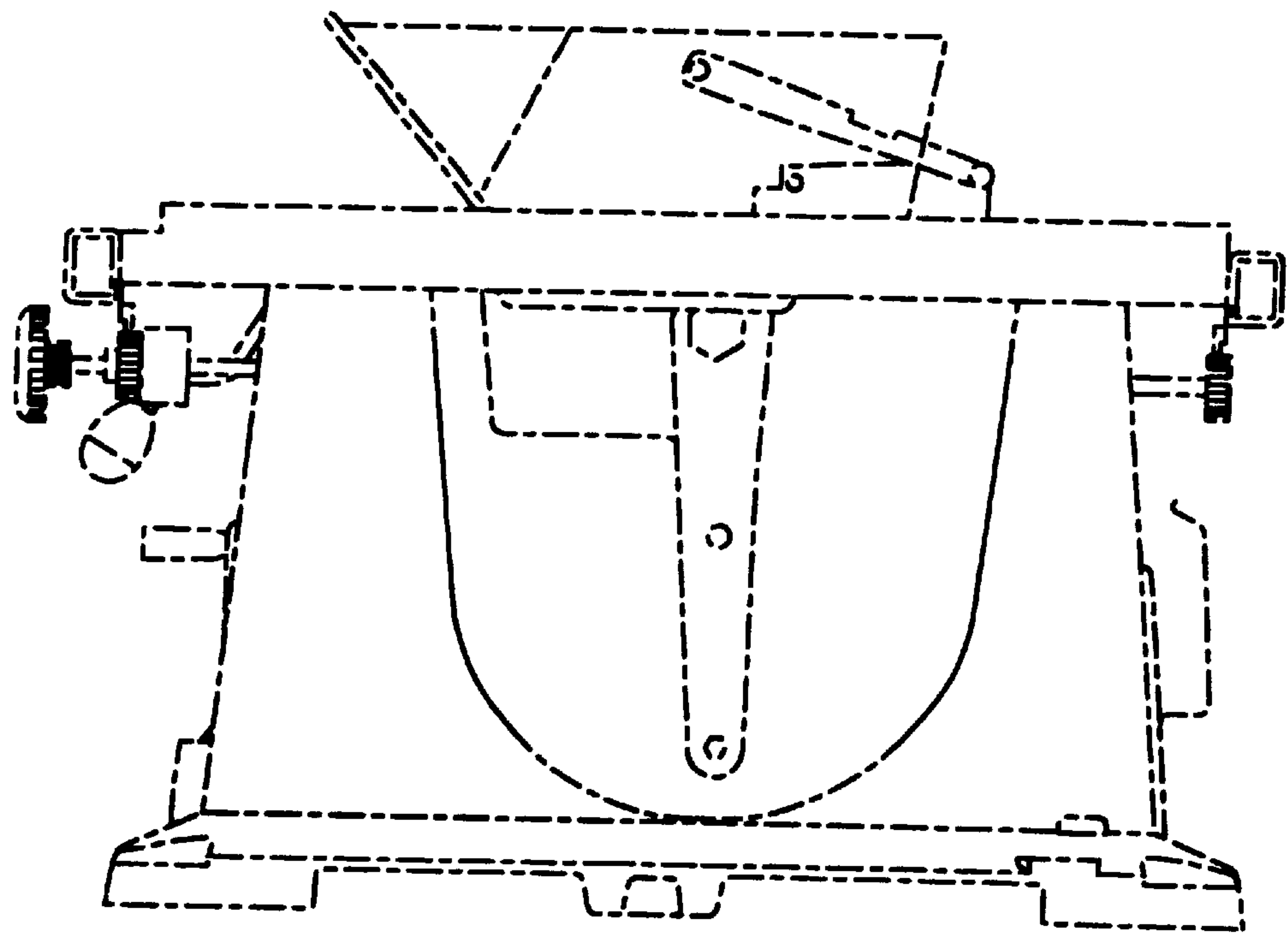
