The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club head showing our new design;

FIG. 2 is a front elevational view of the golf club head of FIG. 1;

FIG. 3 is a top view of the golf club head of FIG. 1;

FIG. 4 is a rear elevational view of the golf club head of FIG. 1;

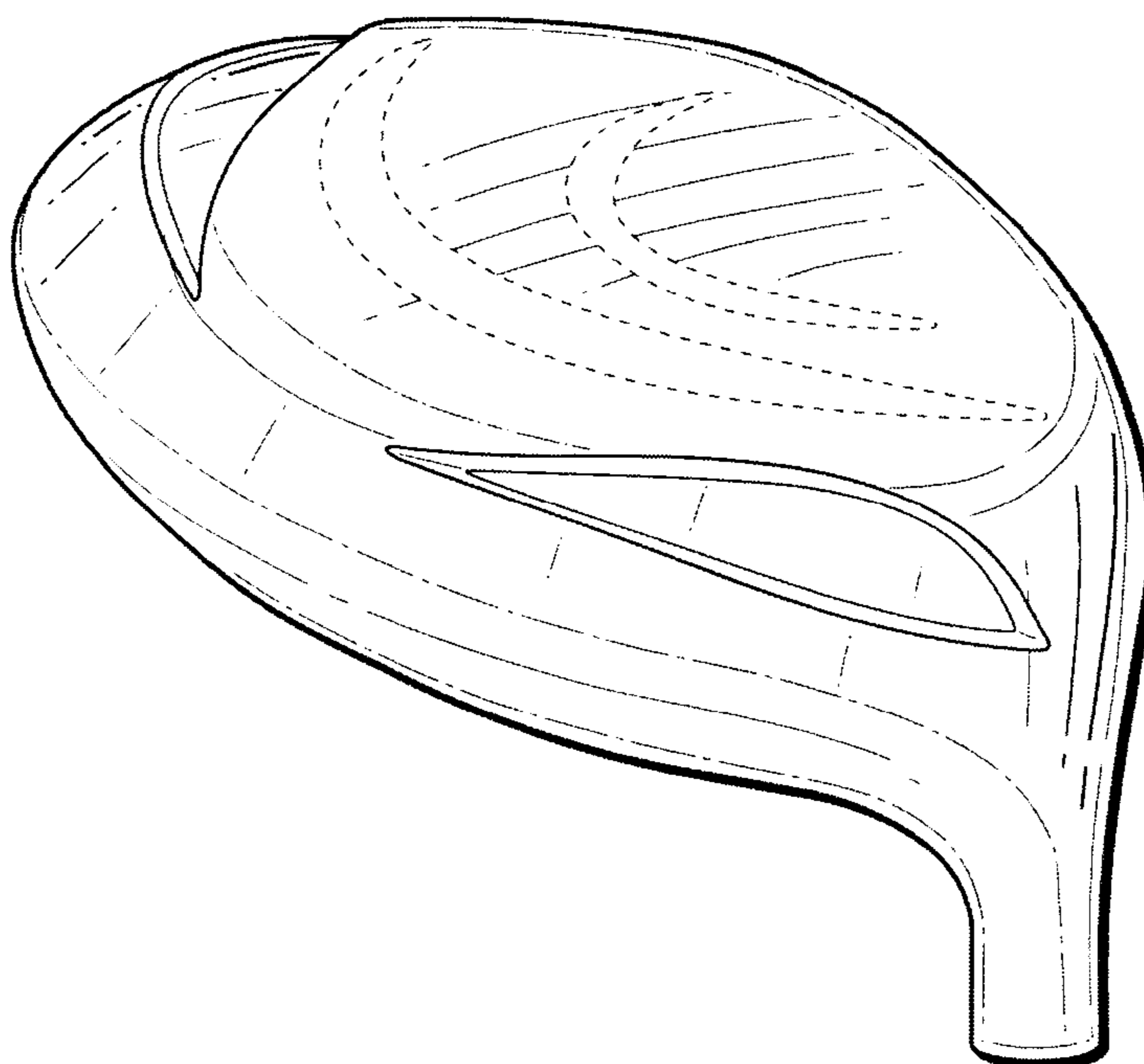
FIG. 5 is a heel end view of the golf club head of FIG. 1;

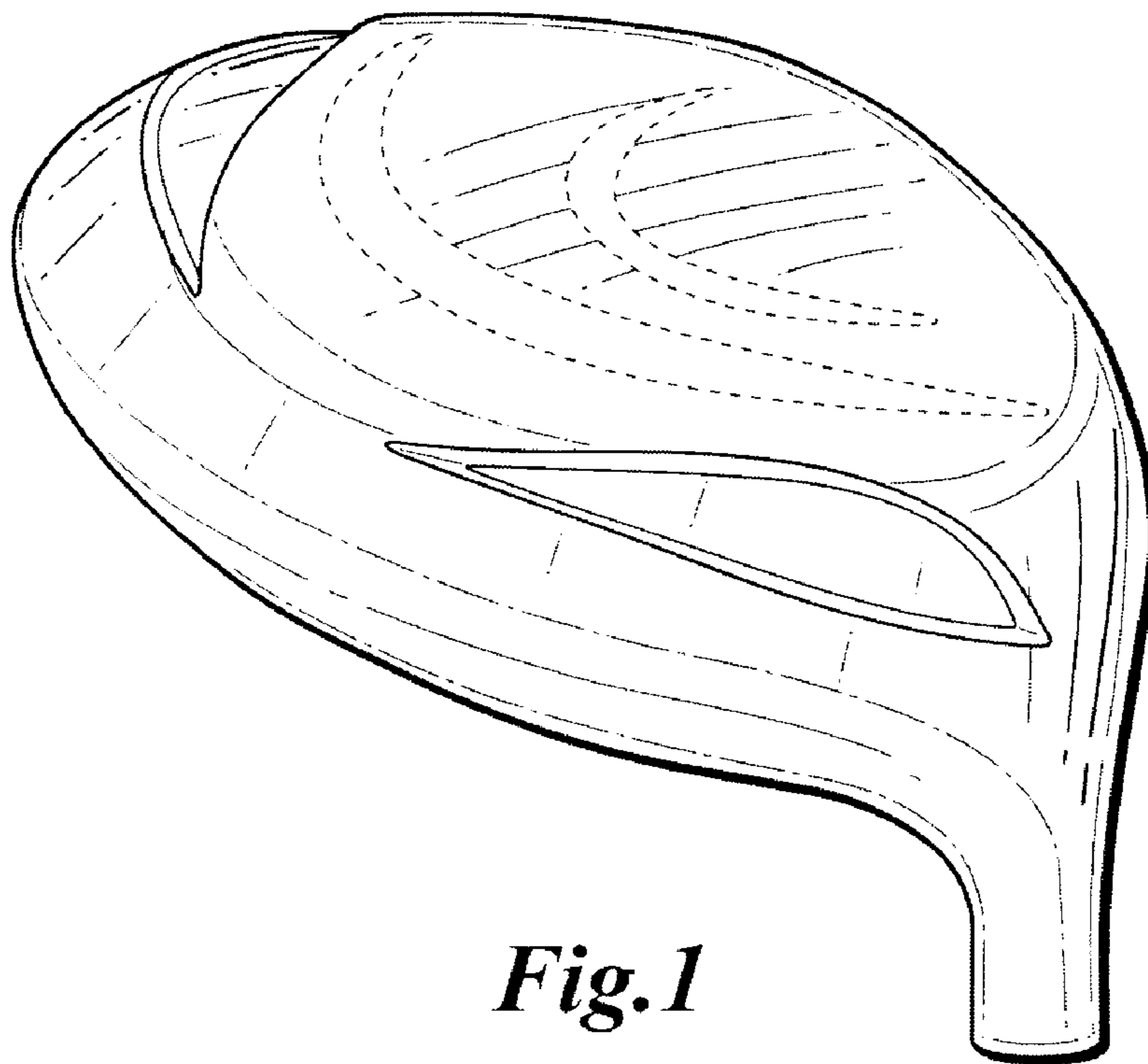

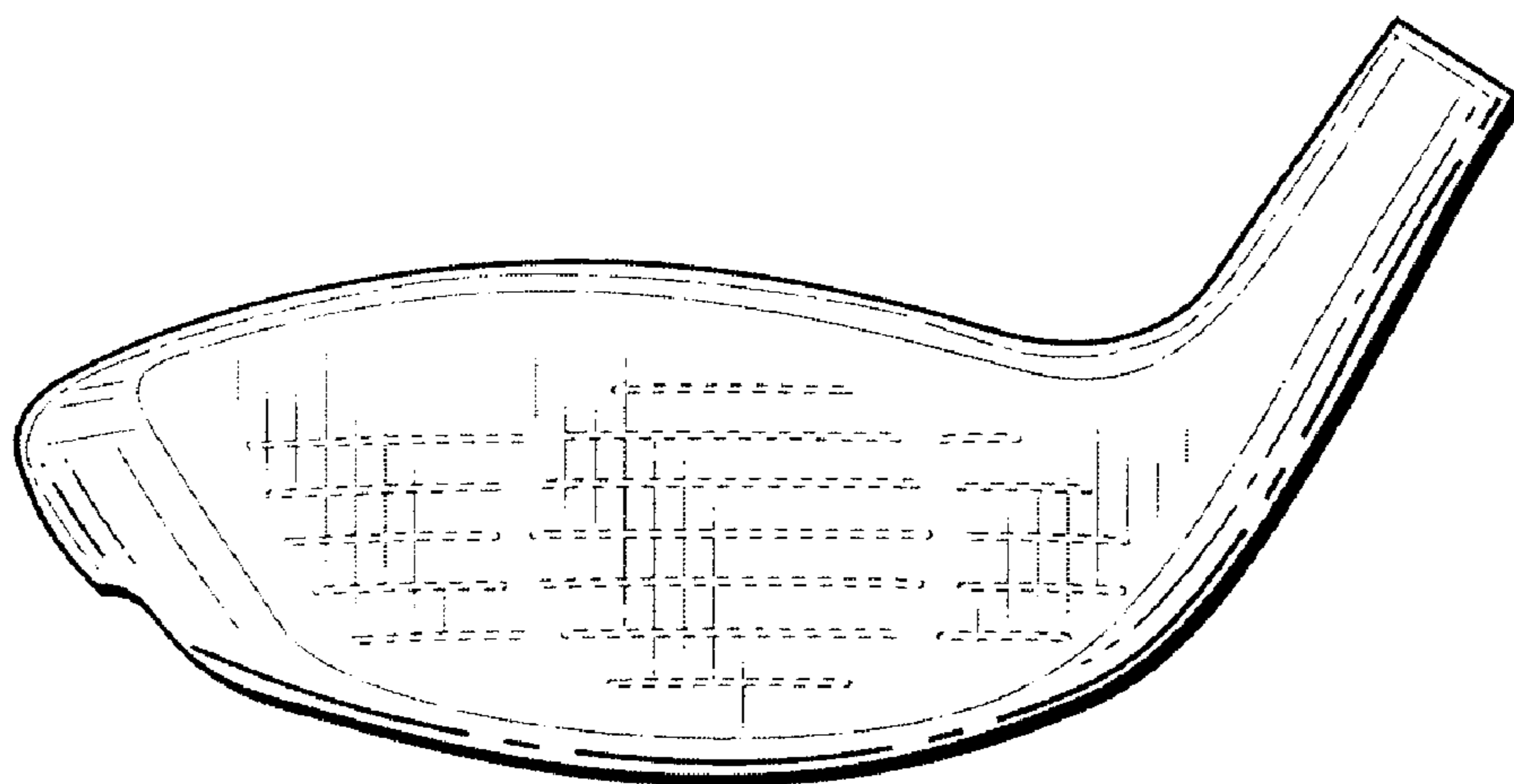

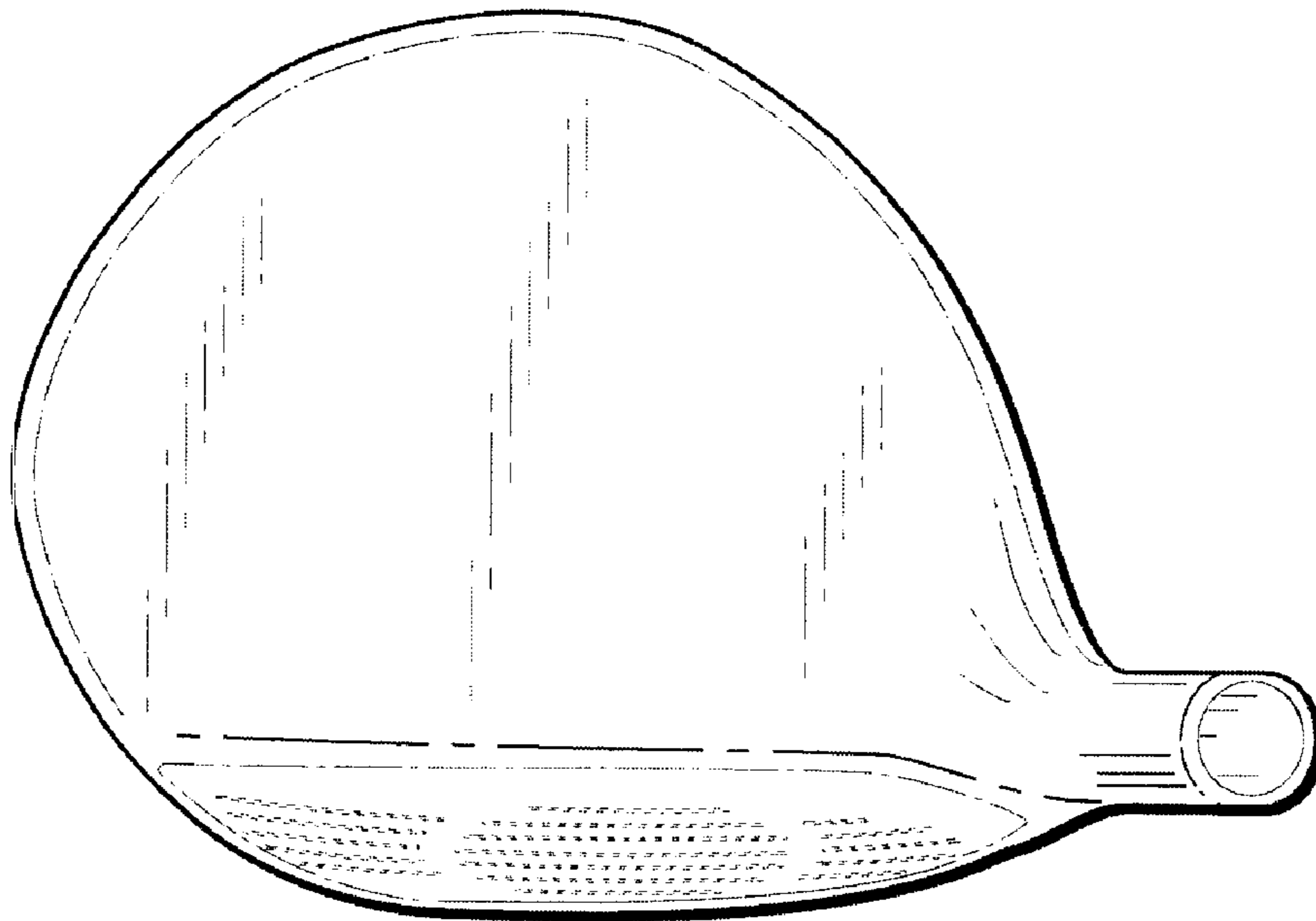

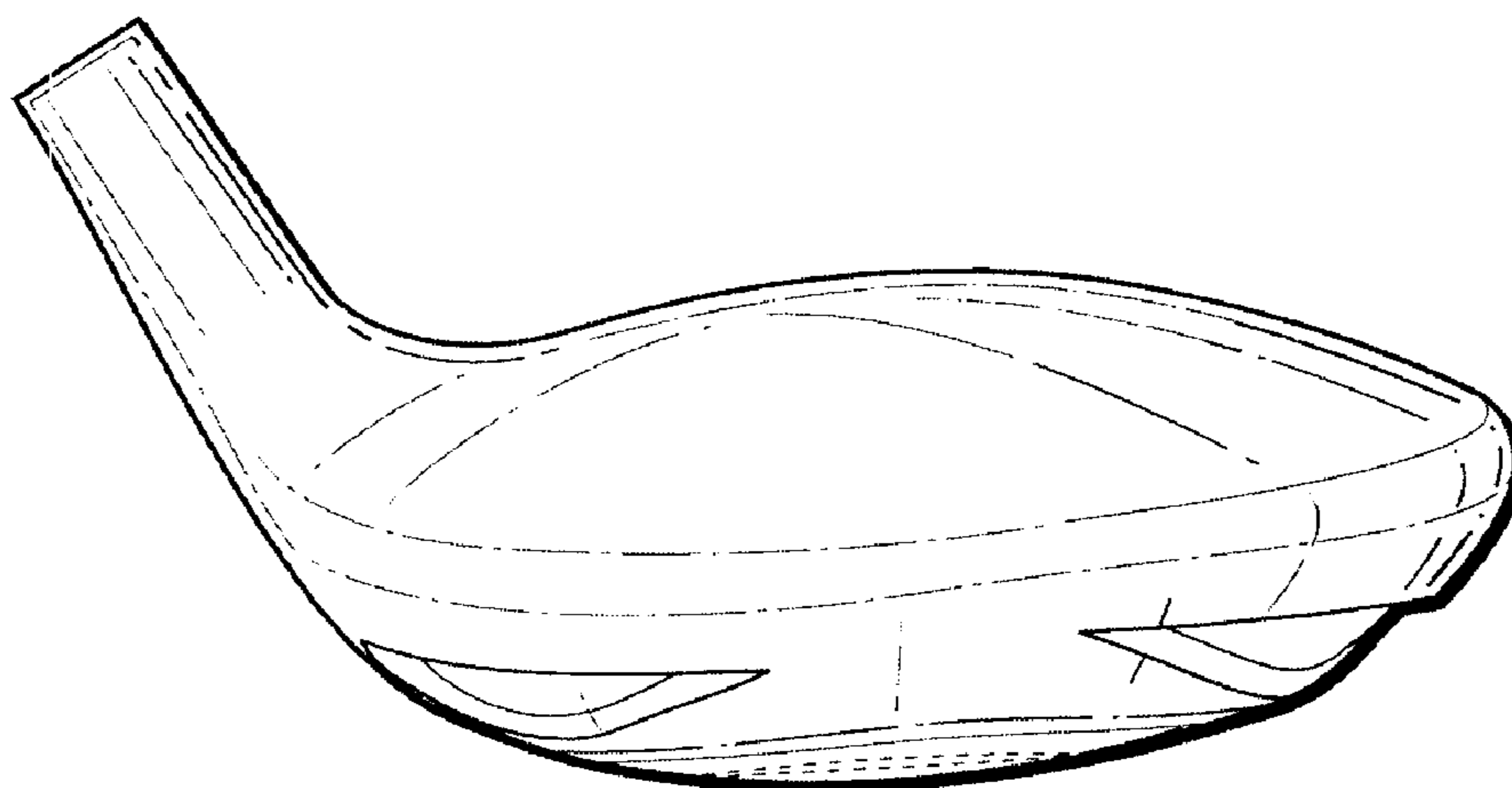

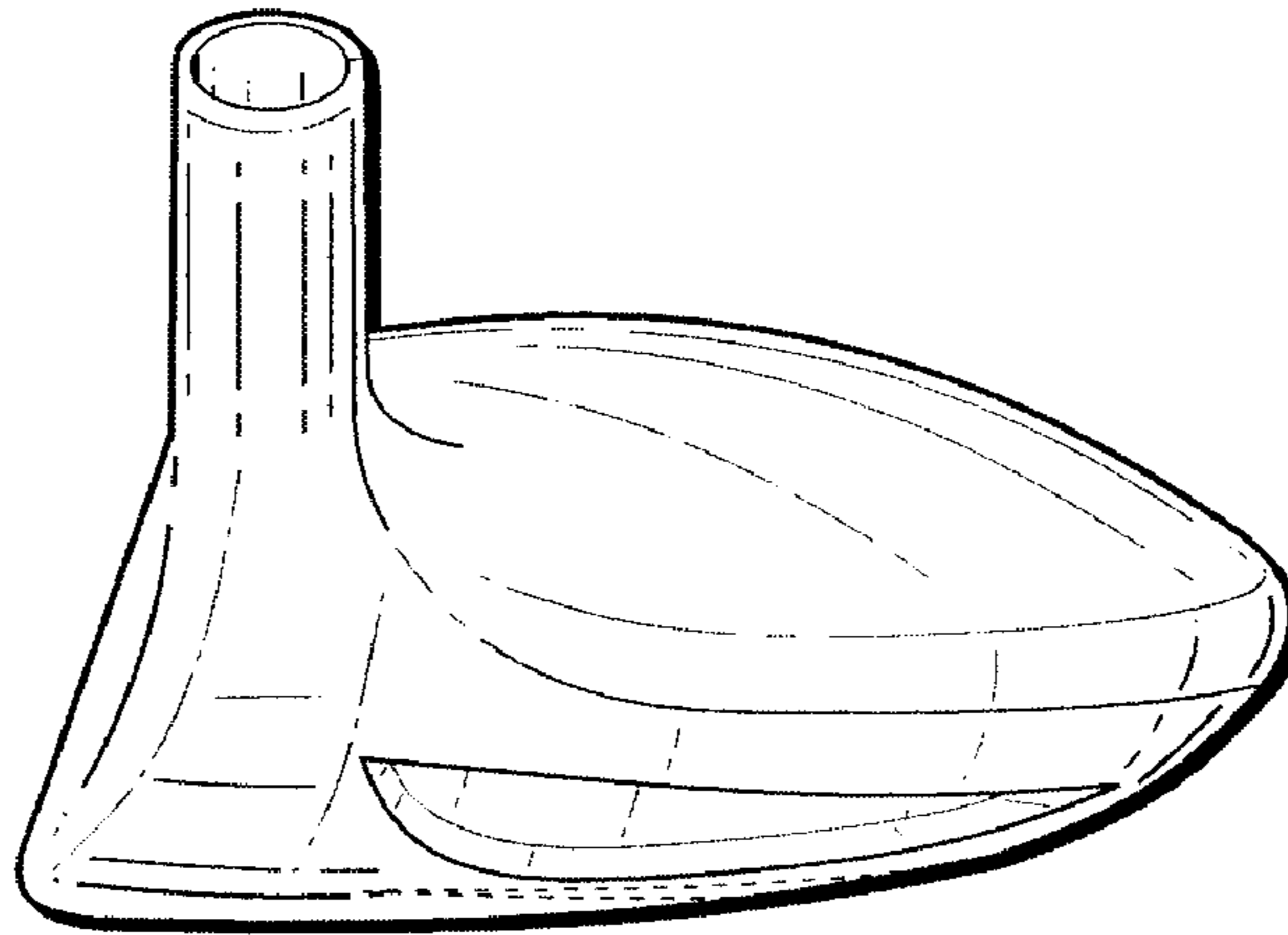

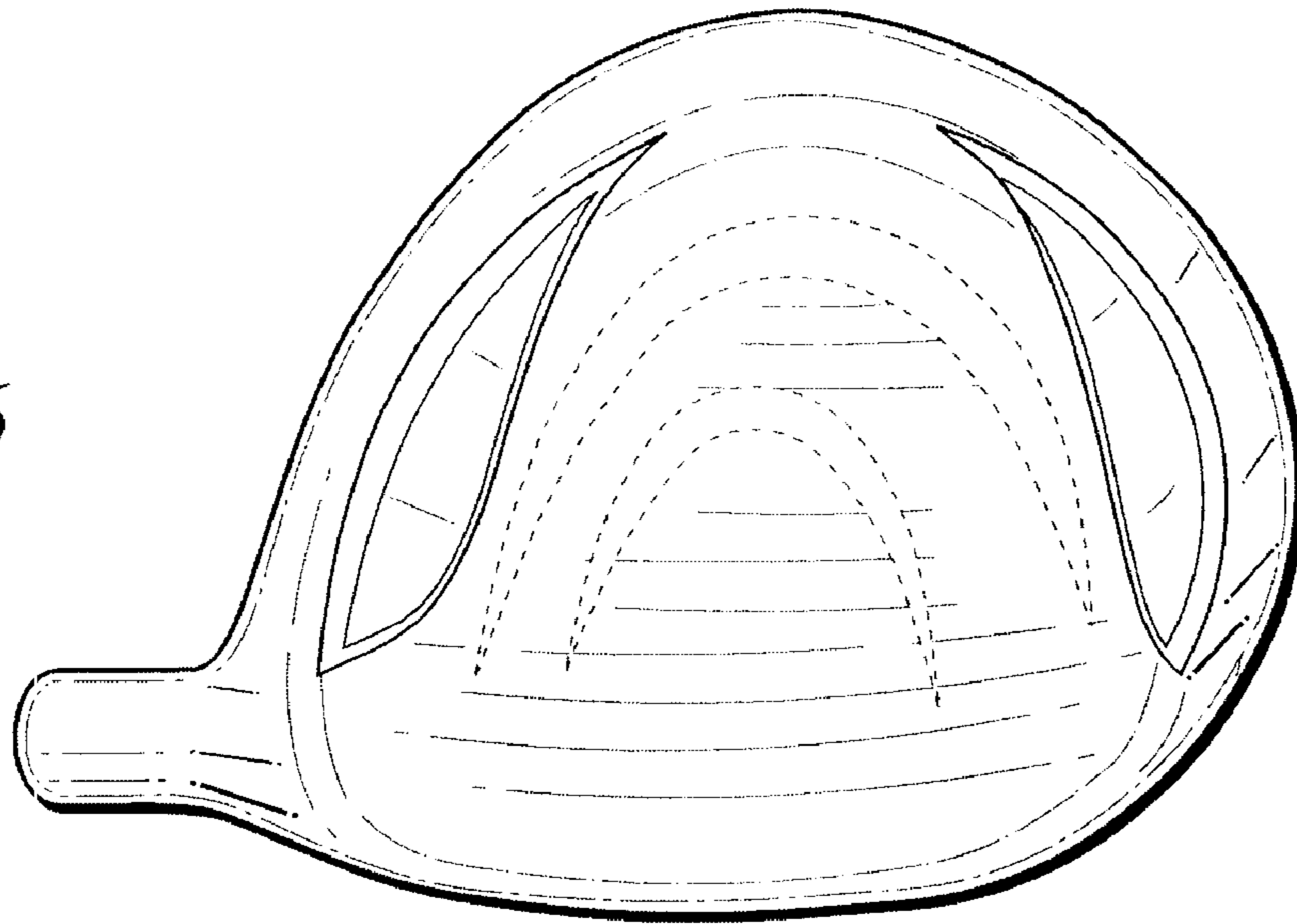
