DESCRIPTION

FIG. 3 is a right side view of the new design for a faucet handle;

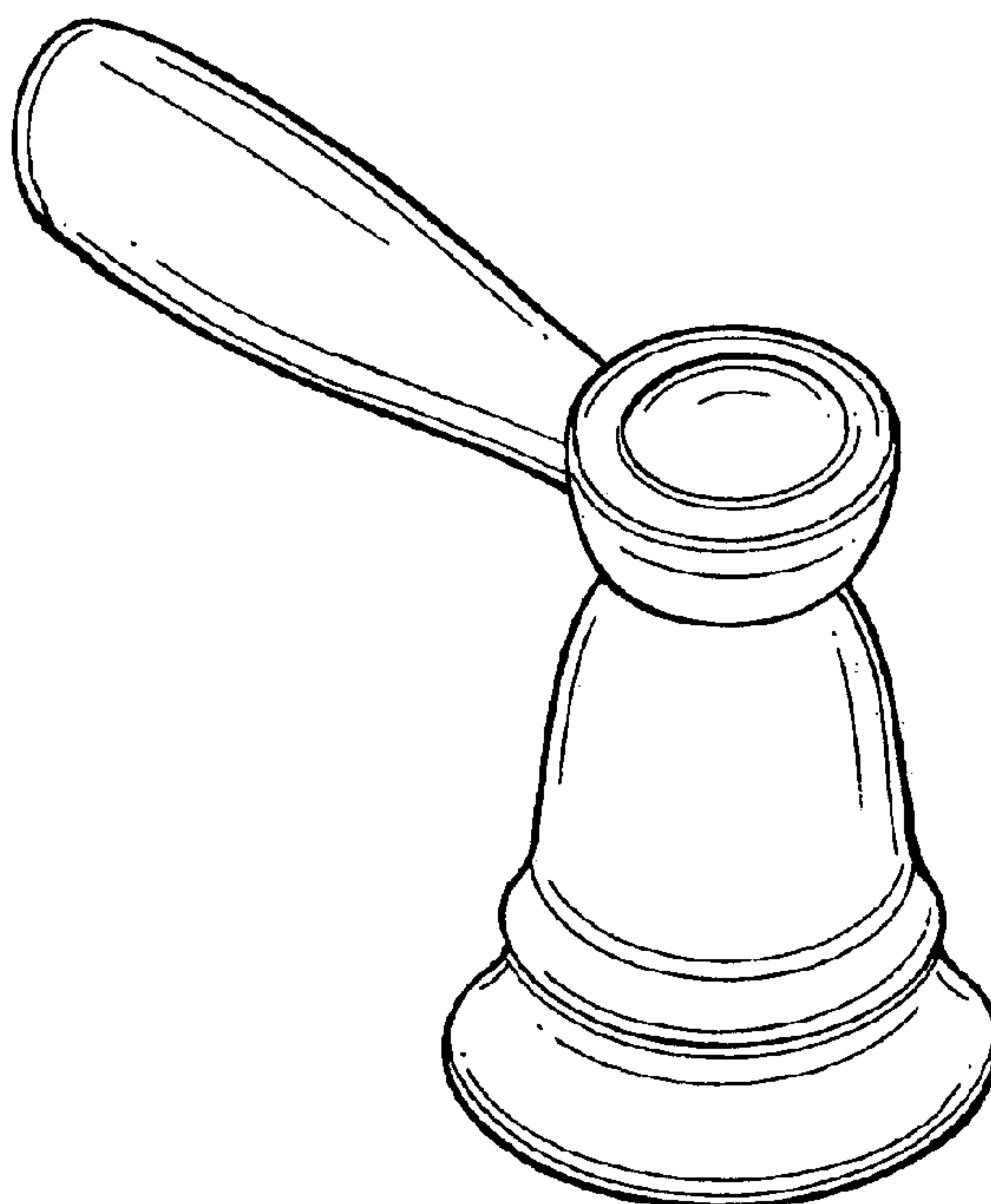
FIG. 4 is the left side view of the new design for a faucet handle.

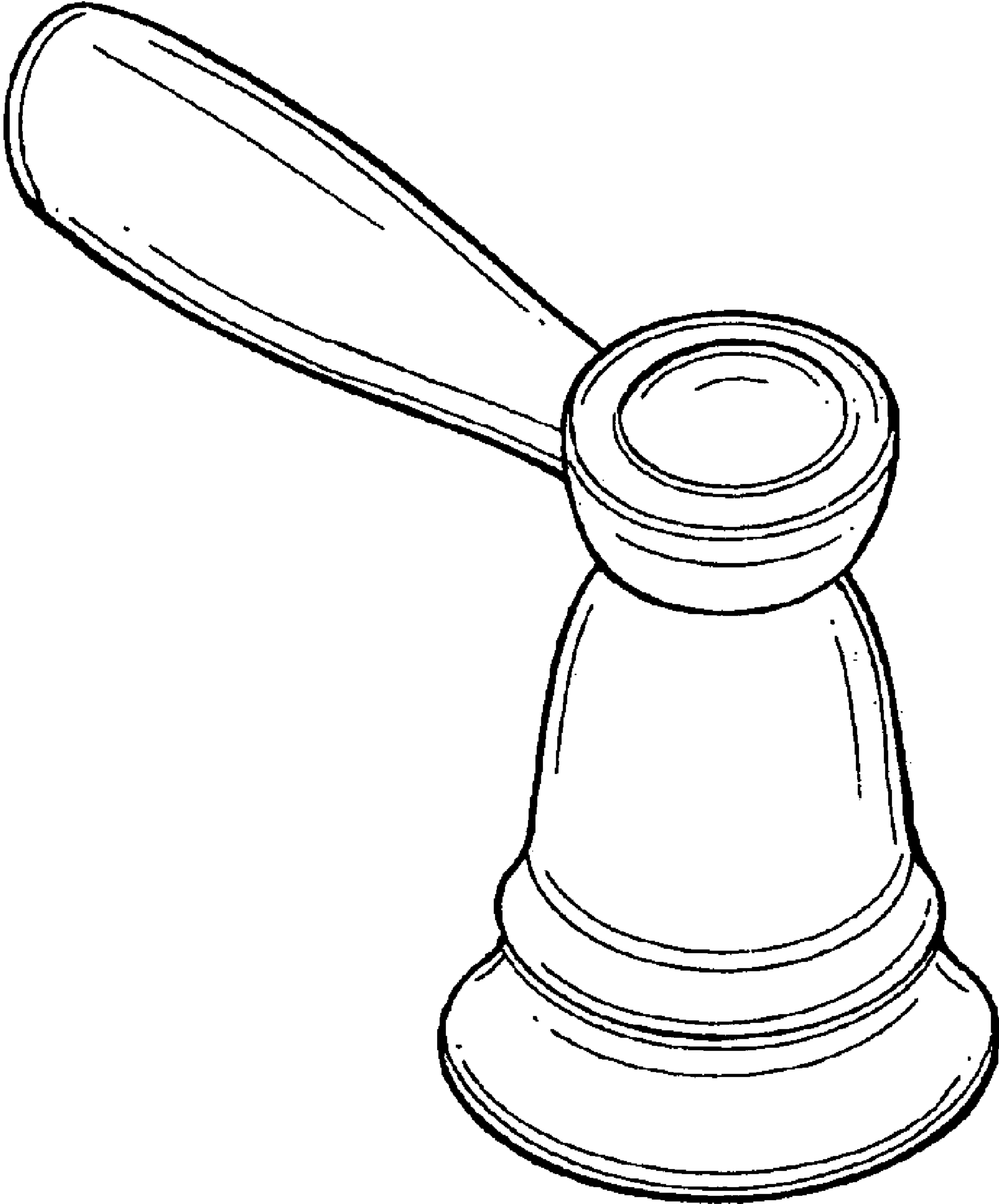

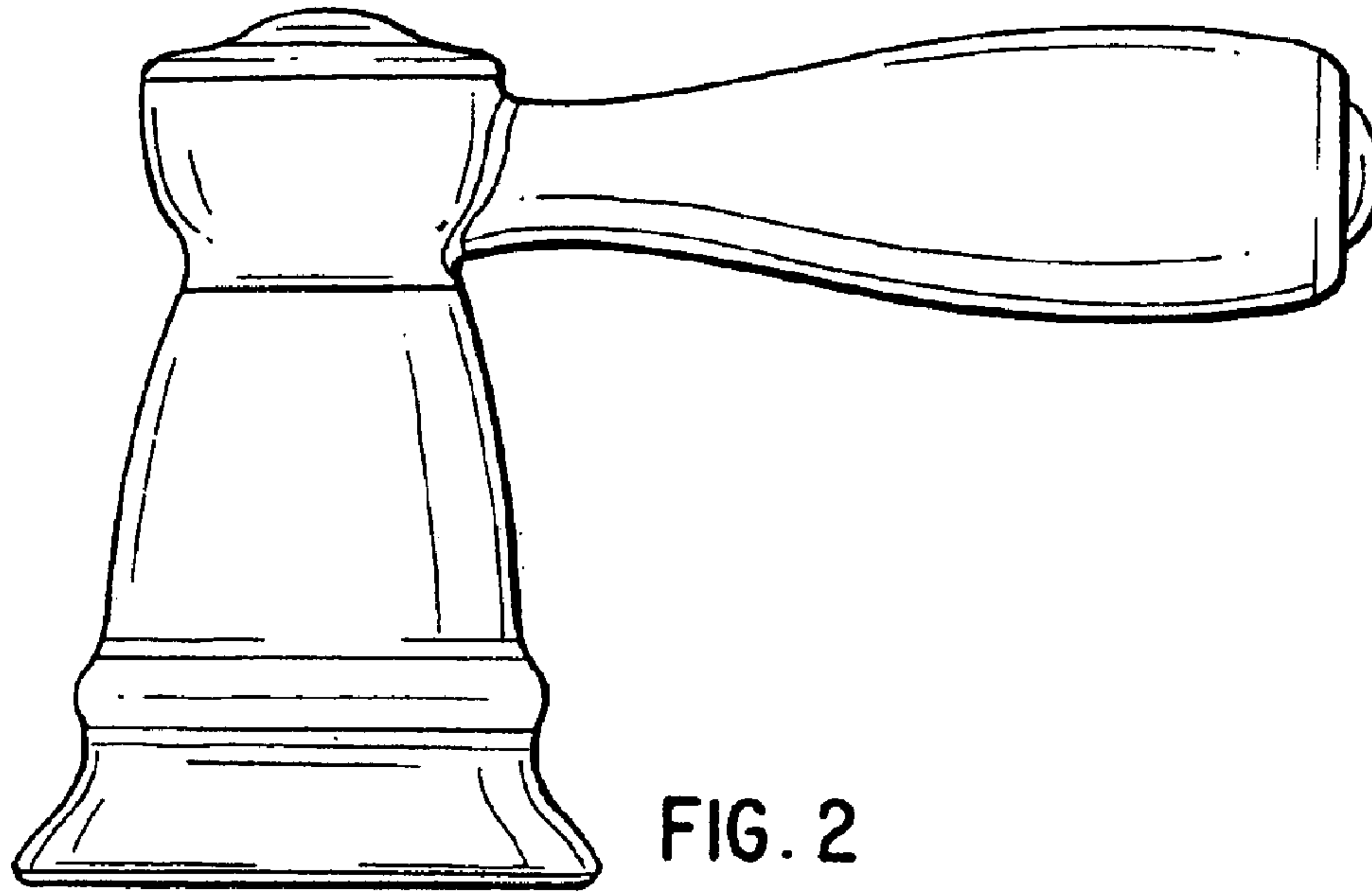

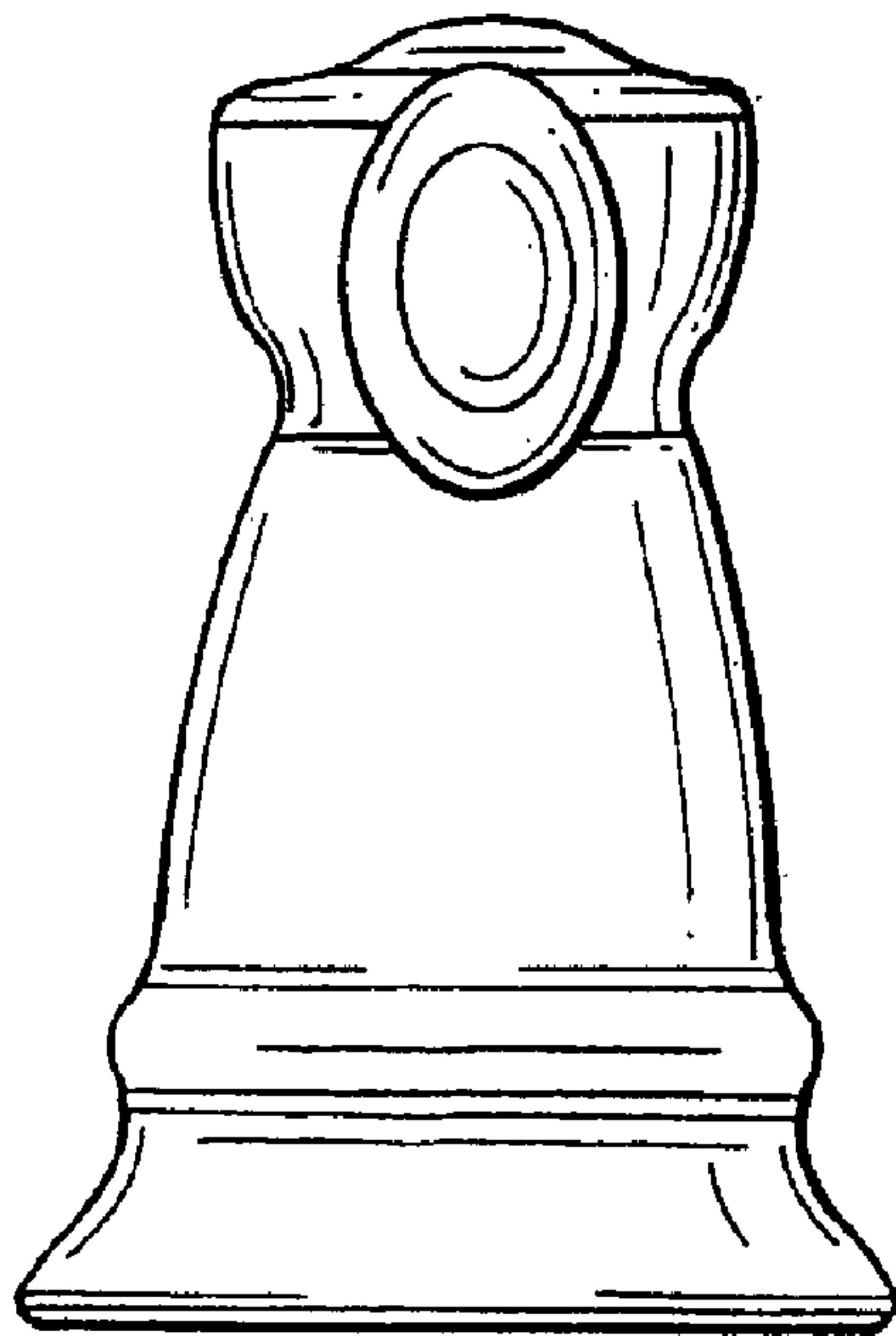

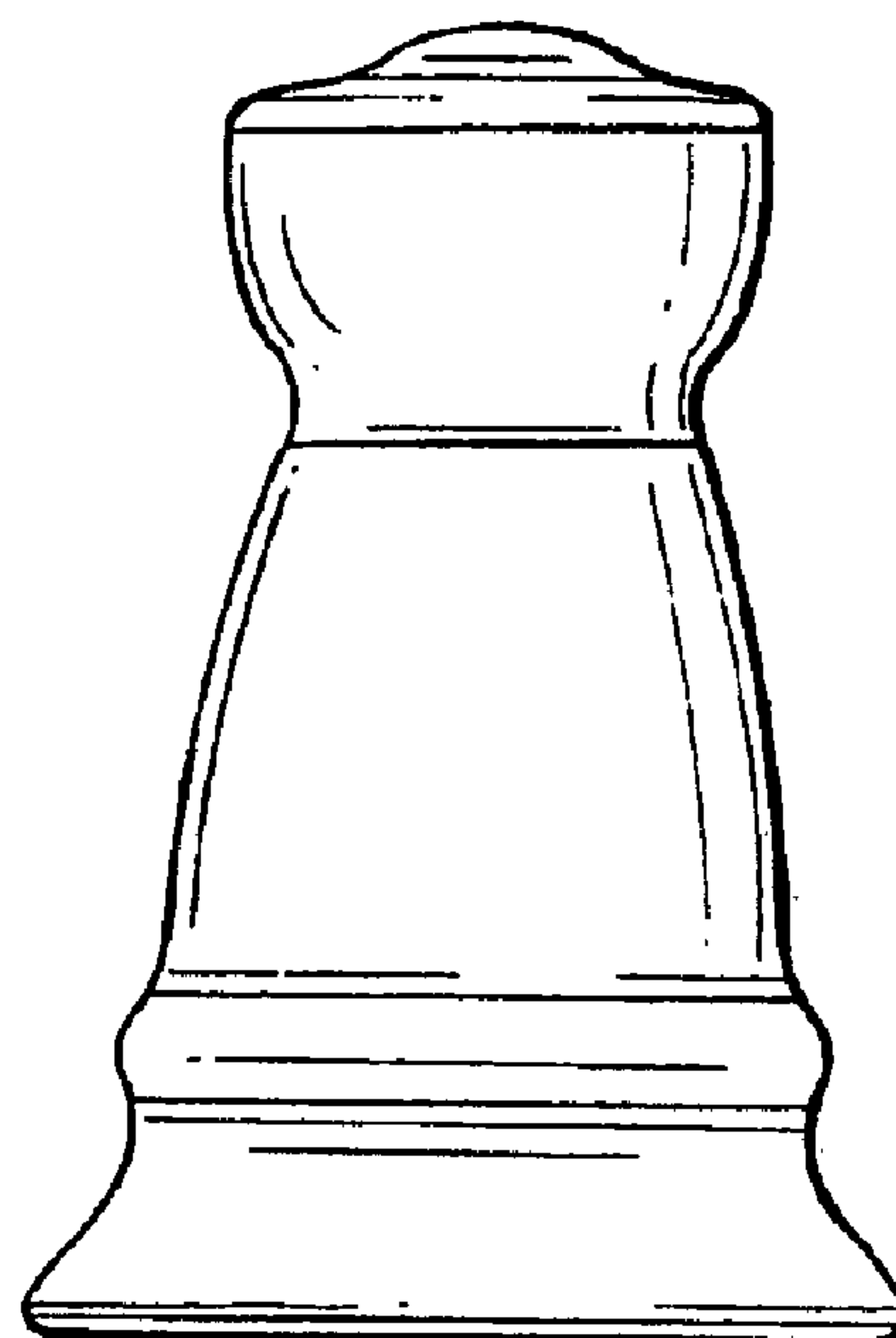

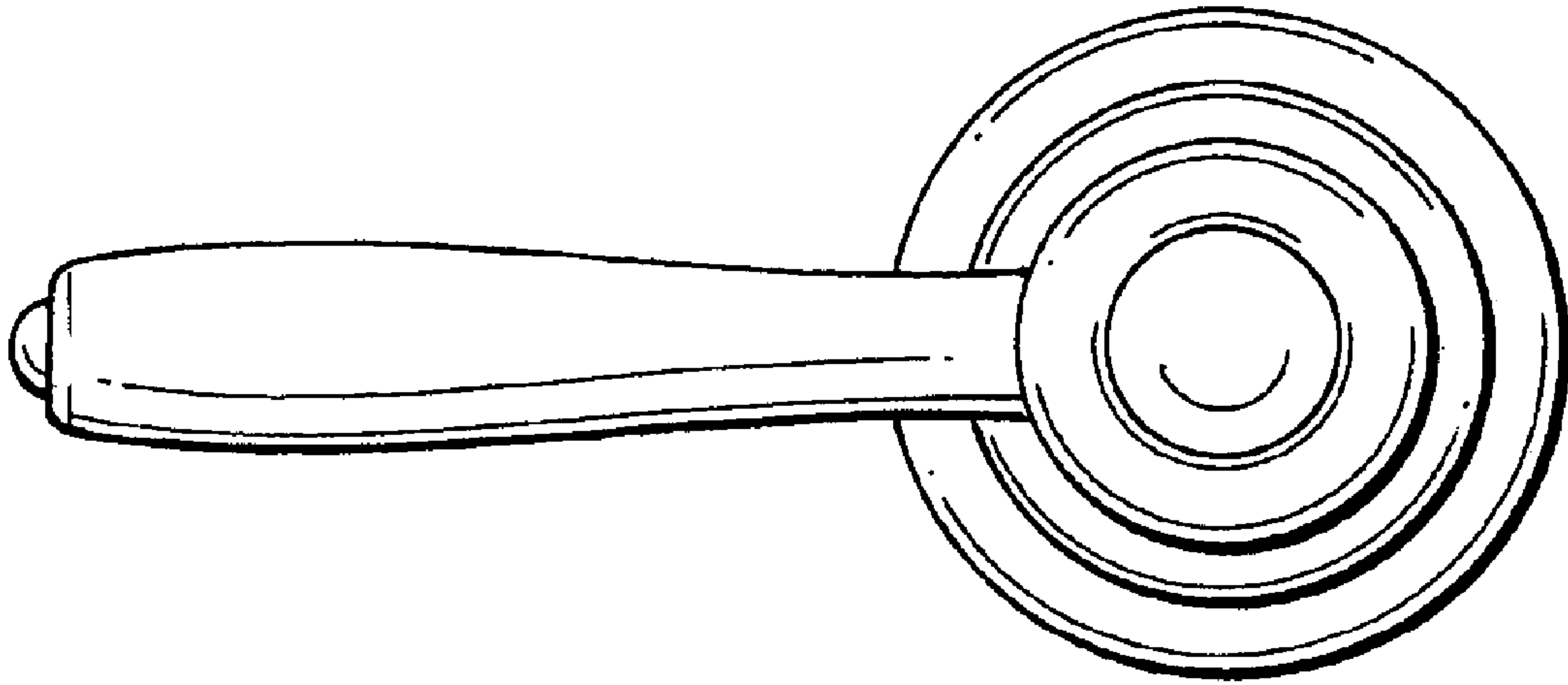

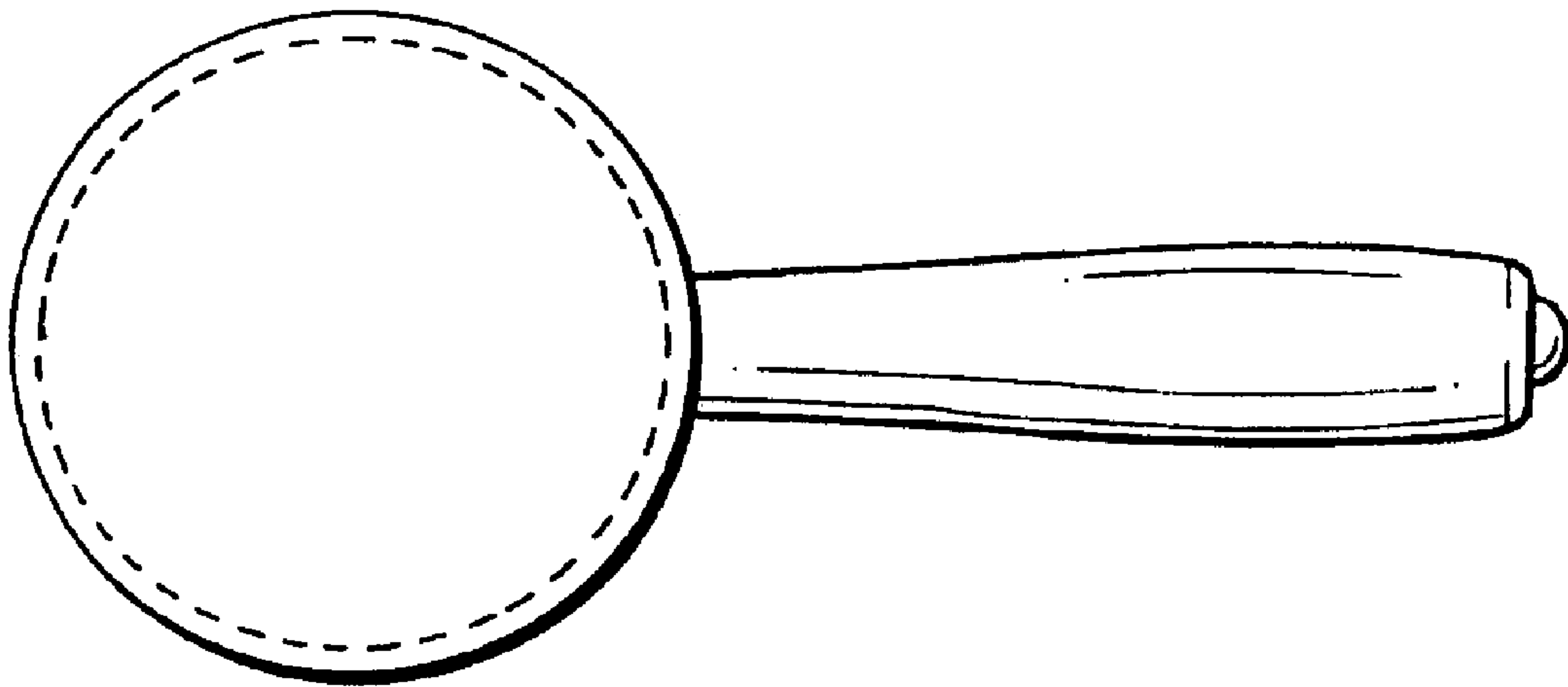
