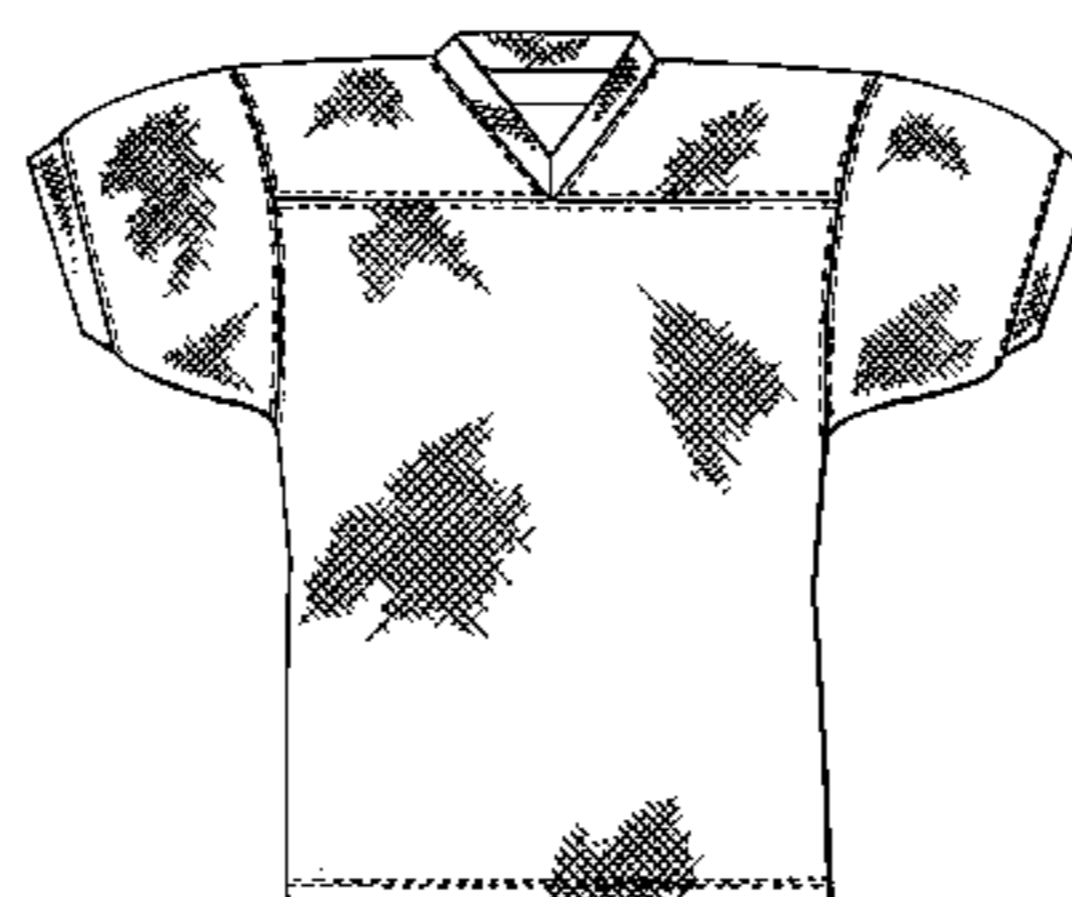
(57) **CLAIM**

We claim the ornamental design for an athletic jersey, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the design for an athletic jersey;
FIG. 2 is a rear elevational view of the design for an athletic jersey;
FIG. 3 is a front perspective view of the design for an athletic jersey; and,
FIG. 4 is a rear perspective view of the design for an athletic jersey.
The broken lines shown on the surfaces of FIGS. 1 and 2 represent stitching.

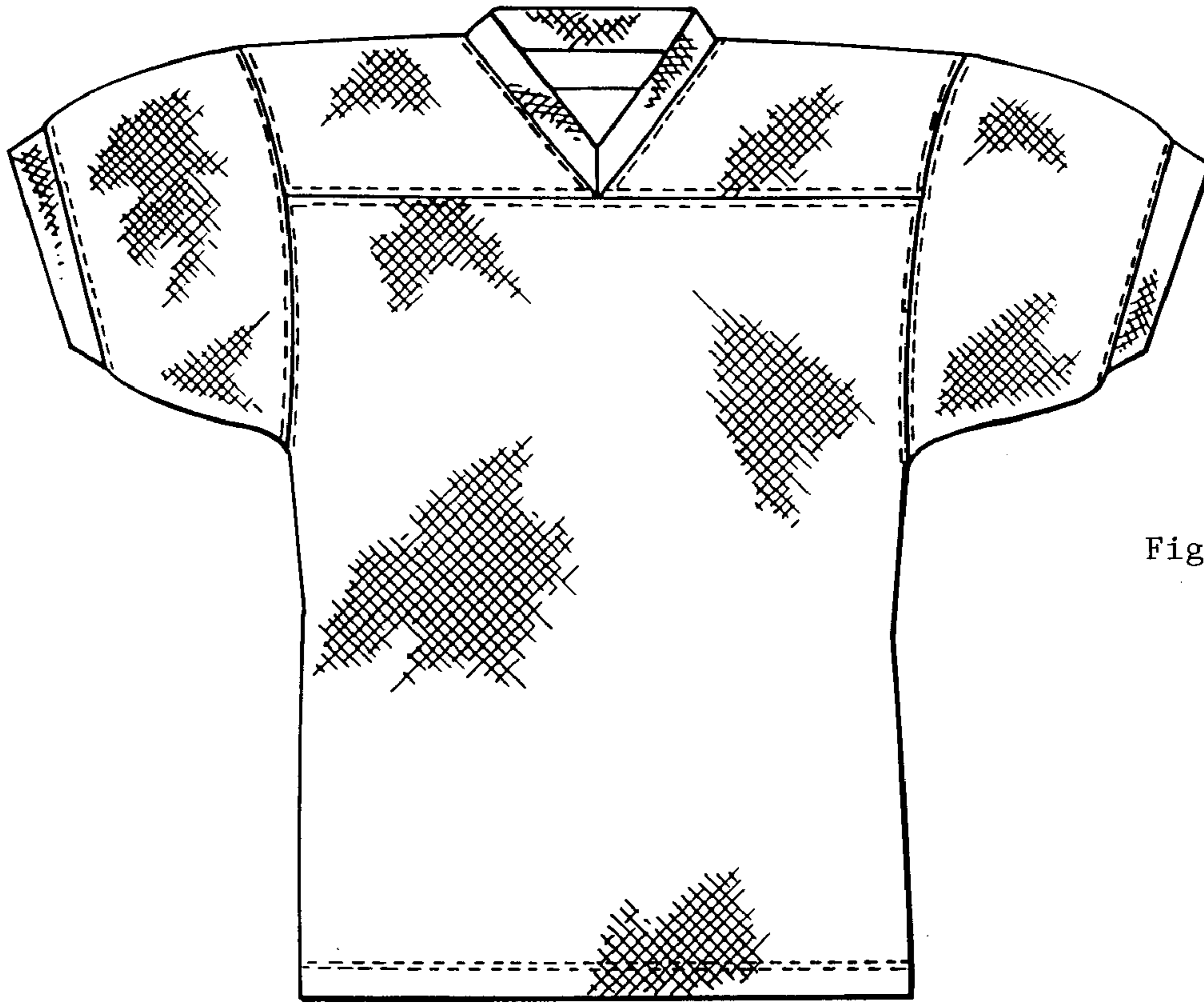

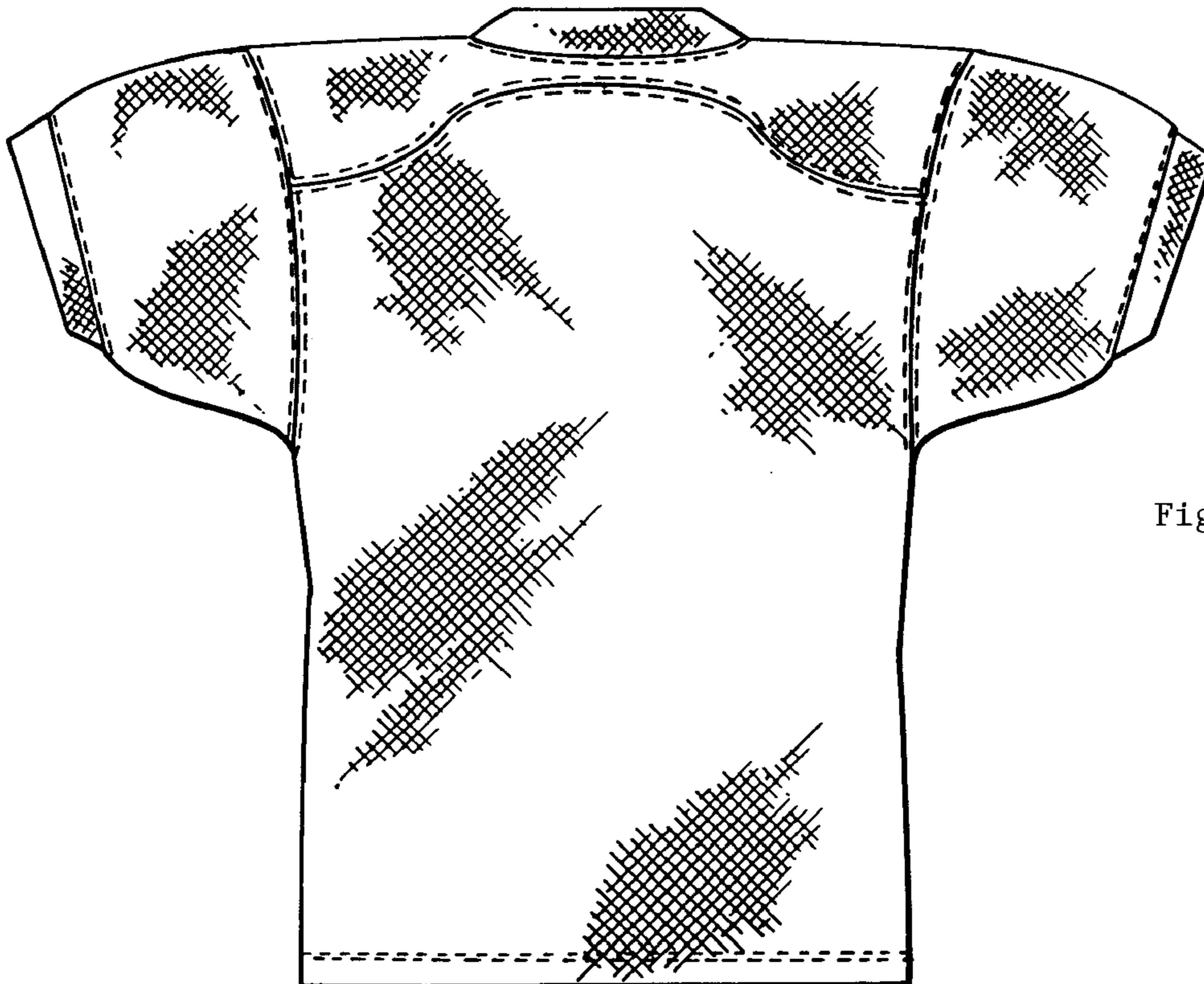

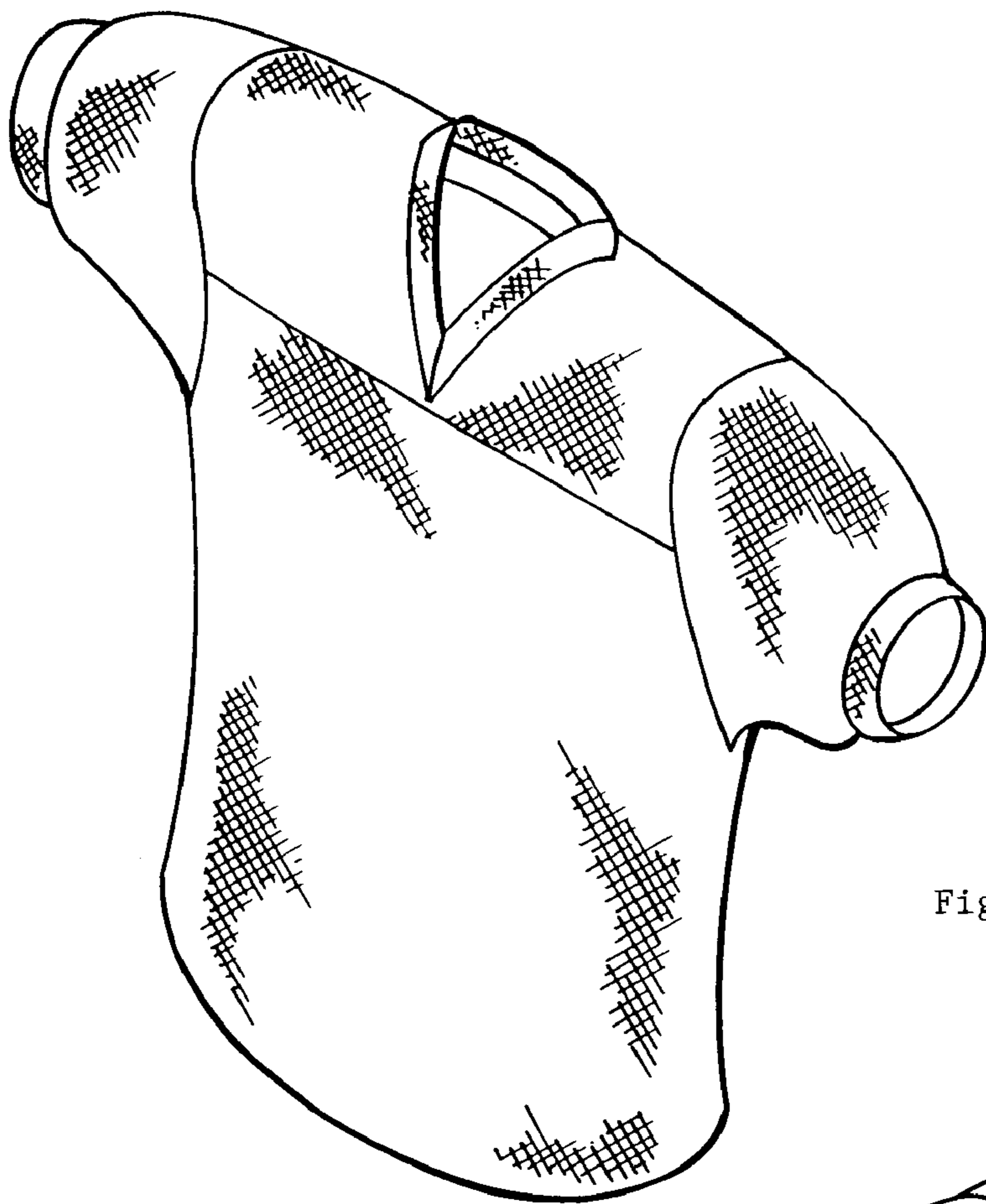

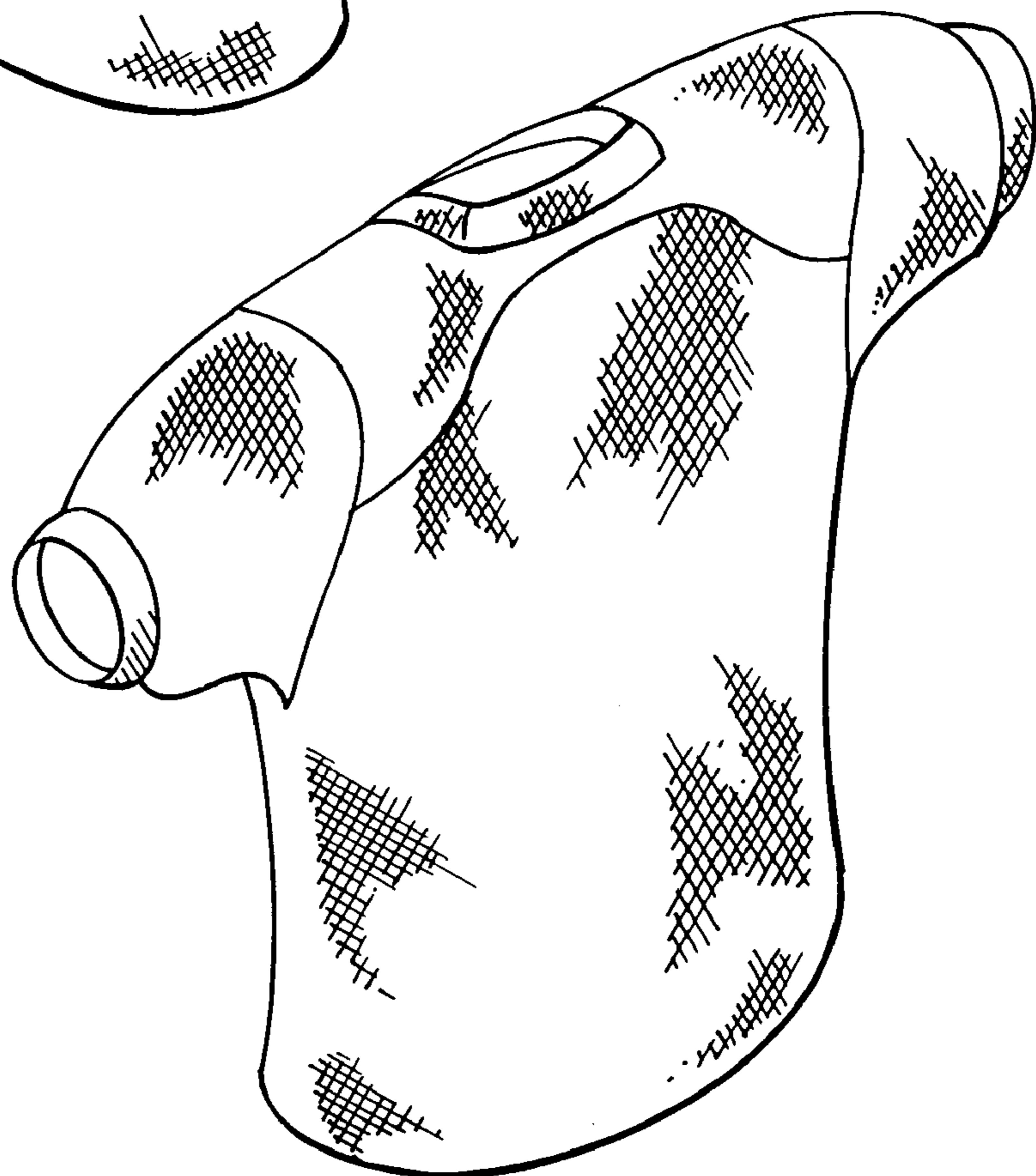
